[57] **CLAIM**

The ornamental design for an emergency information
label, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of an ornamental
design for an emergency information label showing my
new design;

showing my new design;

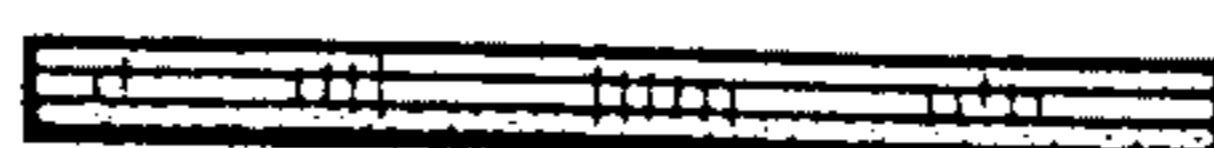
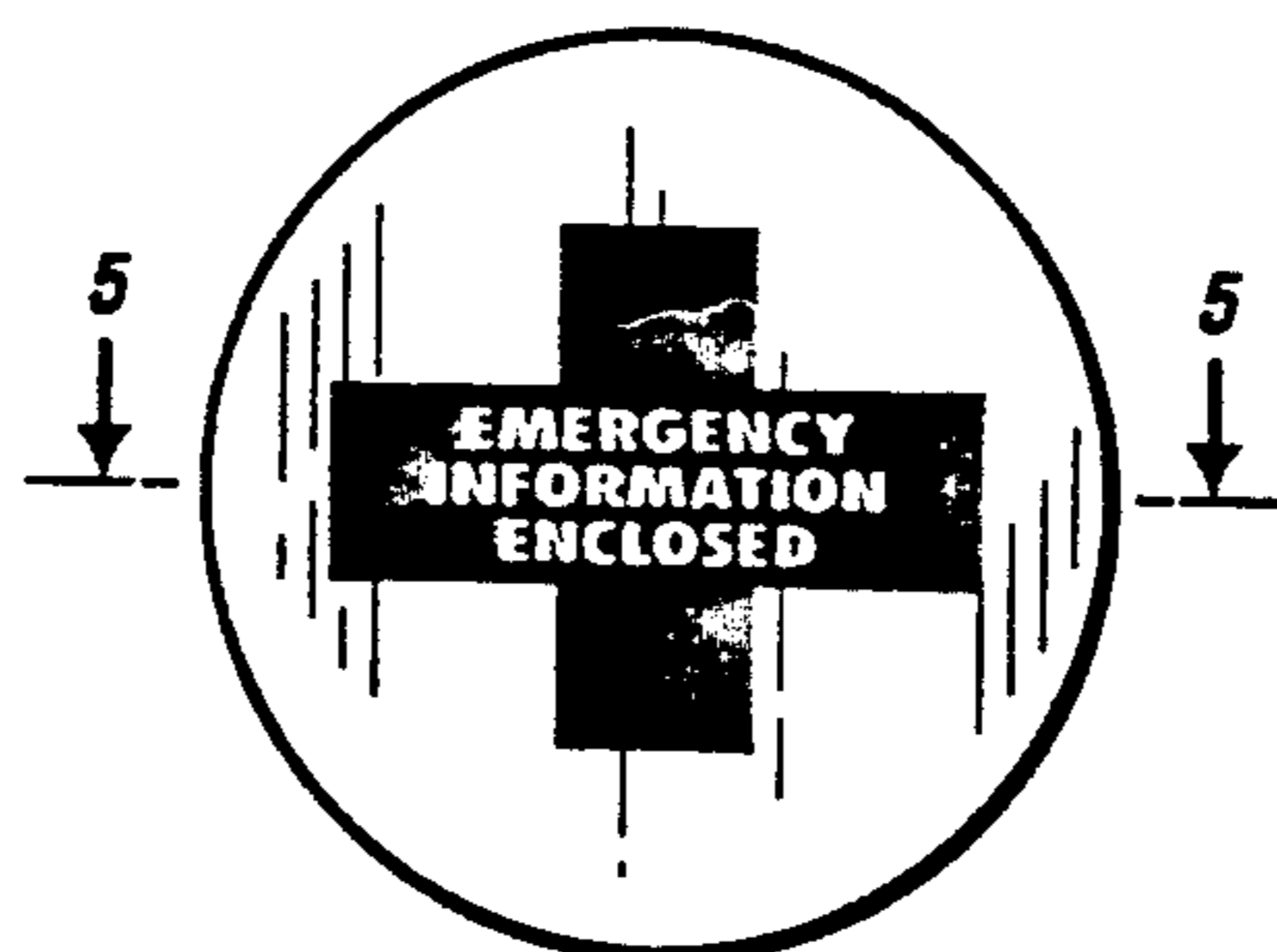


FIG. 29 is a bottom plan view thereof;

FIG. 35 is a cross-sectional thereof taken along line 5—5 of FIG. 31.

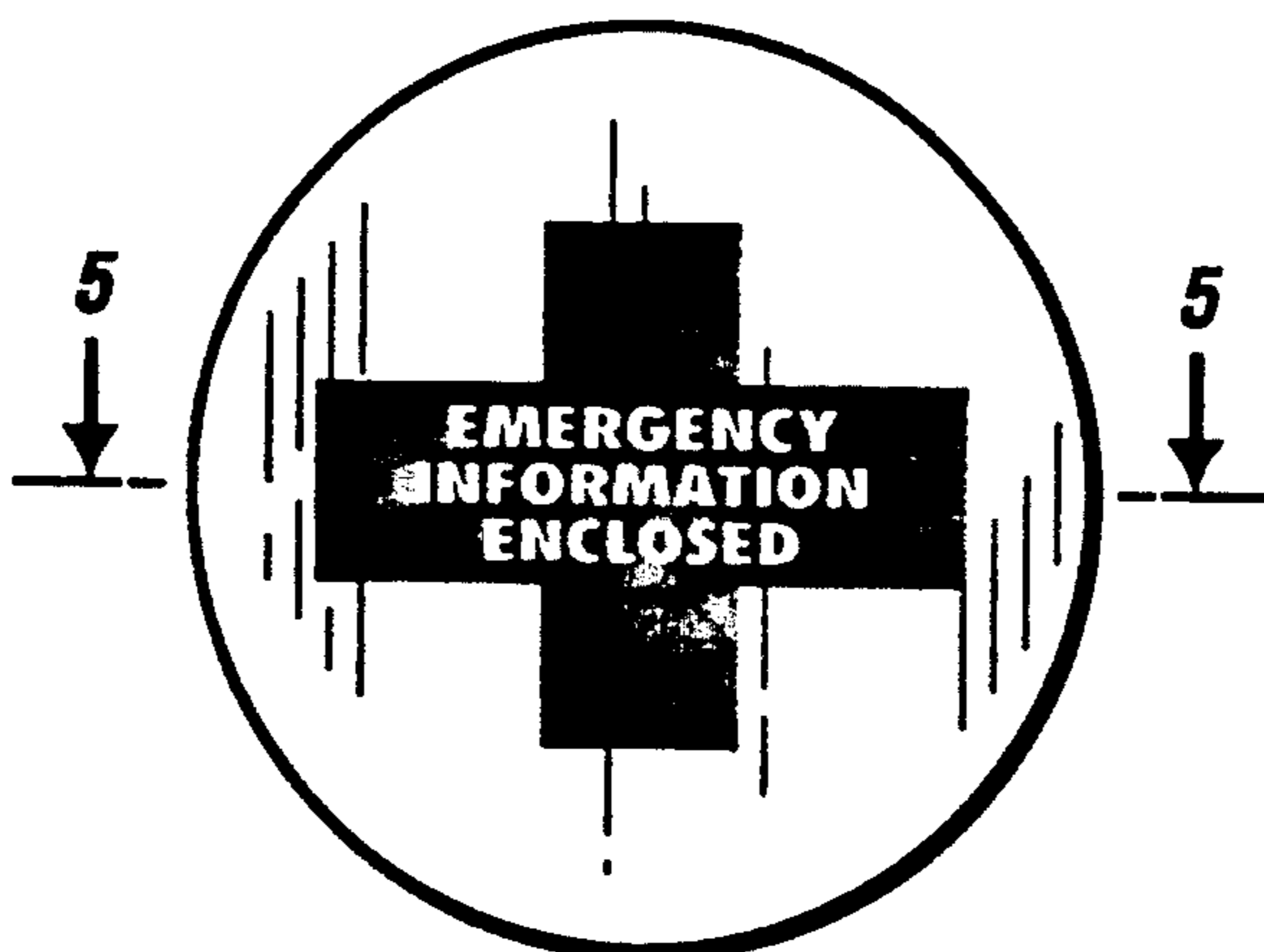

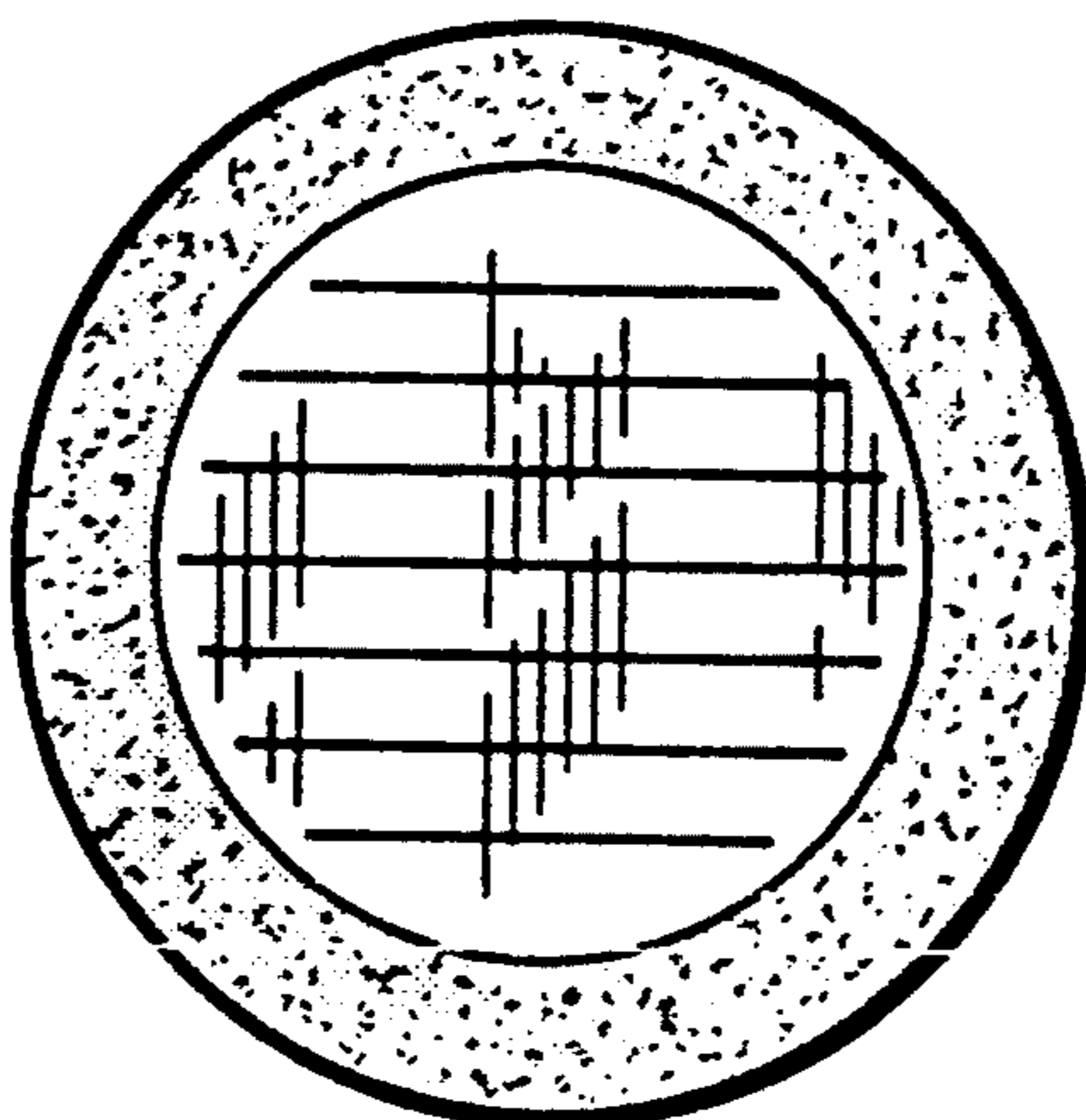

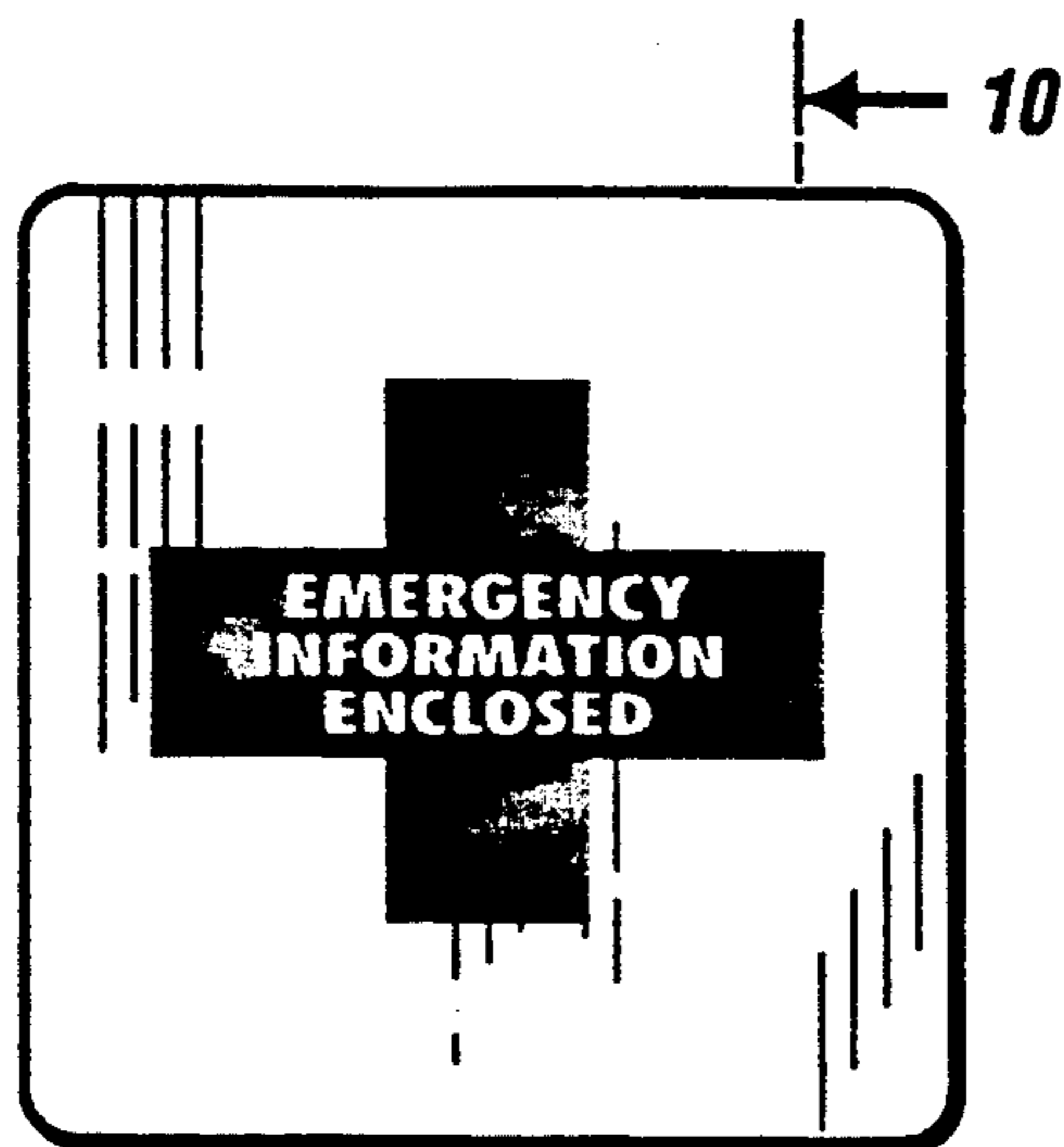

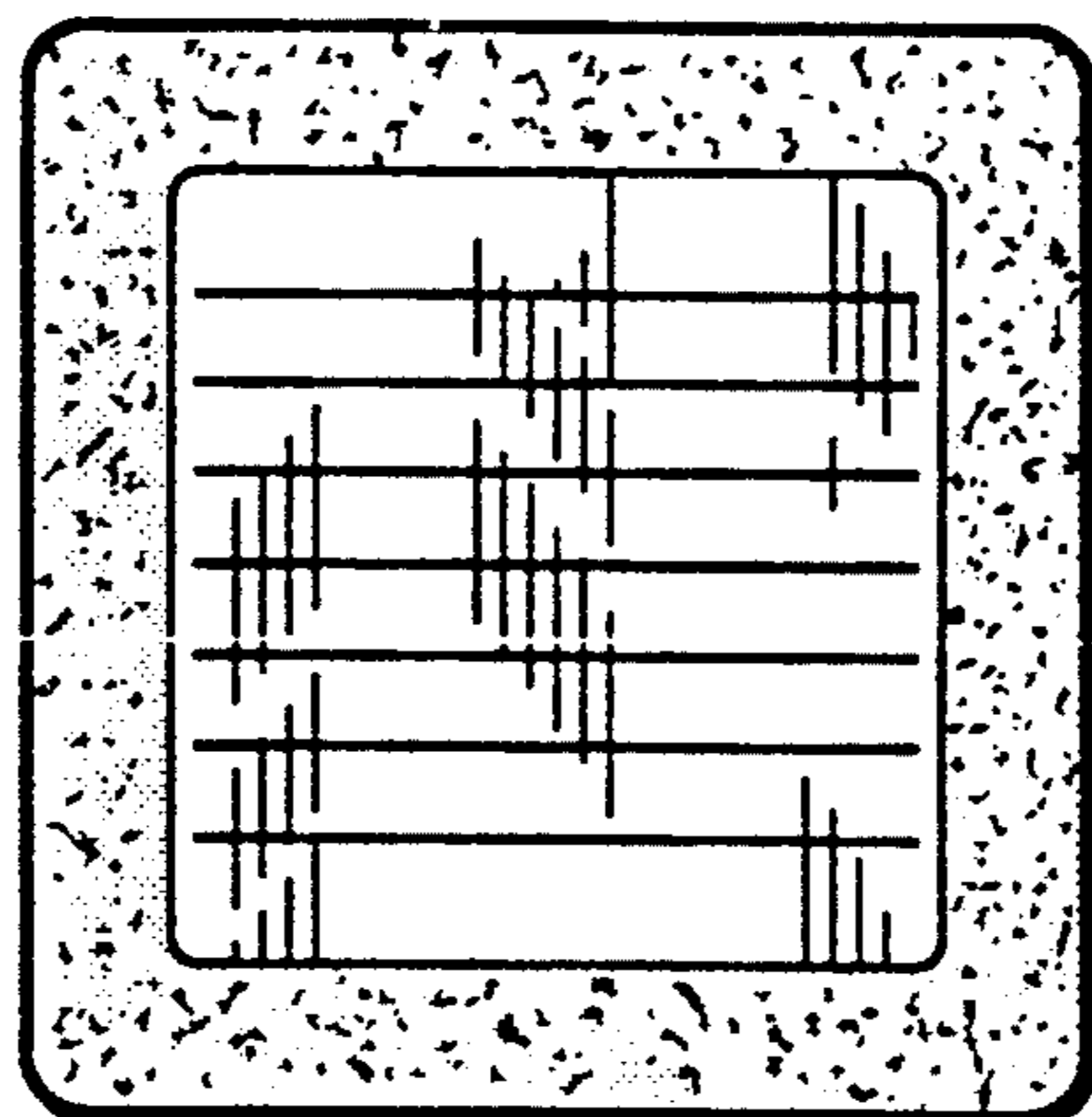

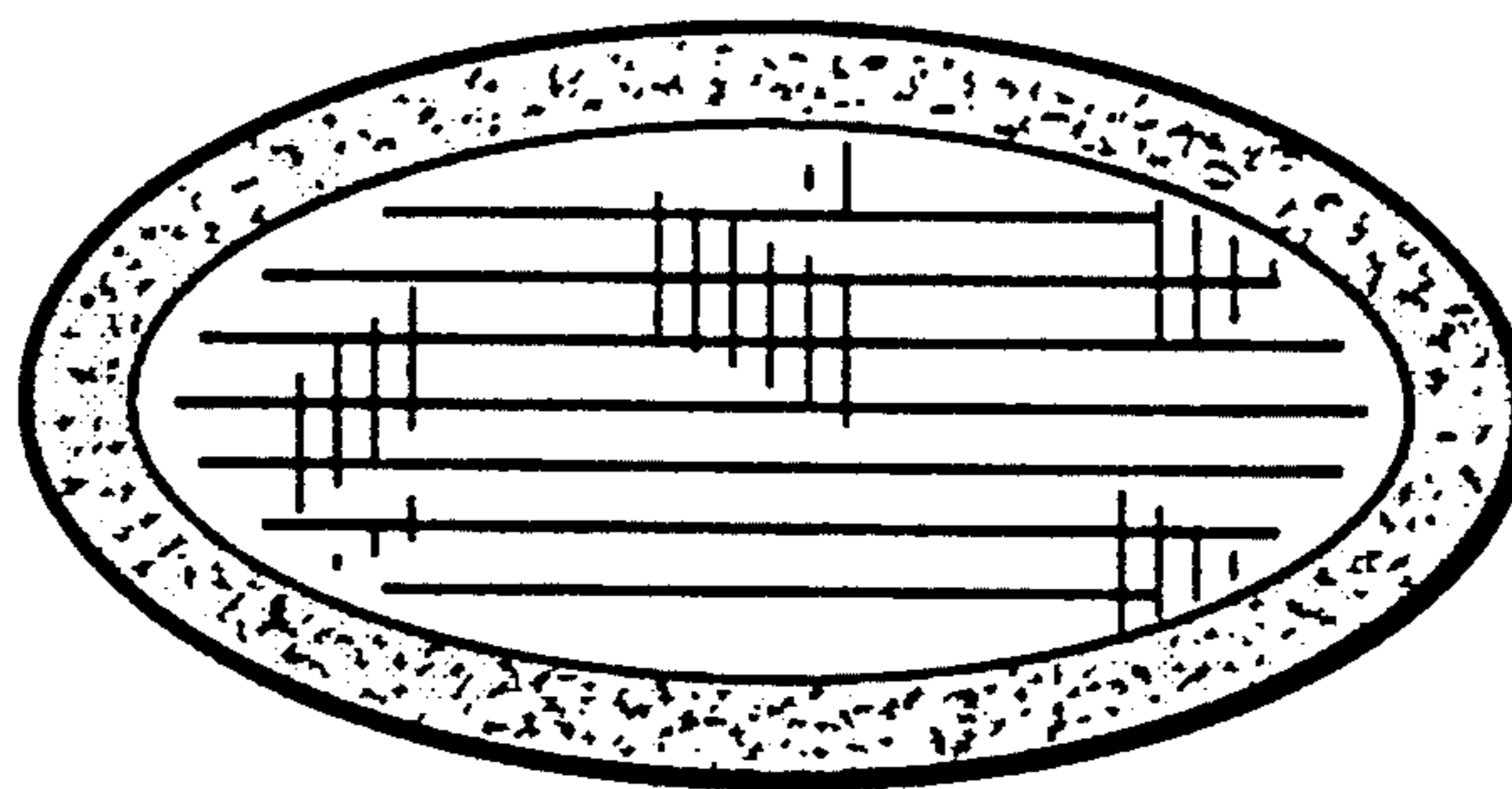

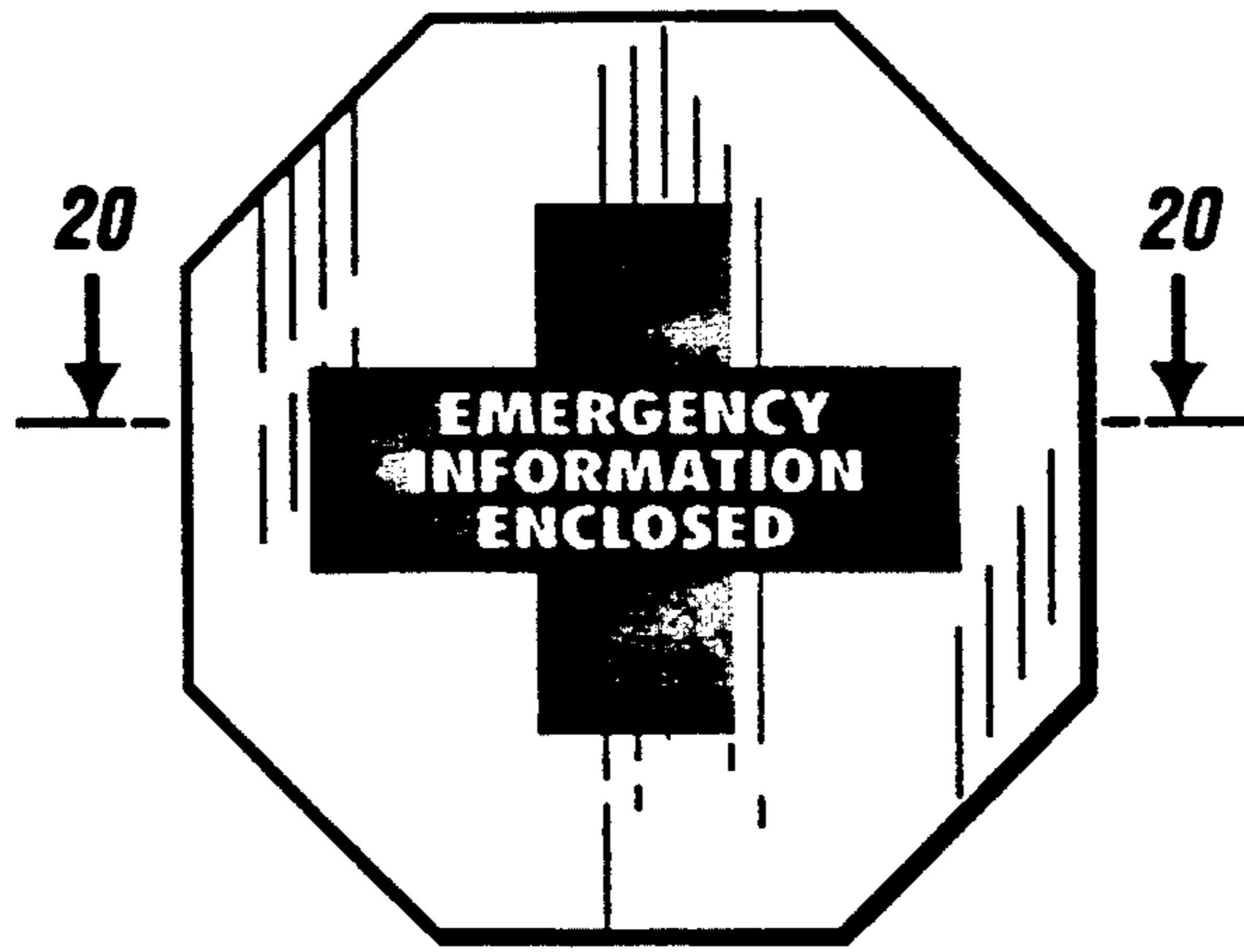

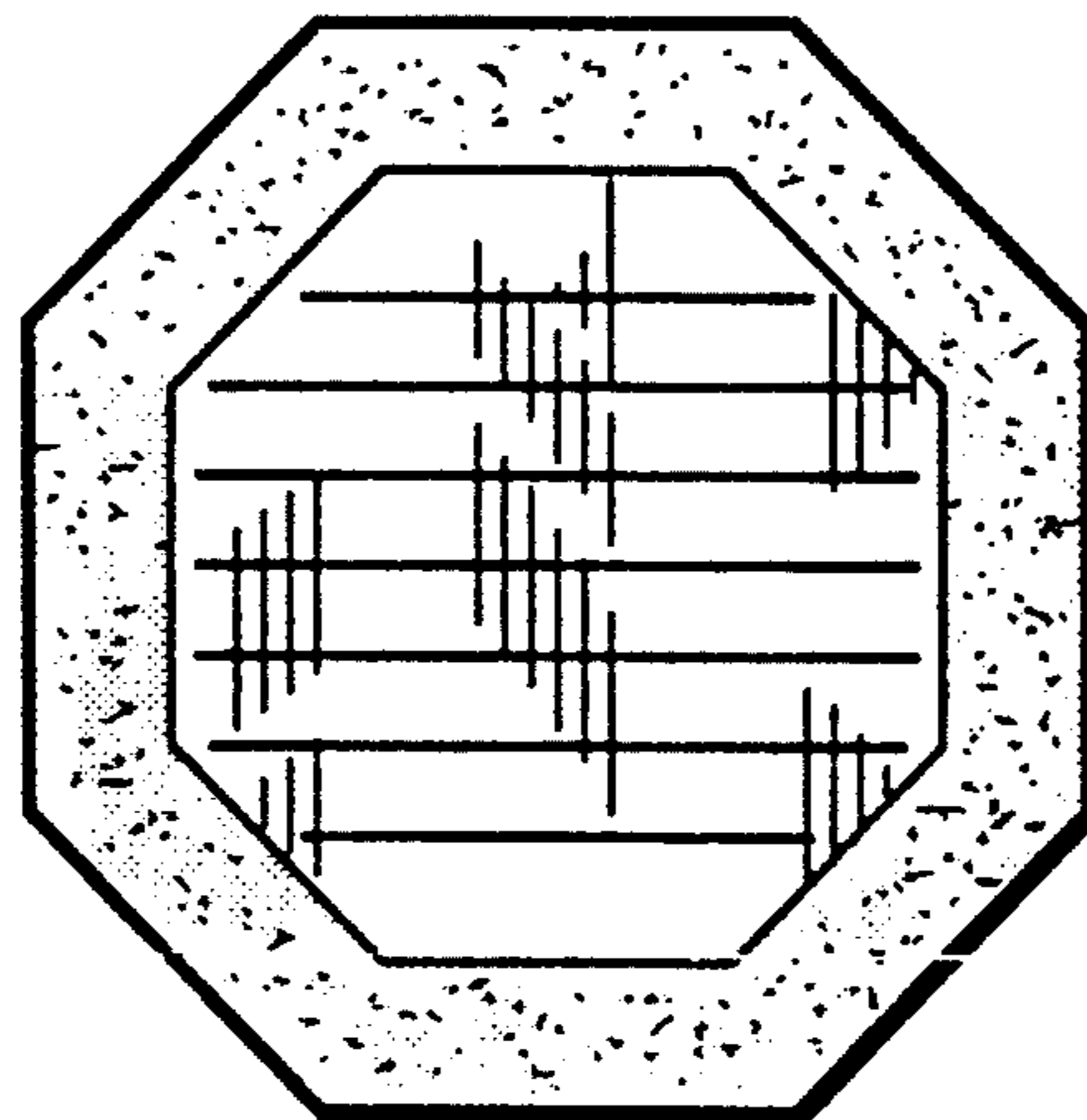

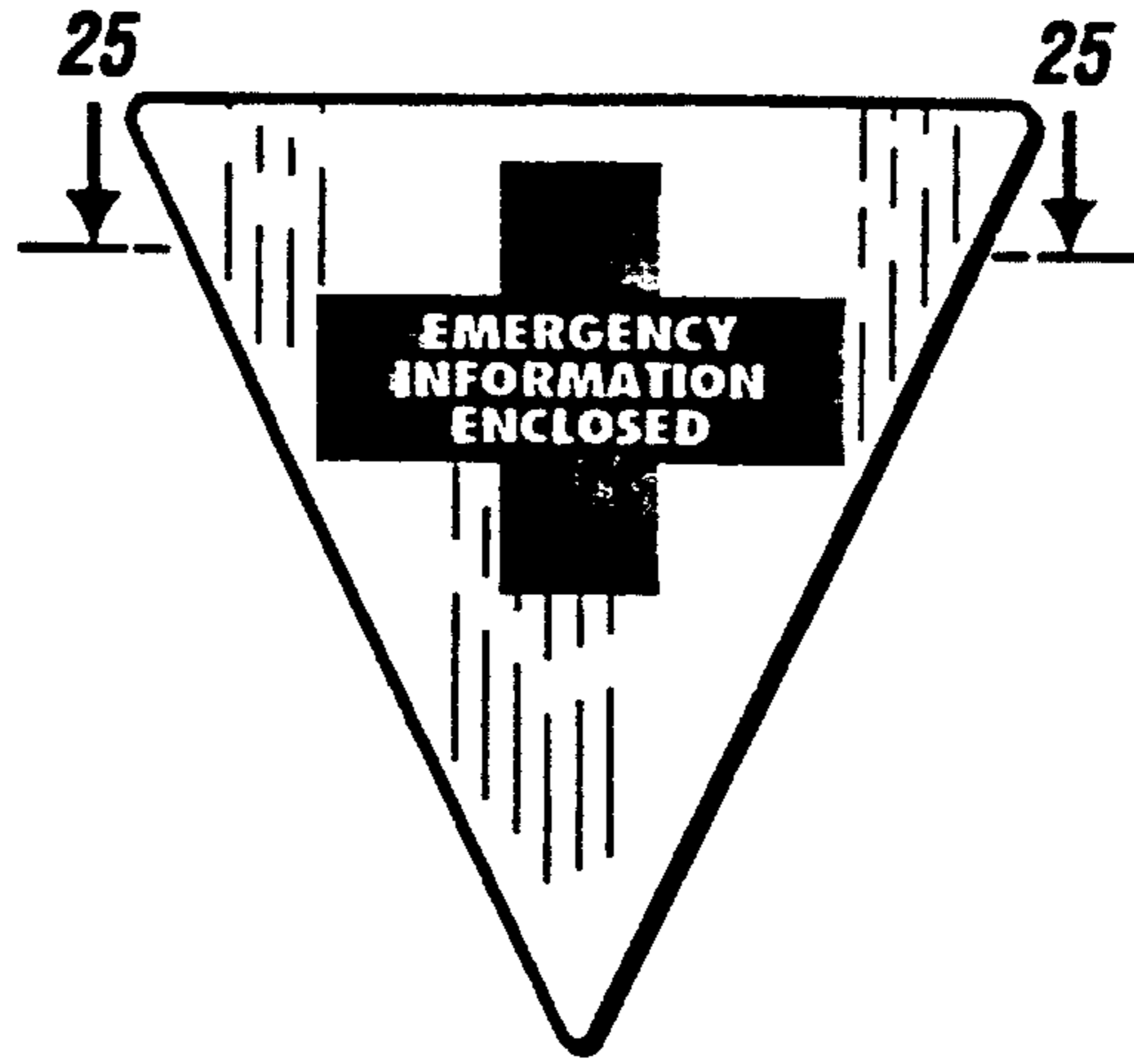

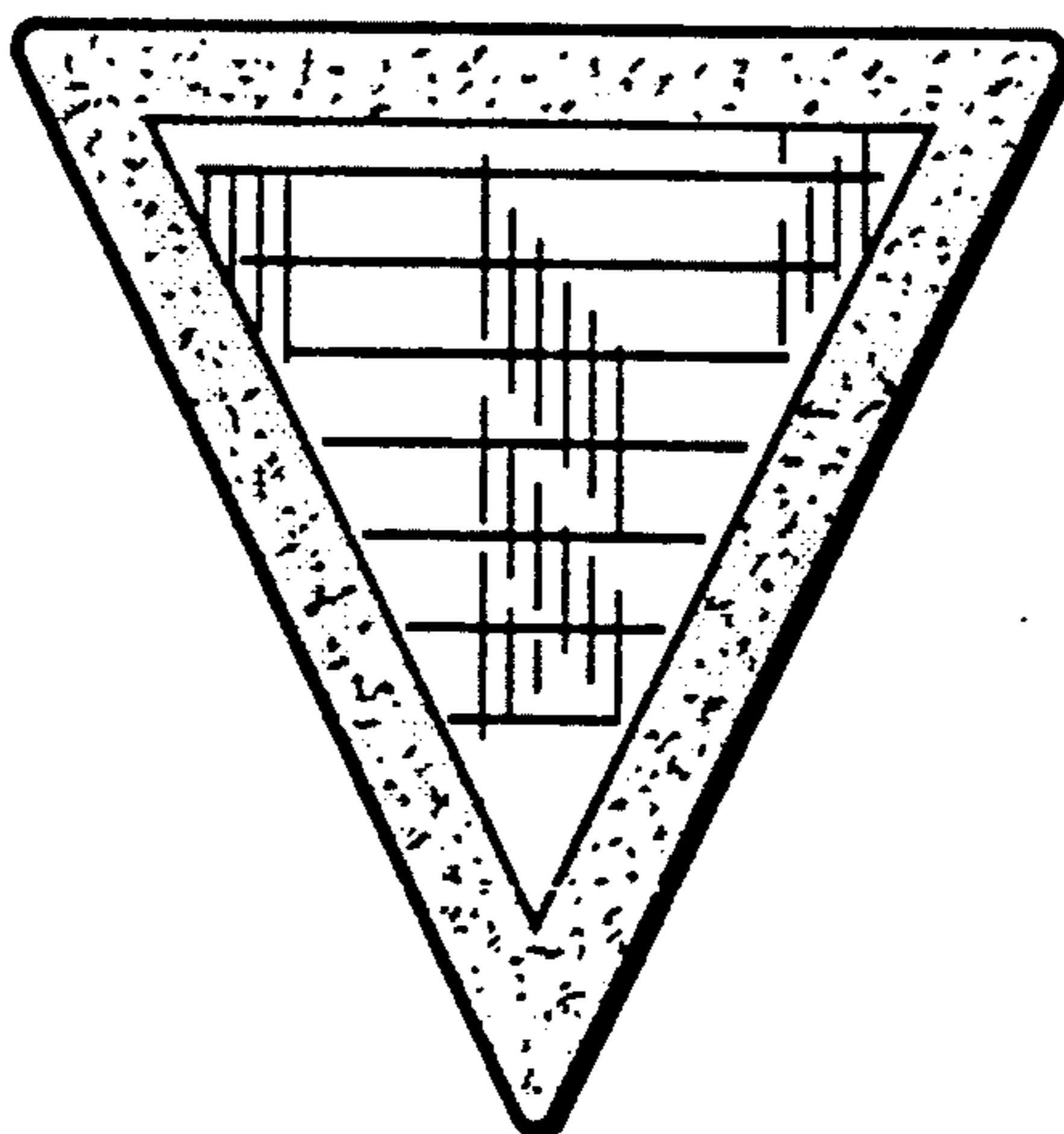

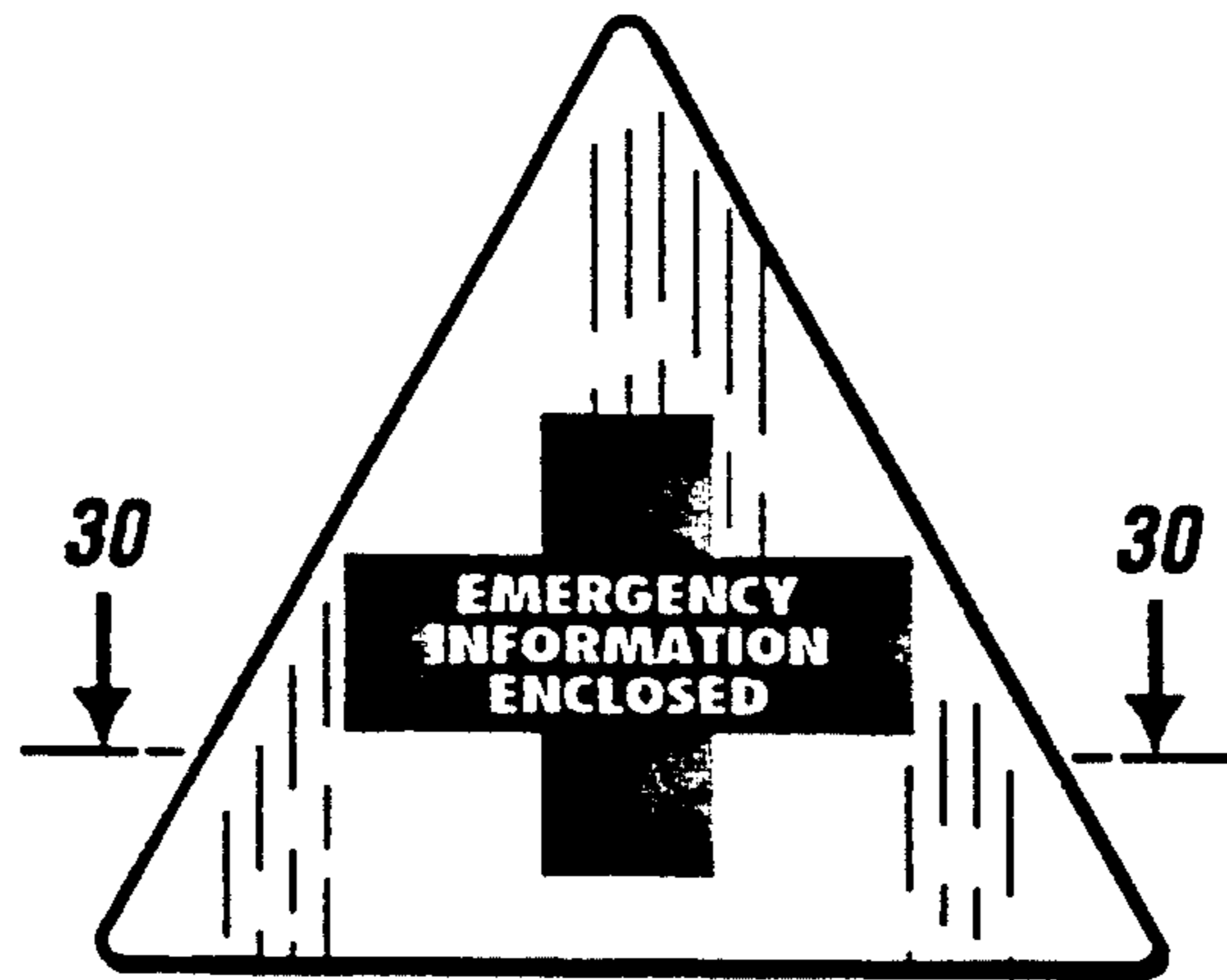

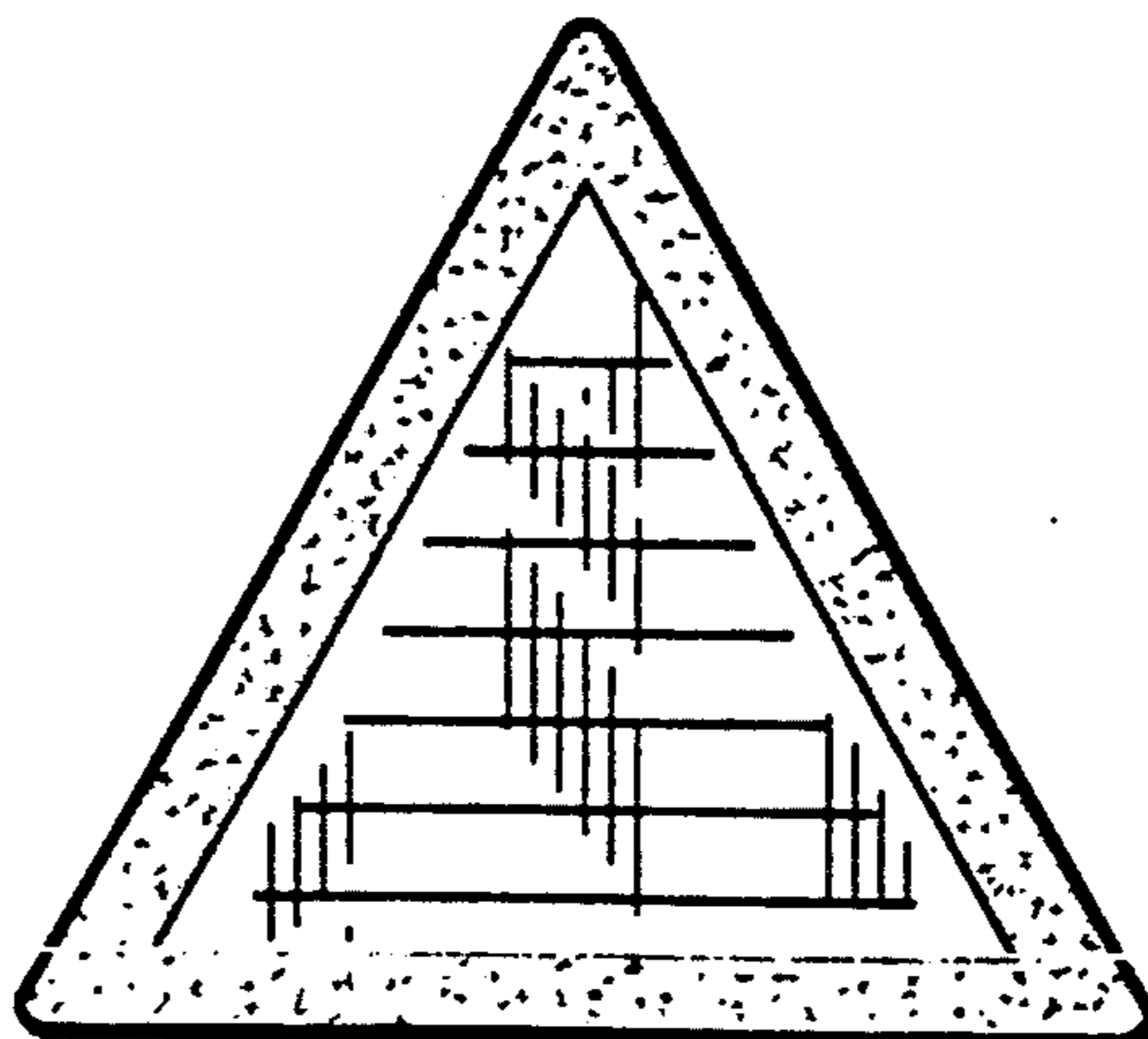

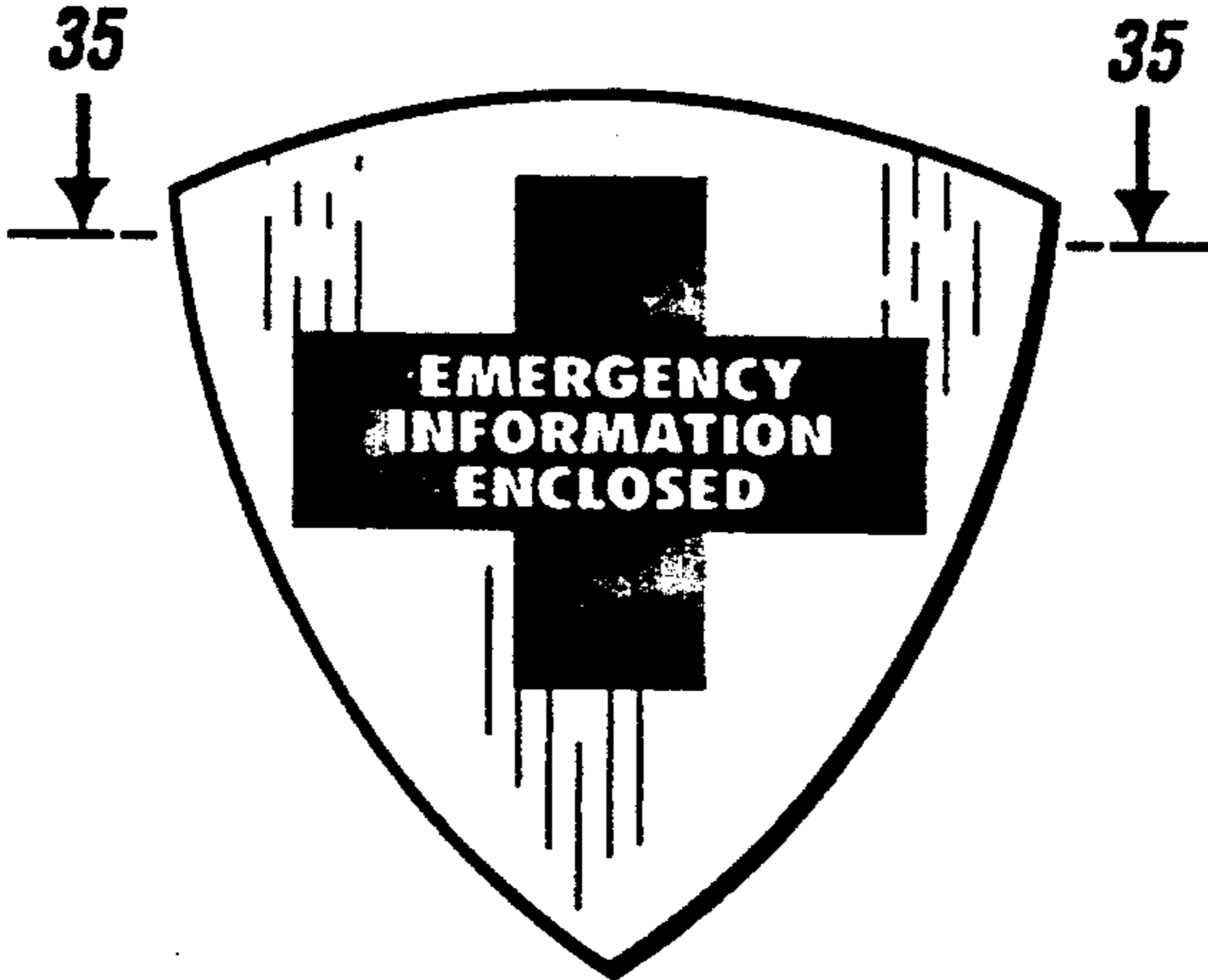

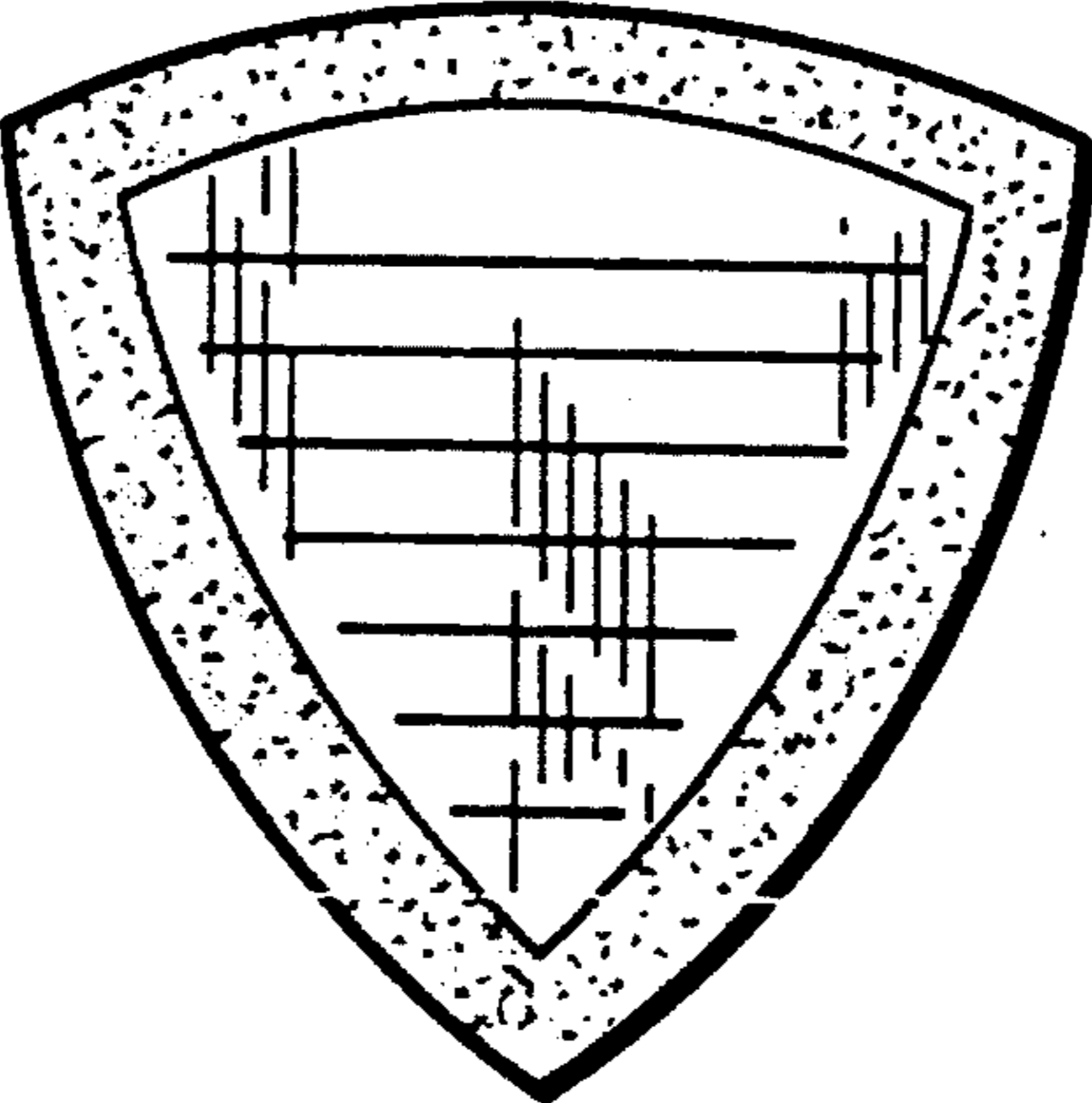
