FIG. 9 is a right side elevational view of FIG. 6;

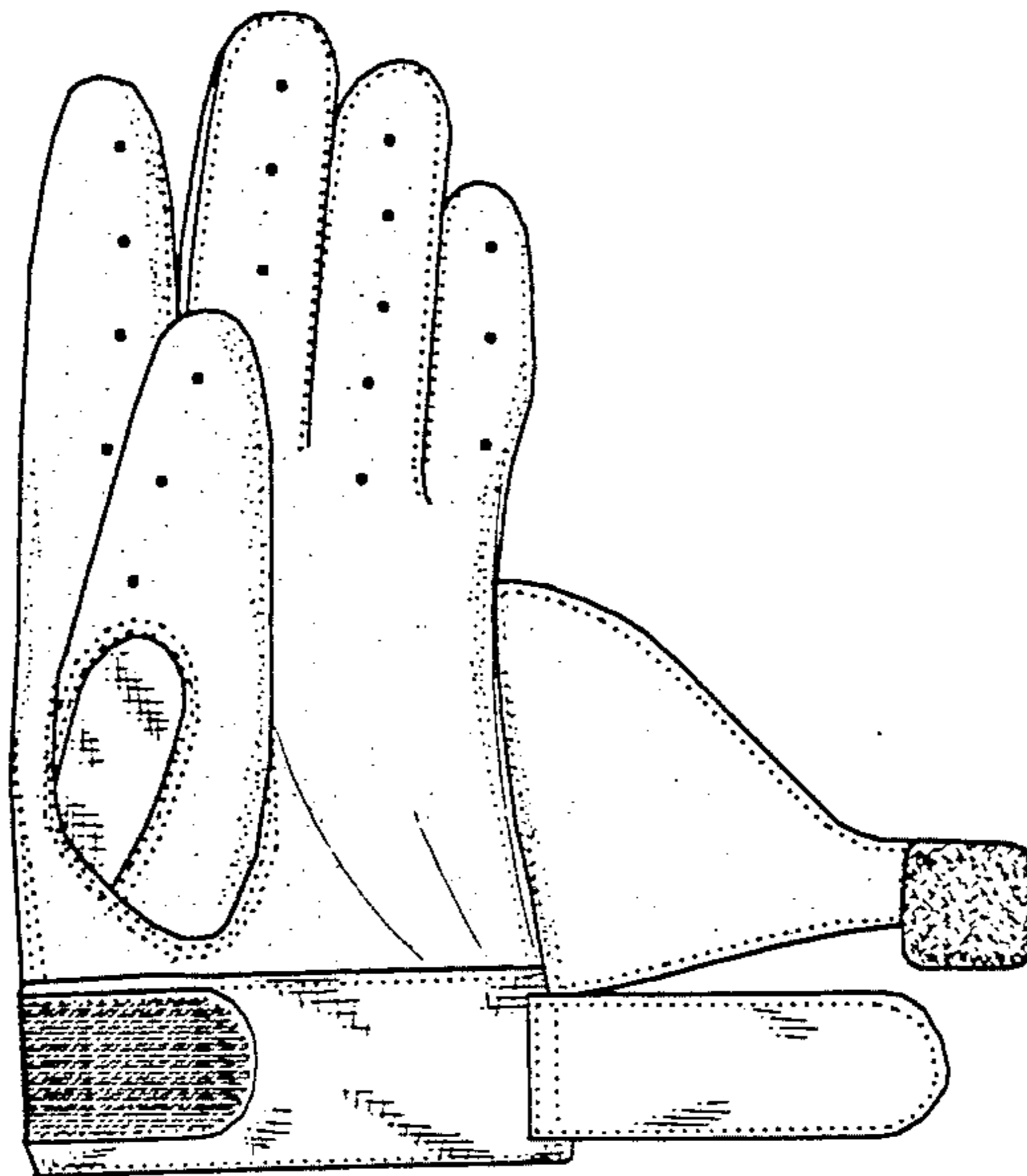
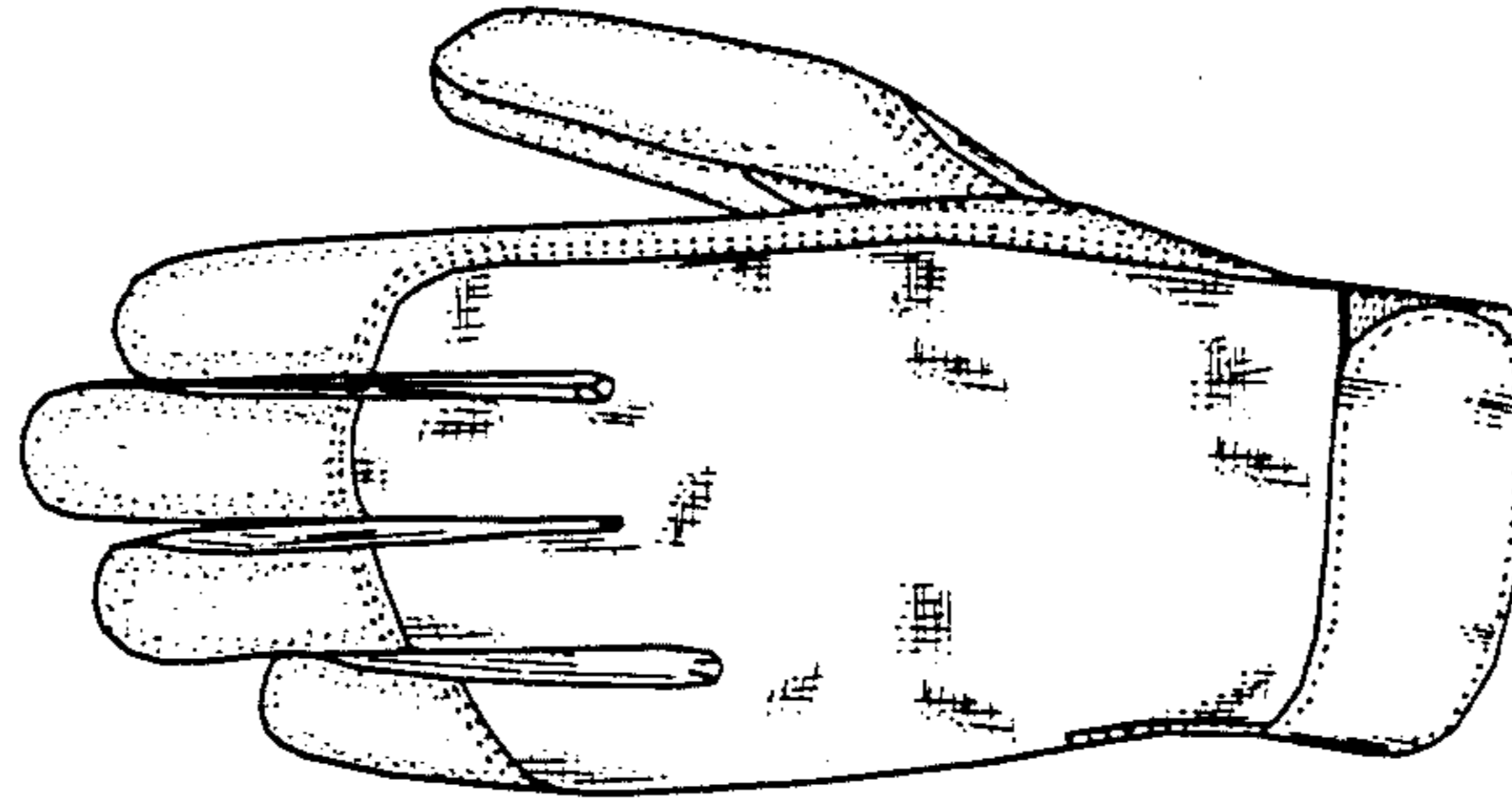
FIG. 10 is an front elevational view of FIG. 6;

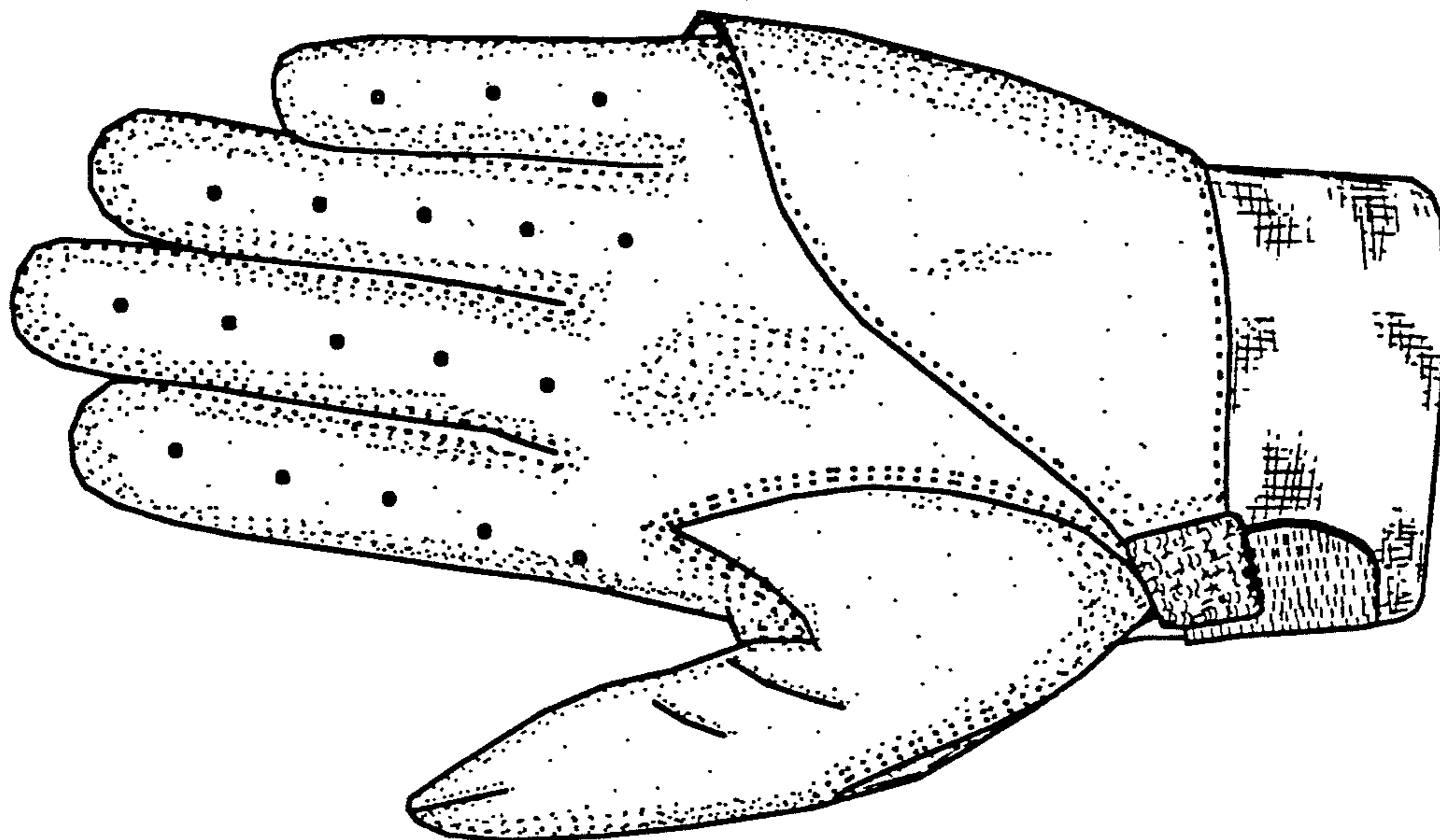

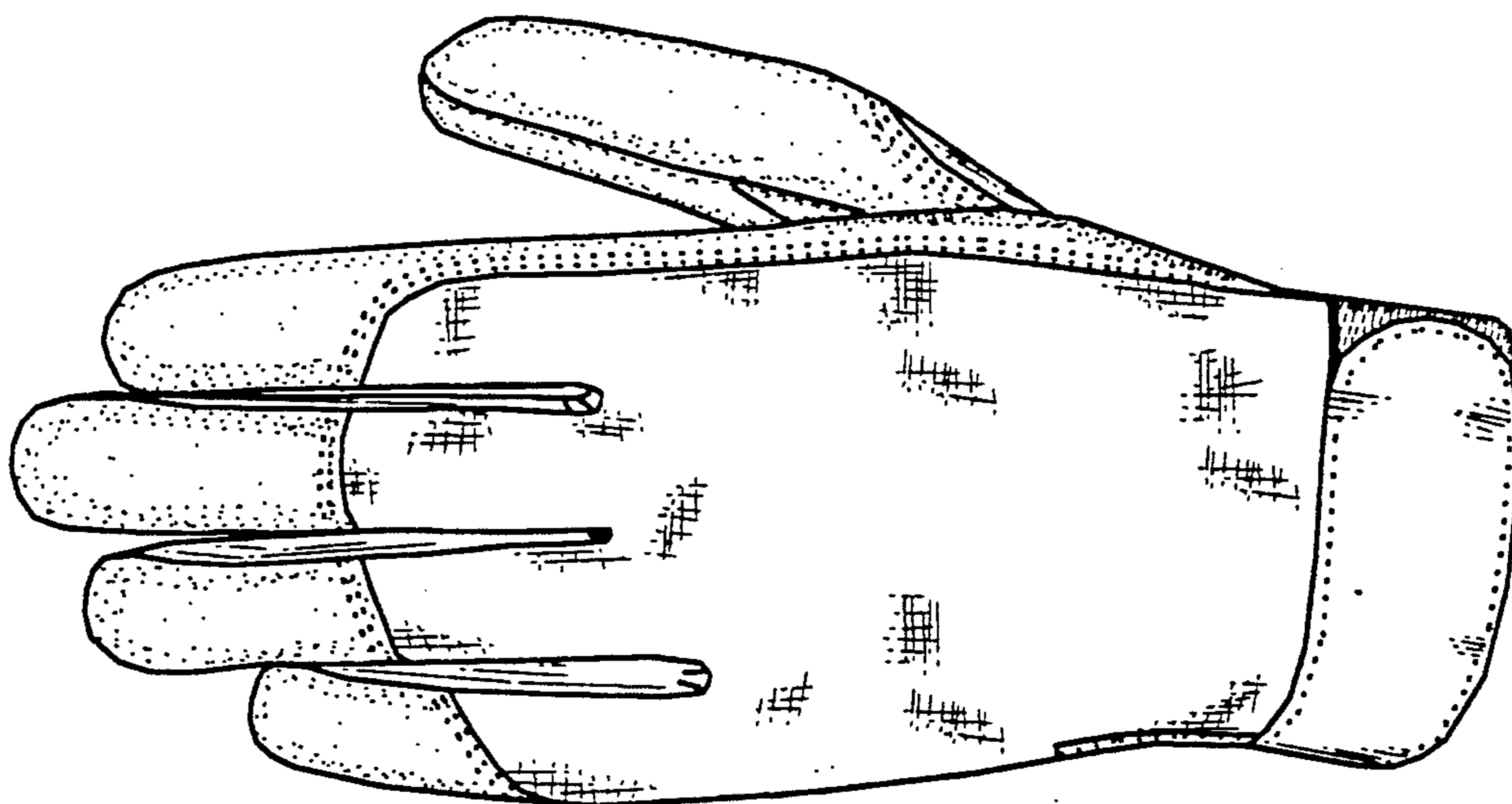

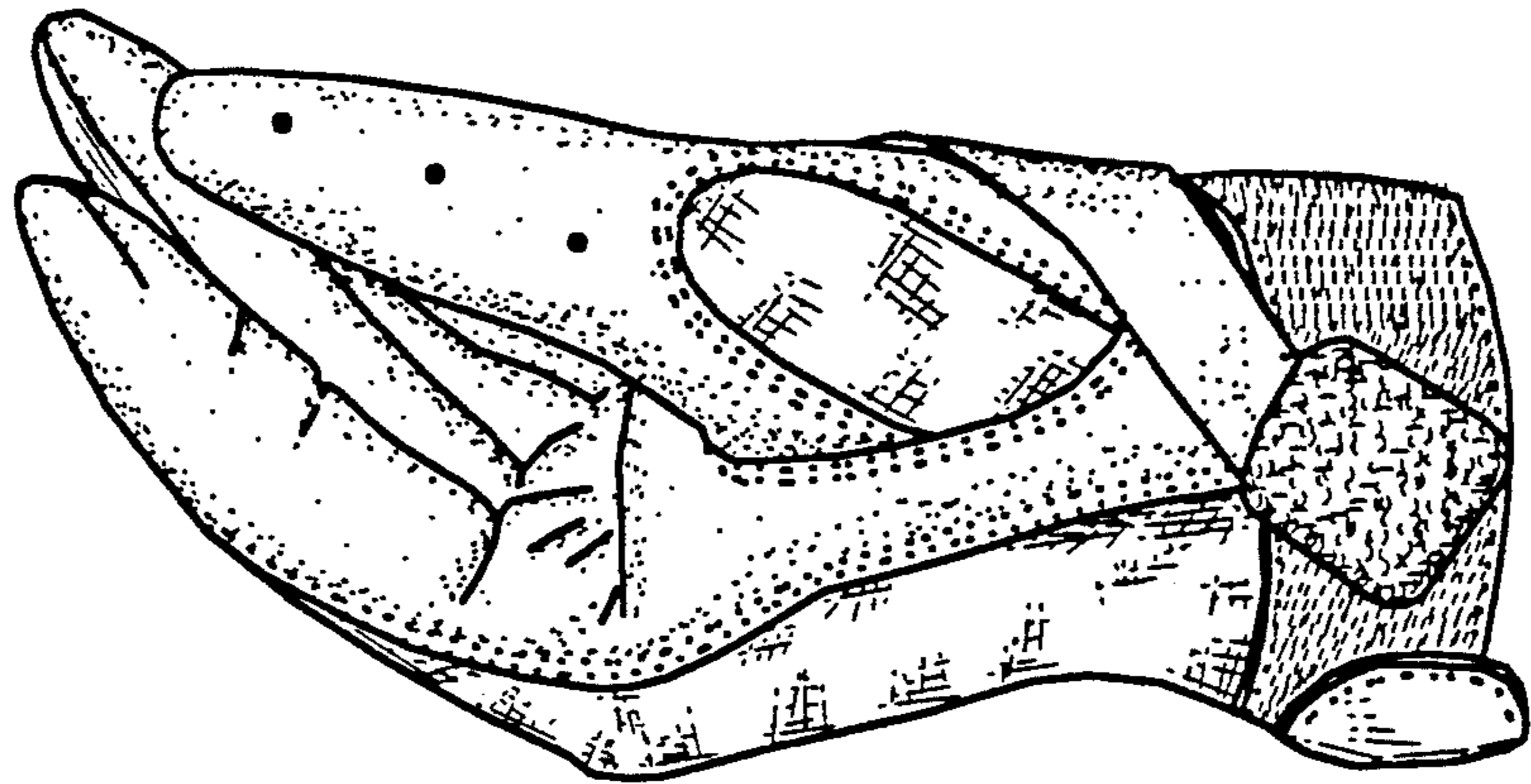

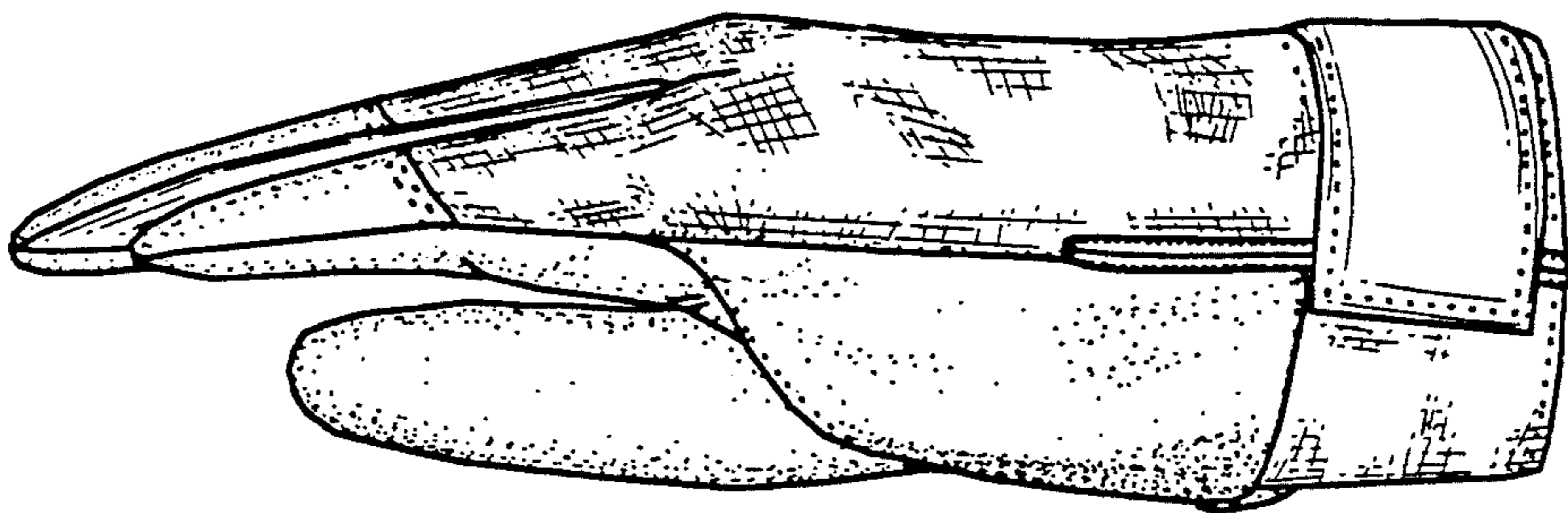

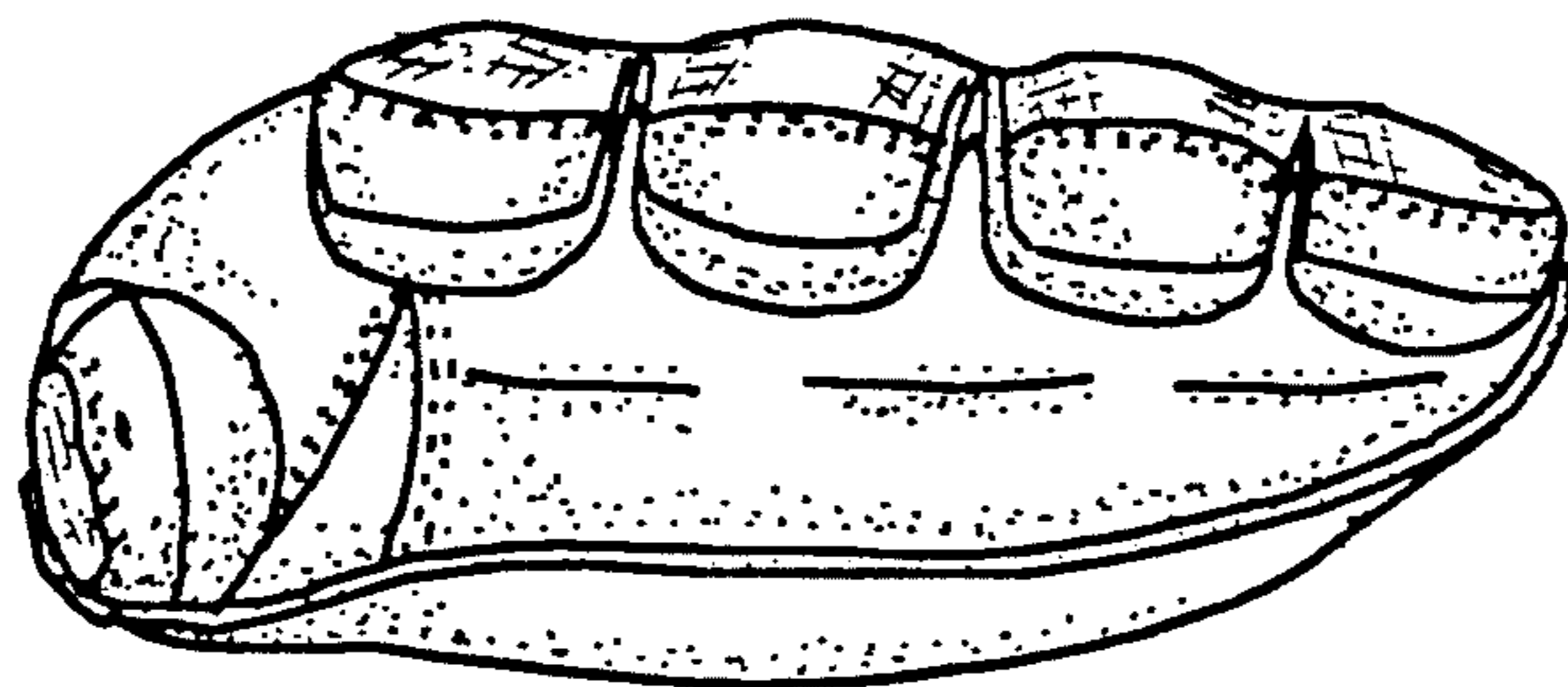

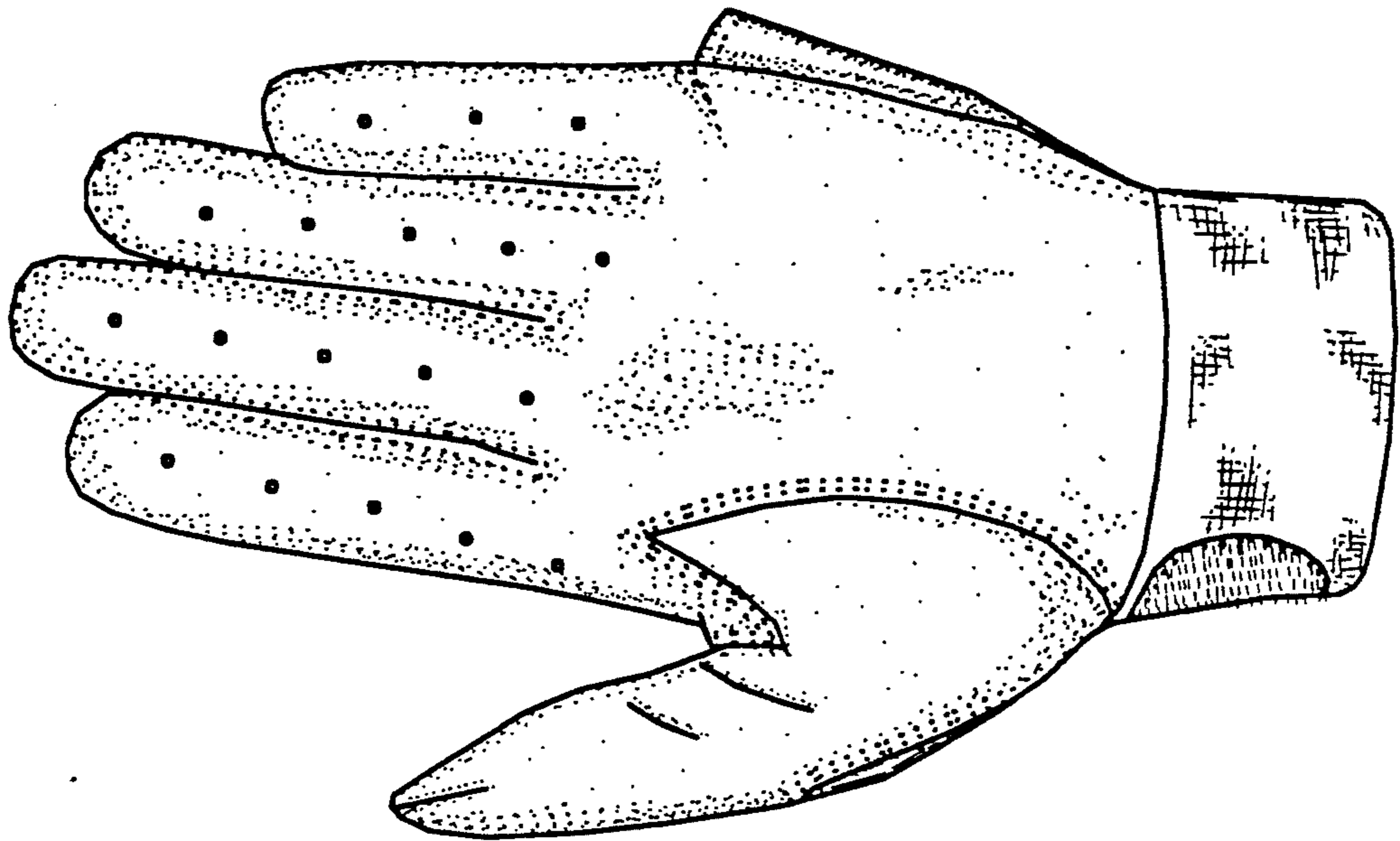

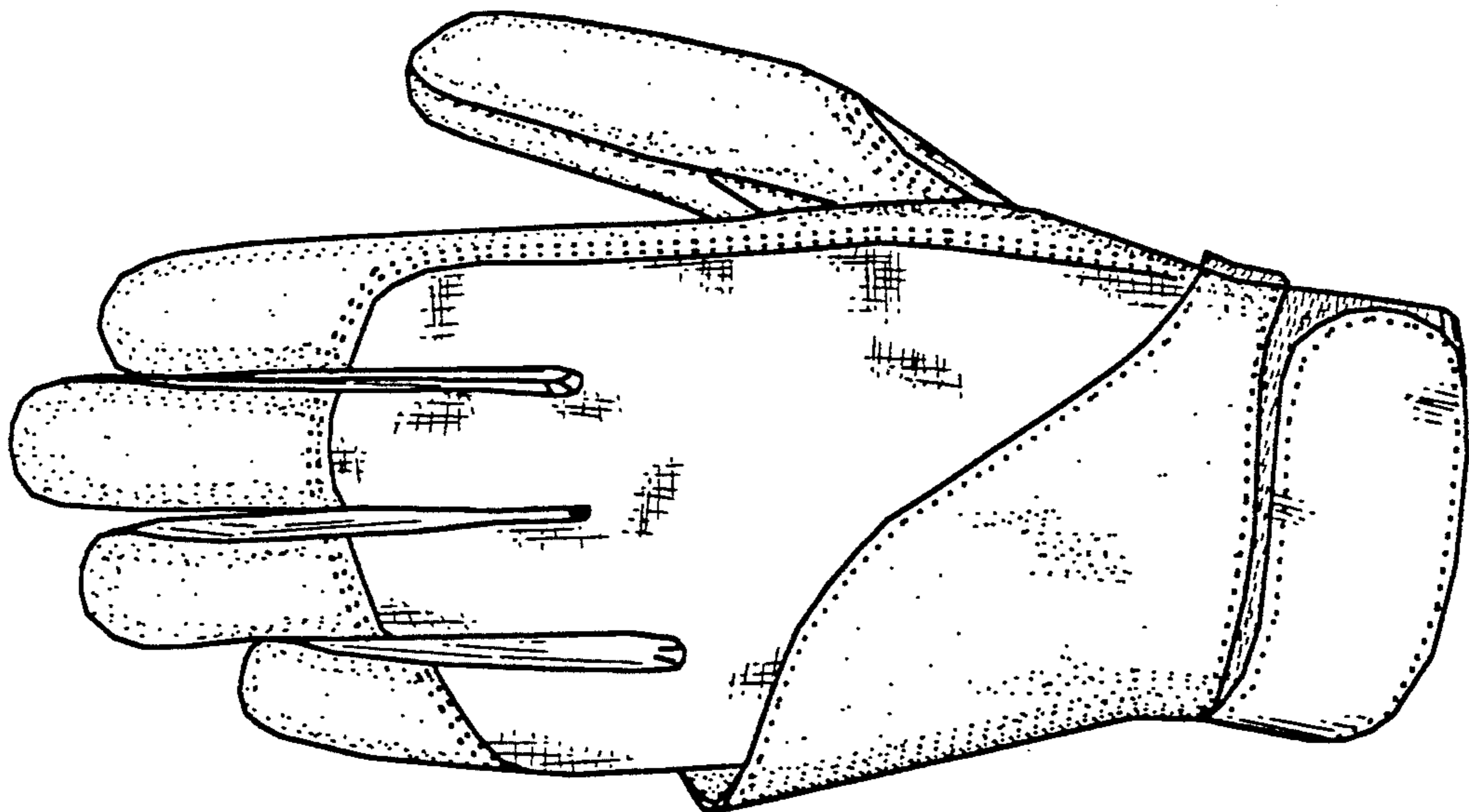

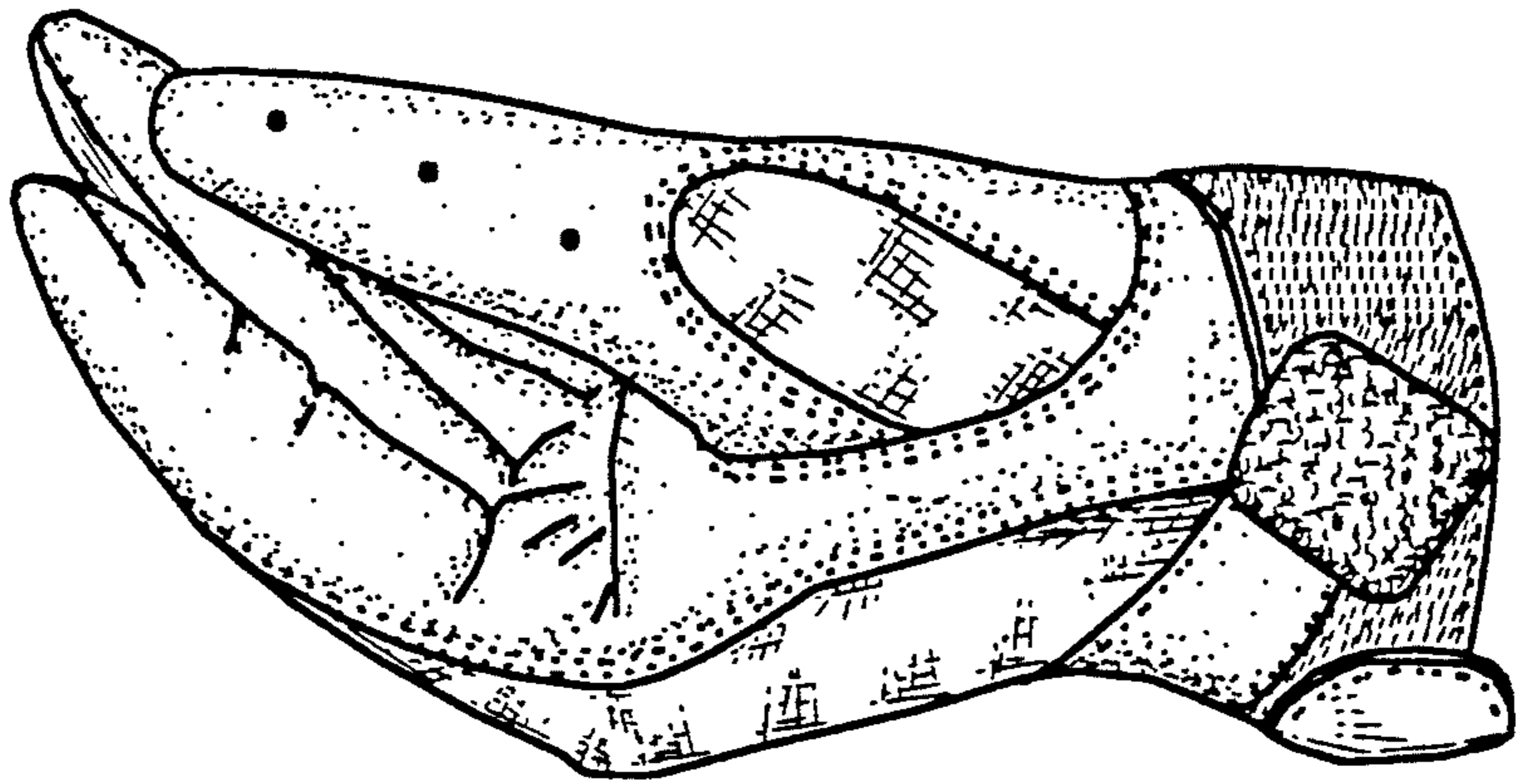

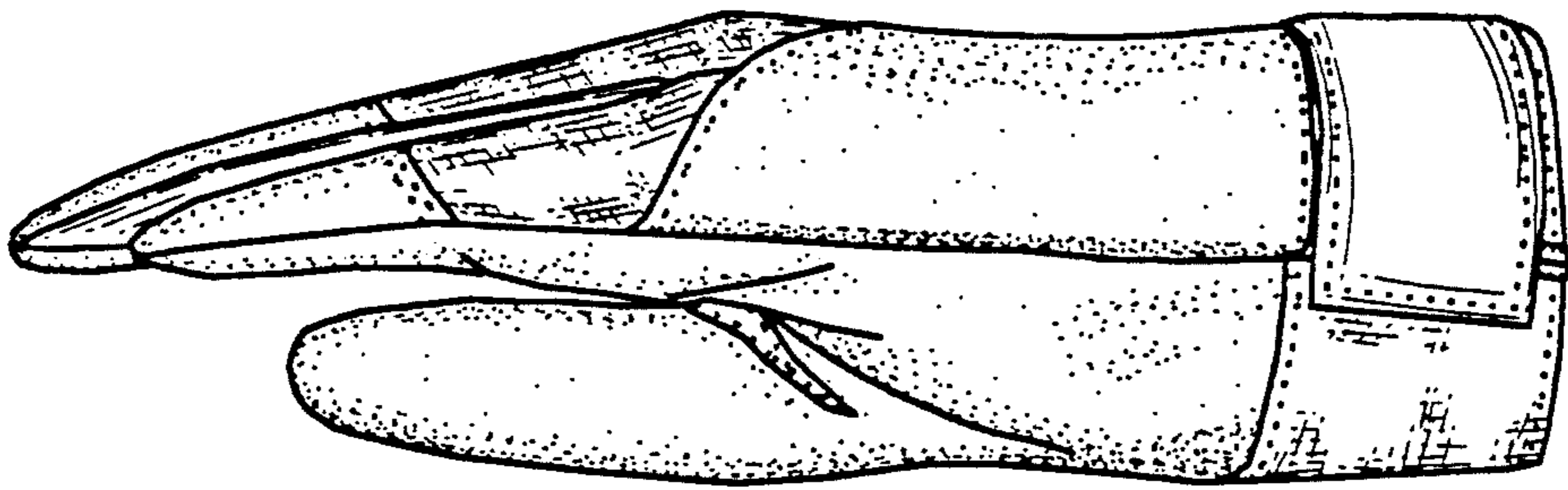

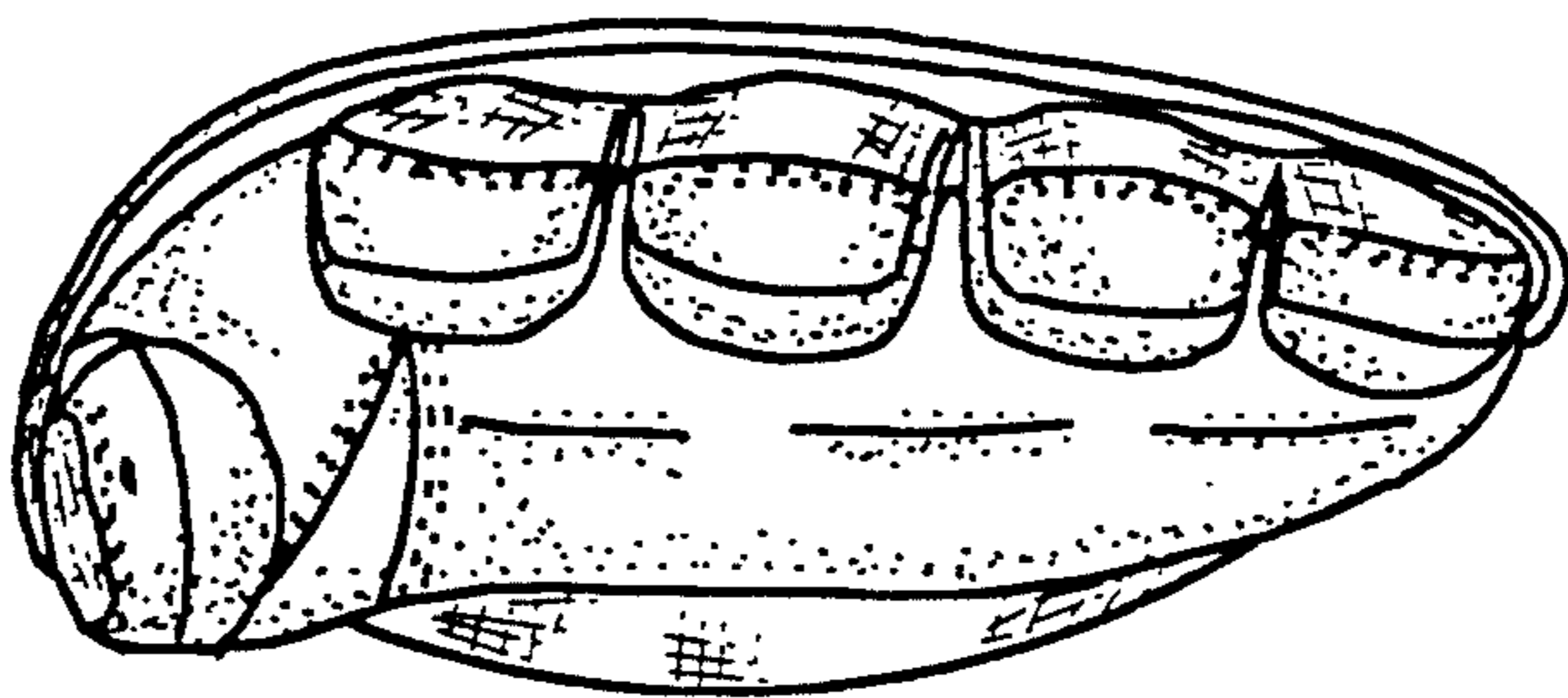

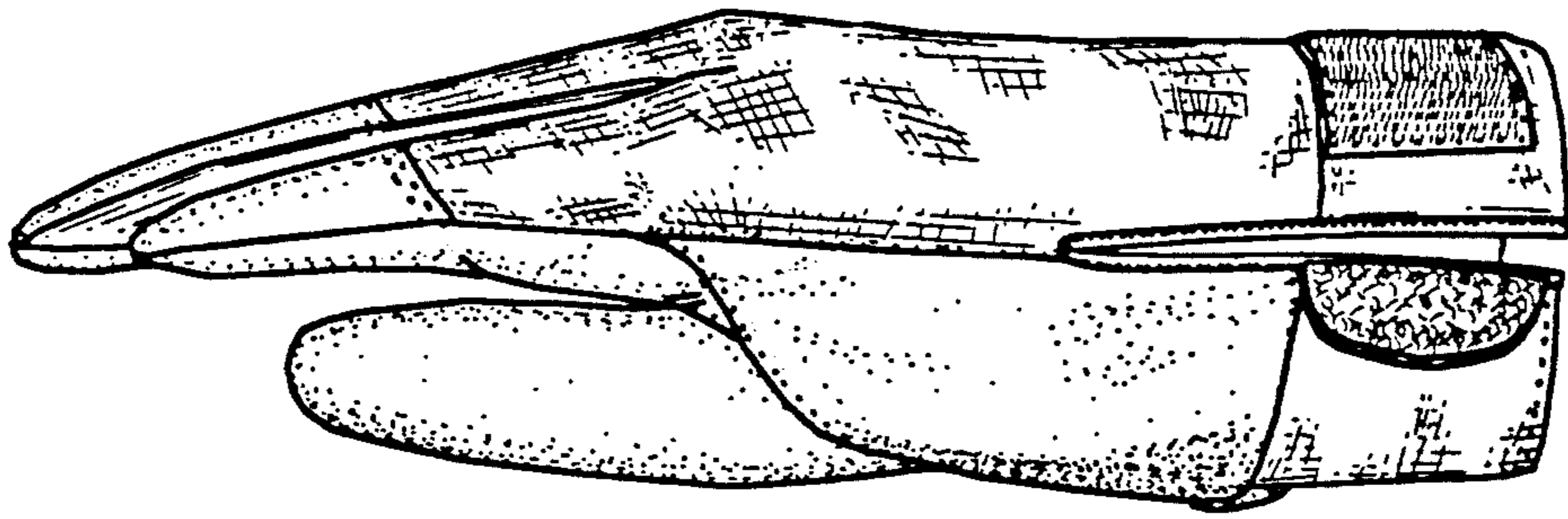

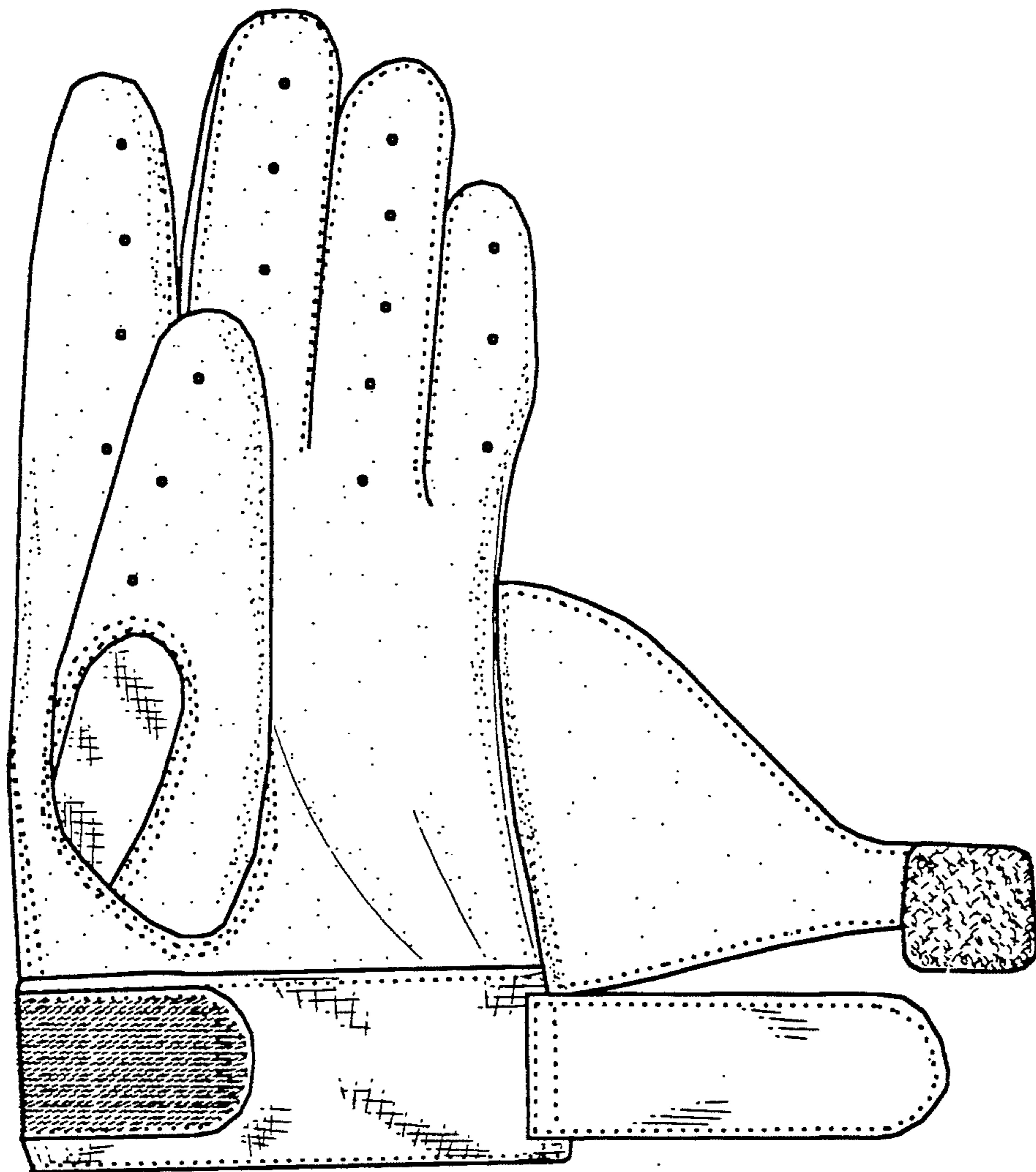
