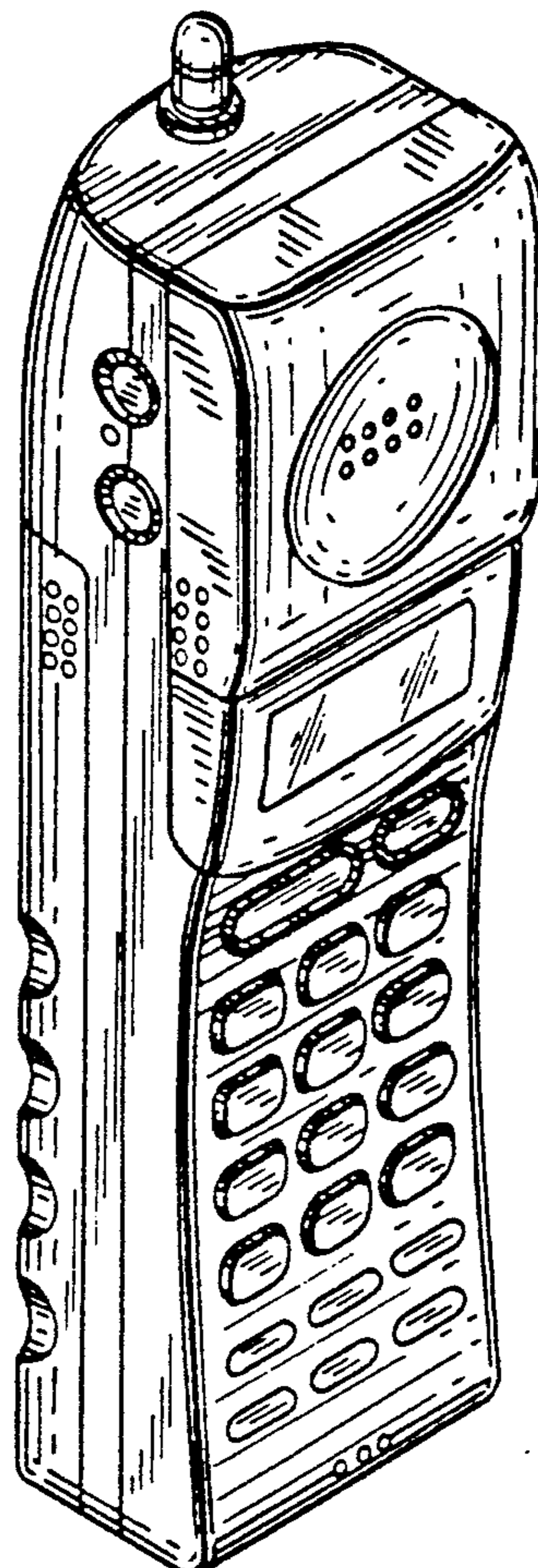

The ornamental design for a cordless telephone, as shown and described.

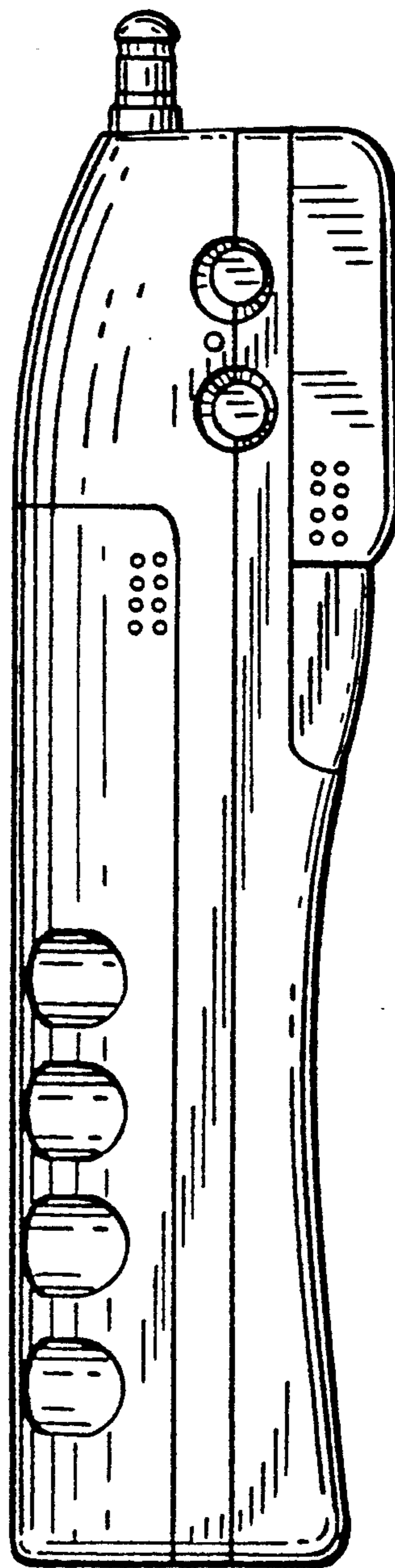
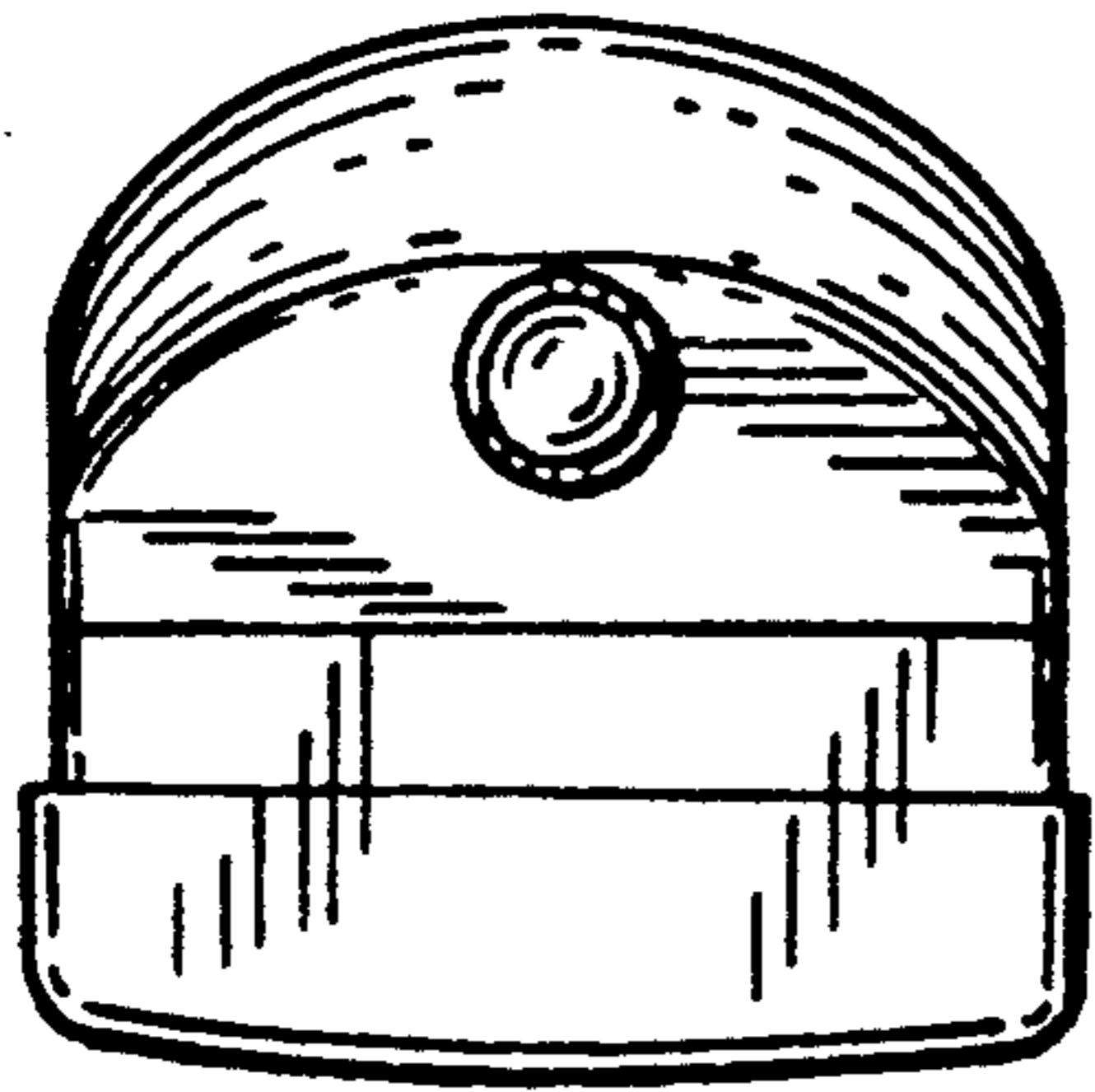
**DESCRIPTION**

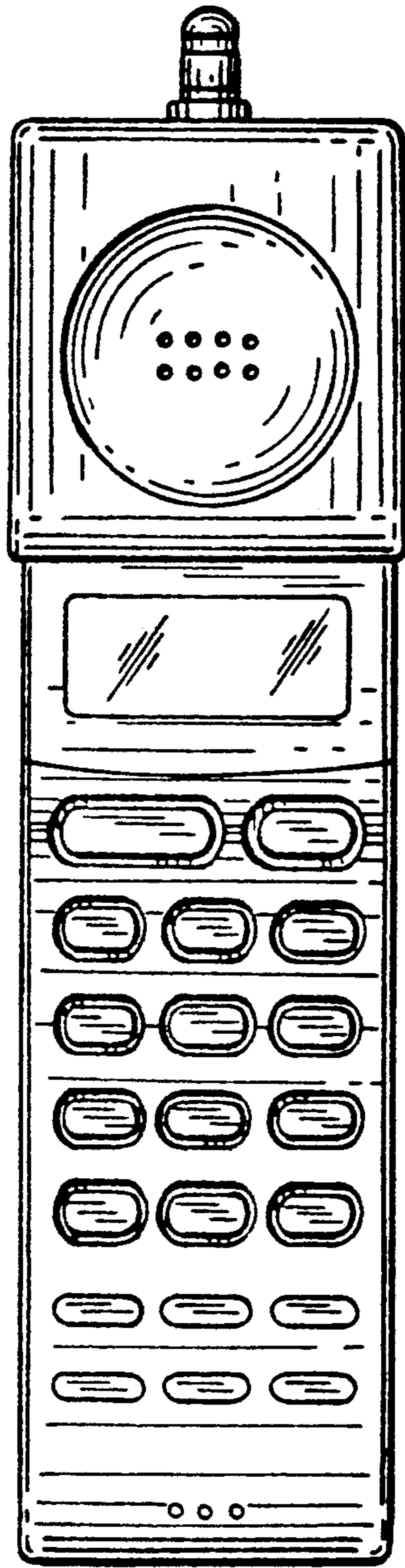

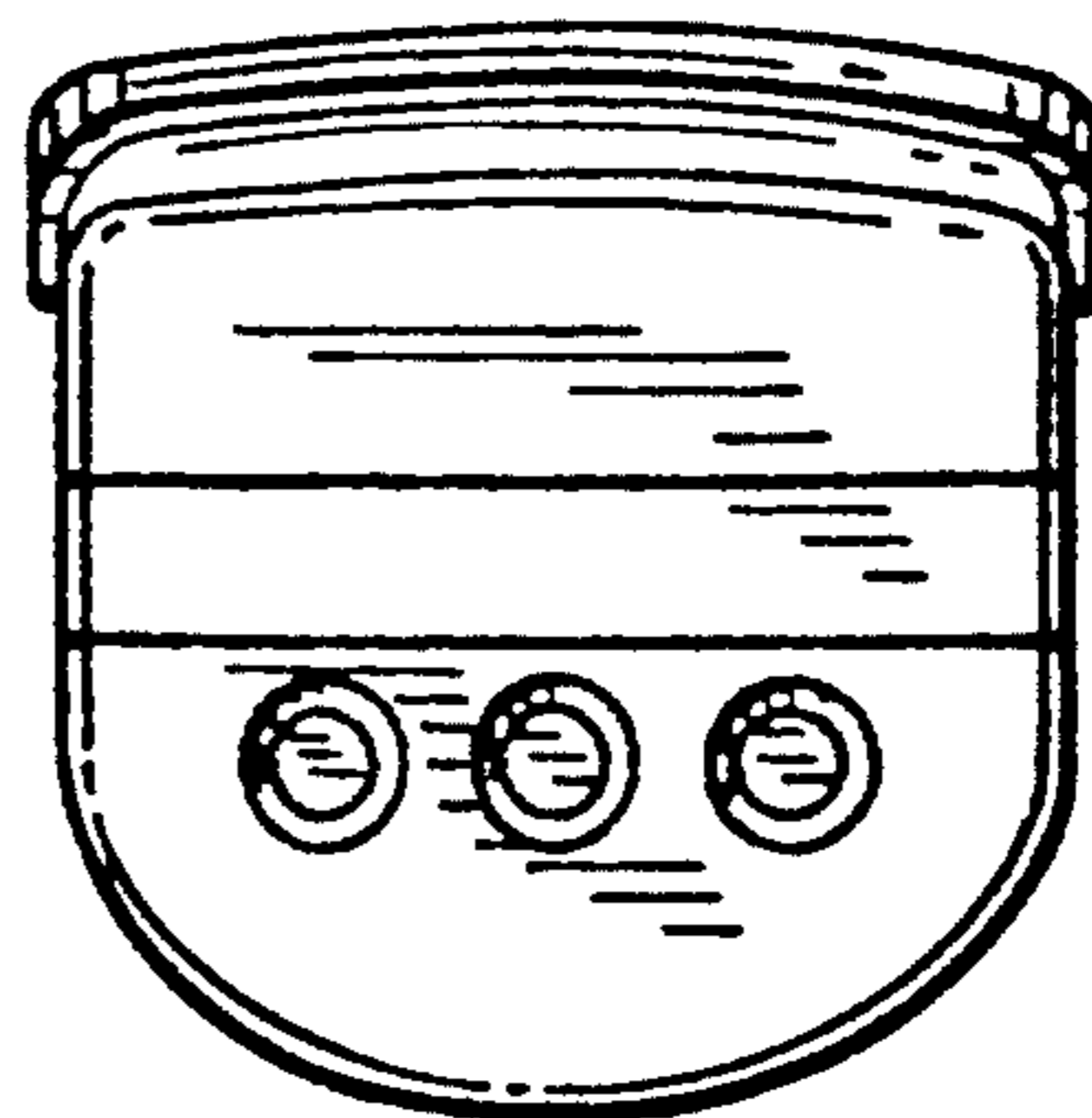
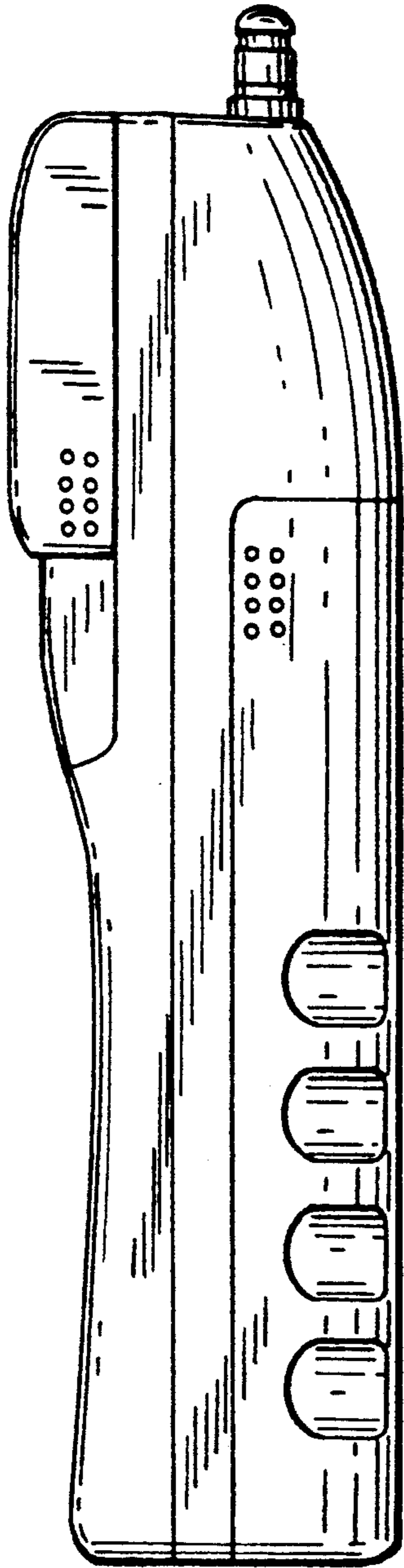
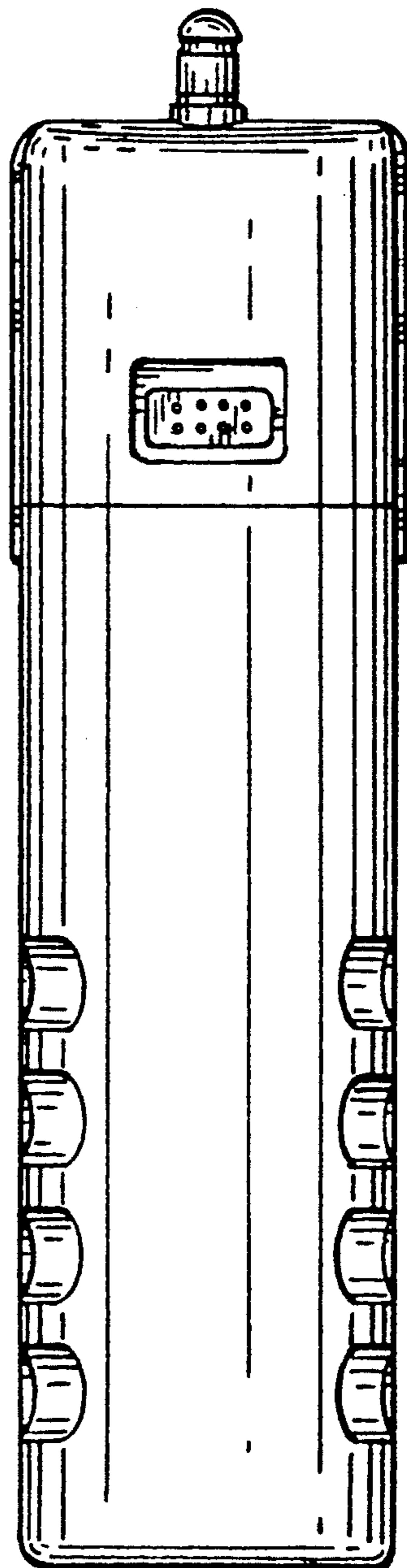

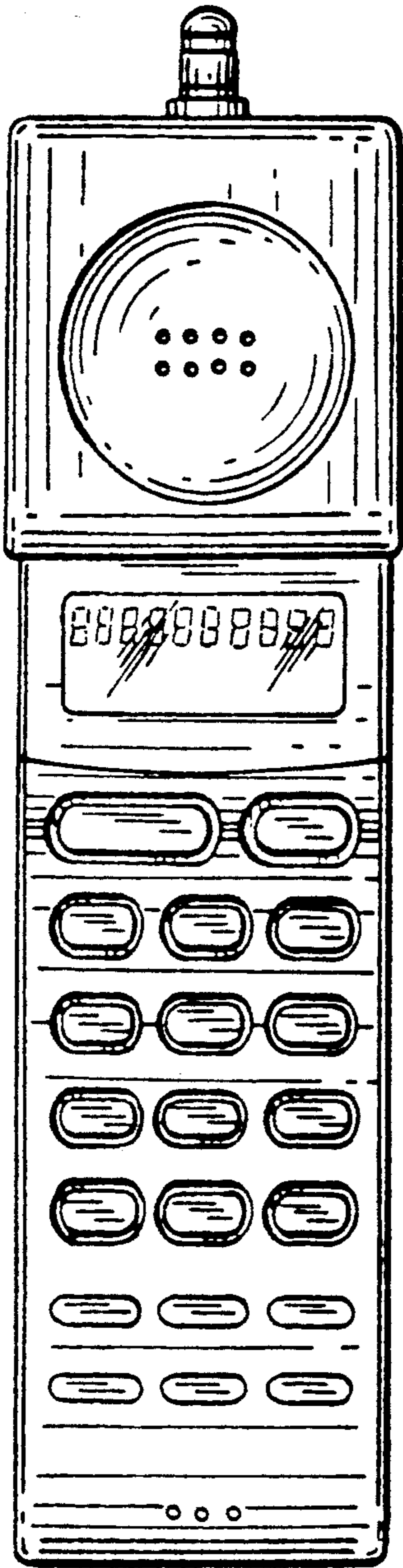

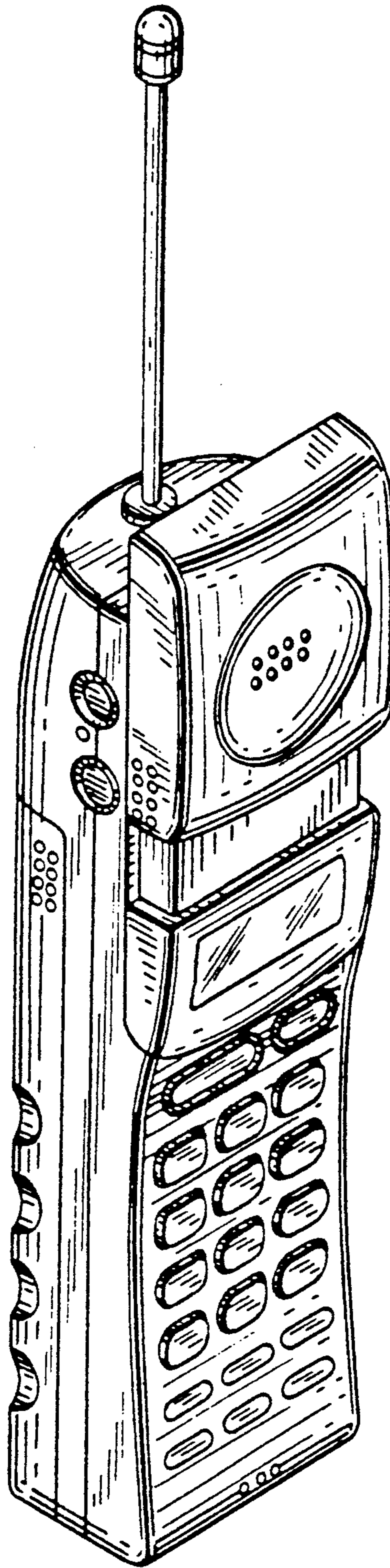
