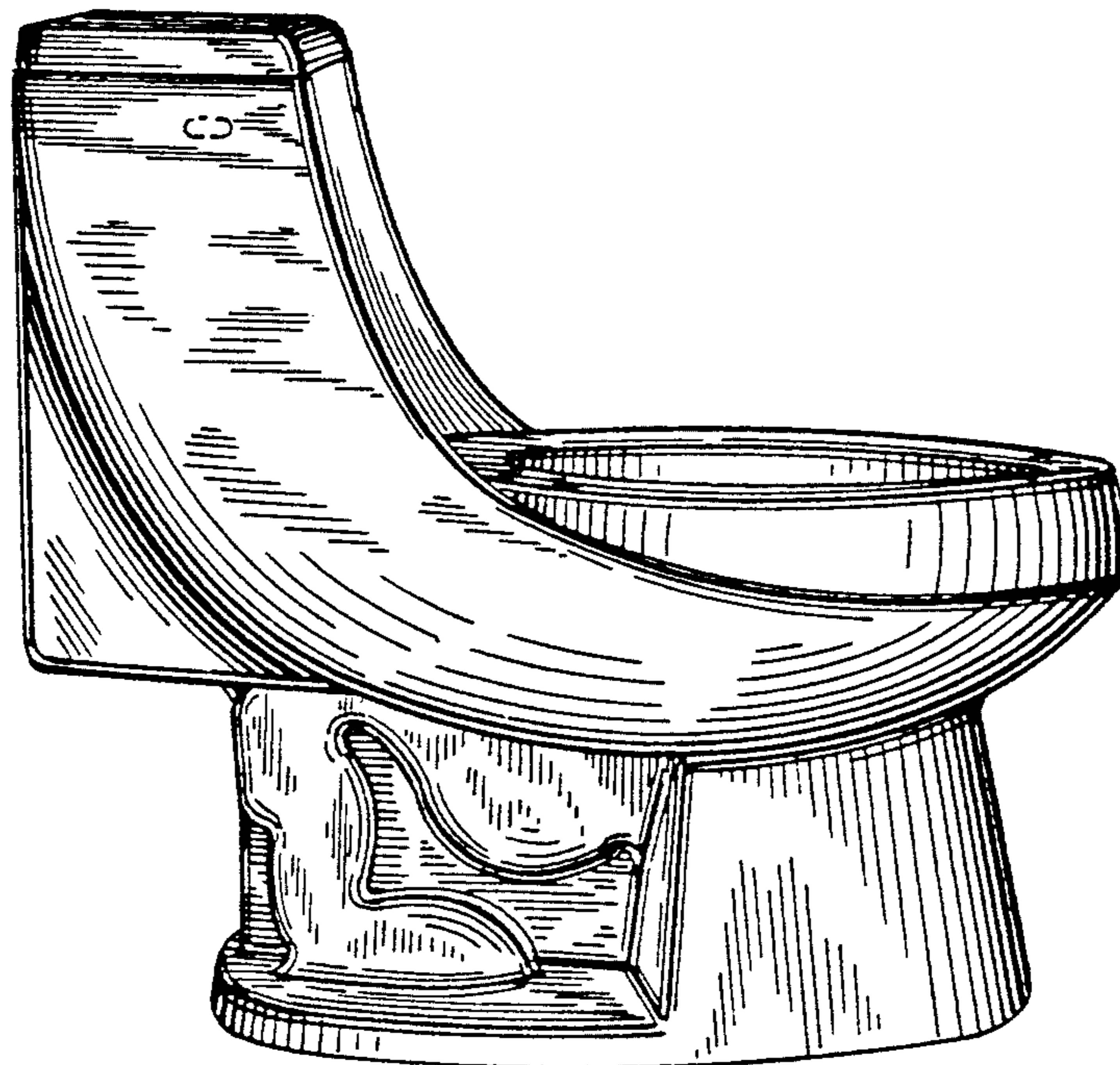

[57] **CLAIM**

The ornamental design for a water closet, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view taken from the top and left side of a water closet showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a rear elevational view thereof; FIG. 6 is a right side elevational view thereof; FIG. 7 is a perspective view taken from the top and left side of a second embodiment thereof; FIG. 8 is a front elevational view of FIG. 7; FIG. 9 is a top plan view of FIG. 7; FIG. 10 is a left side elevational view of FIG. 7; FIG. 11 is a rear elevational view of FIG. 7; and, FIG. 12 is a right side elevational view of FIG. 7. The fragmentary broken line representations of holes in FIGS. 1-4 and 7-10 are for the purpose of illustration only and form no part of the claimed design.



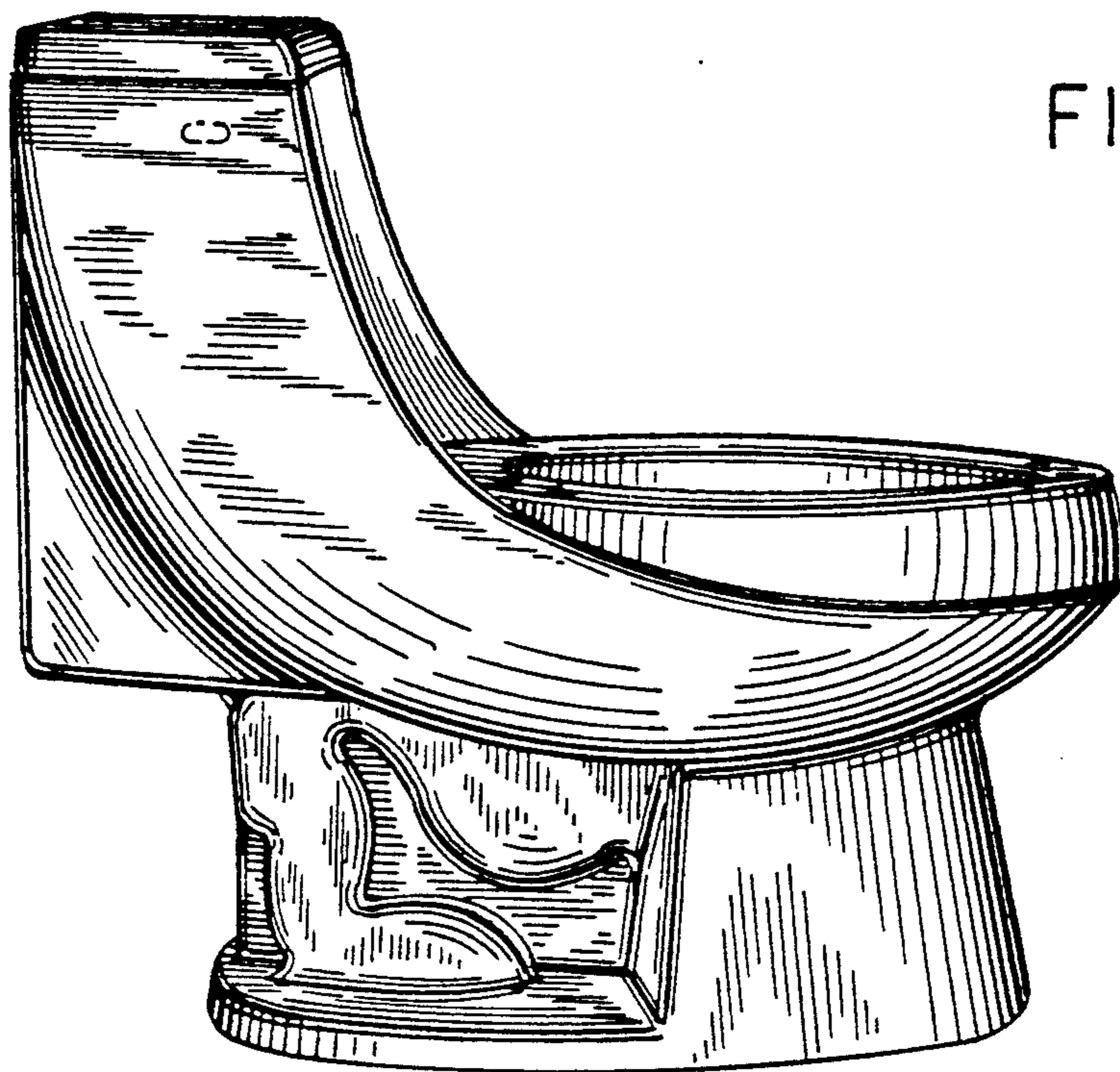

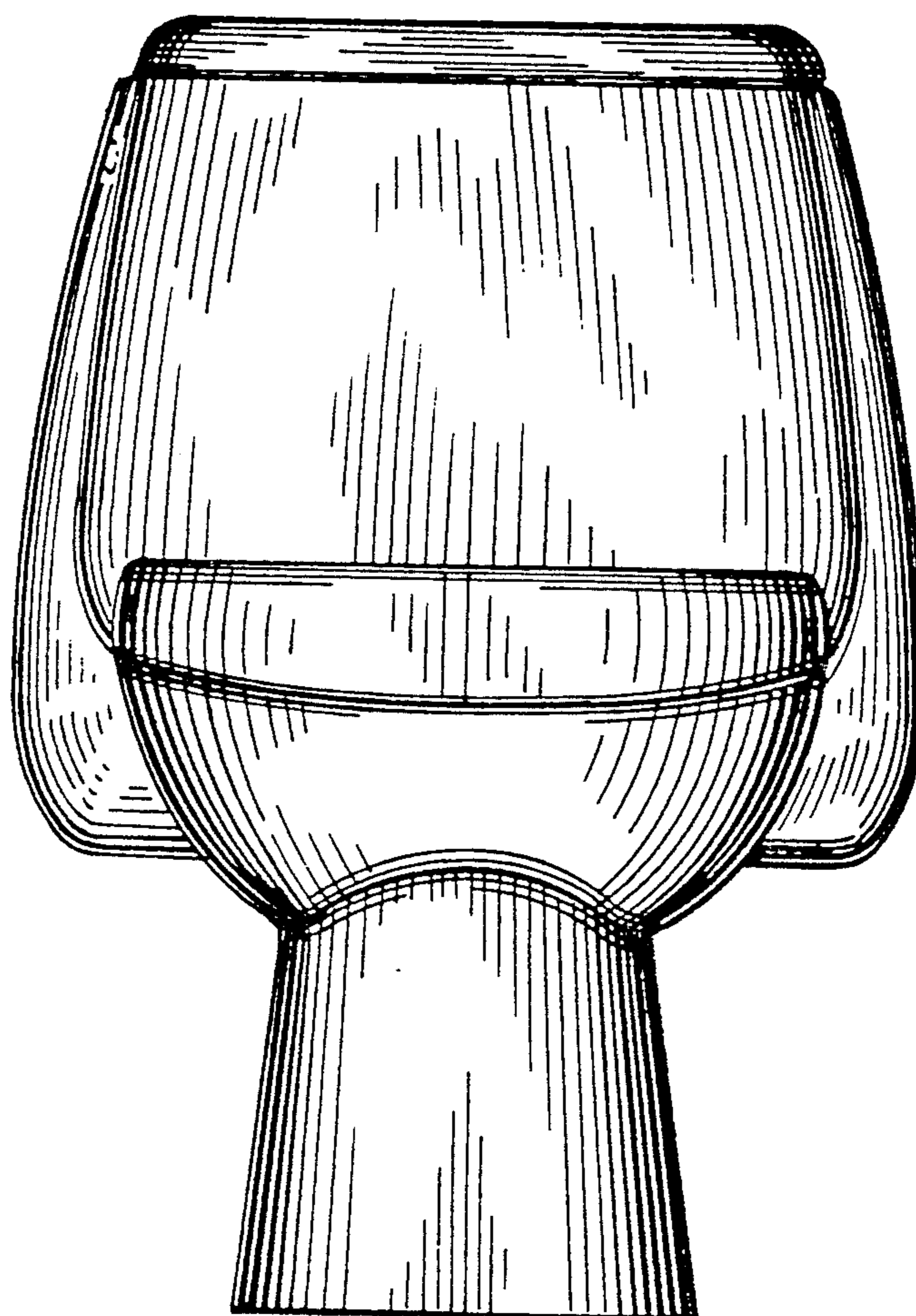

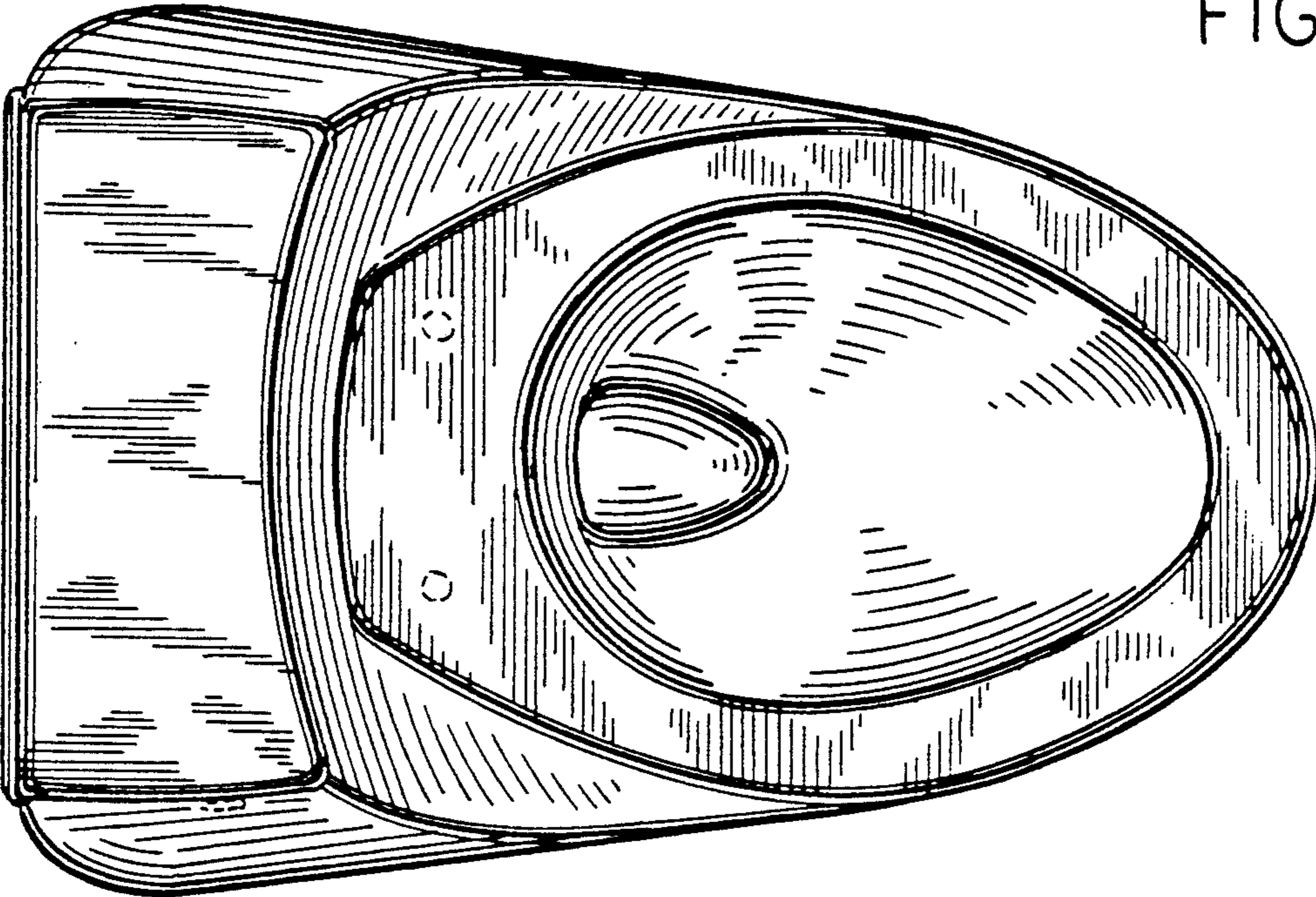
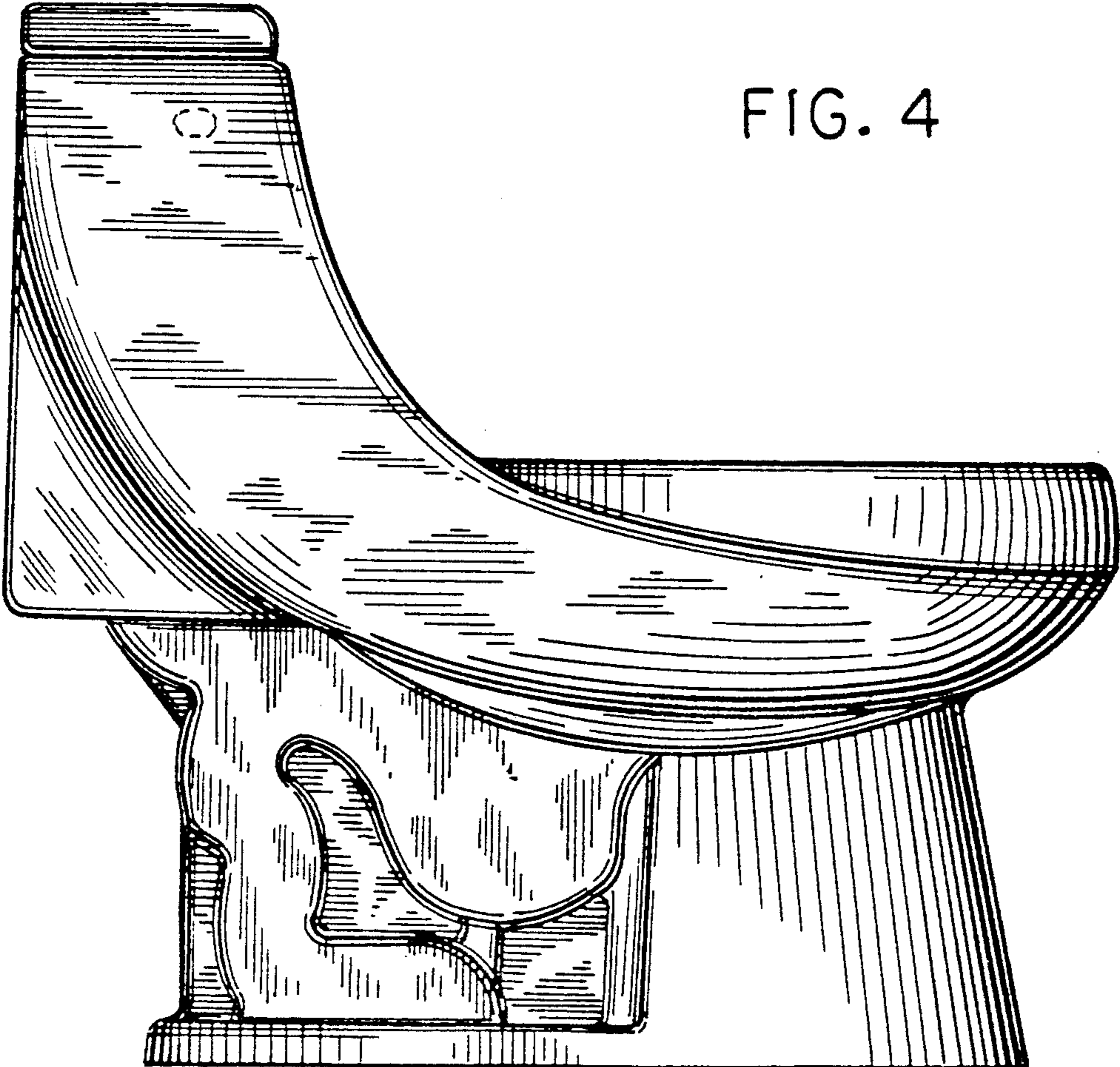

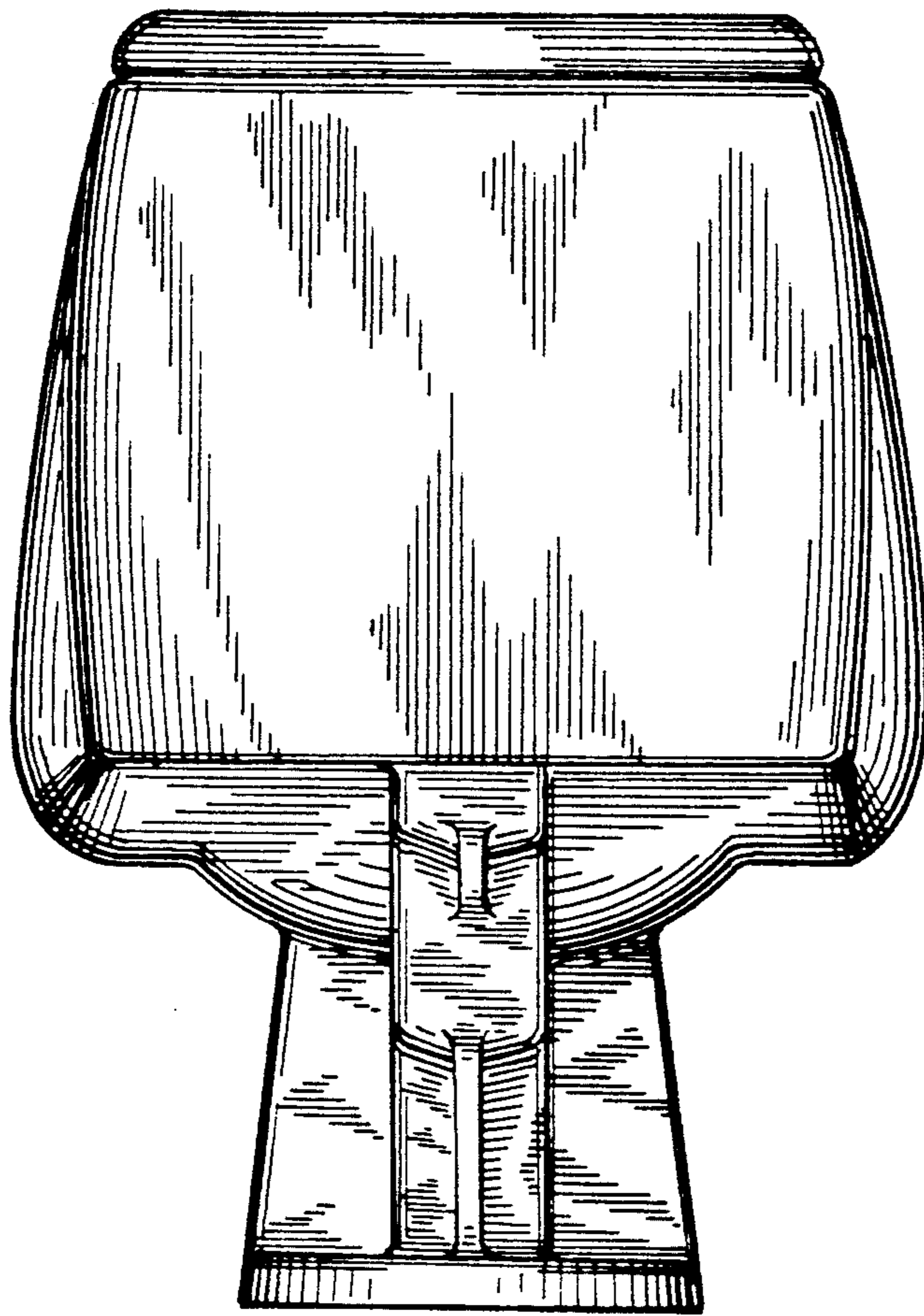

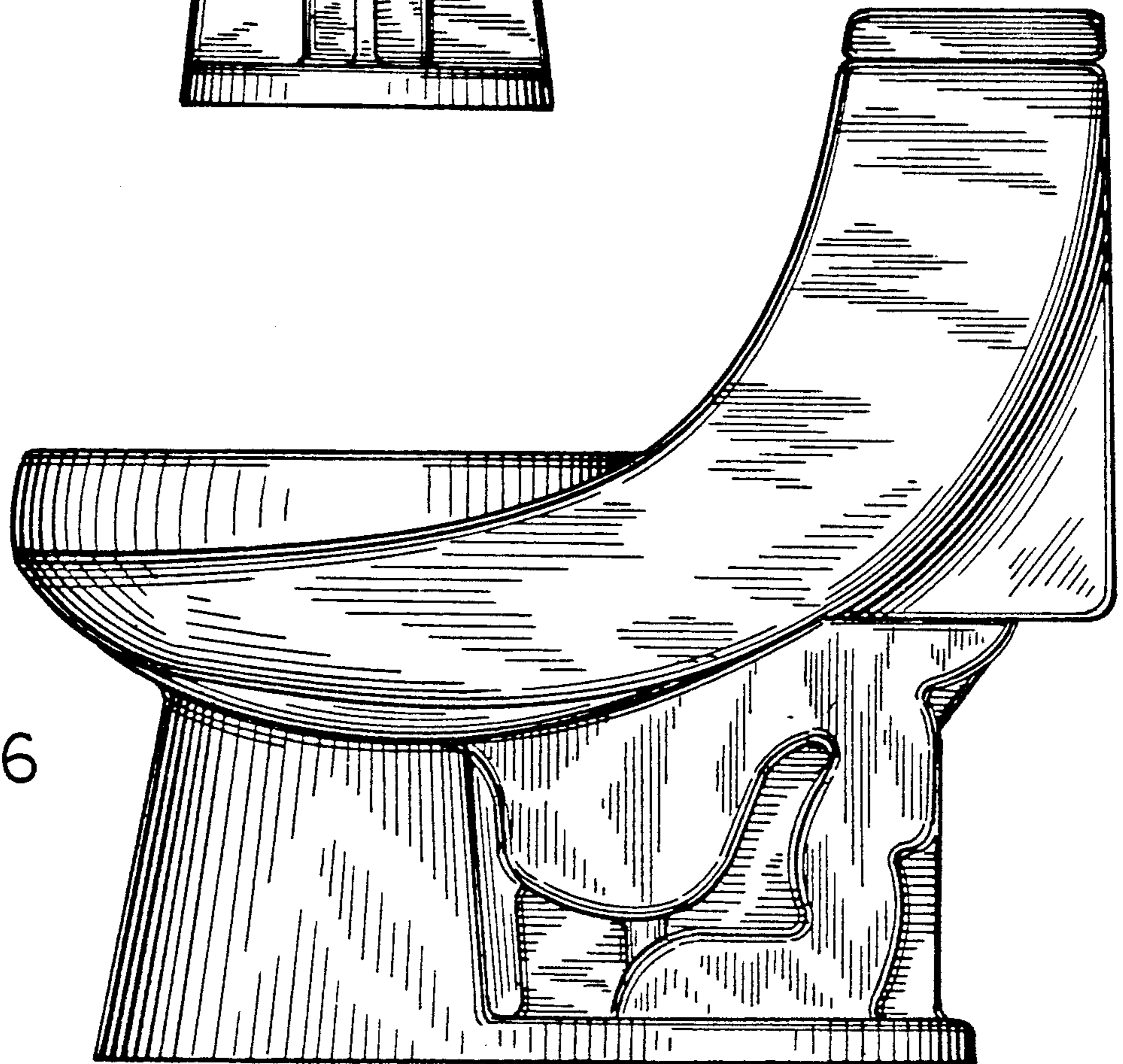

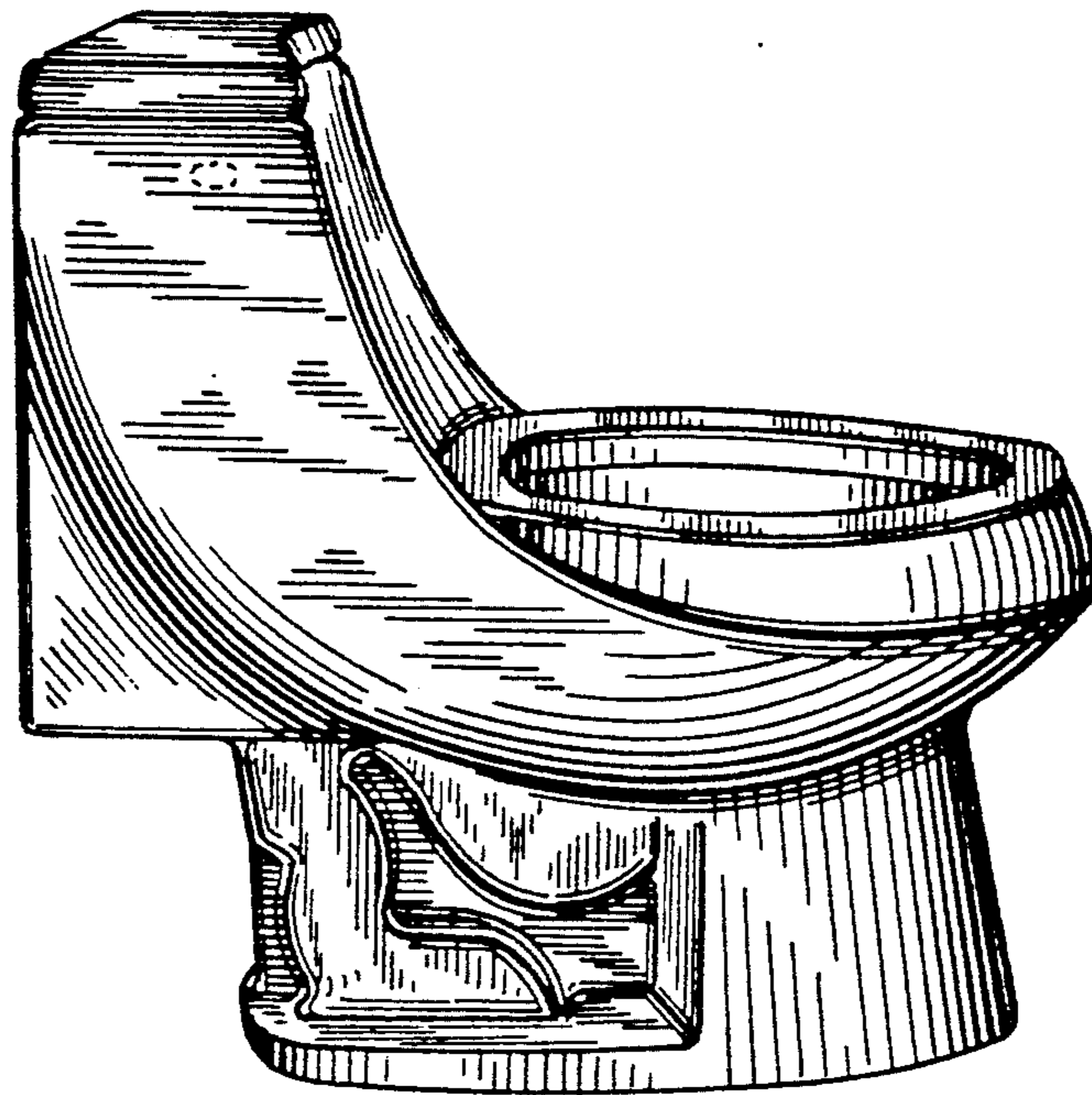

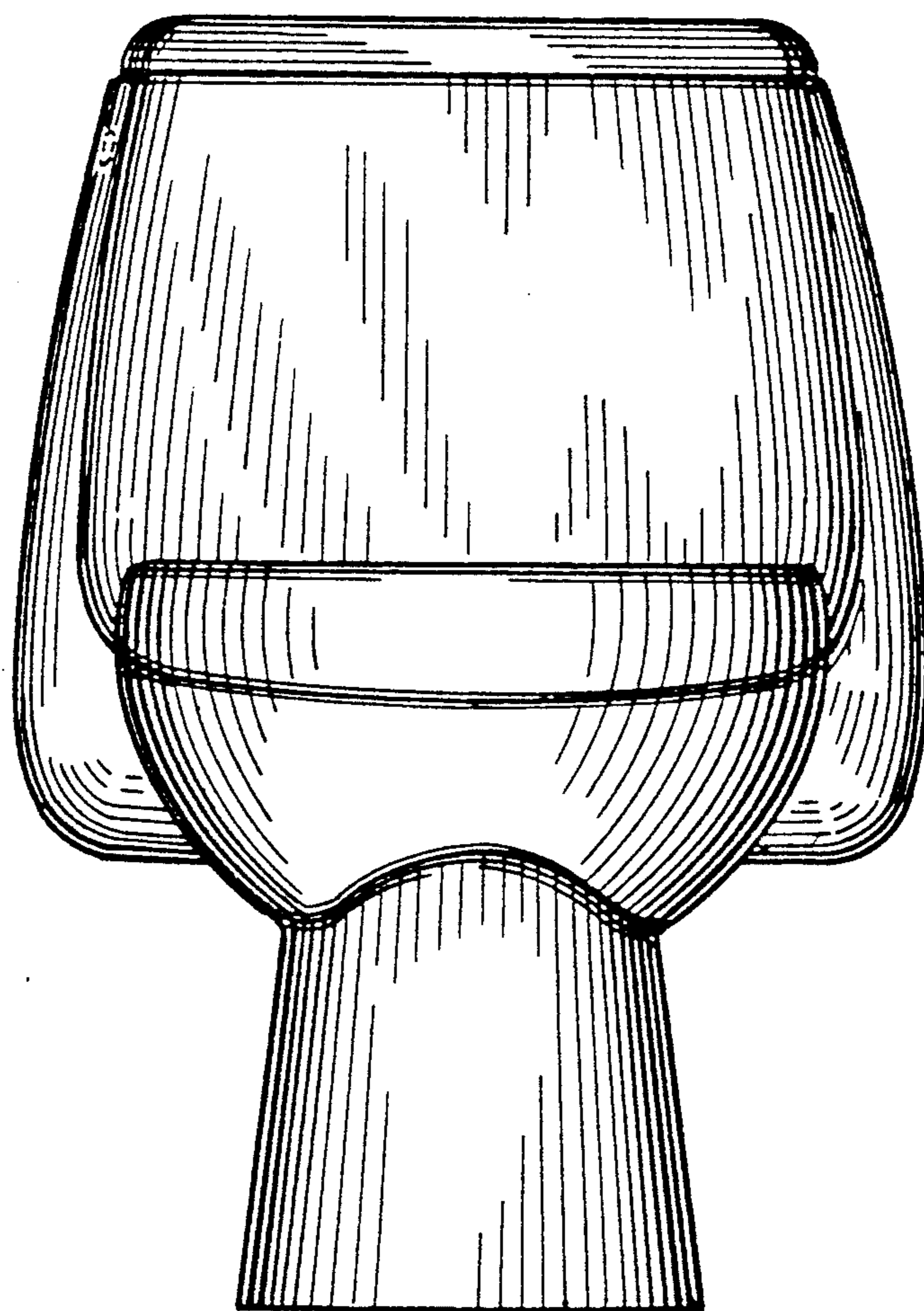

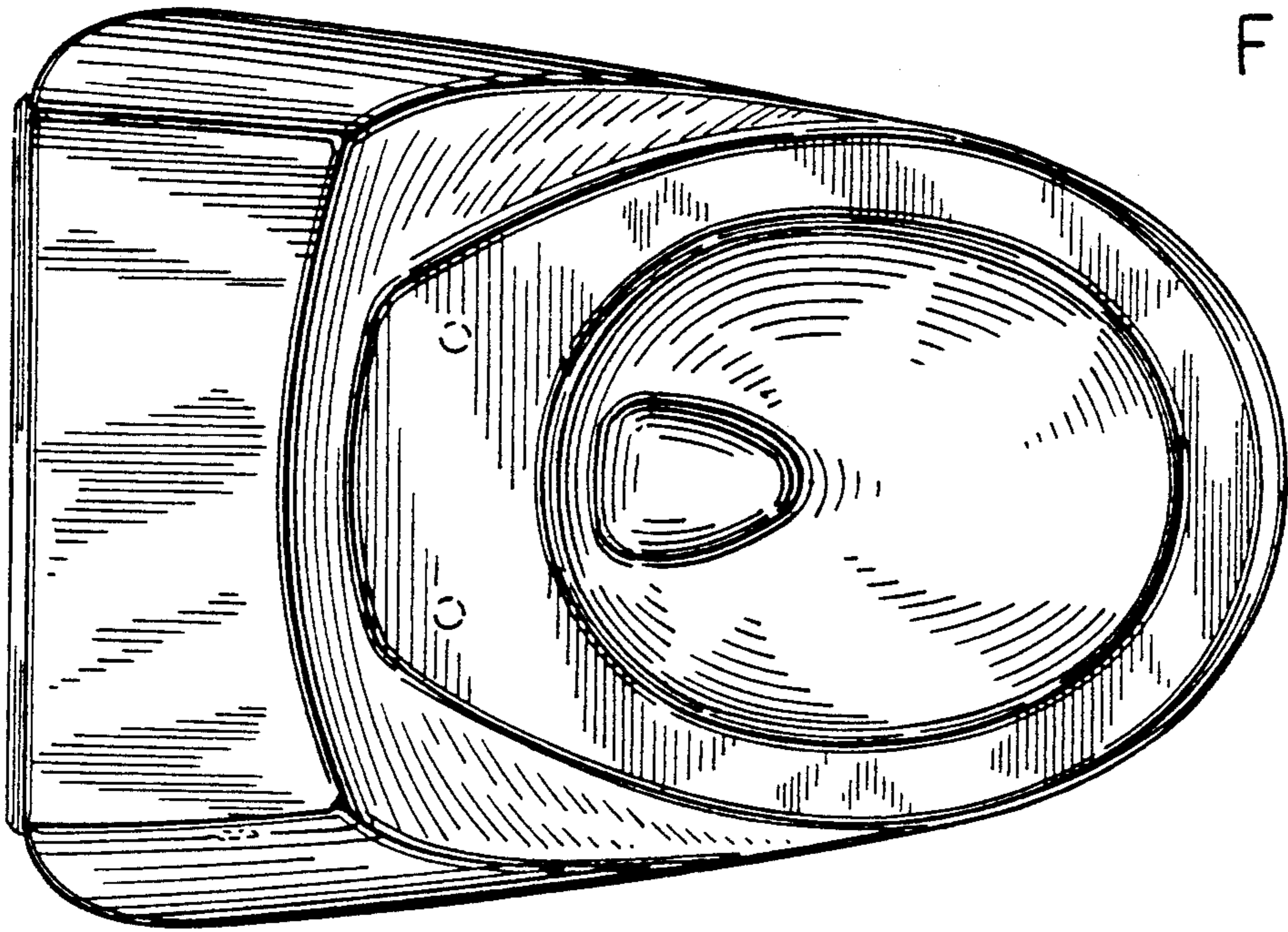
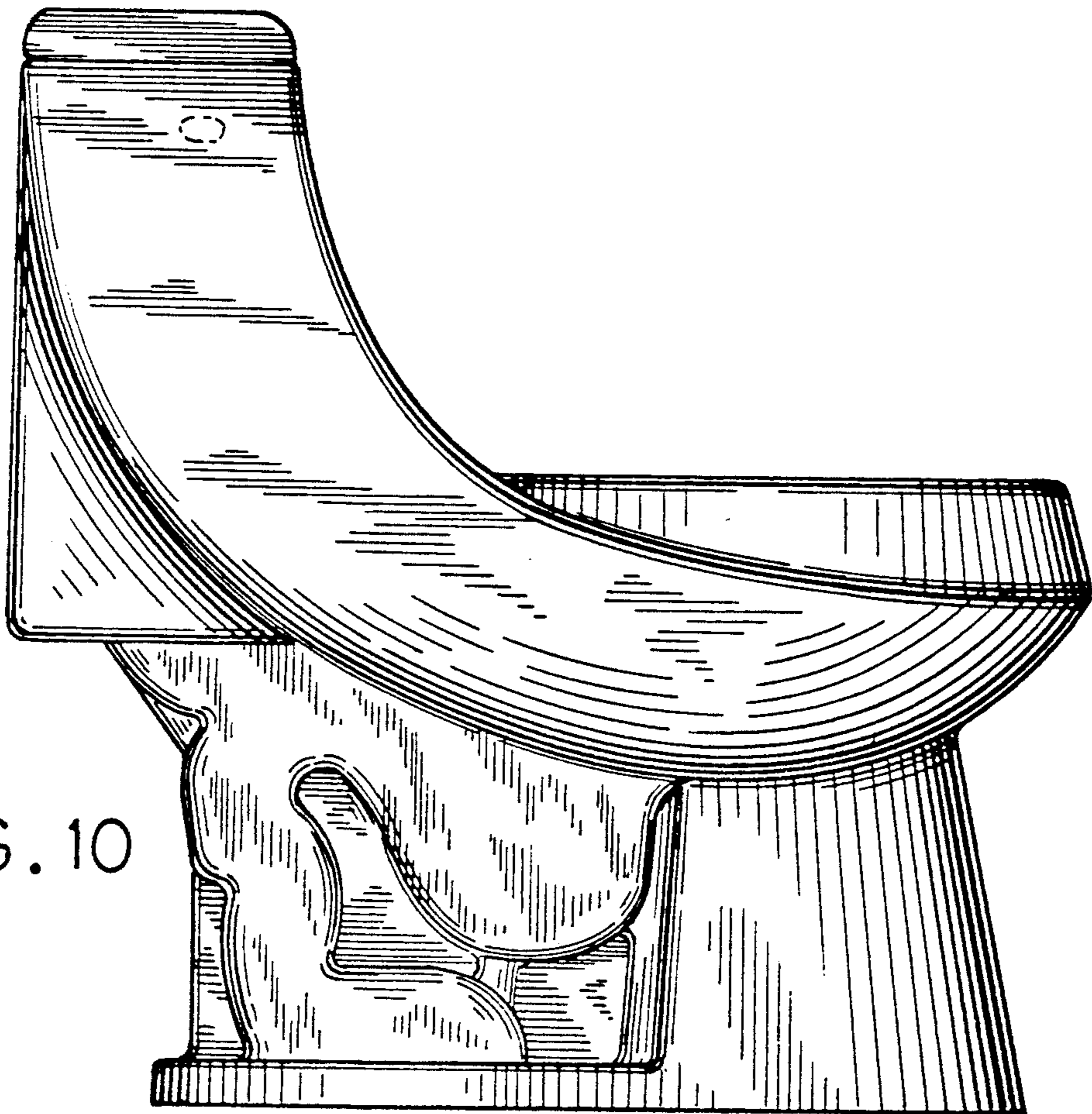

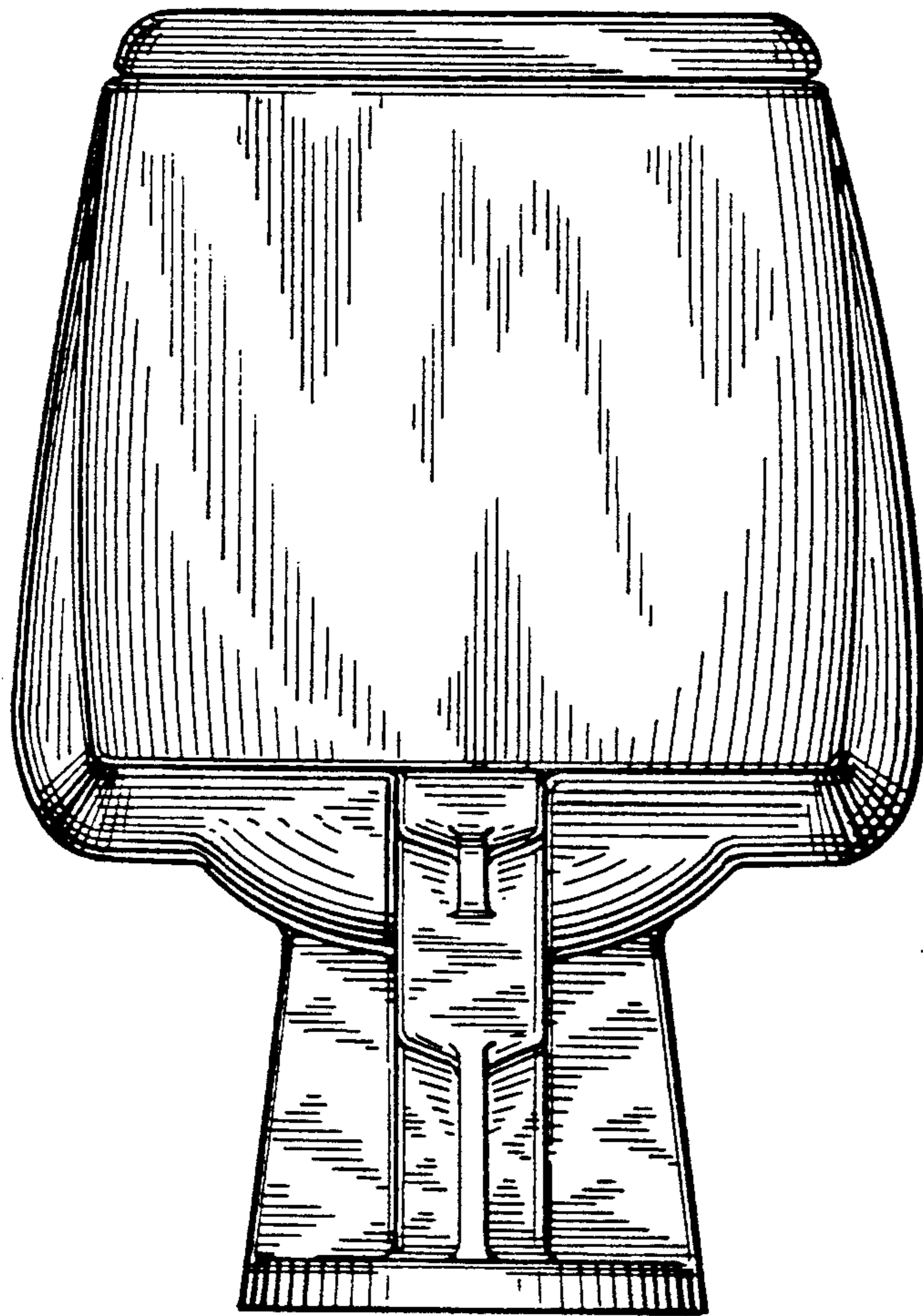

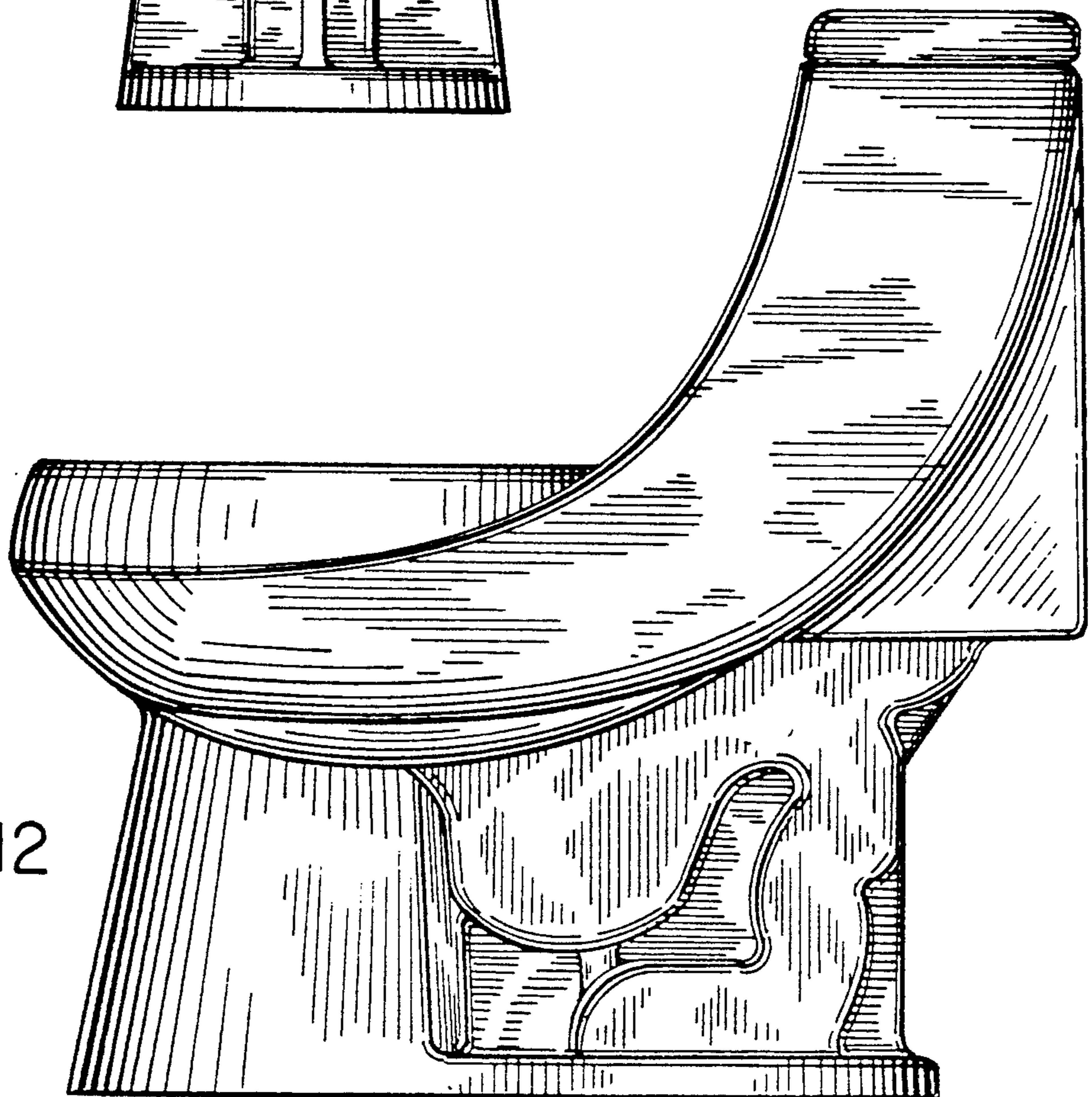
