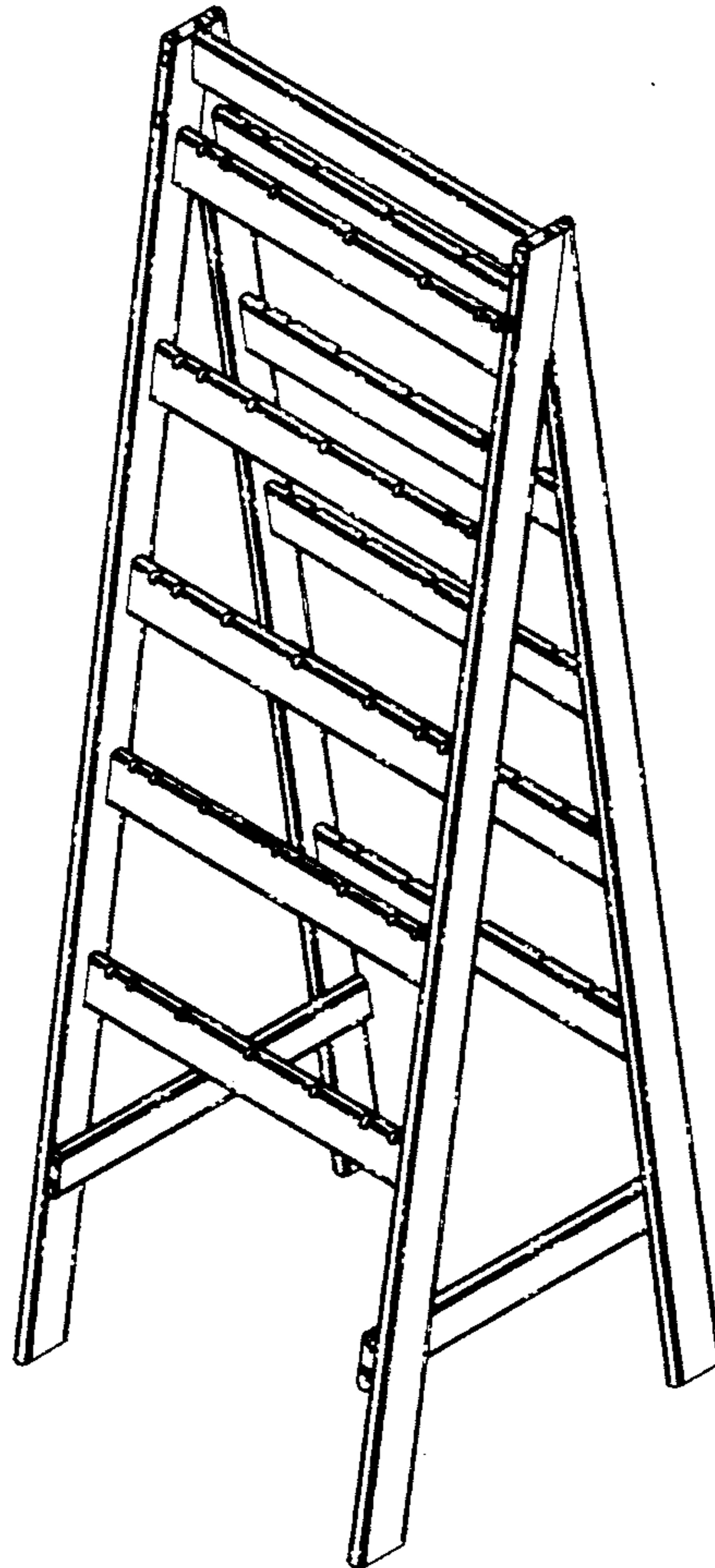
[57] **CLAIM**

The ornamental design for a display rack, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view taken from above and to the side, of a display rack showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a side elevational view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; and, FIG. 6 is a cross-sectional view taken with line 6—6 of FIG. 2.

The broken line showing of hooks are for illustrative purposes only.



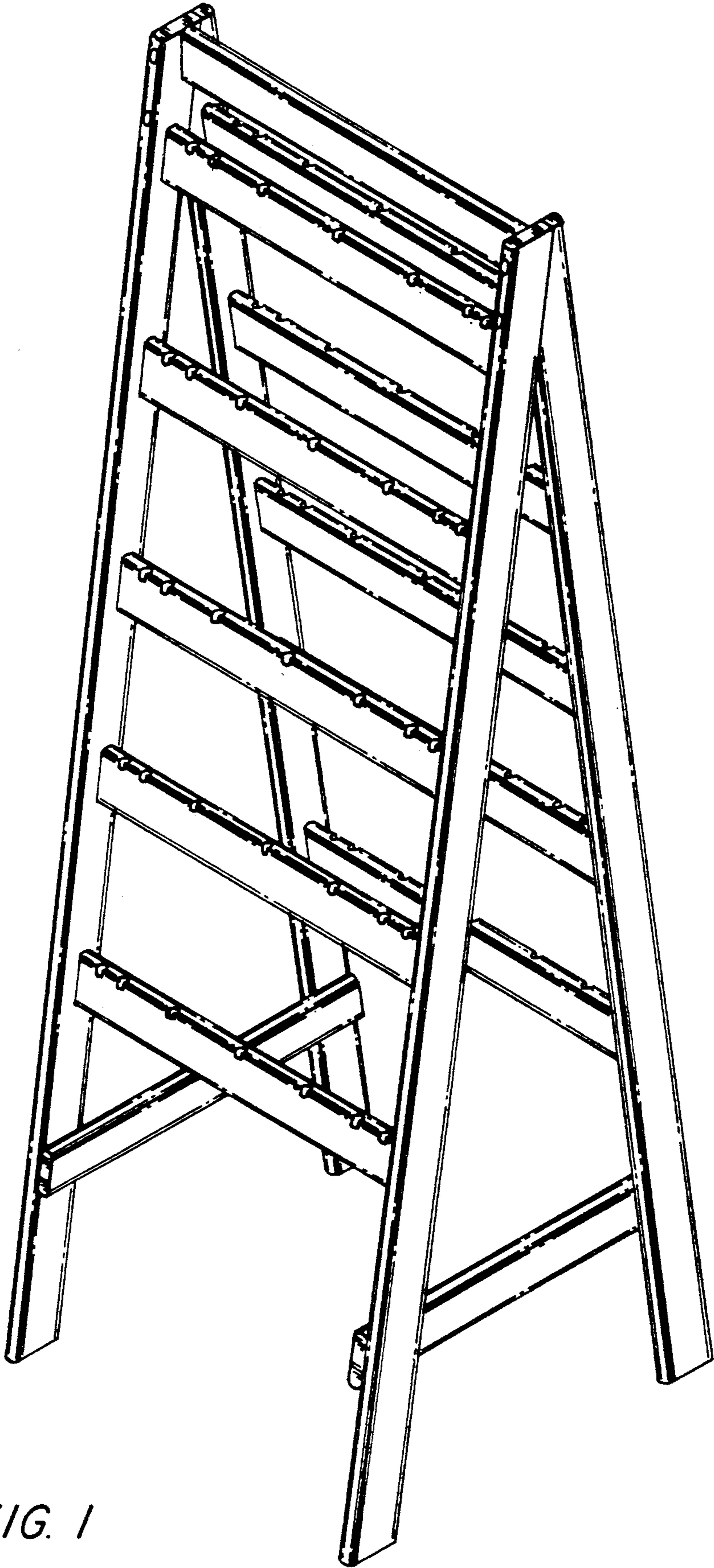

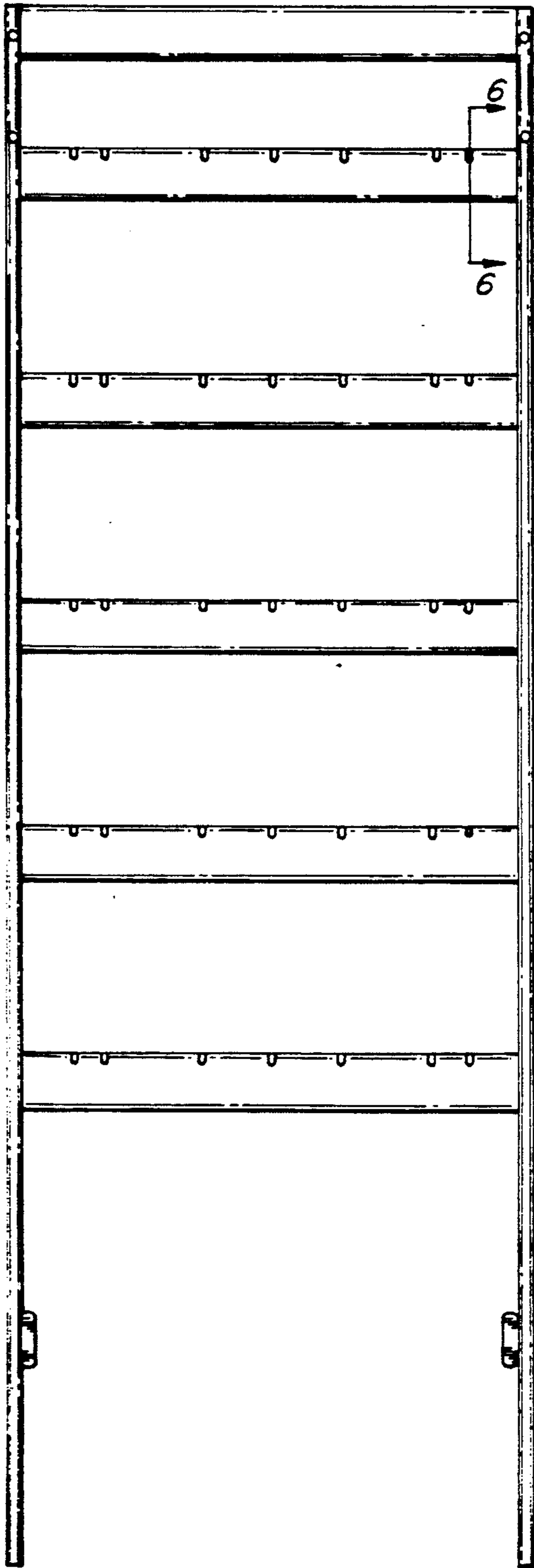

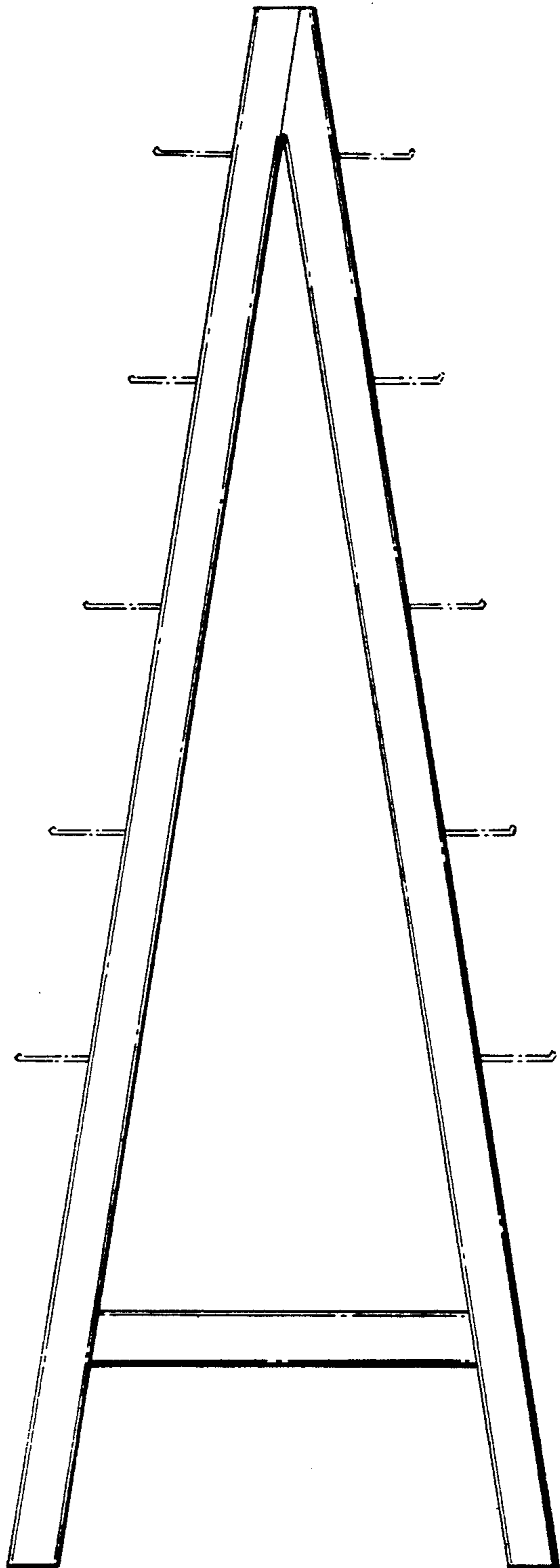

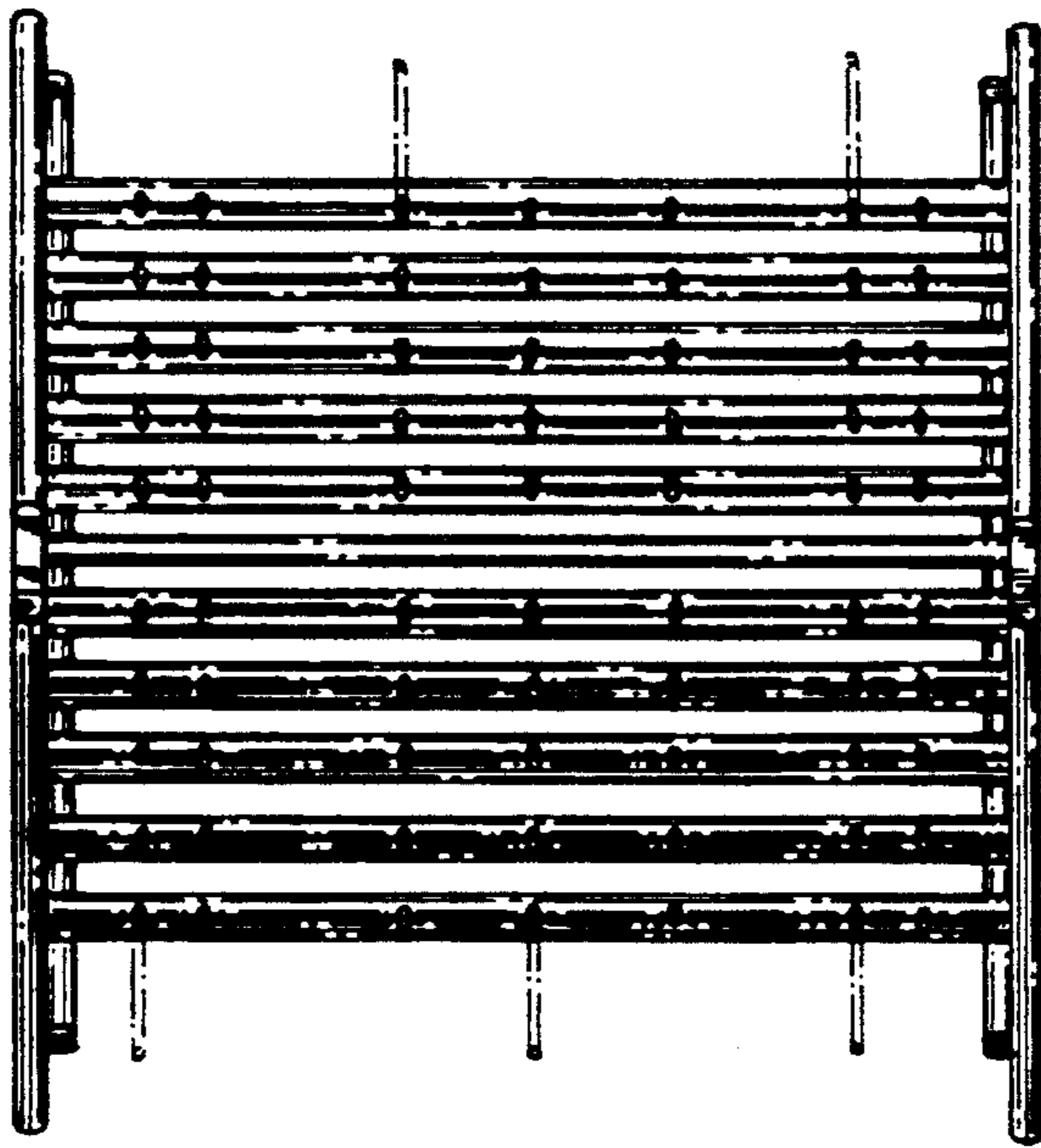

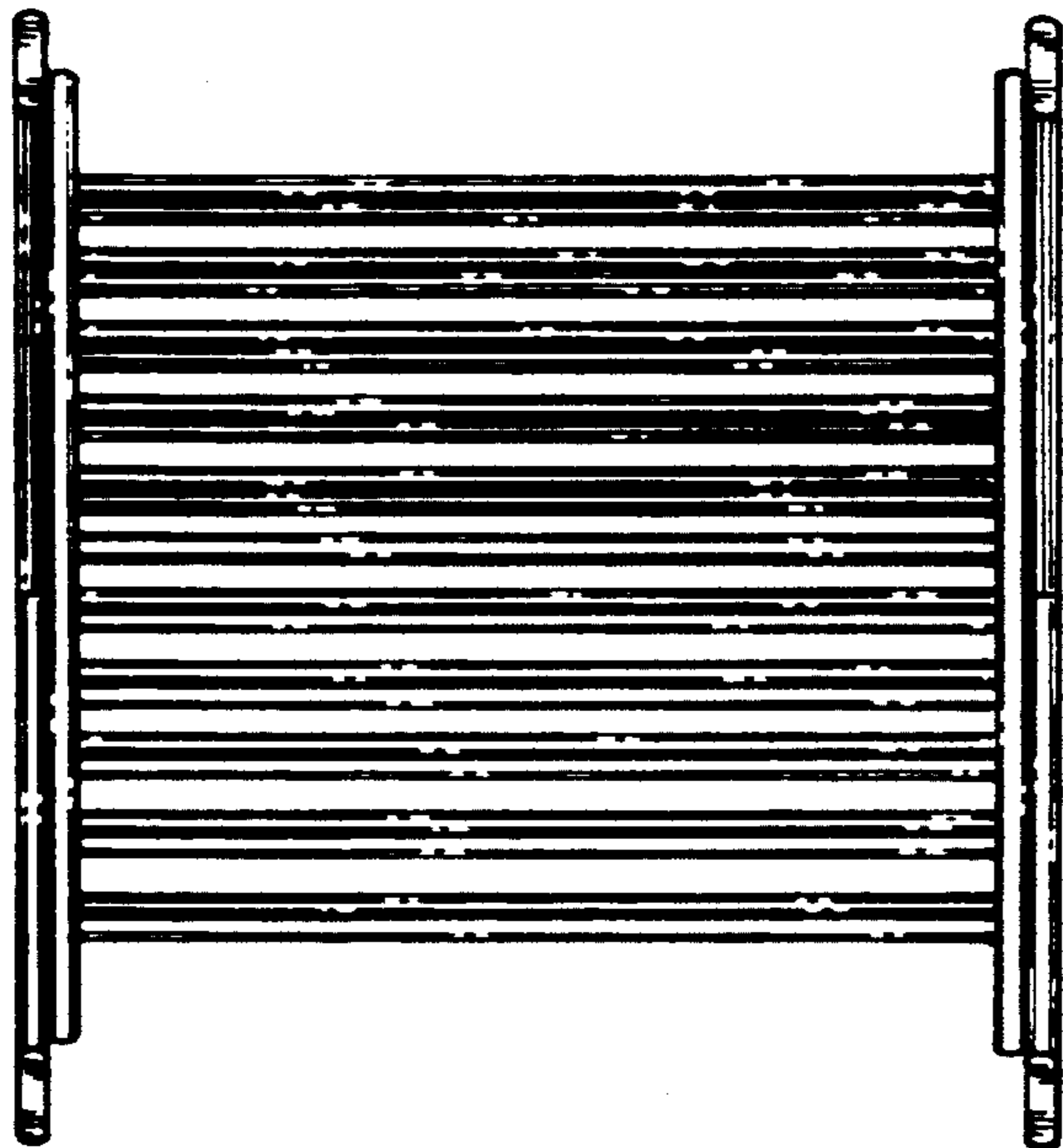

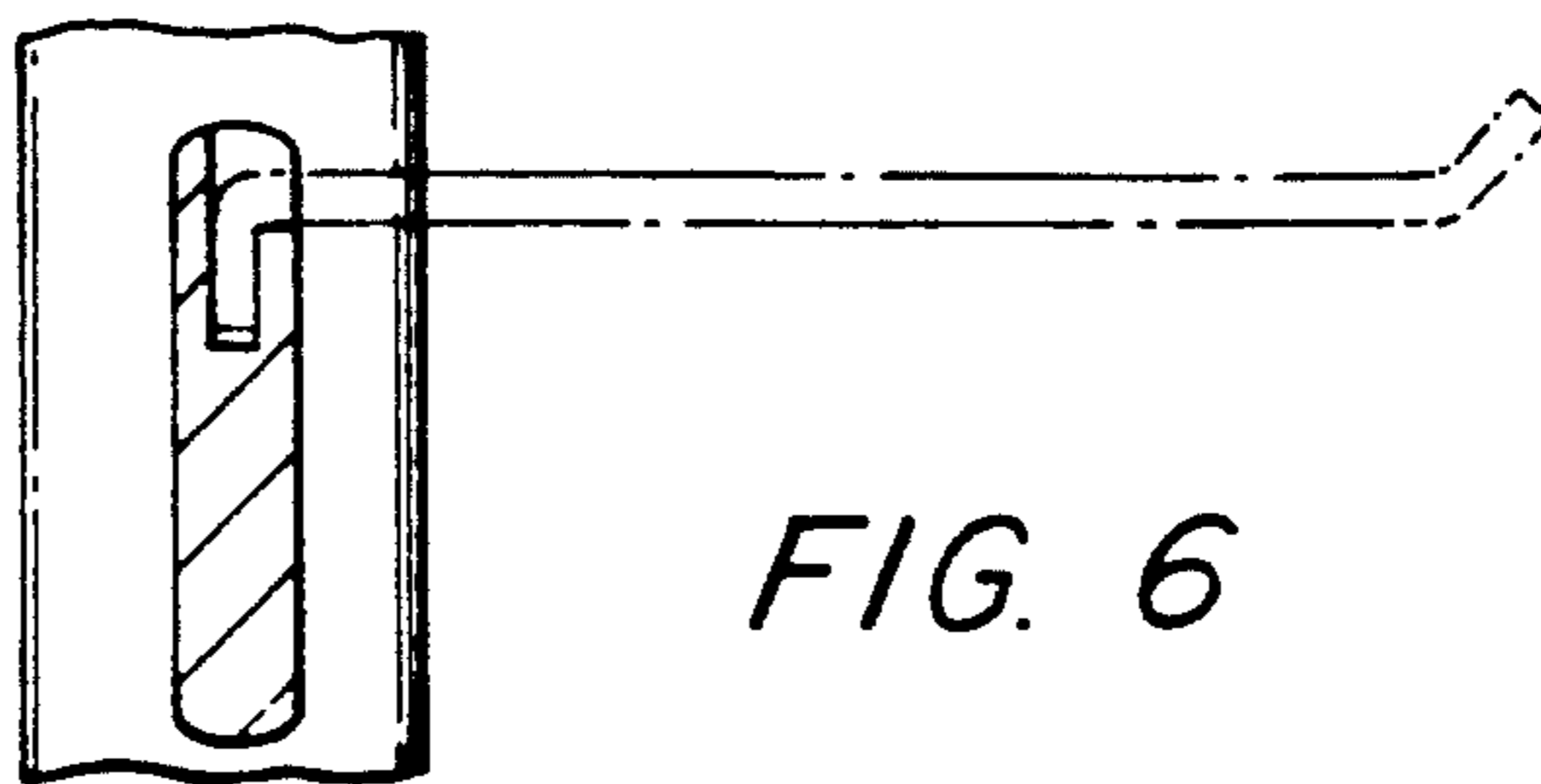
