[57] CLAIM

The ornamental design for a tape cartridge for tape writing machine, as shown and described.

DESCRIPTION

FIG. 1 is a front, bottom and left side perspective view of a tape cartridge for tape writing machine showing our new design;

FIG. 2 is a rear, bottom and left side perspective view thereof;

FIG. 3 is a front view thereof;

FIG. 4 is a right side elevational view thereof;

FIG. 5 is a rear view thereof;

FIG. 6 is a left side elevational view thereof;

FIG. 7 is a top plan view thereof;

FIG. 8 is a bottom plan view thereof;

FIG. 9 is a sectional view thereof taken on the line 9—9 of FIG. 3;

FIG. 10 is a sectional view thereof taken on the line 10—10 of FIG. 3;

FIG. 11 is a sectional view thereof taken on the line 11—11 of FIG. 3; and,

FIG. 12 is a sectional view thereof taken on the line 12—12 of FIG. 3.

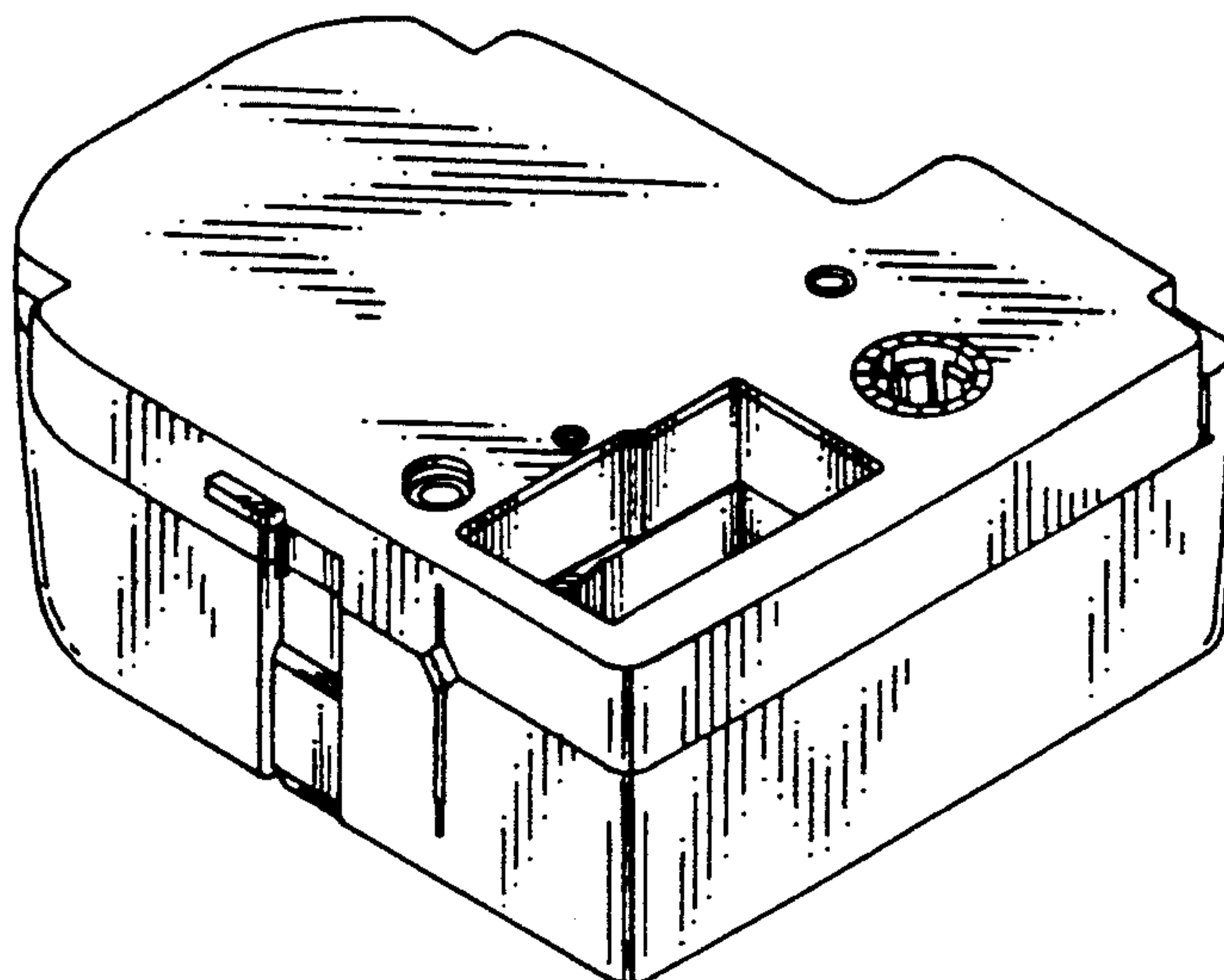

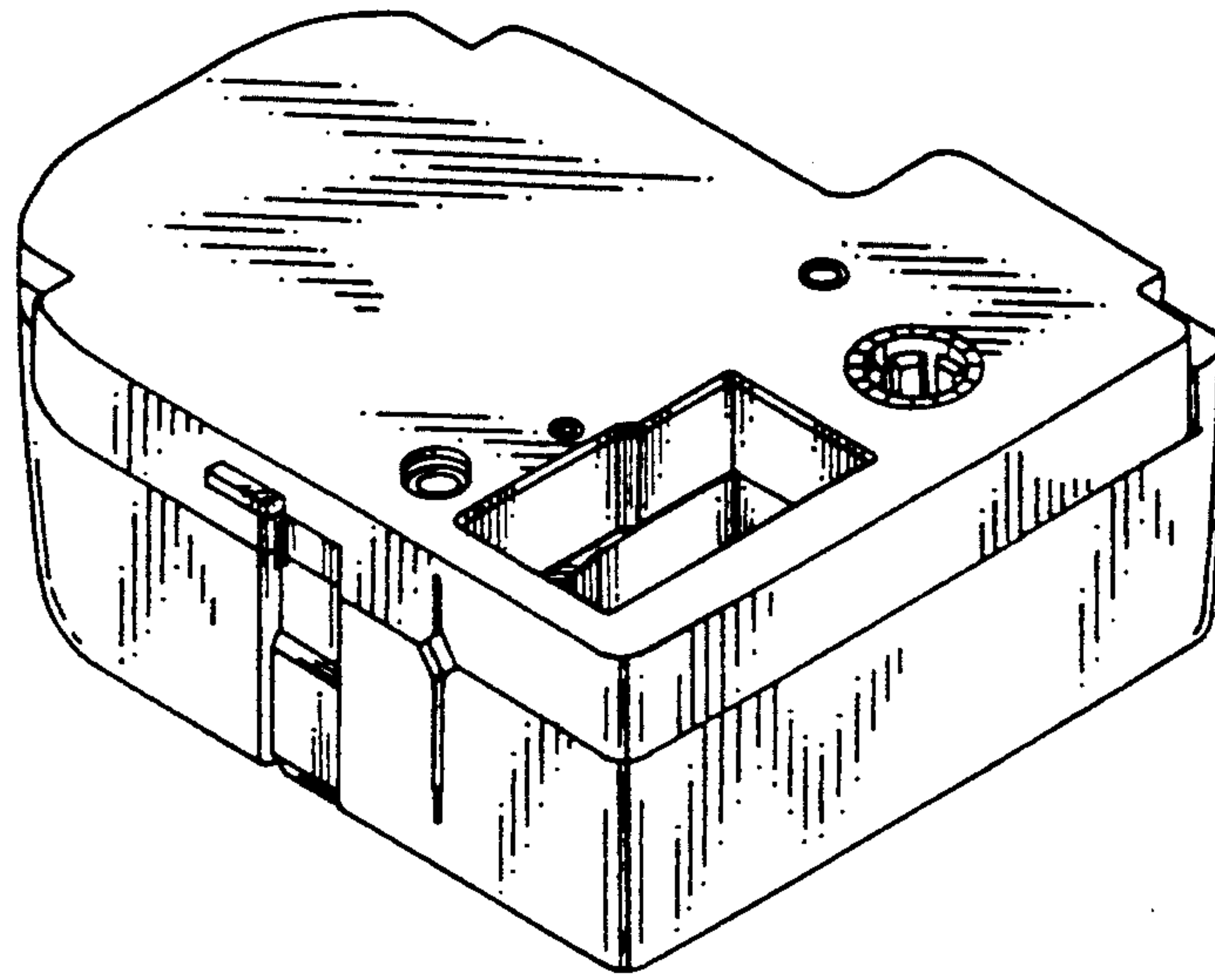

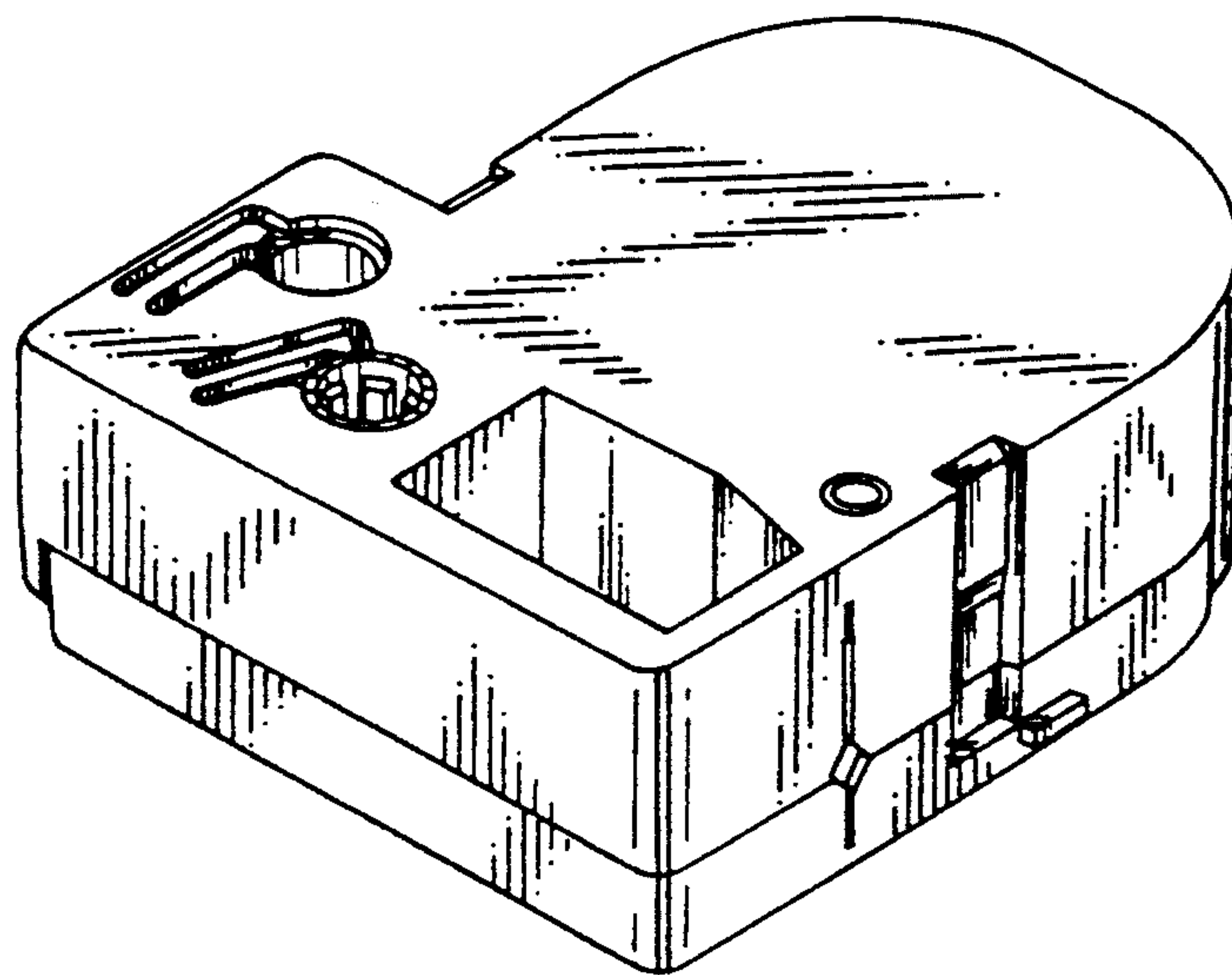

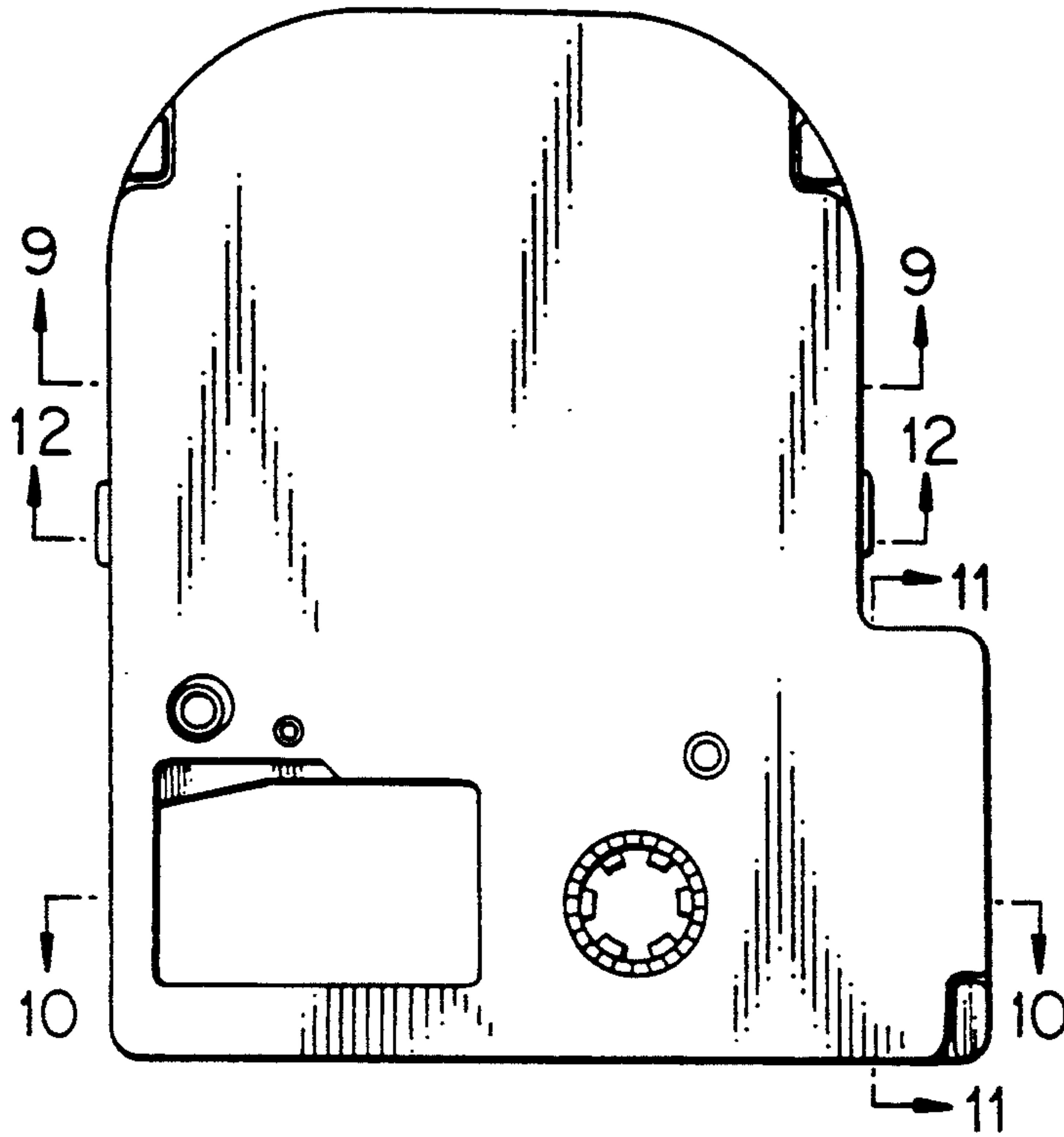

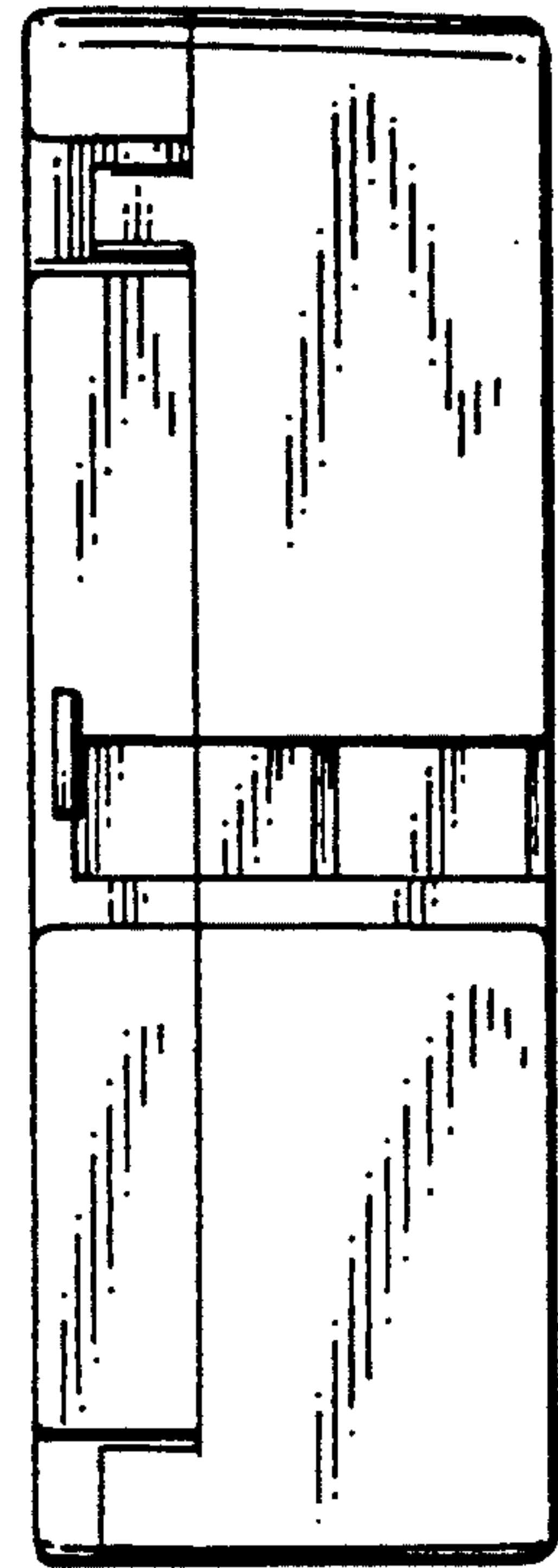

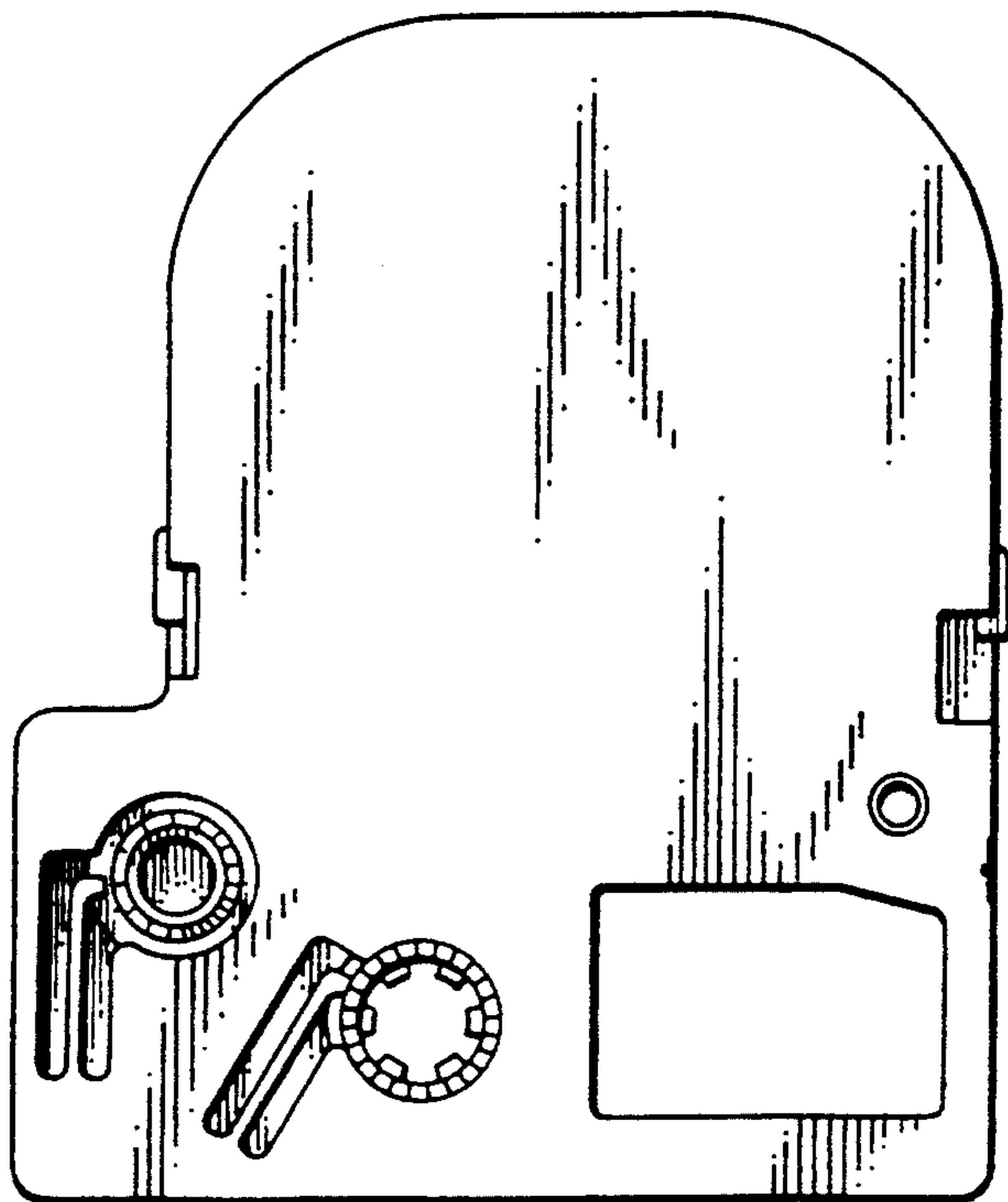

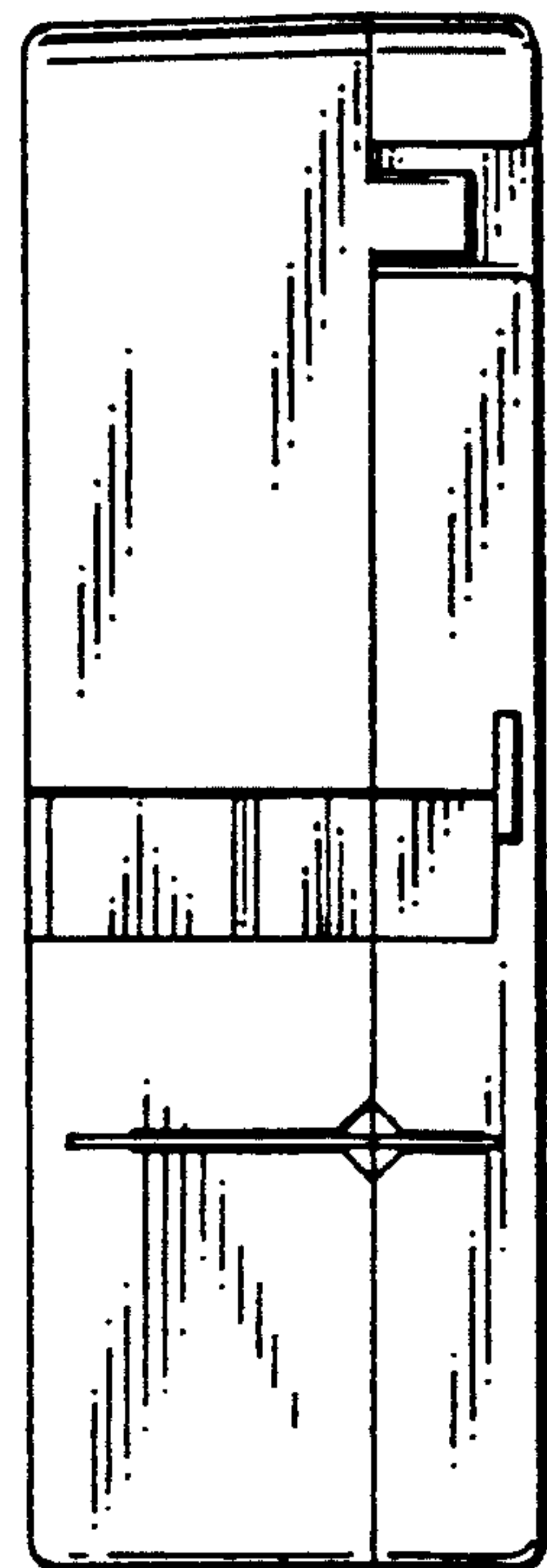

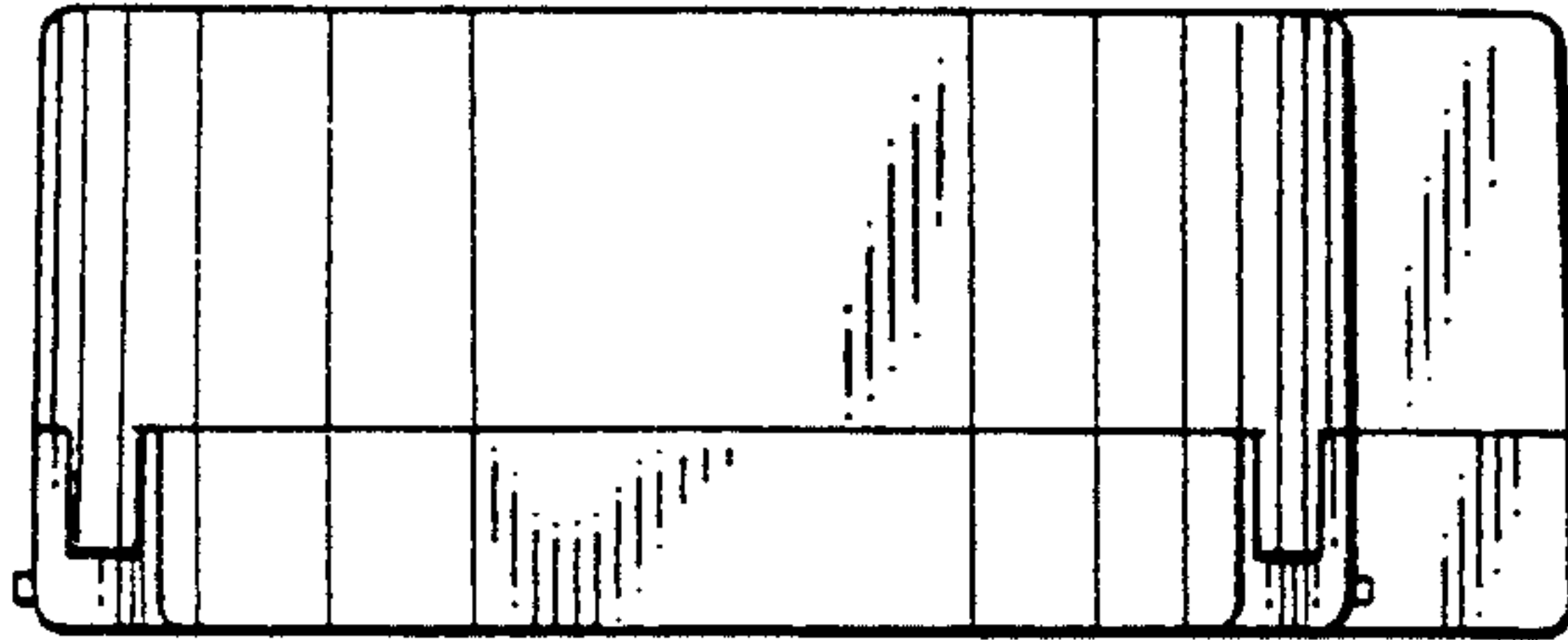

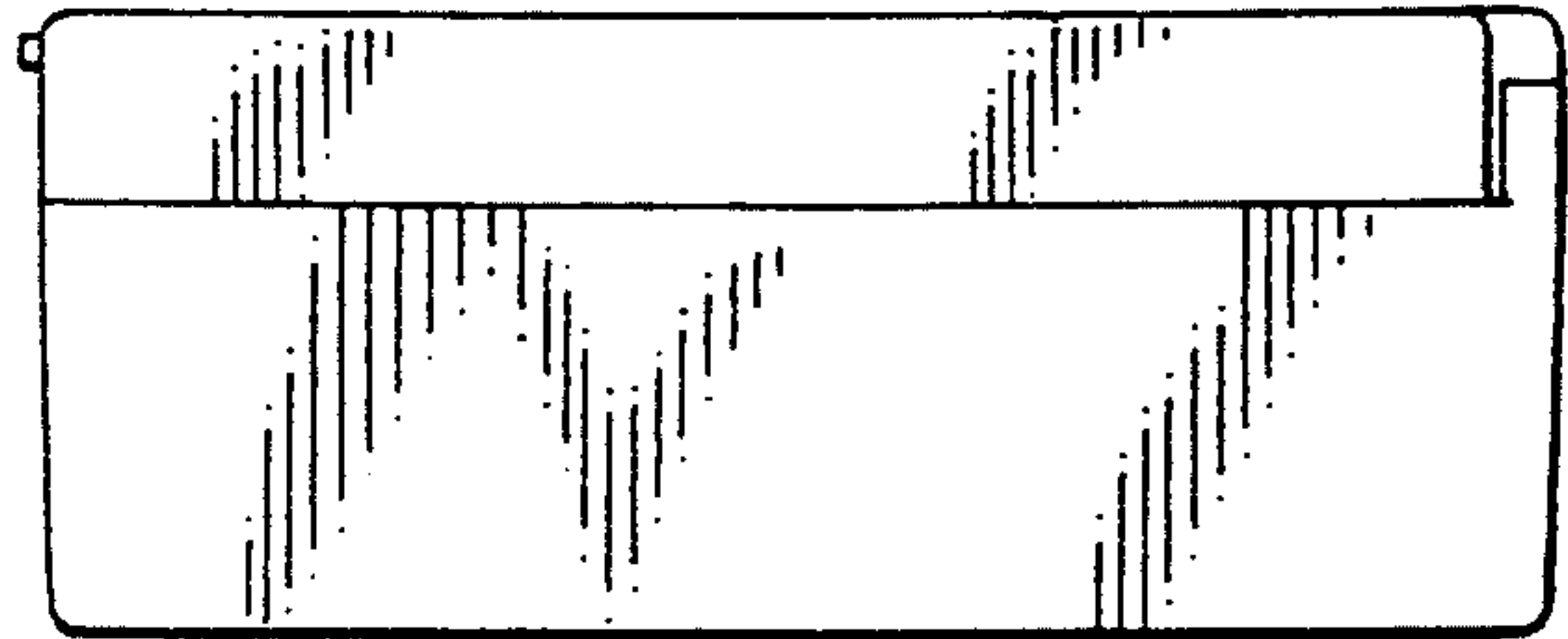

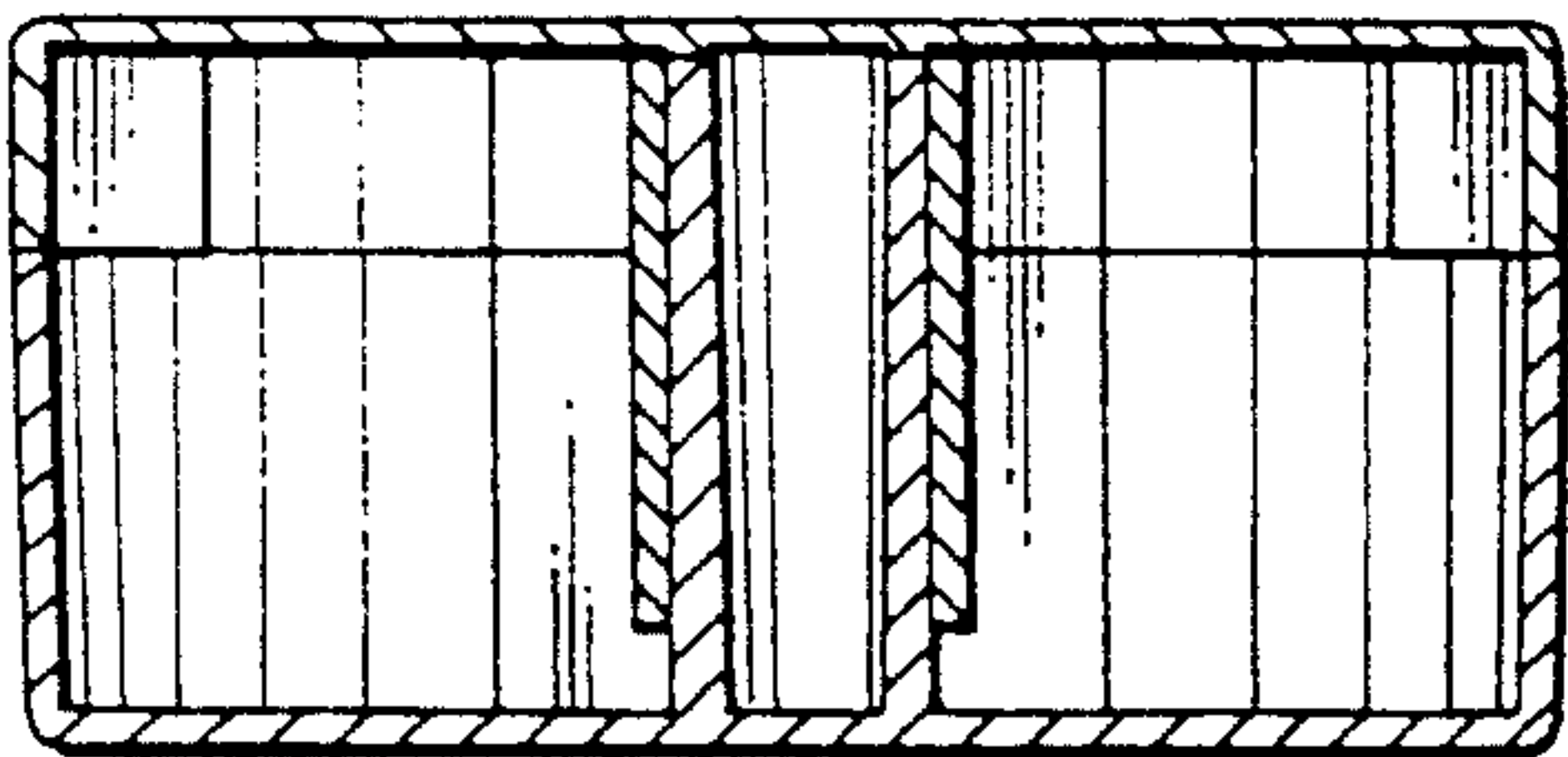

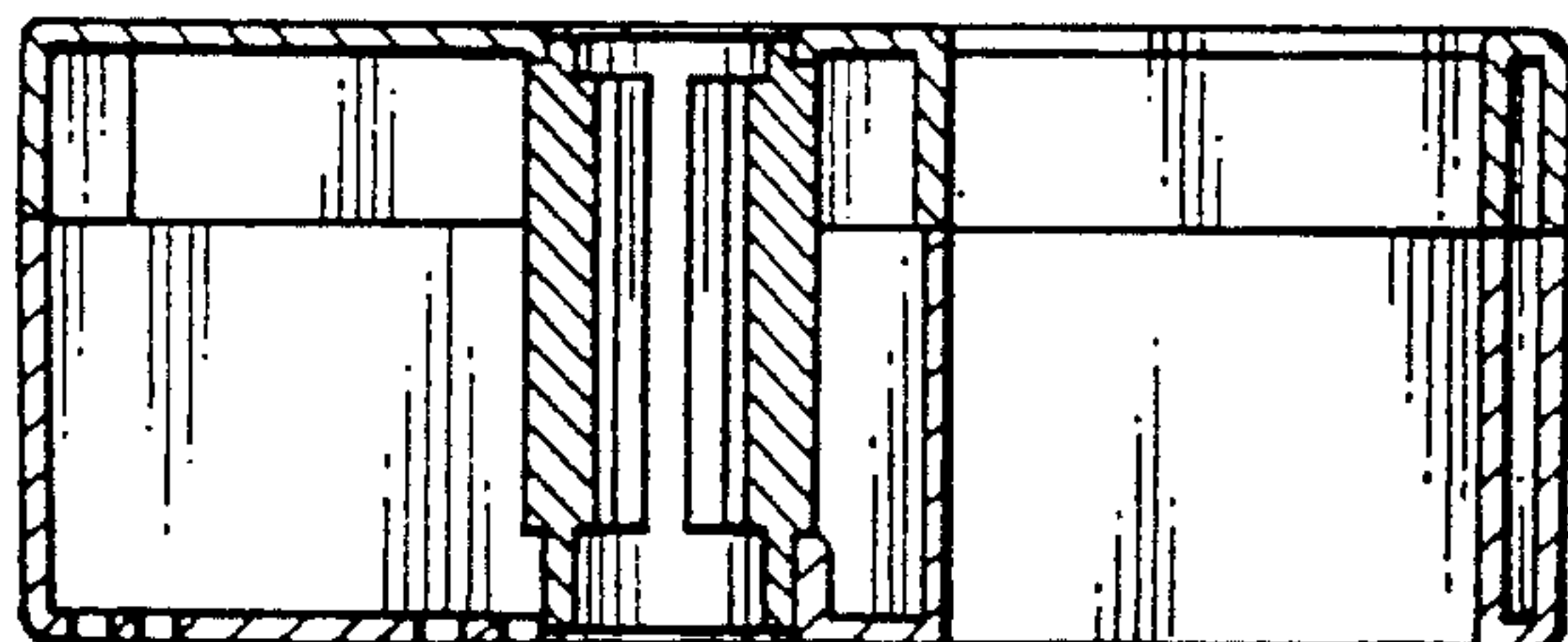

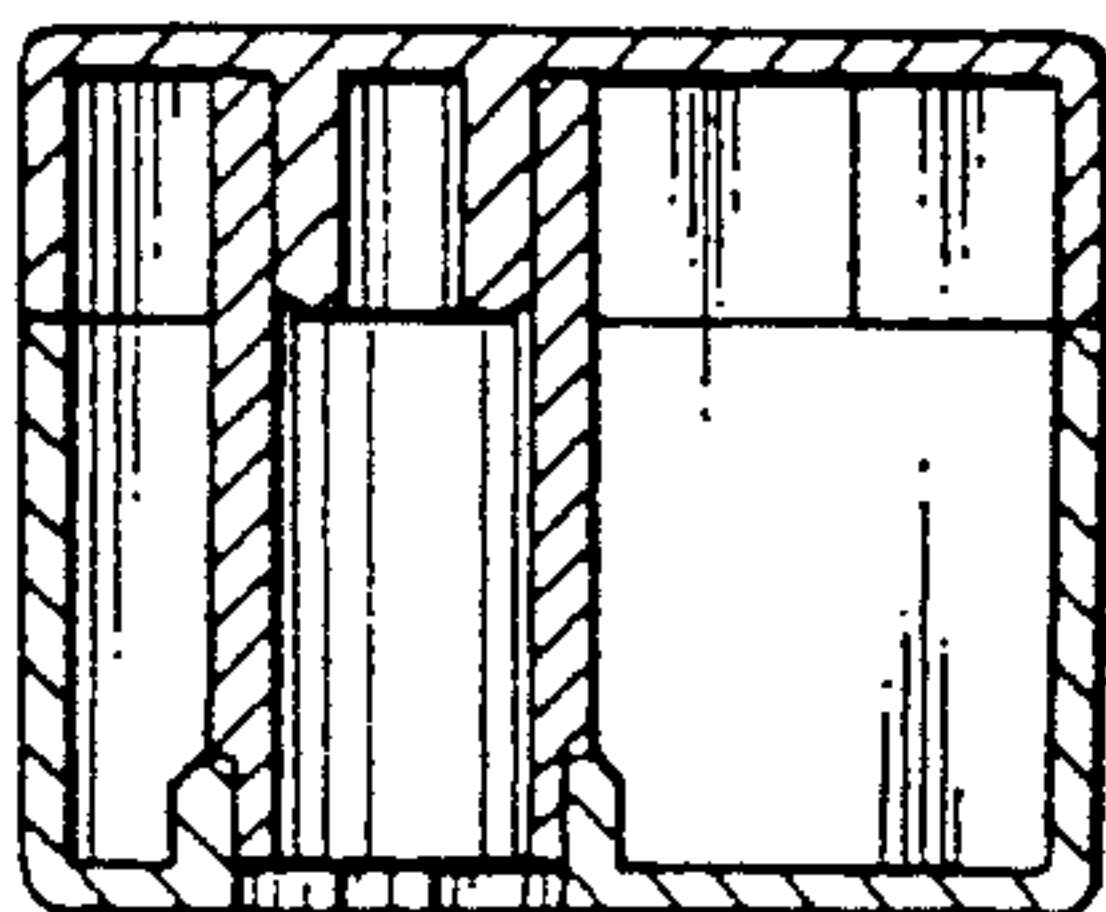
