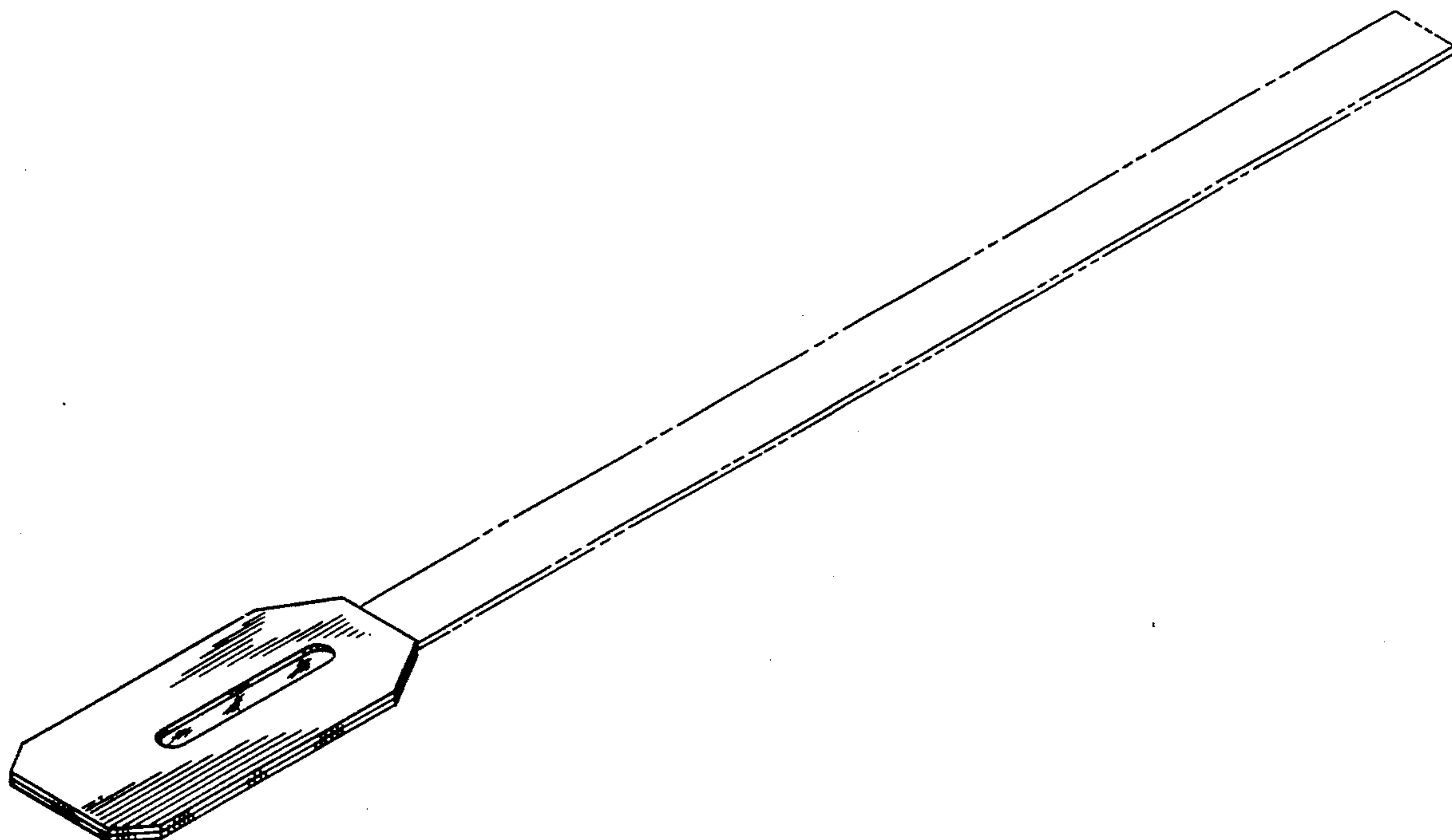

[57] **CLAIM**

The ornamental design for a steam sterilization monitor, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a steam sterilization monitor of our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a side elevational view thereof; and, FIG. 5 is a bottom plan view thereof. The broken line showing of an extension portion is for illustrative purposes only and forms no part of the claimed design.



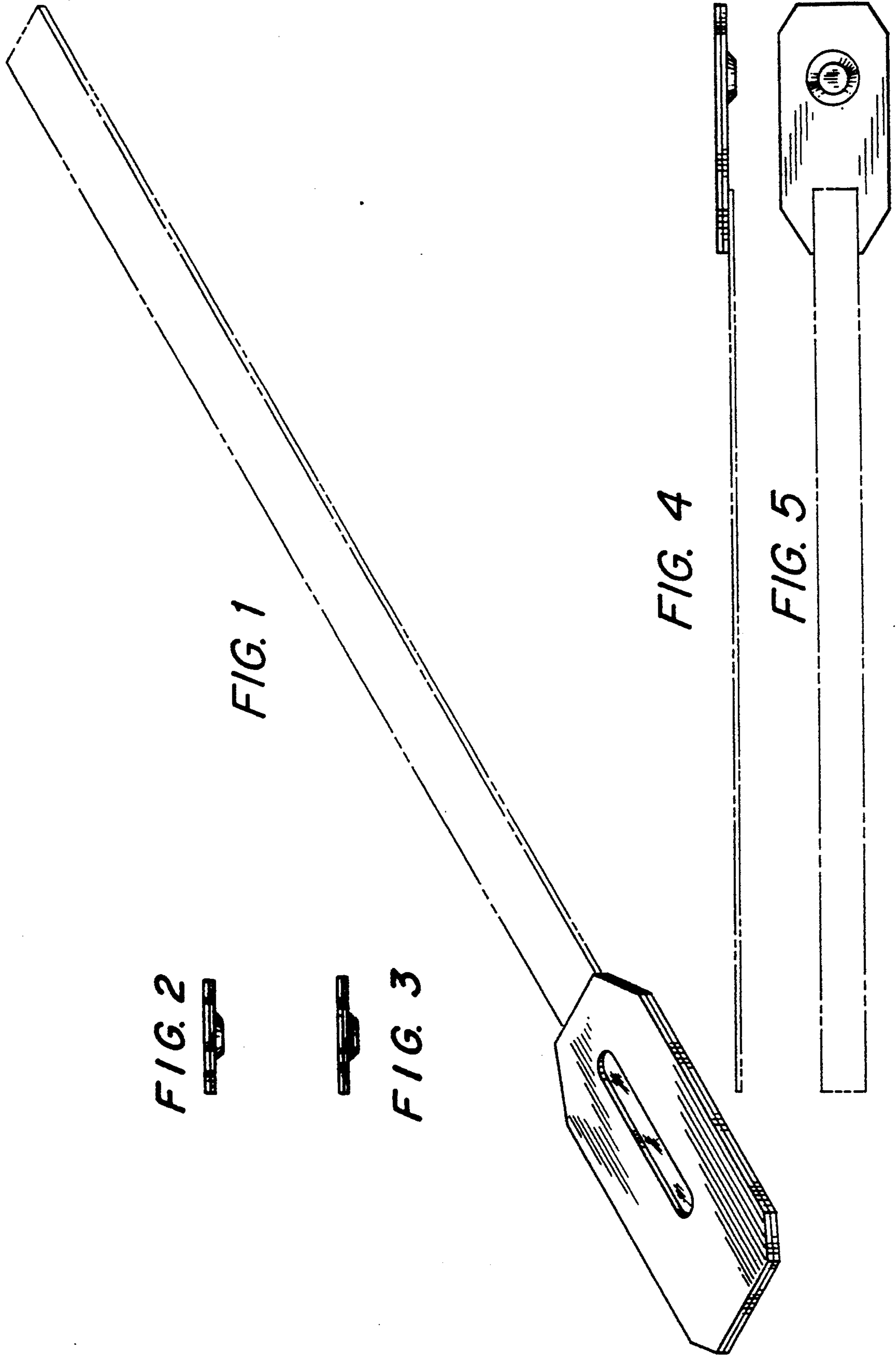
