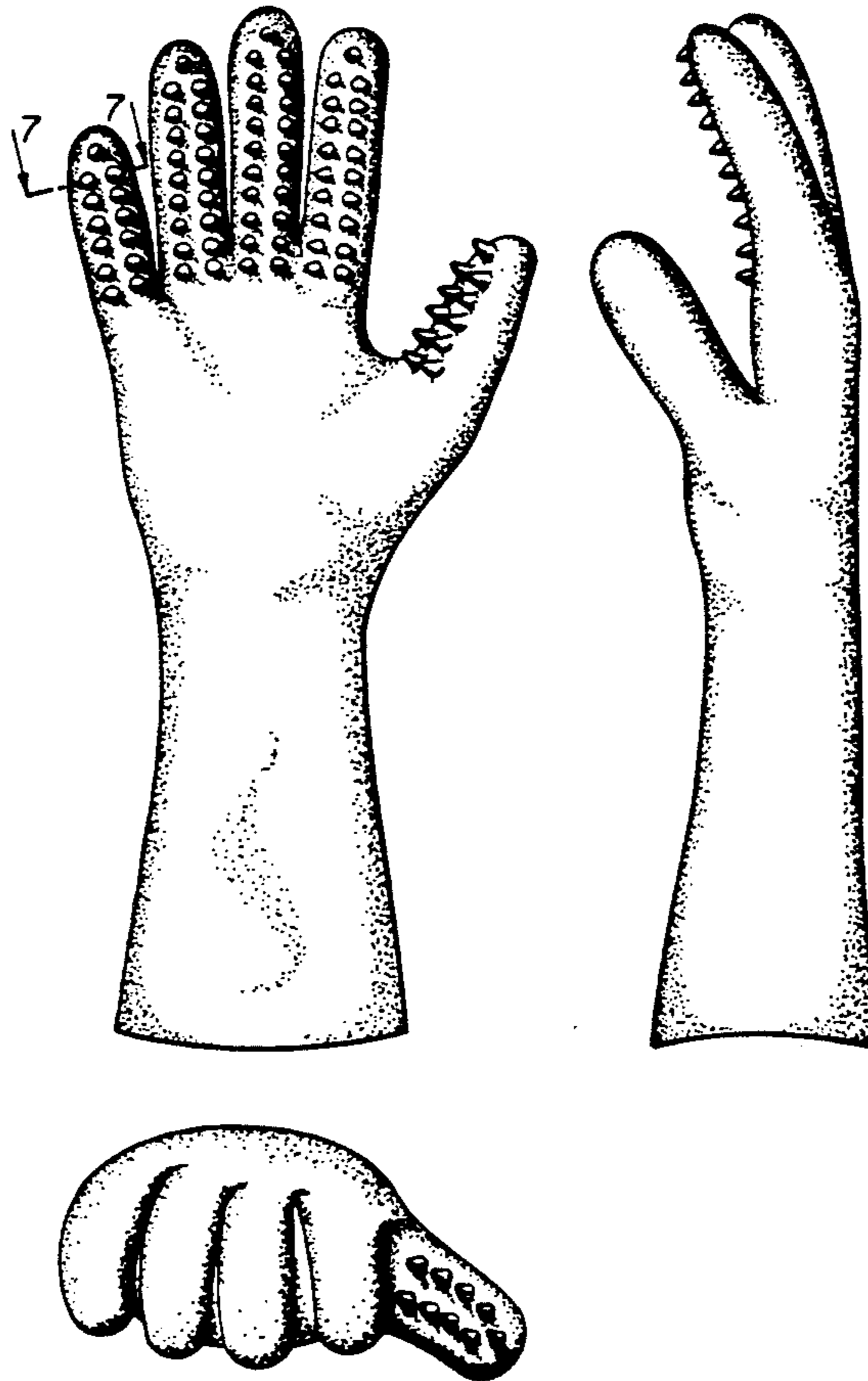
DESCRIPTION

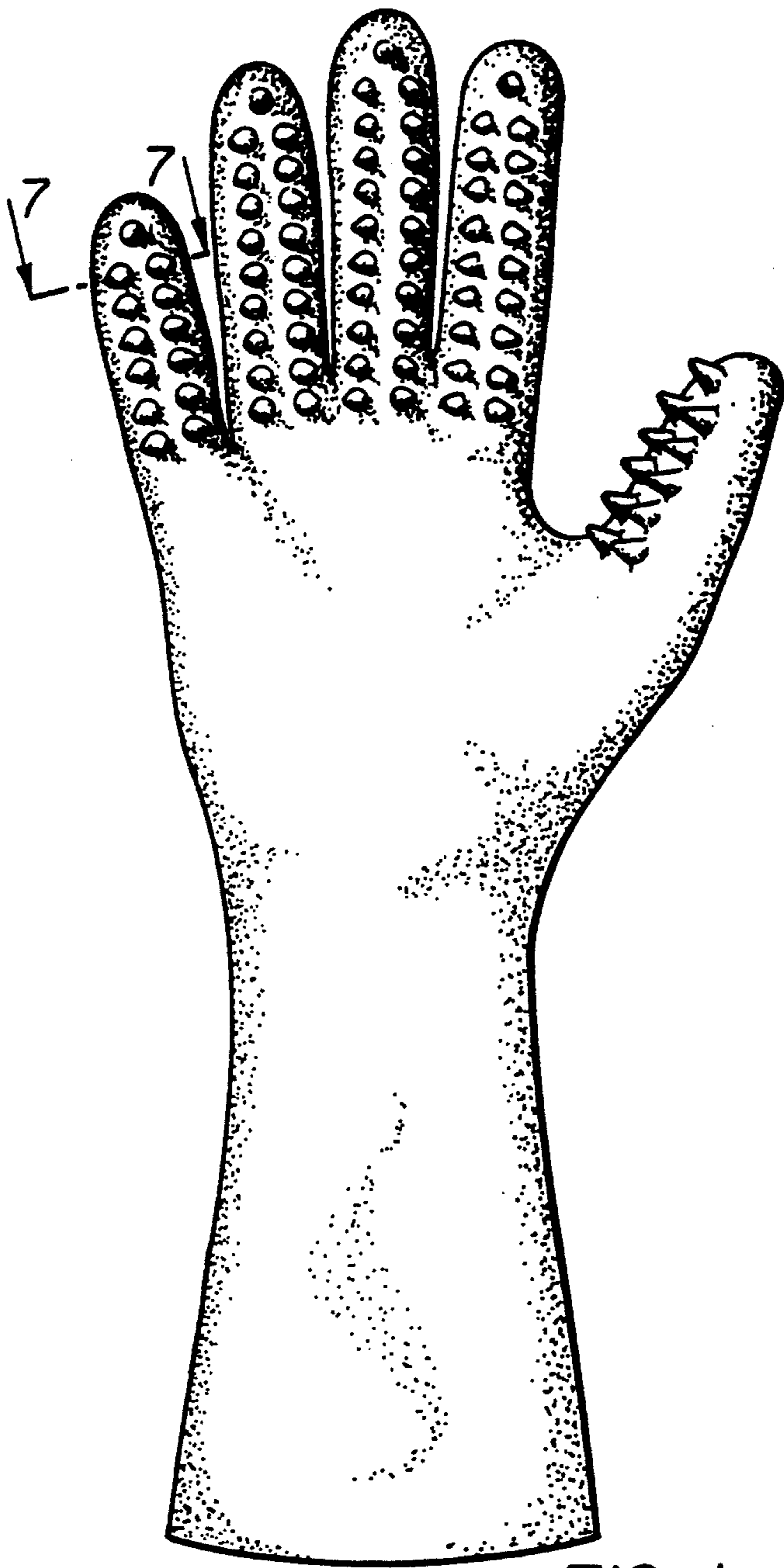

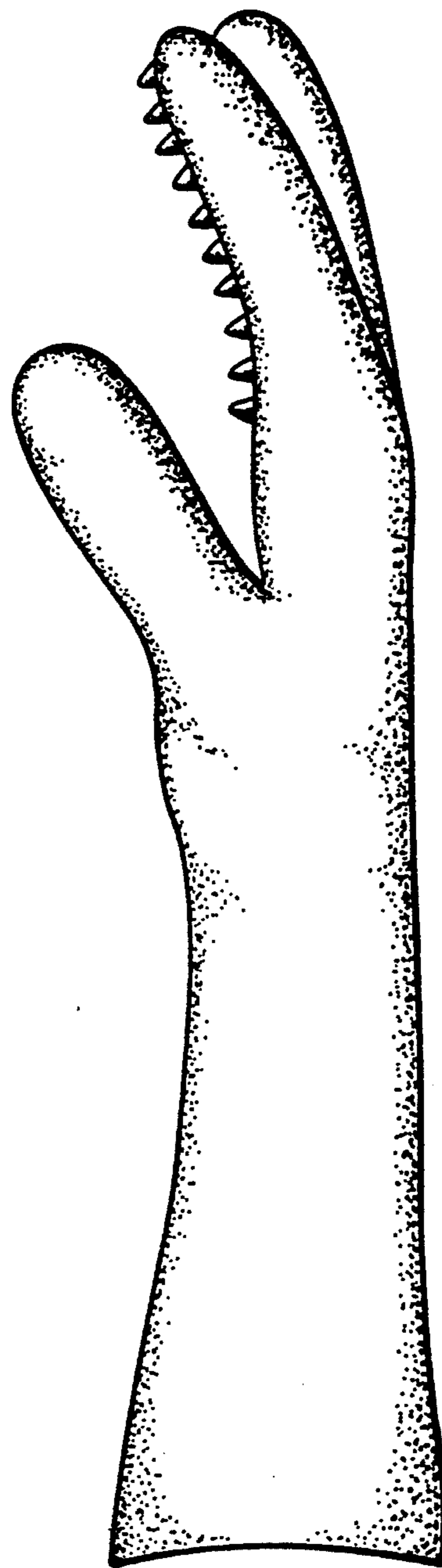

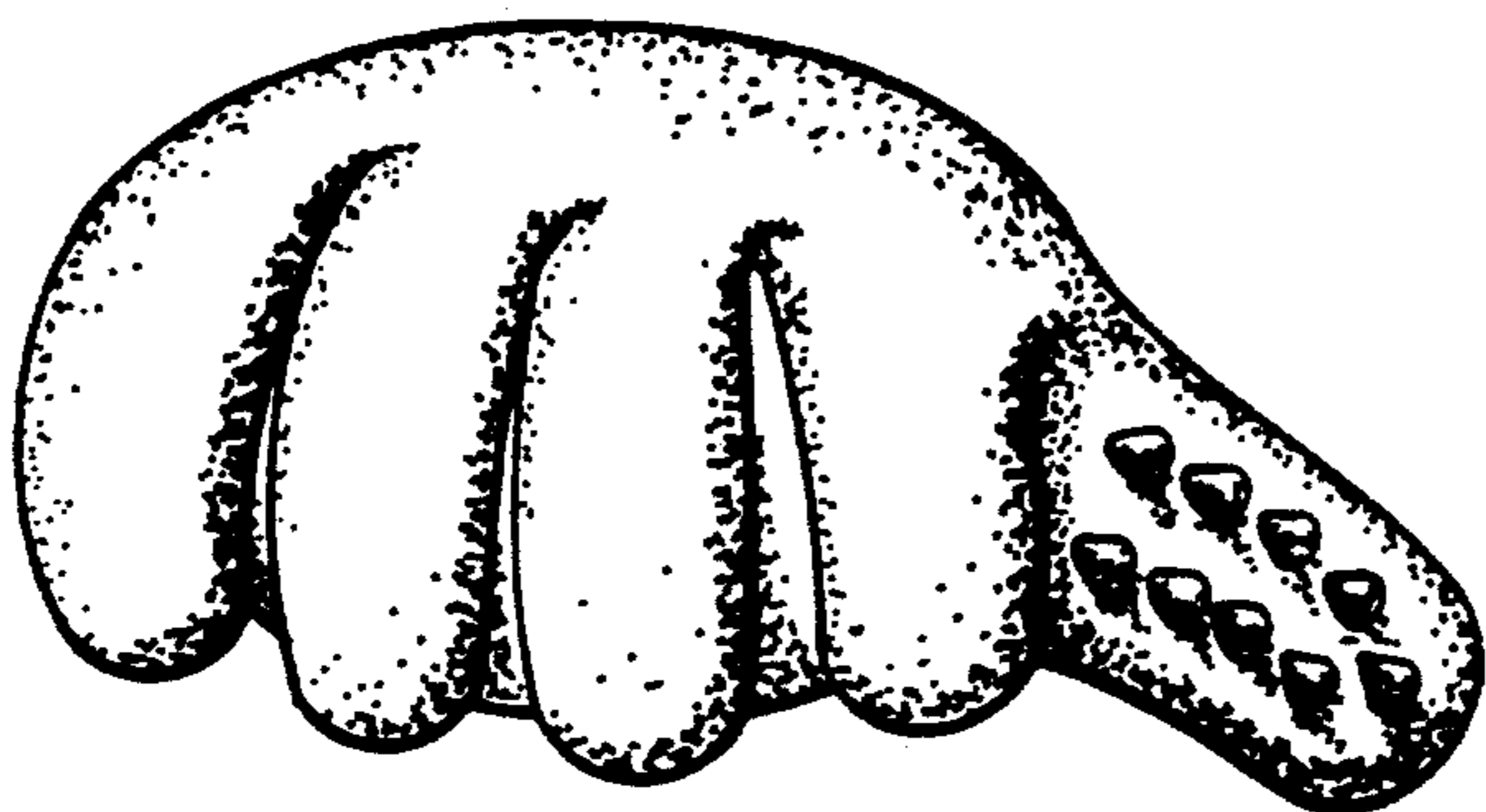

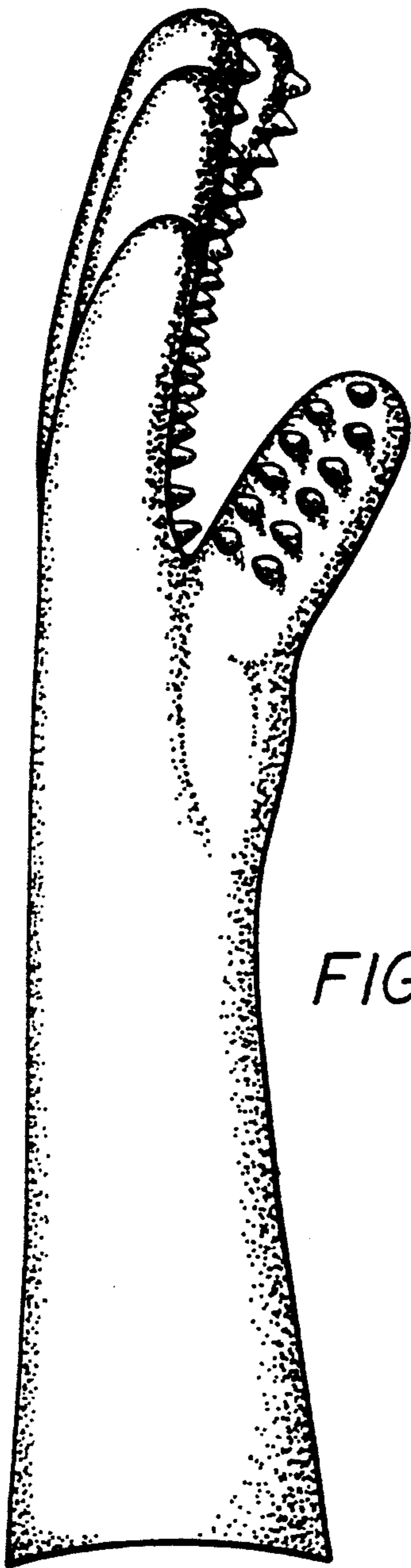

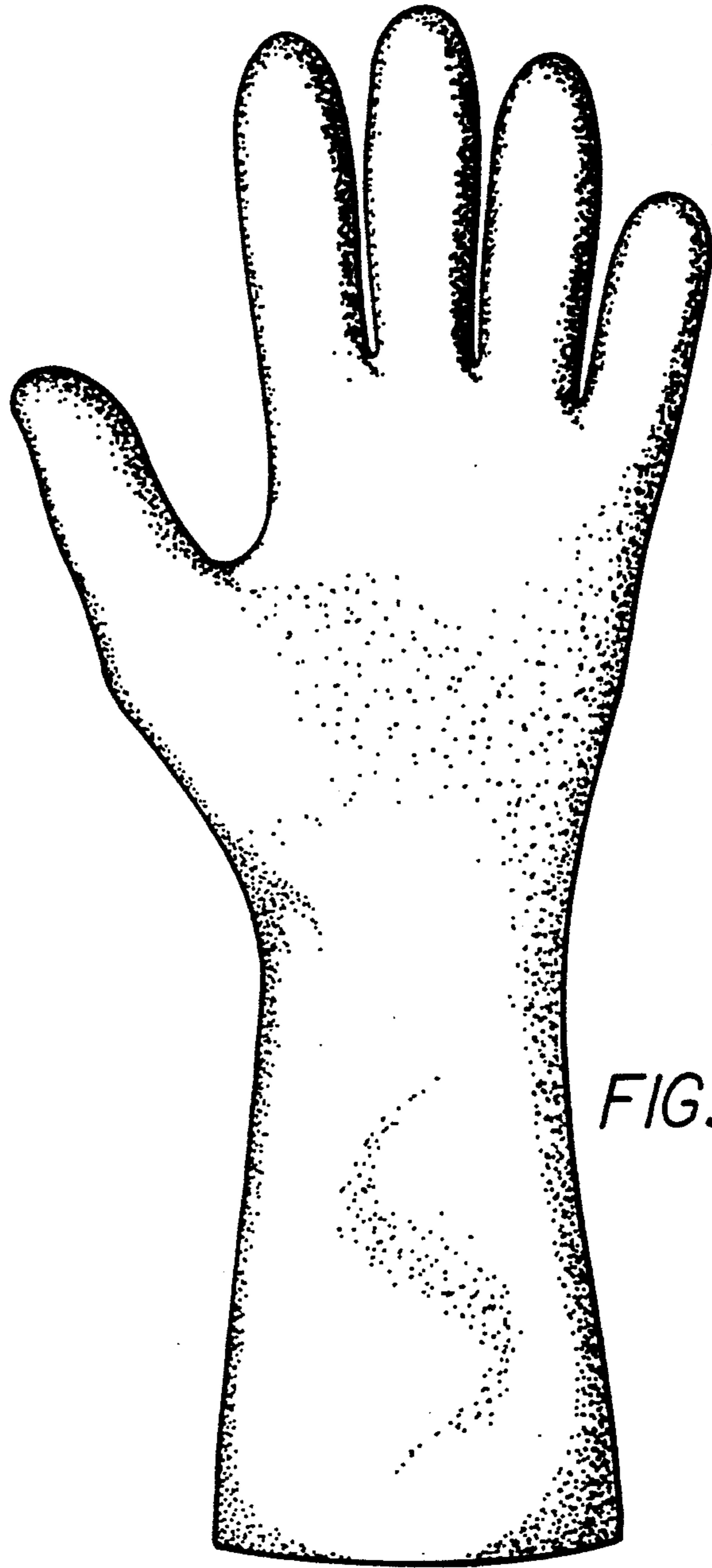

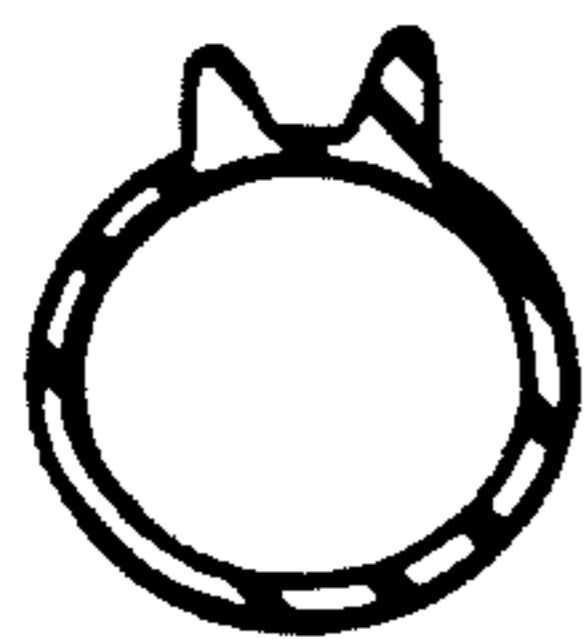

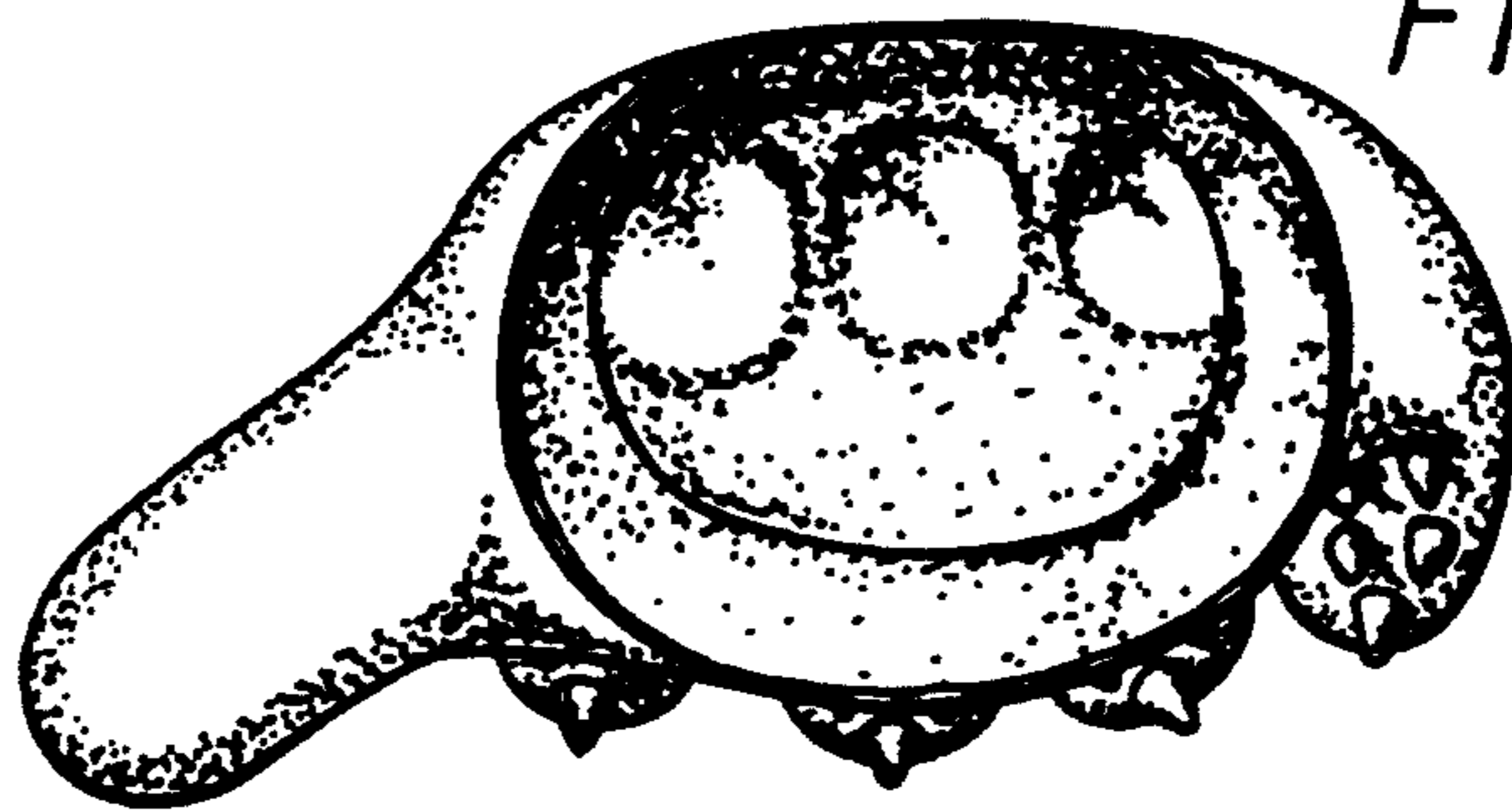
