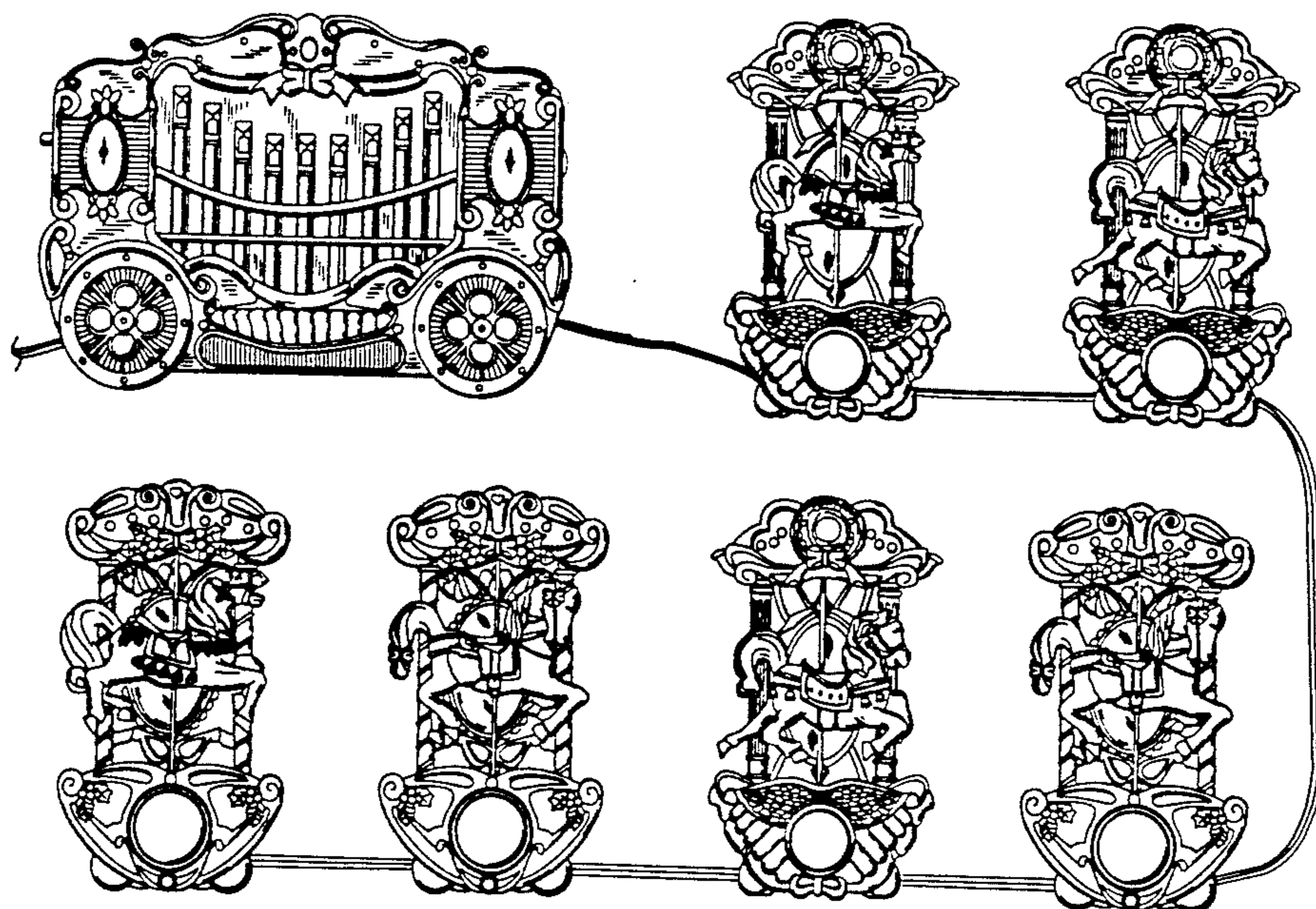

[57] **CLAIM**  
 The ornamental design for a christmas ornamental display, as shown and described.

**DESCRIPTION**  
 FIG. 1 is a perspective view of an ornamental display showing my new design;

 The elements of the claimed design are shown separately for clarity of illustration.



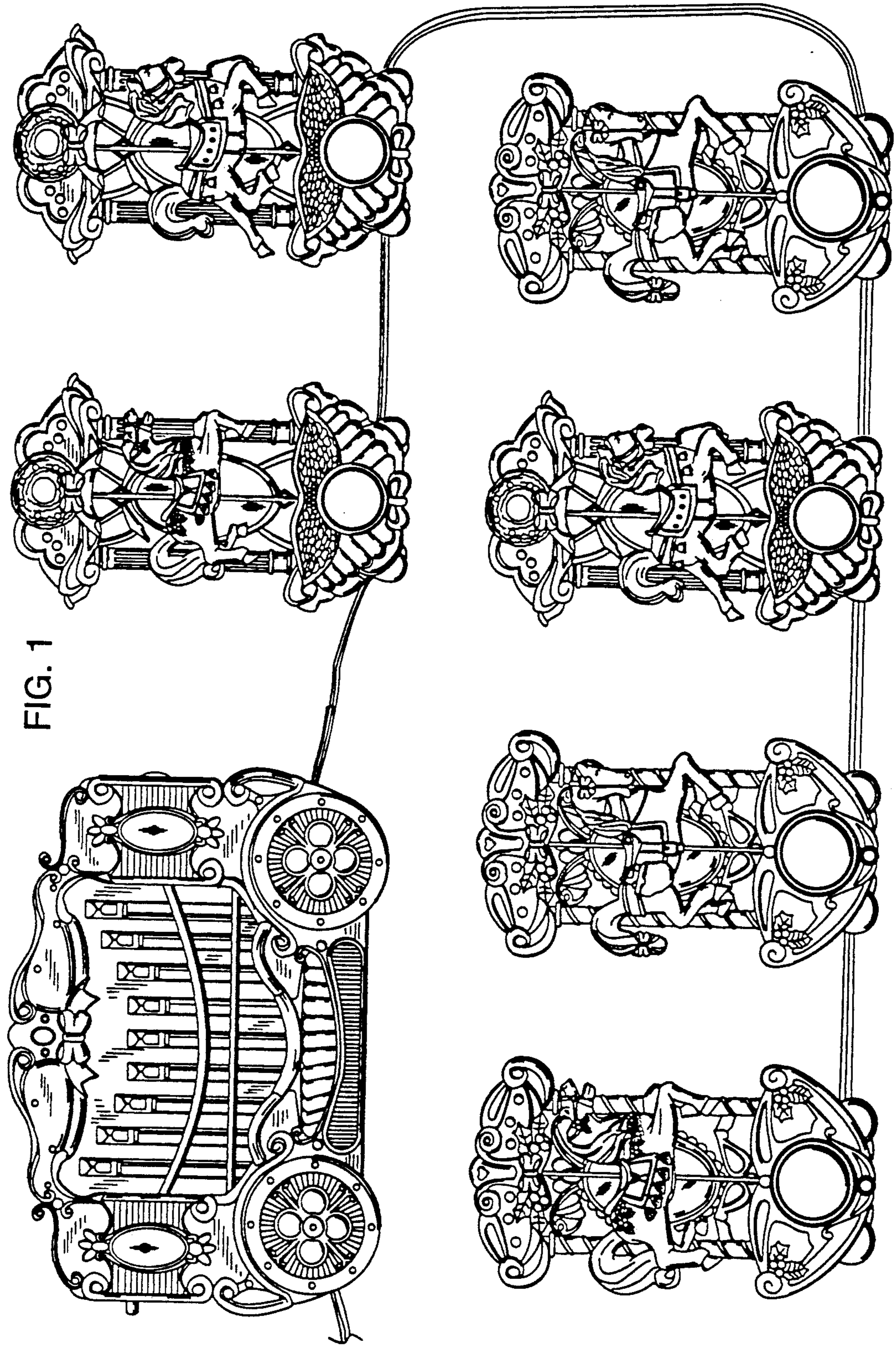

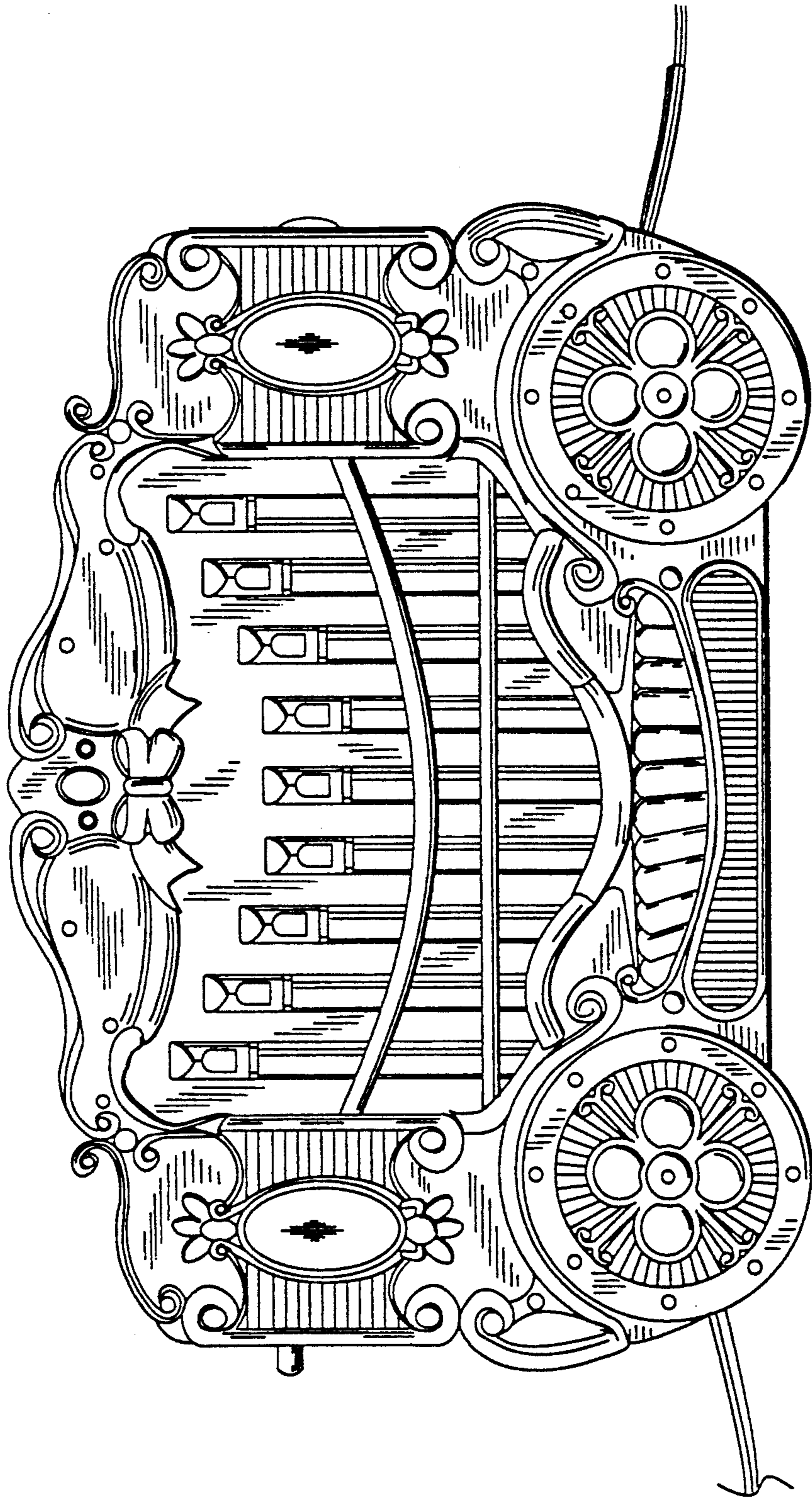

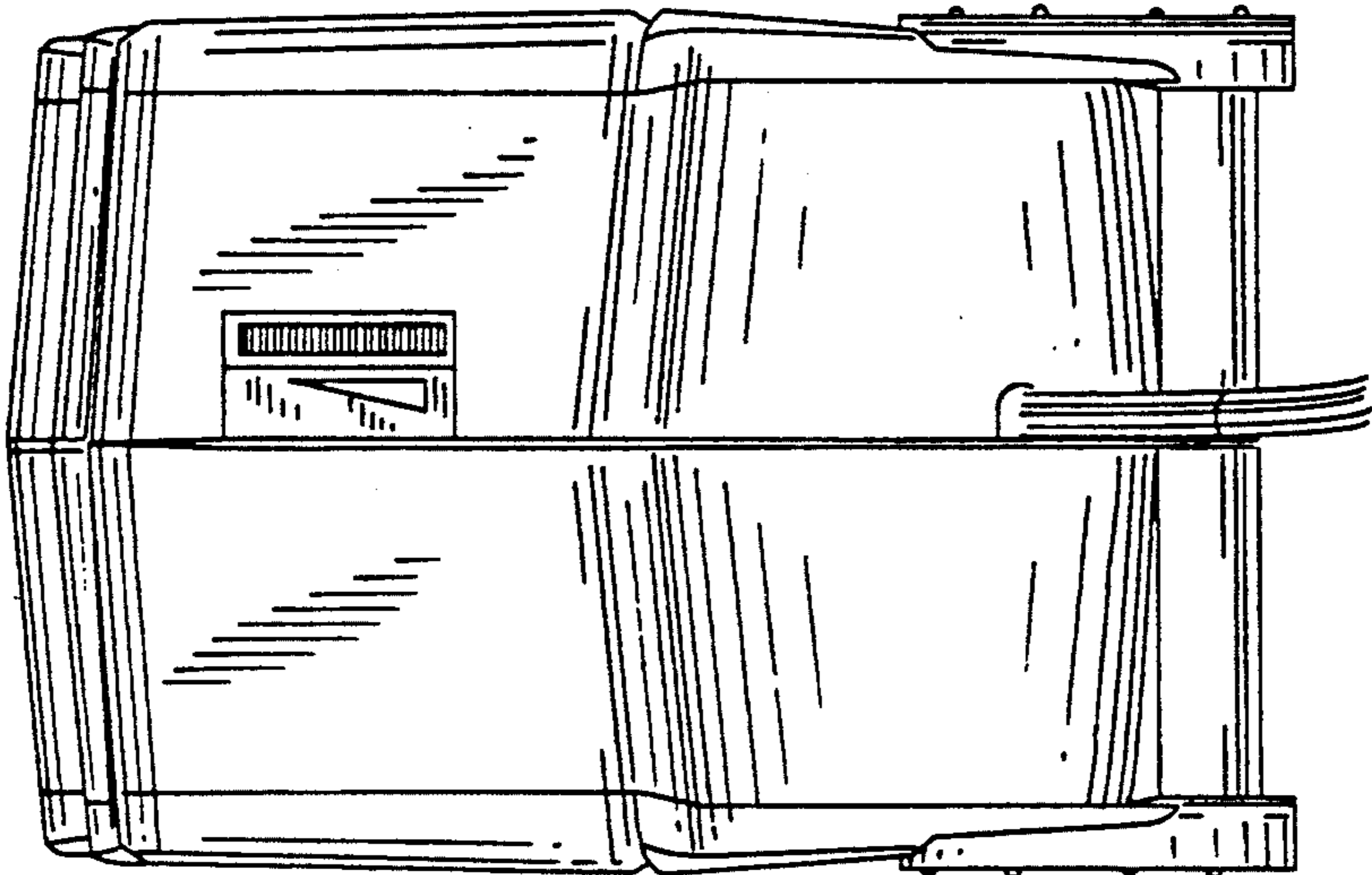

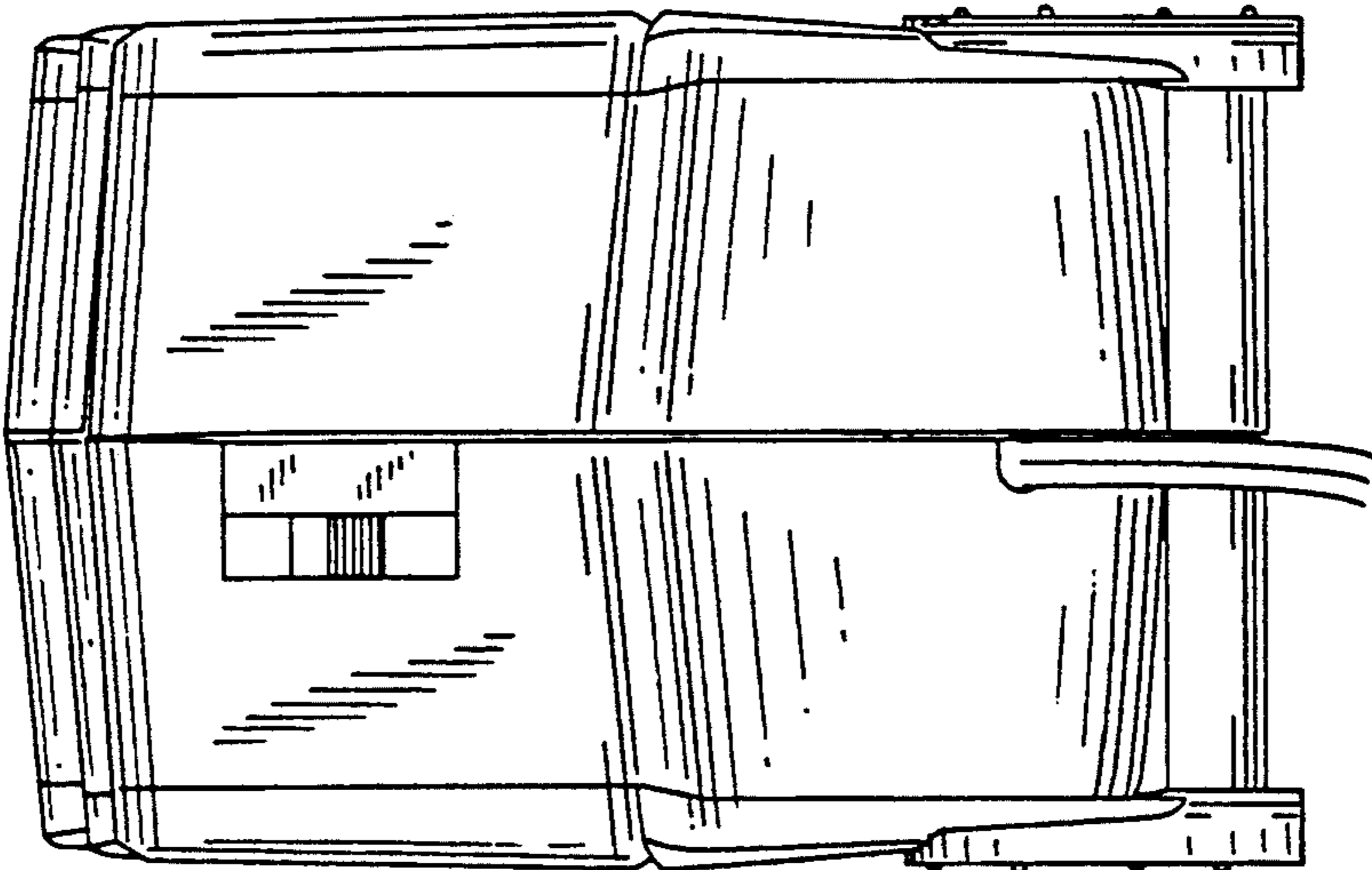

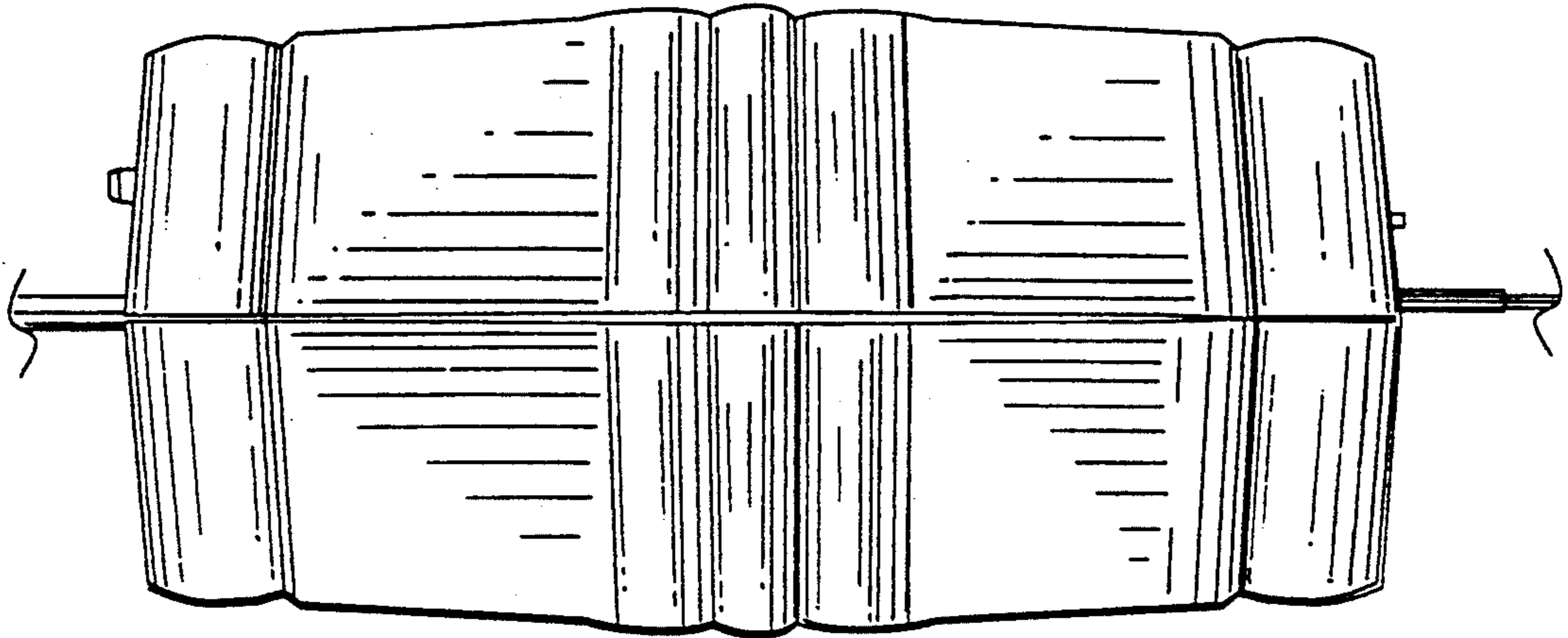

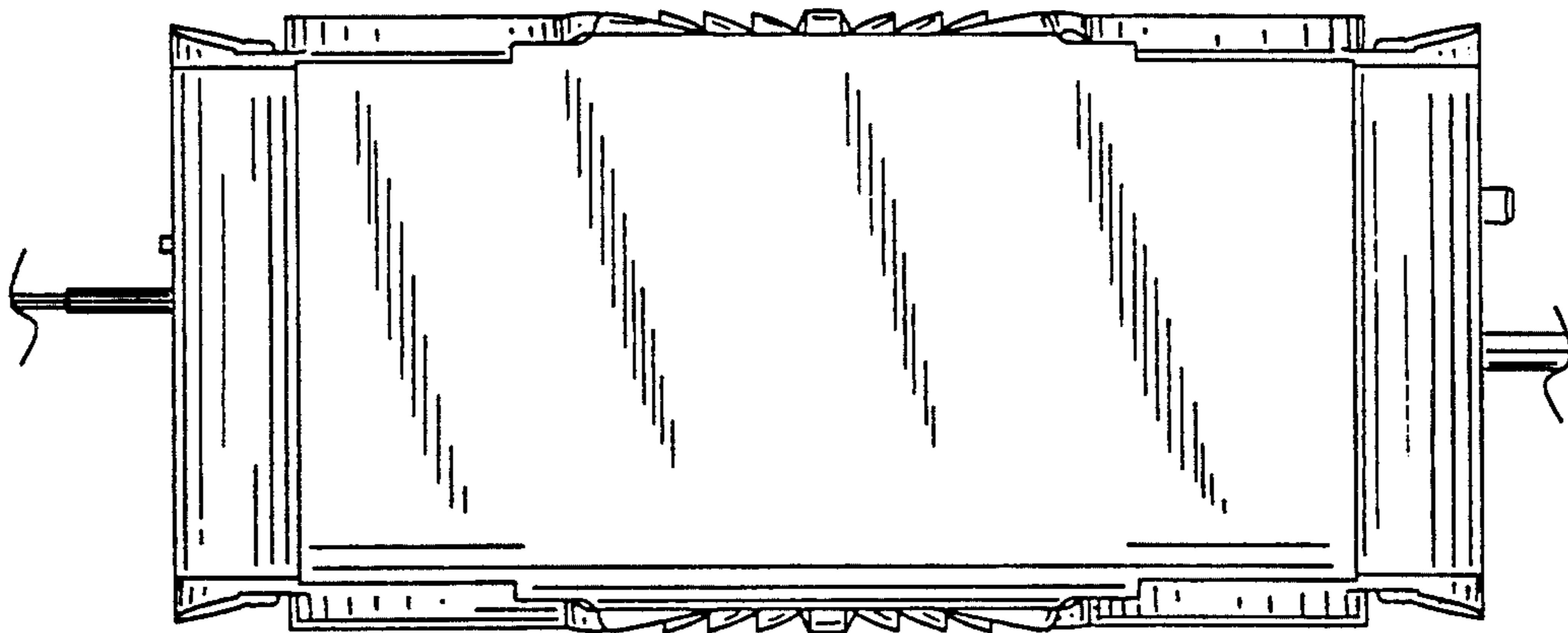

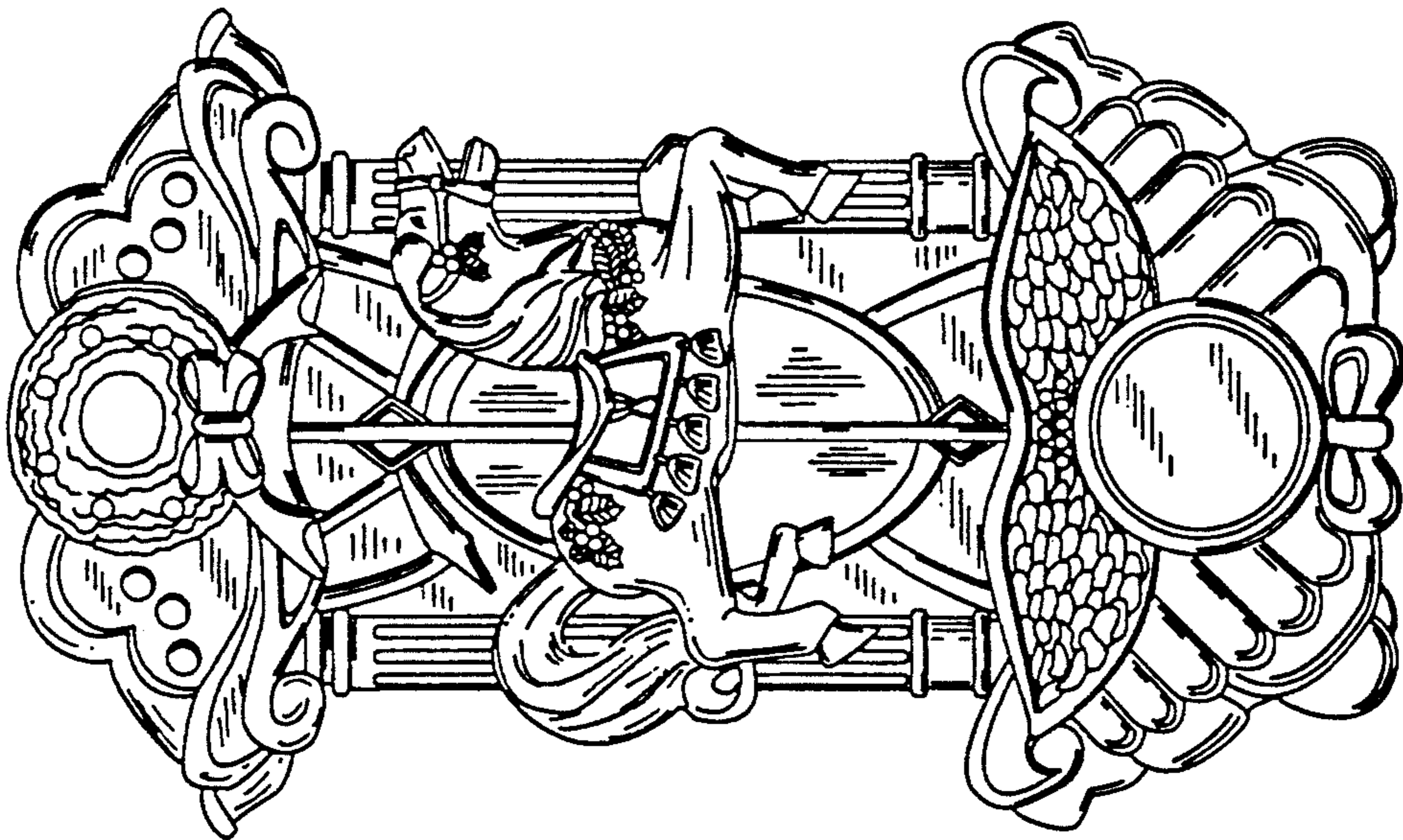

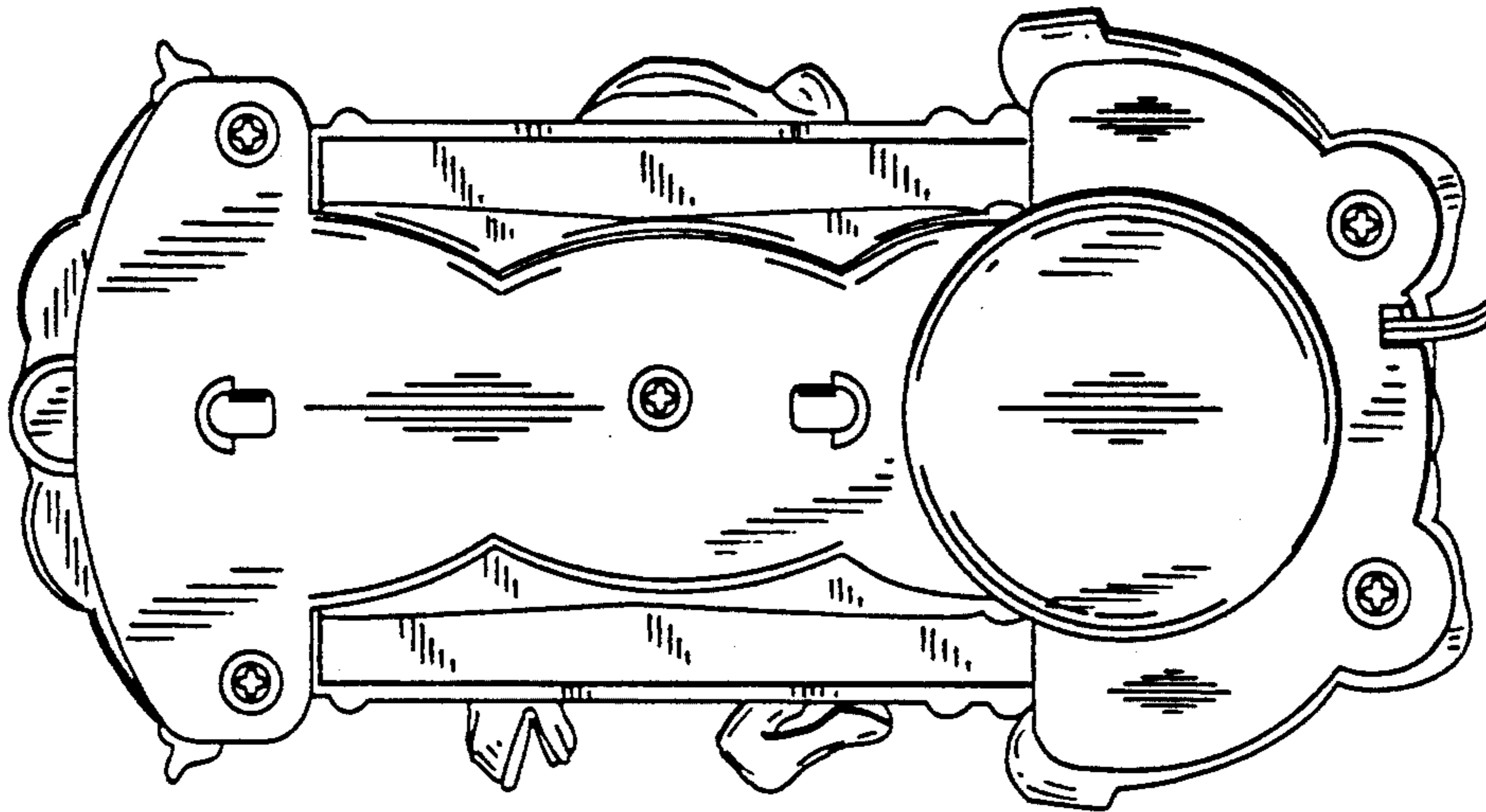

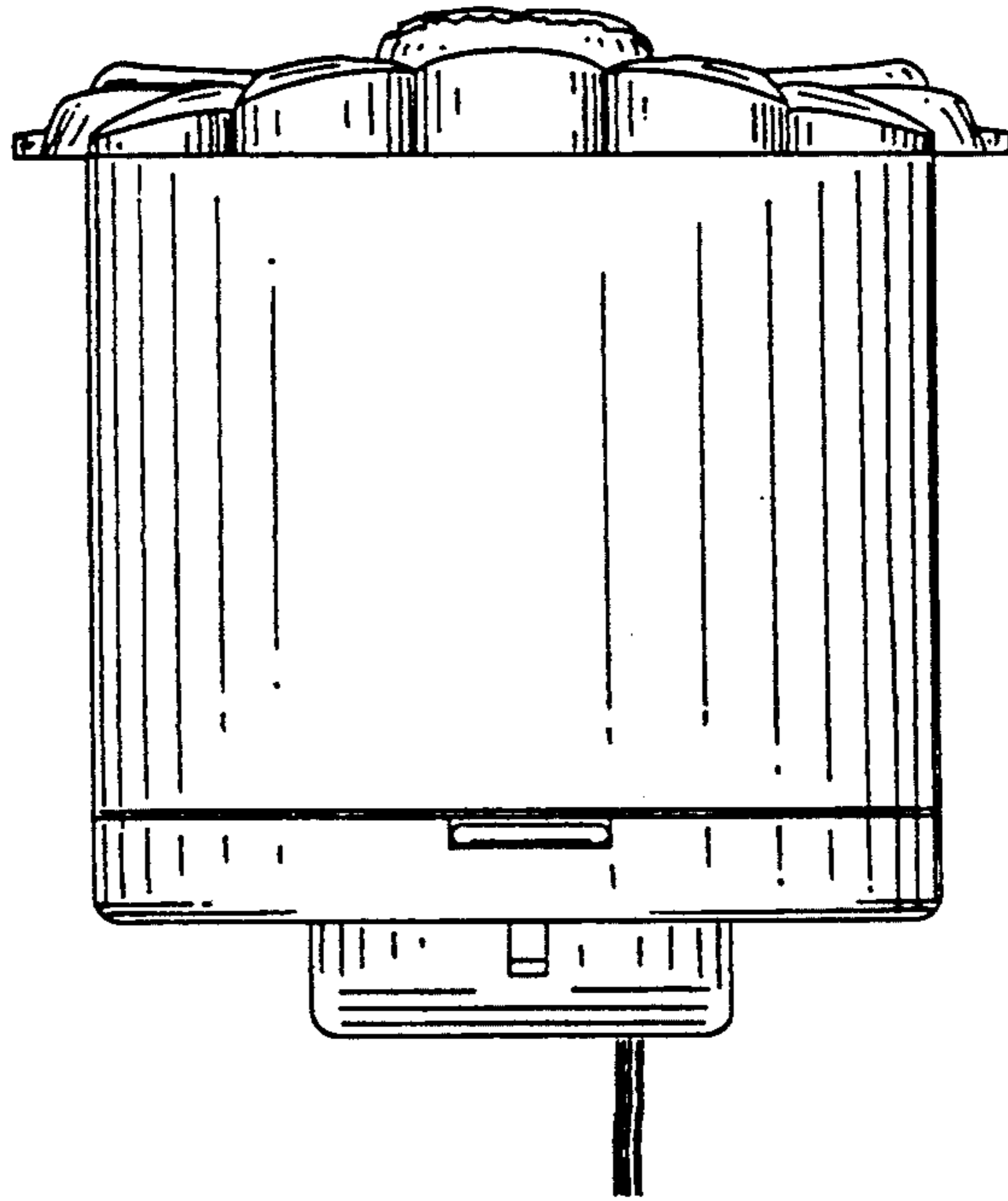

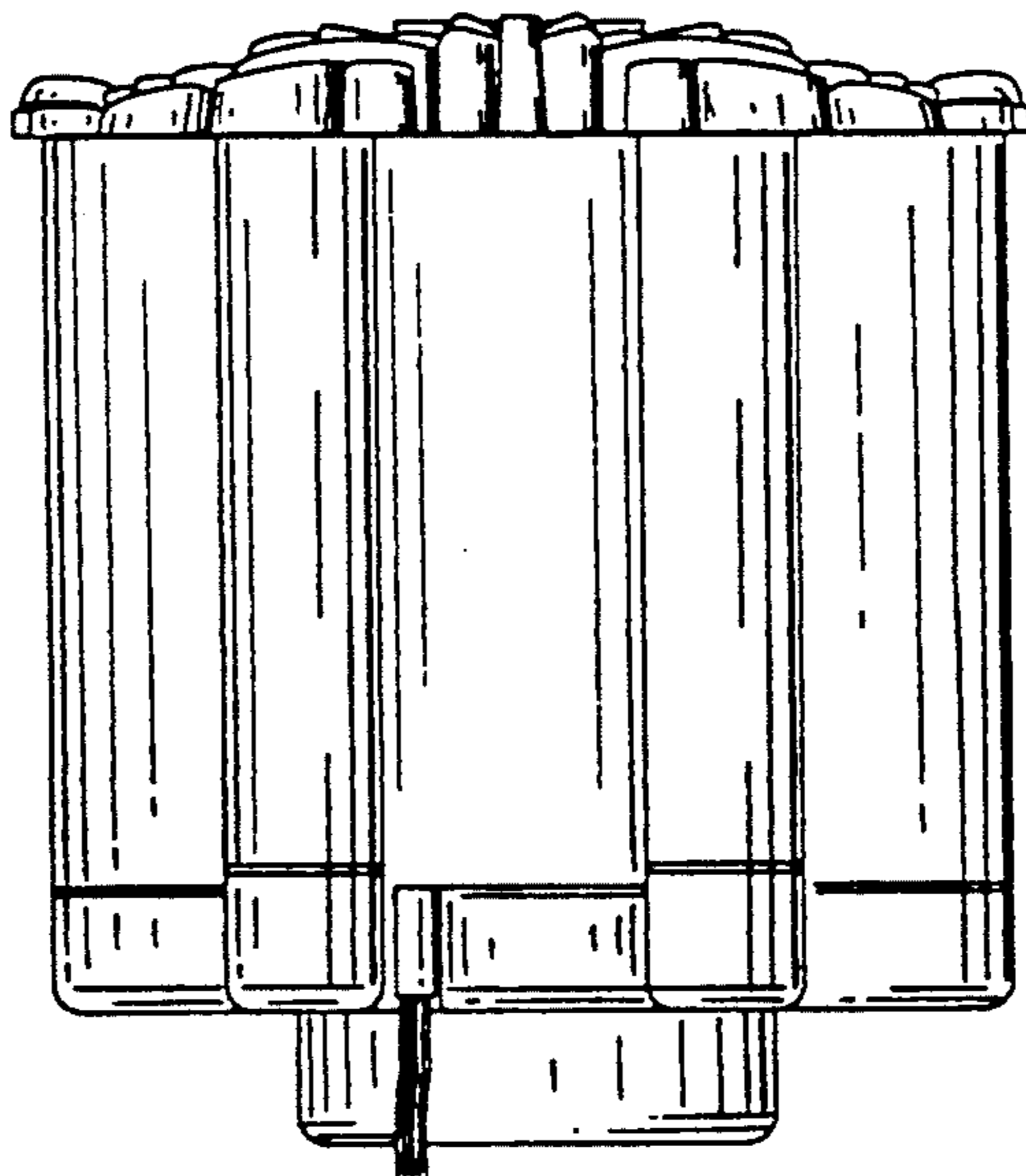
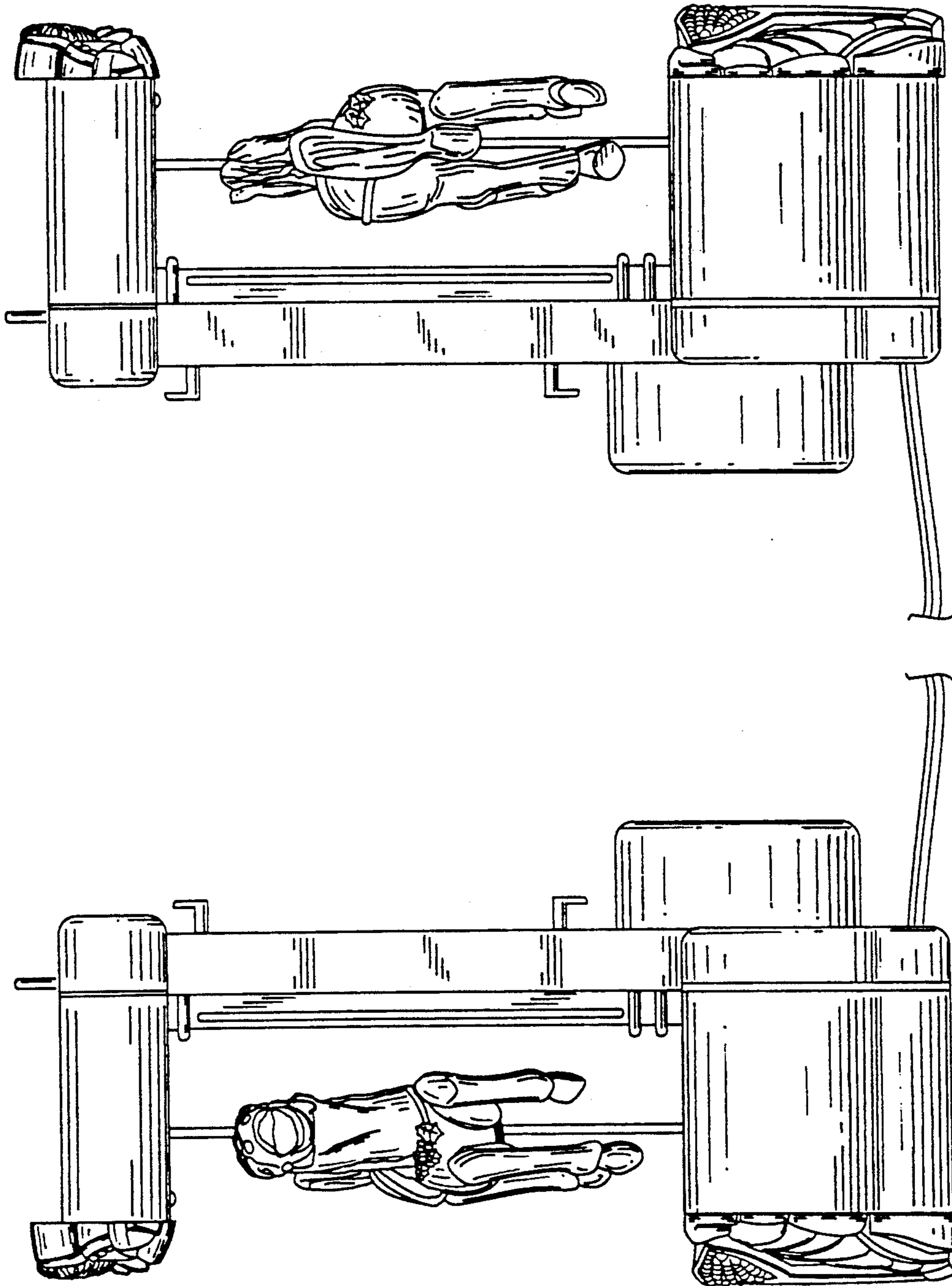

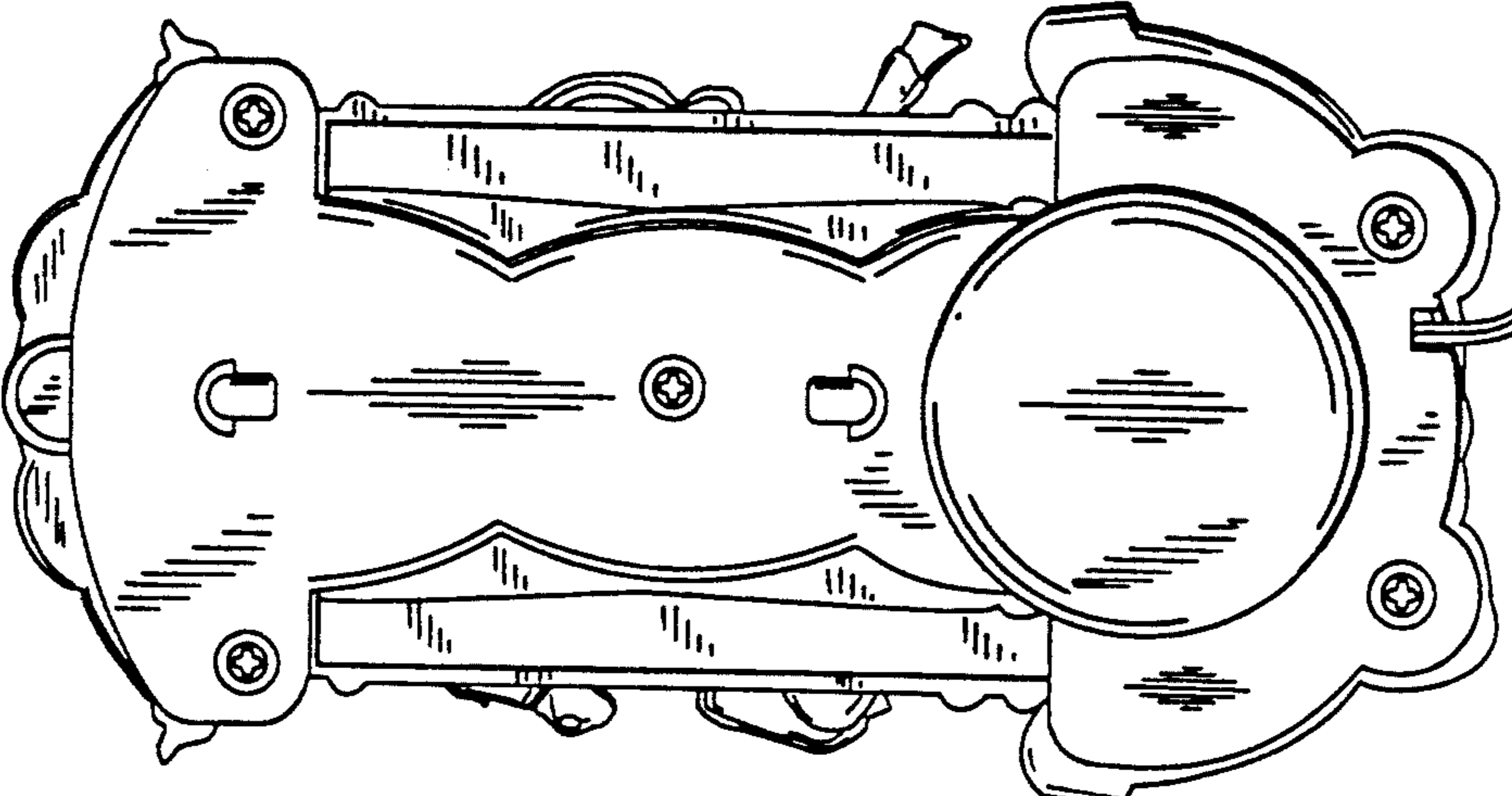

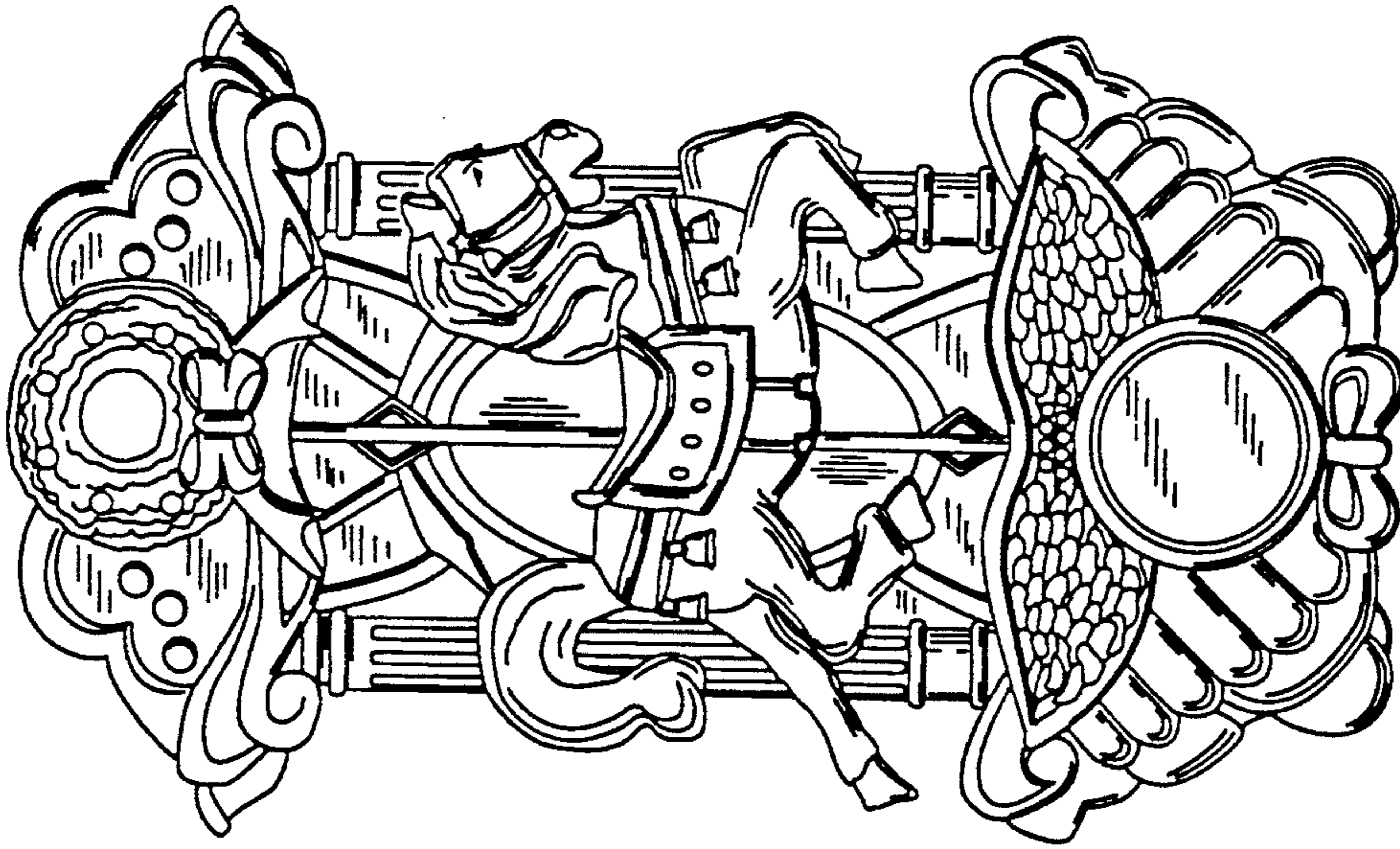

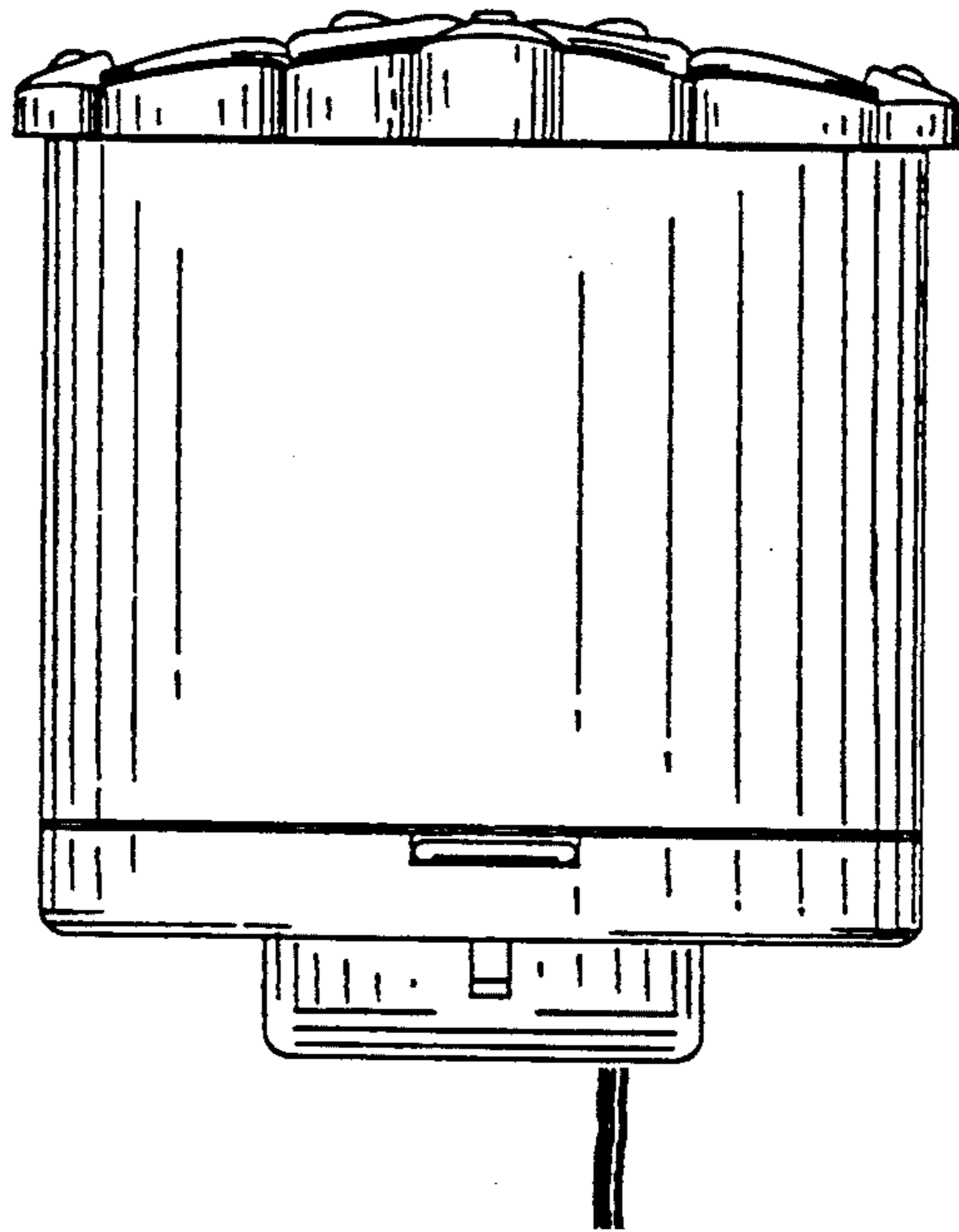

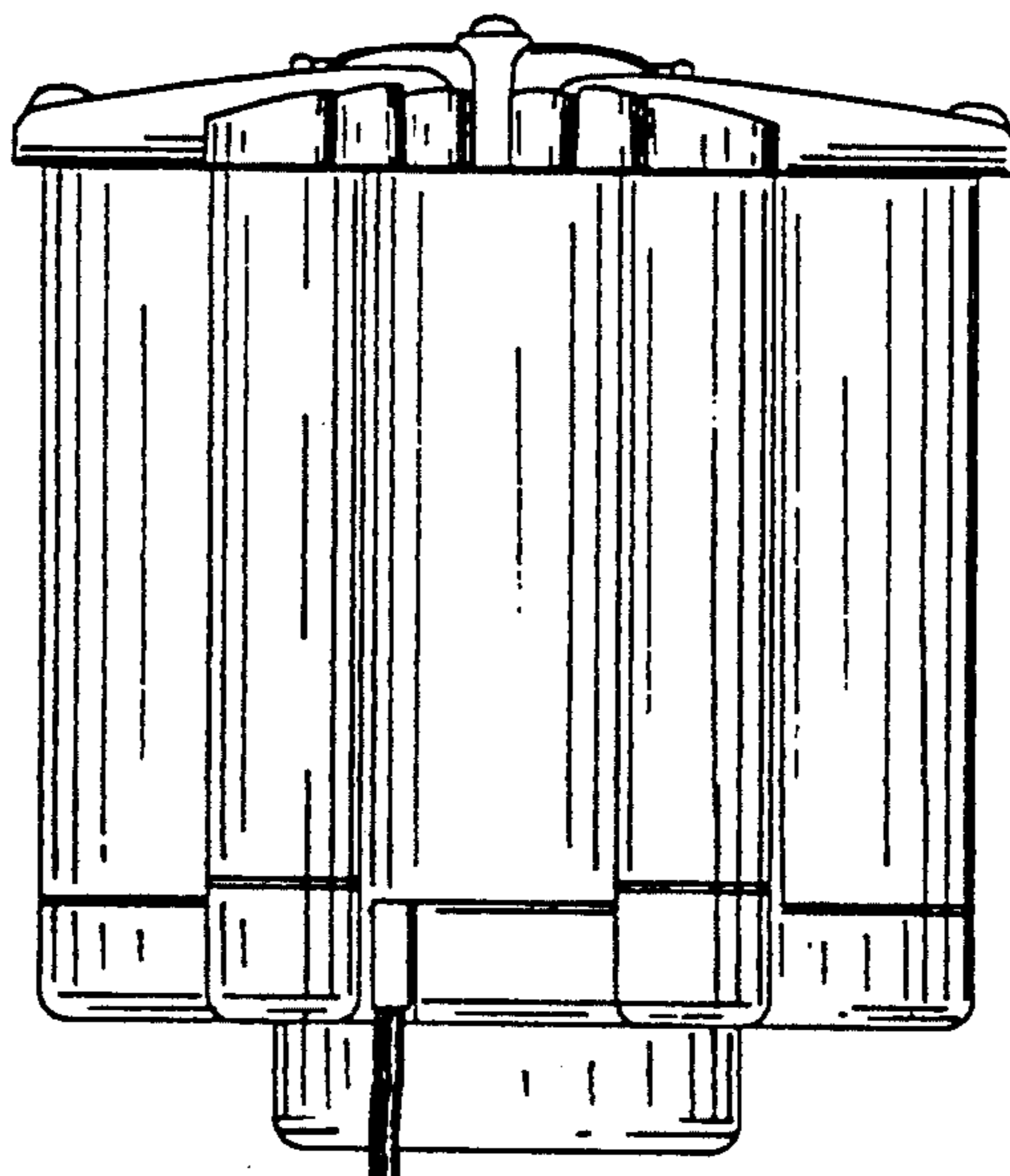

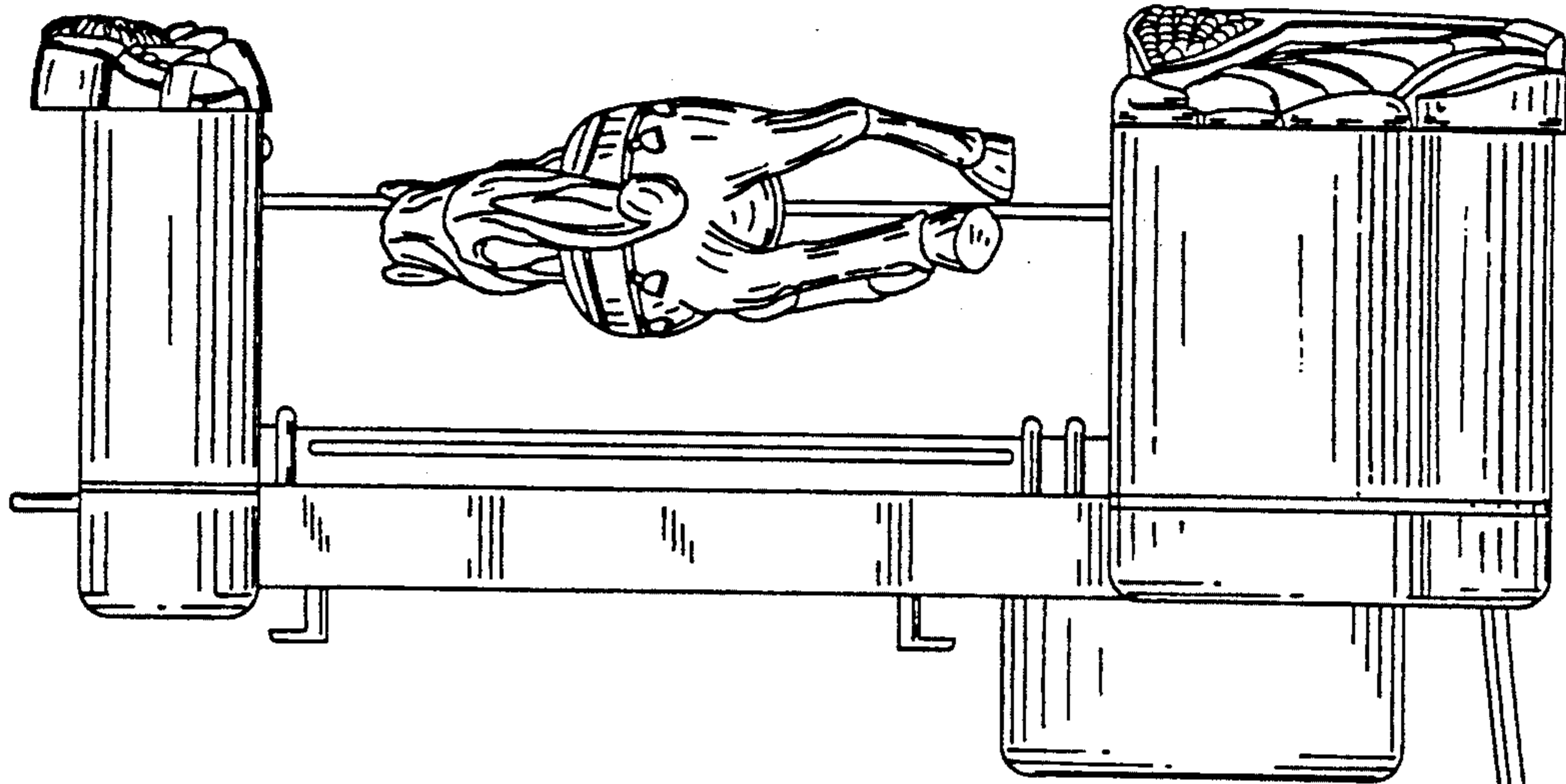

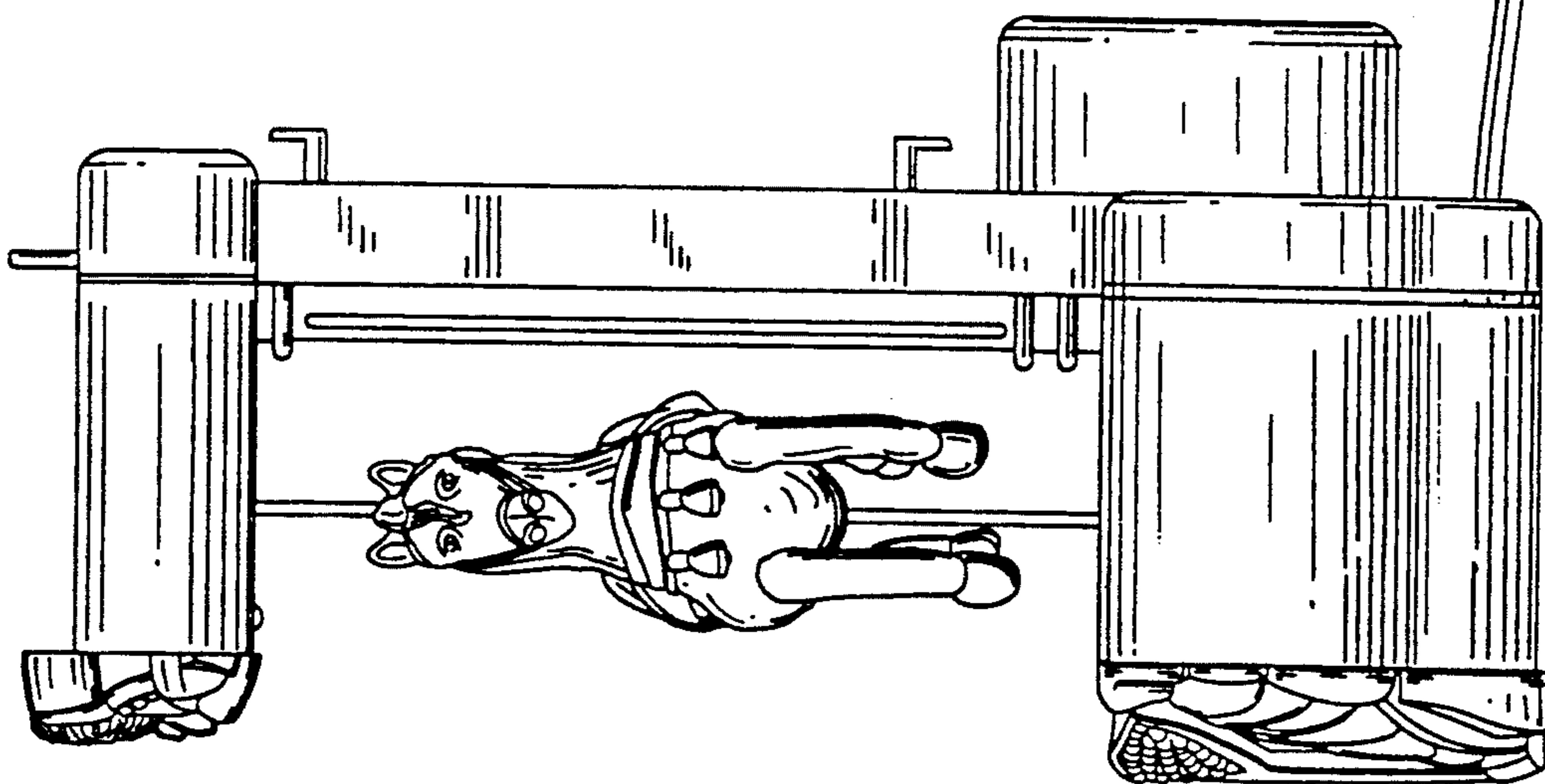

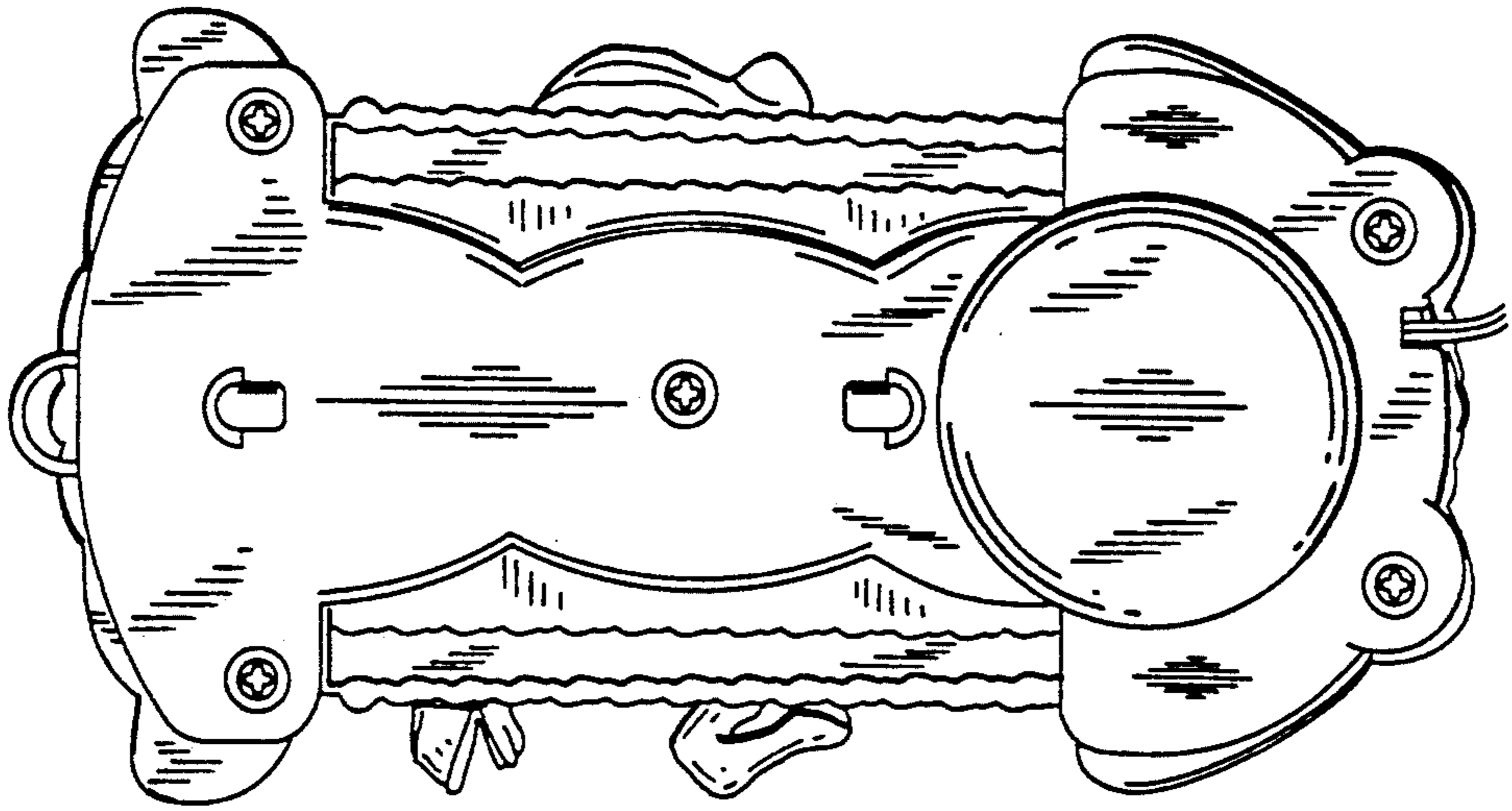

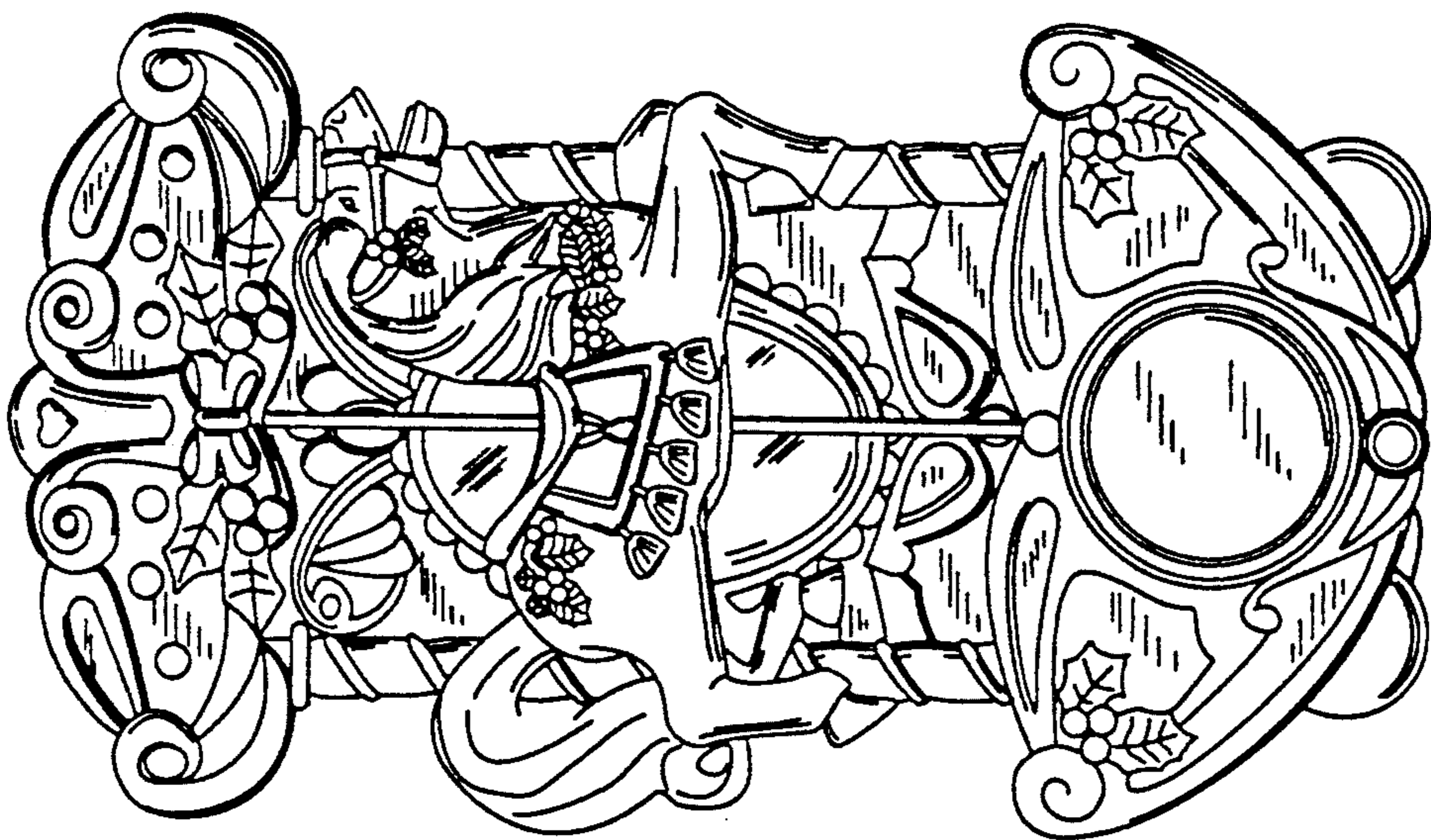

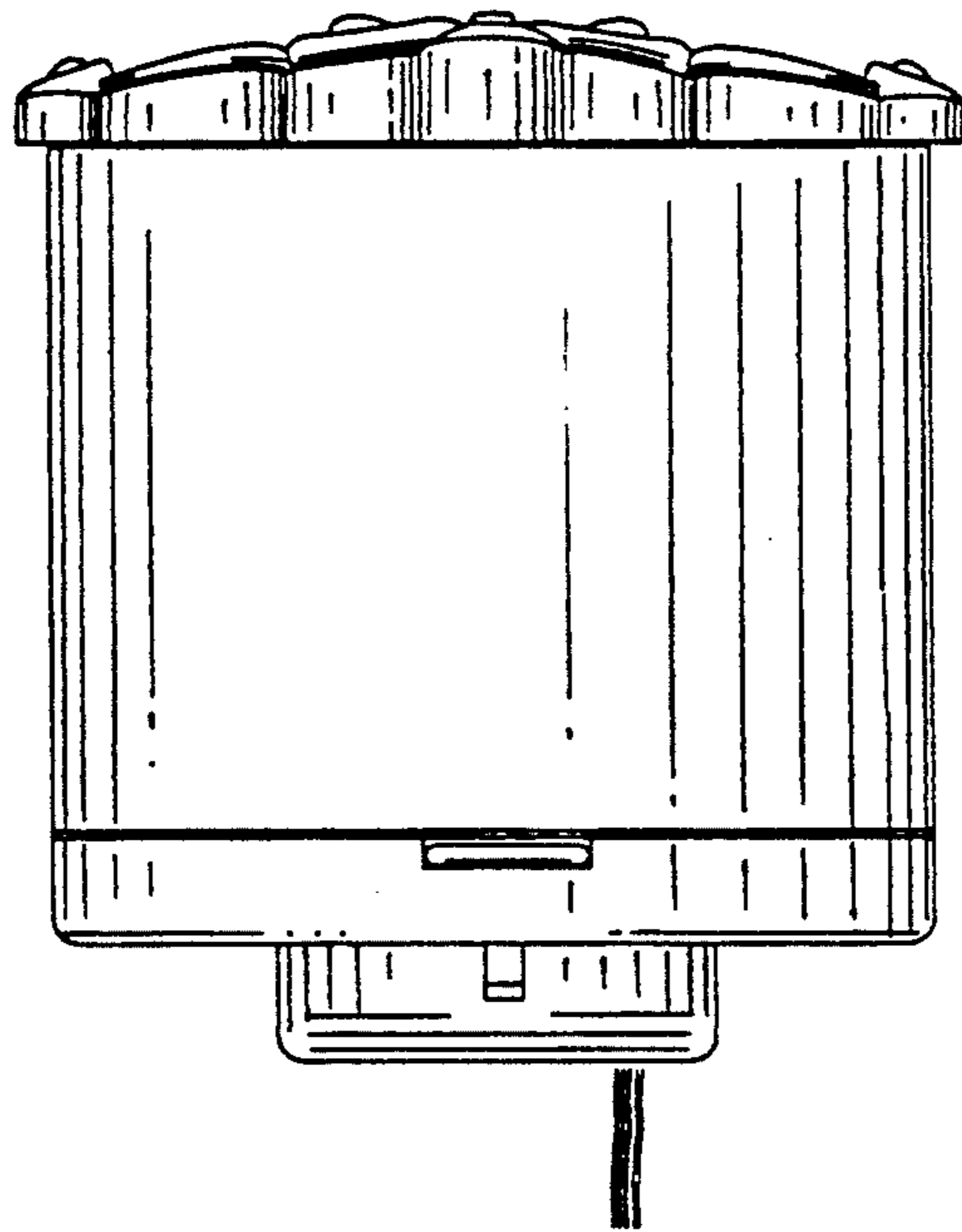

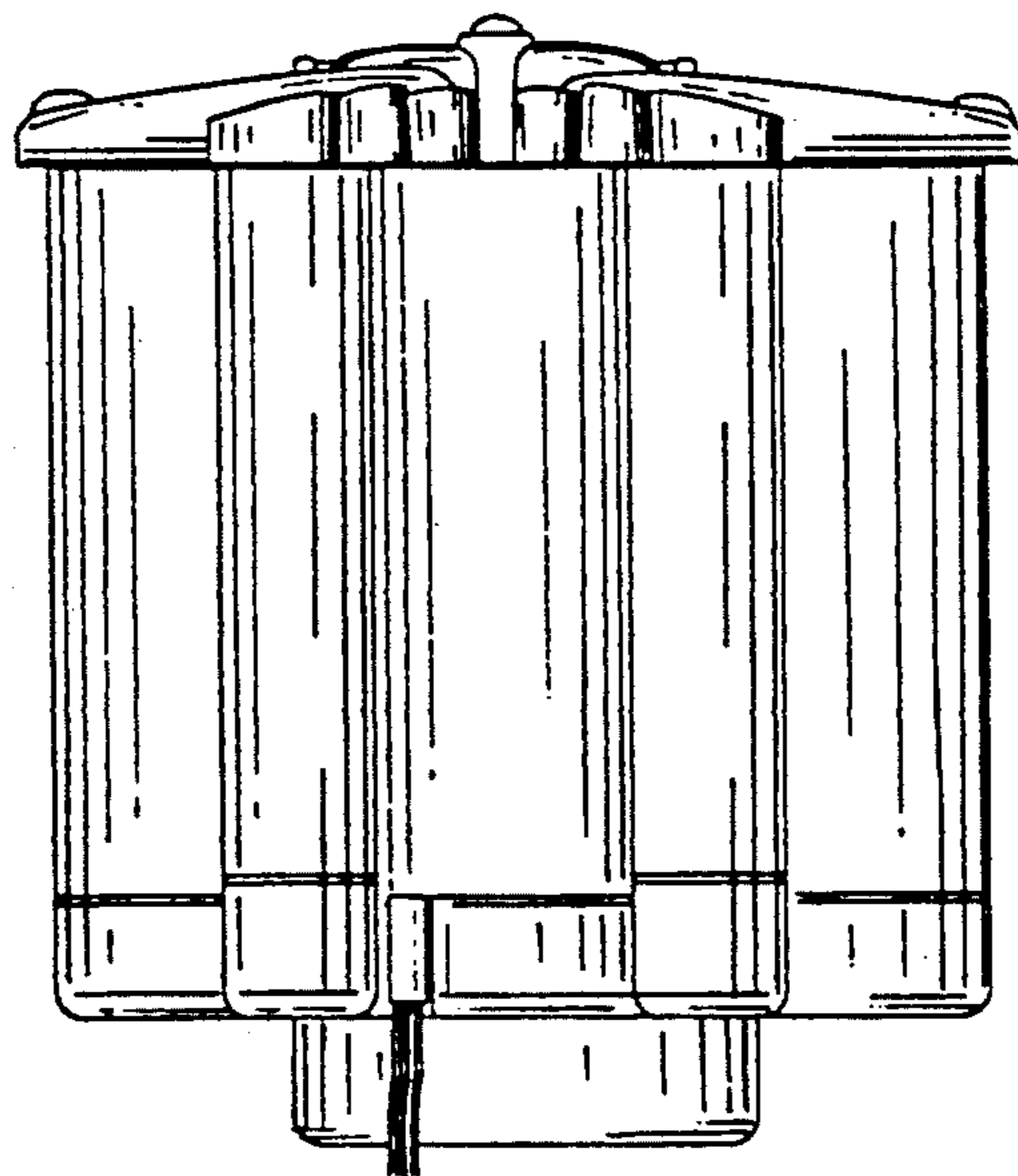

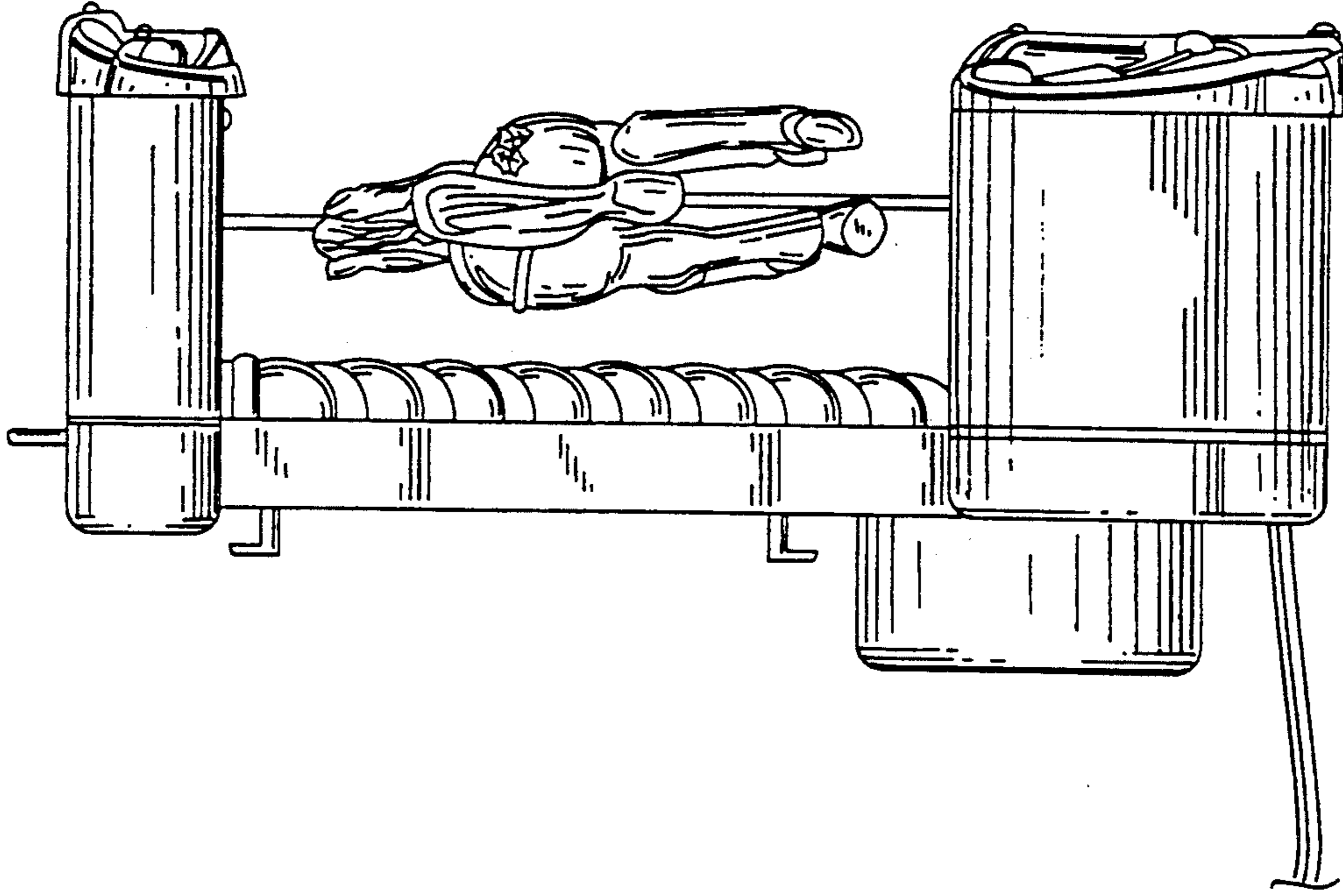

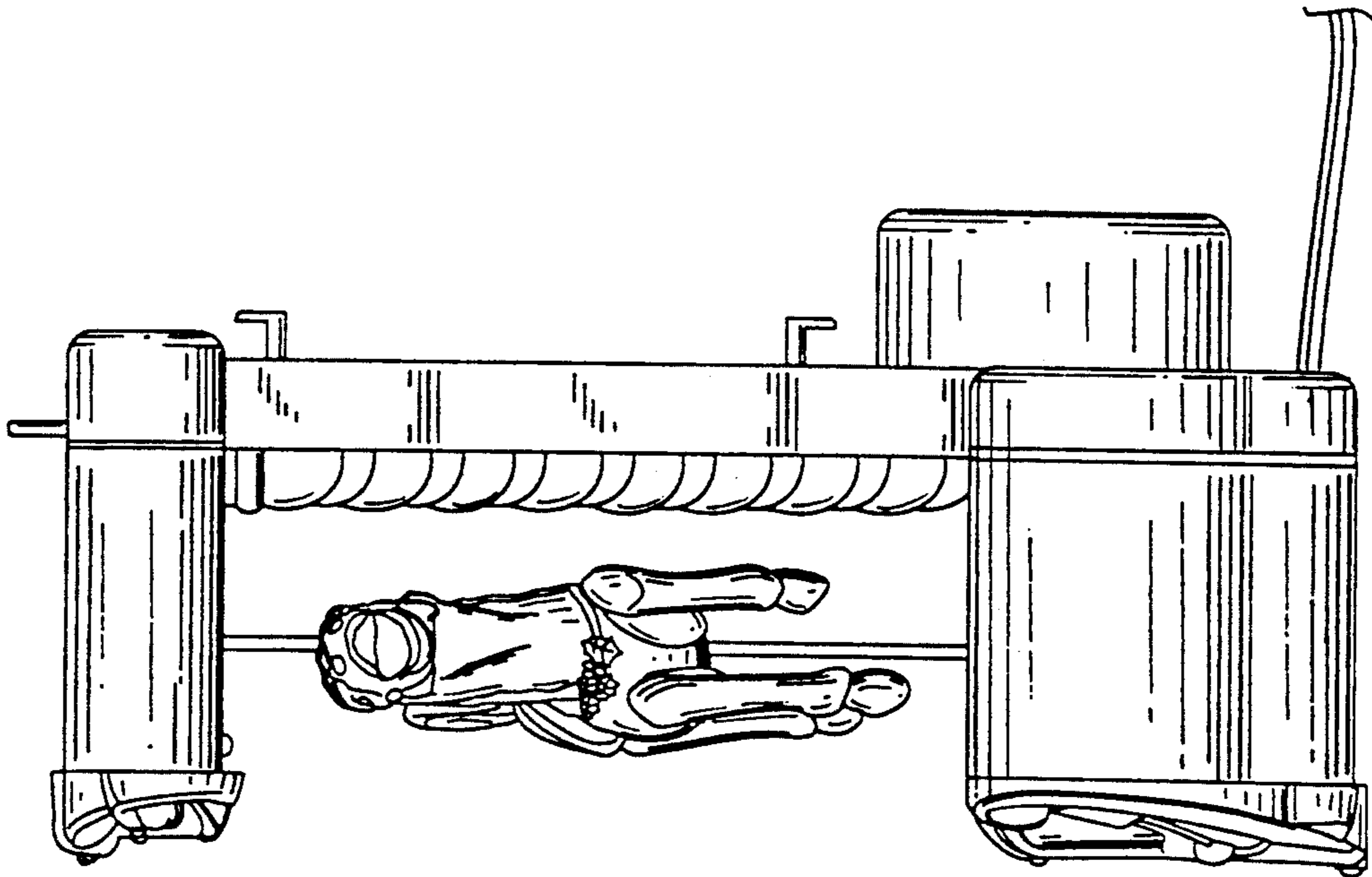

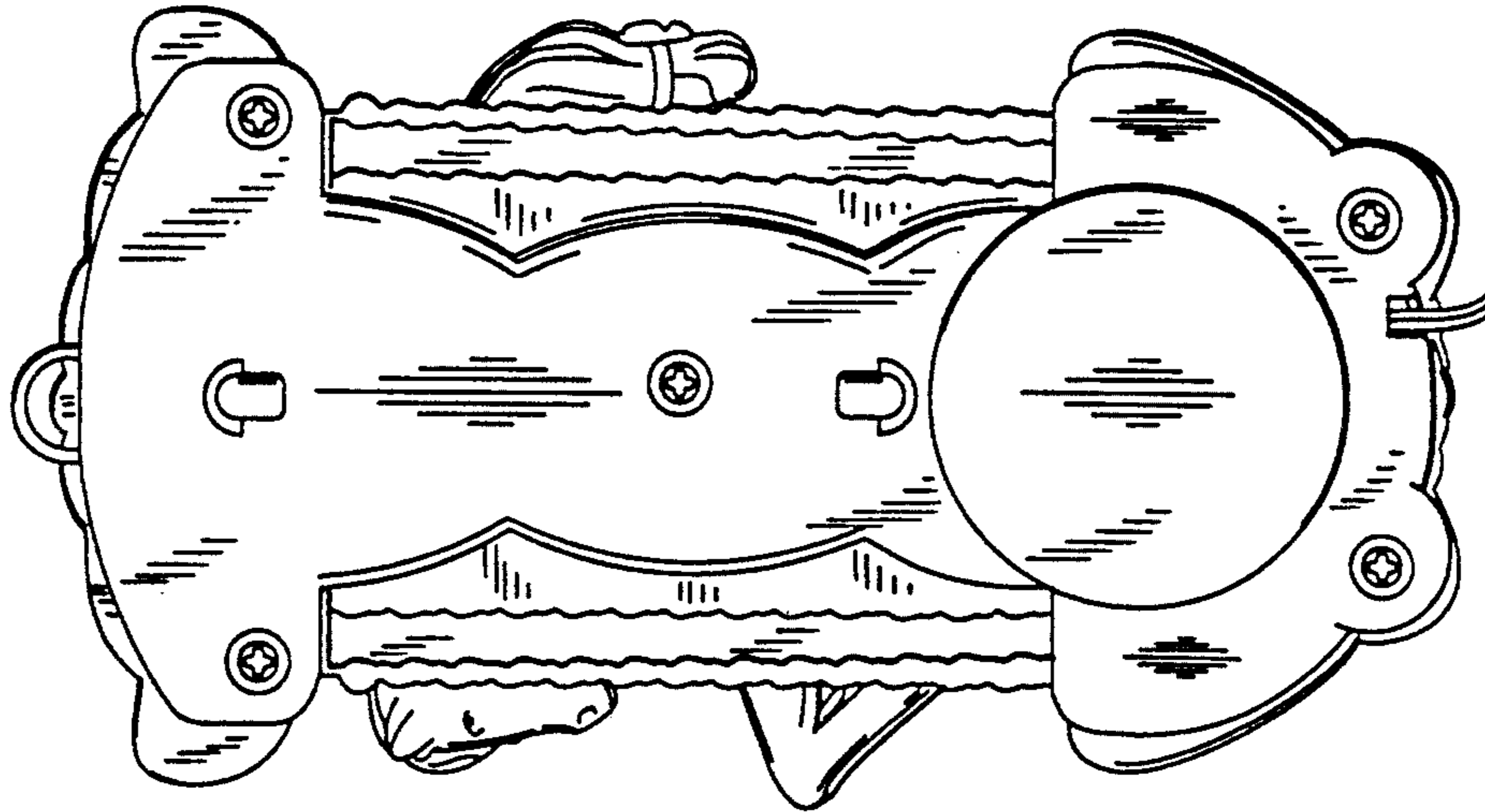

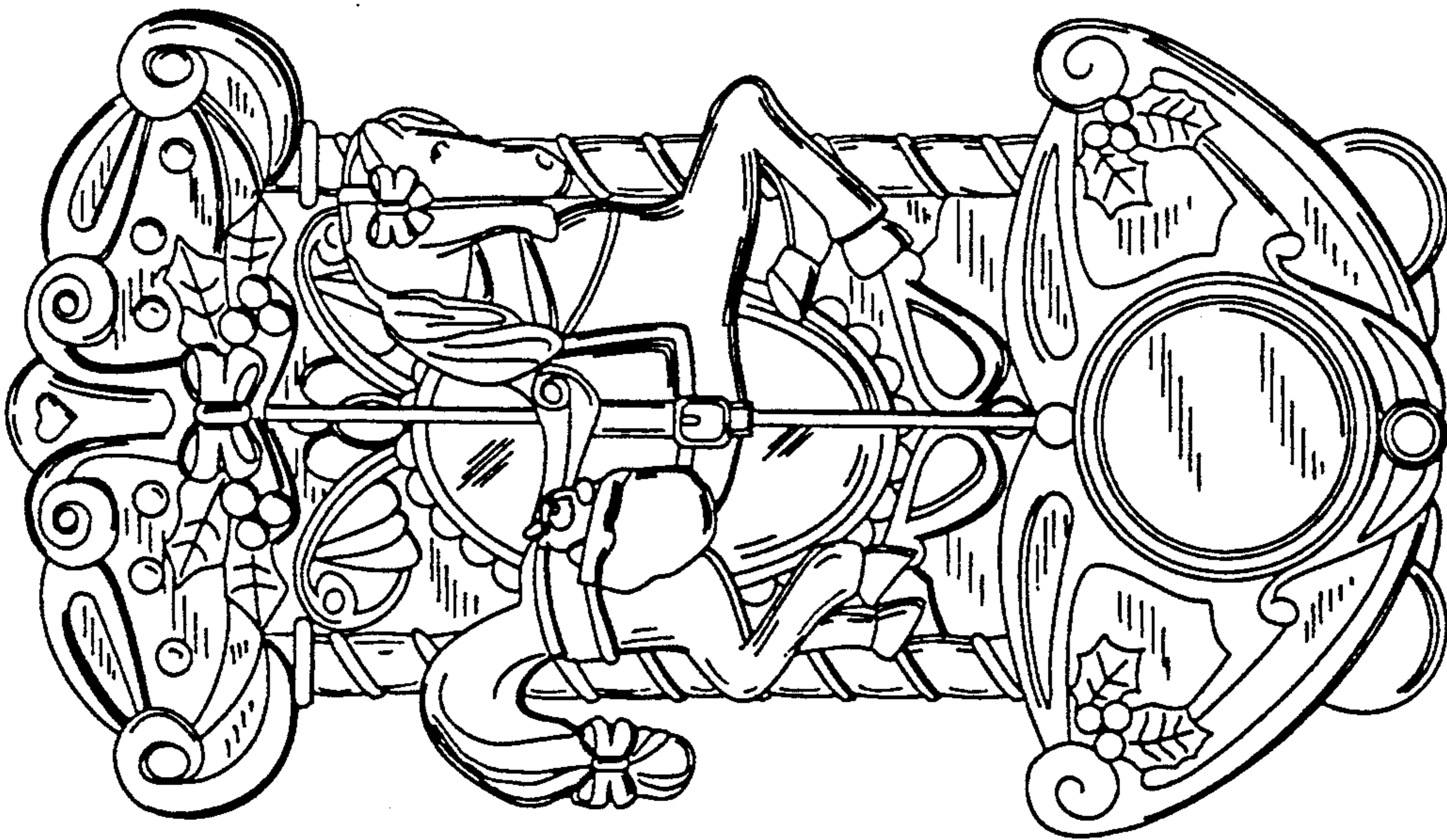

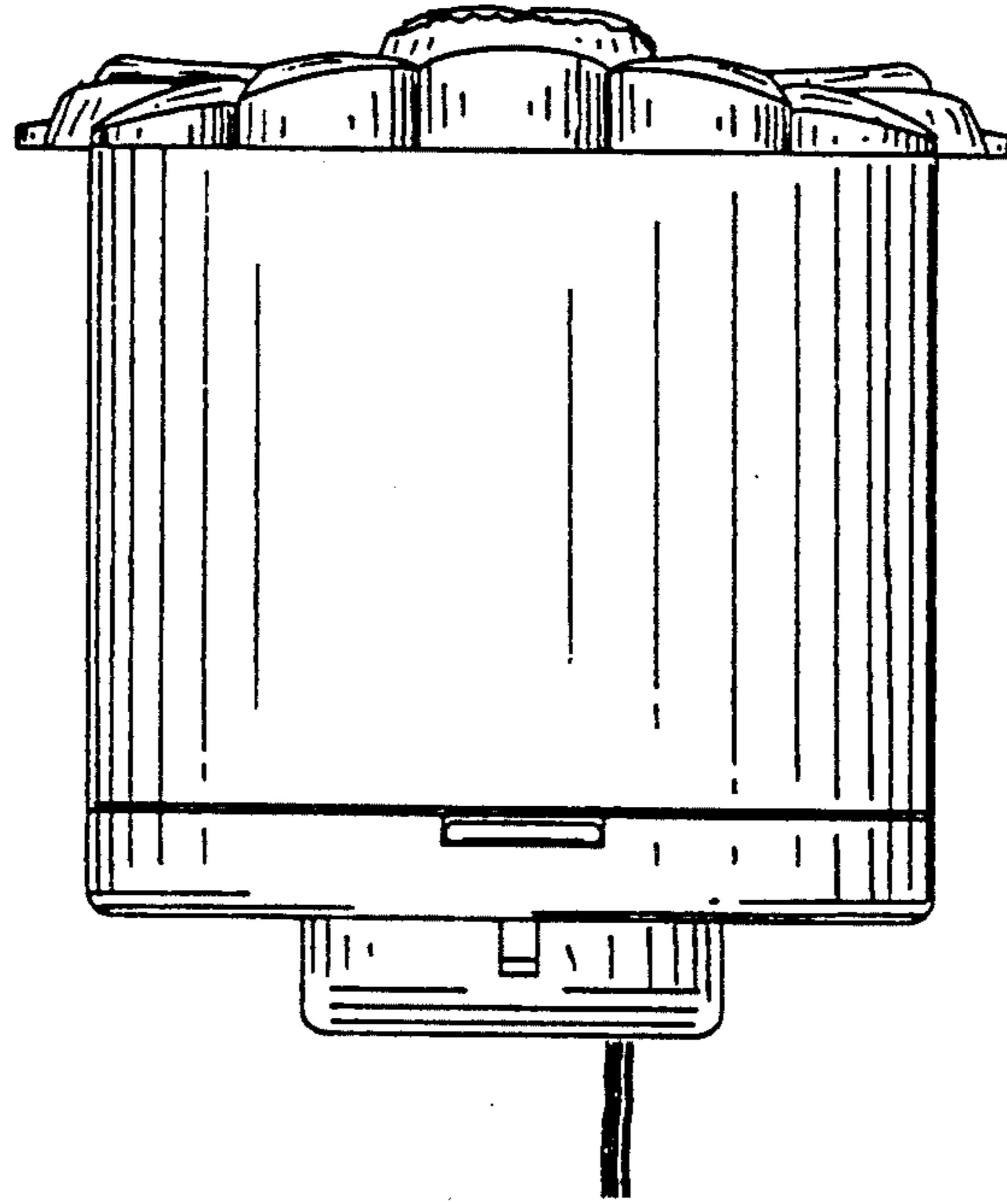

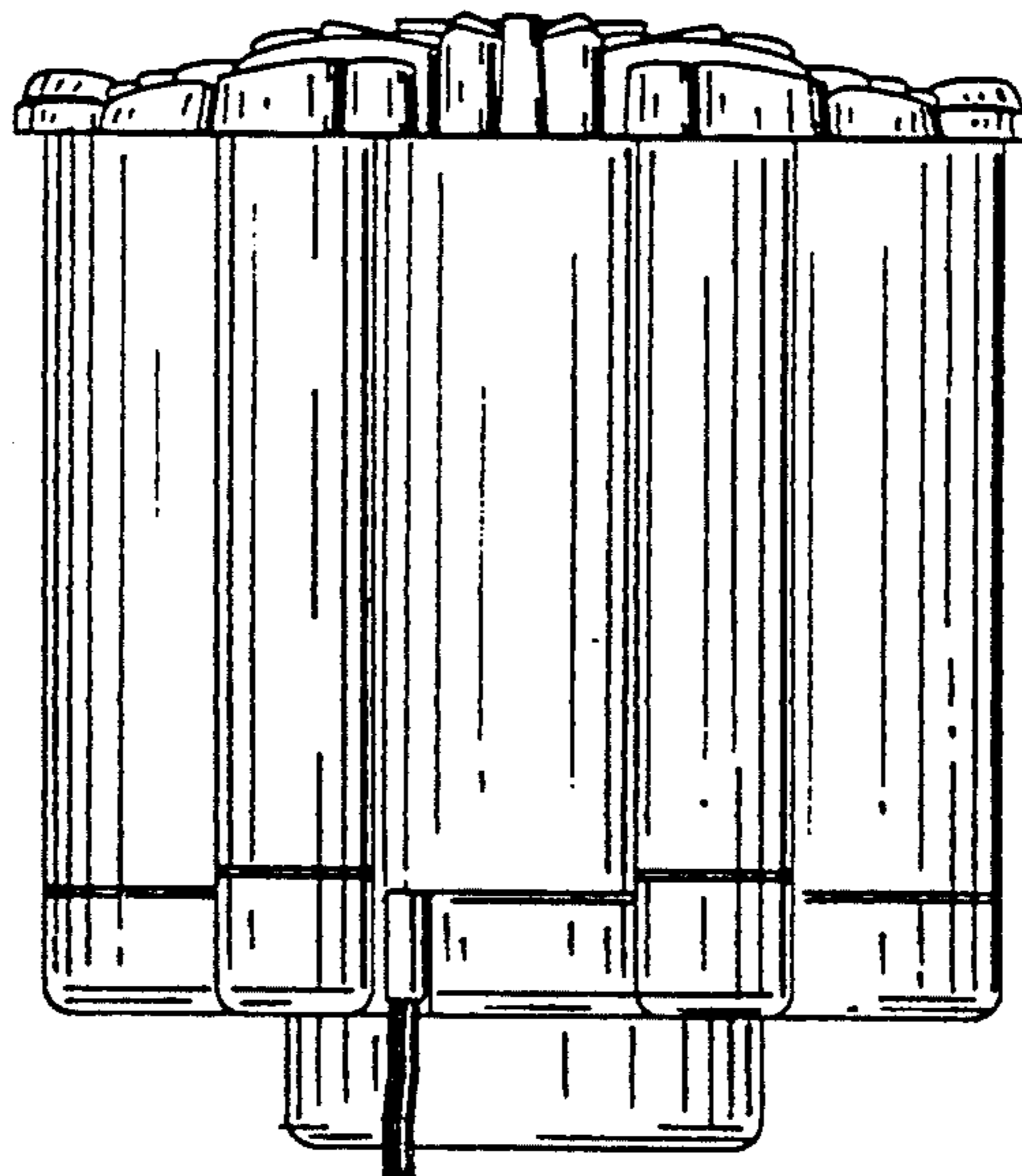

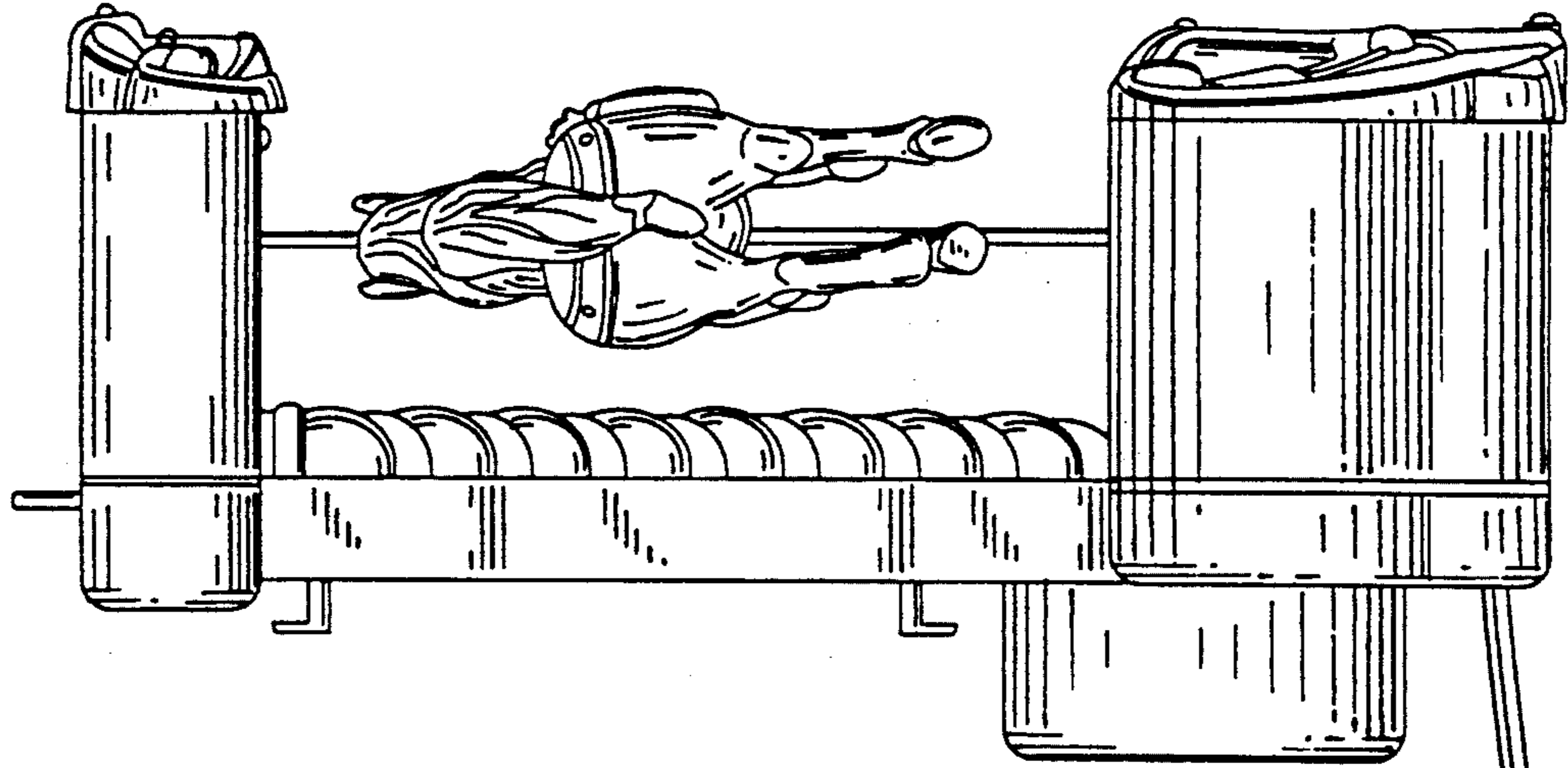

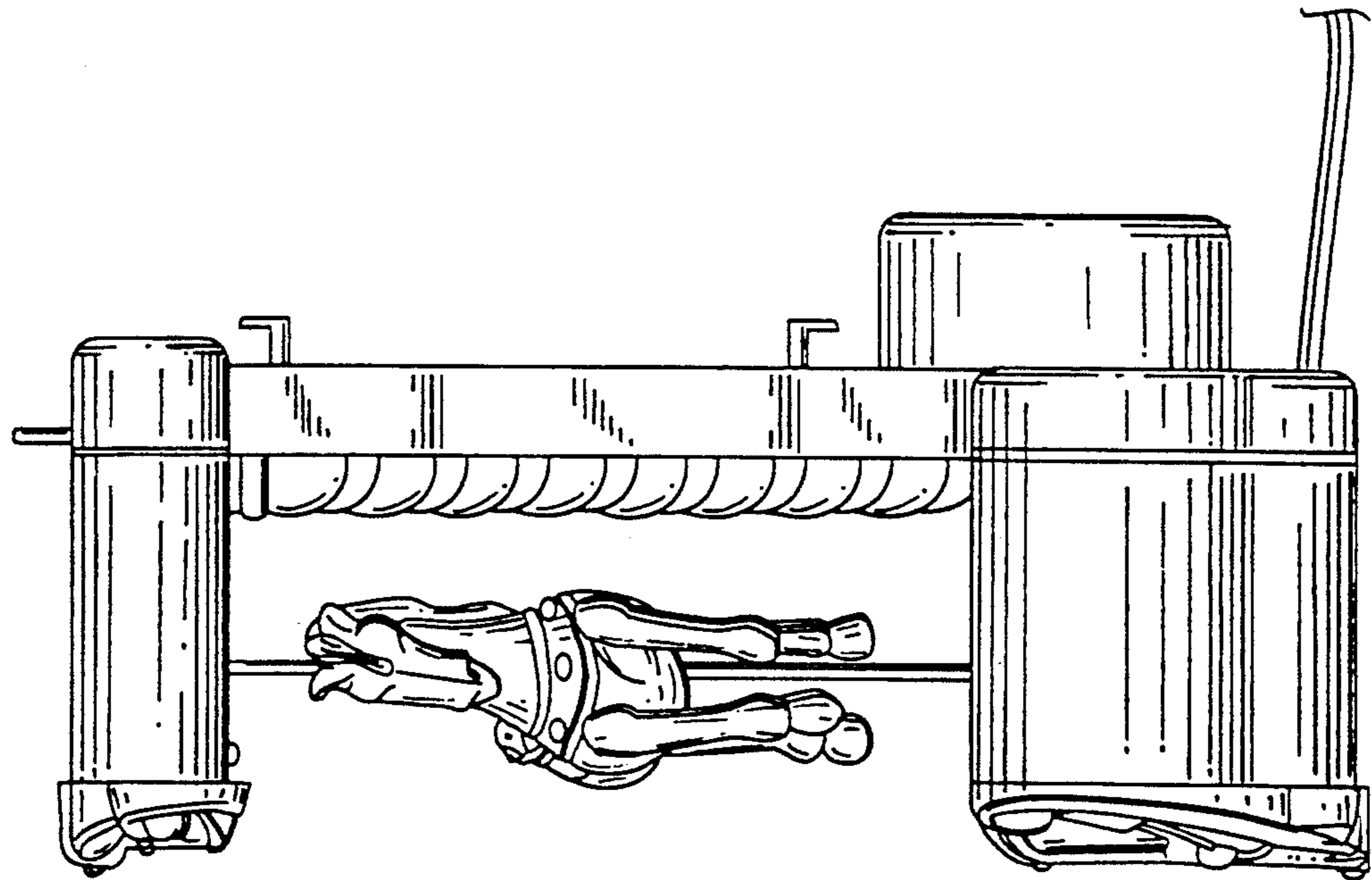
