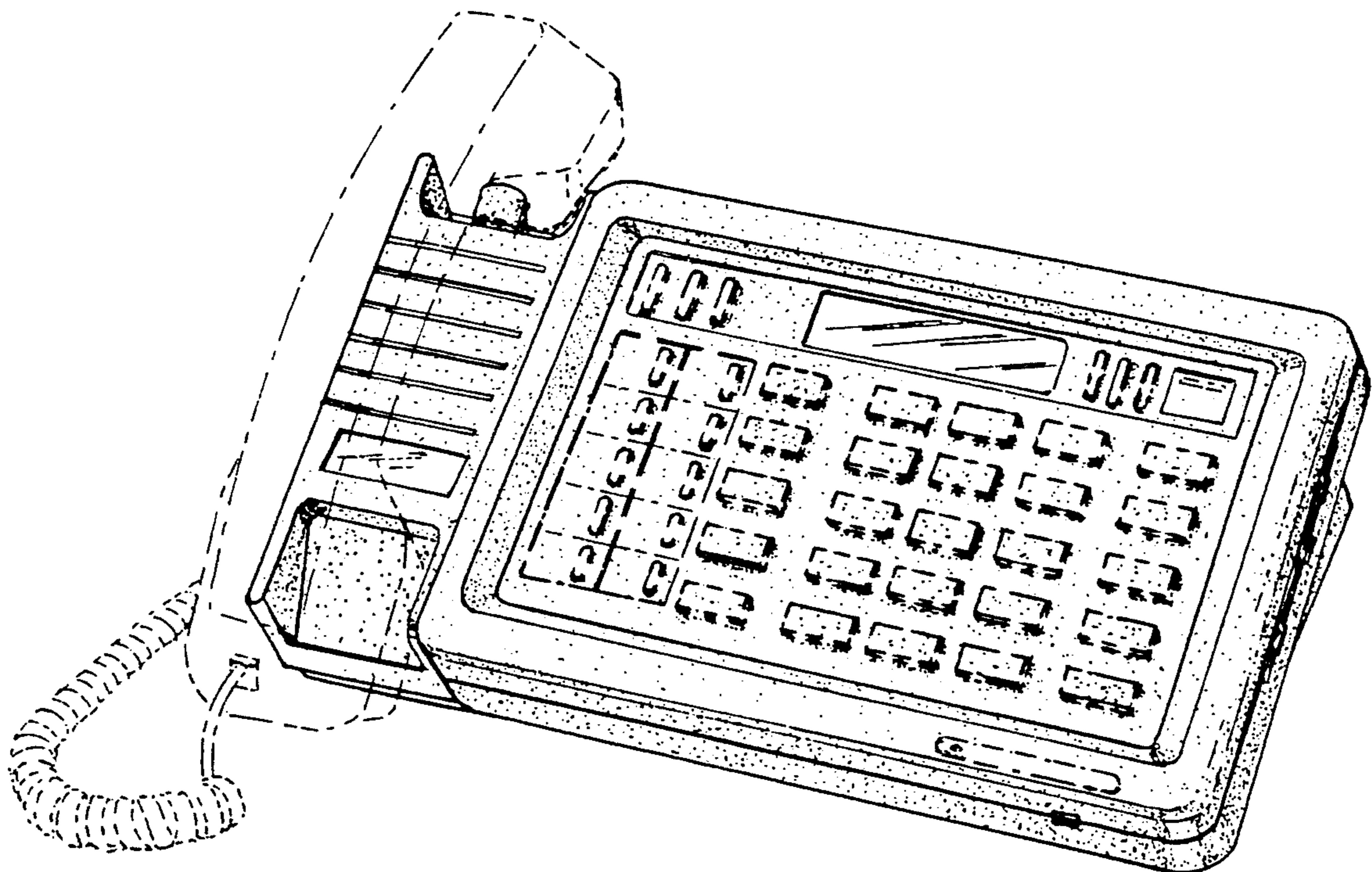
The ornamental design for a housing for base of telephone, as shown and described.

DESCRIPTION

FIG. 1 is a top-front perspective view of the housing for base of telephone with a broken line showing of a hand-set in a cradled position showing my new design;
 FIG. 2 is a front elevational view of the housing for base of telephone of FIG. 1;
 FIG. 3 is a right side elevational view of the housing for base of telephone of FIG. 1;
 FIG. 4 is a left side elevational view of the housing from base of telephone of FIG. 1;
 FIG. 5 is a rear elevational view of the housing for base of telephone of FIG. 1; and,
 FIG. 6 is a top plan view of the housing for base of telephone of FIG. 1.

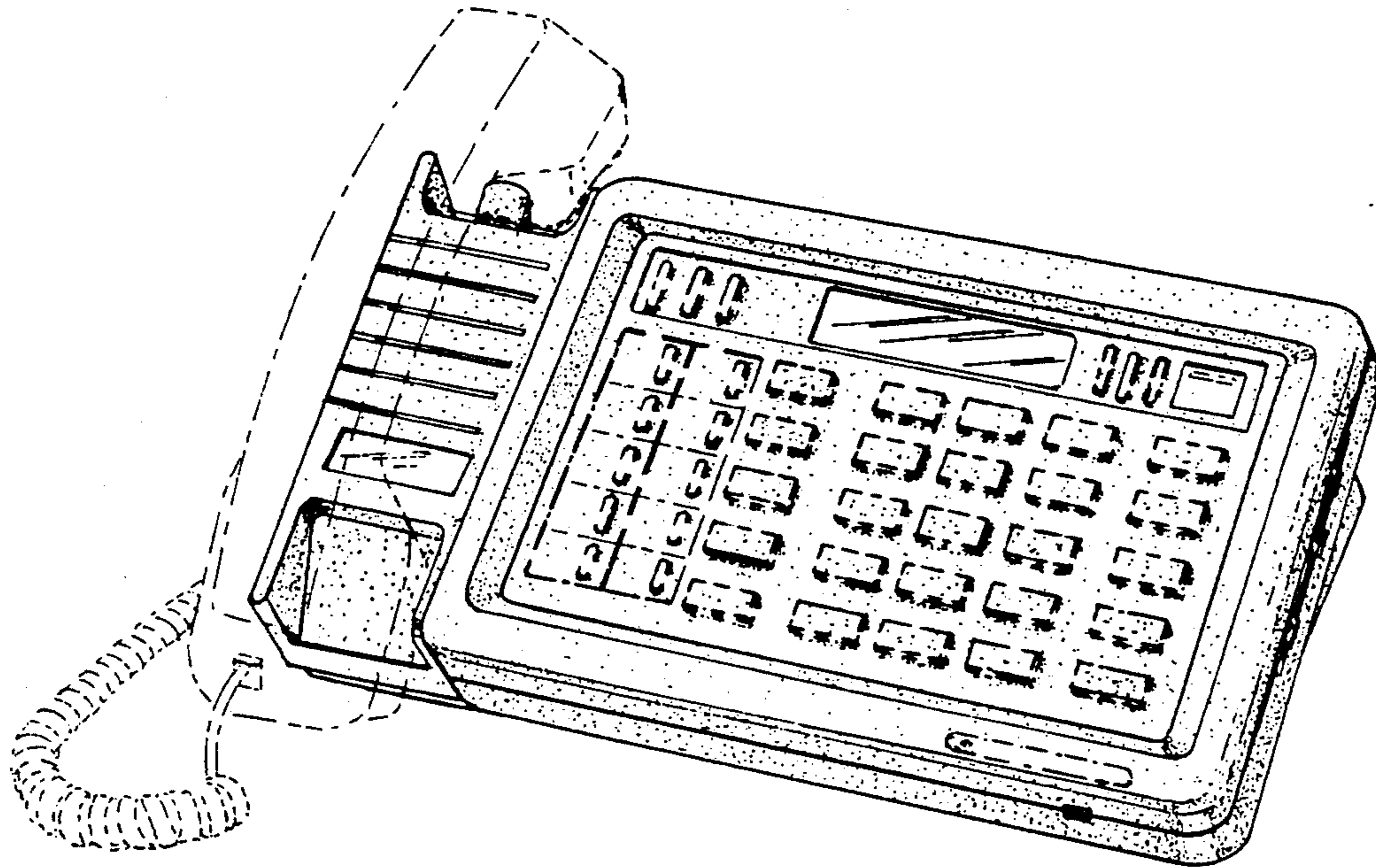

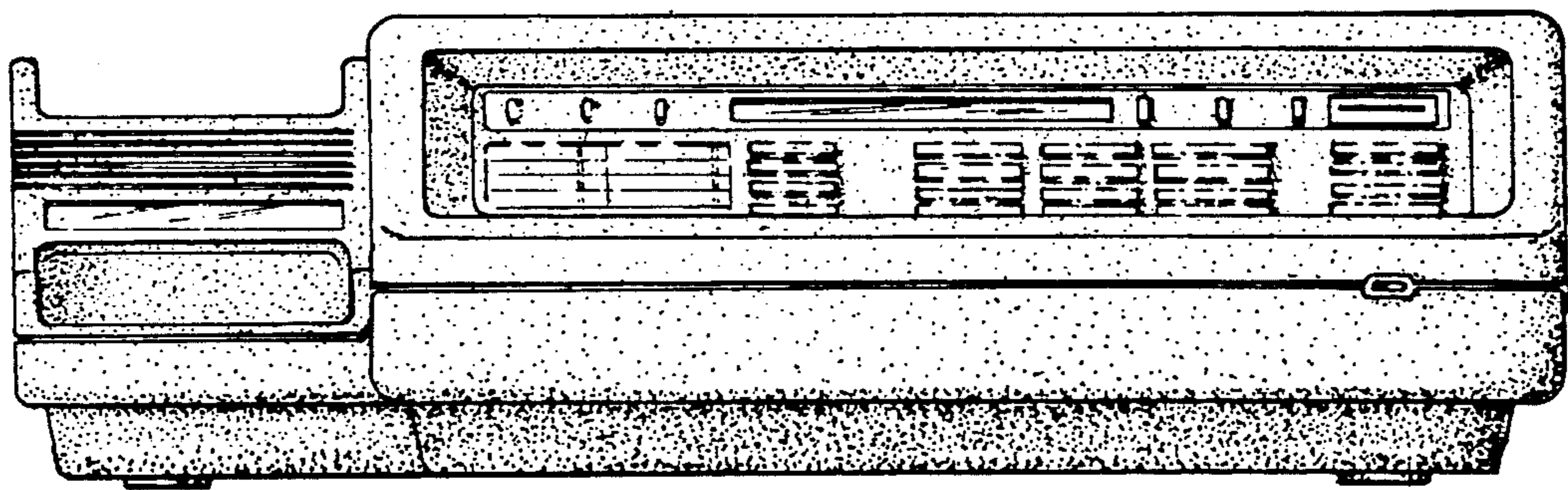

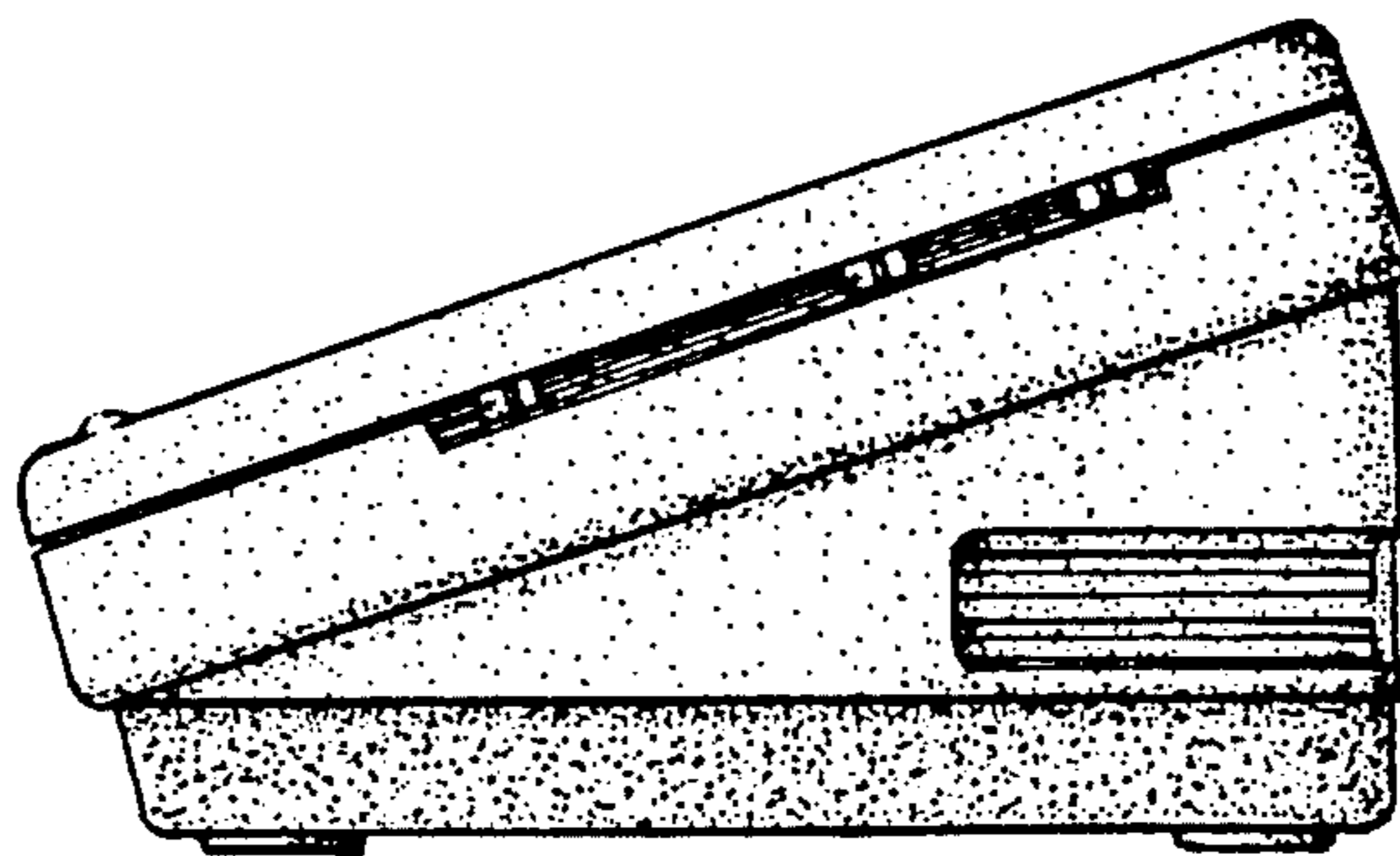

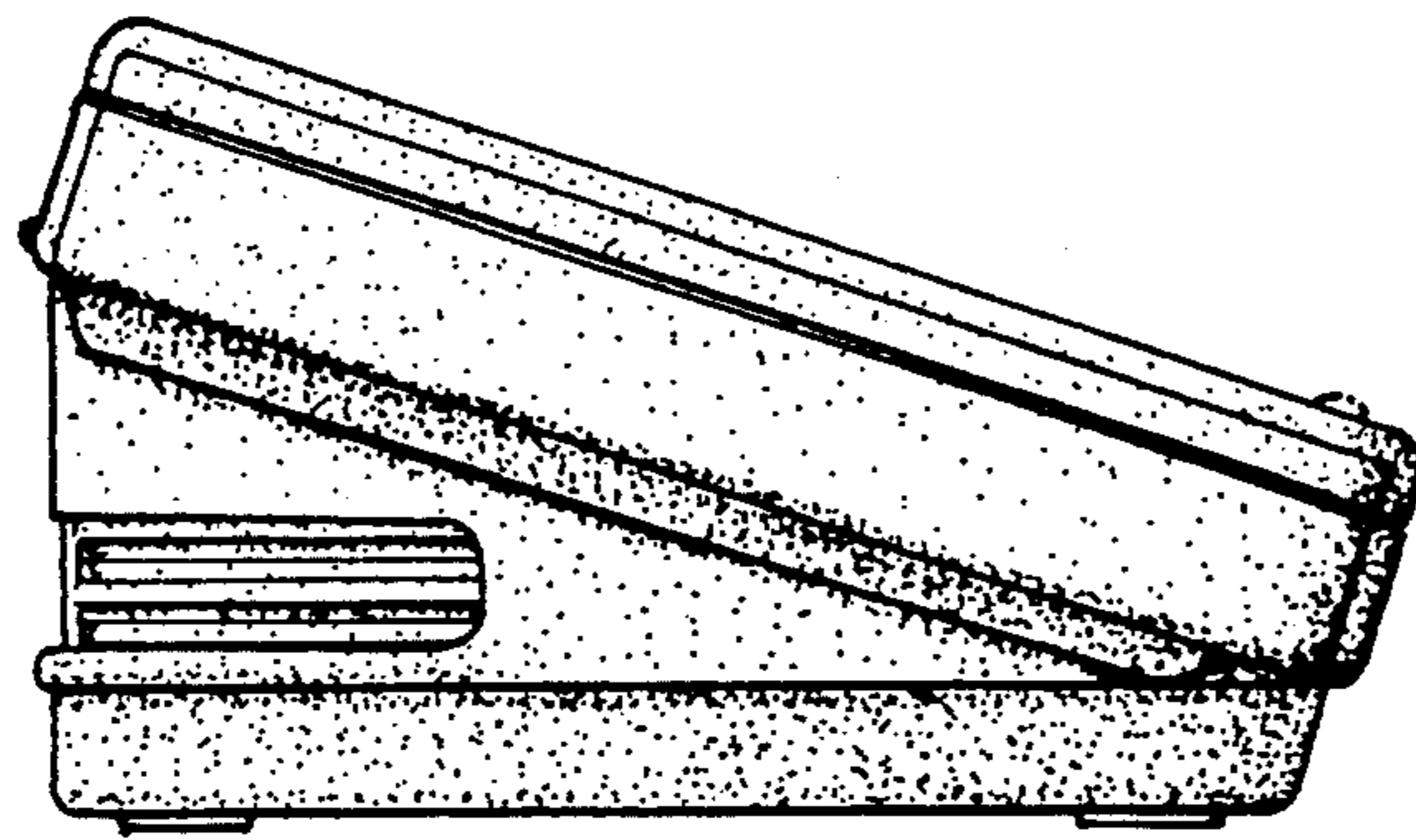

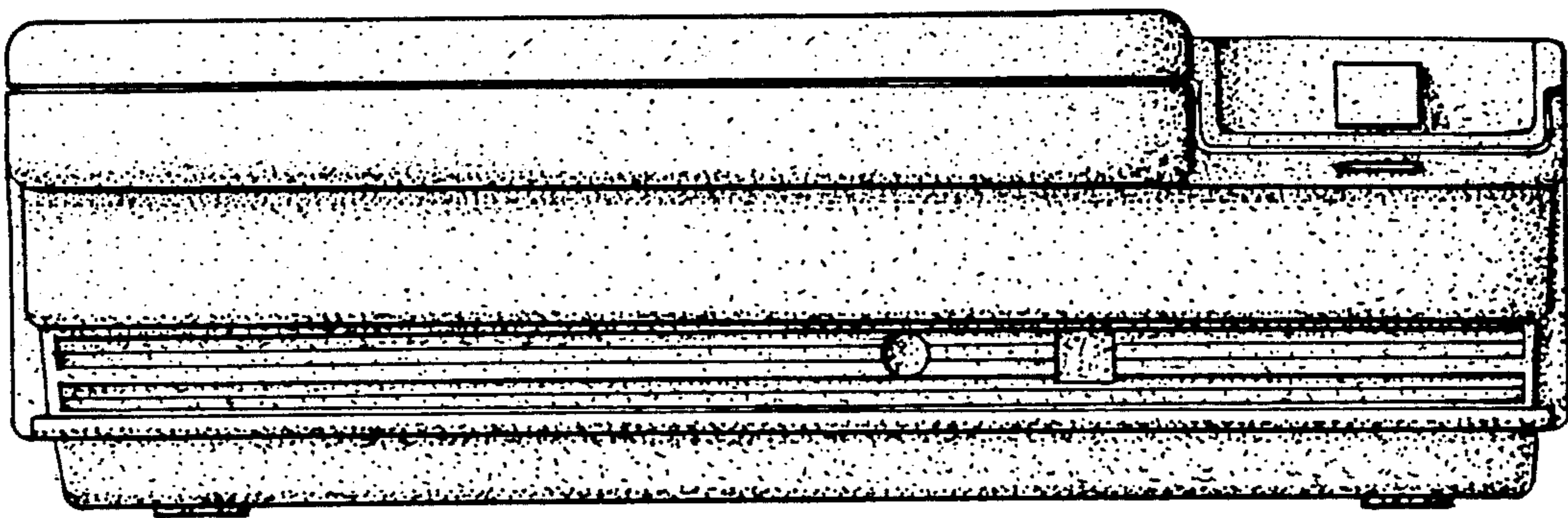

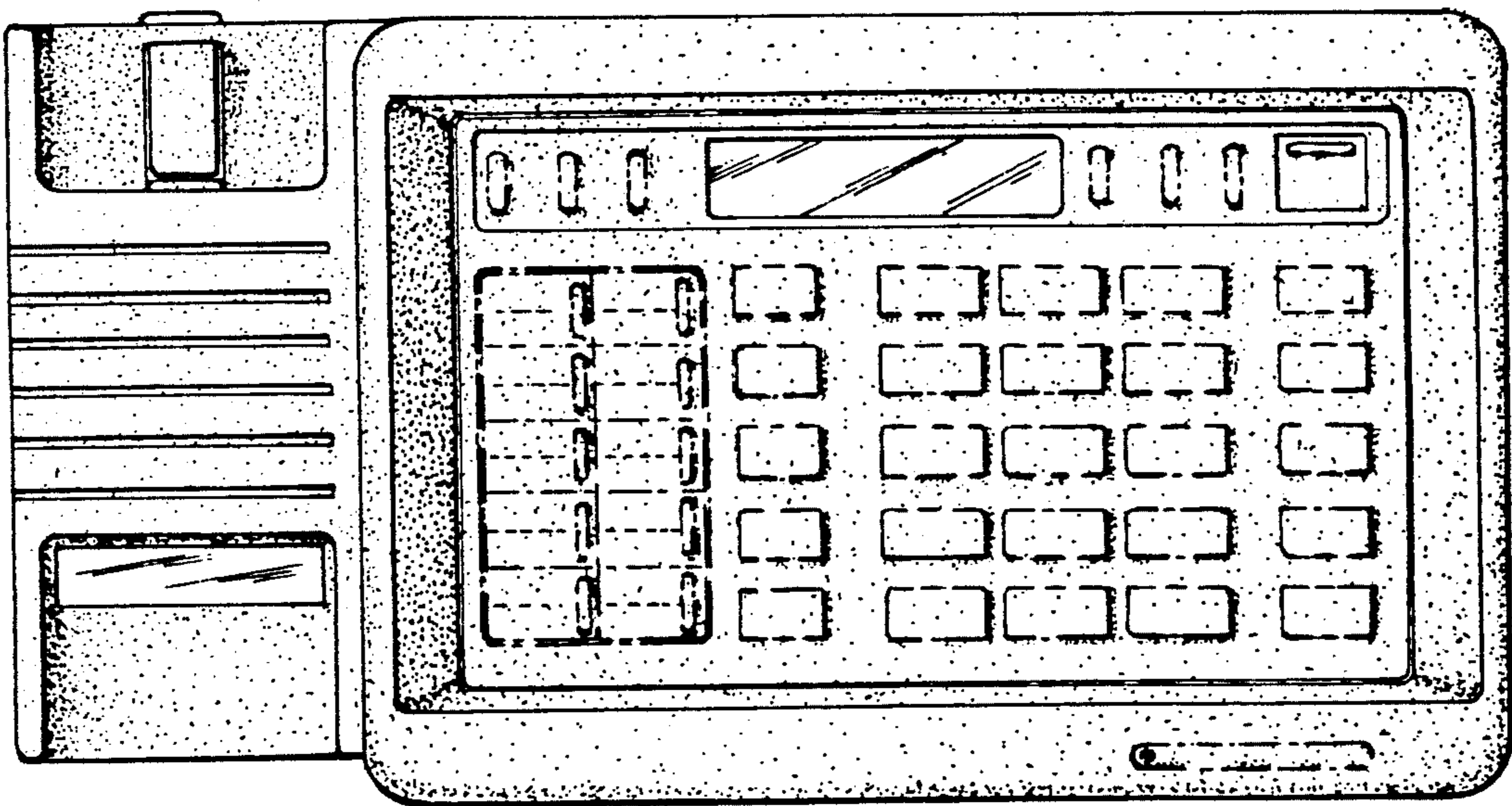
