[57] CLAIM

The ornamental design for a bicycle anti-theft assembly, as shown and described.

DESCRIPTION

FIG. 1 is a front and left side perspective view of a bicycle anti-theft assembly showing my new design, the broken-line disclosure of a plunger-type lock element being for illustrative purposes only and forming no part of the claimed design;

FIG. 2 is an enlarged top plan view thereof;

FIG. 3 is an enlarged front elevational view thereof;

FIG. 4 is an enlarged left side elevational view thereof;

FIG. 5 is an enlarged right side elevational view thereof;

FIG. 6 is an enlarged rear elevational view thereof;

FIG. 7 is an enlarged bottom plan view thereof;

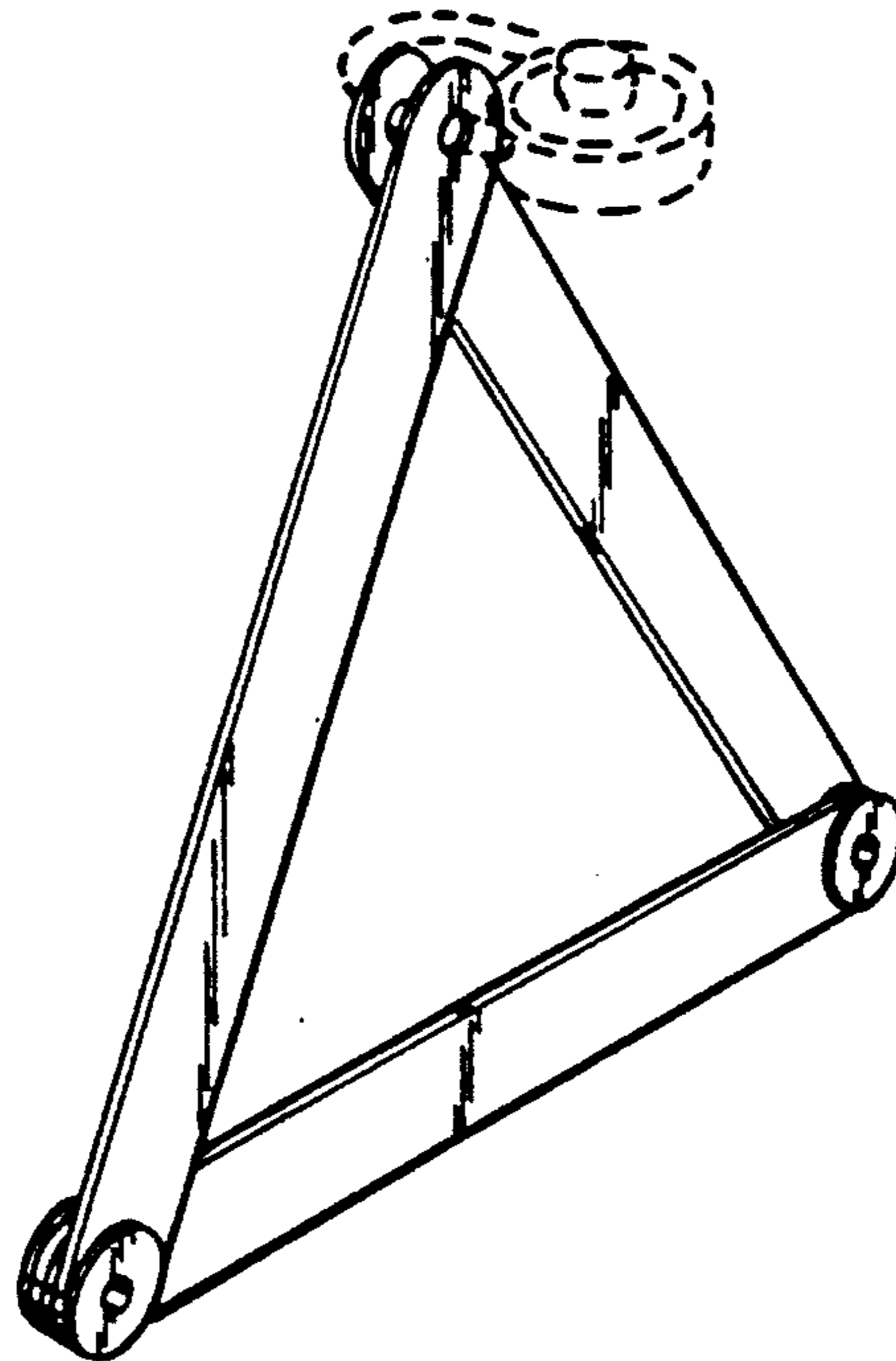
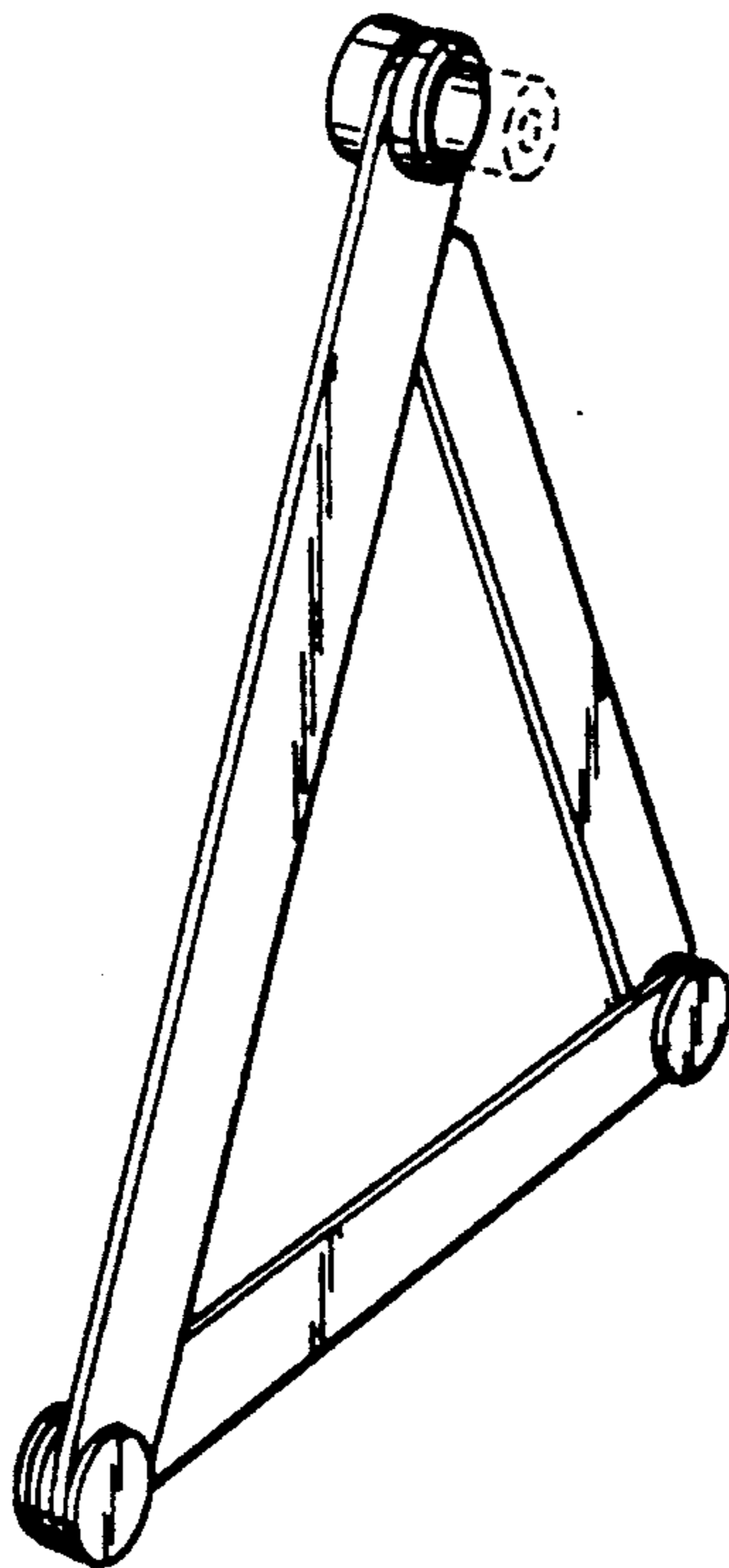

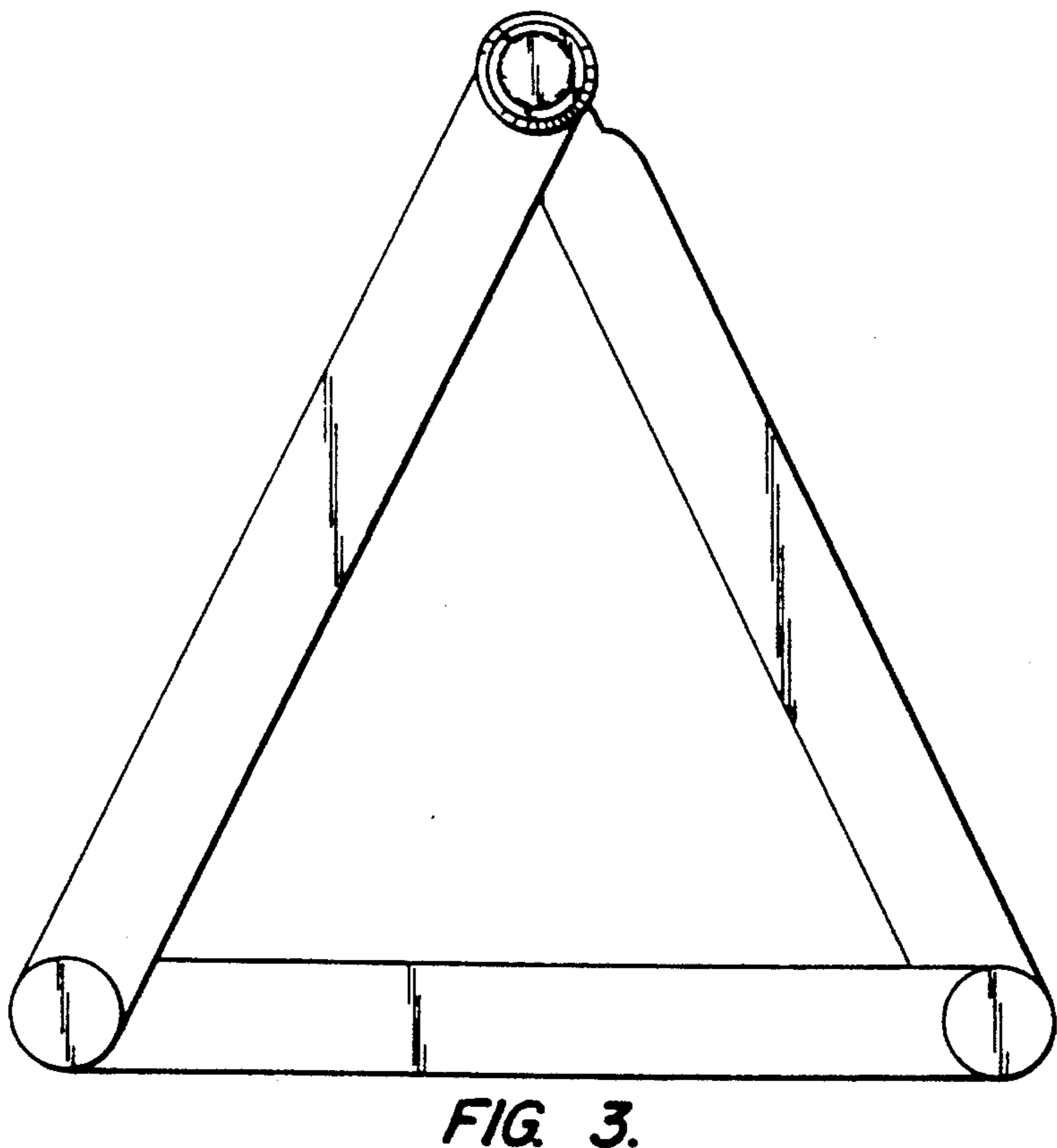
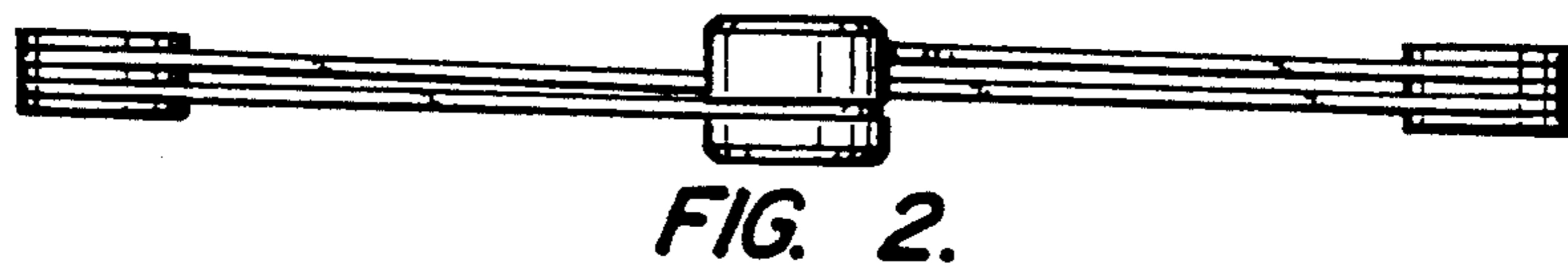
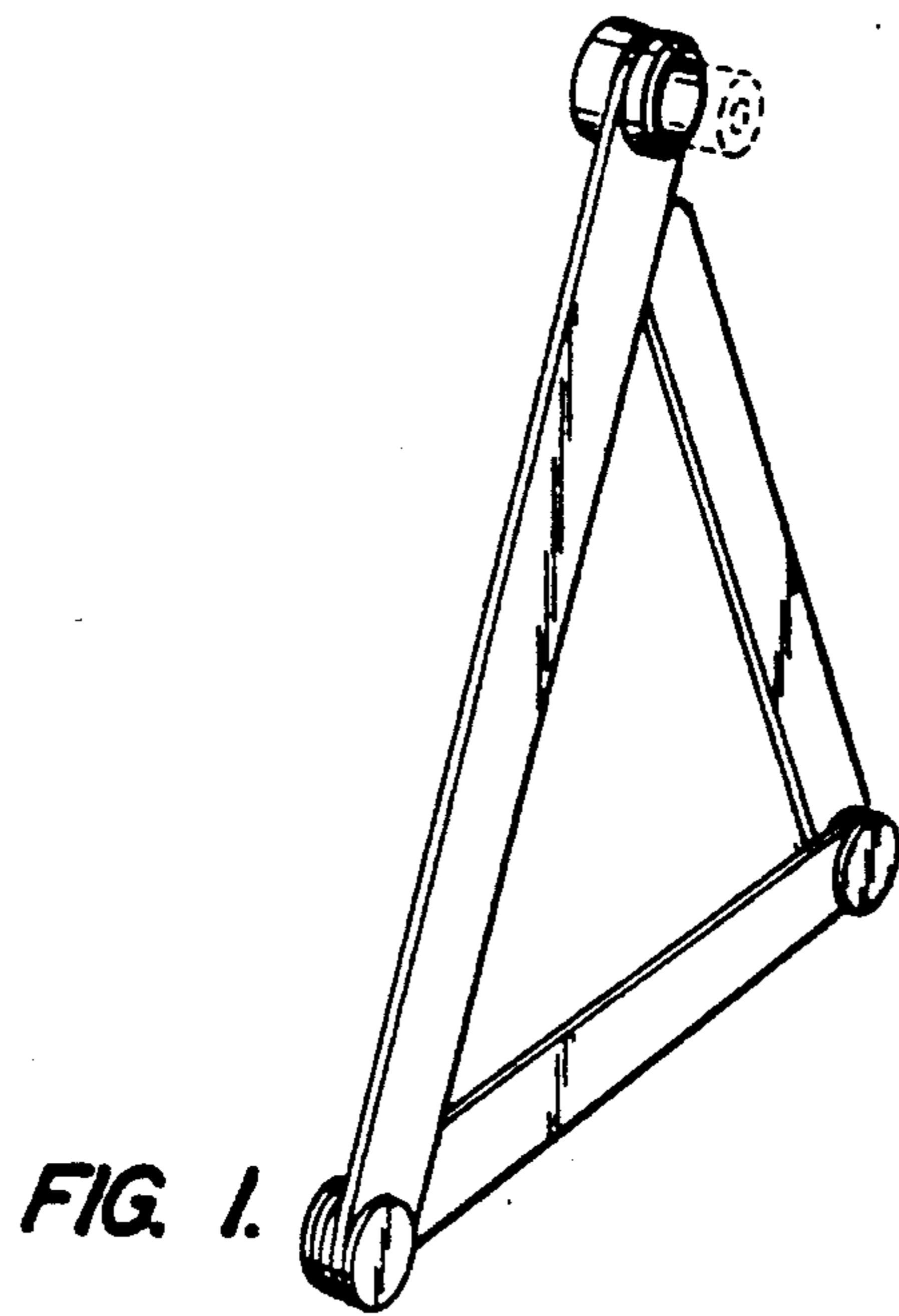
FIG. 9 is an enlarged top plan view thereof;

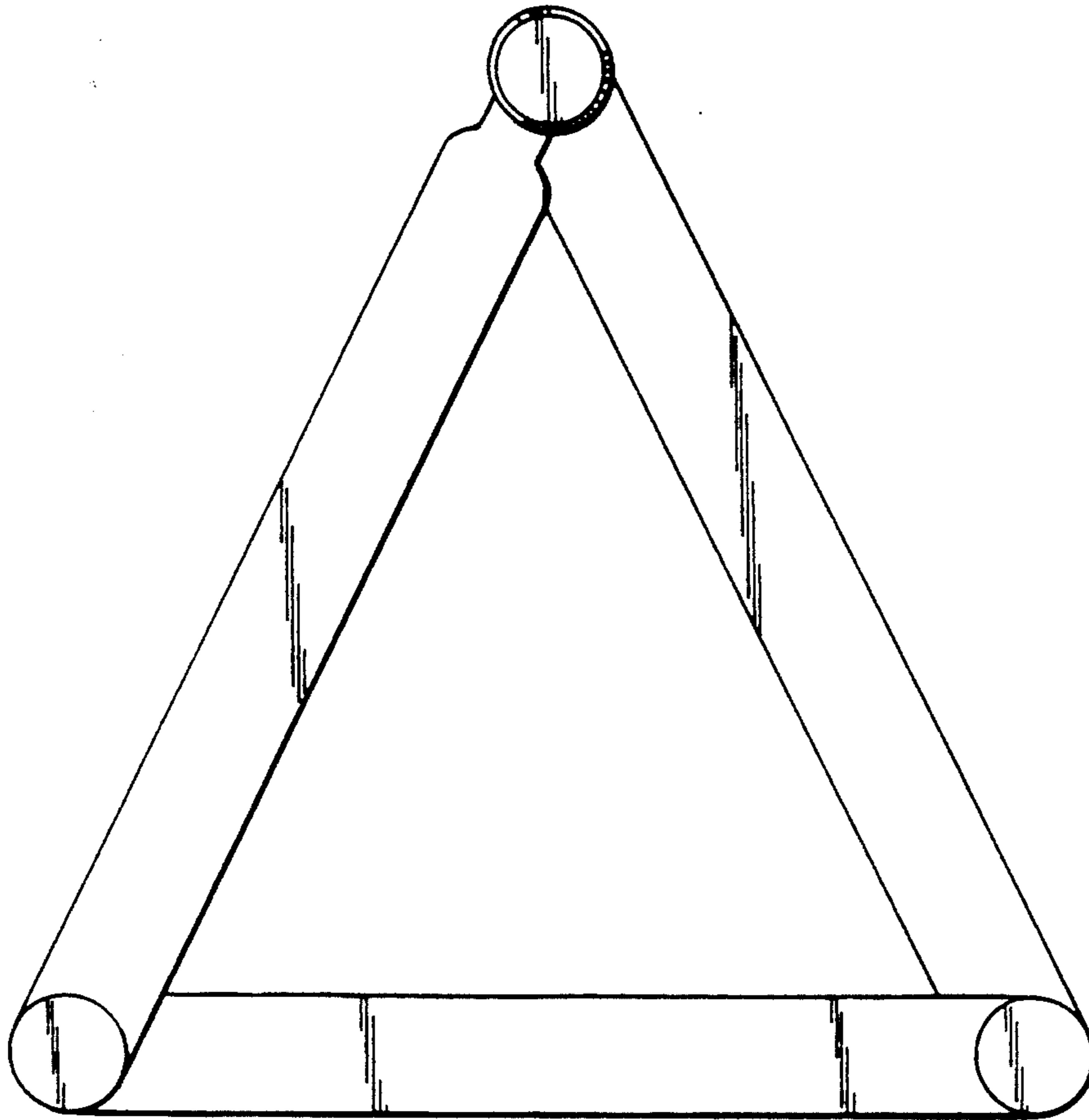
FIG. 10 is an enlarged front elevational view thereof, the rear being identical in appearance;

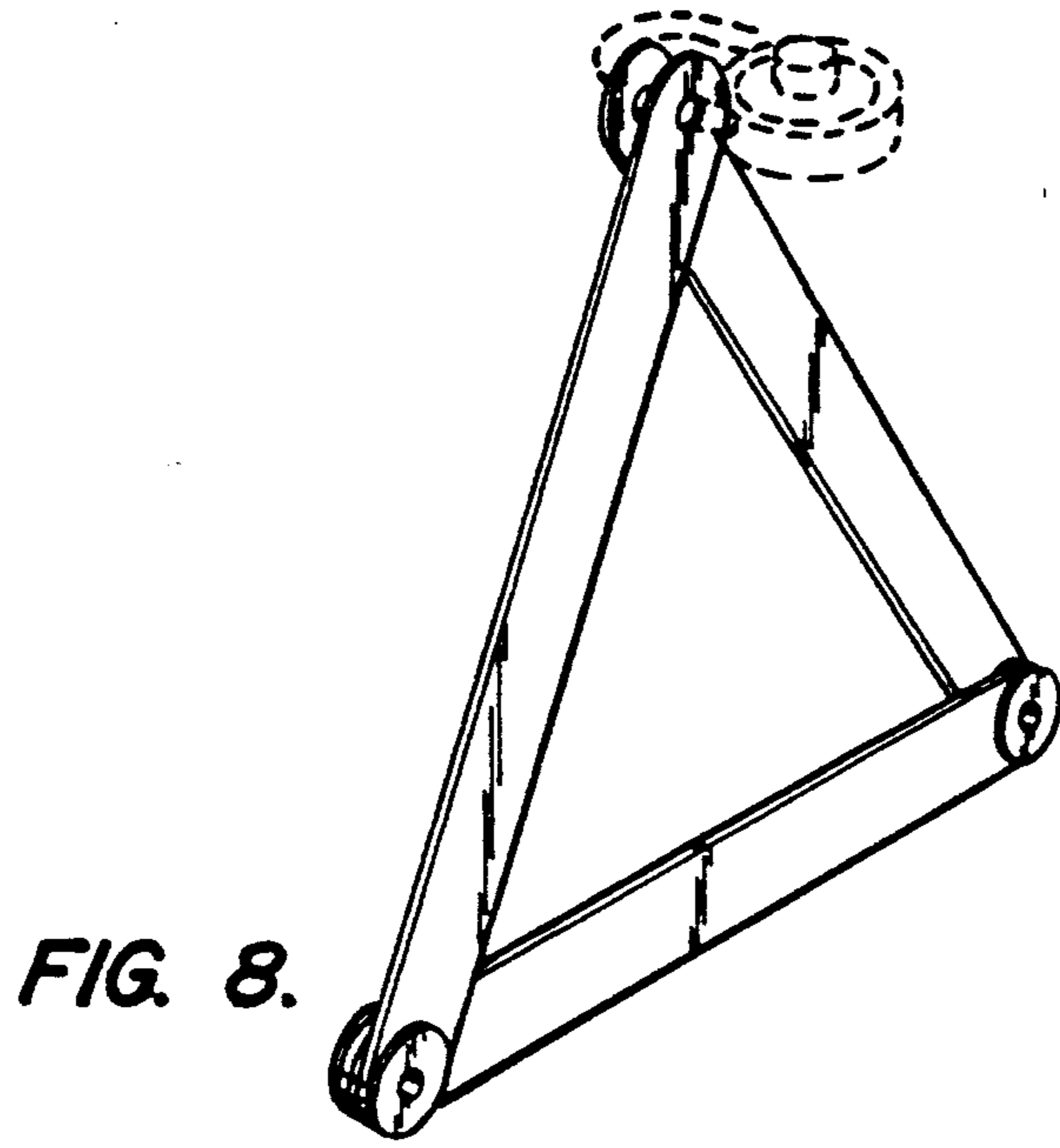

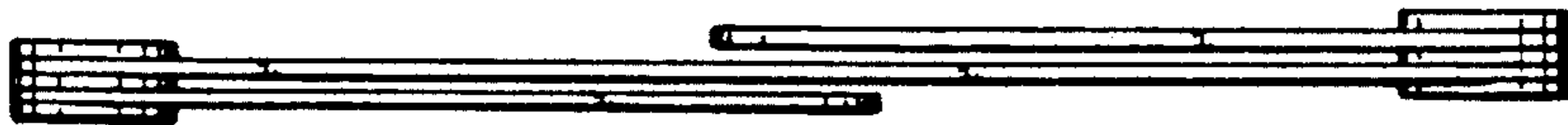

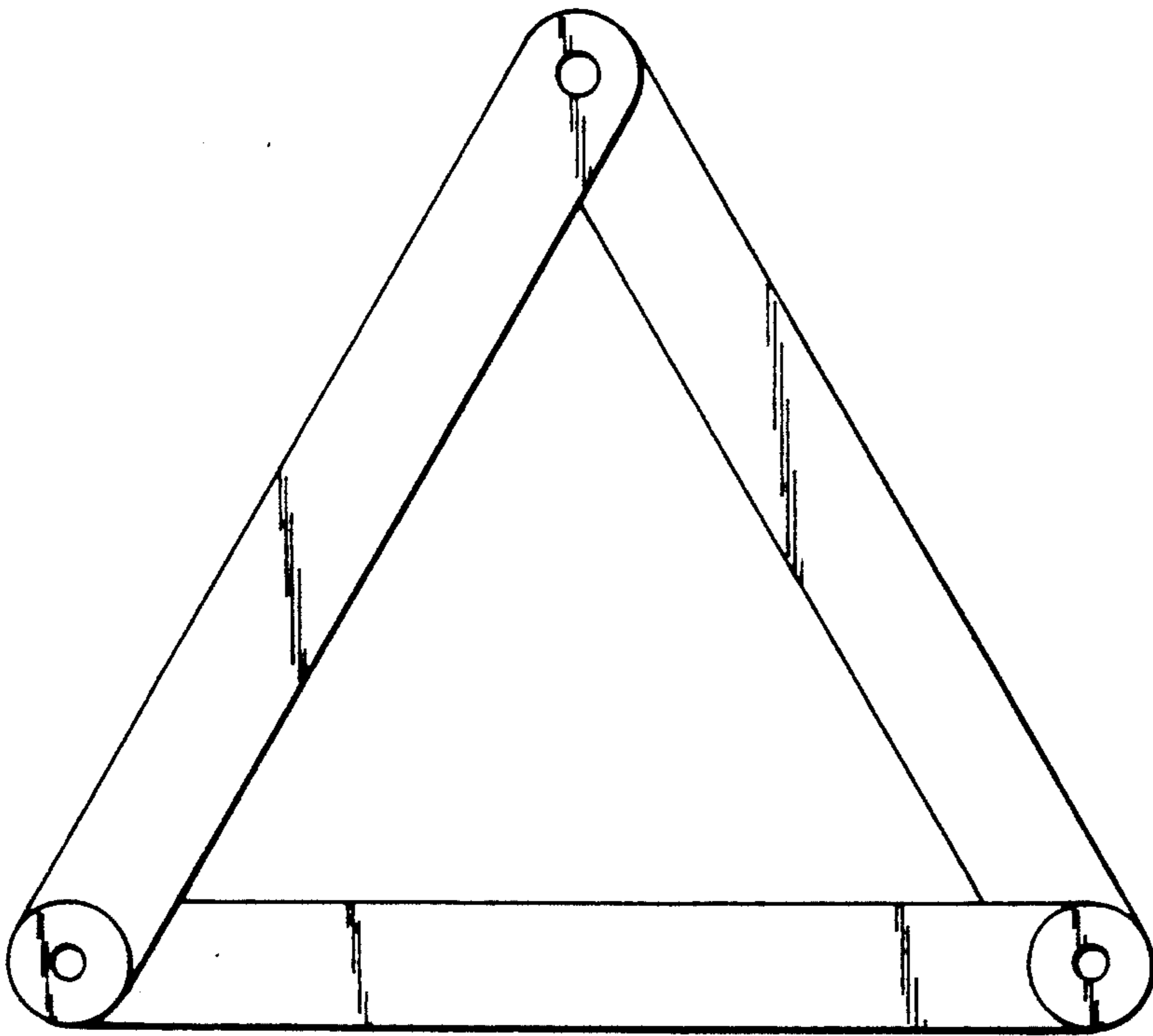

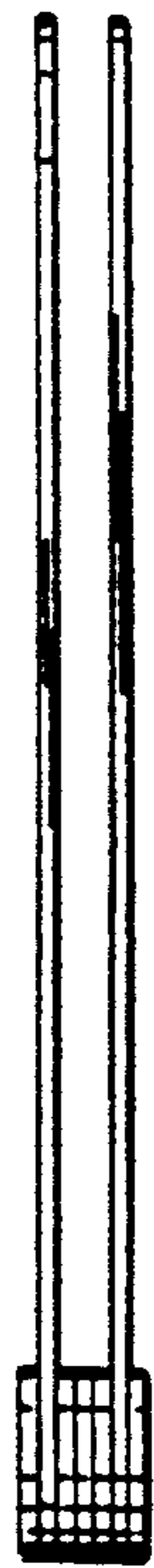

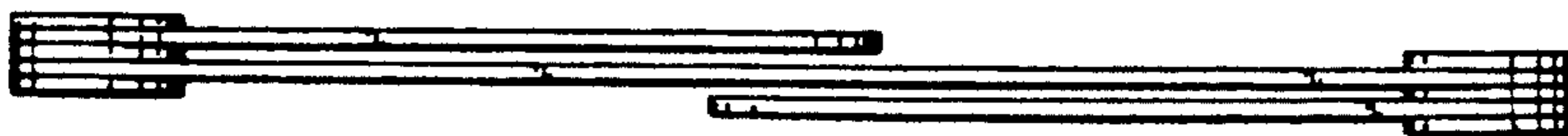
