FIG. 18 is a bottom plan view of a third embodiment thereof.

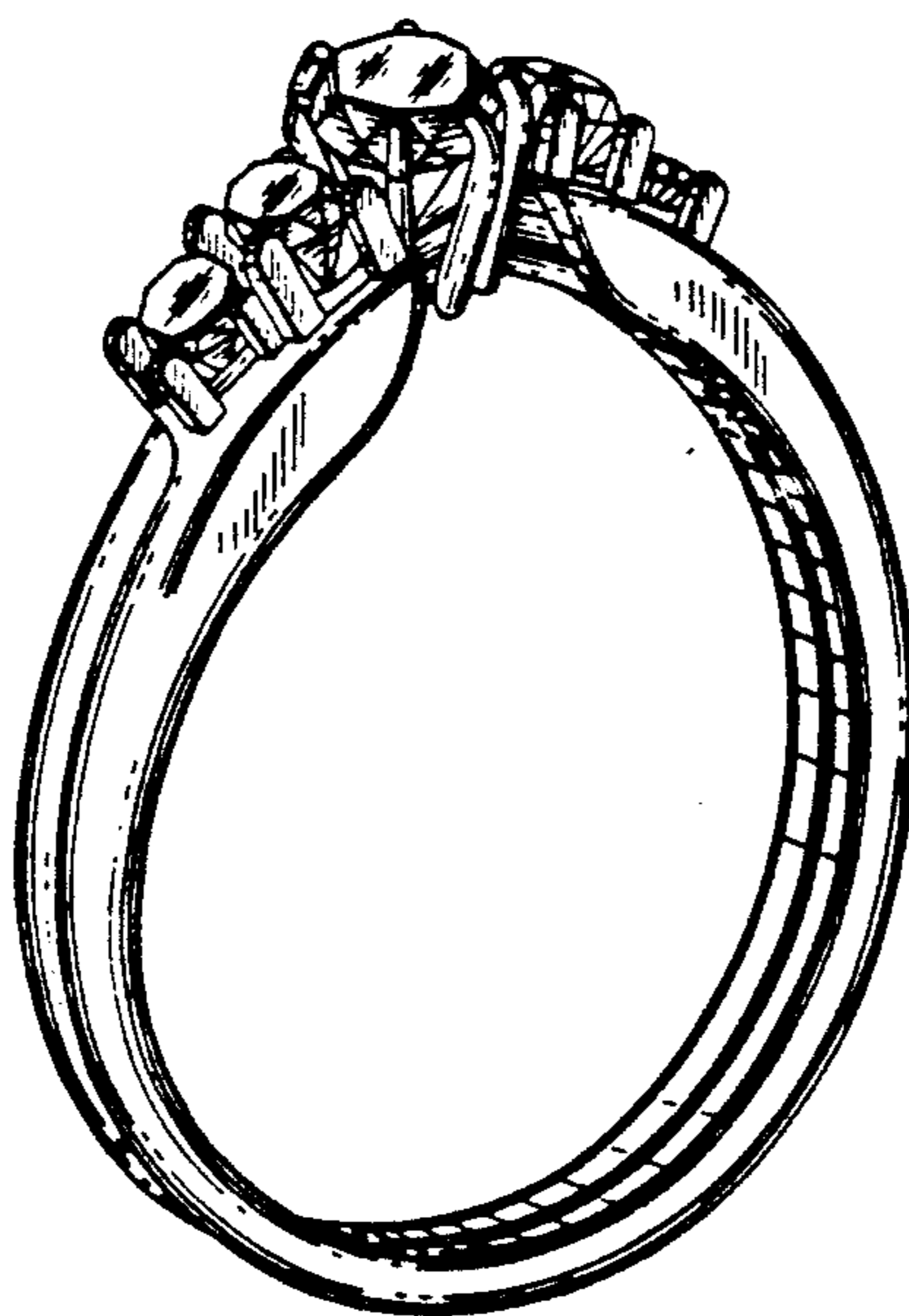

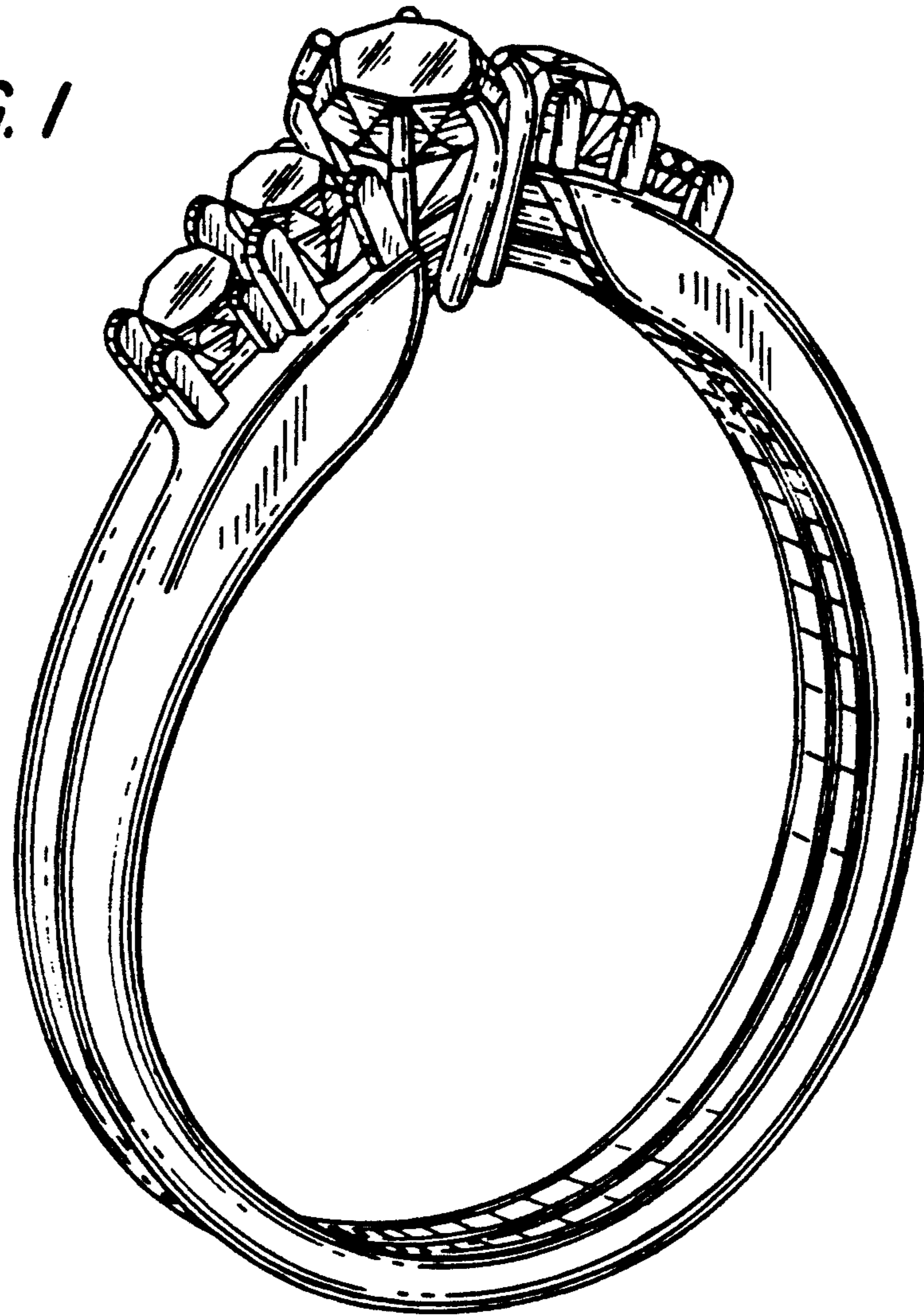

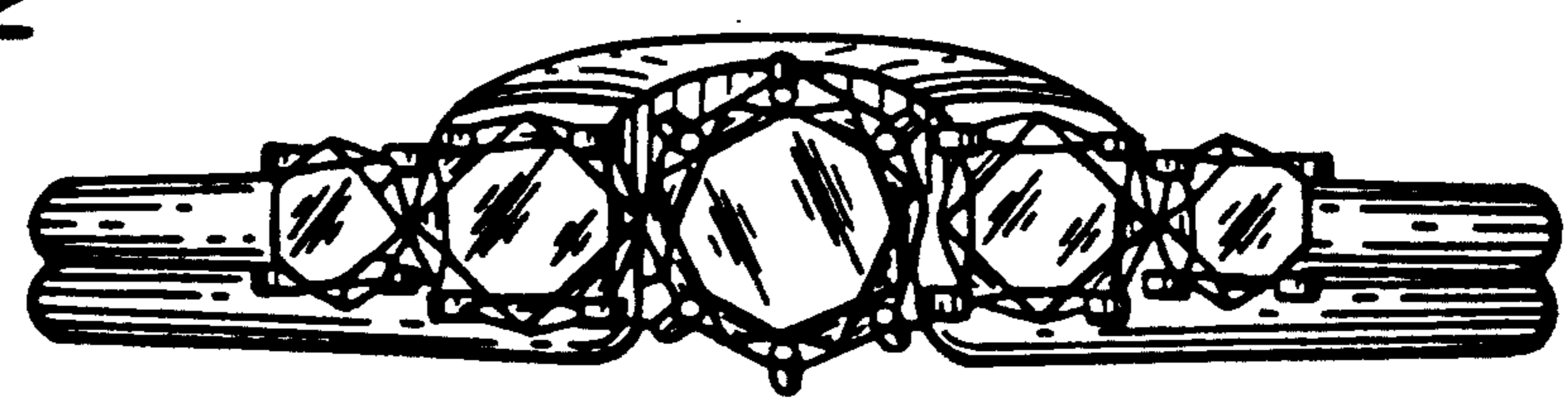

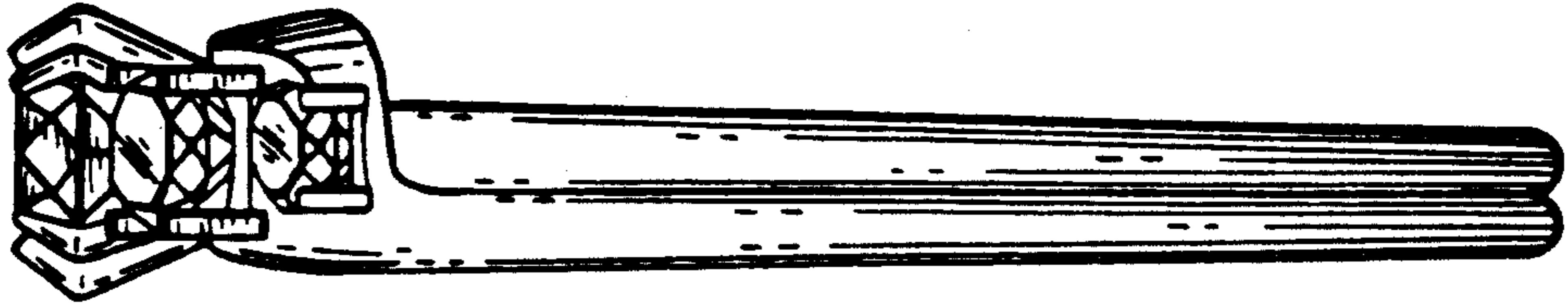
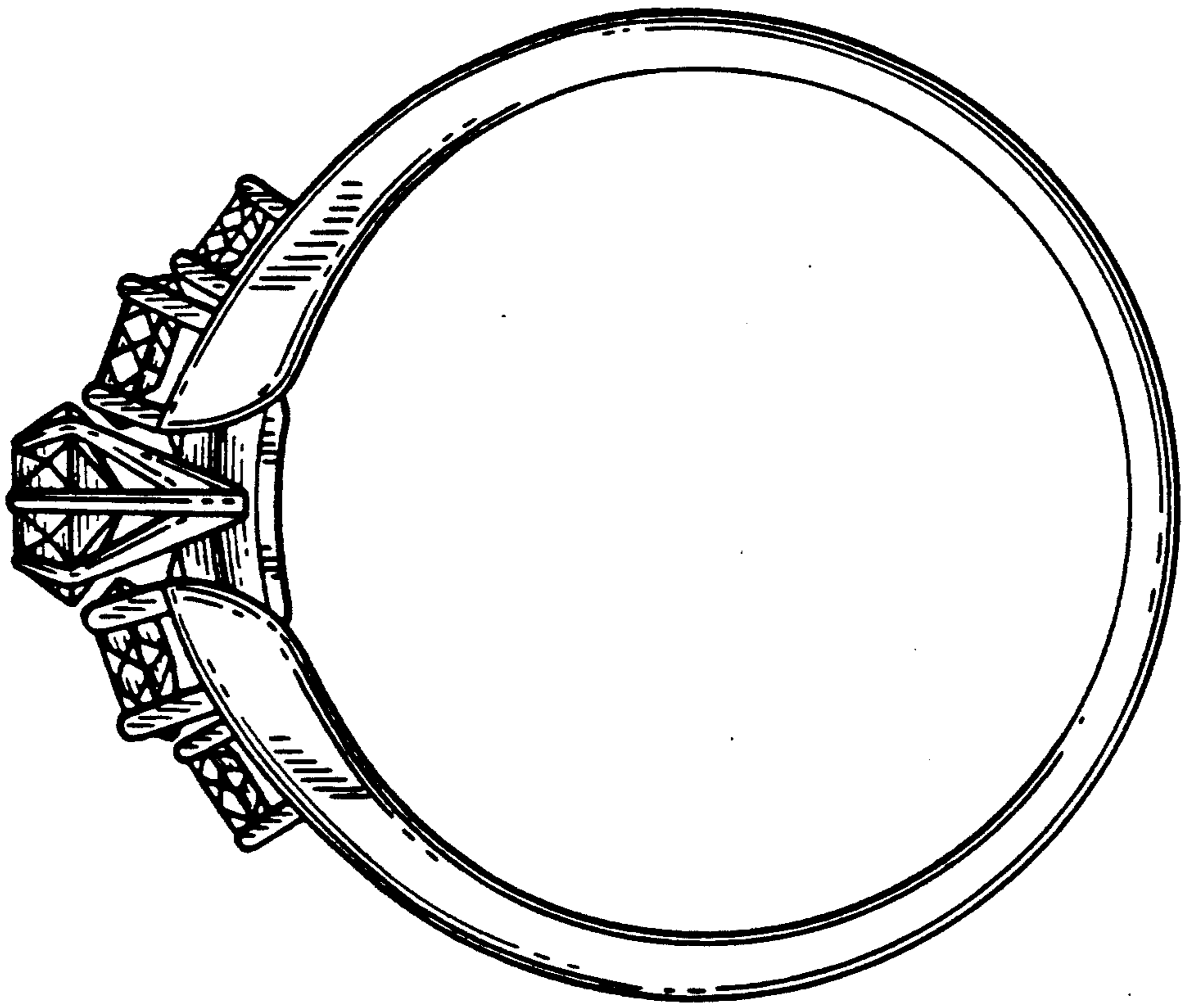
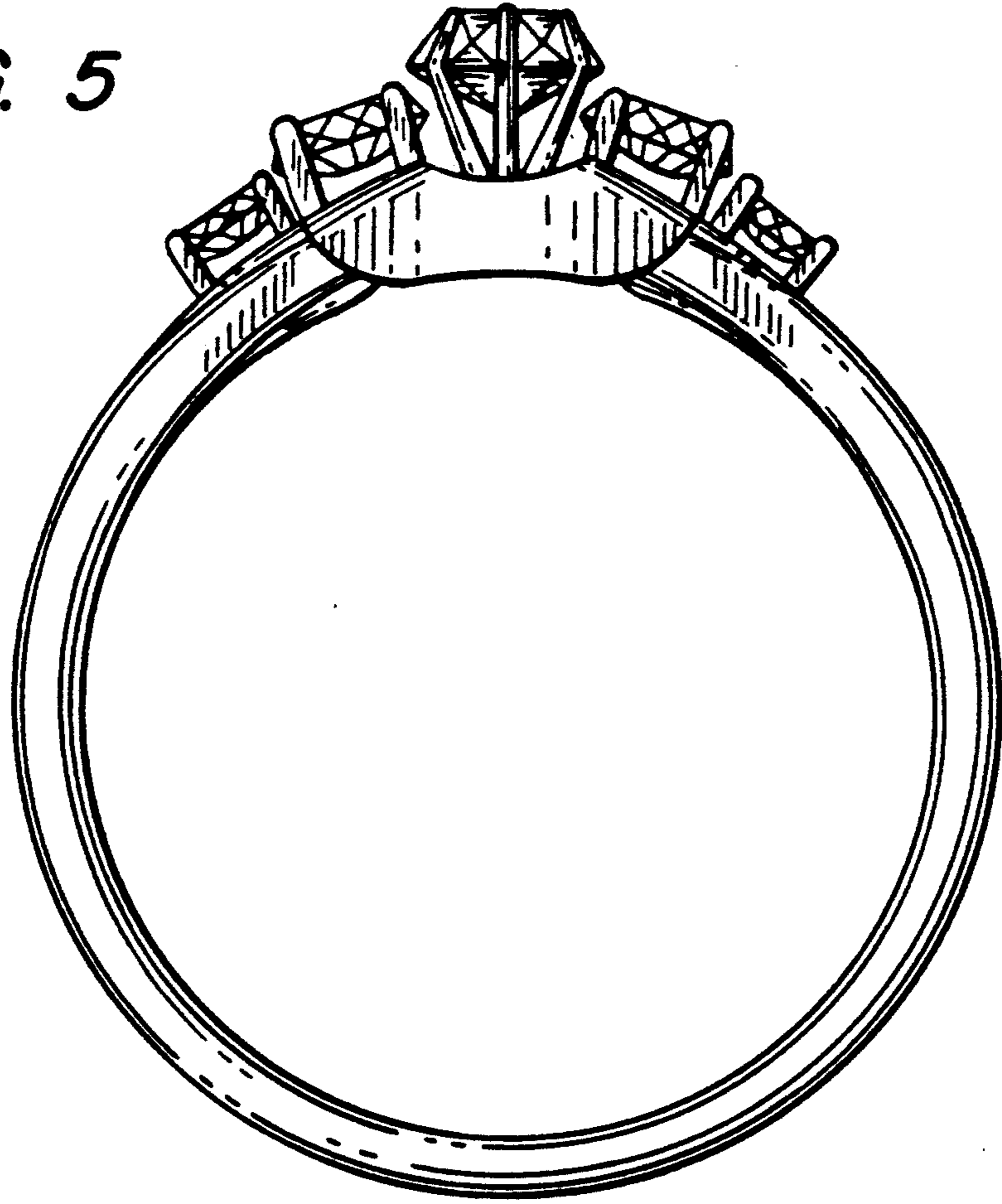


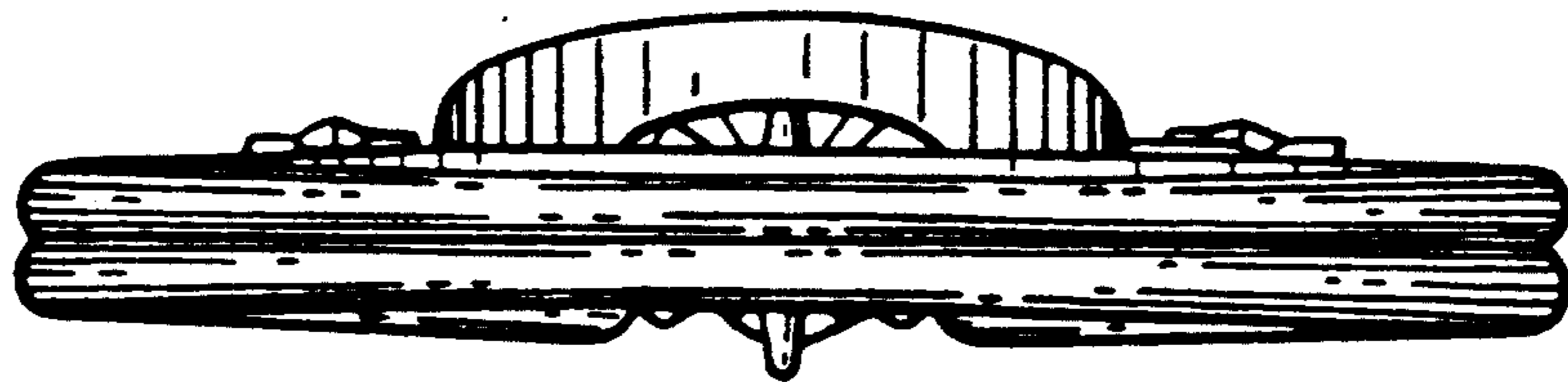

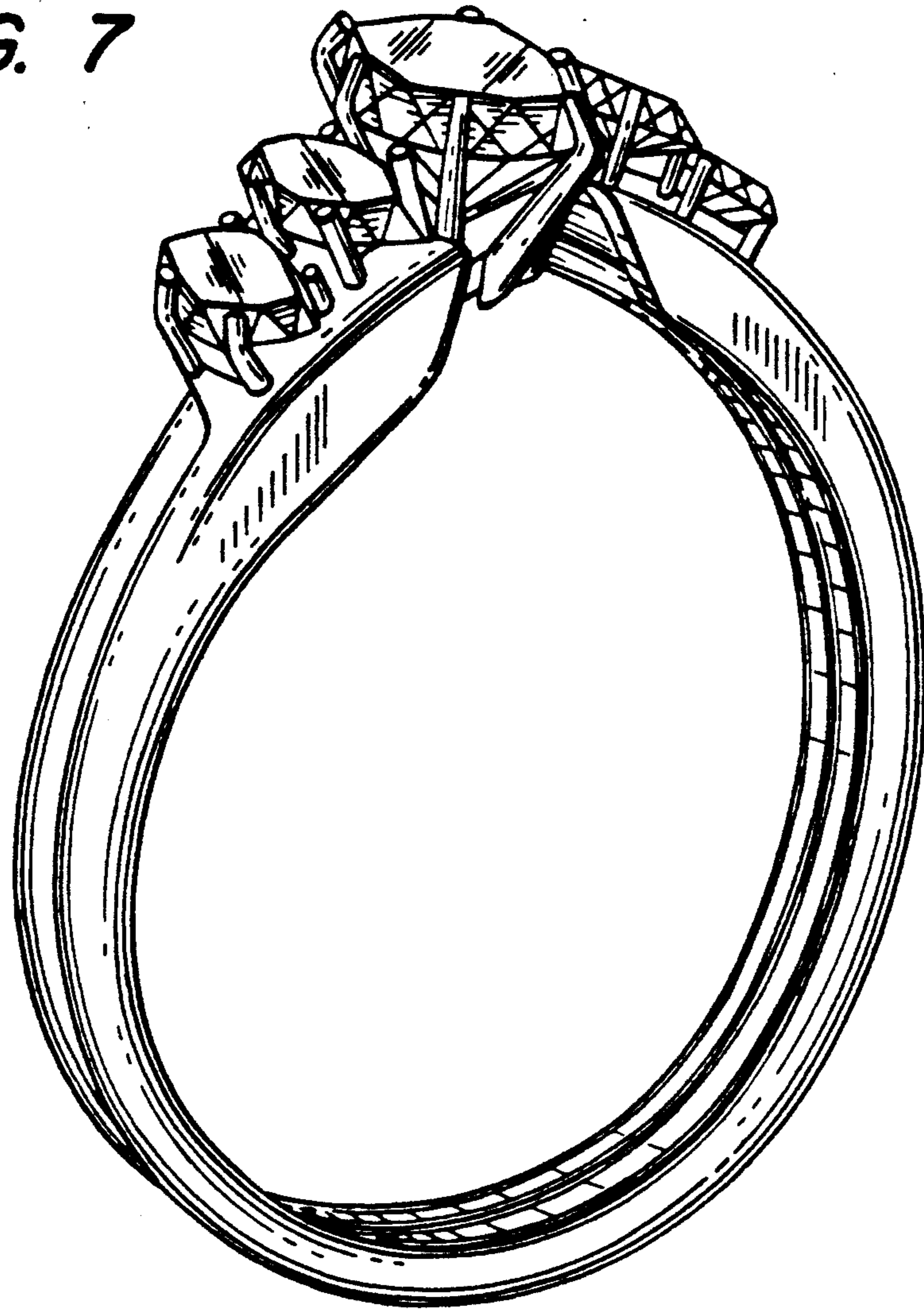

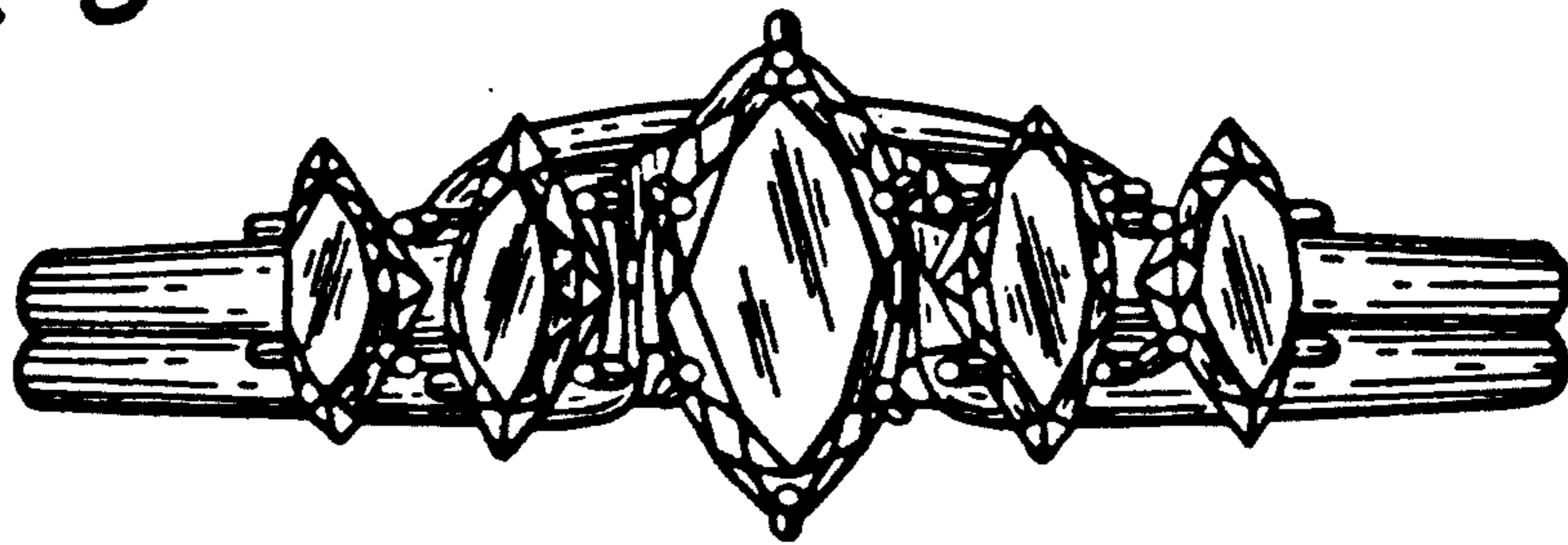

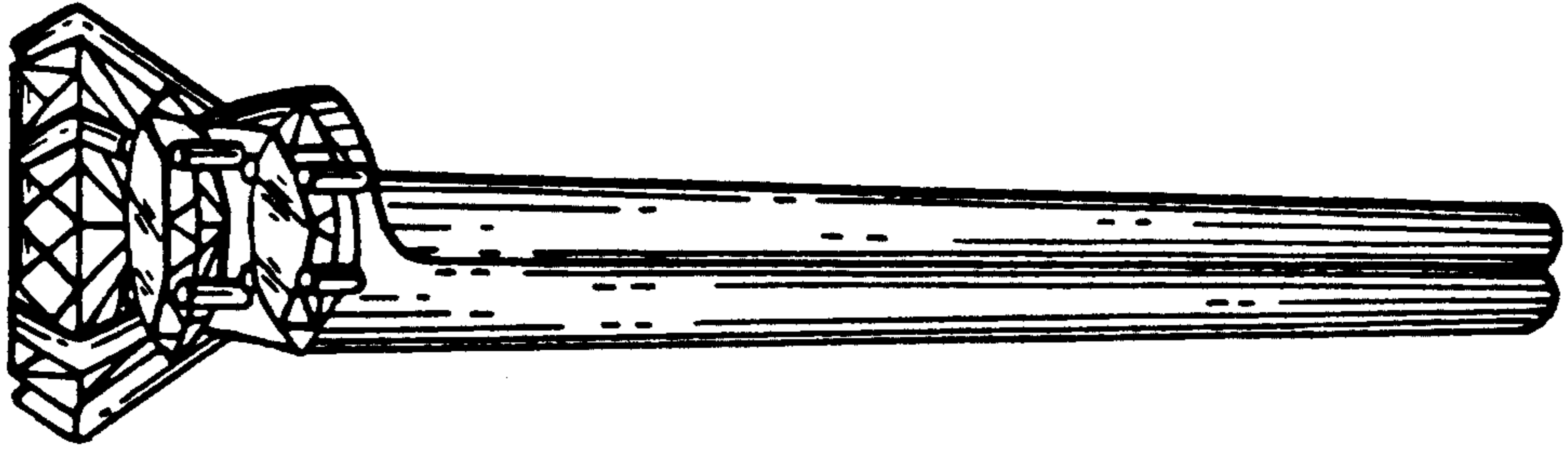
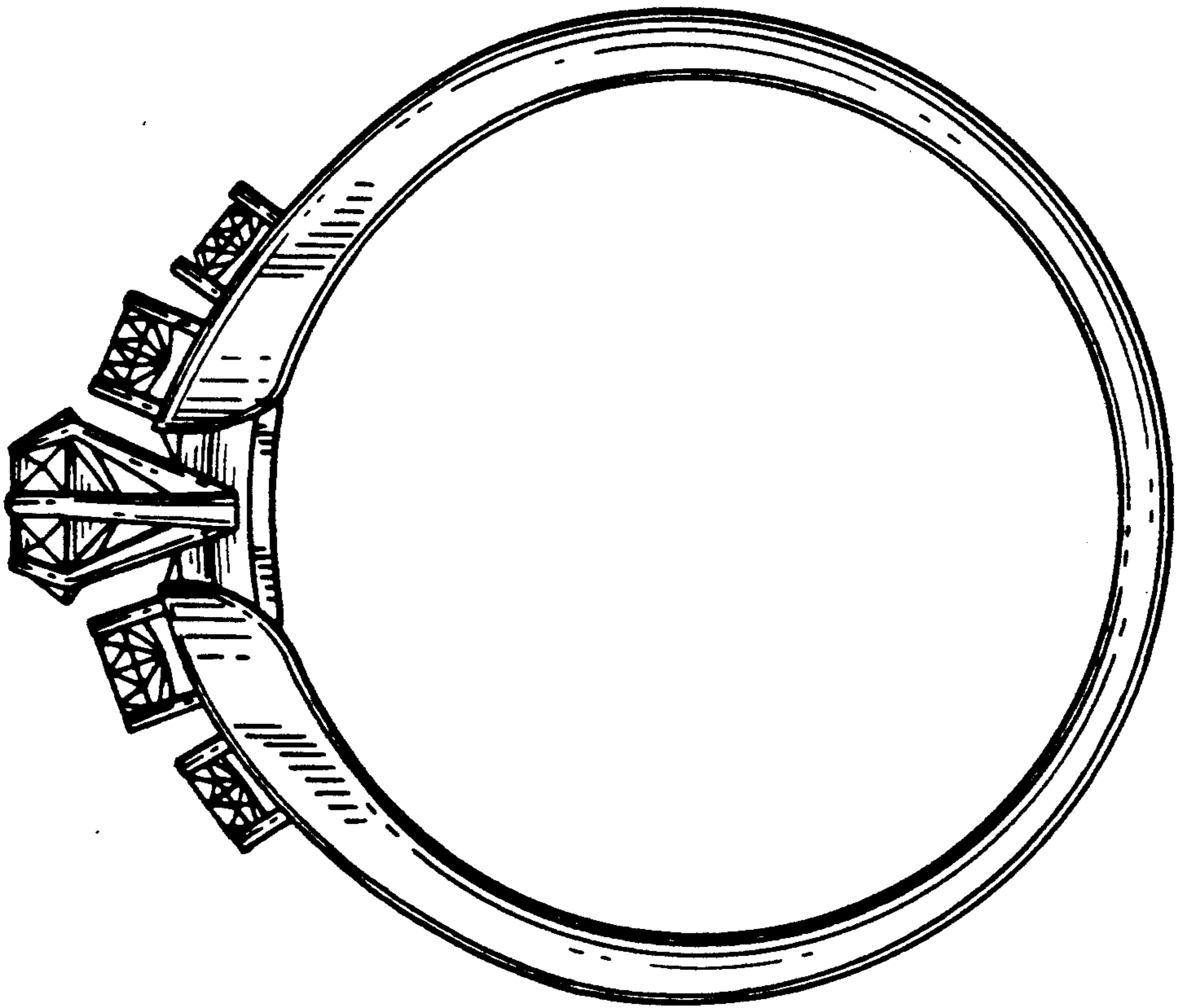
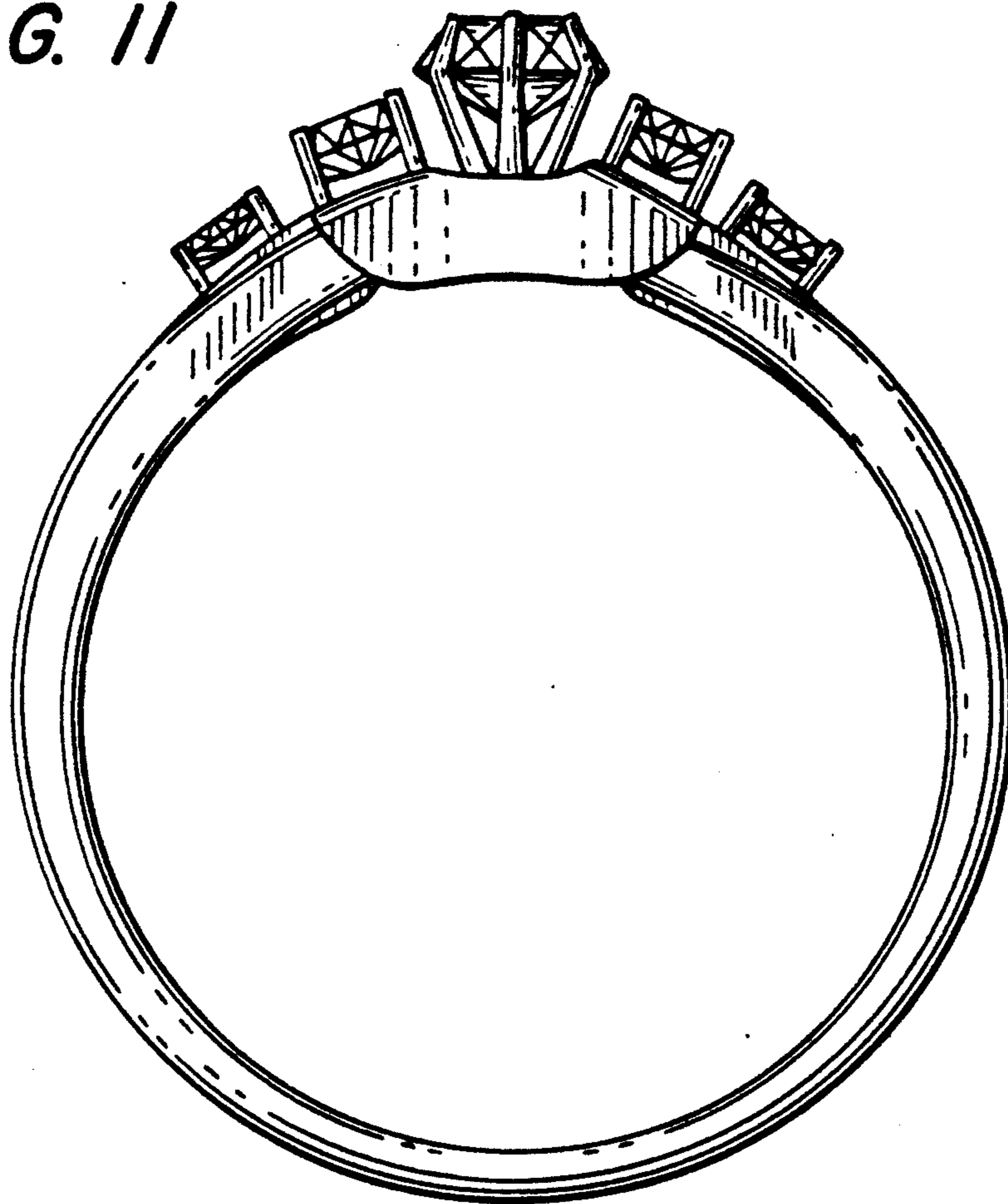


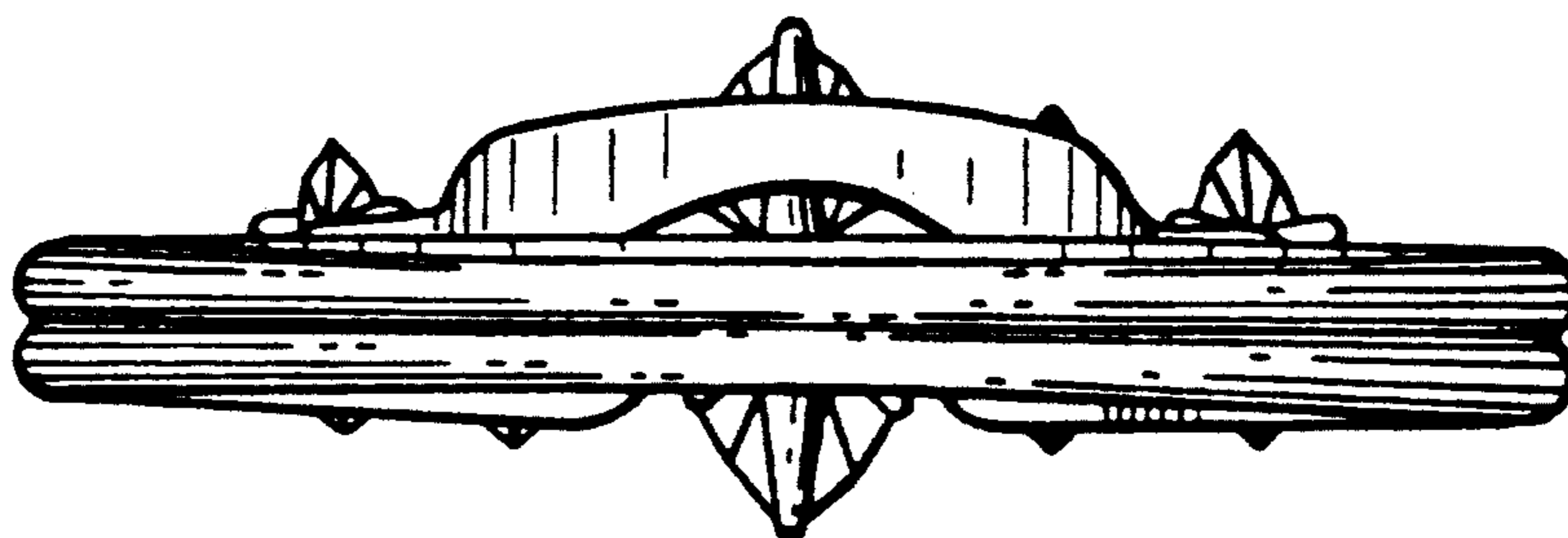

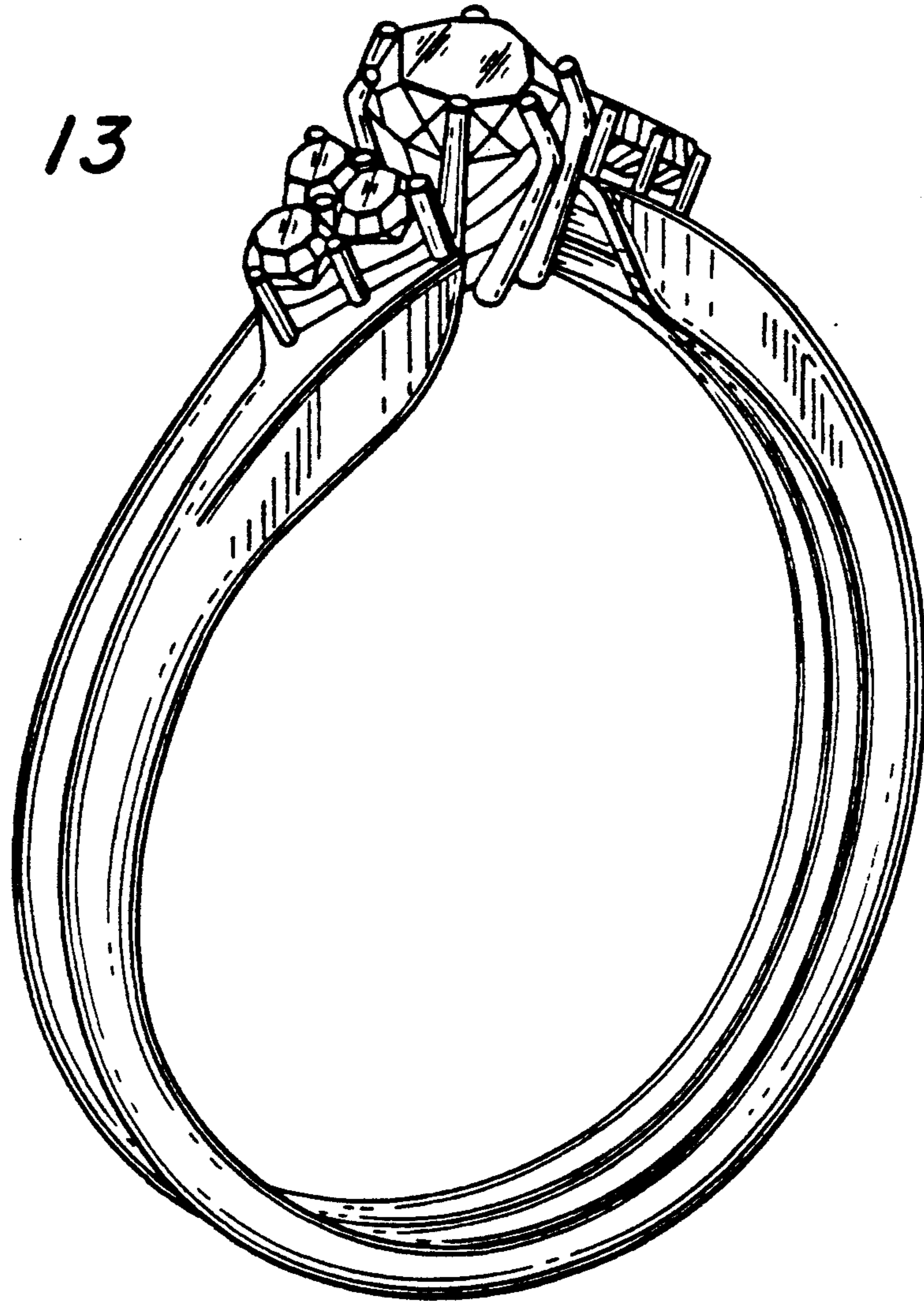

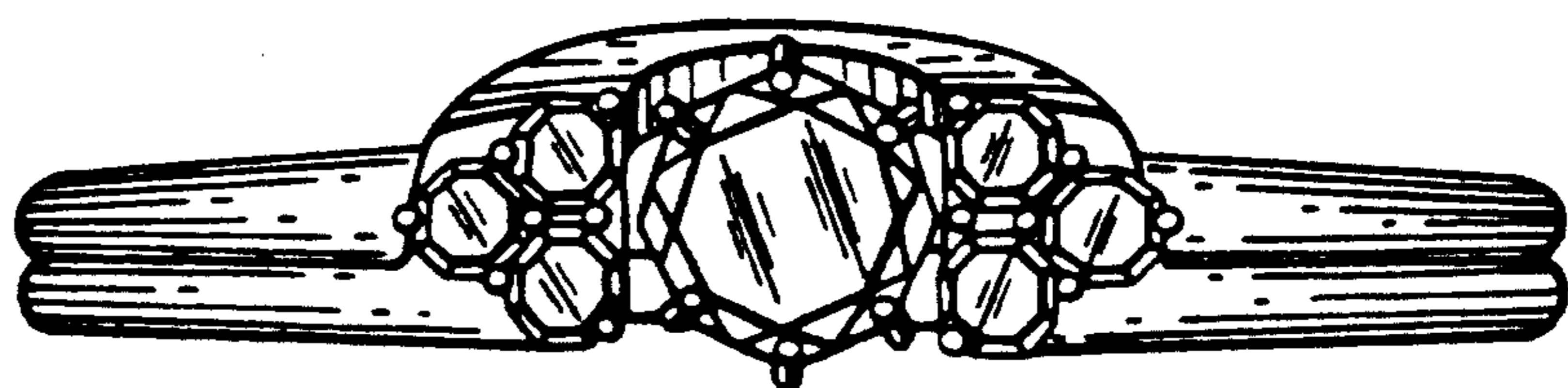

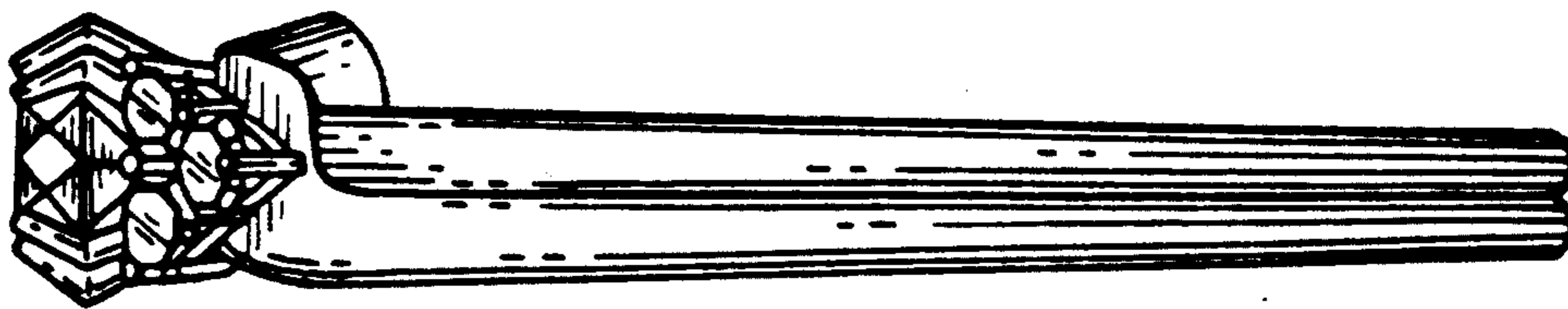
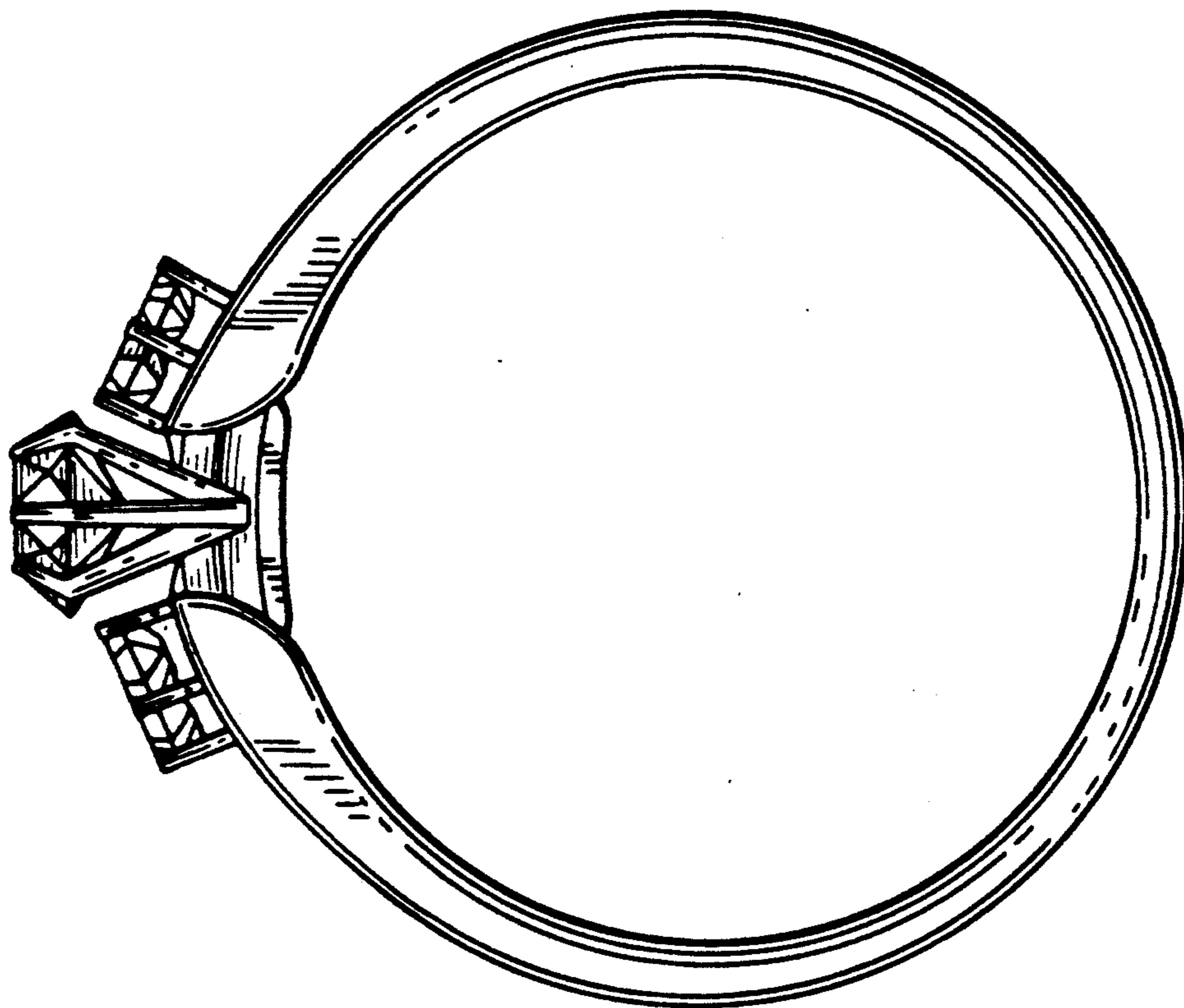
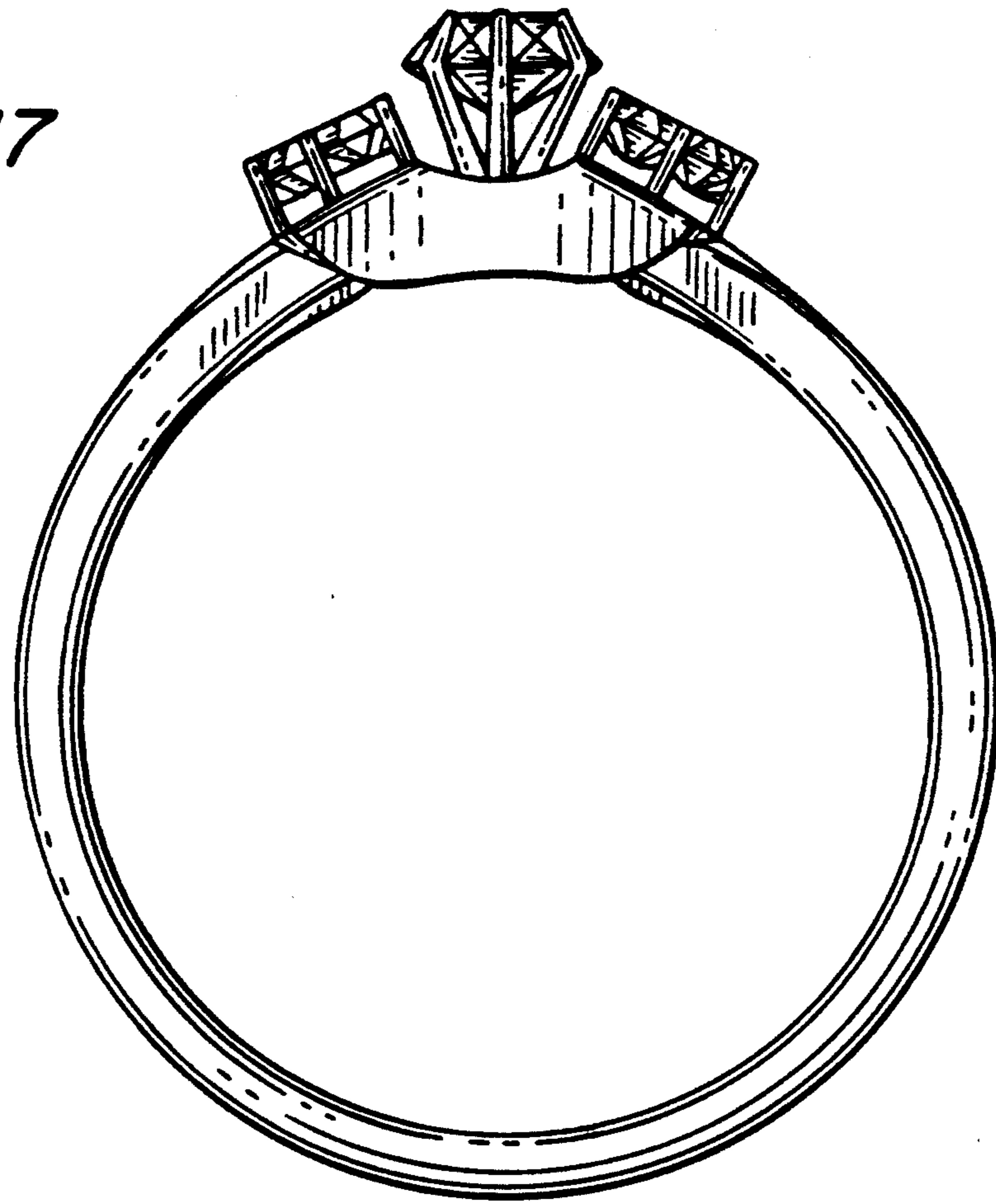
