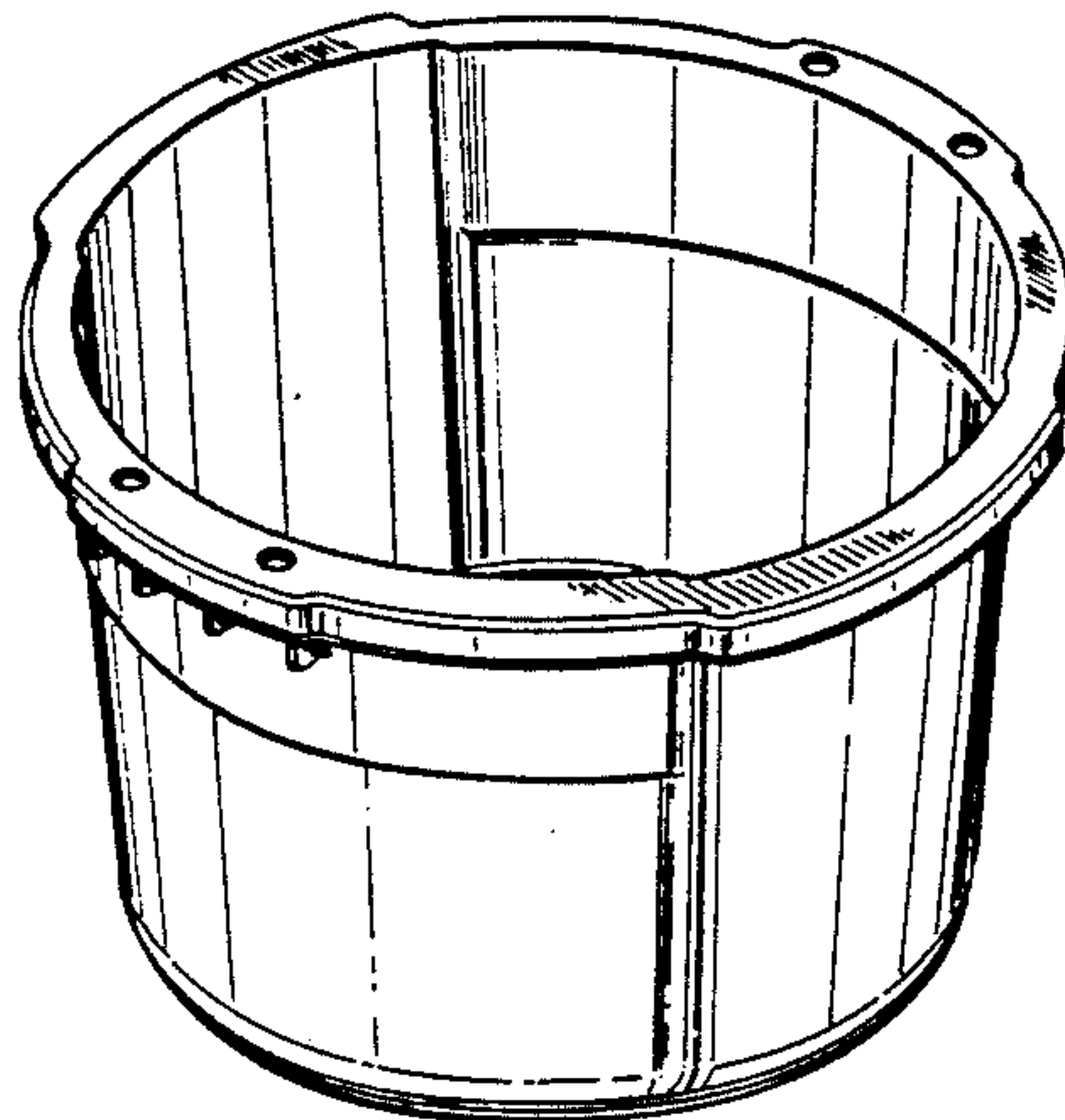

[57] **CLAIM**

The ornamental design for a bucket, as shown and described.

**DESCRIPTION**

FIG. 1 is a top left front perspective view of a bucket showing my new design;  
 FIG. 2 is a top plan view thereof;  
 FIG. 3 is a bottom plan view thereof;  
 FIG. 4 is a front elevational view thereof; the rear elevational view being a mirror image;  
 FIG. 5 is a side elevational view thereof; the opposite side being a mirror image; and,  
 FIG. 6 is a transverse cross-sectional view of the bucket shown in FIG. 2 and taken along line 6—6.

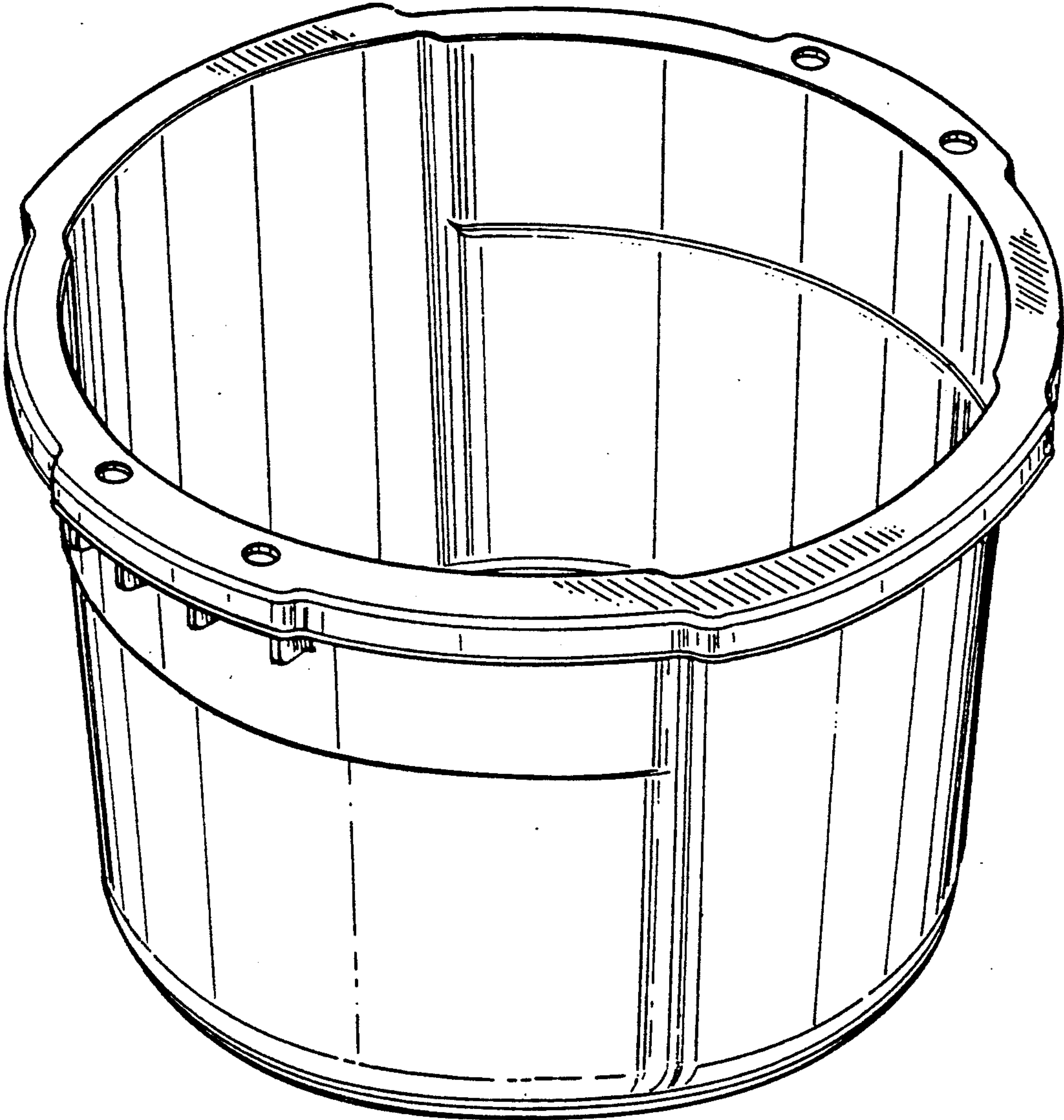

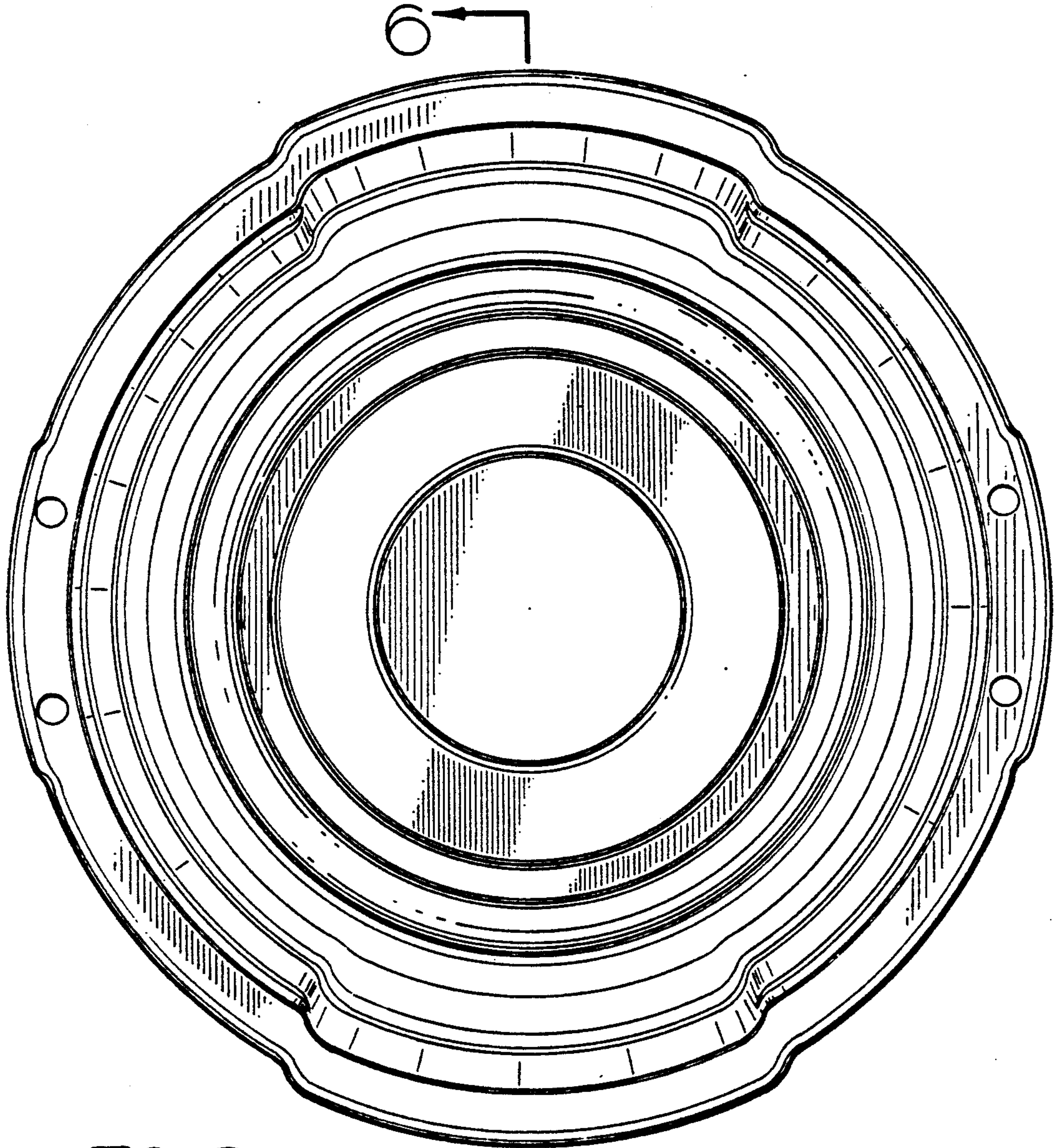
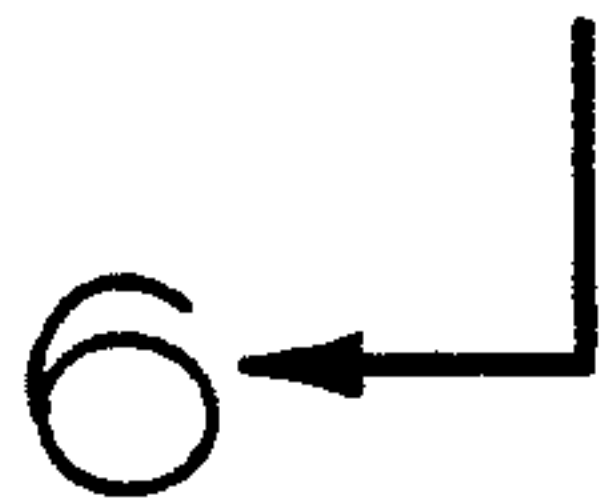

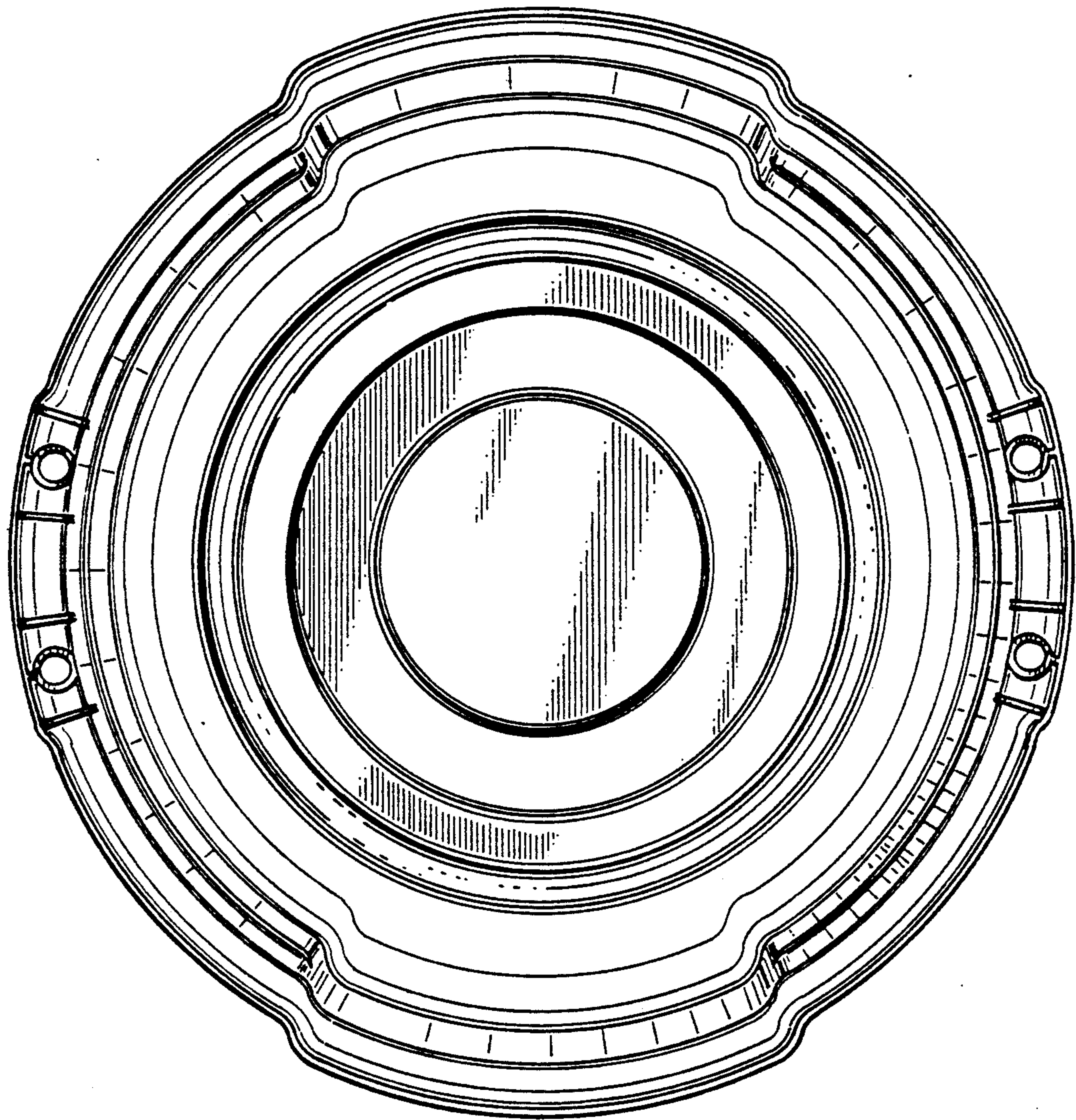

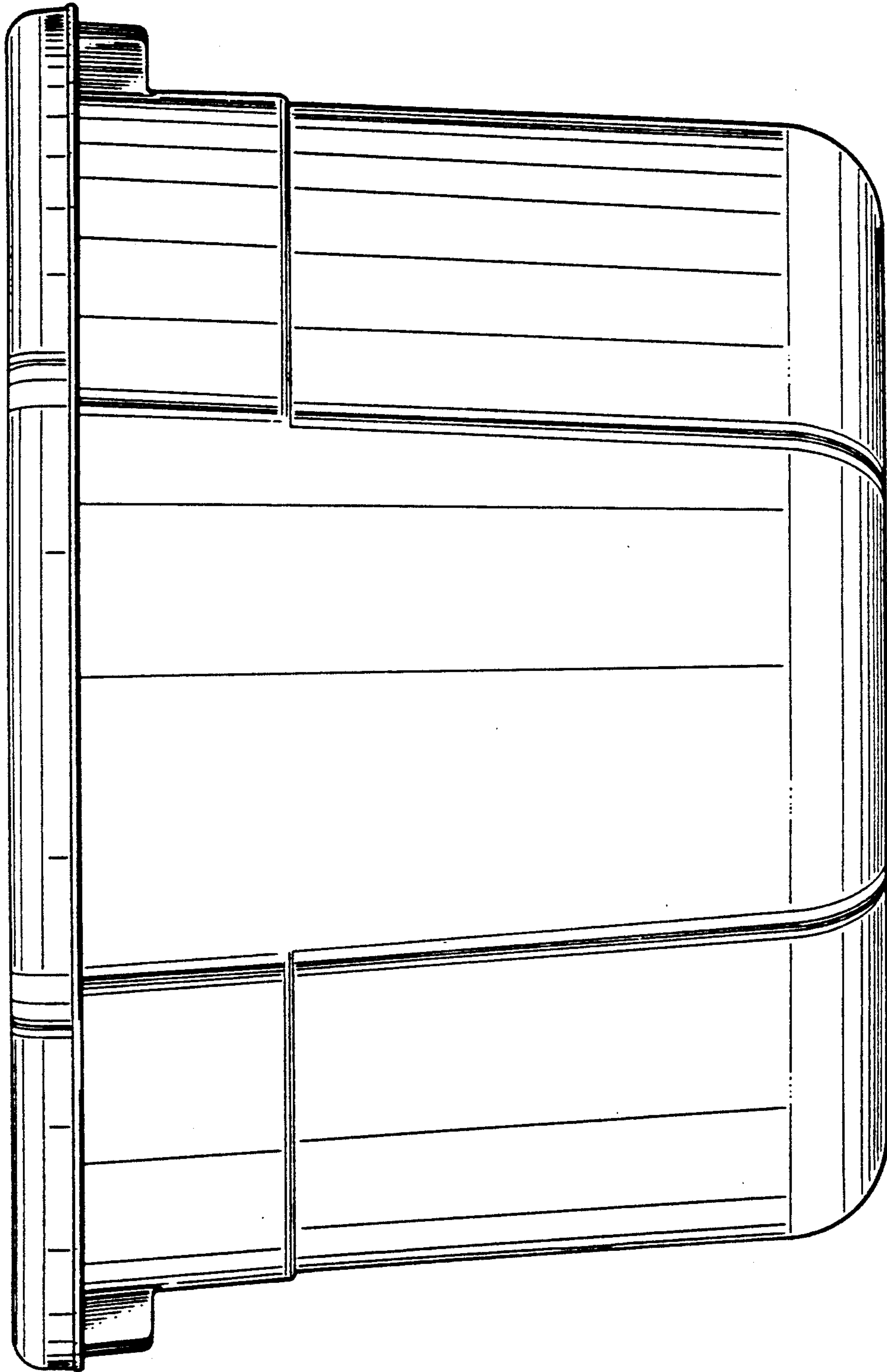

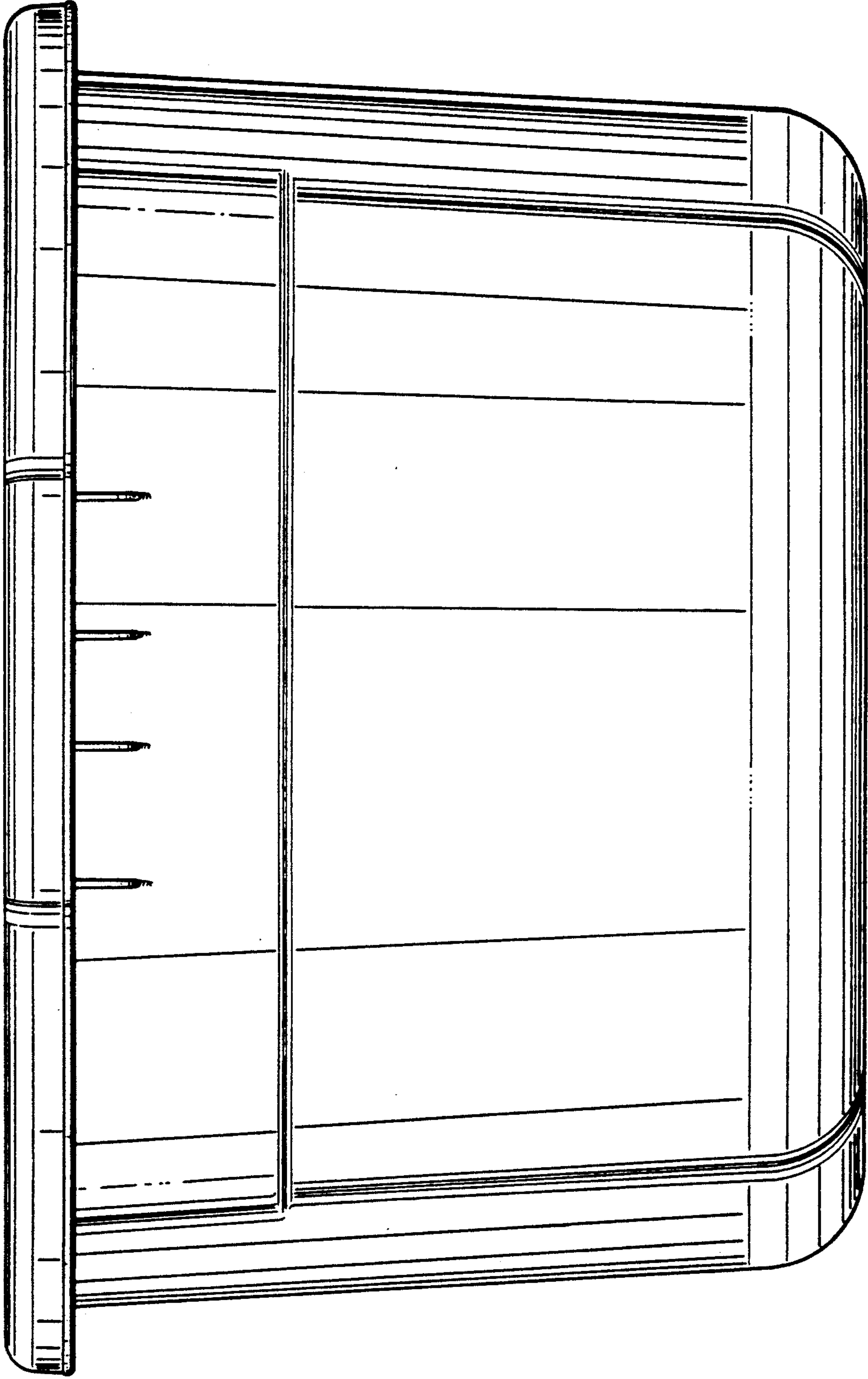

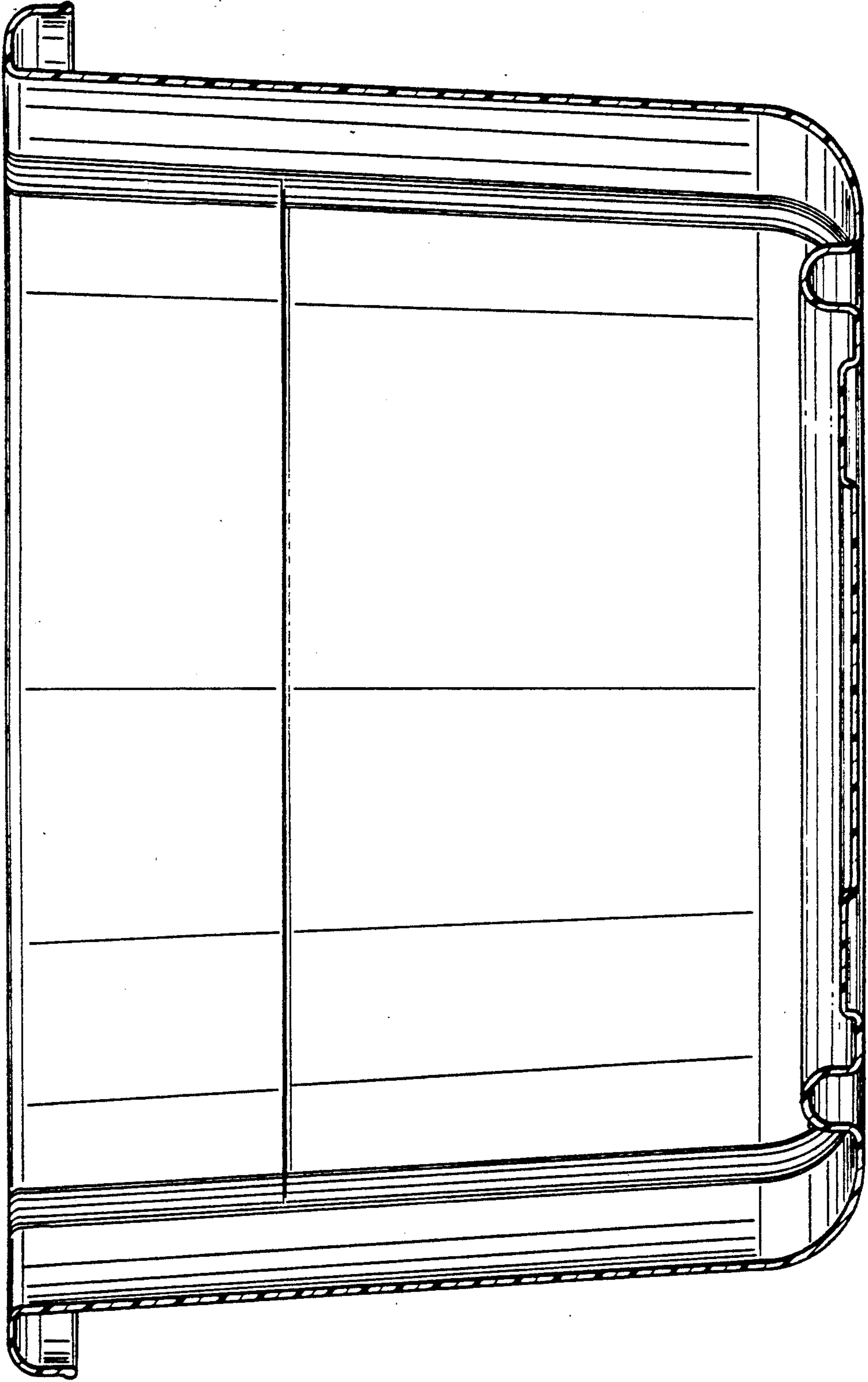
