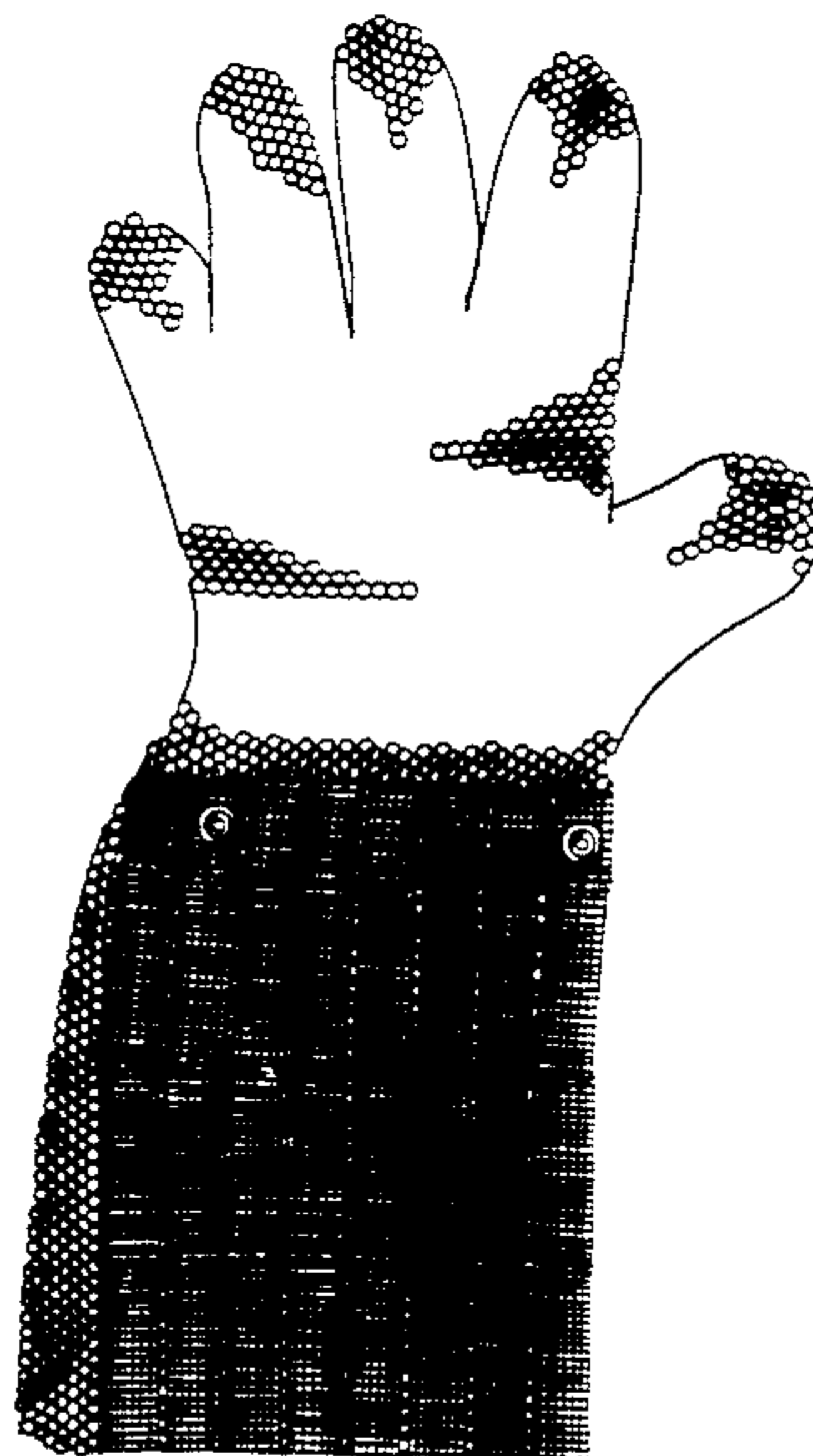
[57] **CLAIM**

The ornamental design for a butcher's glove with lower arm protection, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a butcher's glove with lower arm protection showing our new design, the pattern is understood to continue throughout the glove;

FIG. 2 is a rear view thereof;  
 FIG. 3 is a side view thereof;  
 FIG. 4 is a perspective view thereof with a person's hand inserted into the glove;  
 FIG. 5 is a fragmentary view of the upper hand portion of the glove;  
 FIG. 6 is a fragmentary view of the lower arm portion of the glove;  
 FIG. 7 is a fragmentary view of the hand and wrist junction portion of the glove;  
 FIG. 8 is a rear view of a second embodiment of a butcher's glove showing our new design;  
 FIG. 9 is a front view thereof;  
 FIG. 10 is a side view thereof;  
 FIG. 11 is a rear view of a third embodiment of the butcher's glove showing my new design;

 The broken line showing the word ERGOFLEX is for illustrative purposes only and forms no part of the claimed design.





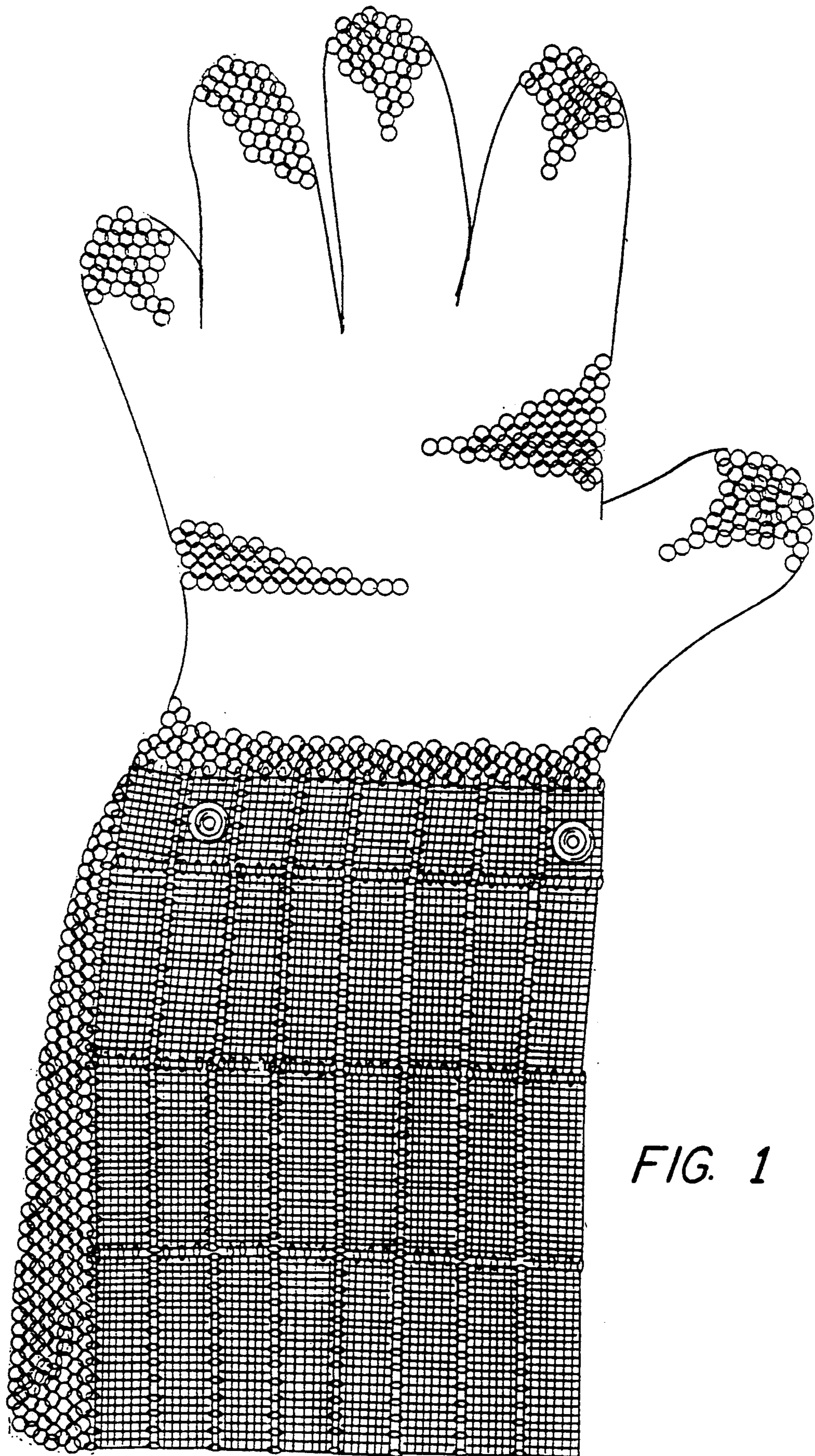

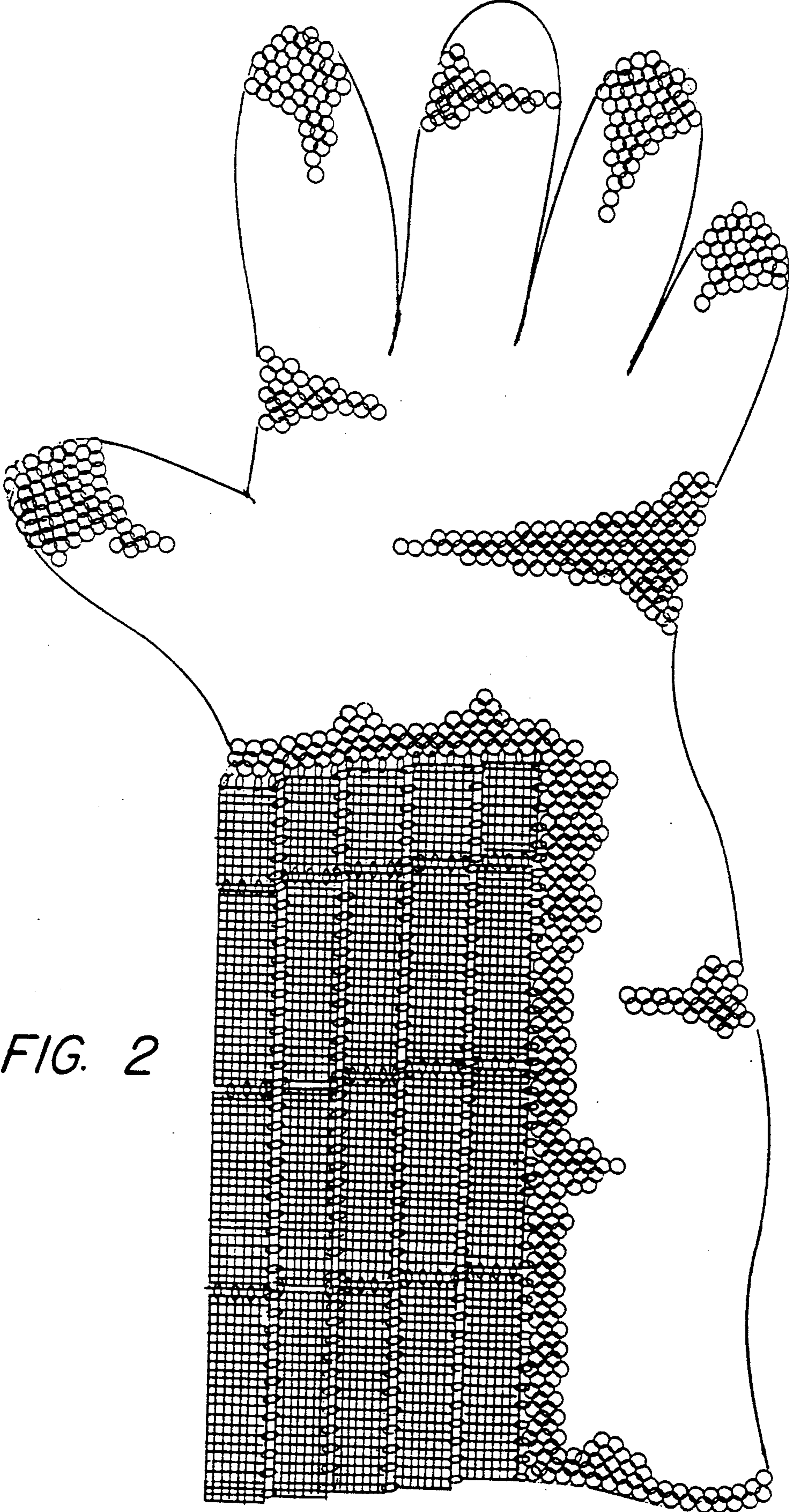

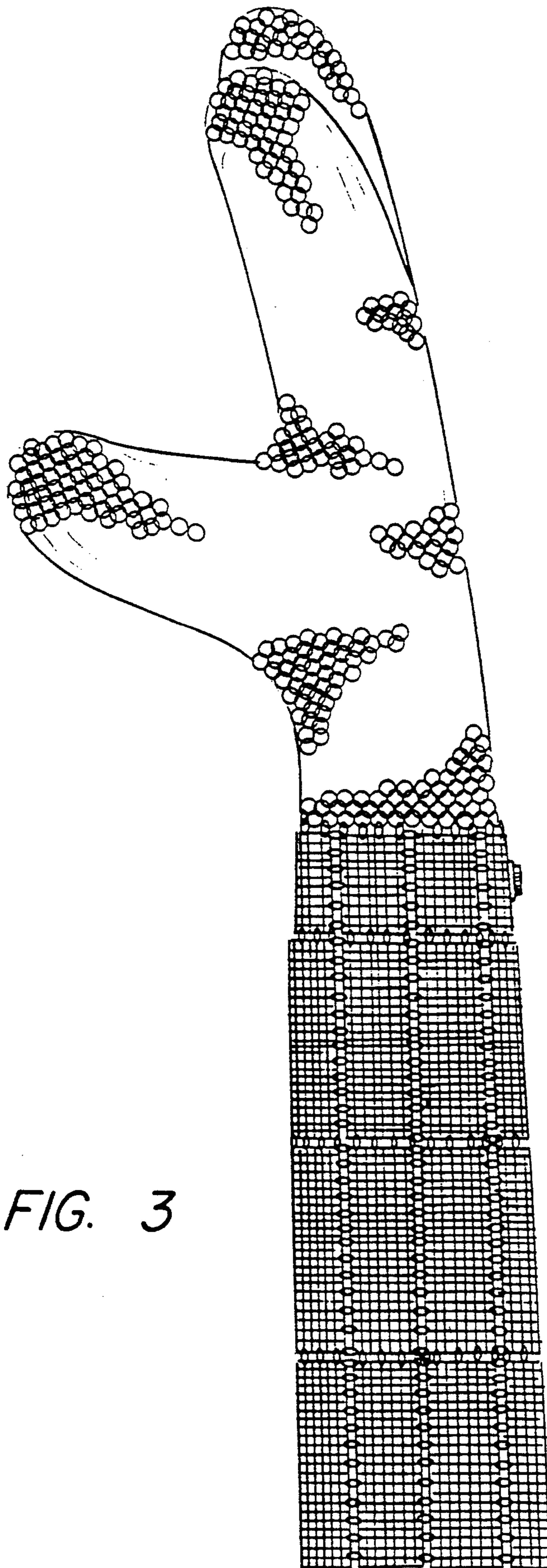

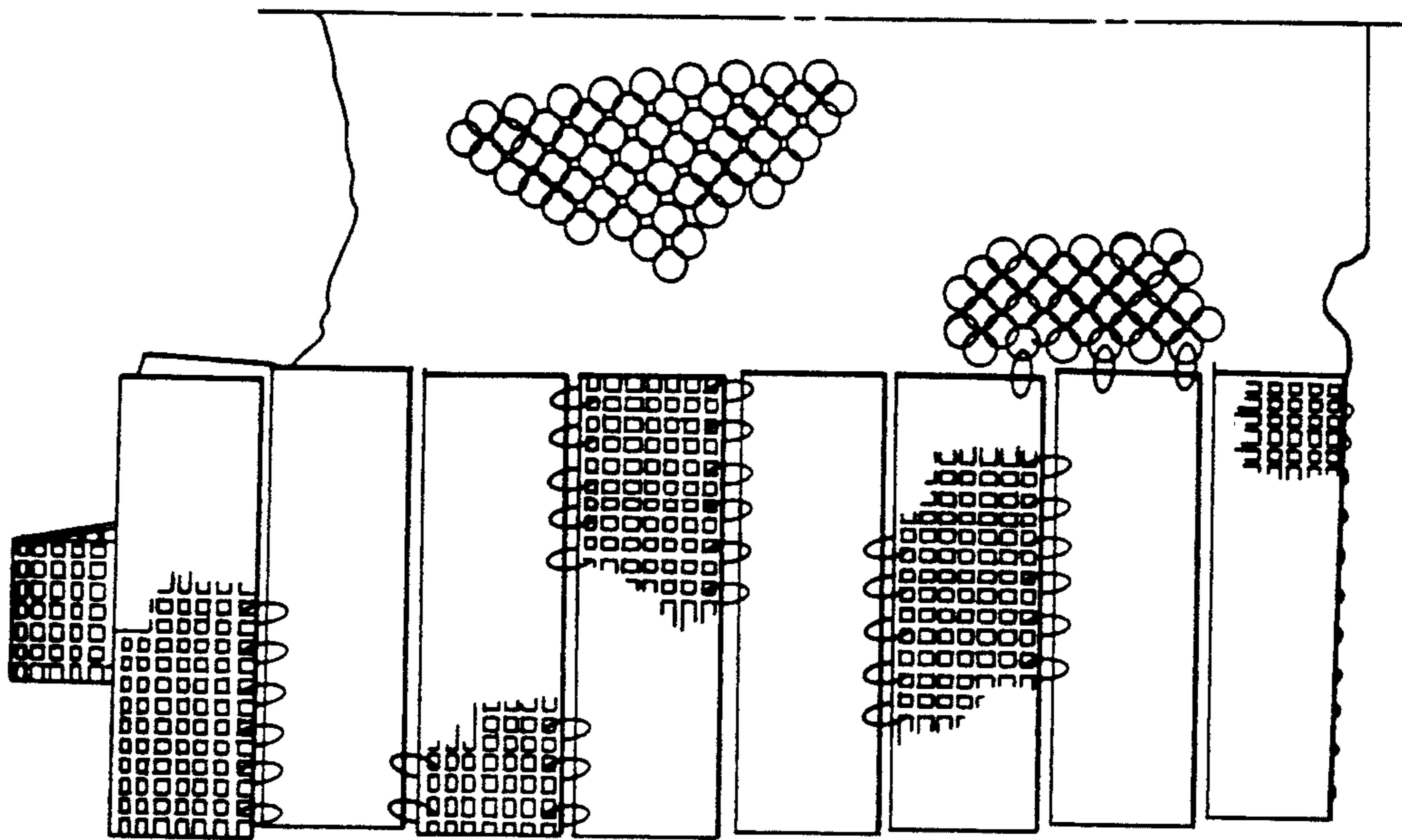

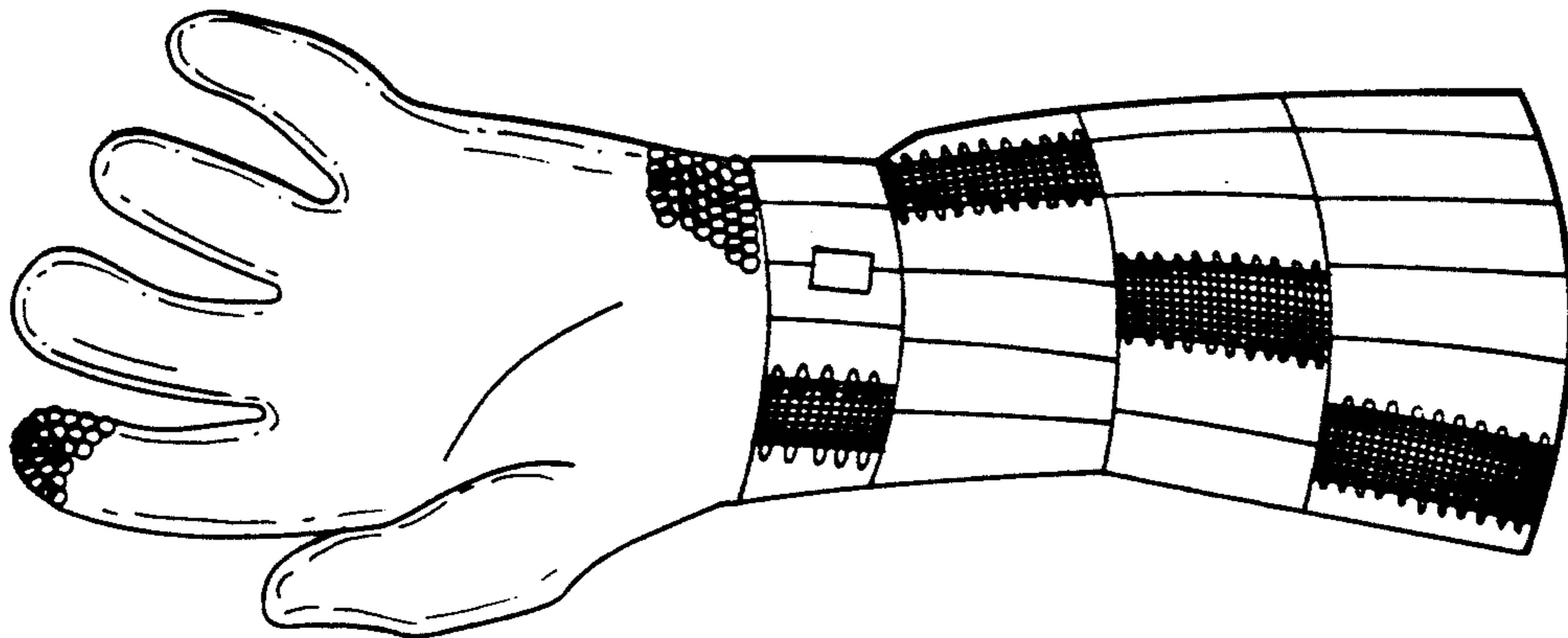

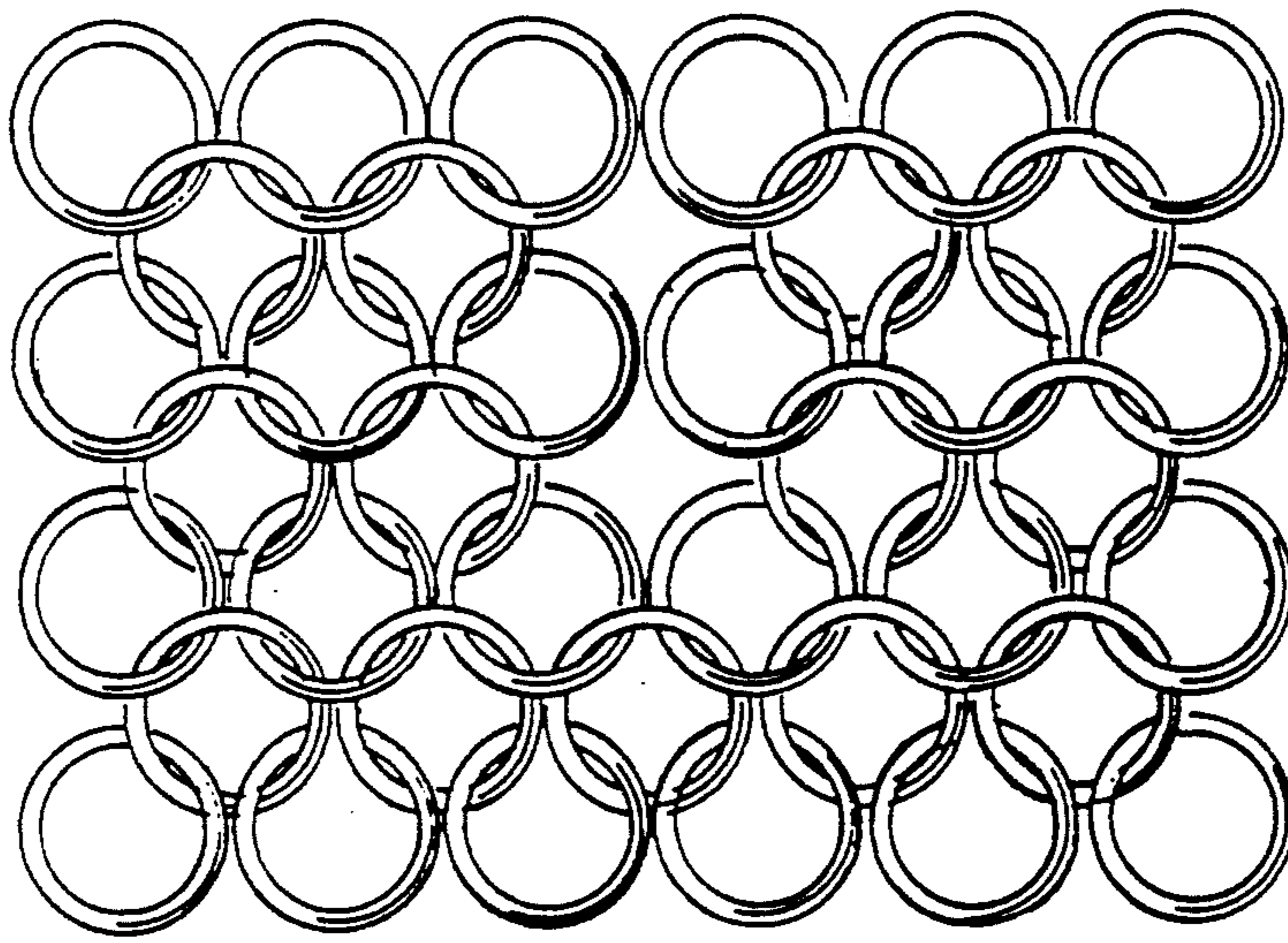

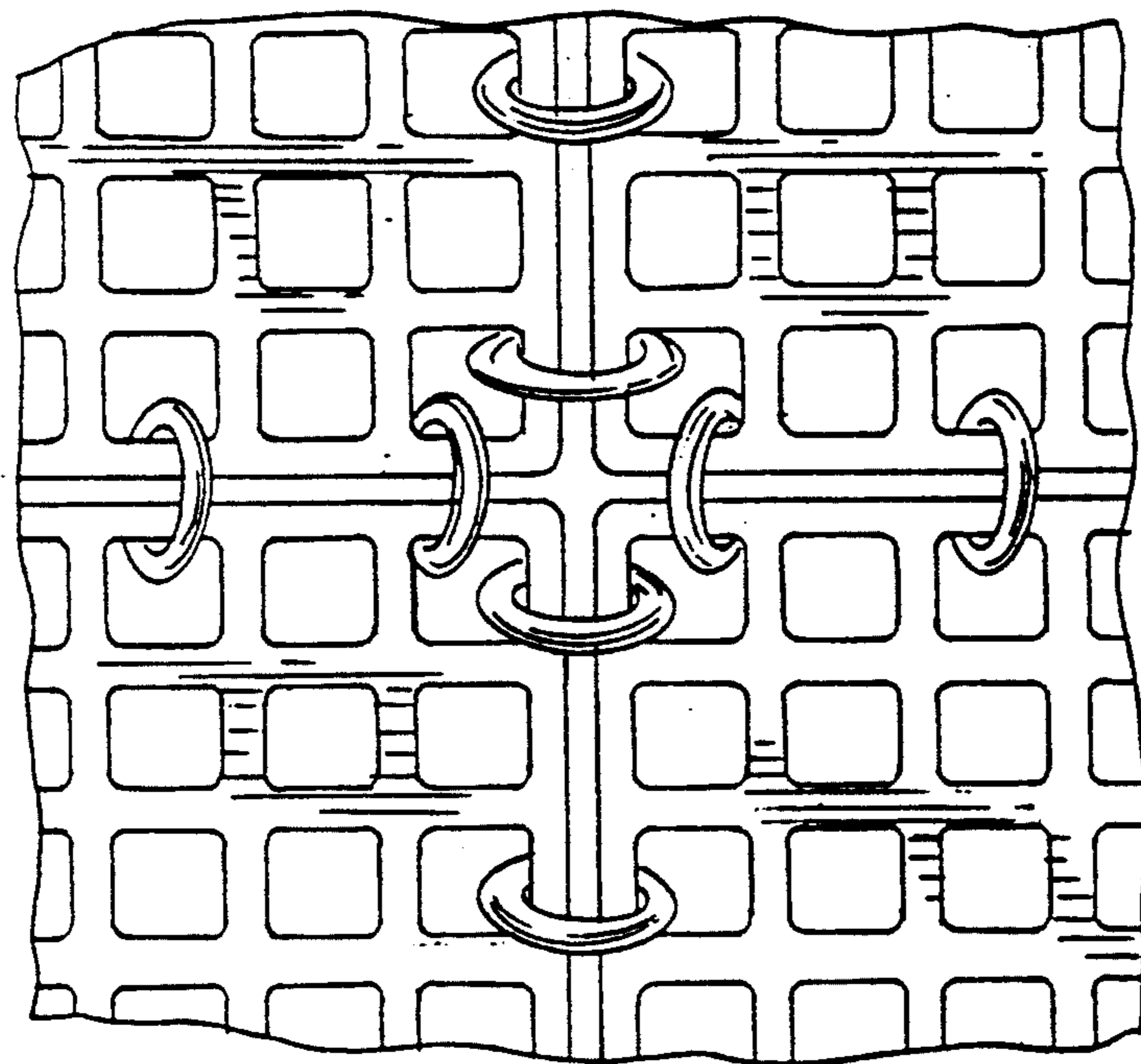

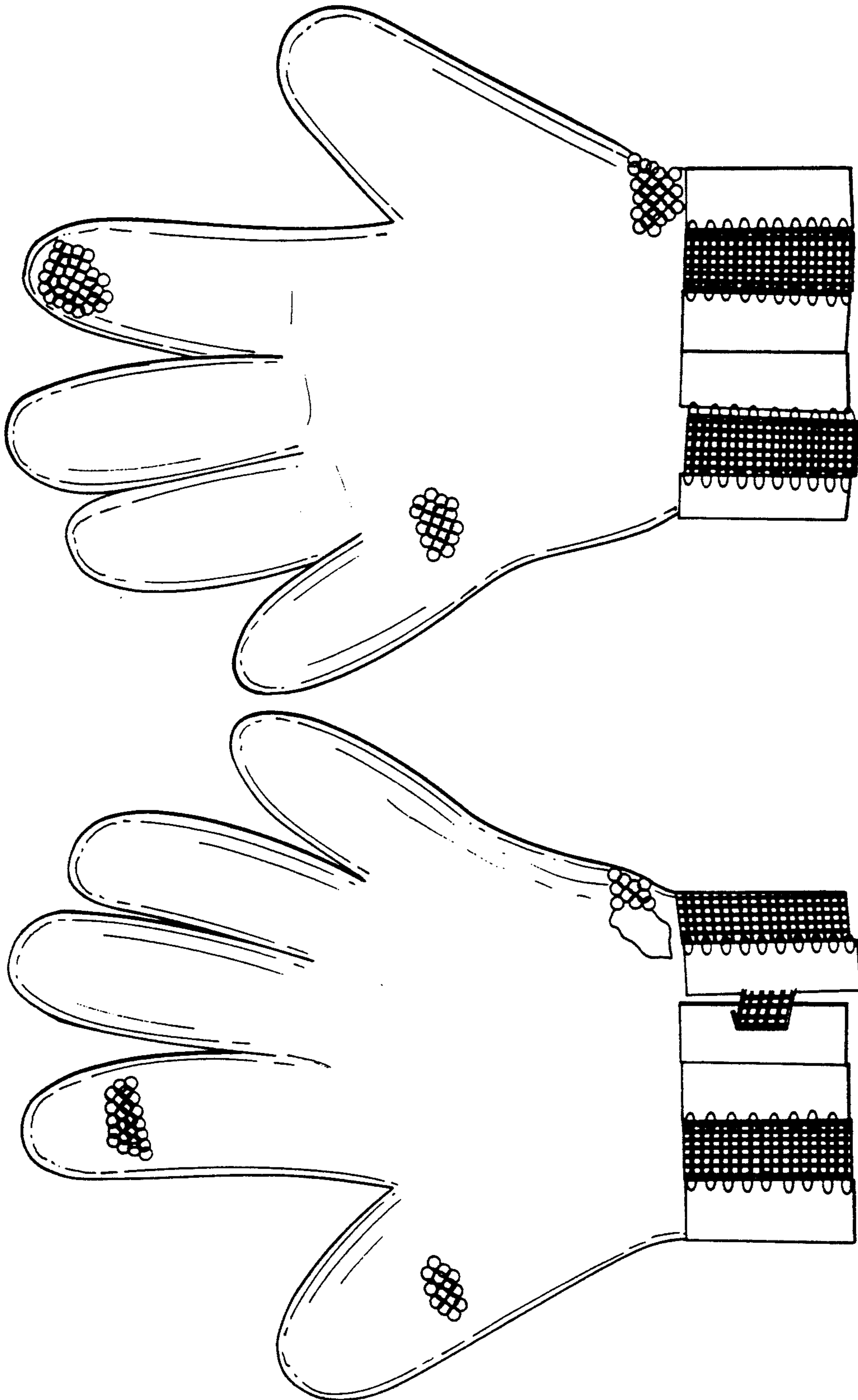

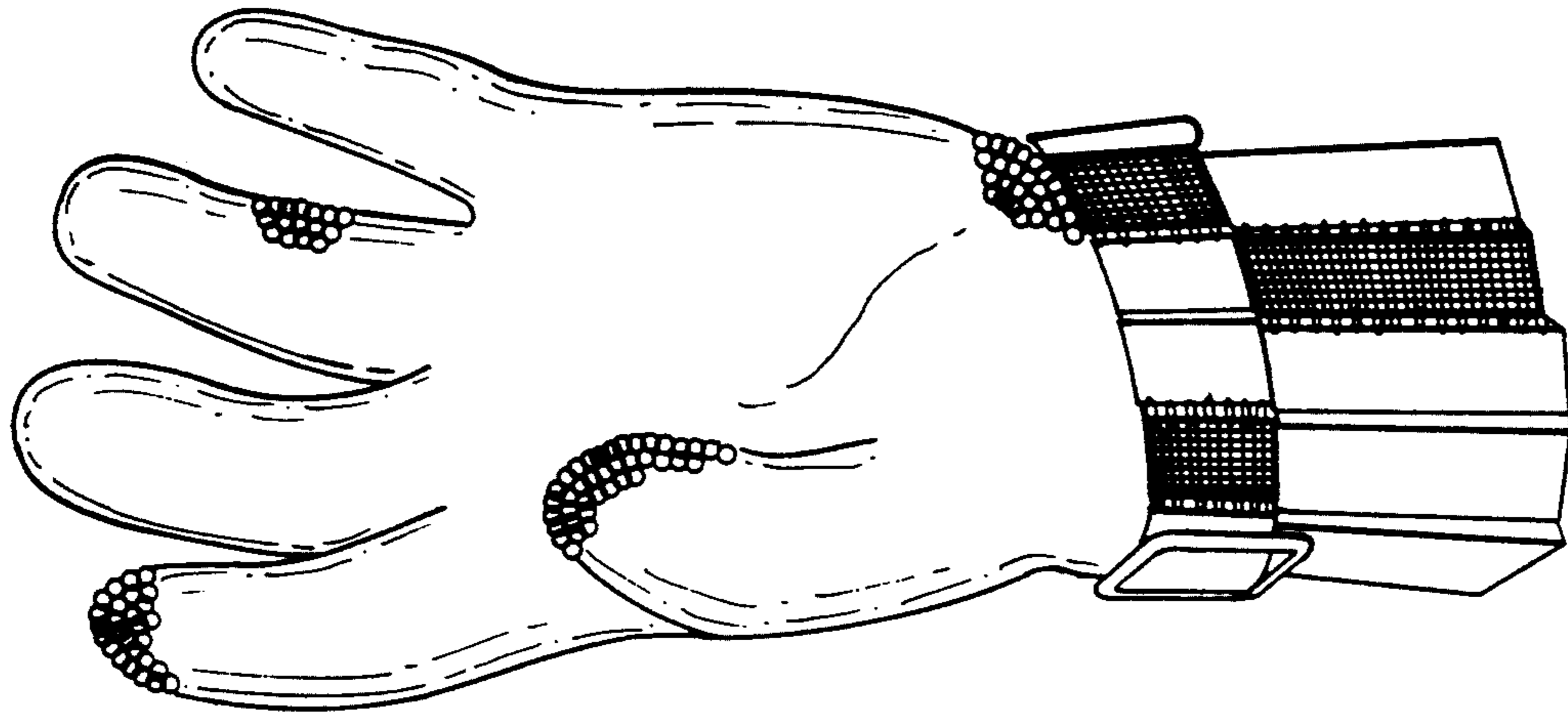

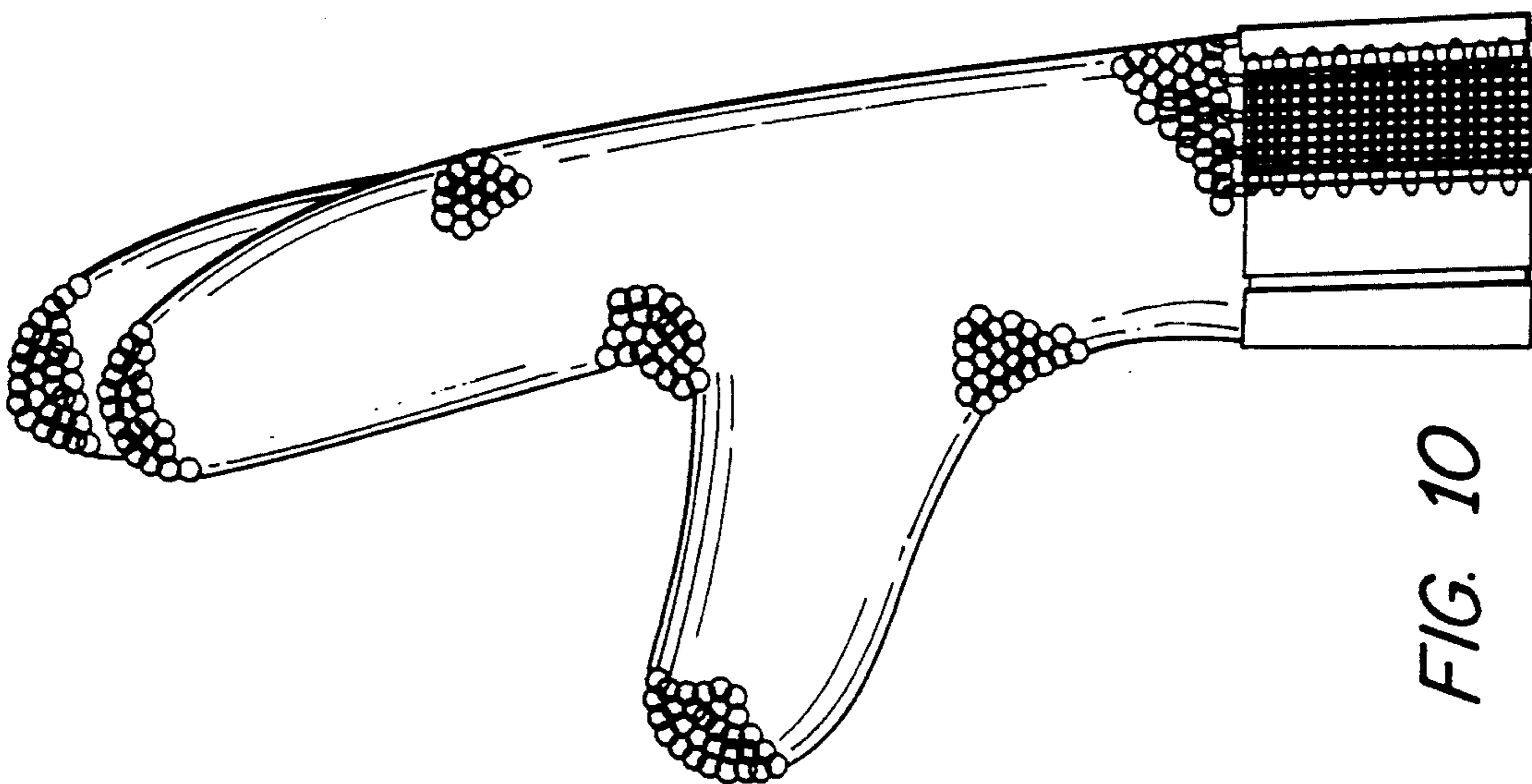

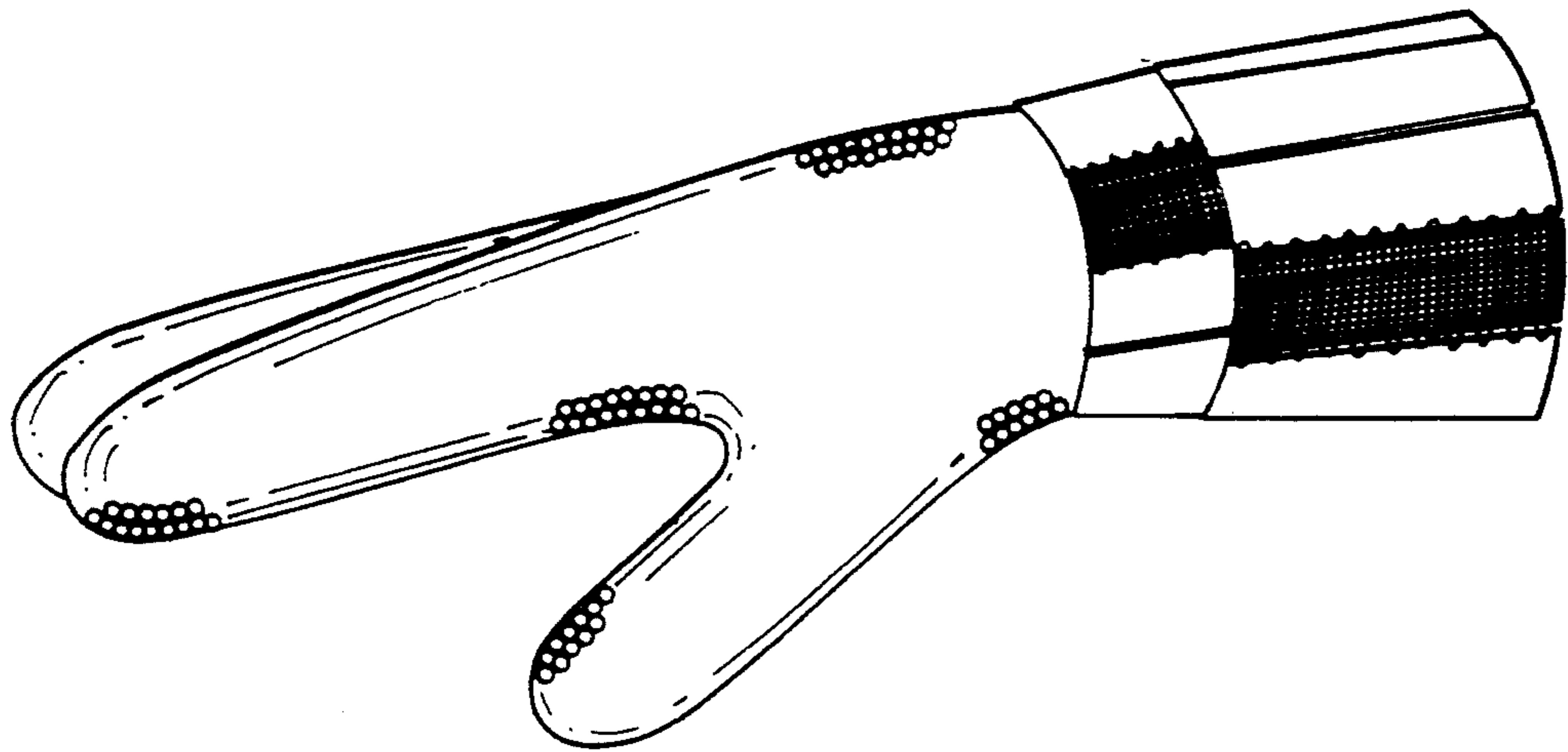

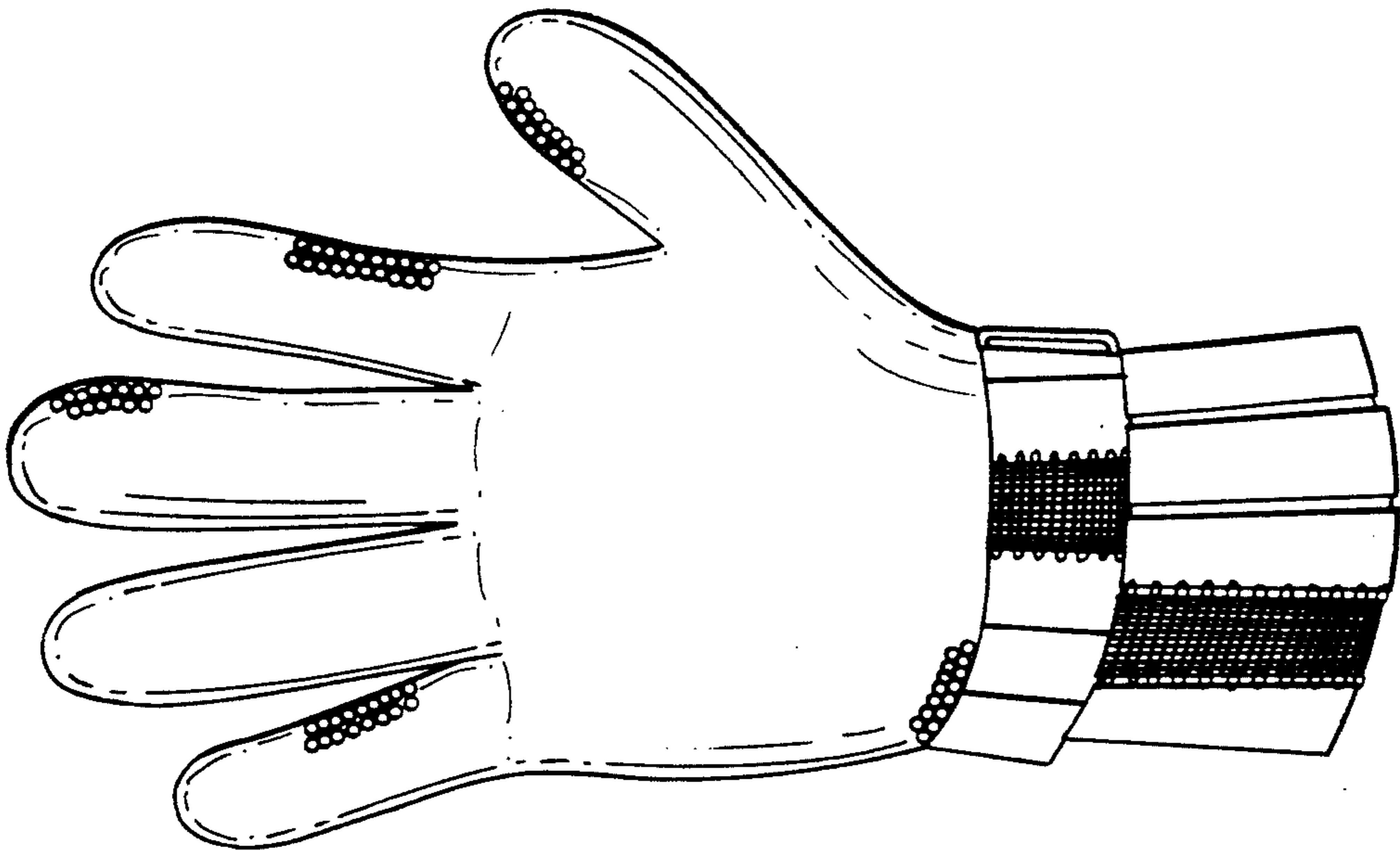

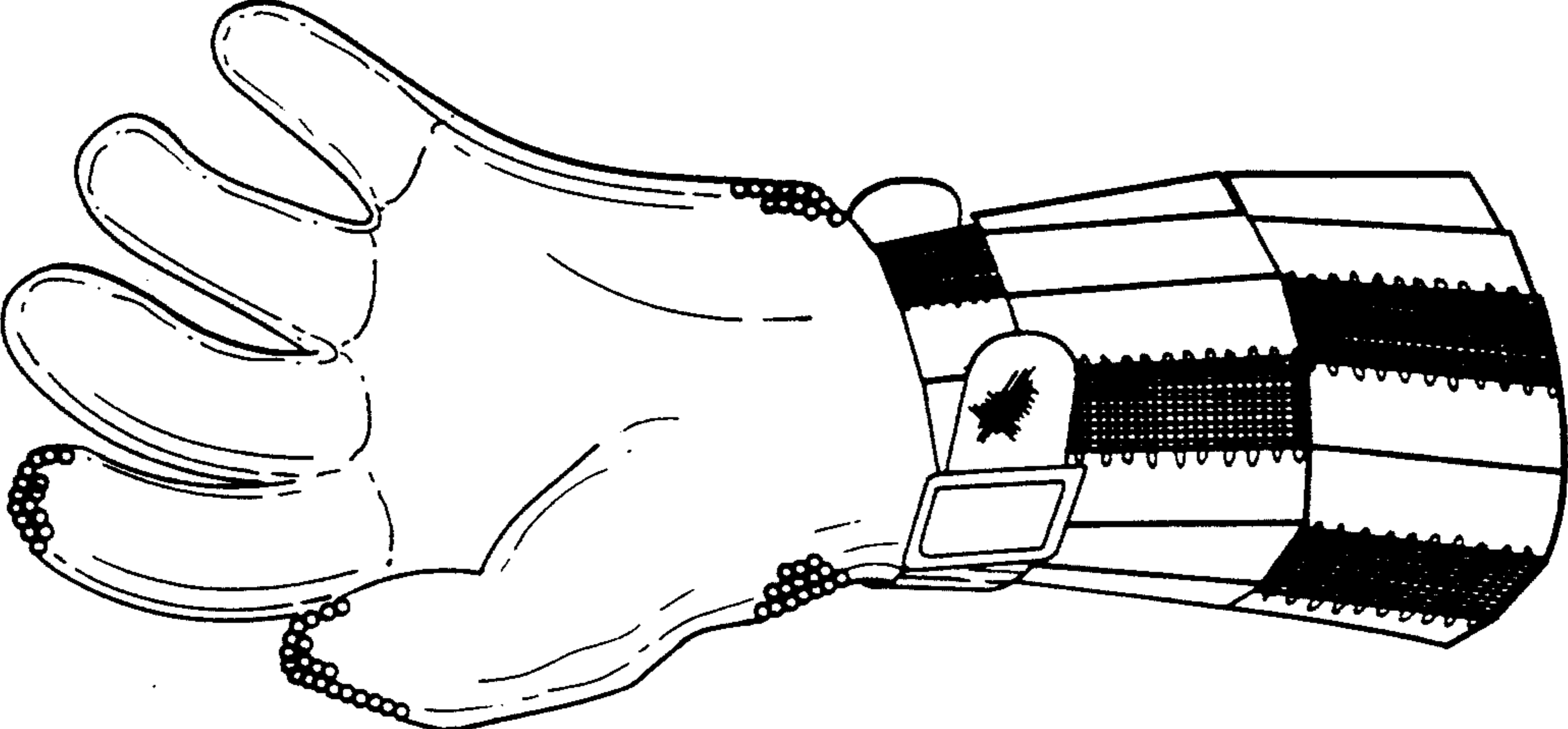

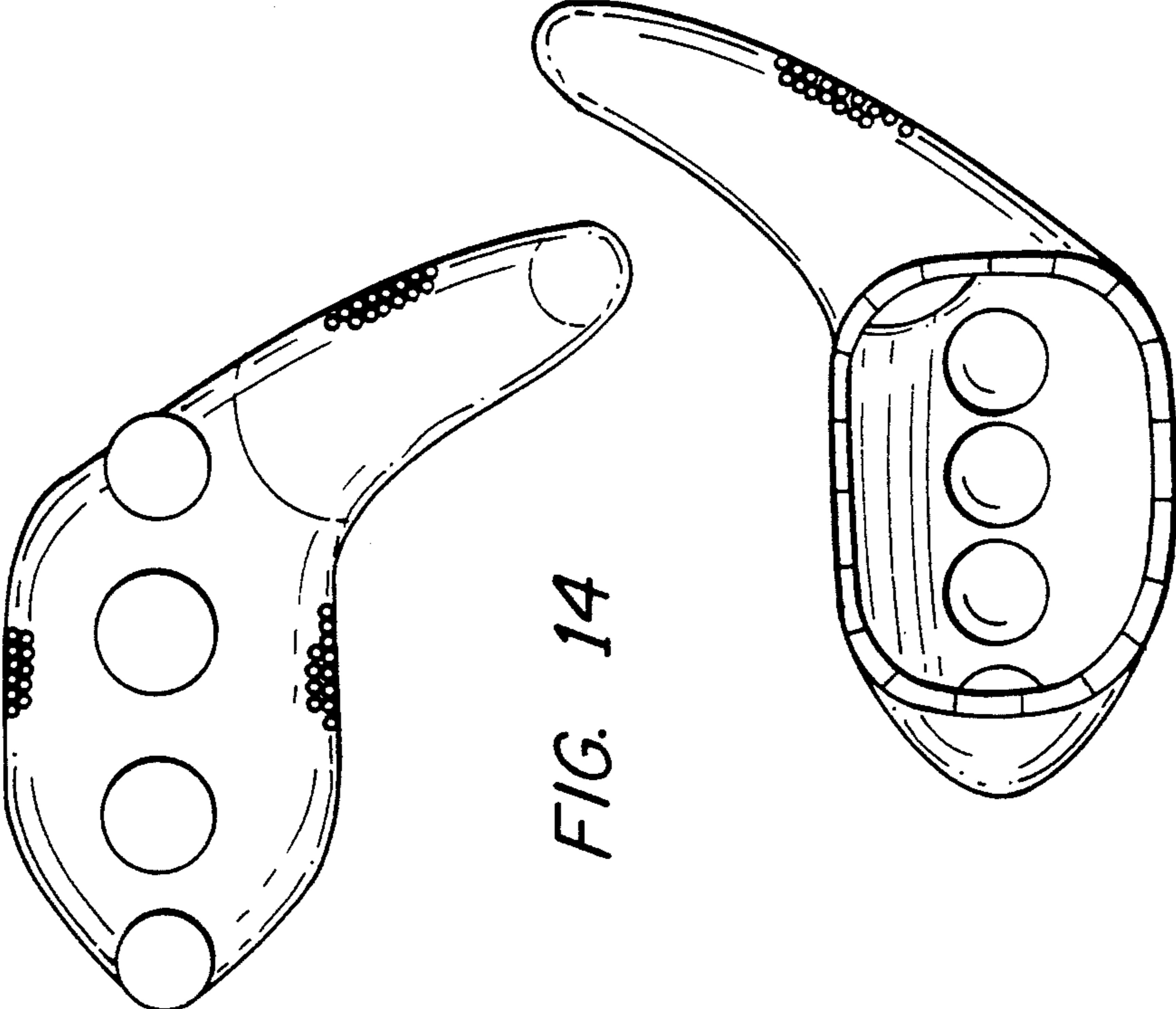

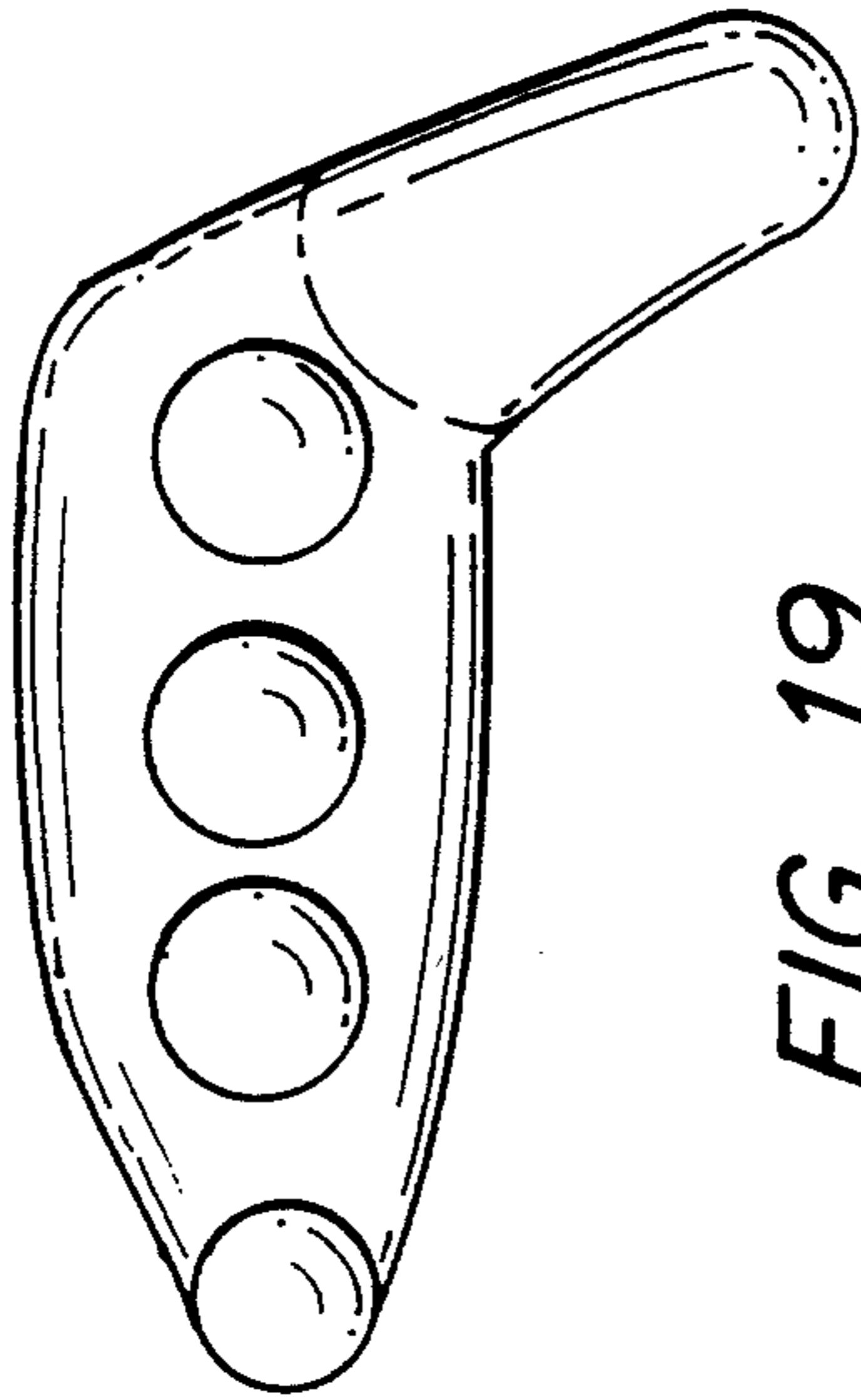

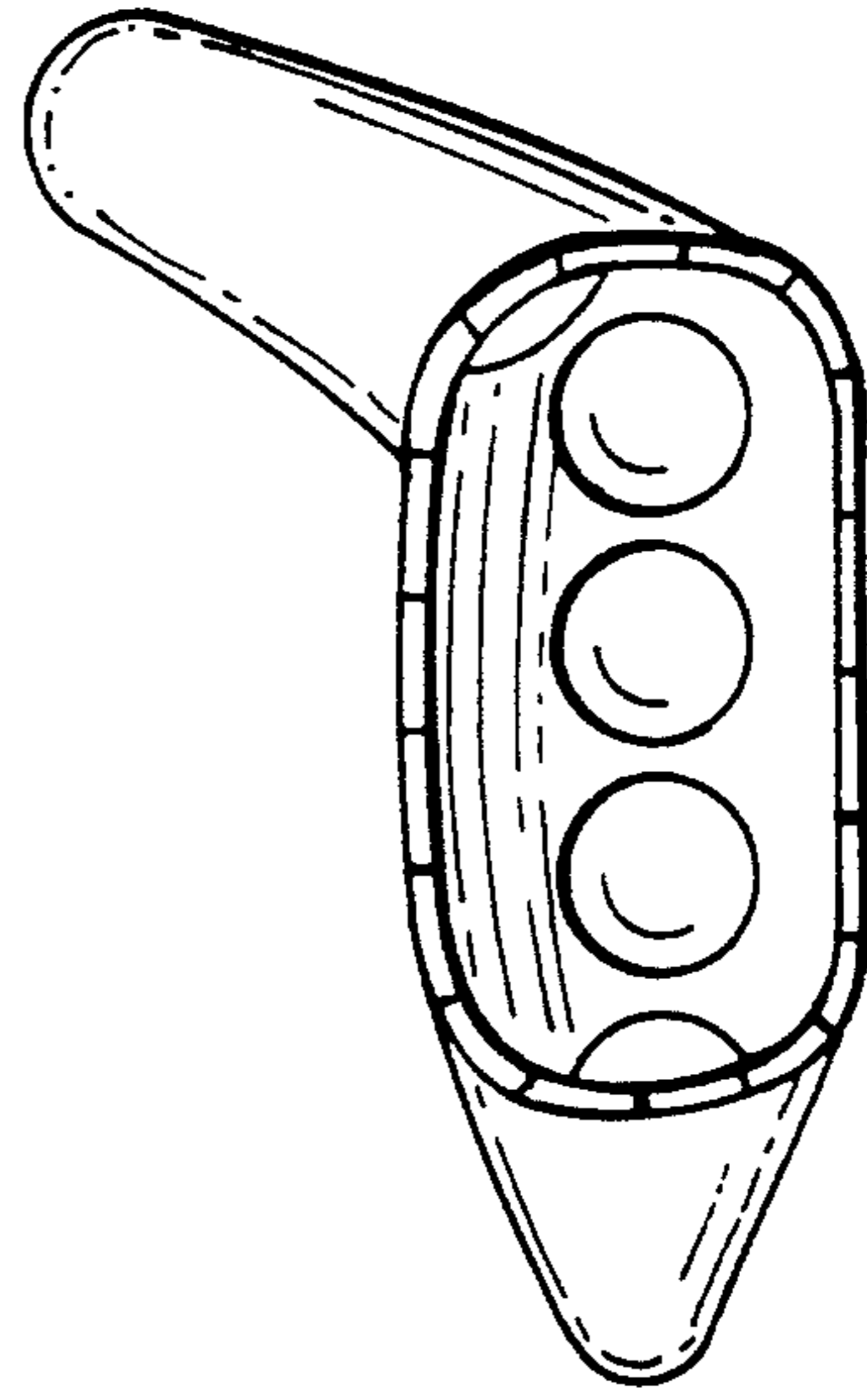

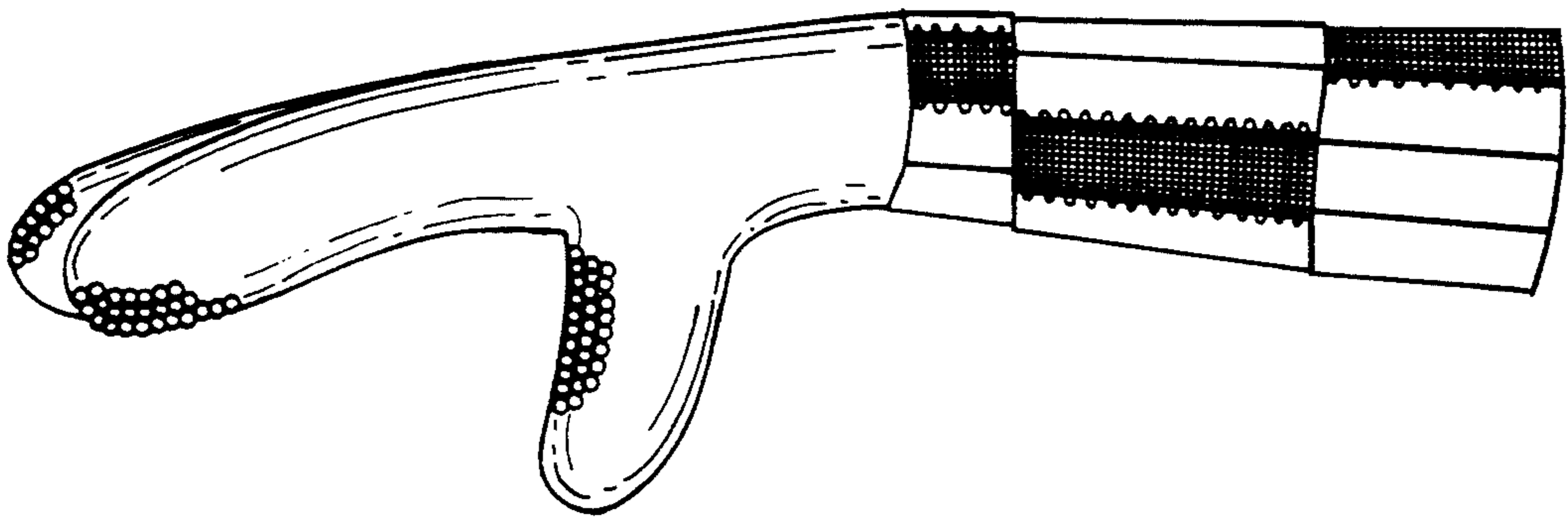

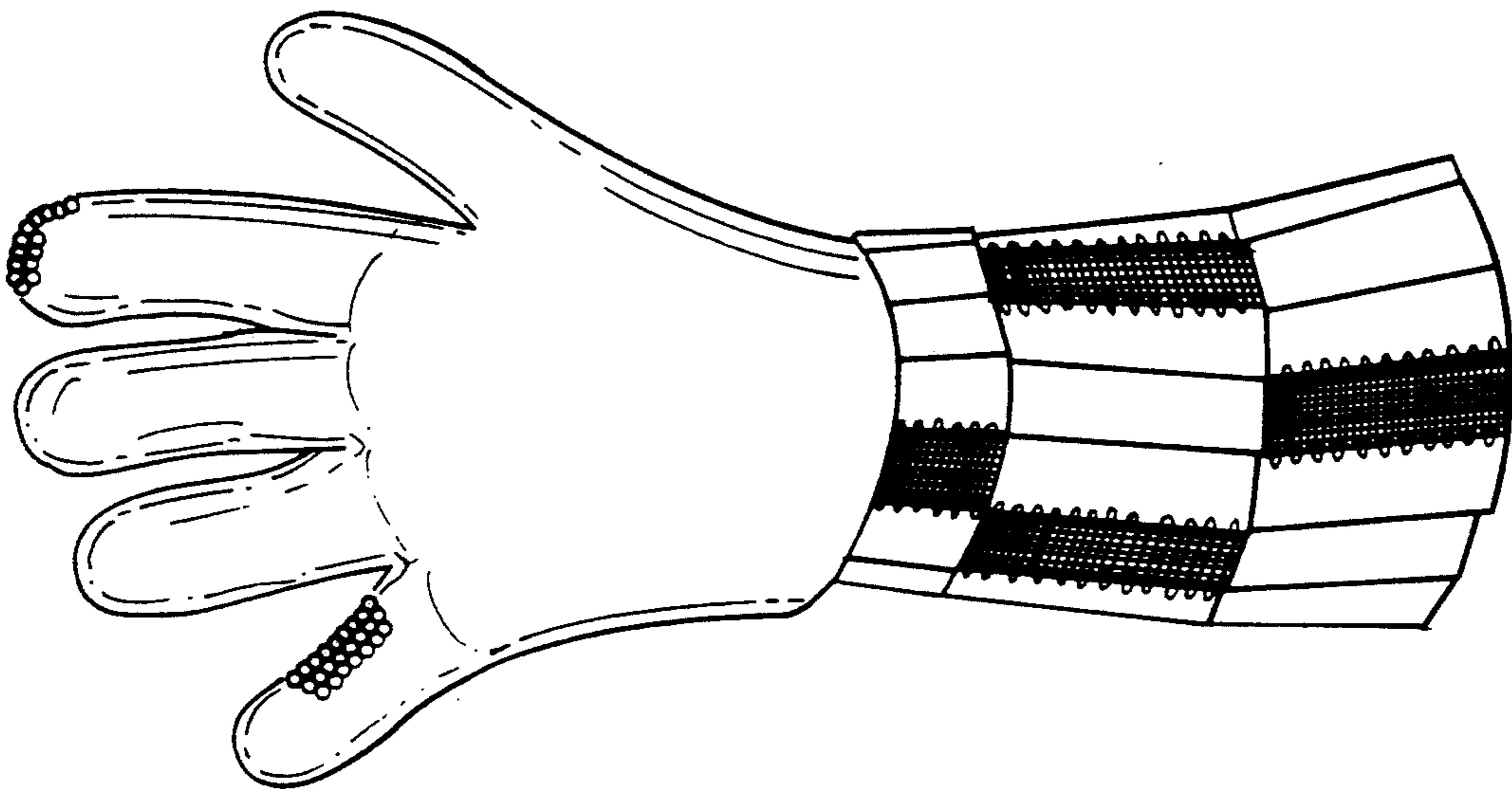

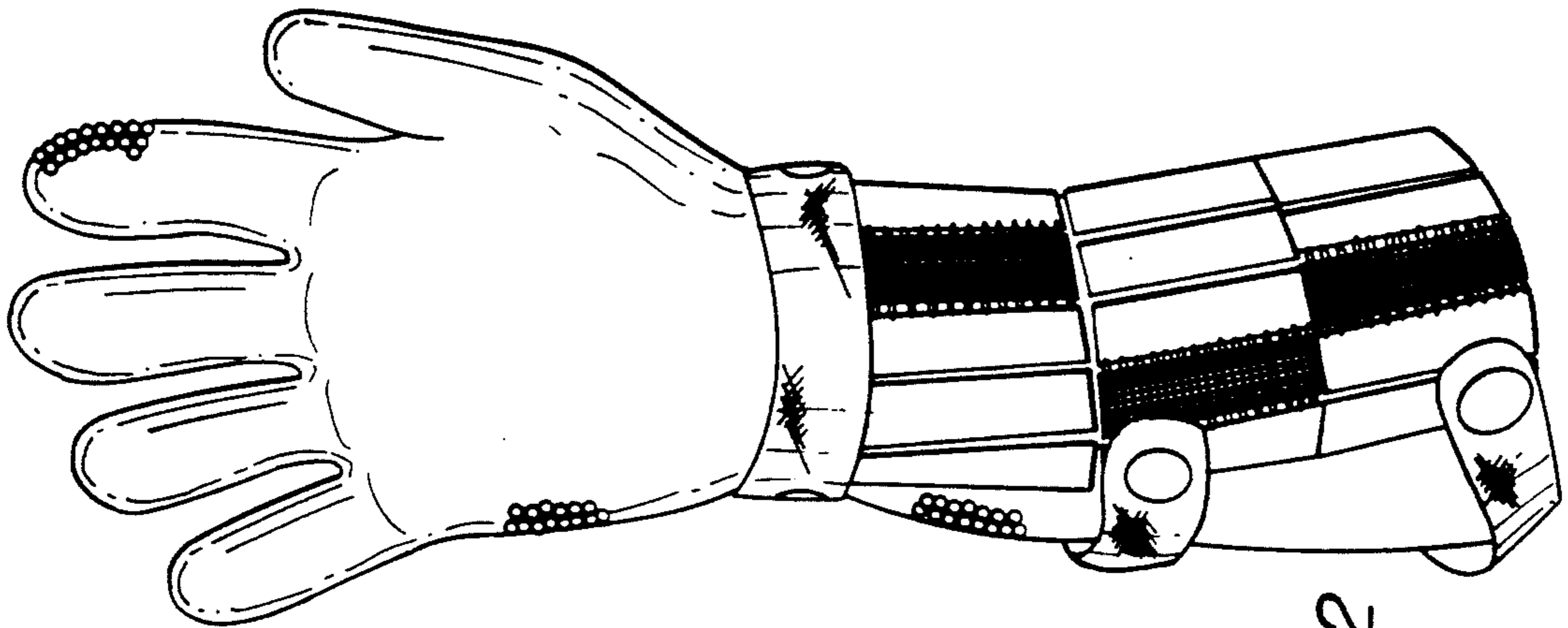

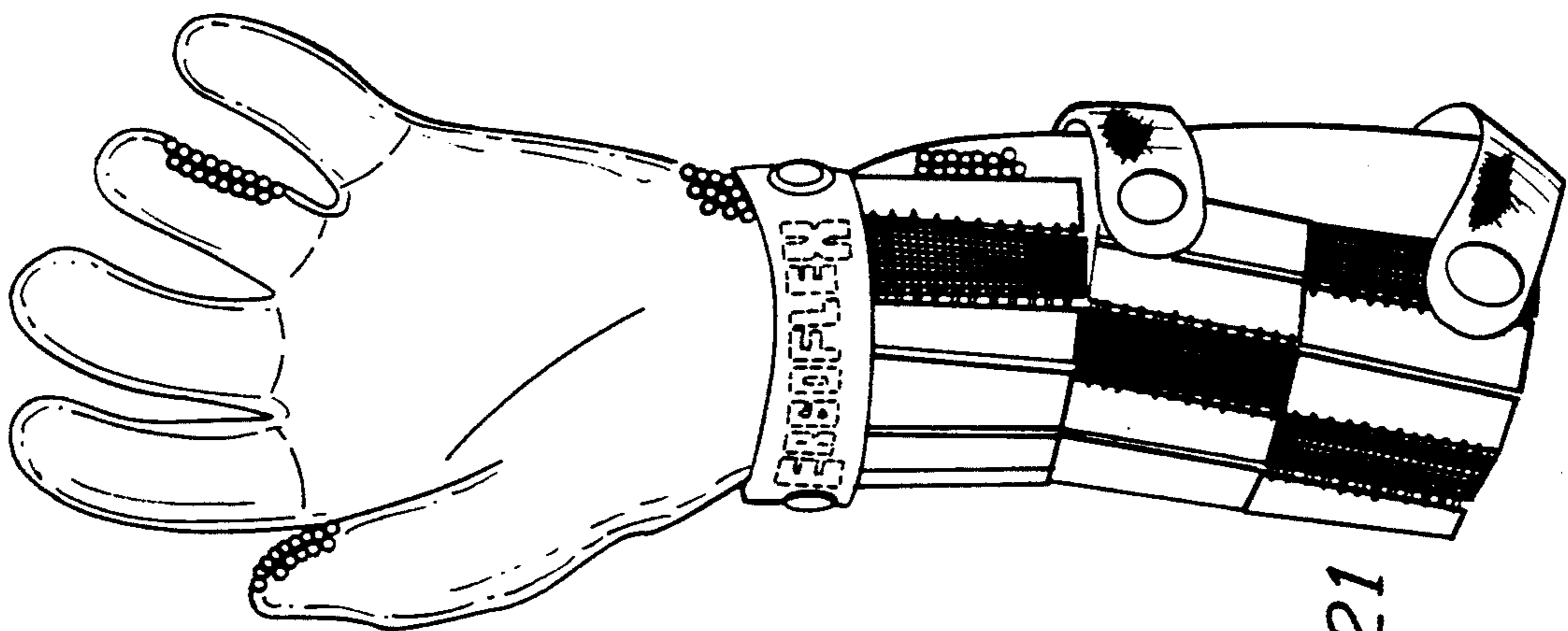

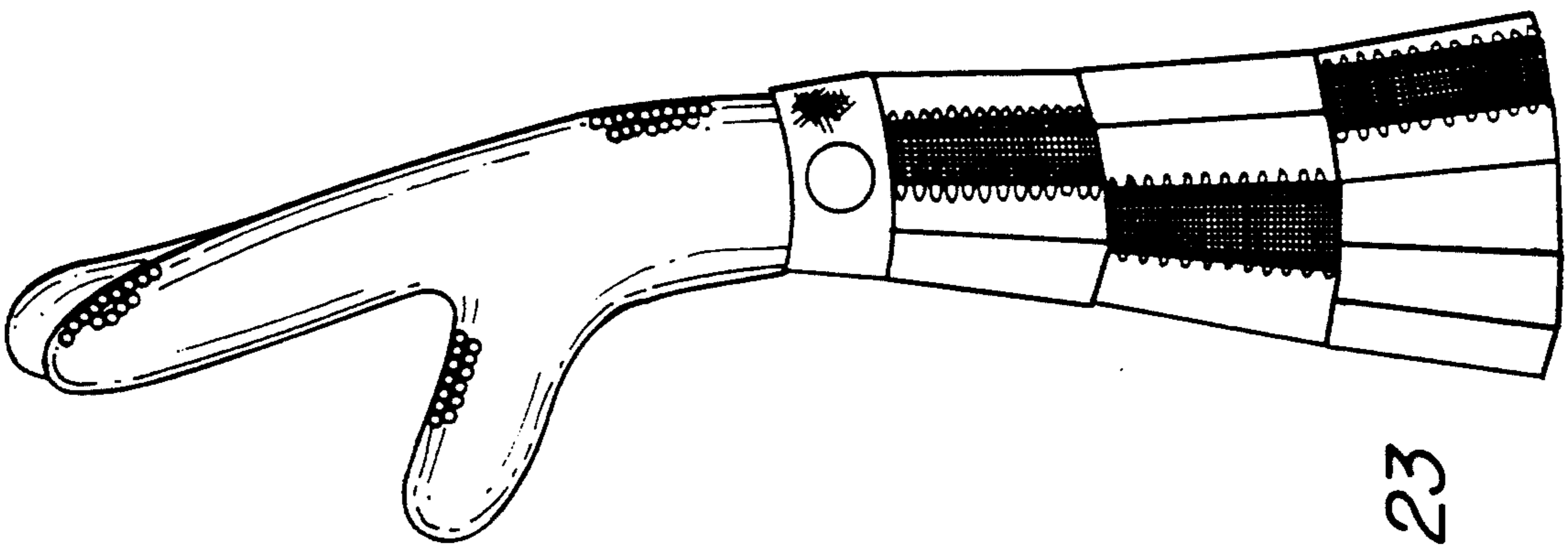

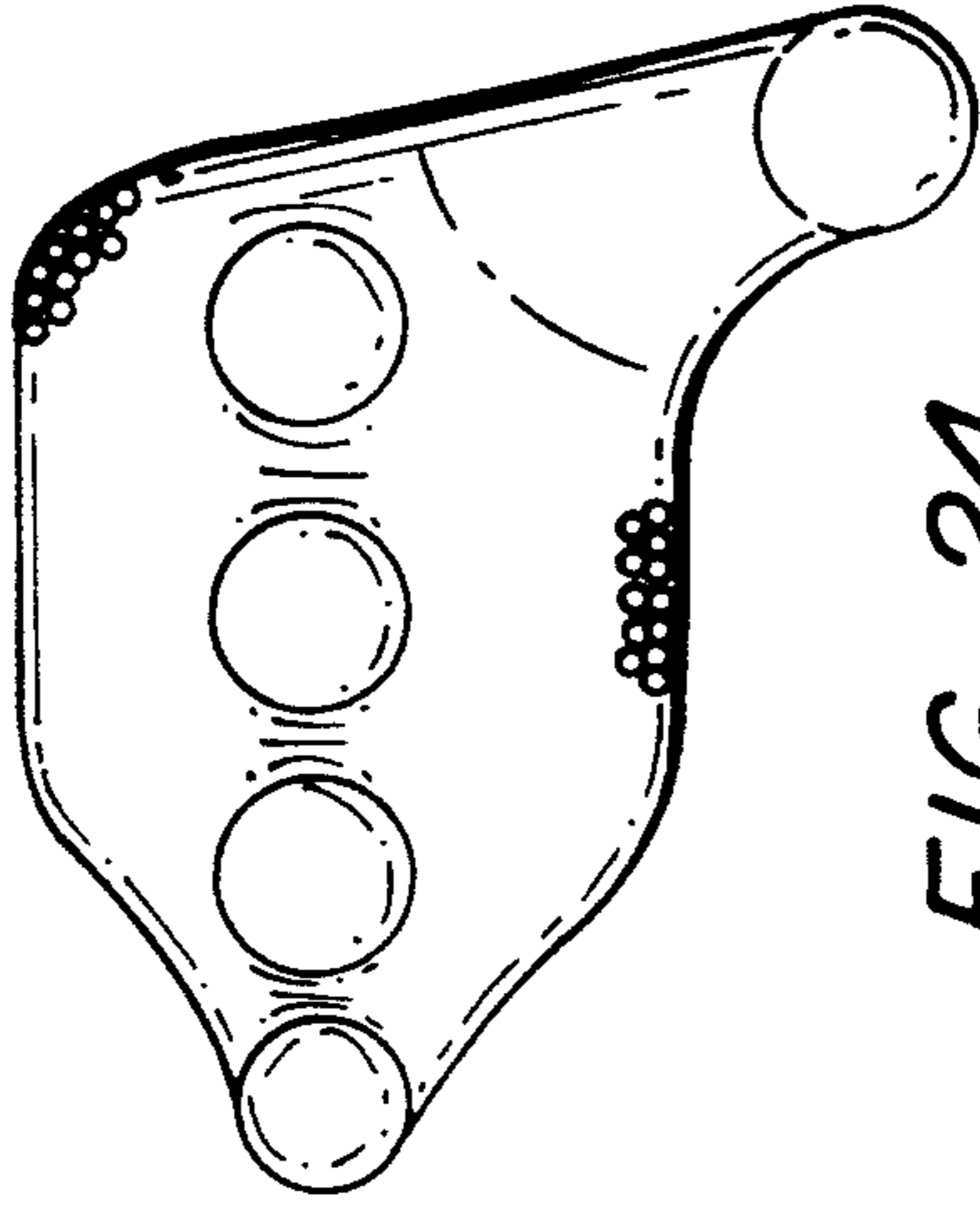

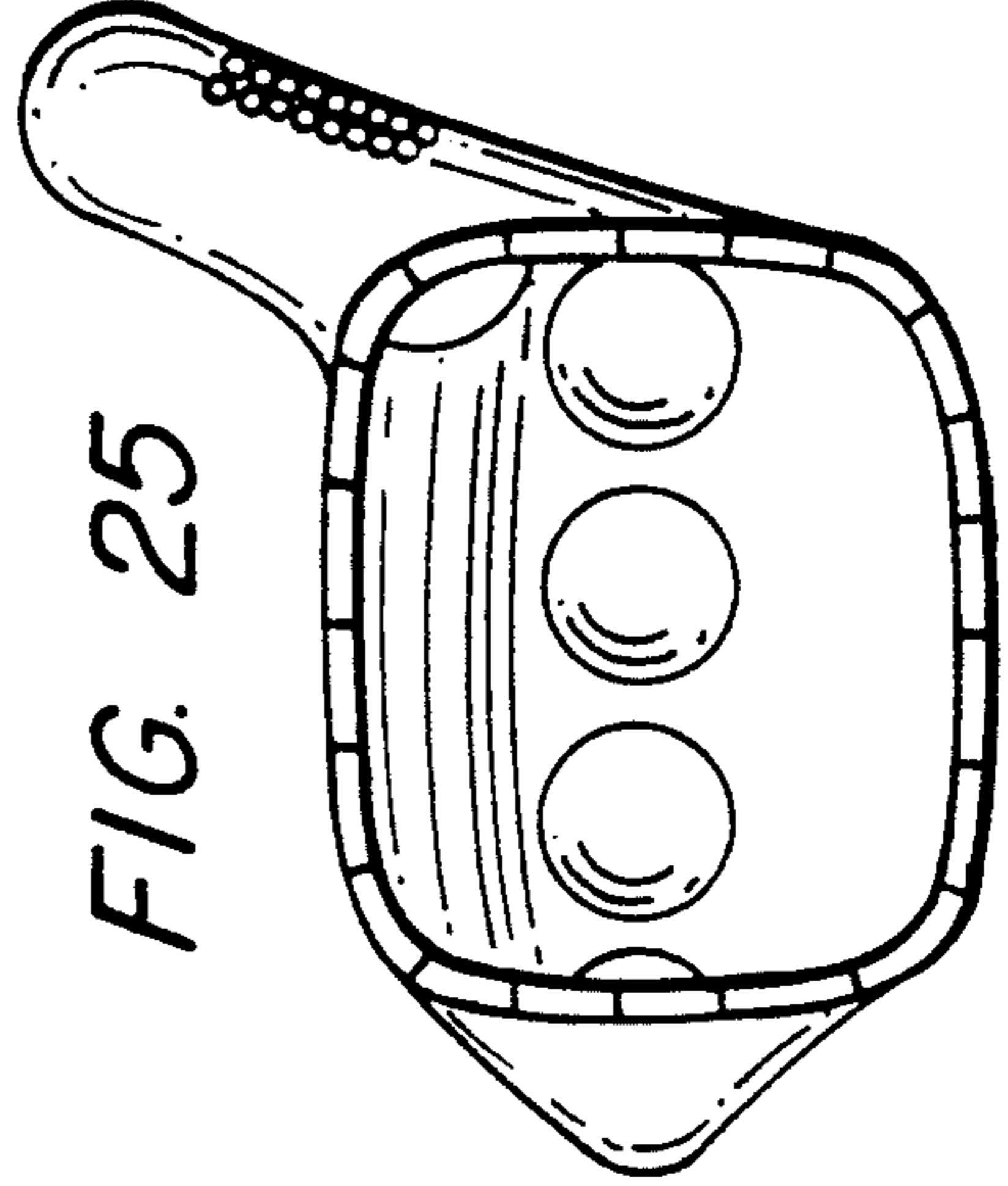

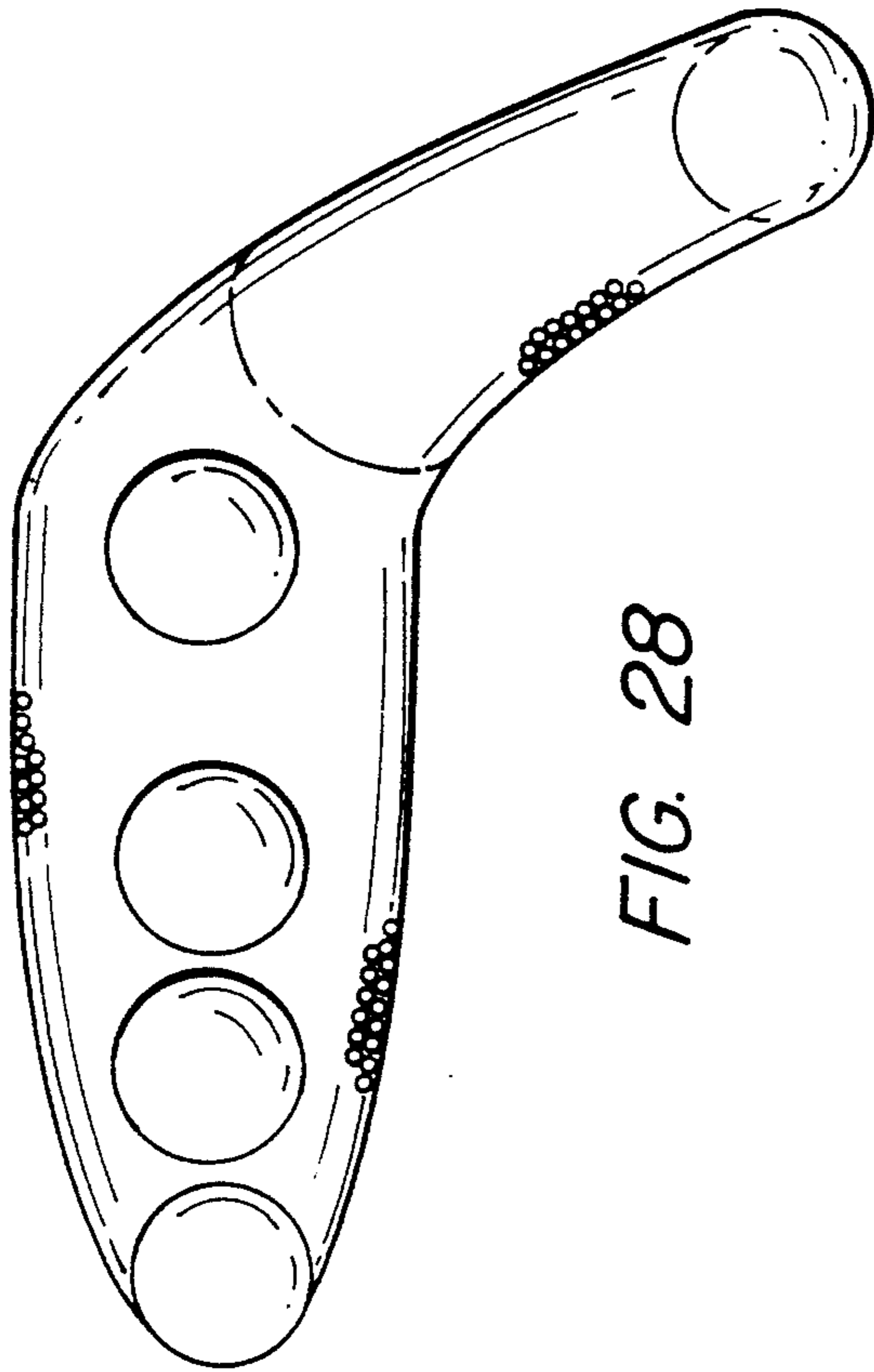

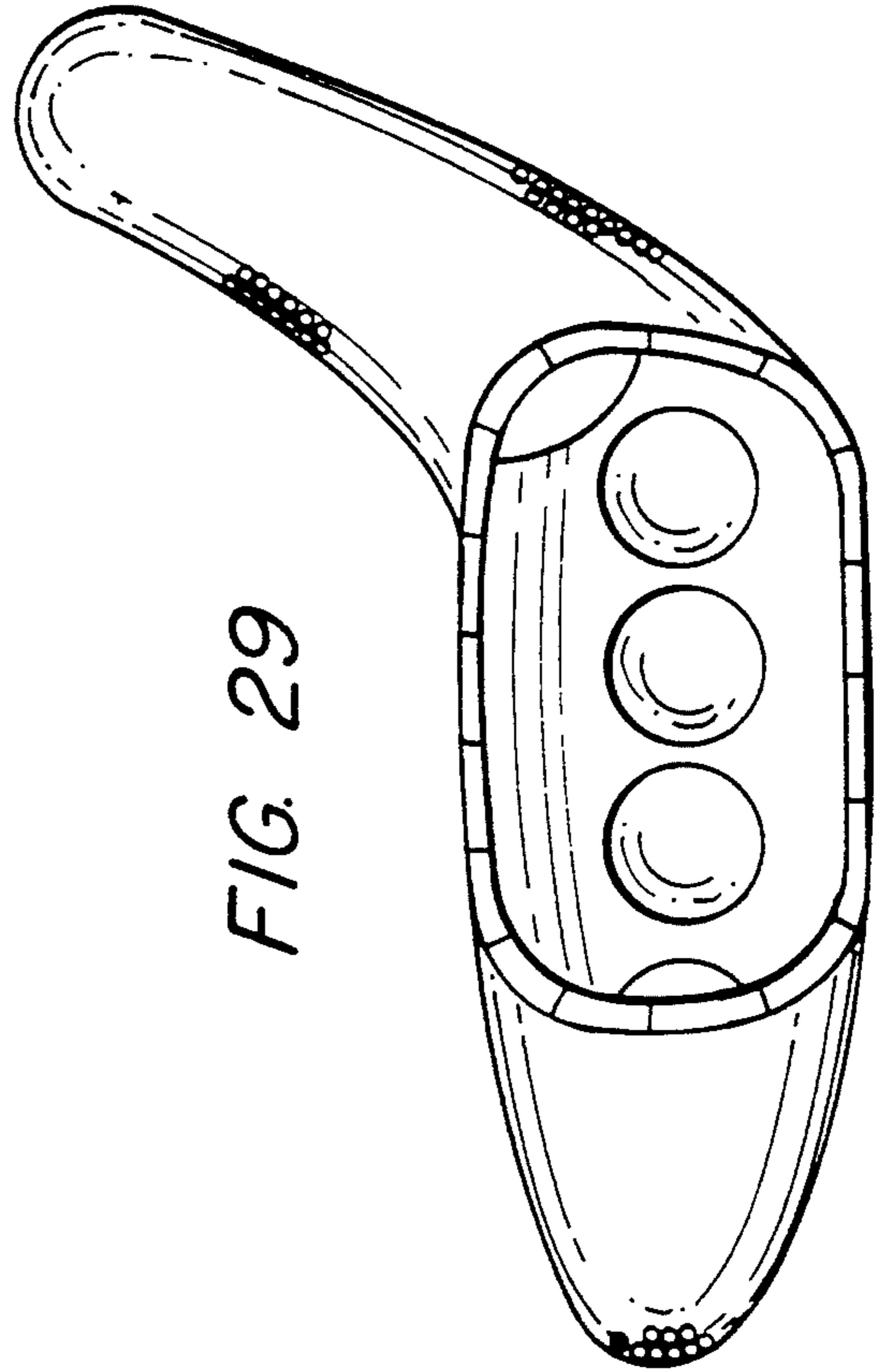

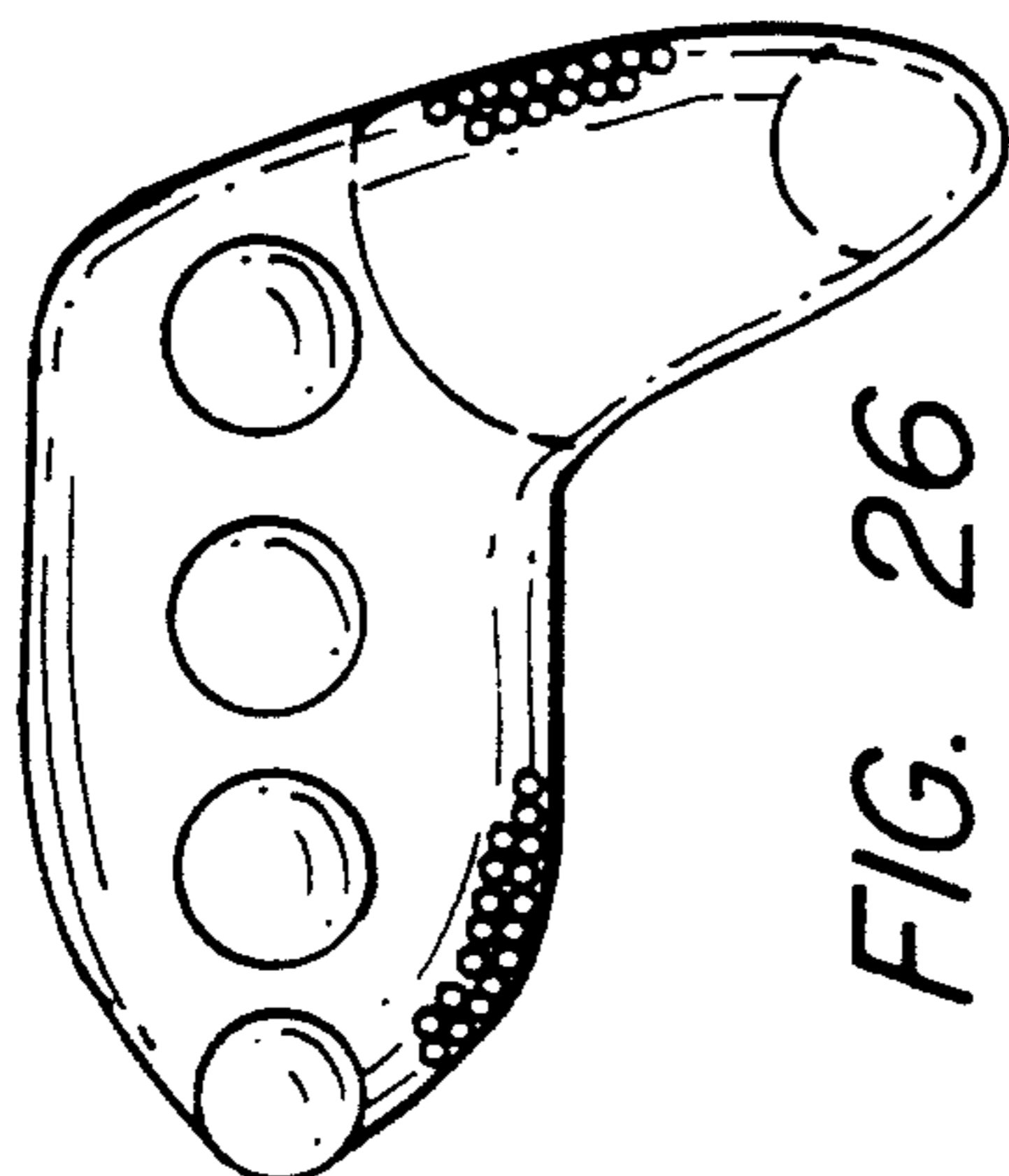

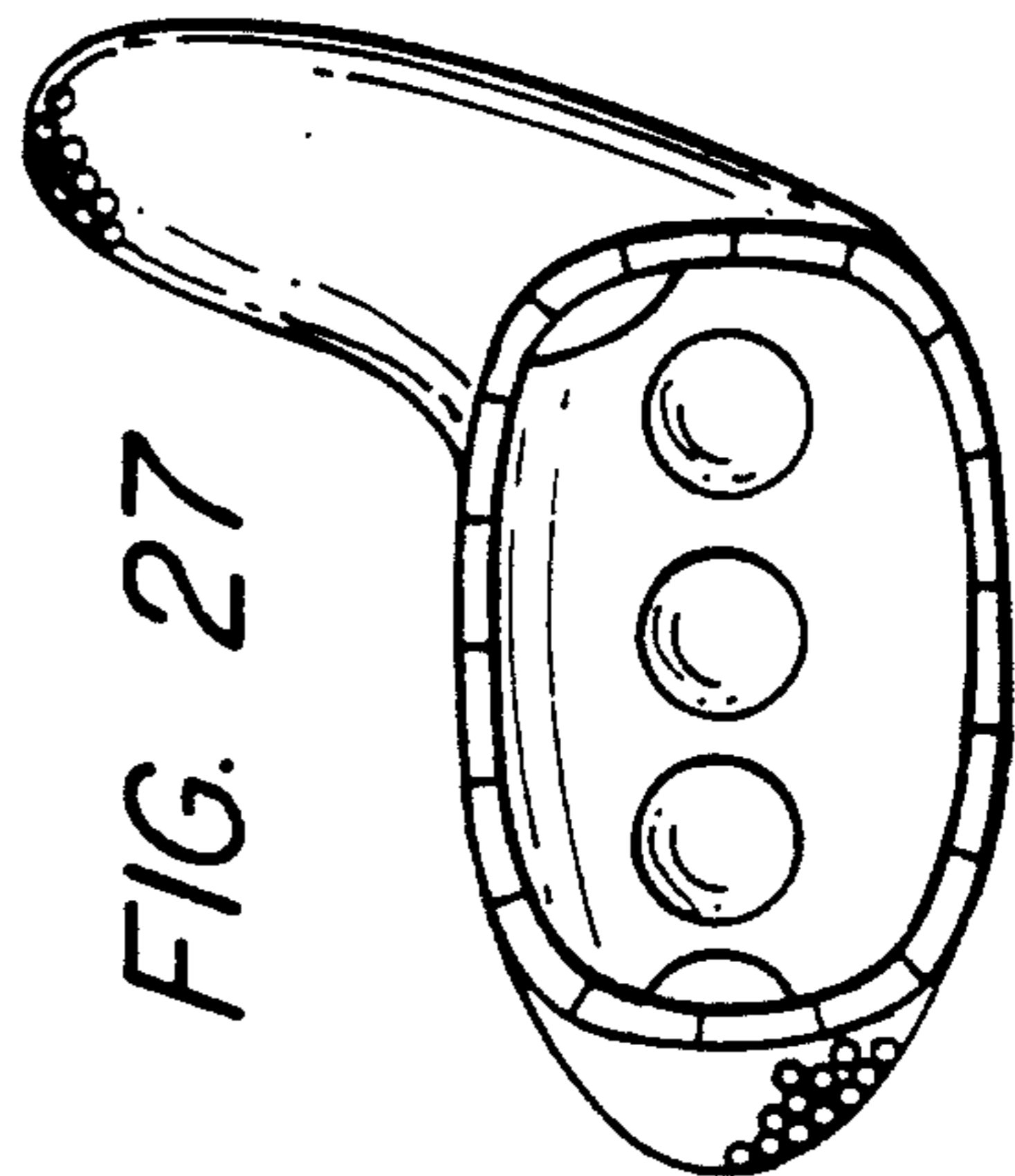
