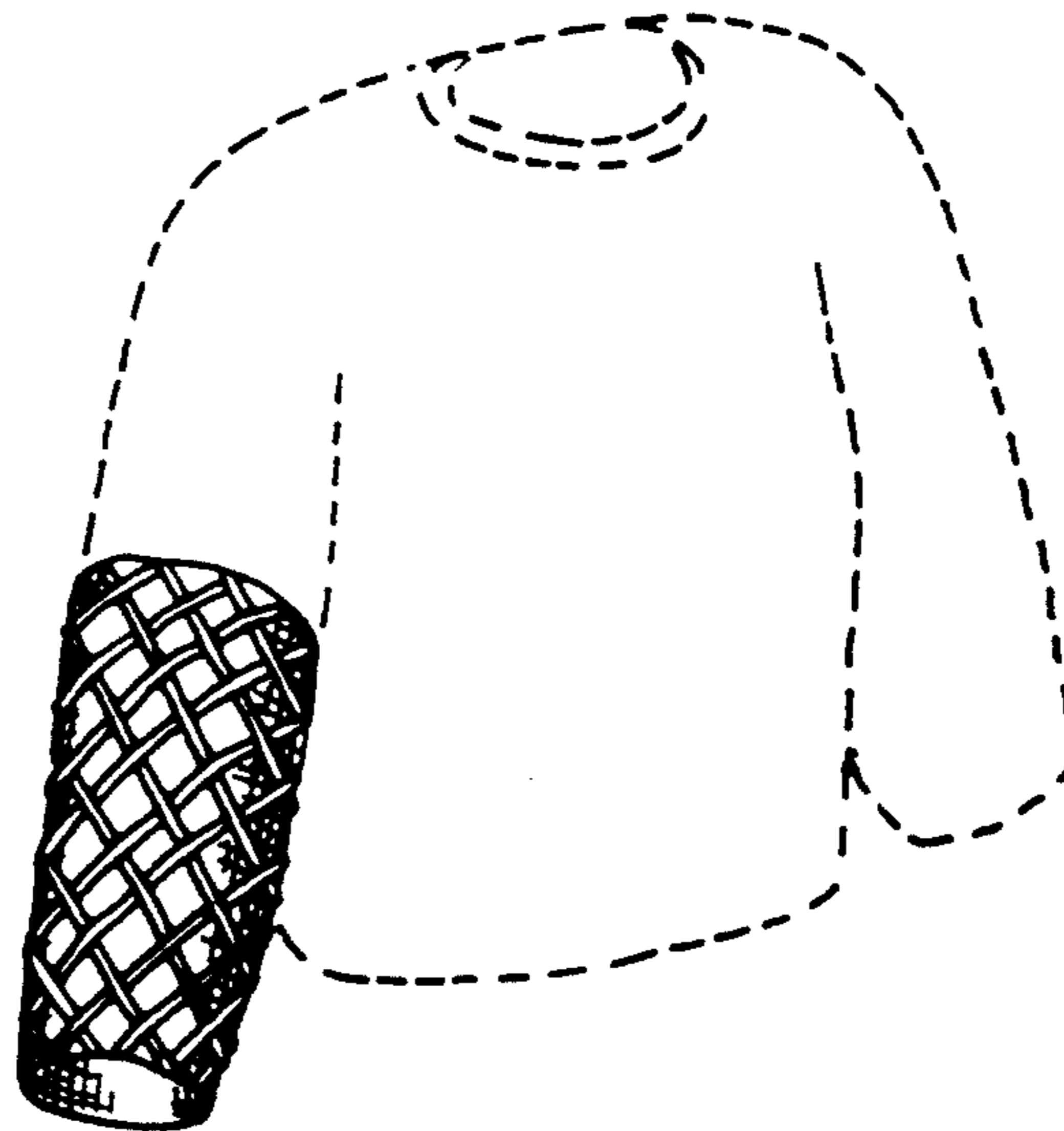

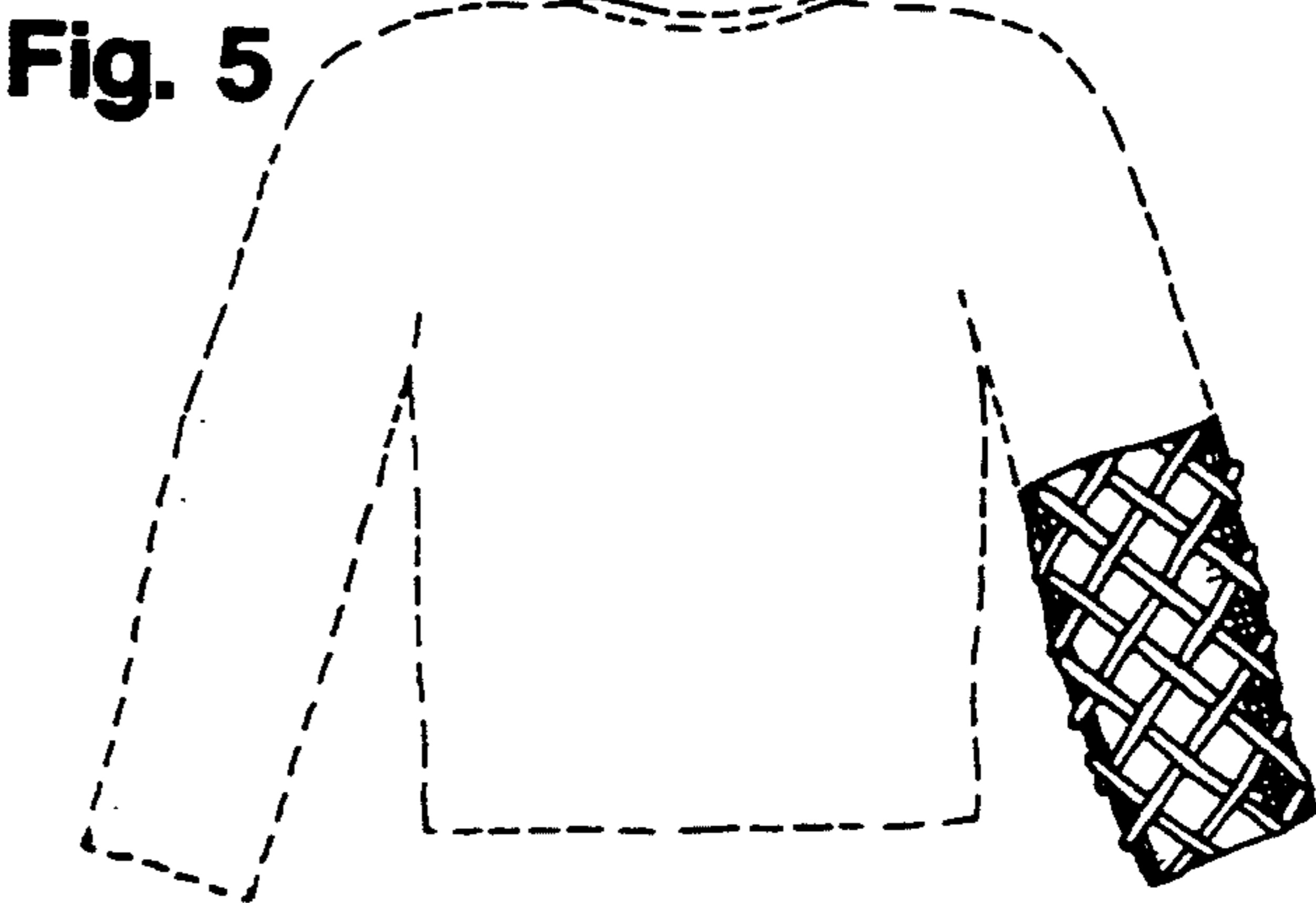
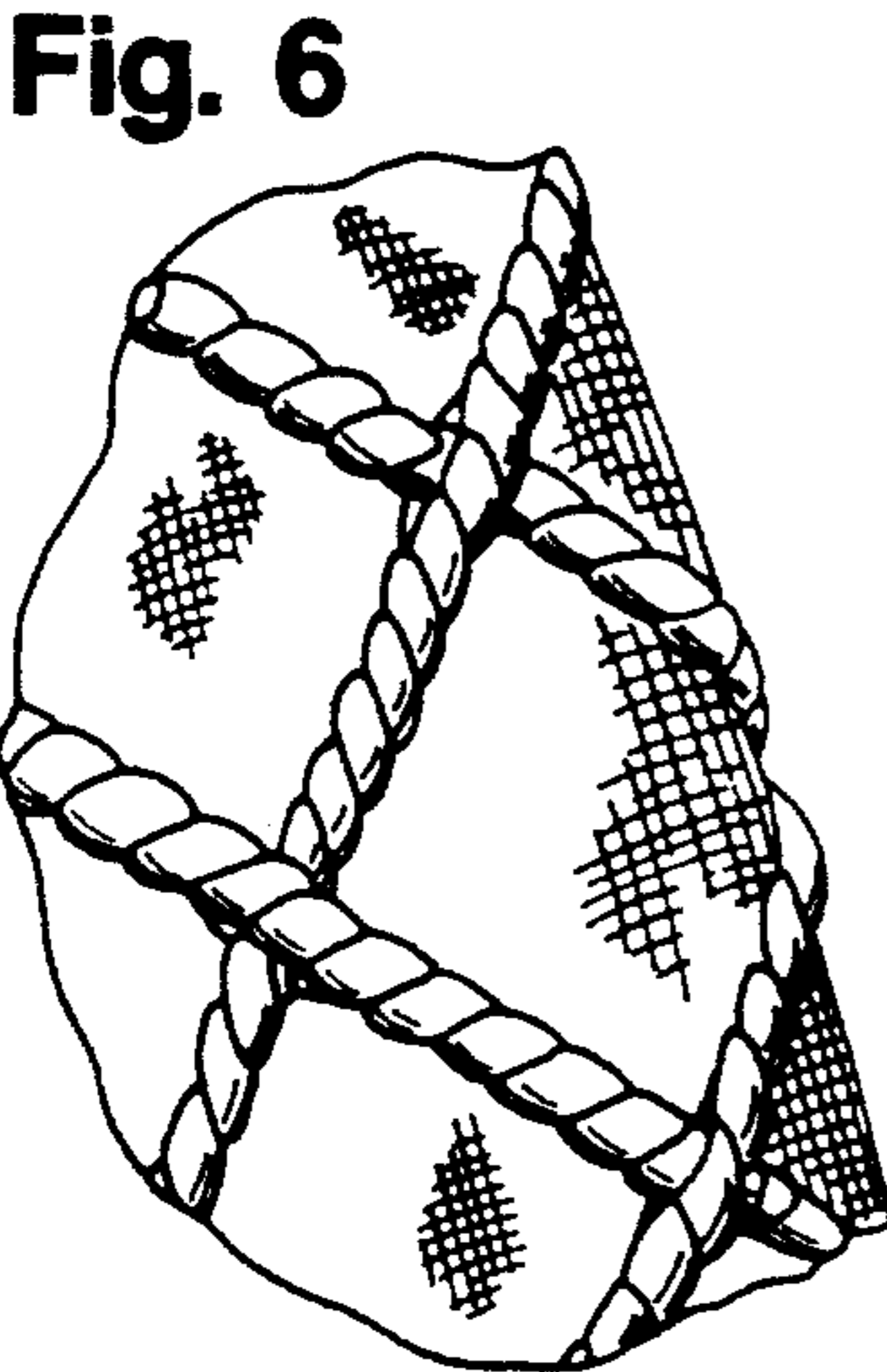
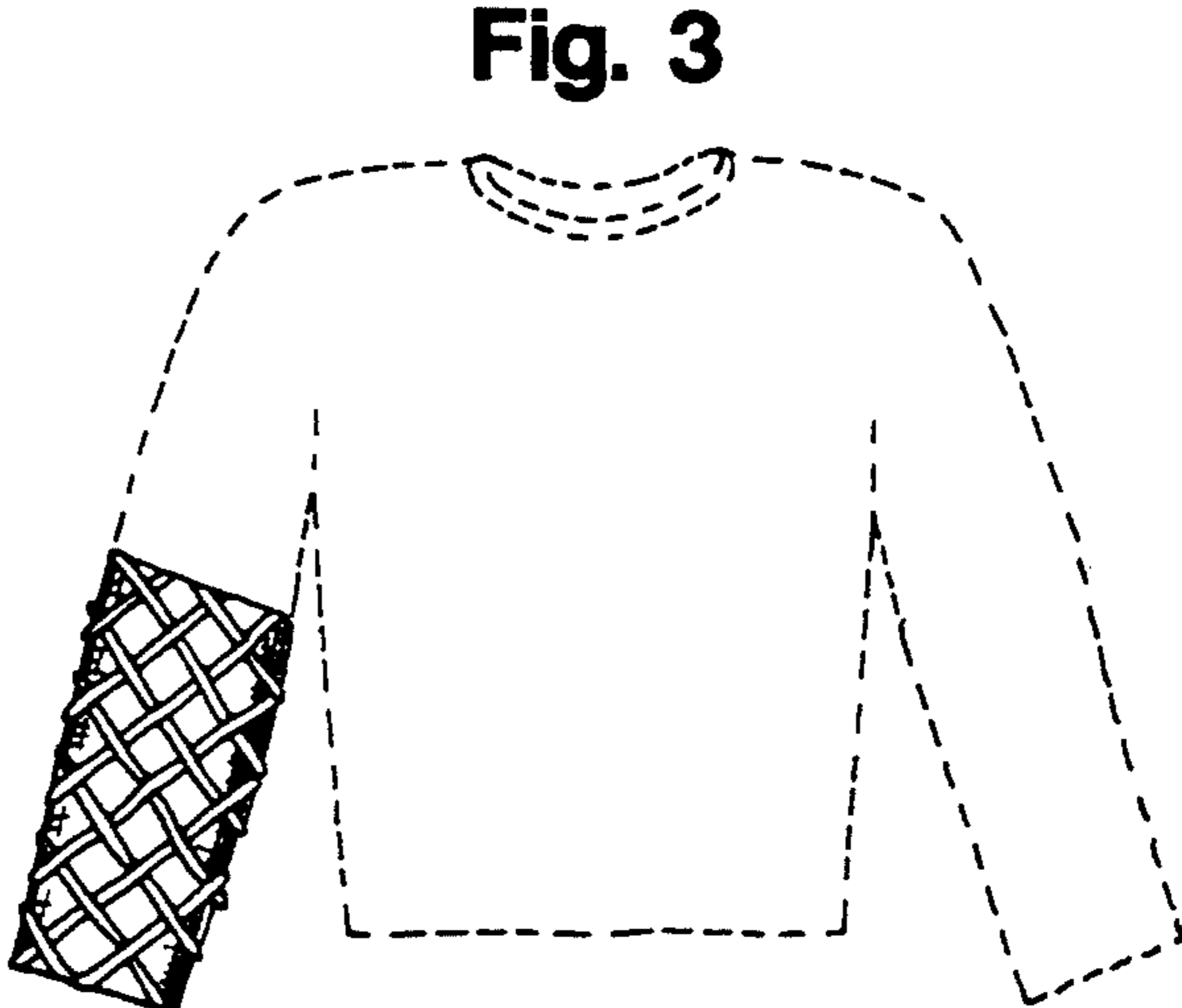
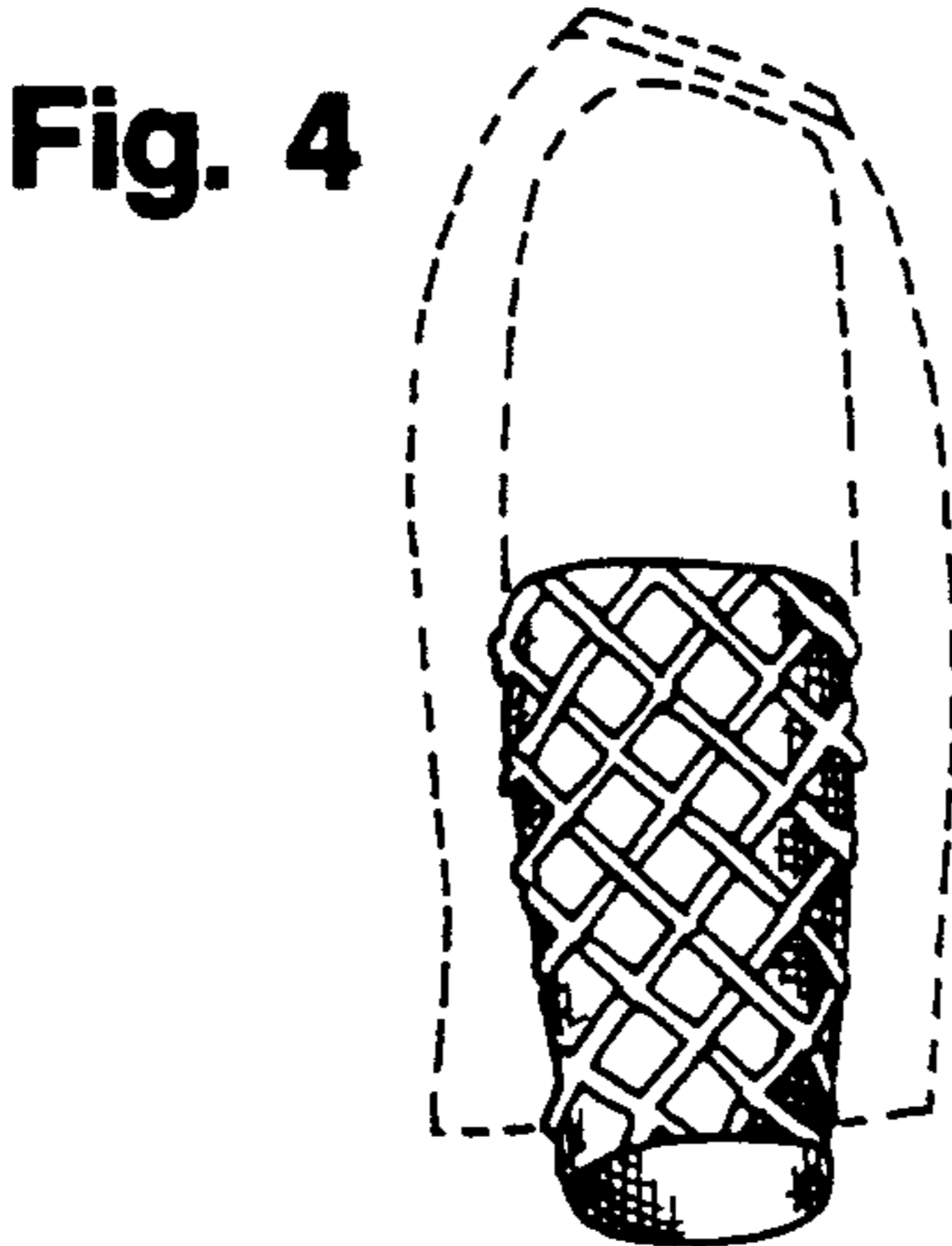
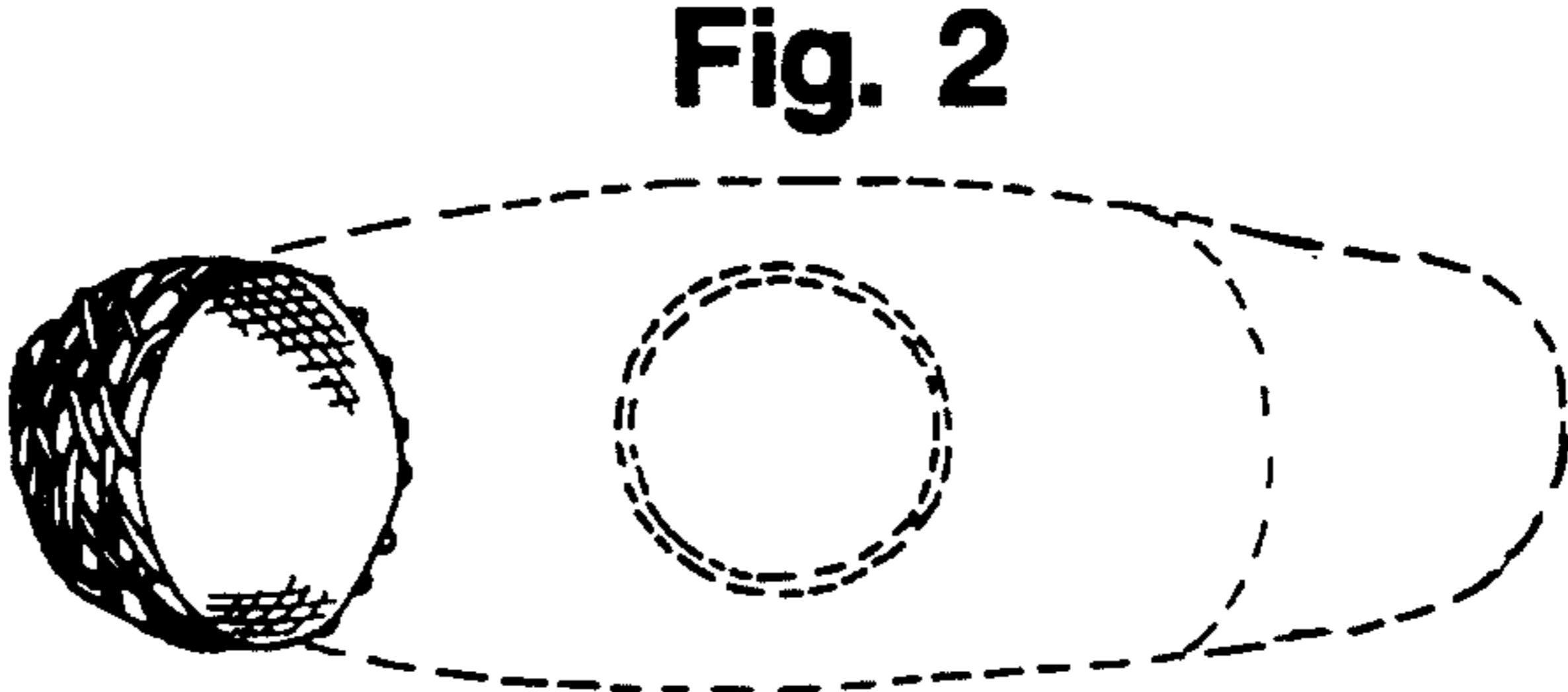
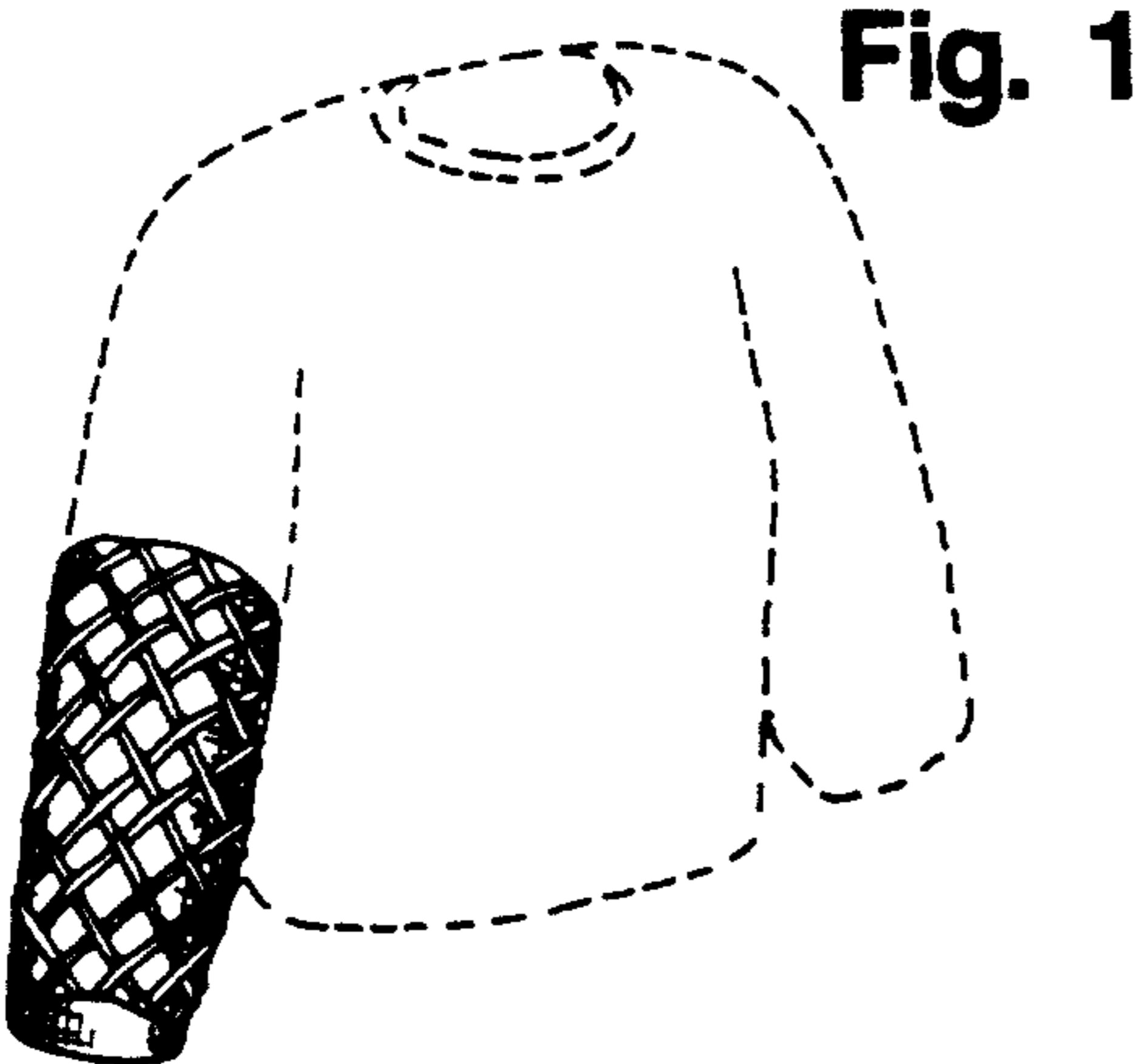
The ornamental design for an element of upper body clothing, as shown and described.
