CLAIM

The ornamental design for a dual personalized watercraft, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a dual personalized watercraft showing our new design; FIG. 2 is a right side elevational view thereof; FIG. 3 is a left side elevational view thereof; FIG. 4 is a sectional view taken along the line 4-4 of FIG. 1; FIG. 5 is a sectional view taken along the line 5-5 of FIG. 1; FIG. 6 is a sectional view taken along the line 6-6 of FIG. 1; FIG. 7 is an enlarged front elevational view thereof; FIG. 8 is an enlarged rear elevational view thereof; and, FIG. 9 is a bottom plan view thereof.
