[57] **CLAIM**

The ornamental design for a shoe outsole, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom plan view of an outsole showing my new design;

FIG. 2 is a side elevational view of one side of the outsole shown in FIG. 1;

FIG. 3 is a side elevational view of the other side of the outsole shown in FIG. 1;

FIG. 4 is a cross section taken along line 4-4 of FIG. 1;

FIG. 5 is a cross section taken along line 5-5 of FIG. 1;

FIG. 6 is a cross section taken along line of 6-6 of FIG. 1;

FIG. 7 is a cross section taken along line 7-7 of FIG. 1;

FIG. 8 is a cross section taken along line 8-8 of FIG. 1;

FIG. 9 is a cross section taken along line 9-9 of FIG. 1; and,

FIG. 10 is a cross section taken along line 10-10 of FIG. 1.

The broken line showing of a sole periphery and a shoe upper in FIGS. 2 and 3 are for illustrative purposes and form no part of the claimed design.

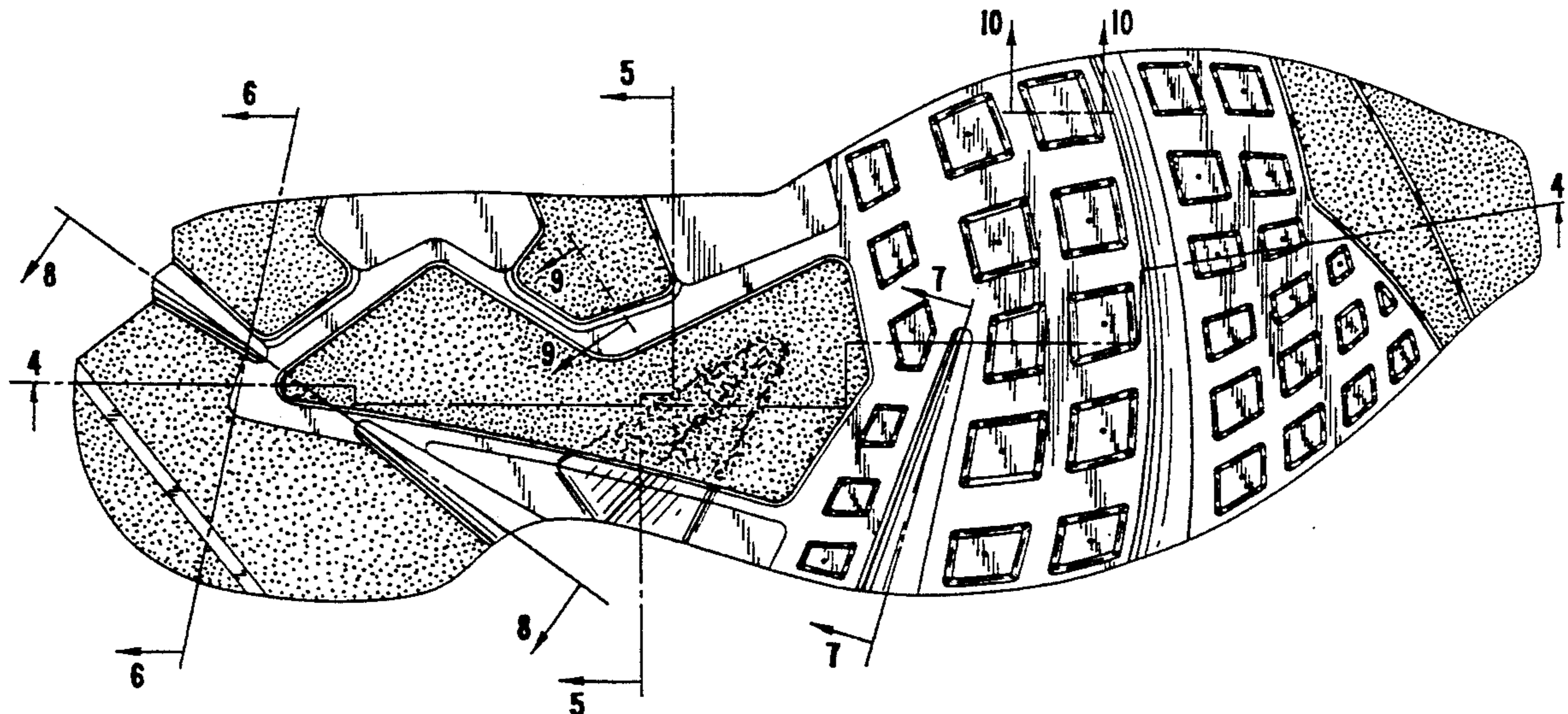

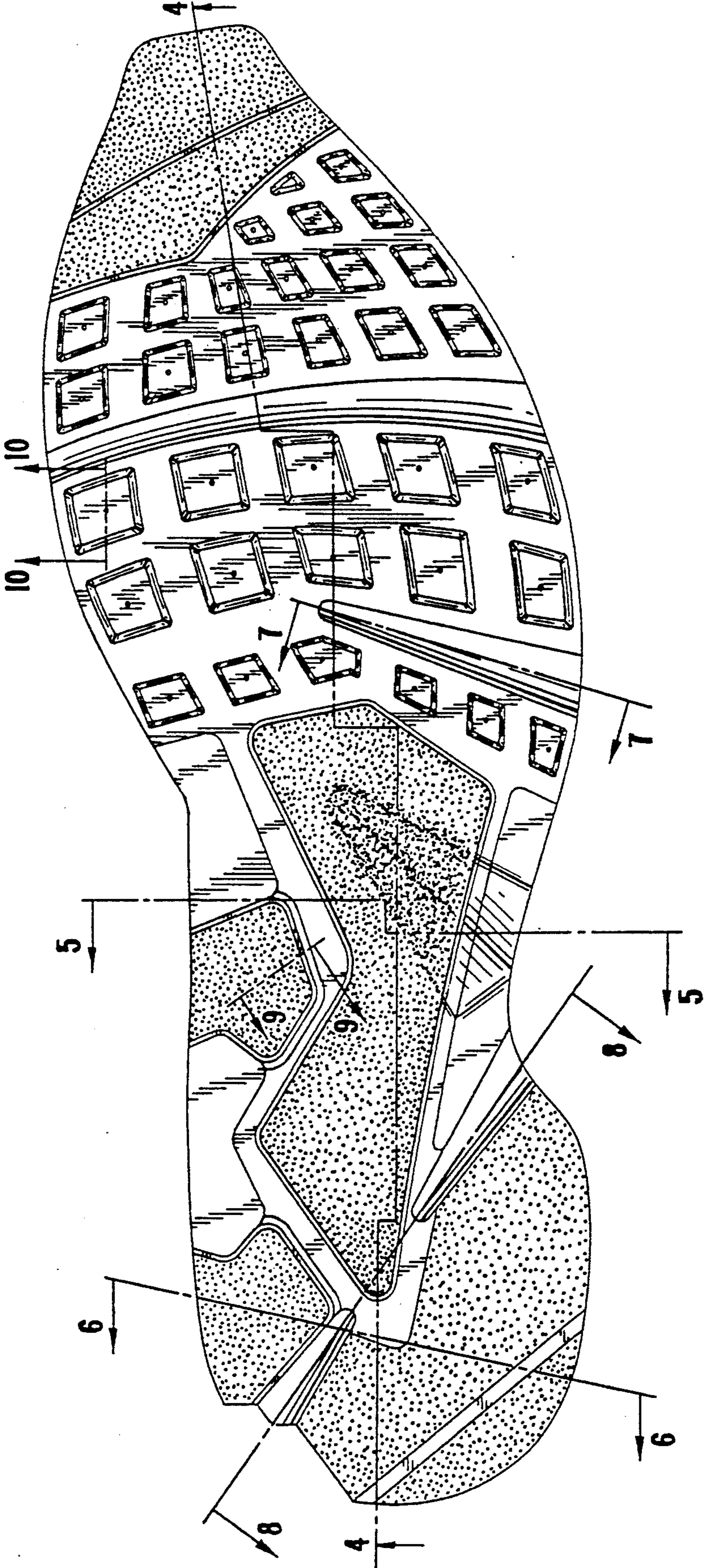
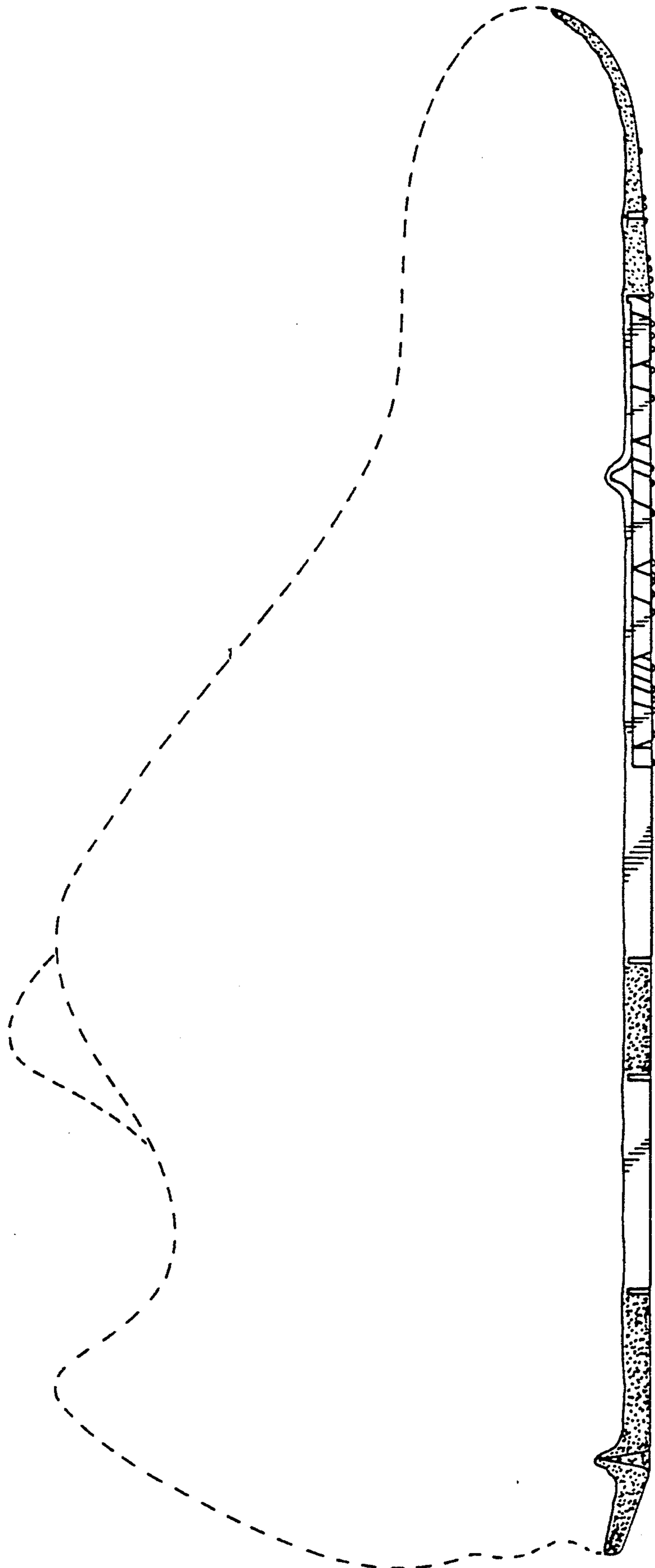

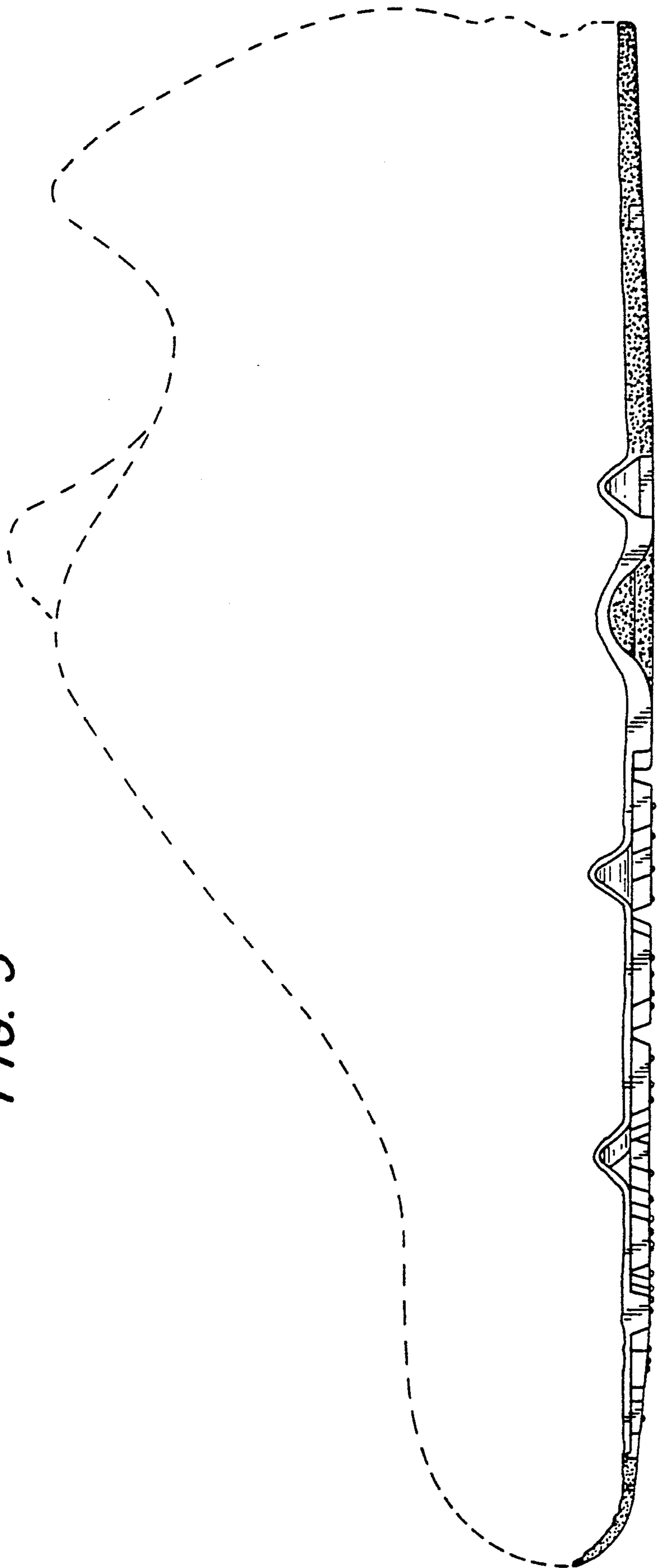

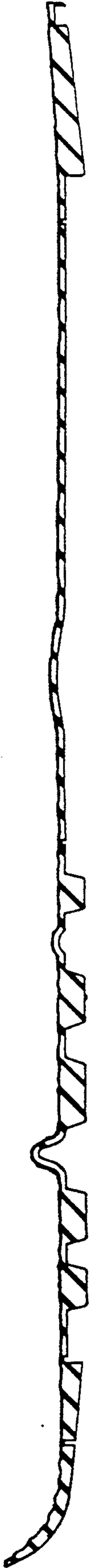
