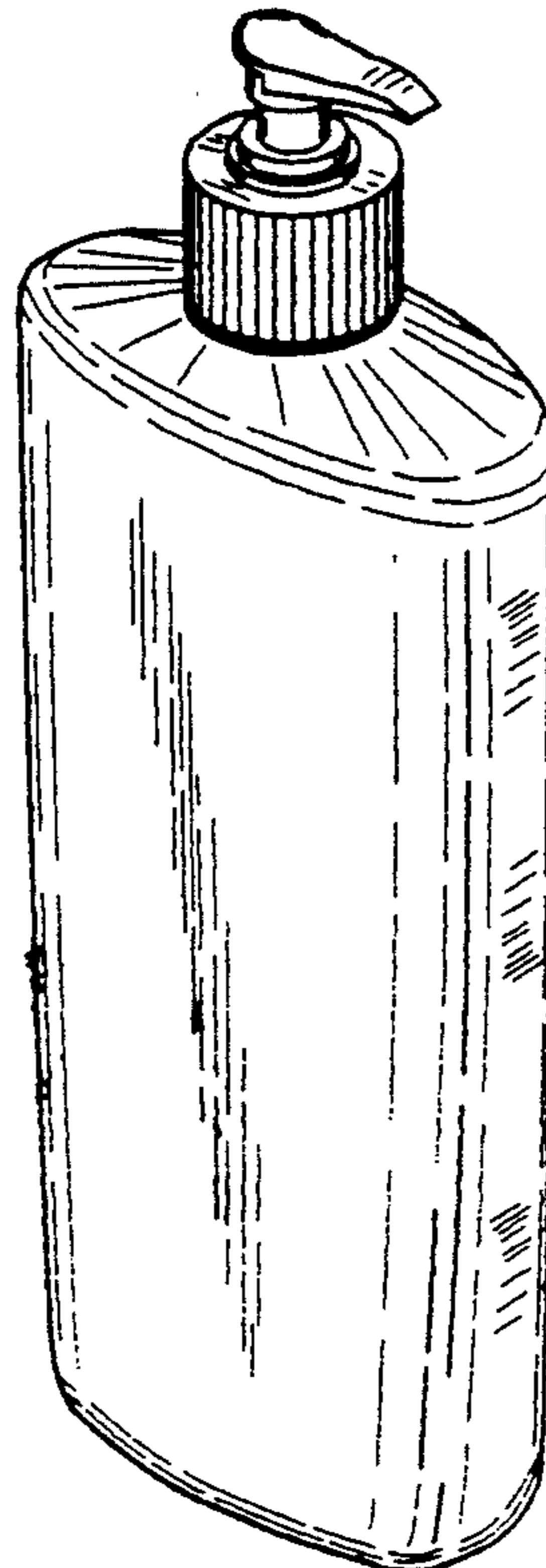
The ornamental design for a pump dispenser, as shown and described.

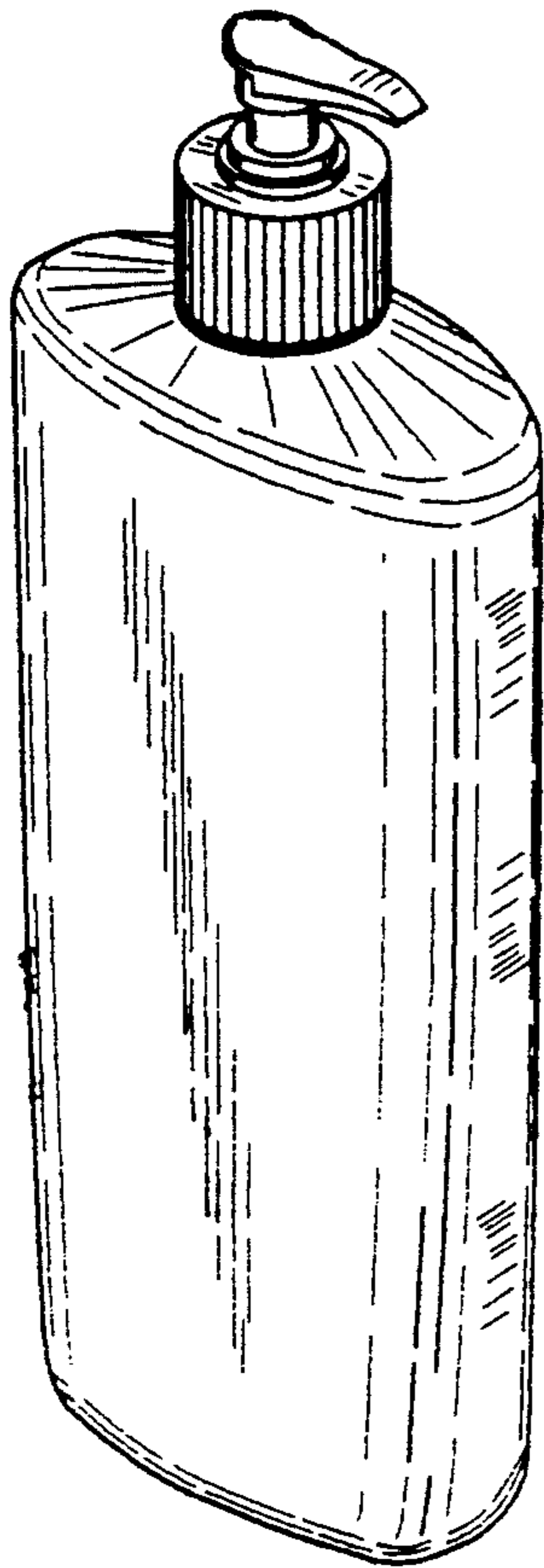

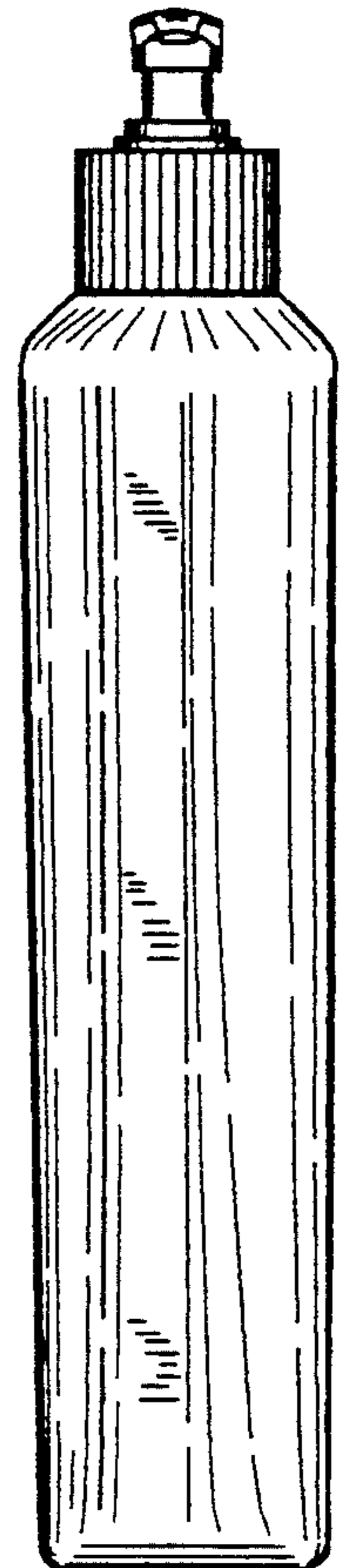

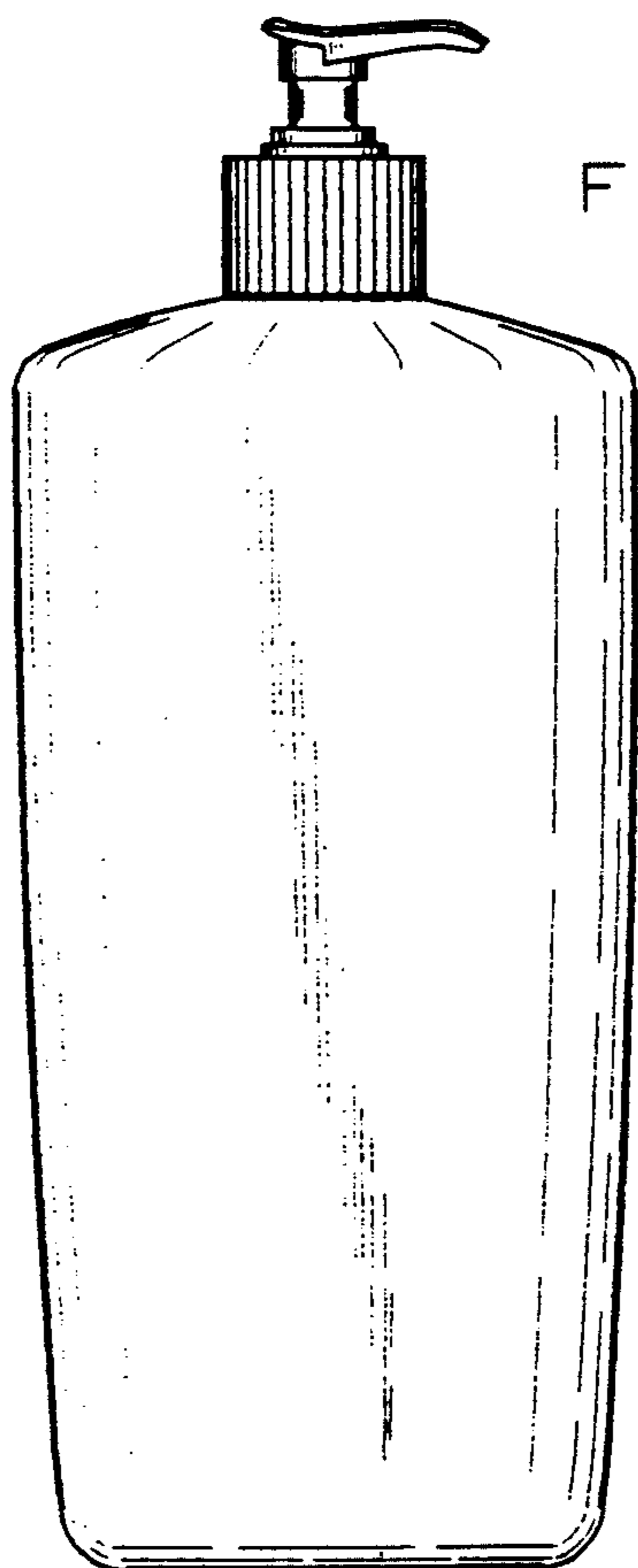

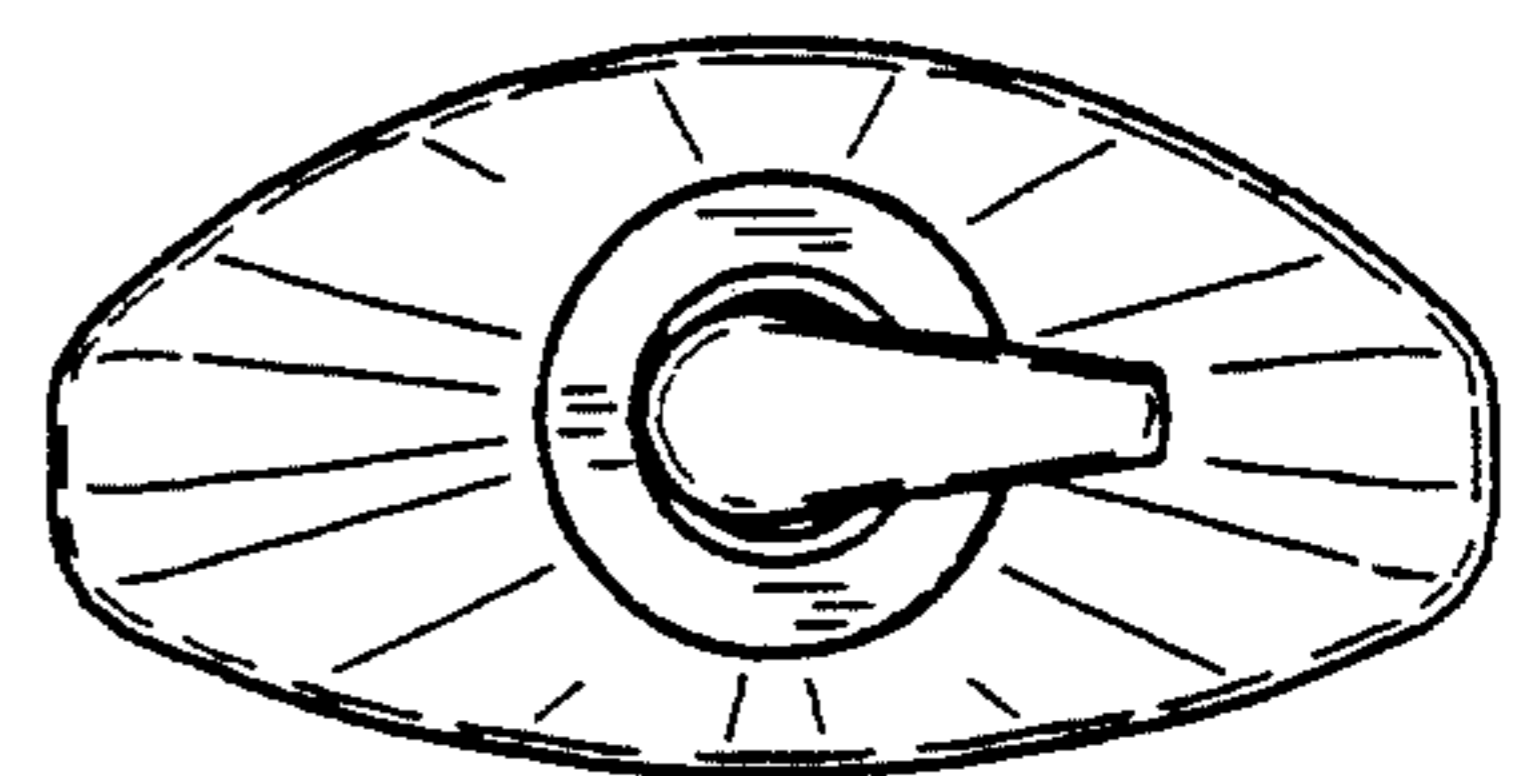

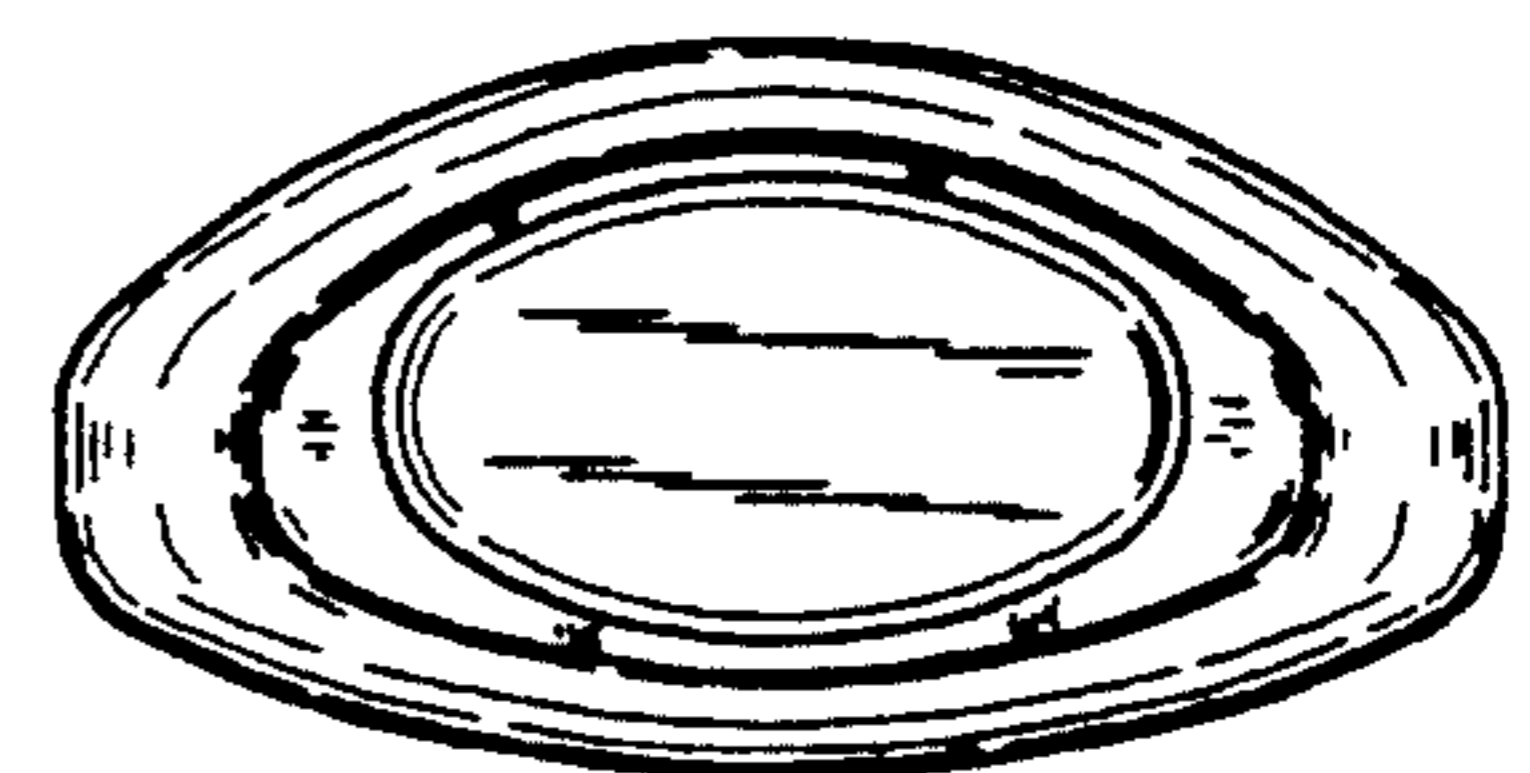
