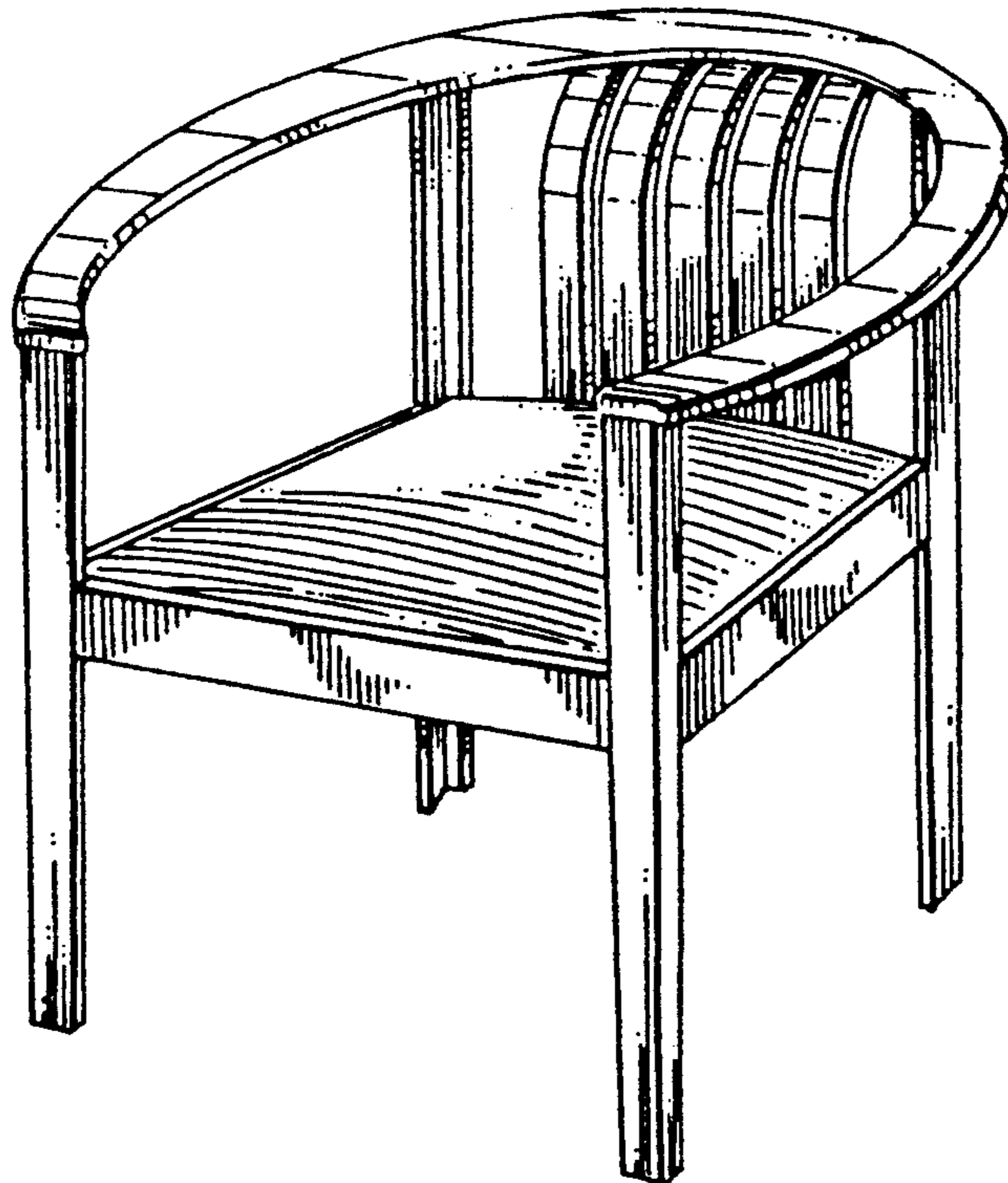

The ornamental design for a chair, as shown.

**DESCRIPTION**

FIG. 1 is a front elevational view of a chair, showing my new design;  
FIG. 2 is a back elevational view;  
FIG. 3 is a side elevational view;  
FIG. 4 is an elevational view, showing the side not shown in FIG. 3;  
FIG. 5 is a top plan view;  
FIG. 6 is a bottom plan view;  
FIG. 7 is a perspective view thereof;  
FIG. 8 is a perspective view of a chair showing a second embodiment of my new design;  
FIG. 9 is a perspective view of a chair showing a third embodiment of my new design; and,  
FIG. 10 is a perspective view of a chair showing a fourth embodiment of my new design.



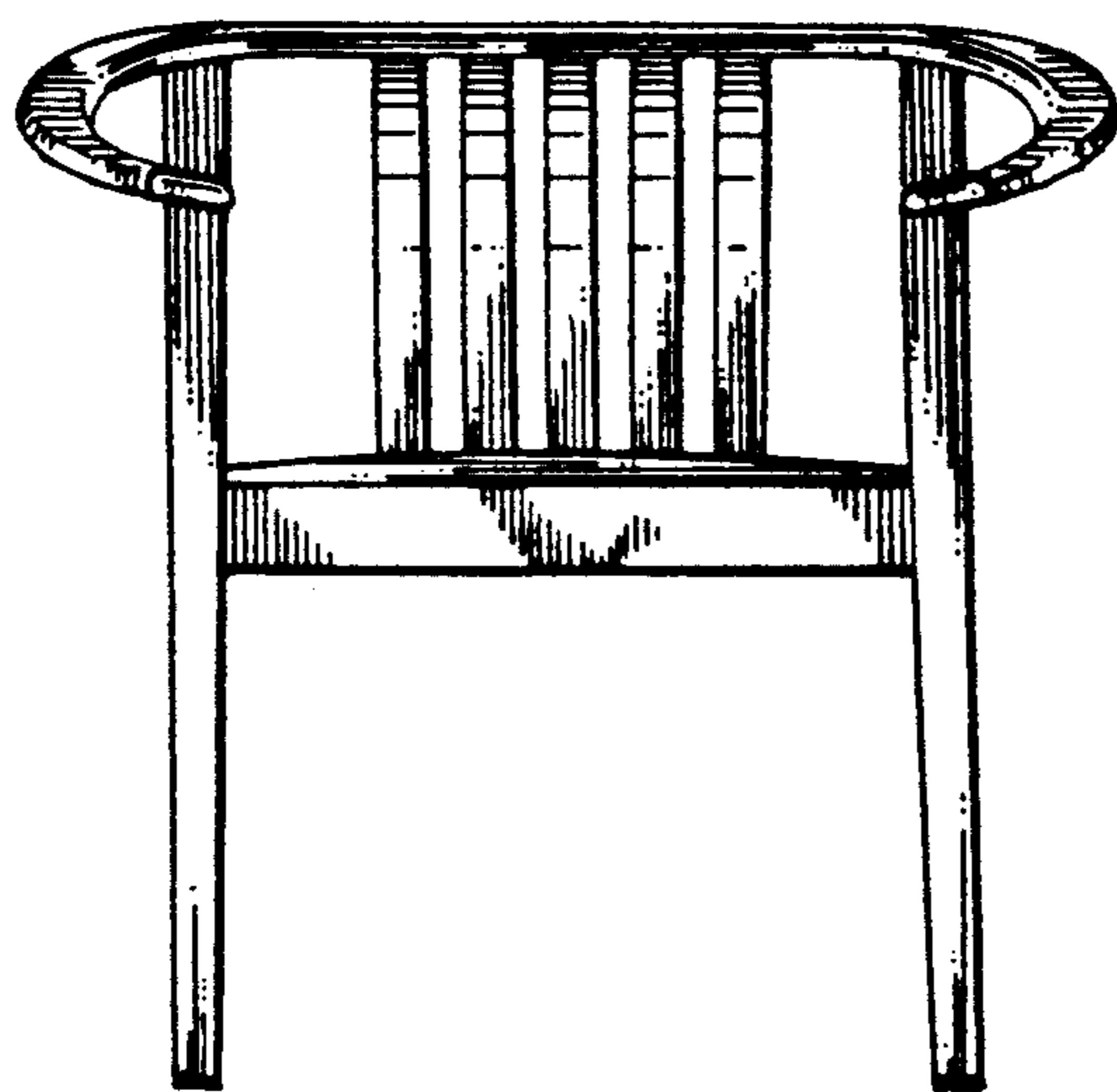

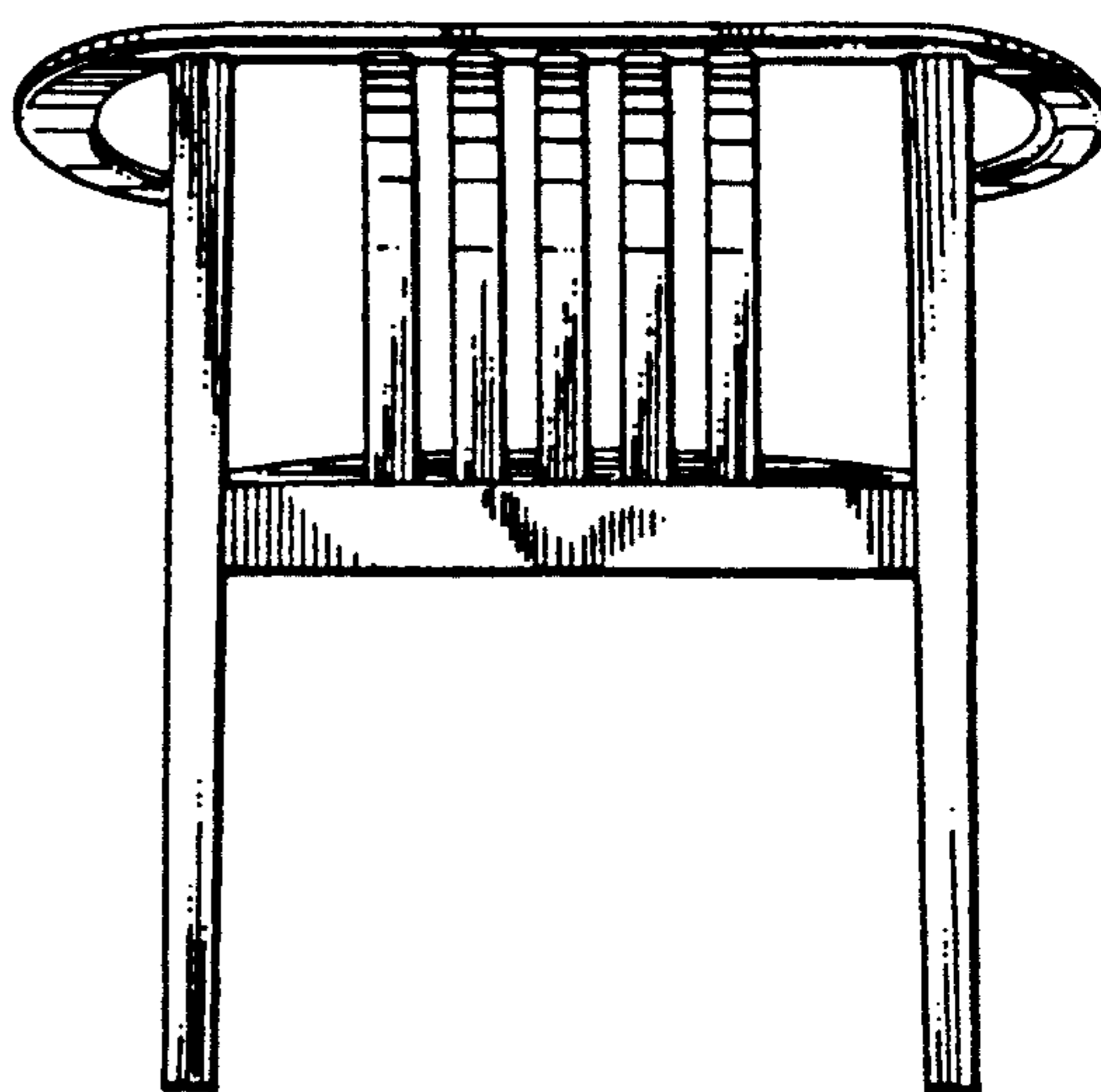

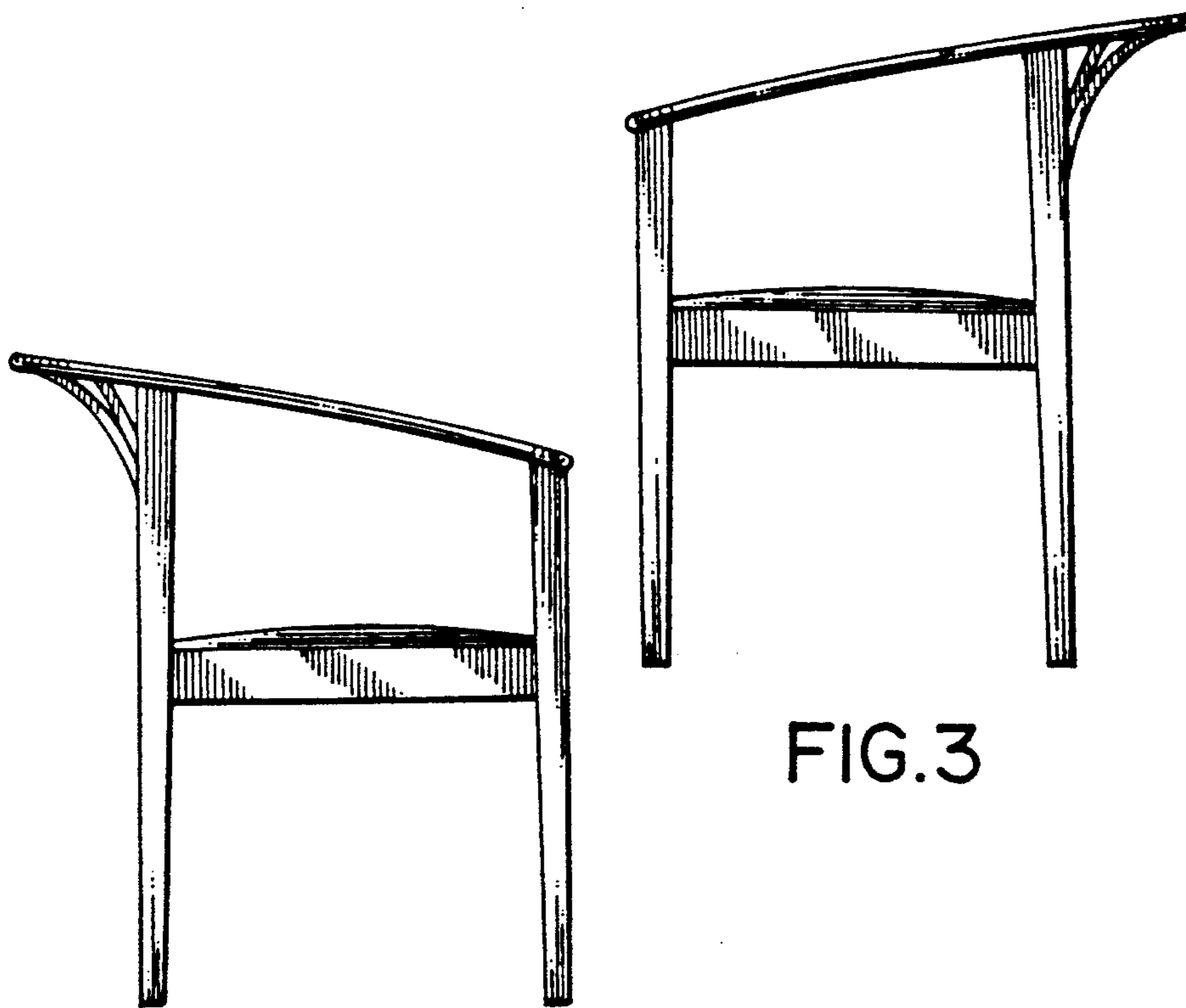

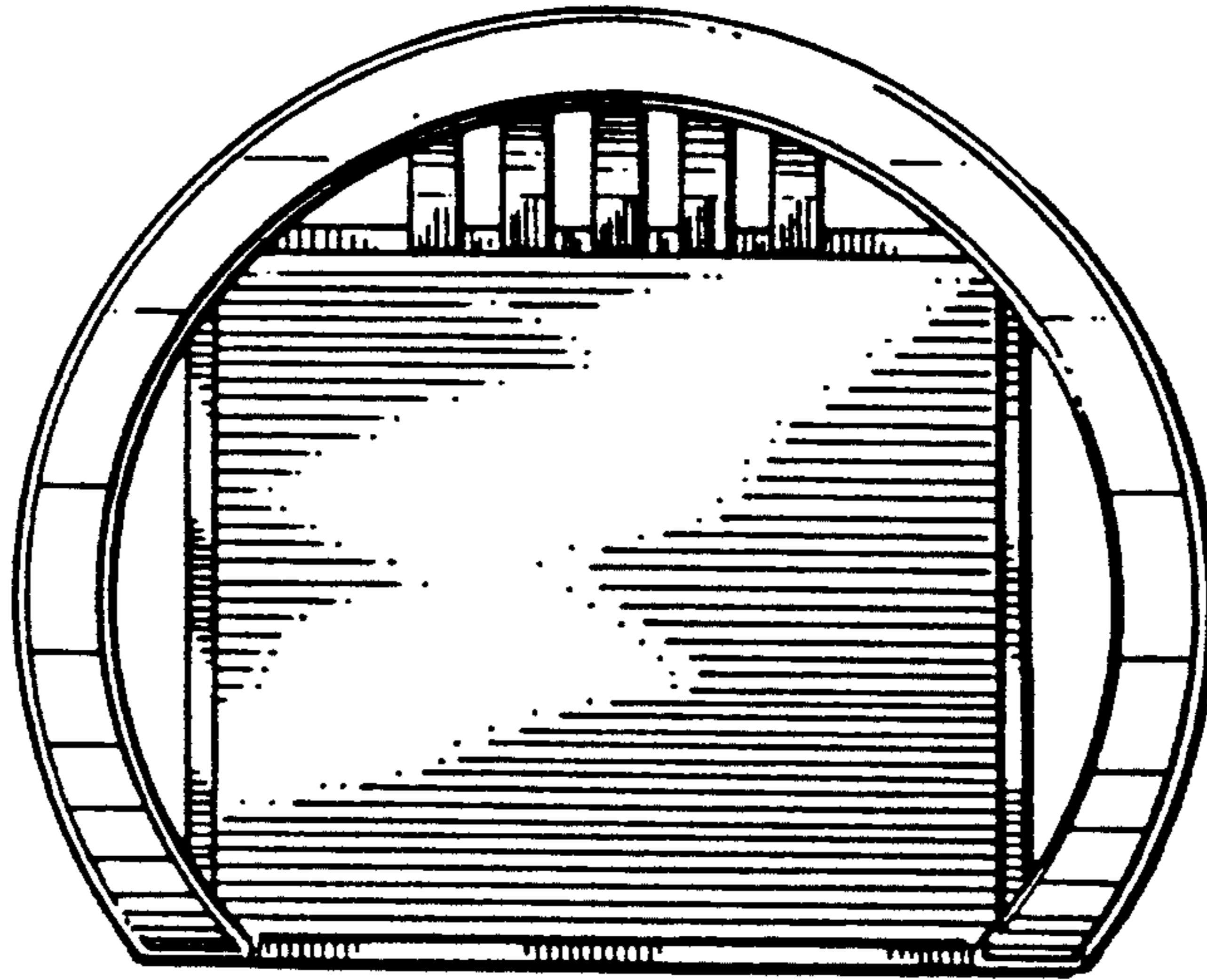

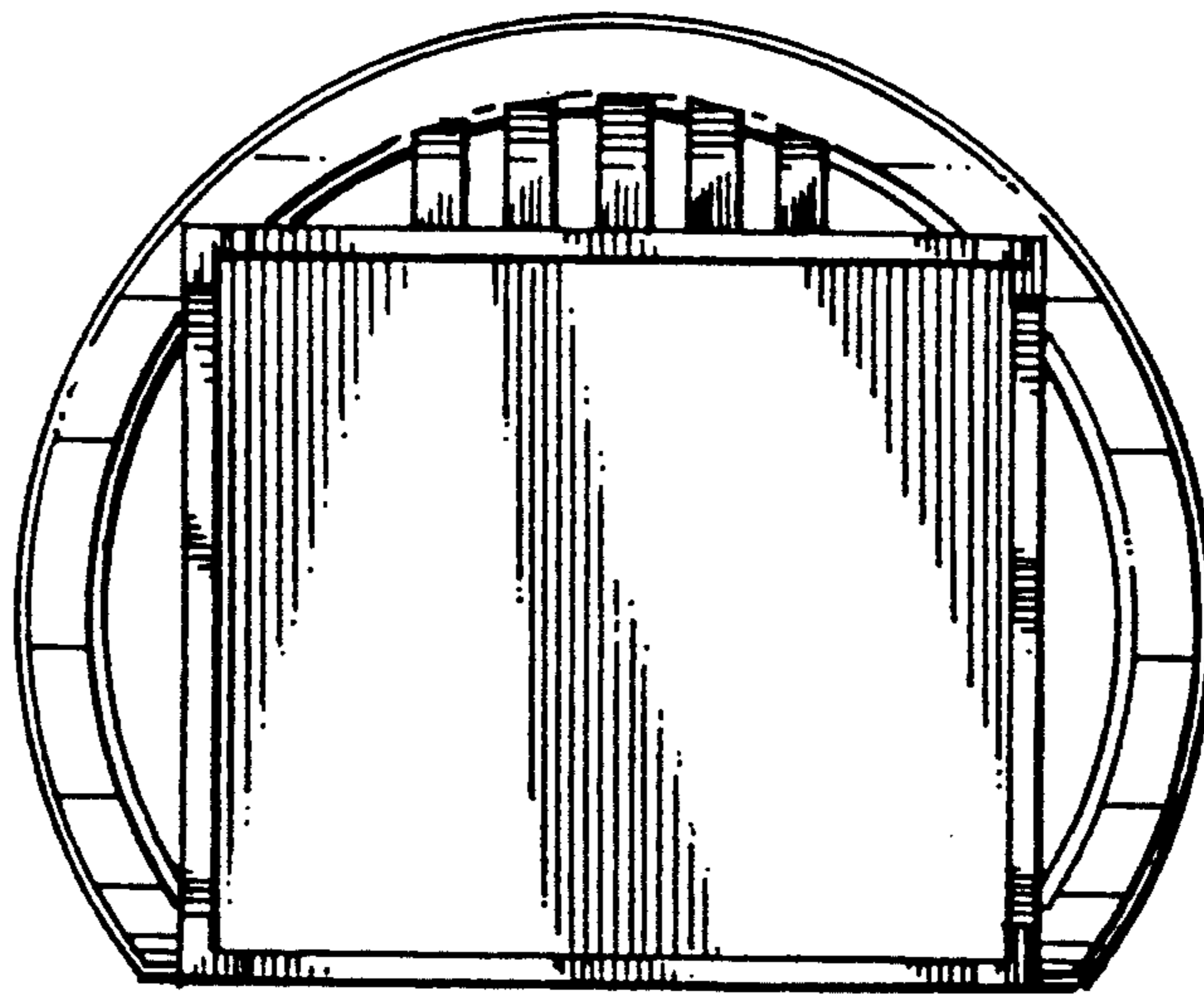

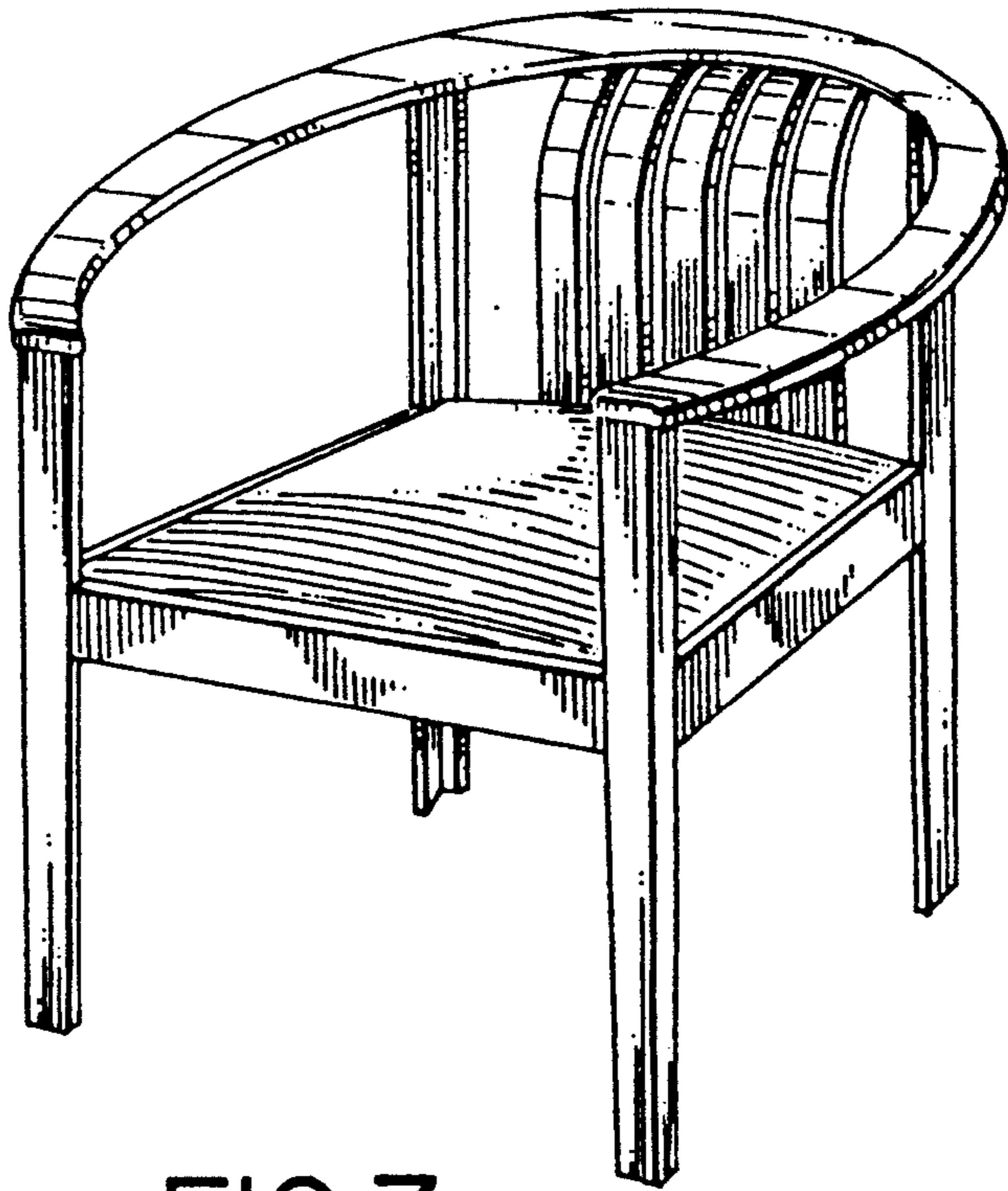

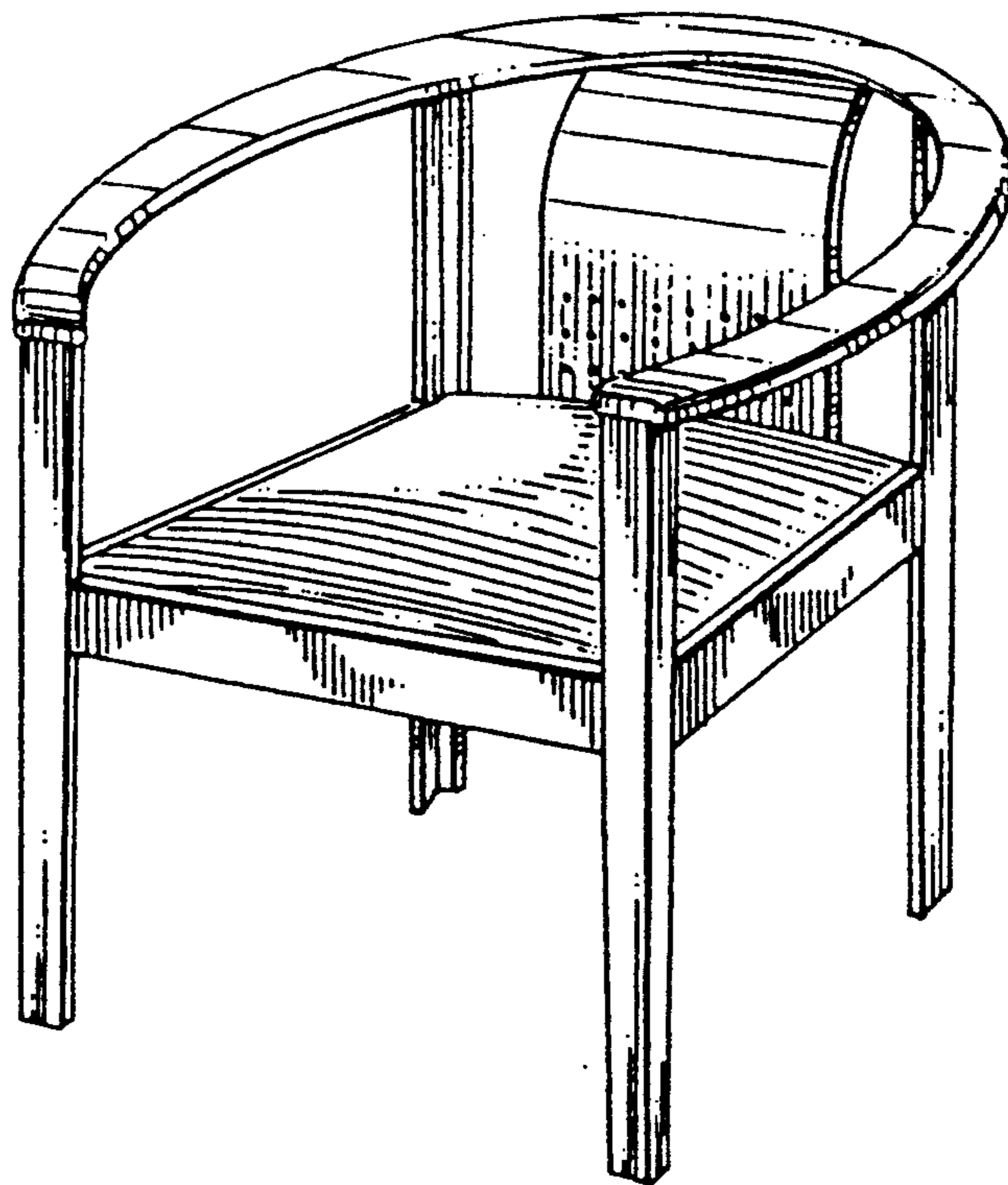

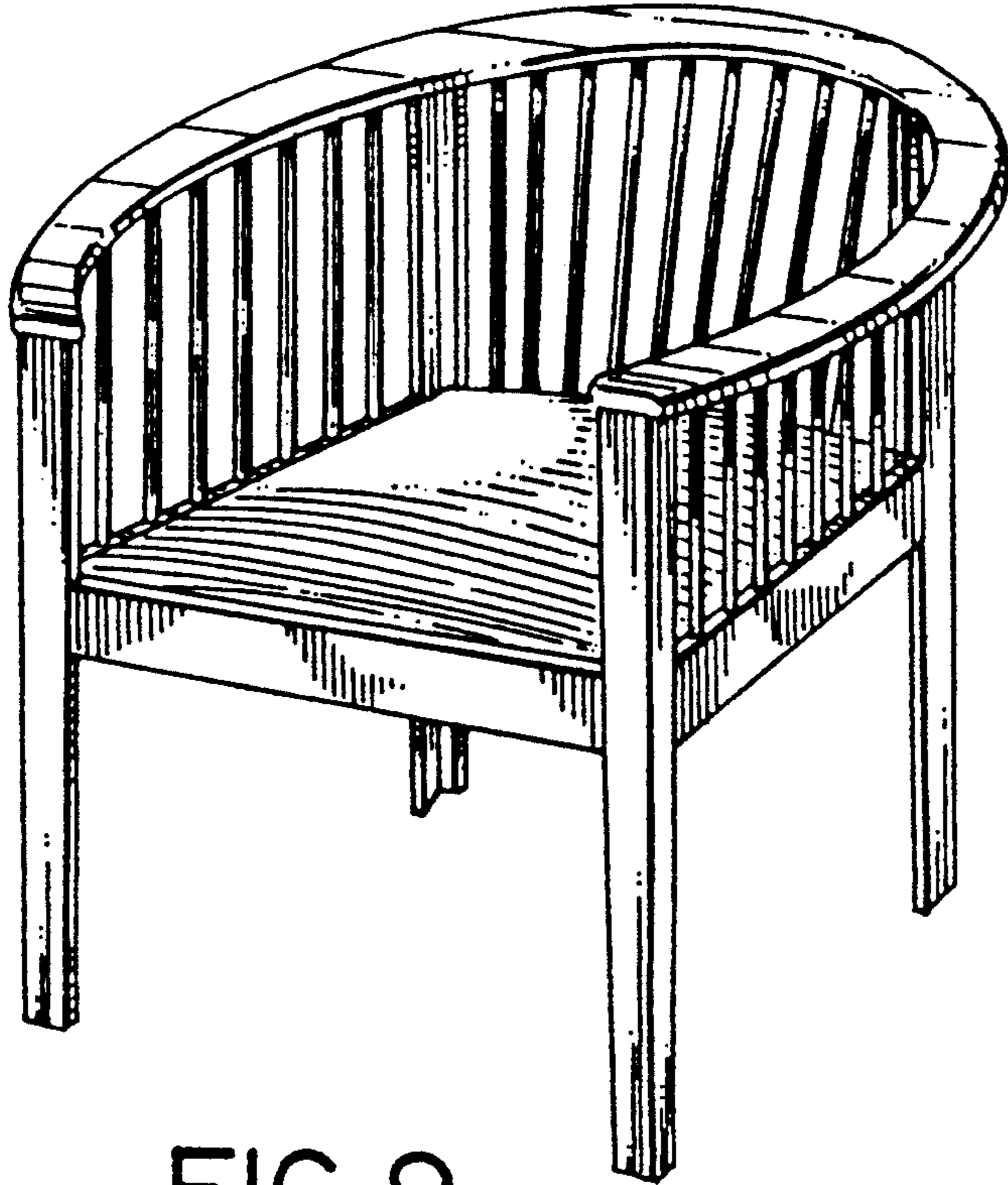

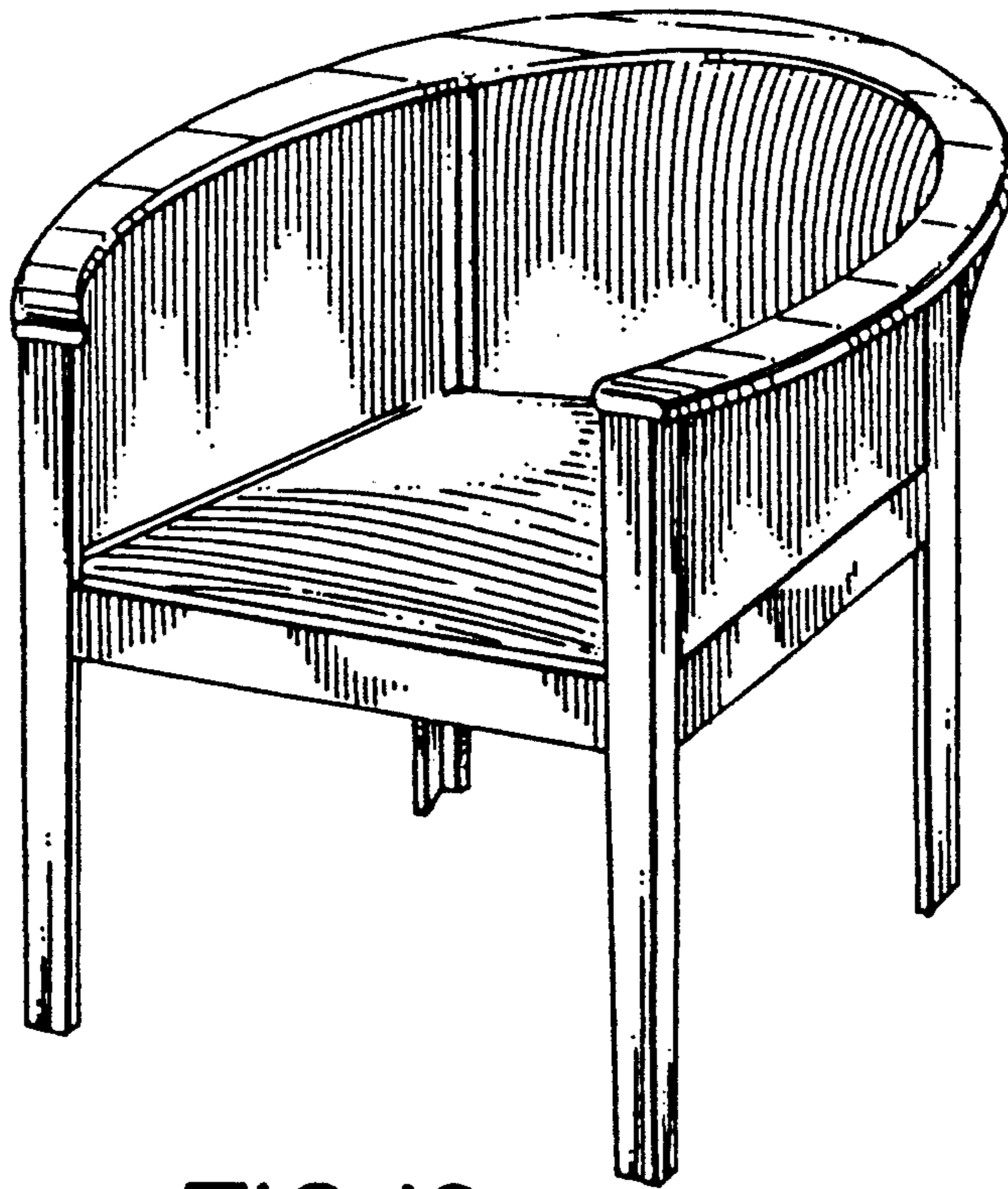
