The ornamental design for a tape dispenser, as shown and described.

DESCRIPTION

FIG. 1 is a front, right side perspective view of a tape dispenser showing my new design;
 FIG. 2 is a front elevational end view, the rear view being a mirror image thereof;
 FIG. 3 is a left side elevational view, the right side being a mirror image thereof;
 FIG. 4 is a bottom plan view thereof; and,
 FIG. 5 is a top plan view thereof.

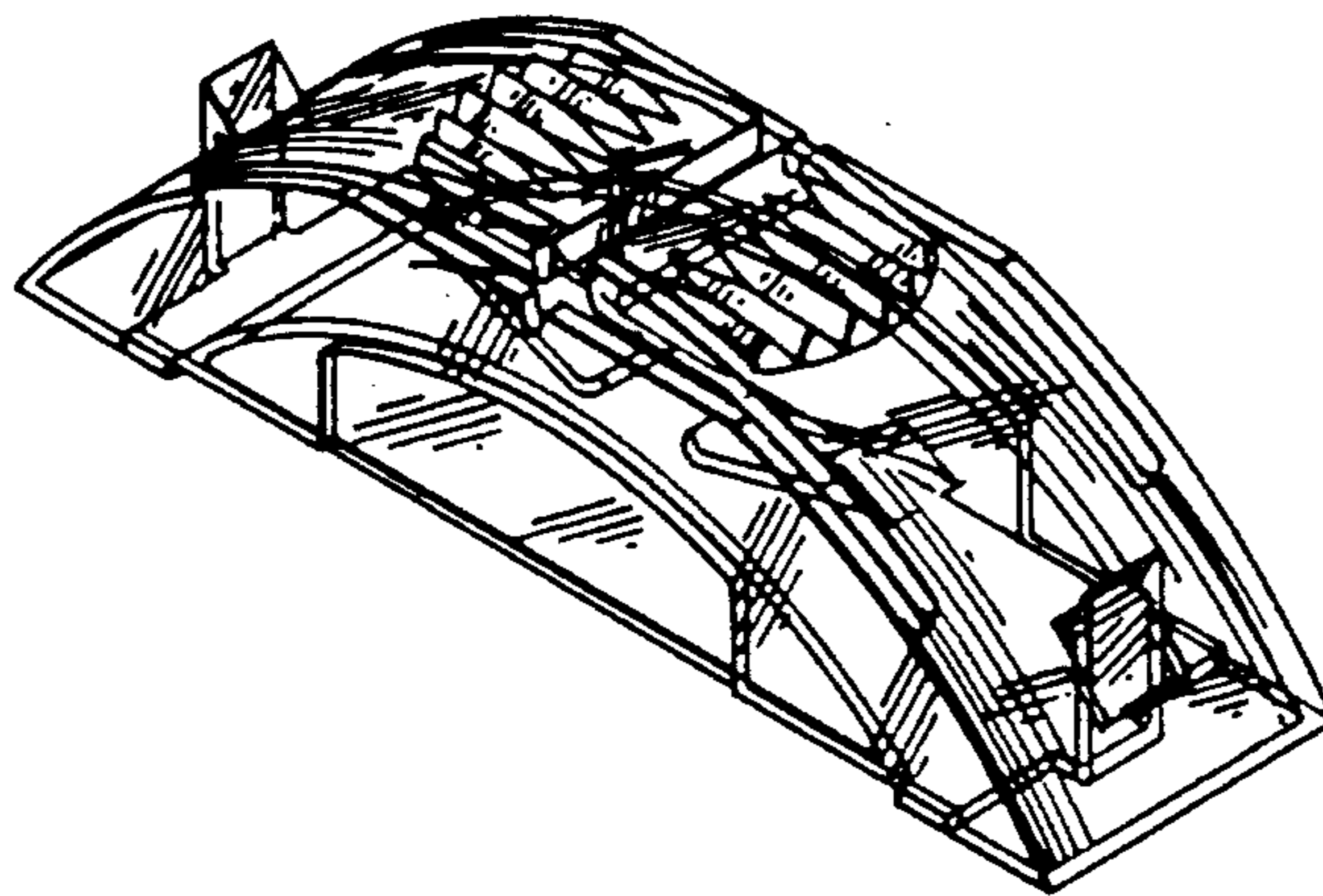

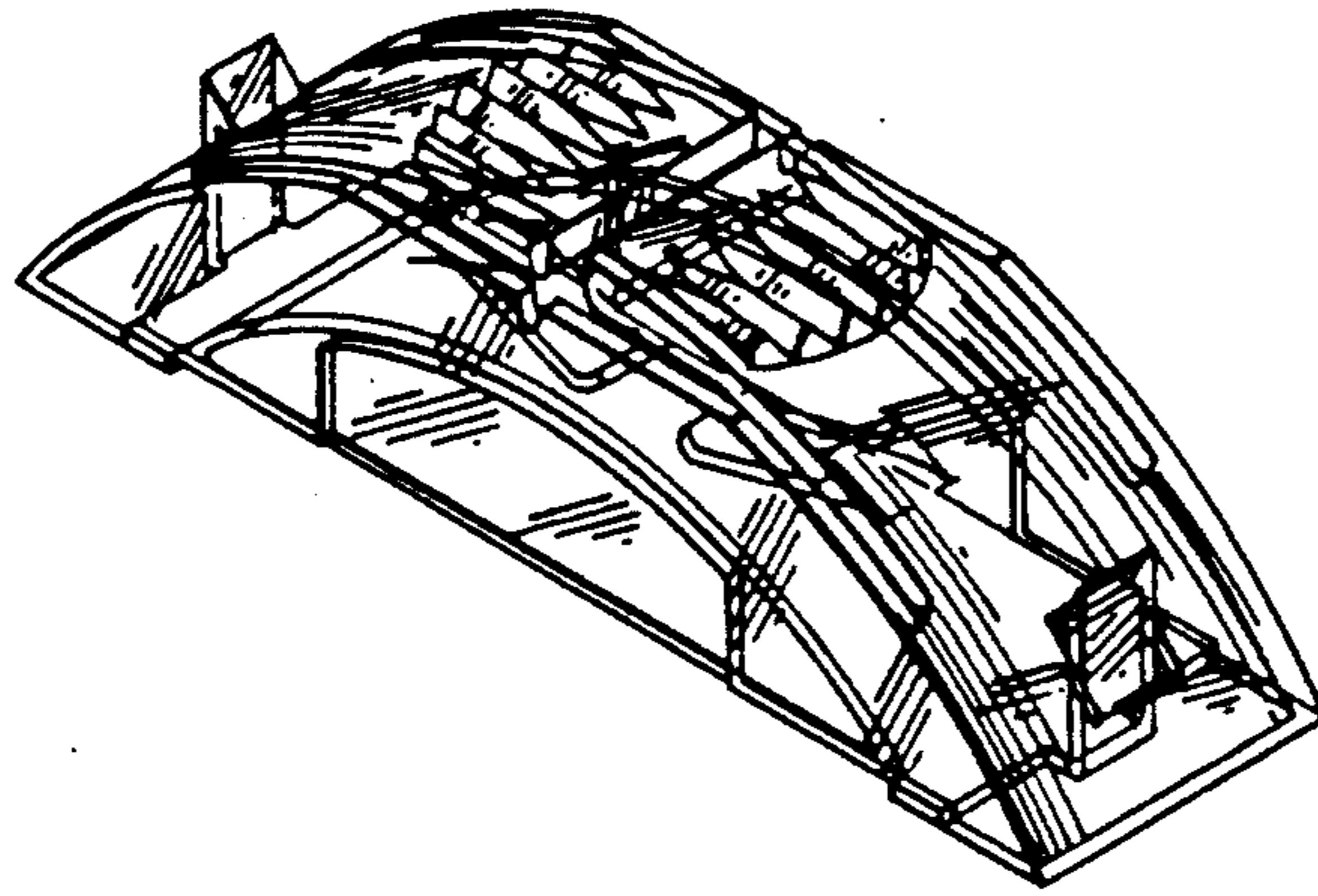

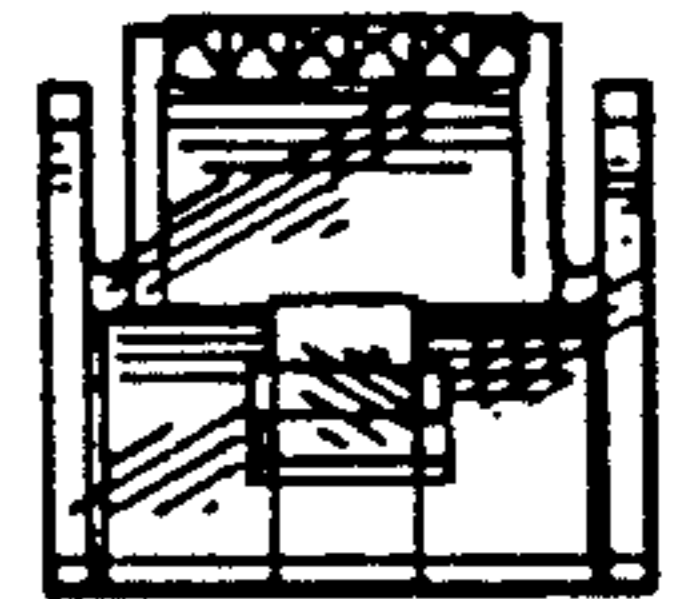

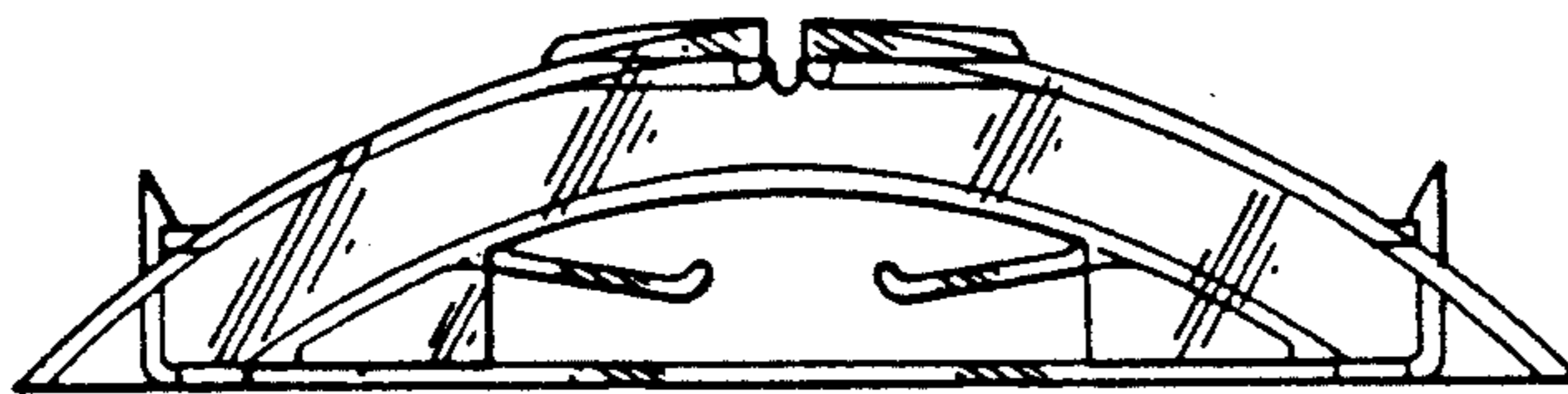

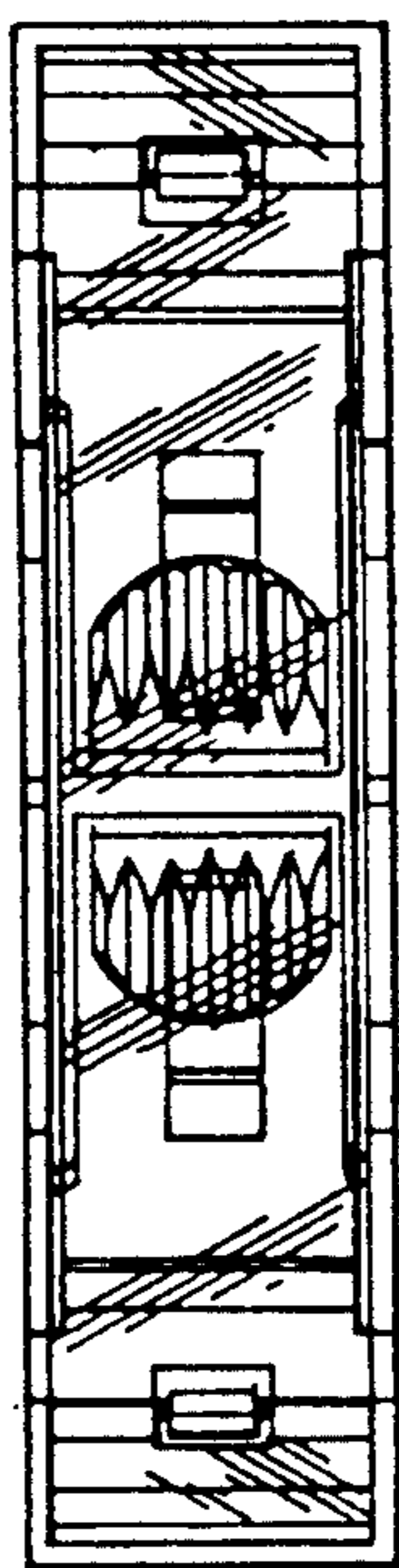
