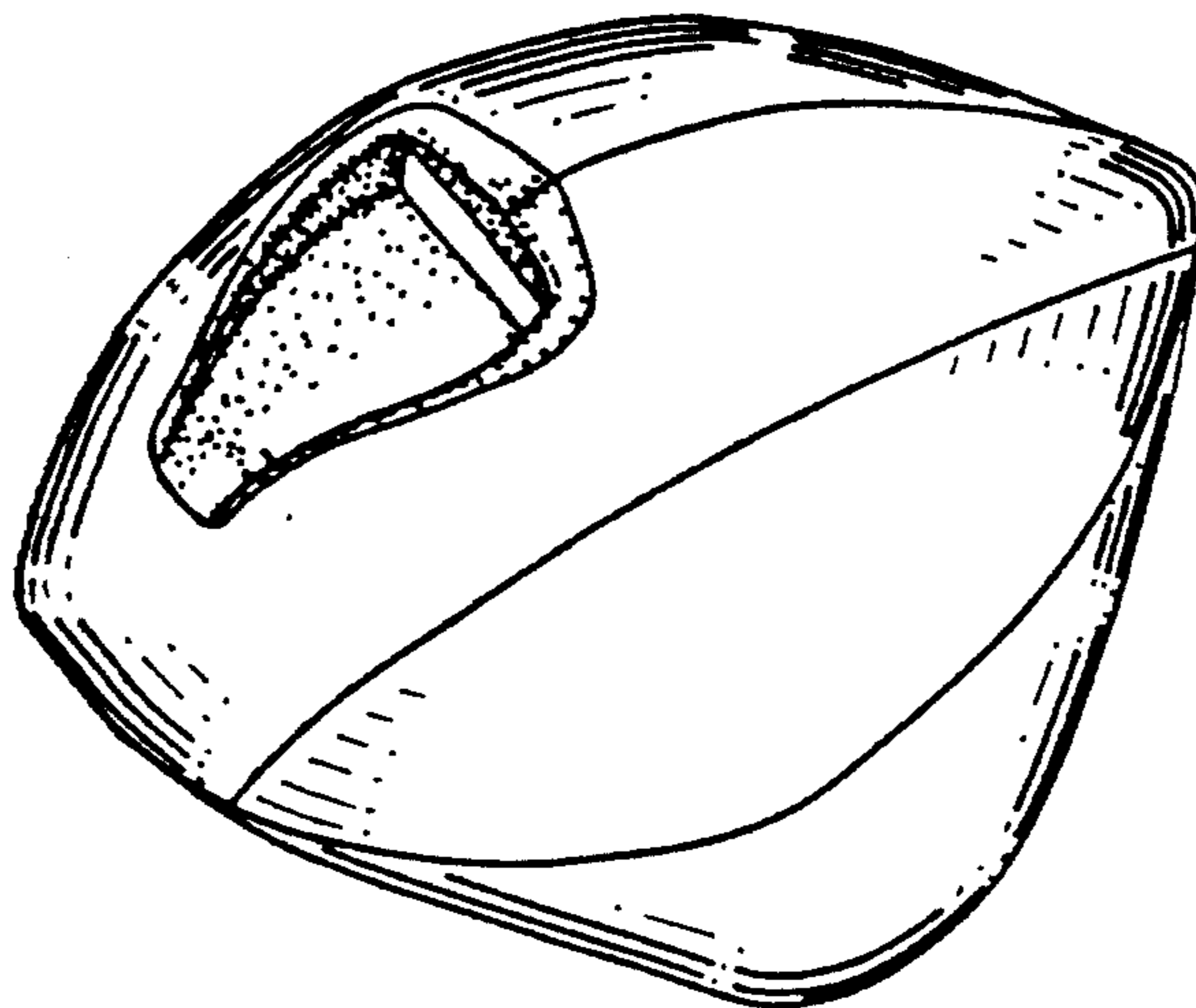

[57] **CLAIM**

The ornamental design for a covered cycling helmet, as shown and described.

DESCRIPTION

- FIG. 1 is a perspective view of a covered cycling helmet showing my new design;
- FIG. 2 is an enlarged top view thereof;
- FIG. 3 is an enlarged side view thereof, the opposite side being a mirror image;
- FIG. 4 is an enlarged rear view thereof;
- FIG. 5 is an enlarged front view thereof; and,
- FIG. 6 is an enlarged bottom view thereof.



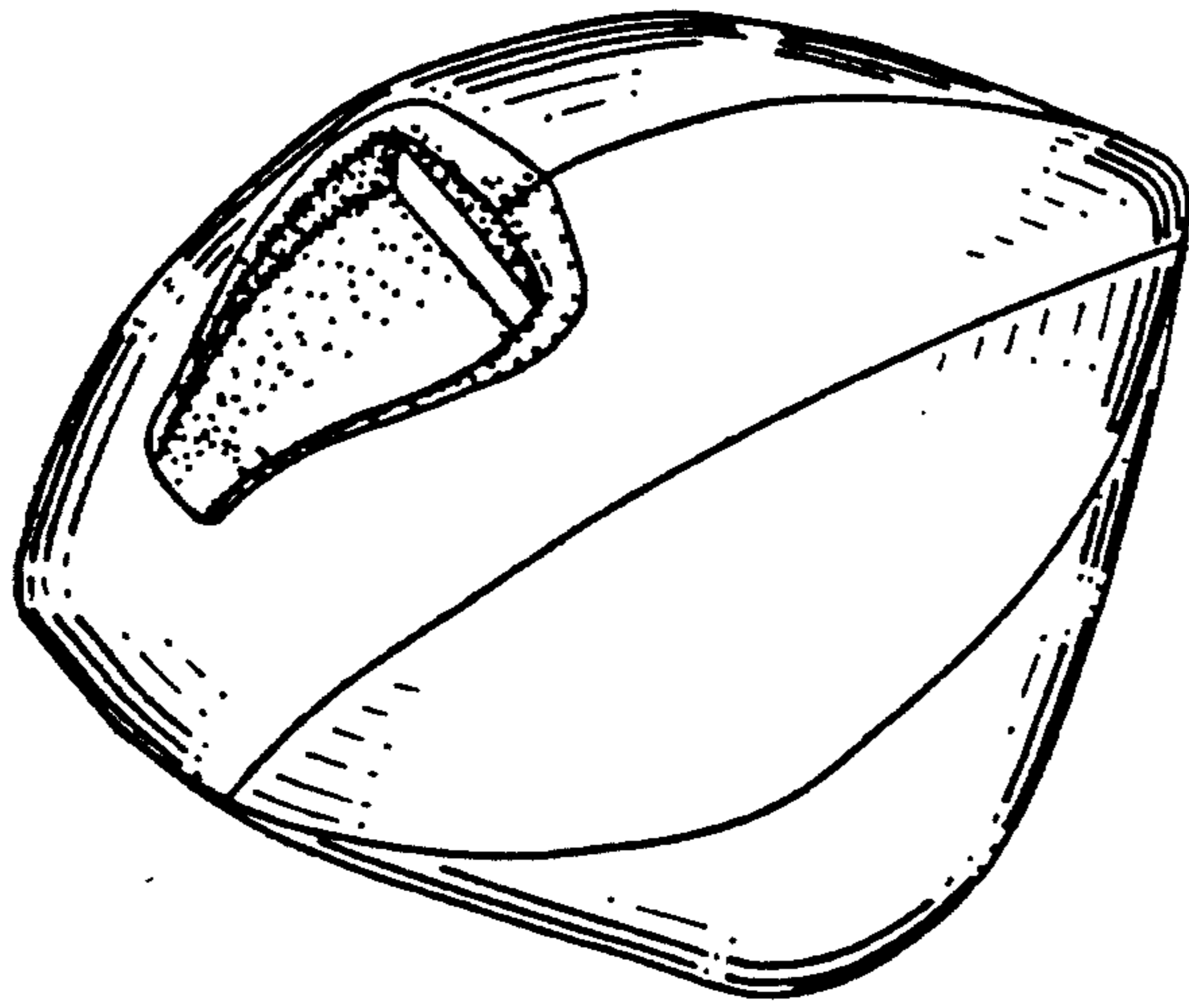

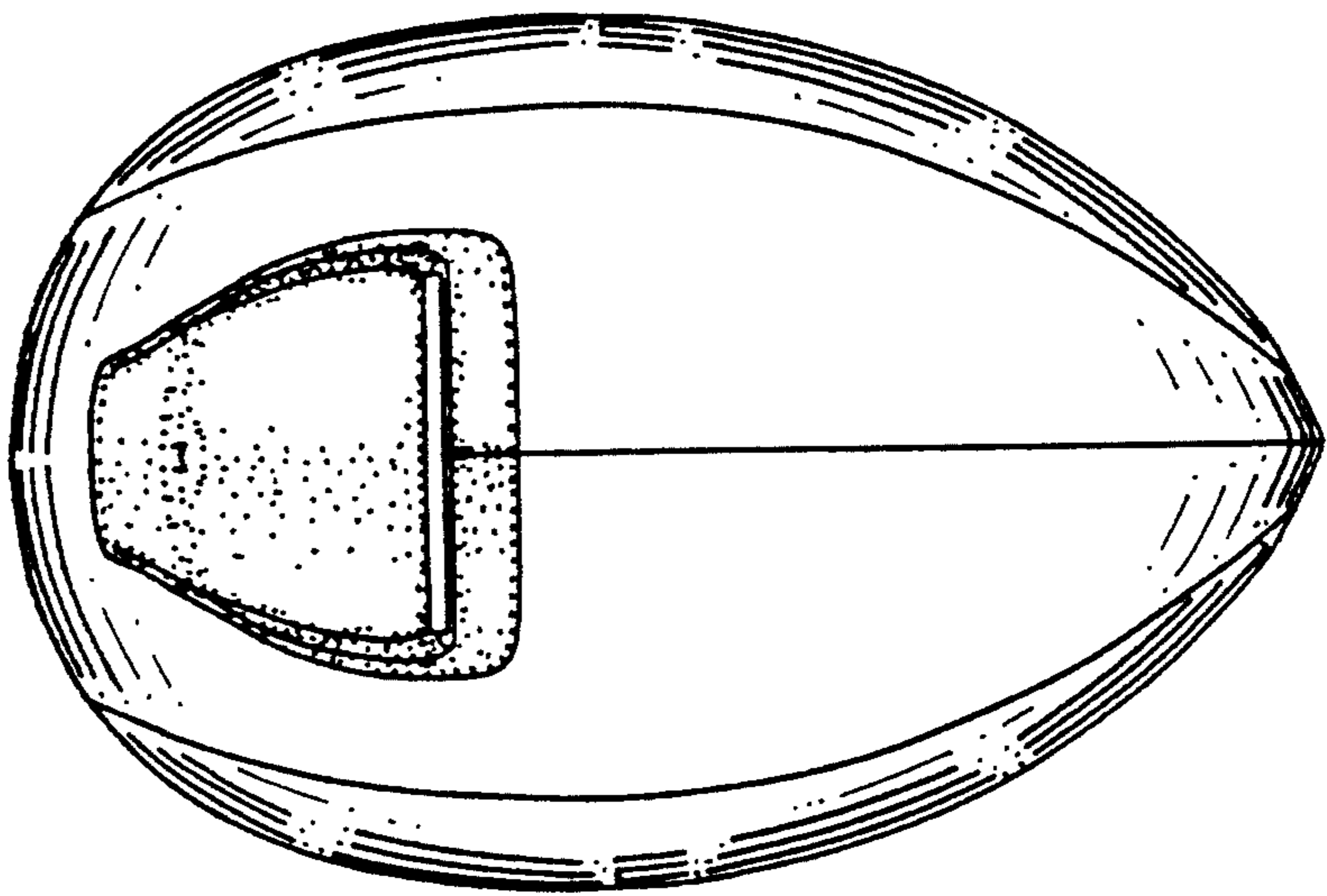

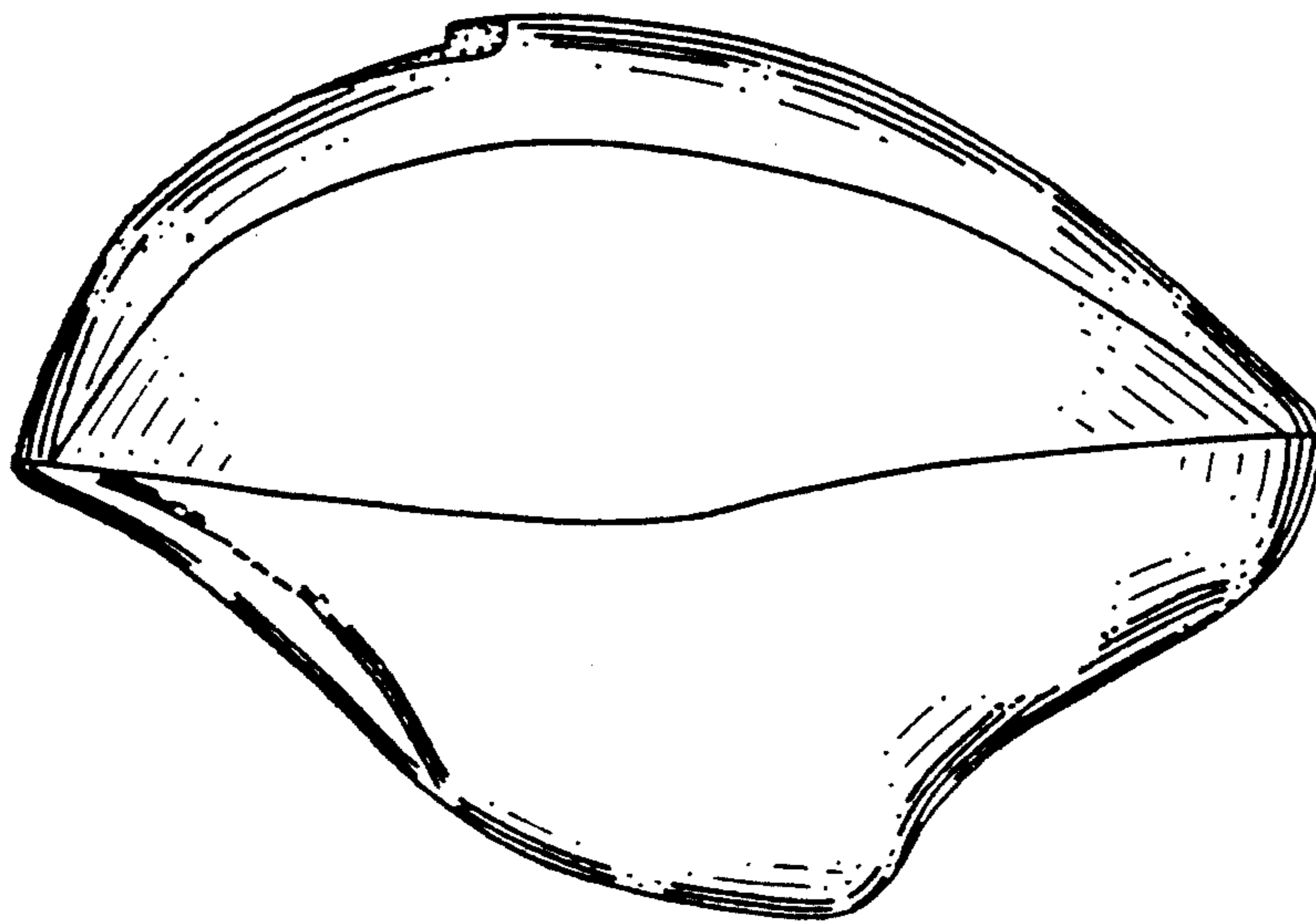

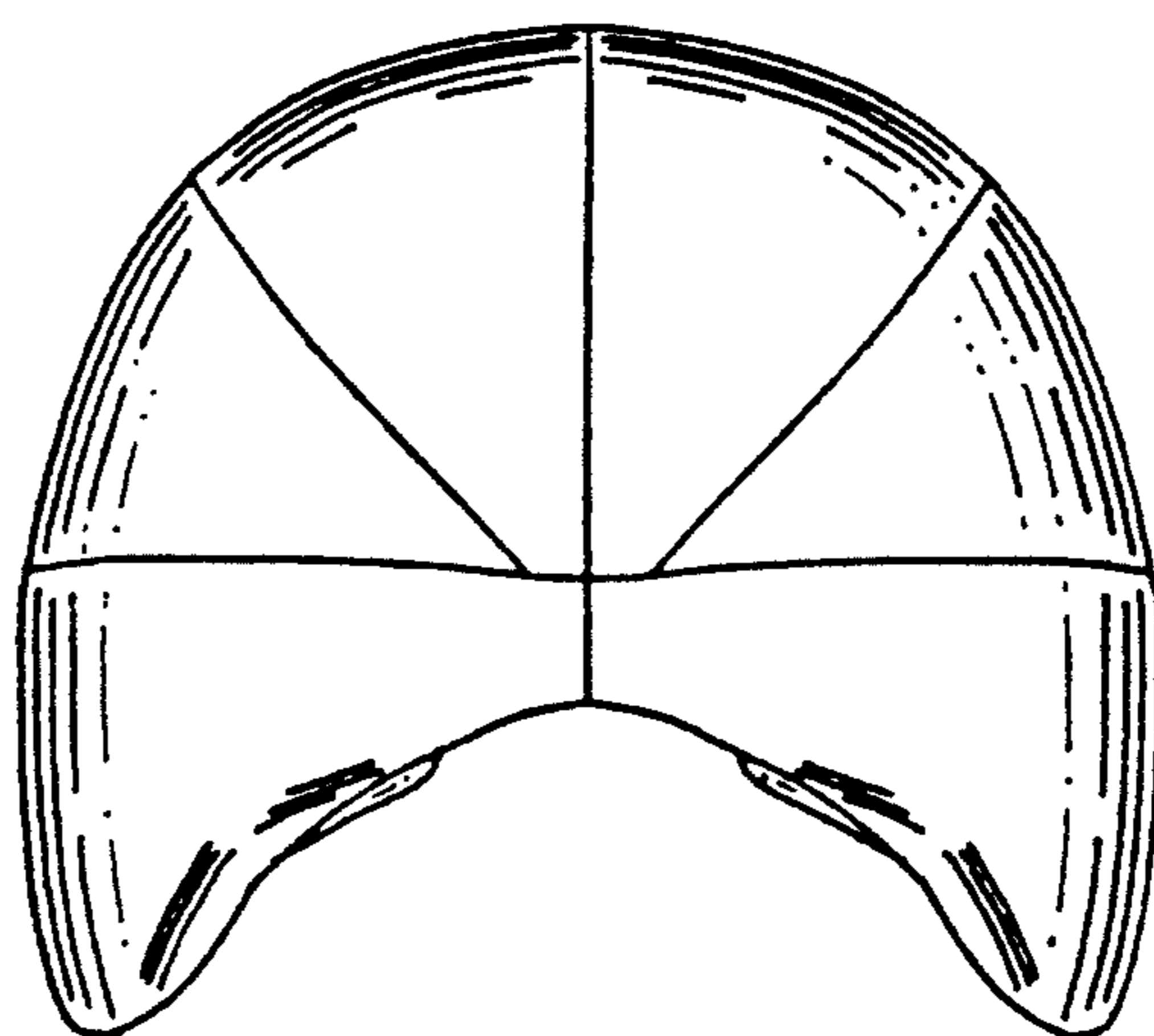

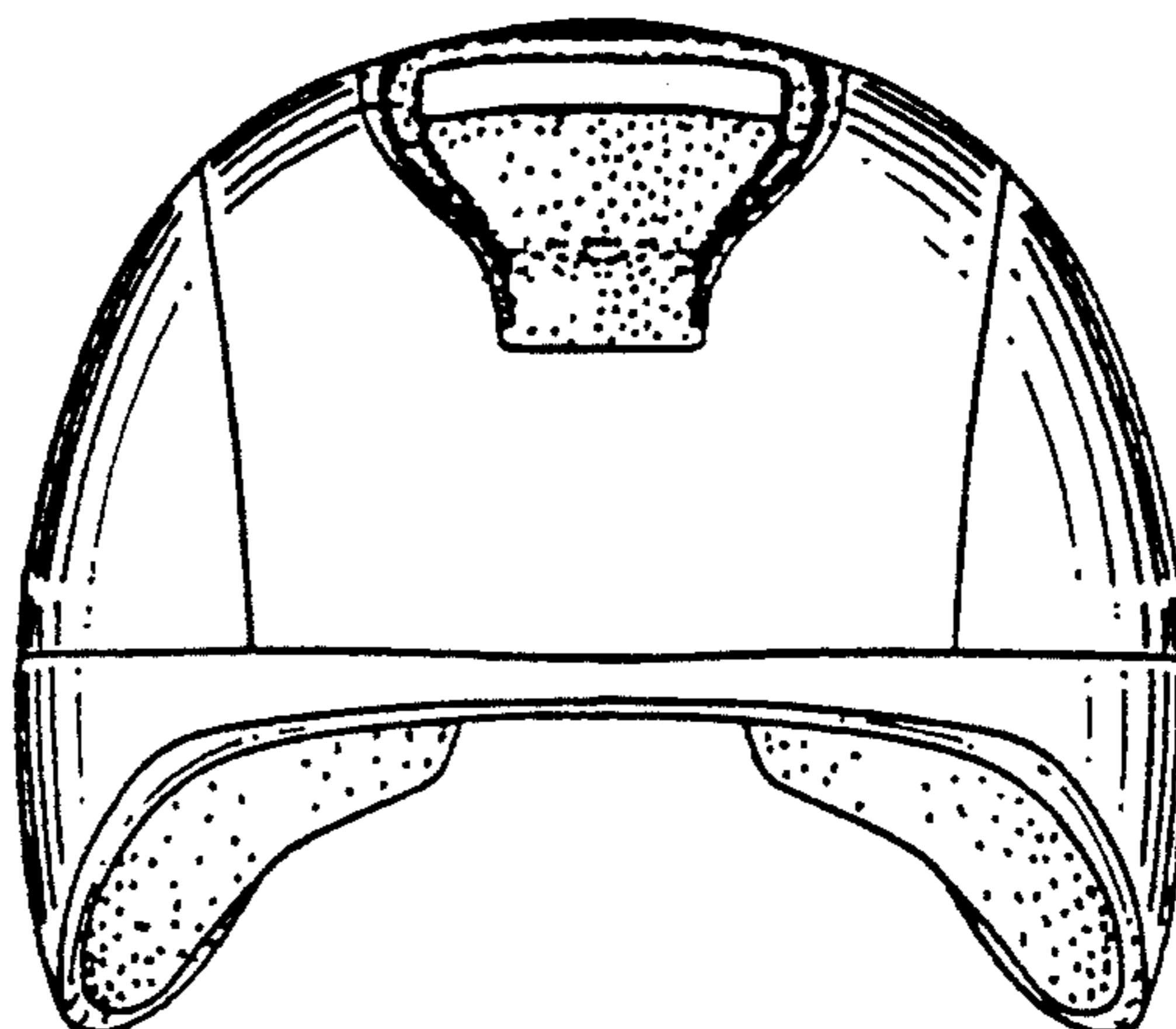

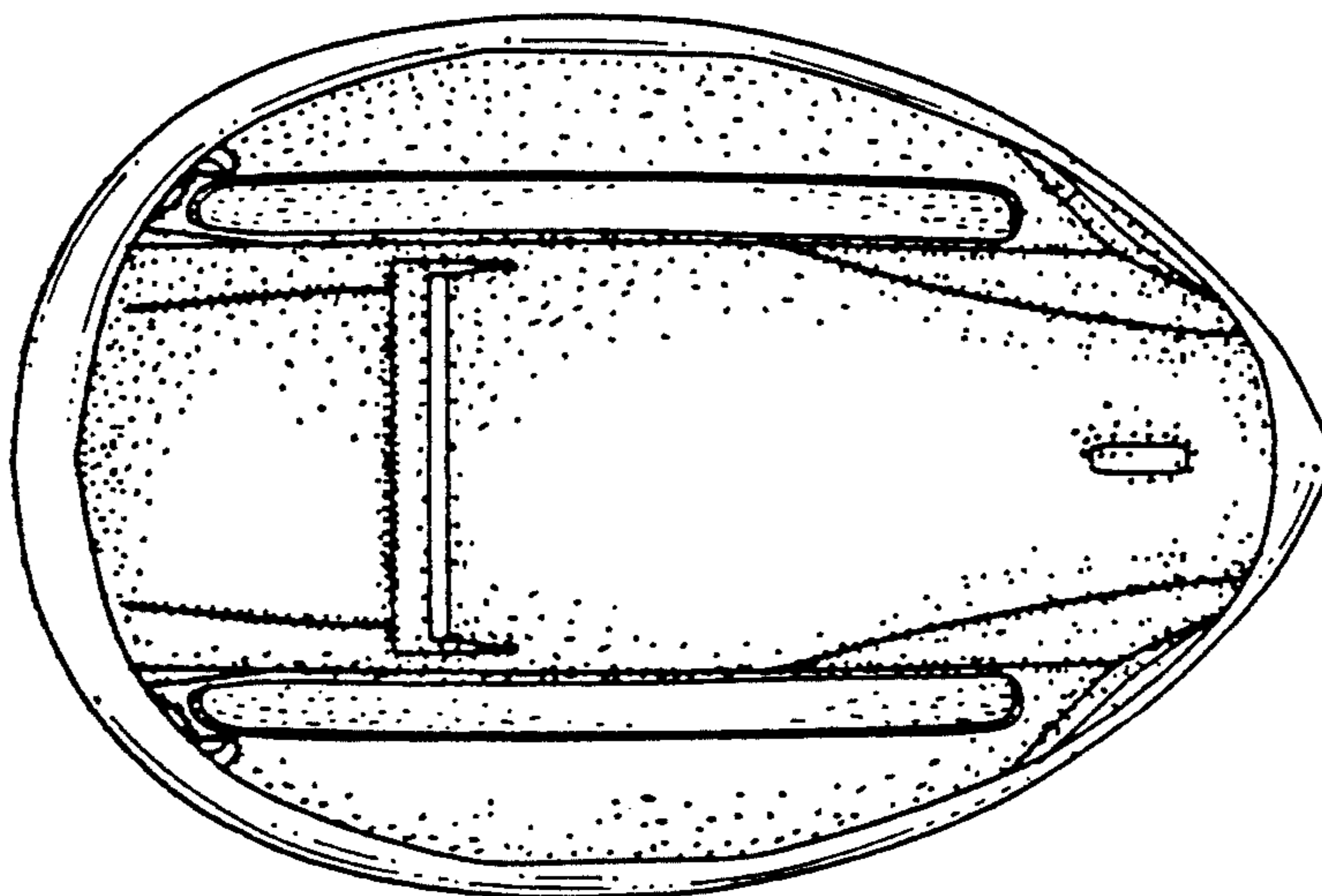
