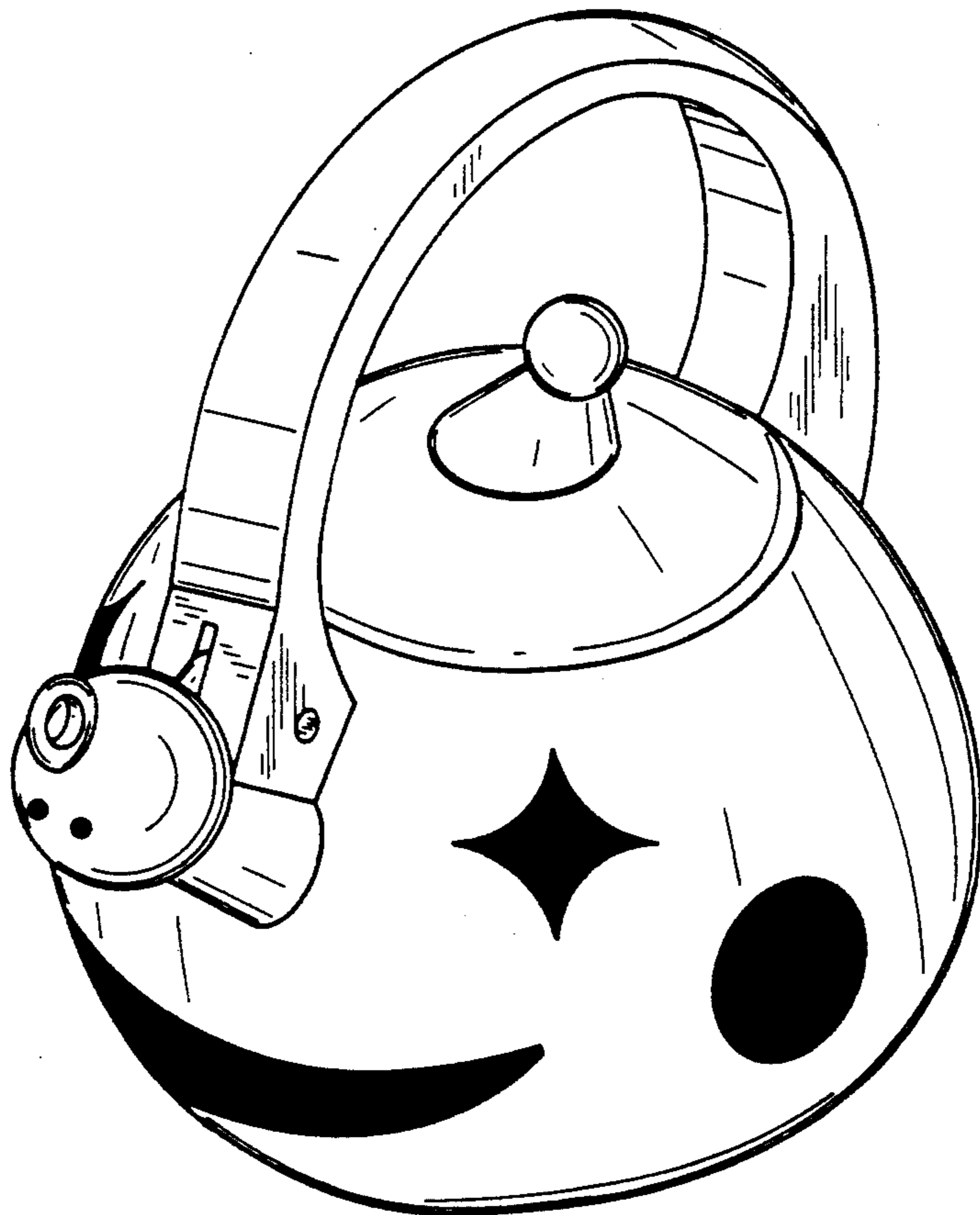

DESCRIPTION

FIG. 1 illustrates the top perspective view of a teapot embodying the present invention;
 FIG. 2 is a right hand side view of the preferred embodiment according to the present invention;
 FIG. 3 is a left hand side view of the preferred embodiment according to the present invention;
 FIG. 4 is a front view of the preferred embodiment according to the present invention;

 FIG. 7 is a bottom view of the preferred embodiment according to the present invention.



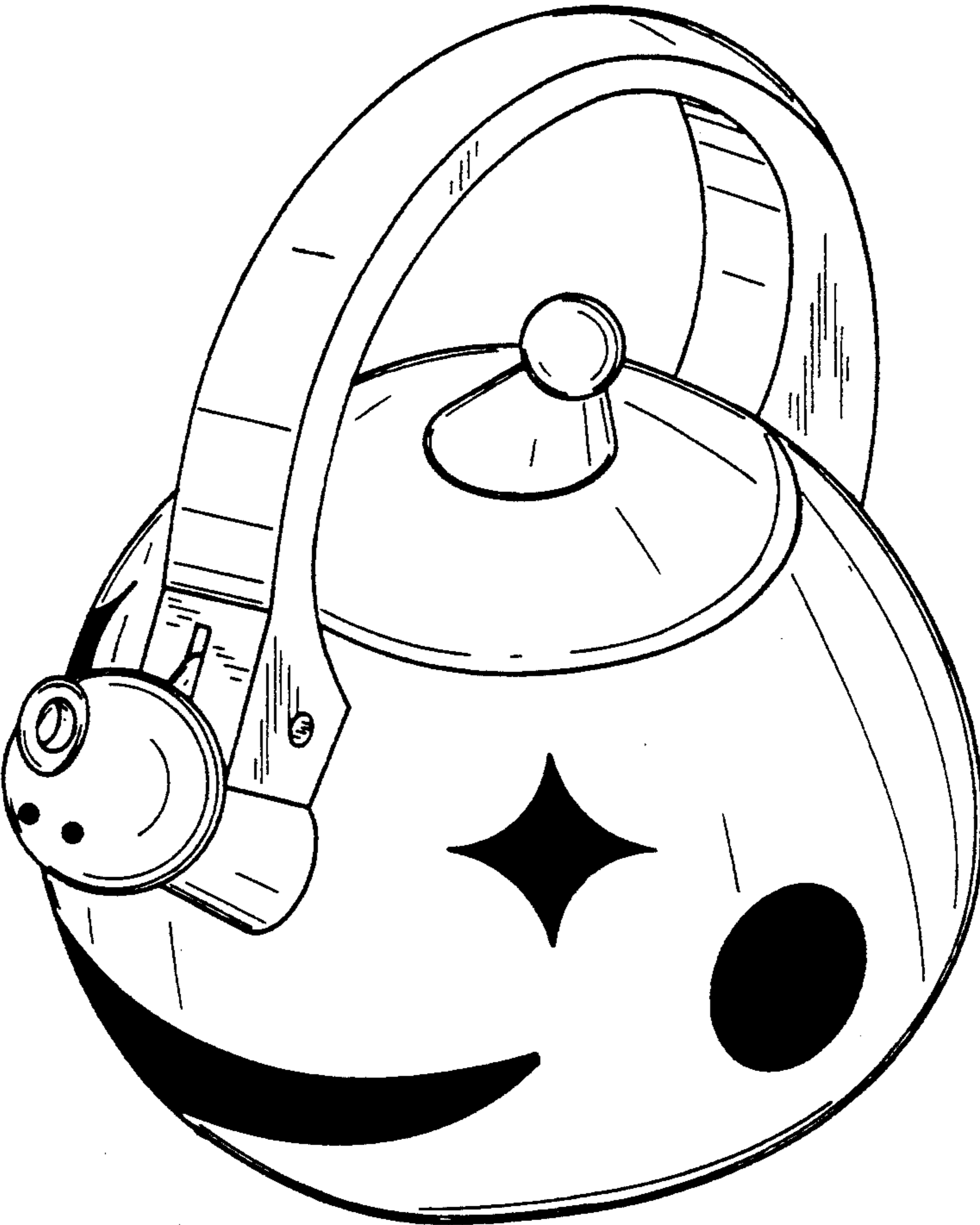

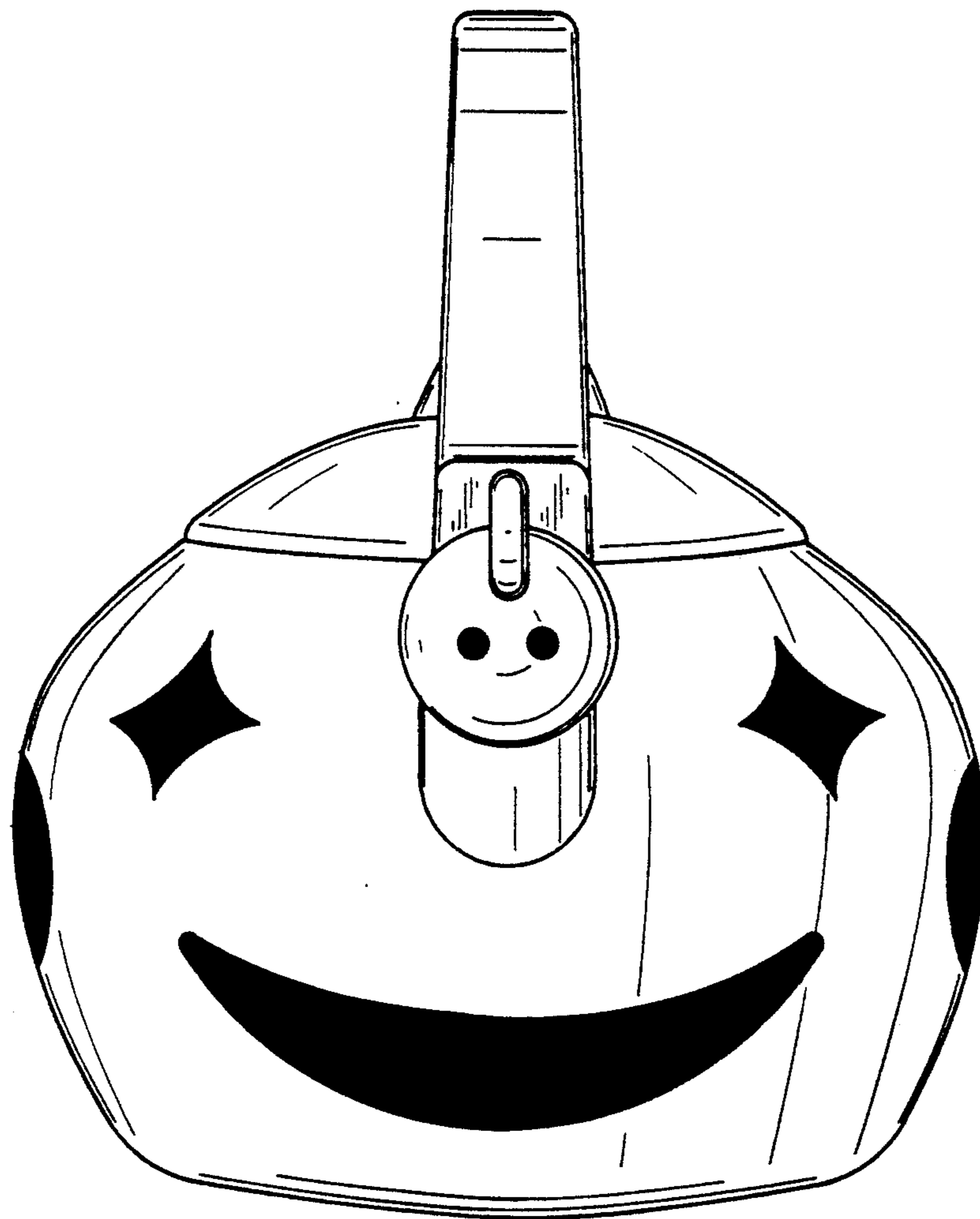

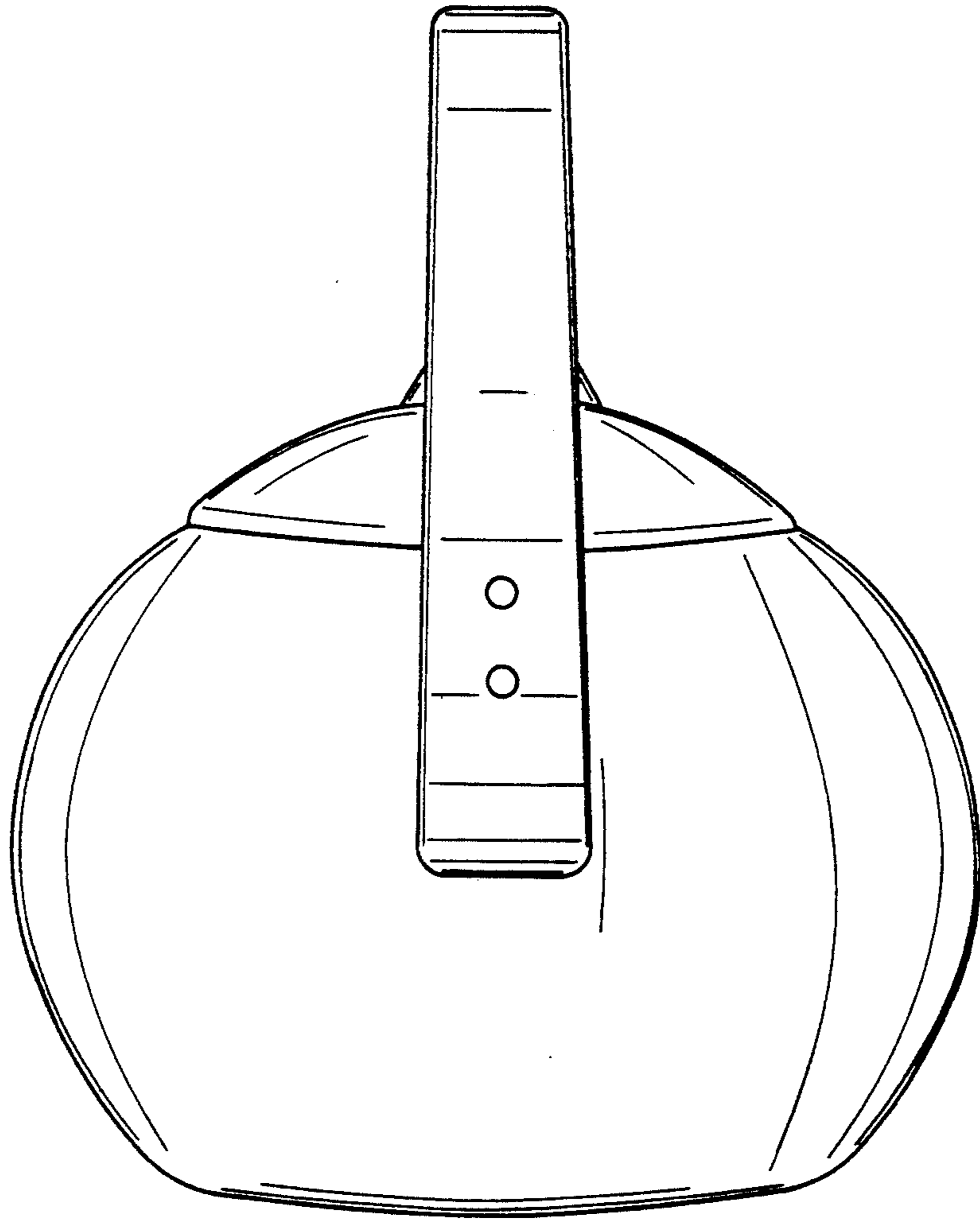

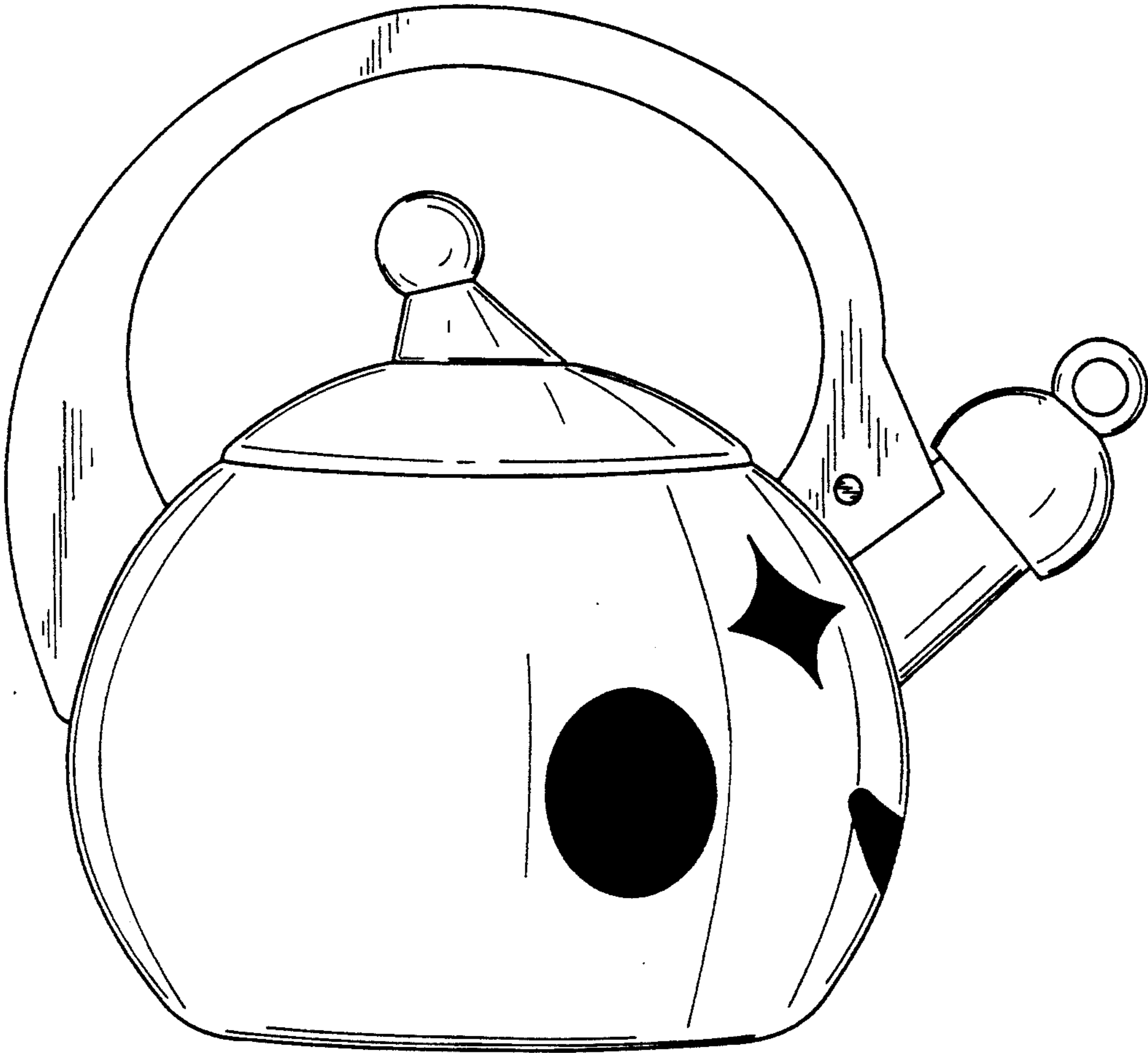

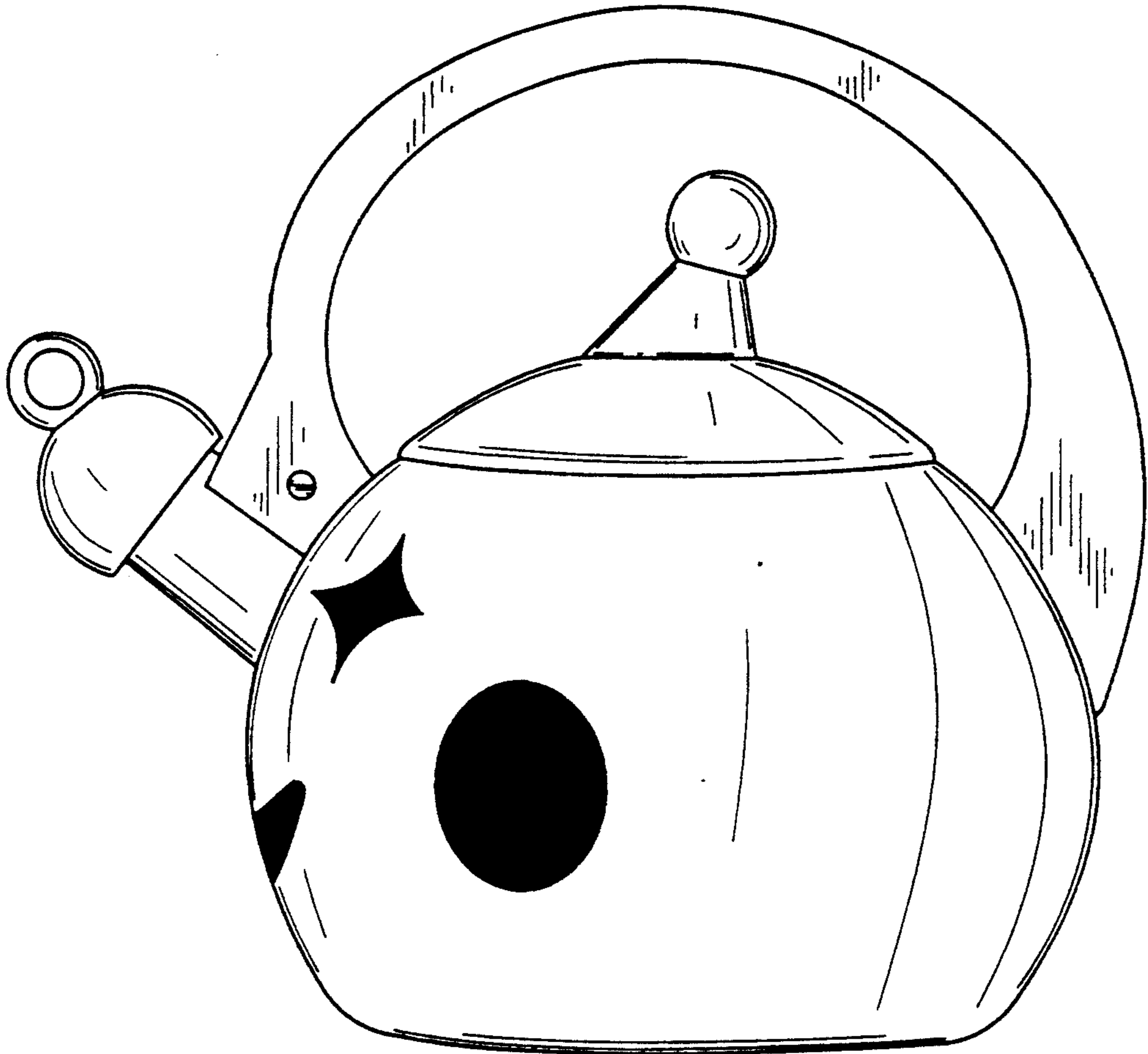

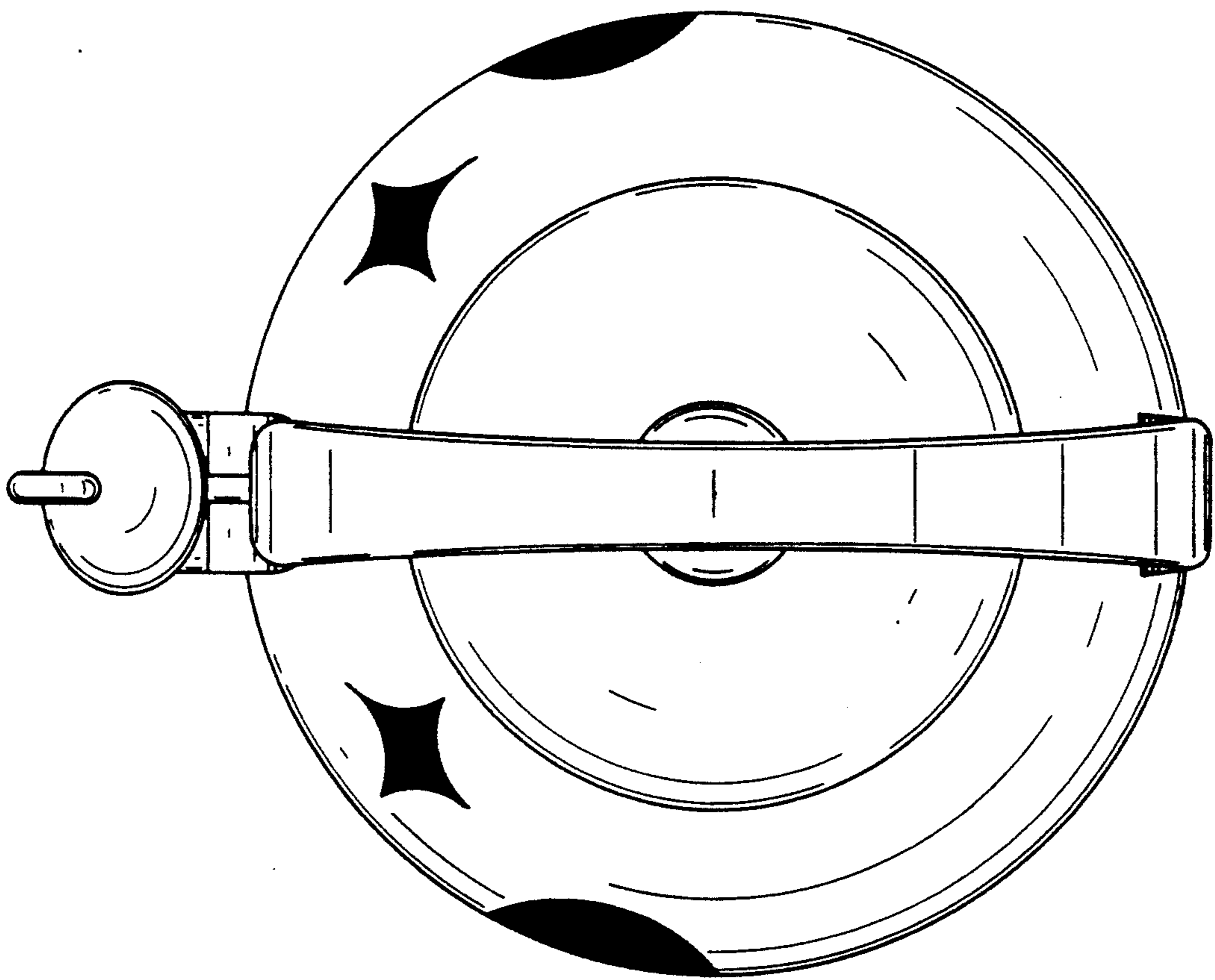

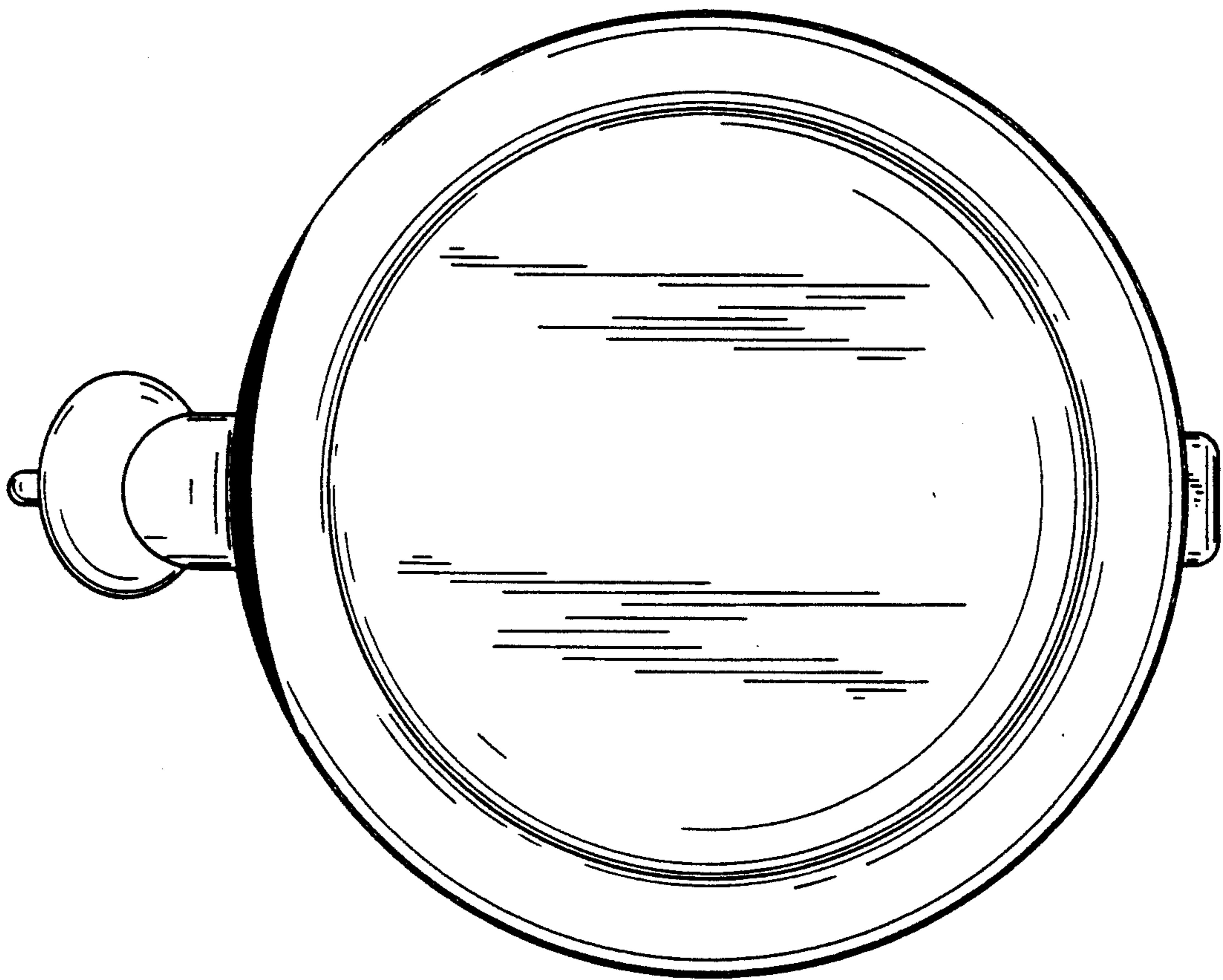
