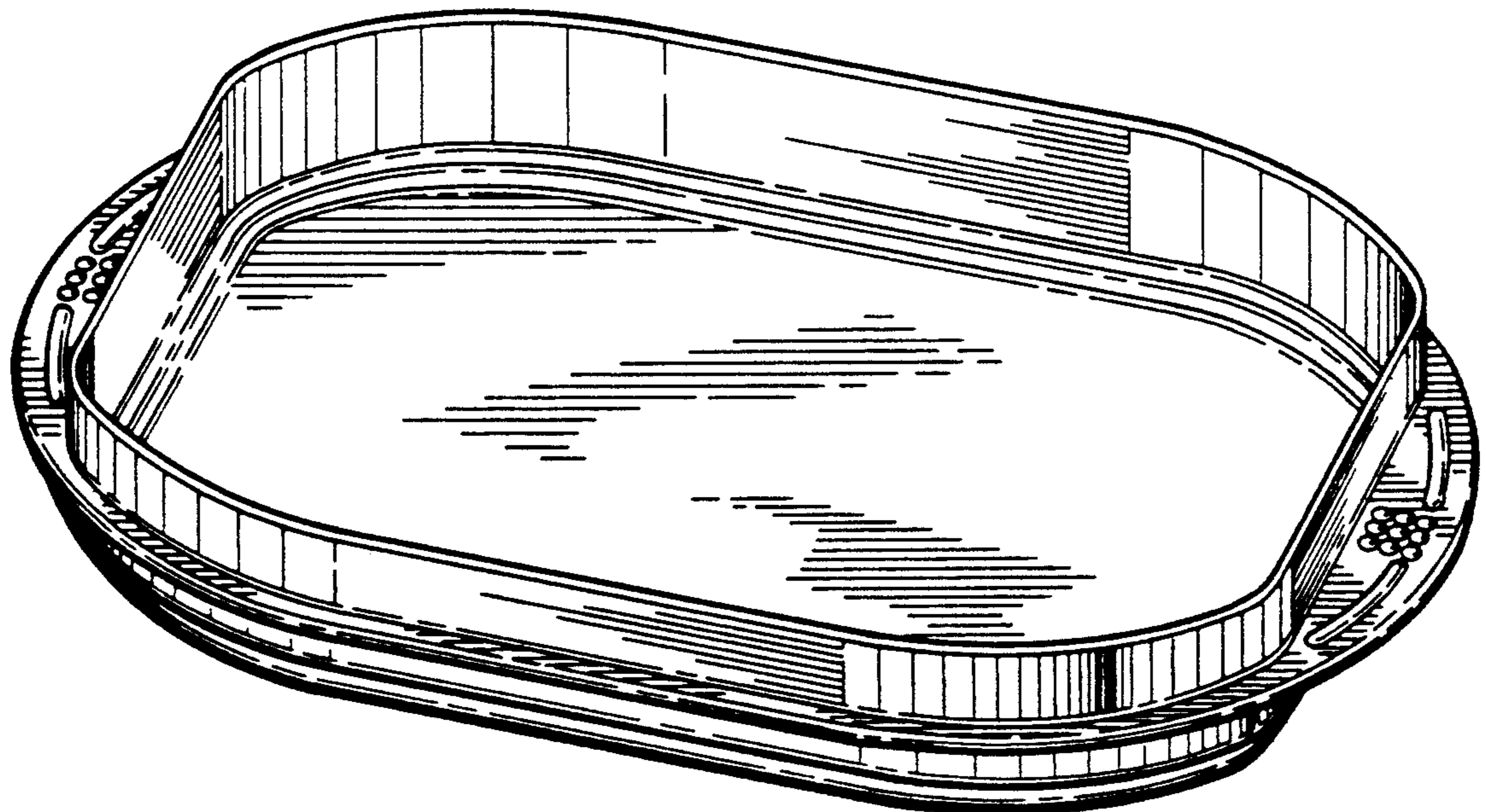

The ornamental design for a stackable container, as shown and described.

**DESCRIPTION**

FIG. 1 is a top and side perspective view of a stackable container showing my new design;  
 FIG. 2 is a top plan view thereof;  
 FIG. 3 is a bottom plan view thereof;  
 FIG. 4 is a side elevation view thereof, the opposite side being identical;  
 FIG. 5 is an end elevation view thereof, the opposite end being identical;  
 FIG. 6 is a top and side perspective view of a second embodiment thereof;  
 FIG. 7 is a top plan view of the second embodiment;  
 FIG. 8 is a bottom plan view of the second embodiment;  
 FIG. 9 is a side elevation view of the second embodiment, the opposite side being identical; and,  
 FIG. 10 is an end elevation view of the second embodiment, the opposite end being identical.



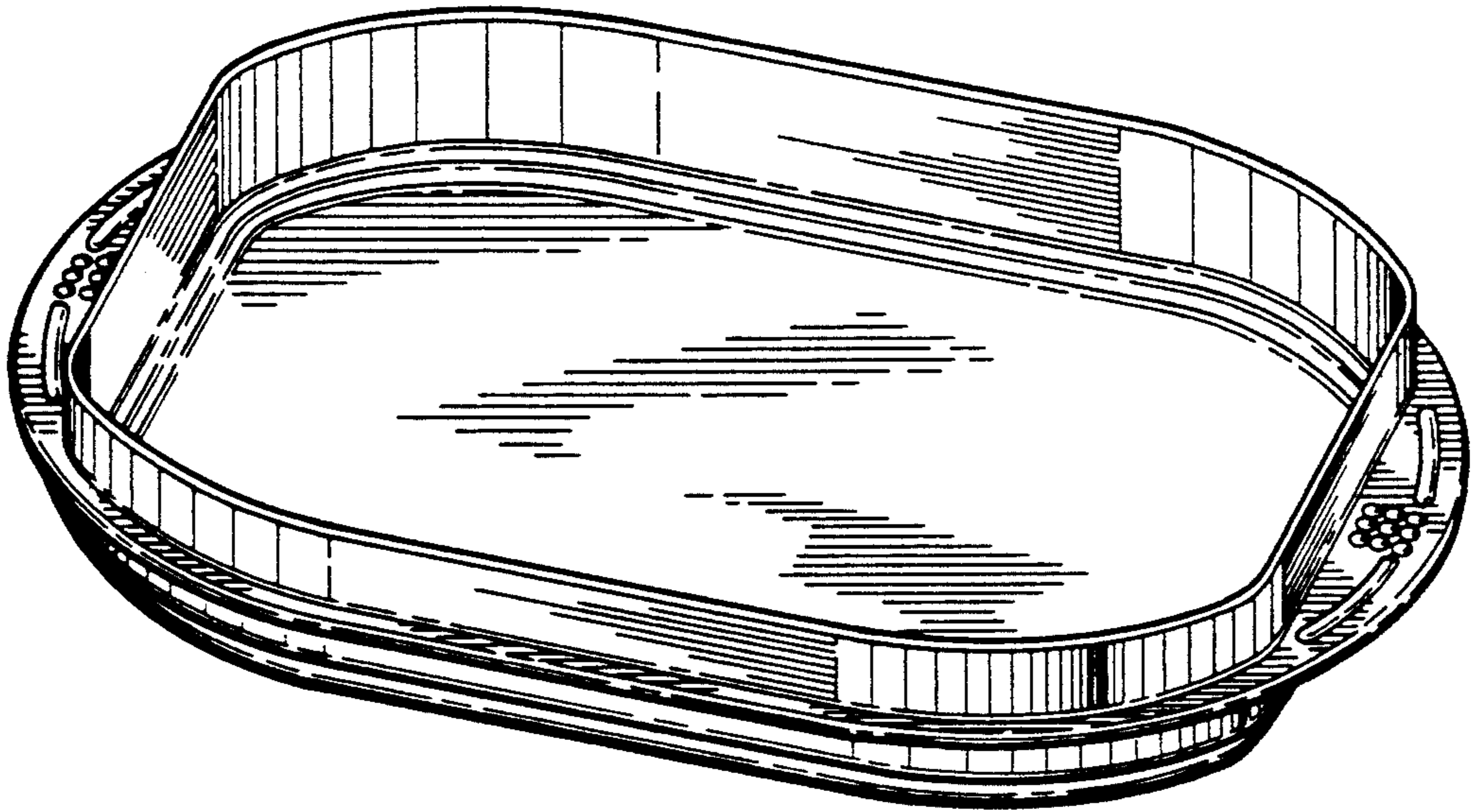

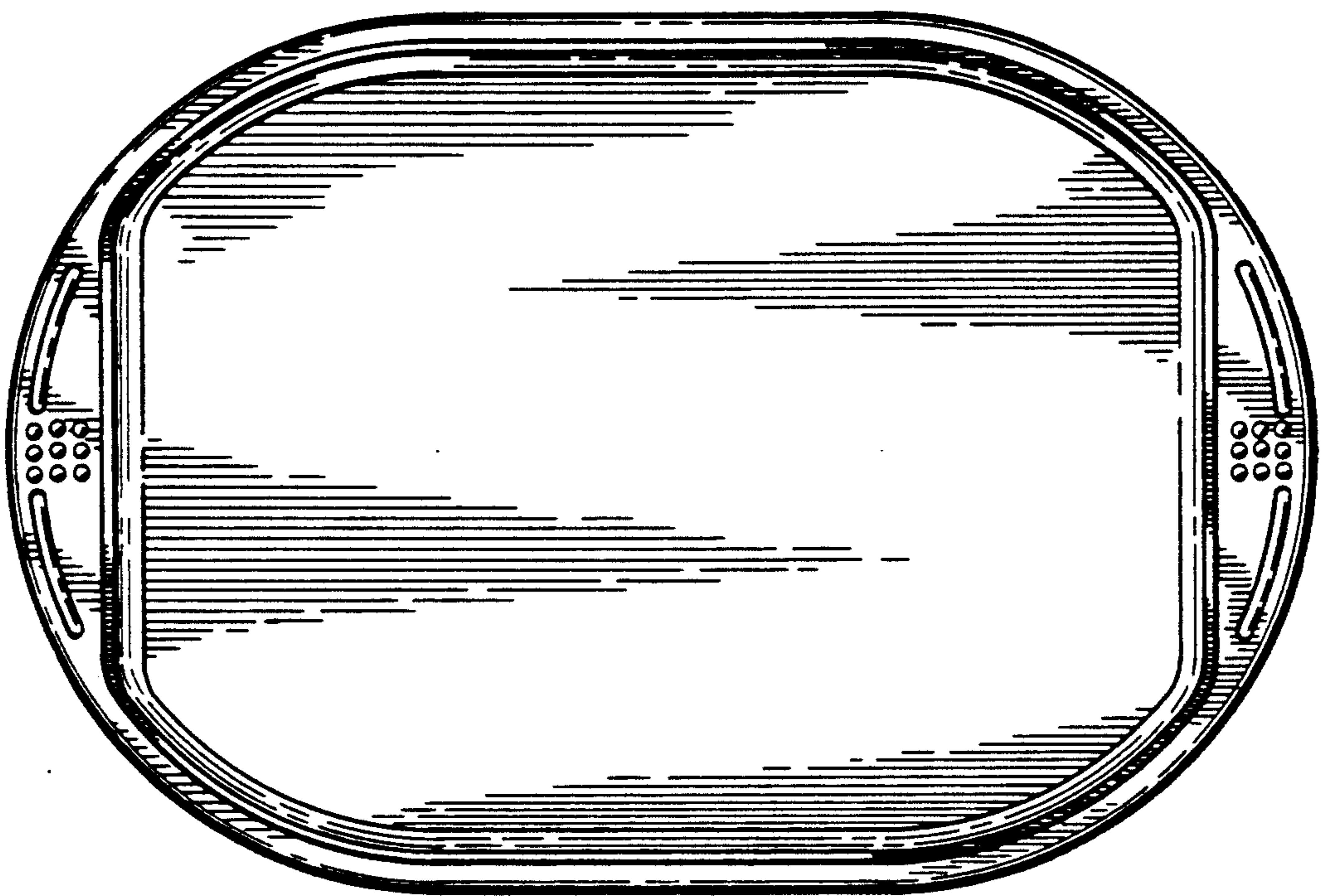

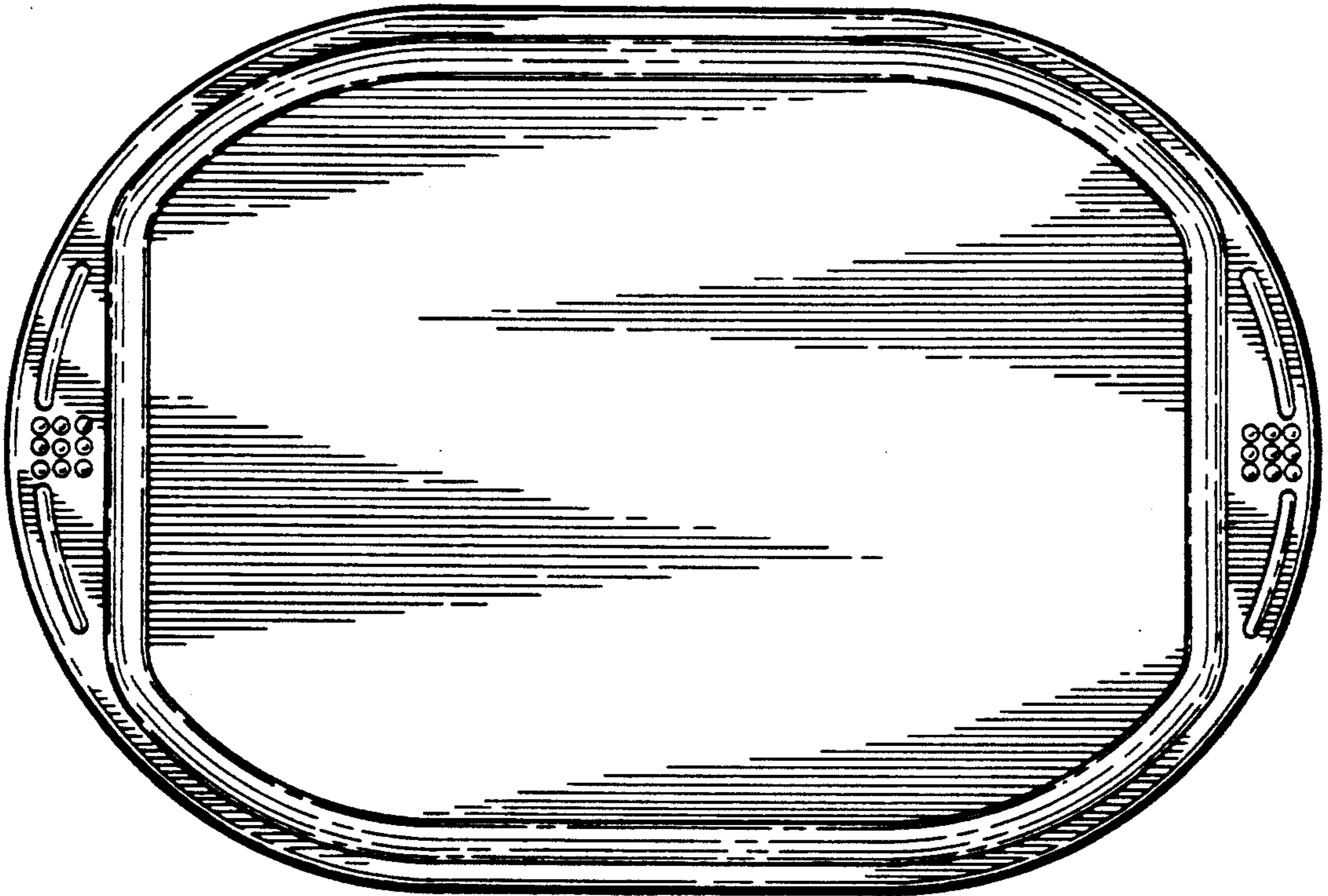

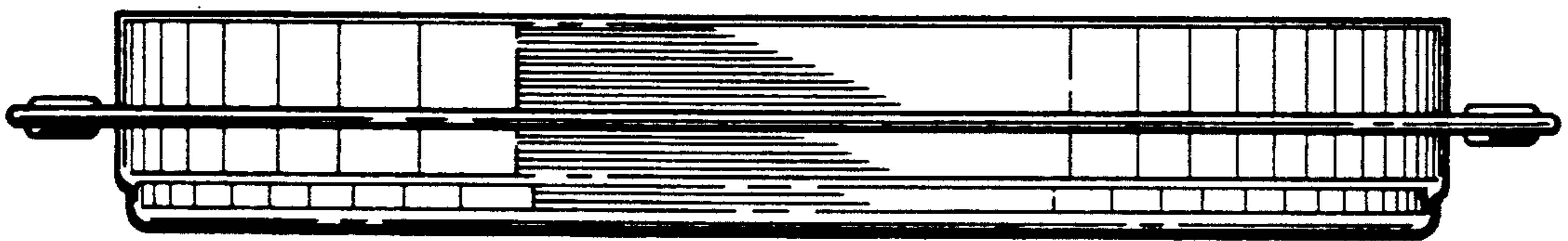

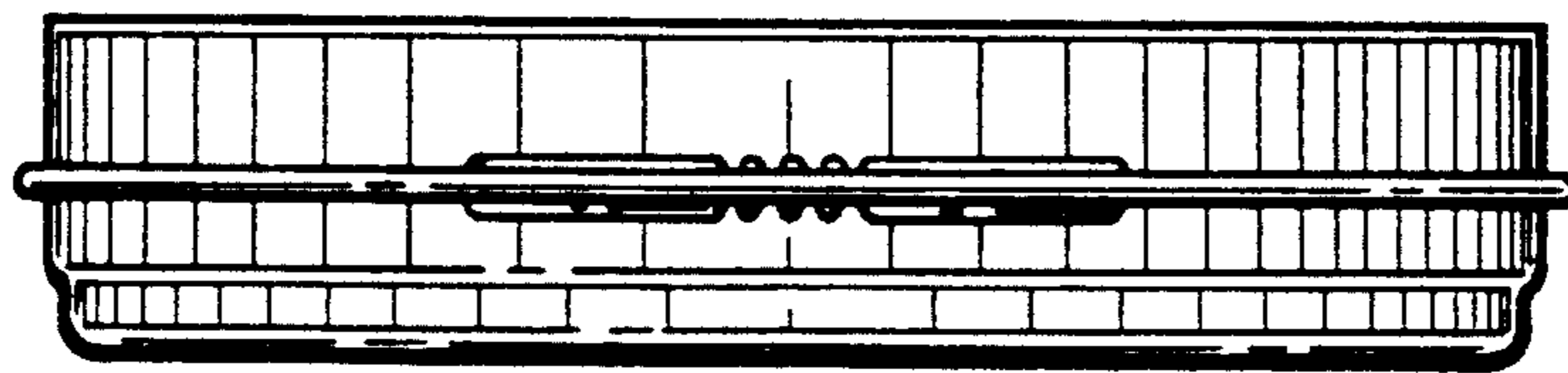

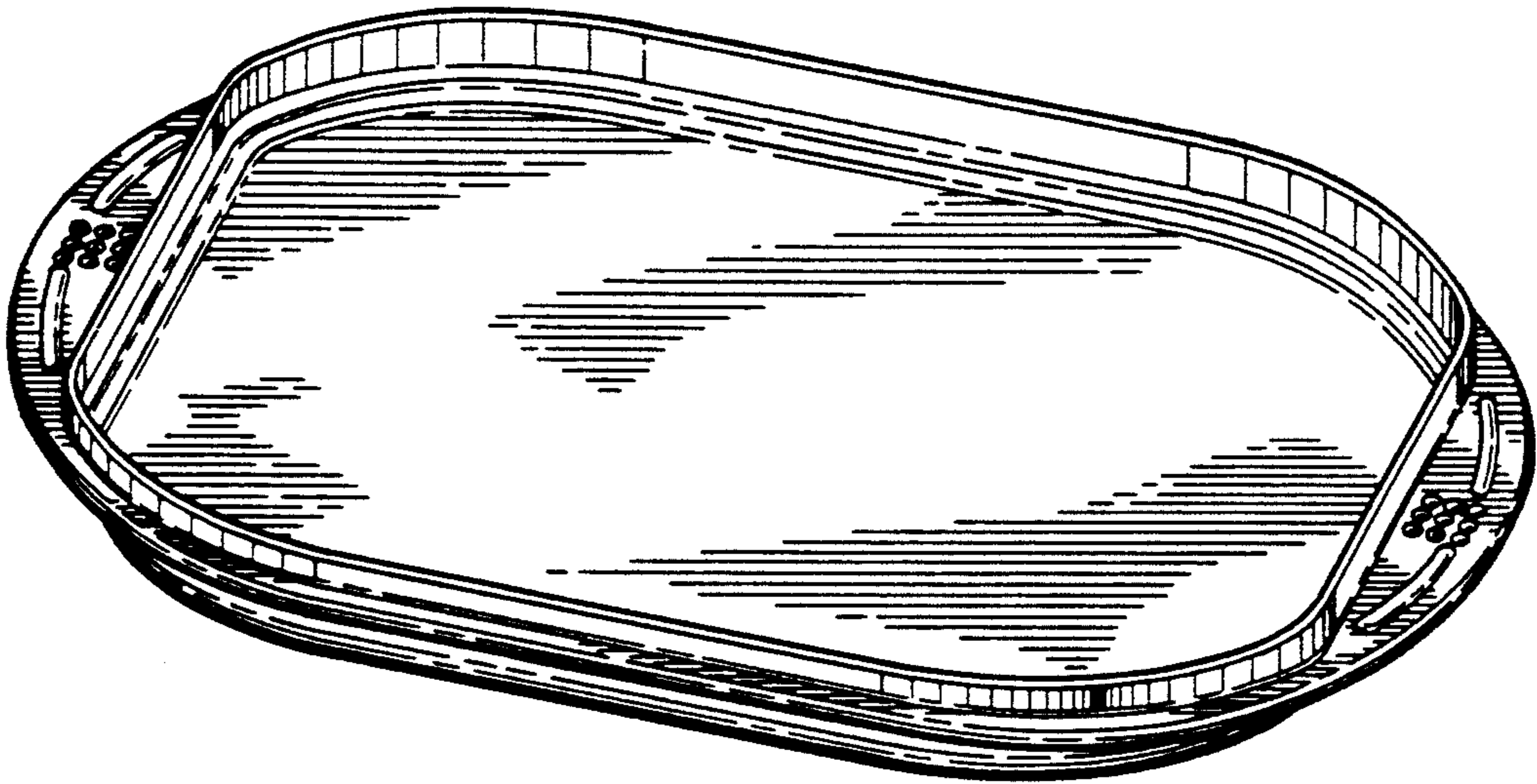

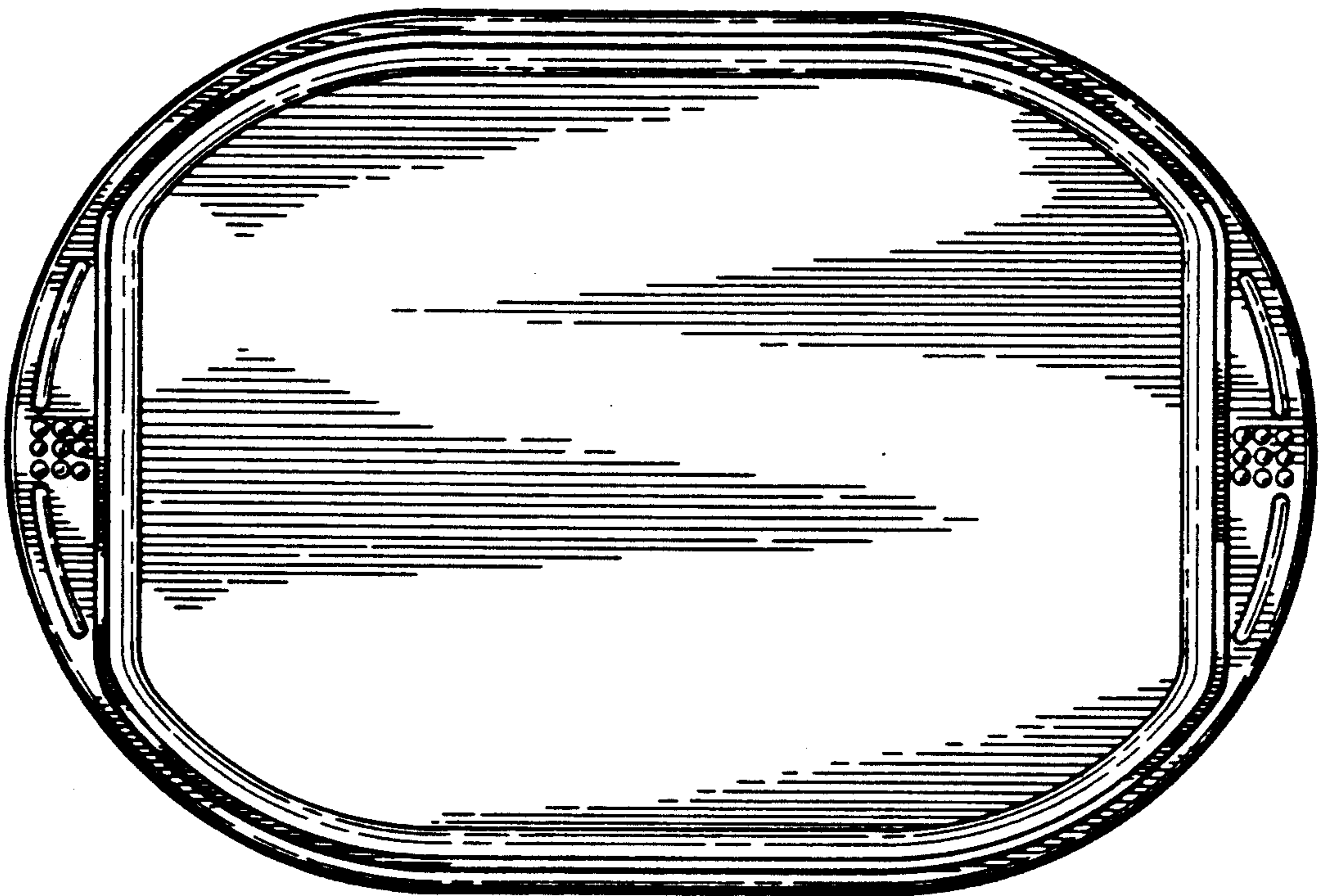

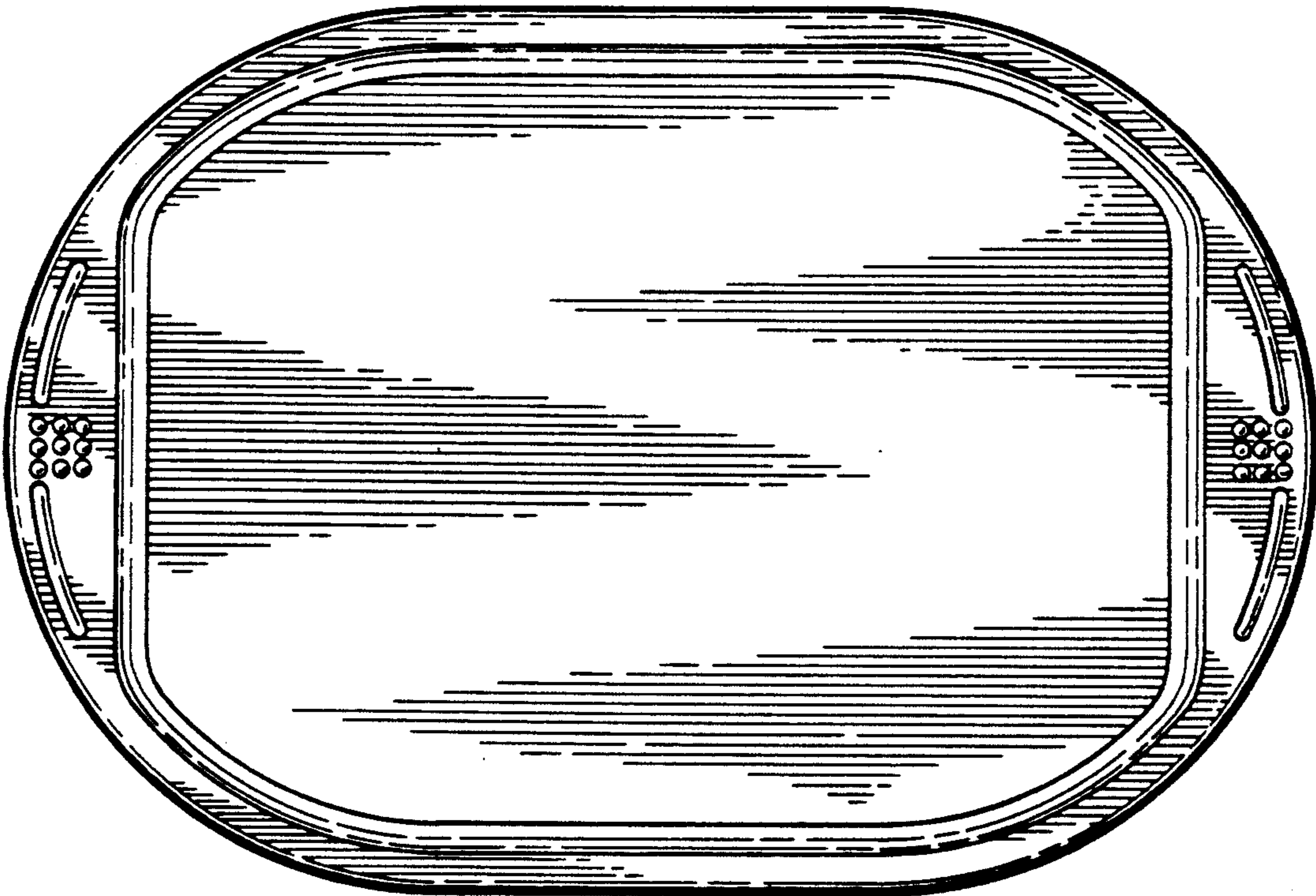
