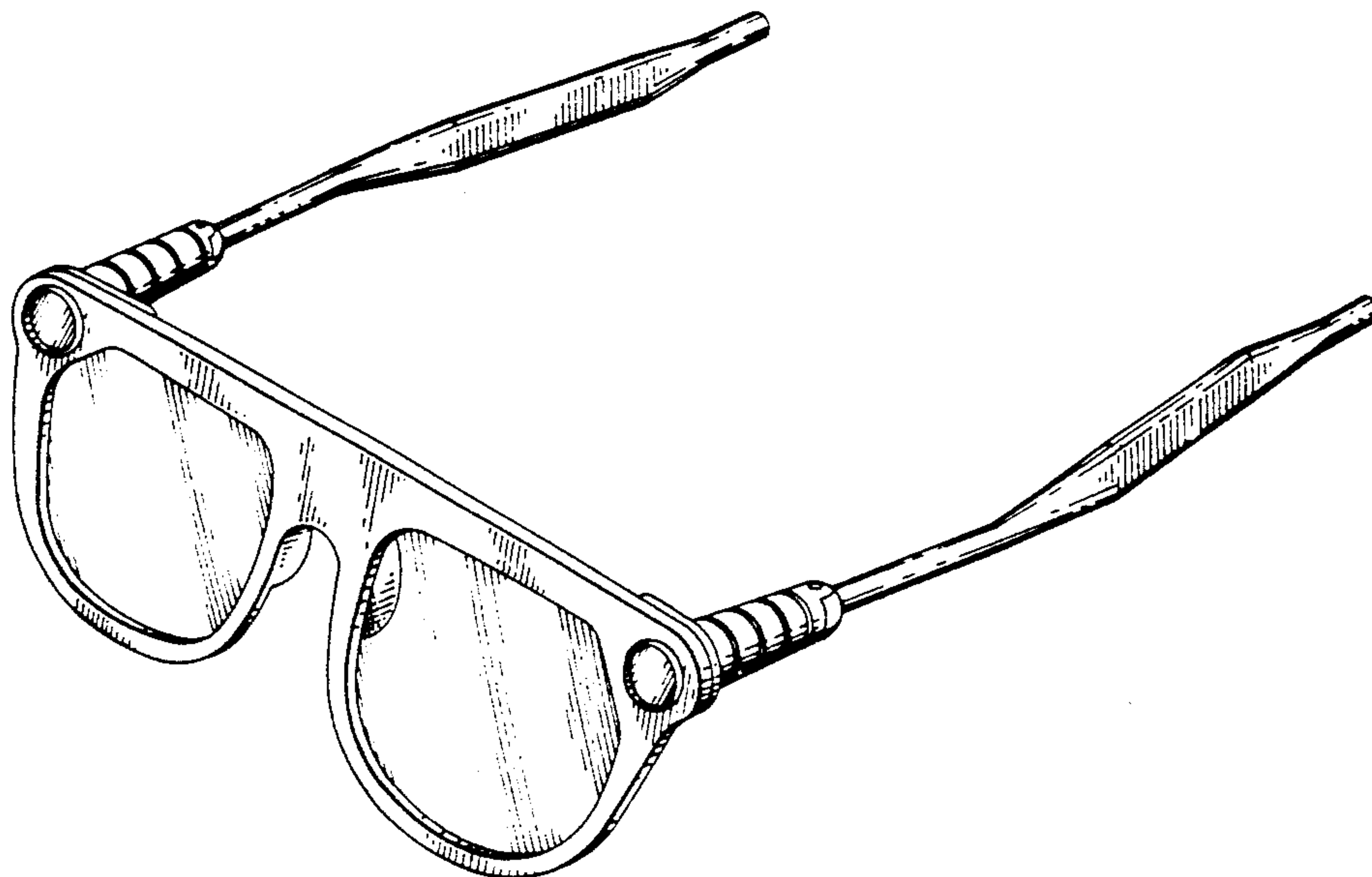

The ornamental design for a spectacle frame, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a spectacle frame;
FIG. 2 is a front view of the spectacle frame;
FIG. 3 is the rear view of the spectacle frame;
FIG. 4 is a right side view, the side opposite being a mirror image;
FIG. 5 is a top view of the spectacle frame;
FIG. 6 is the bottom view of the spectacle frame.



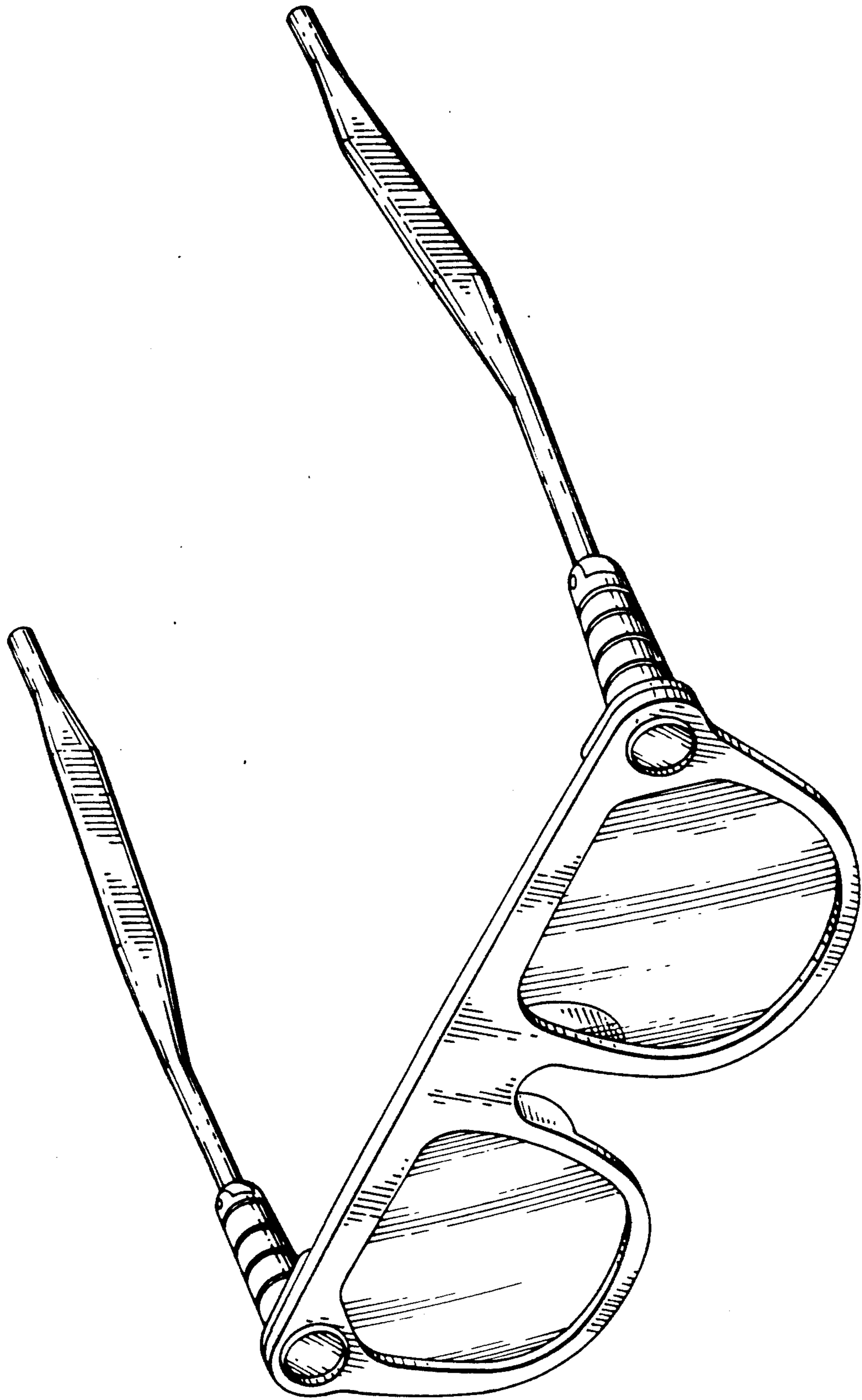

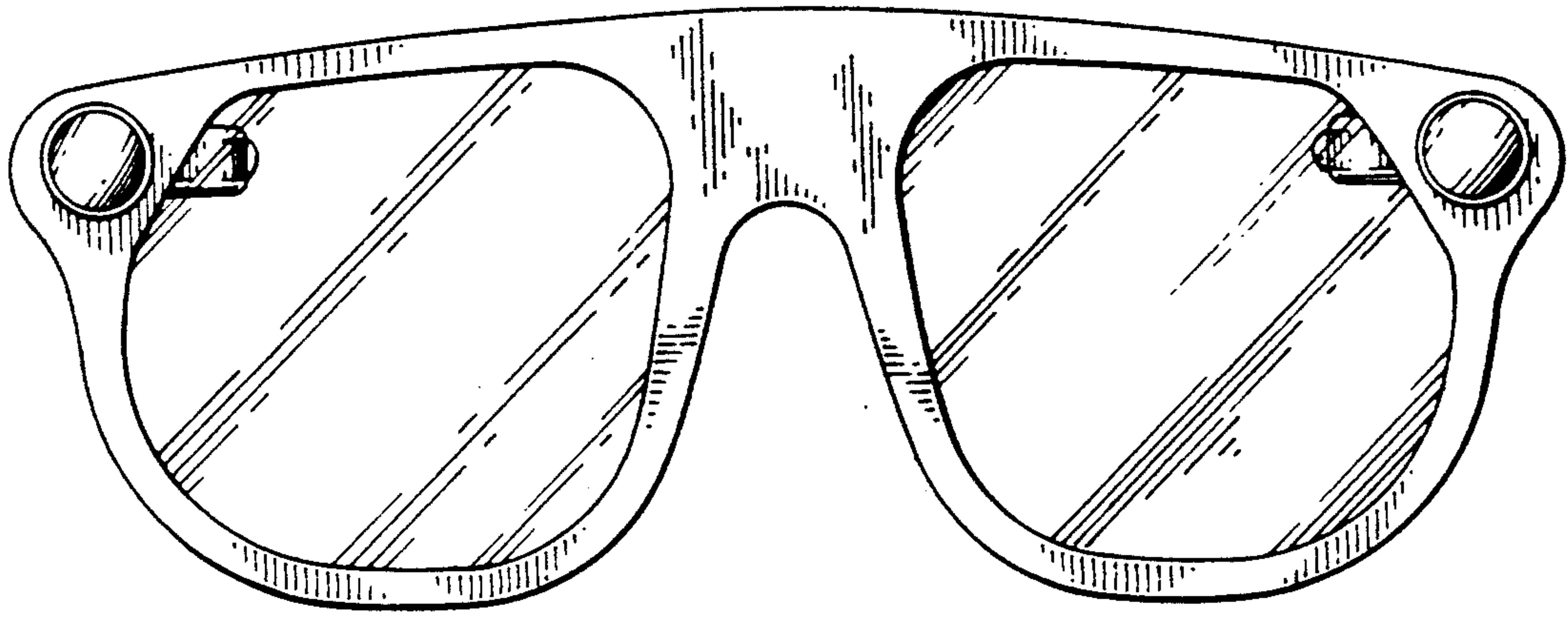

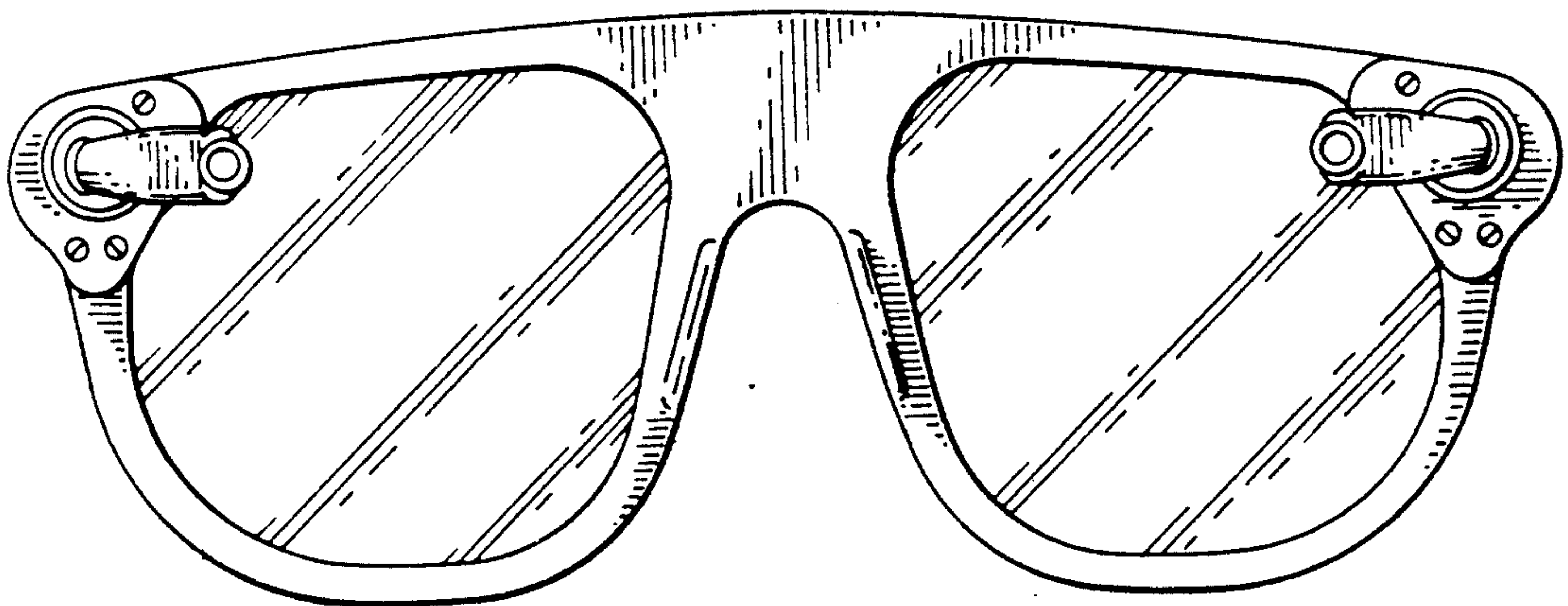

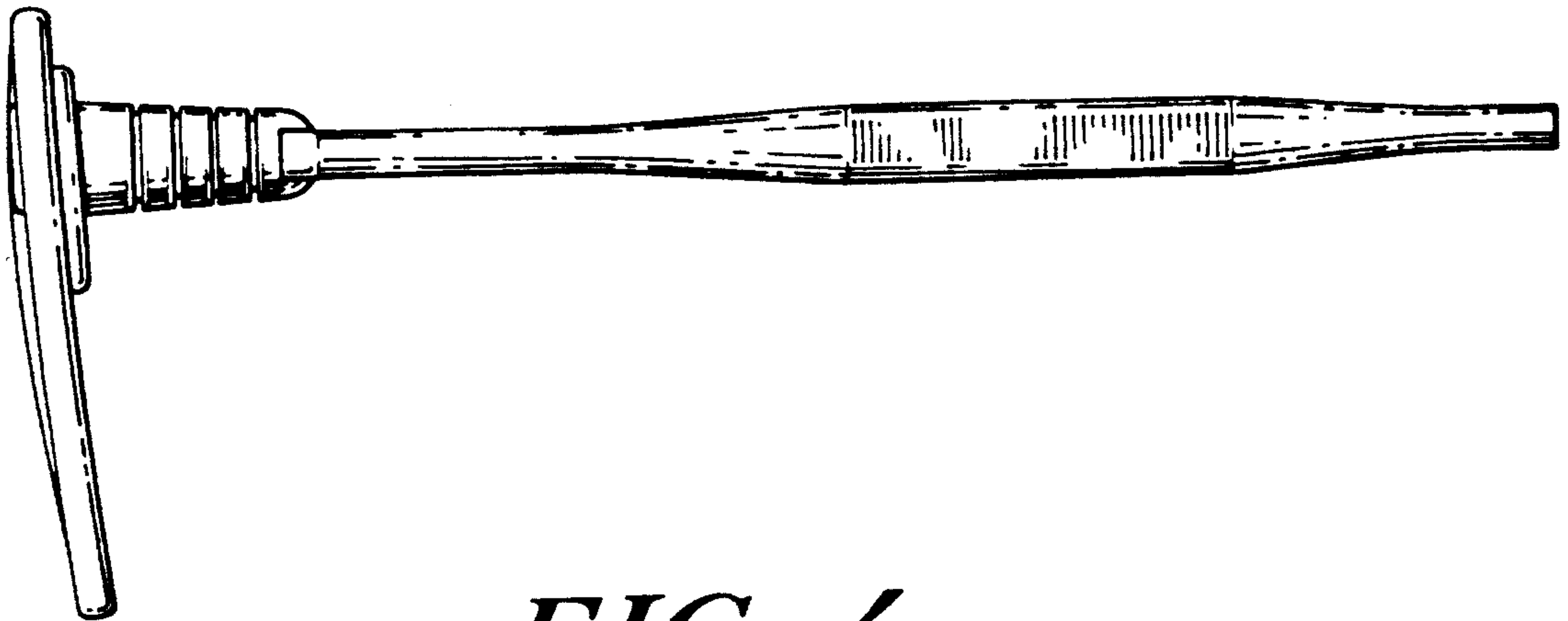

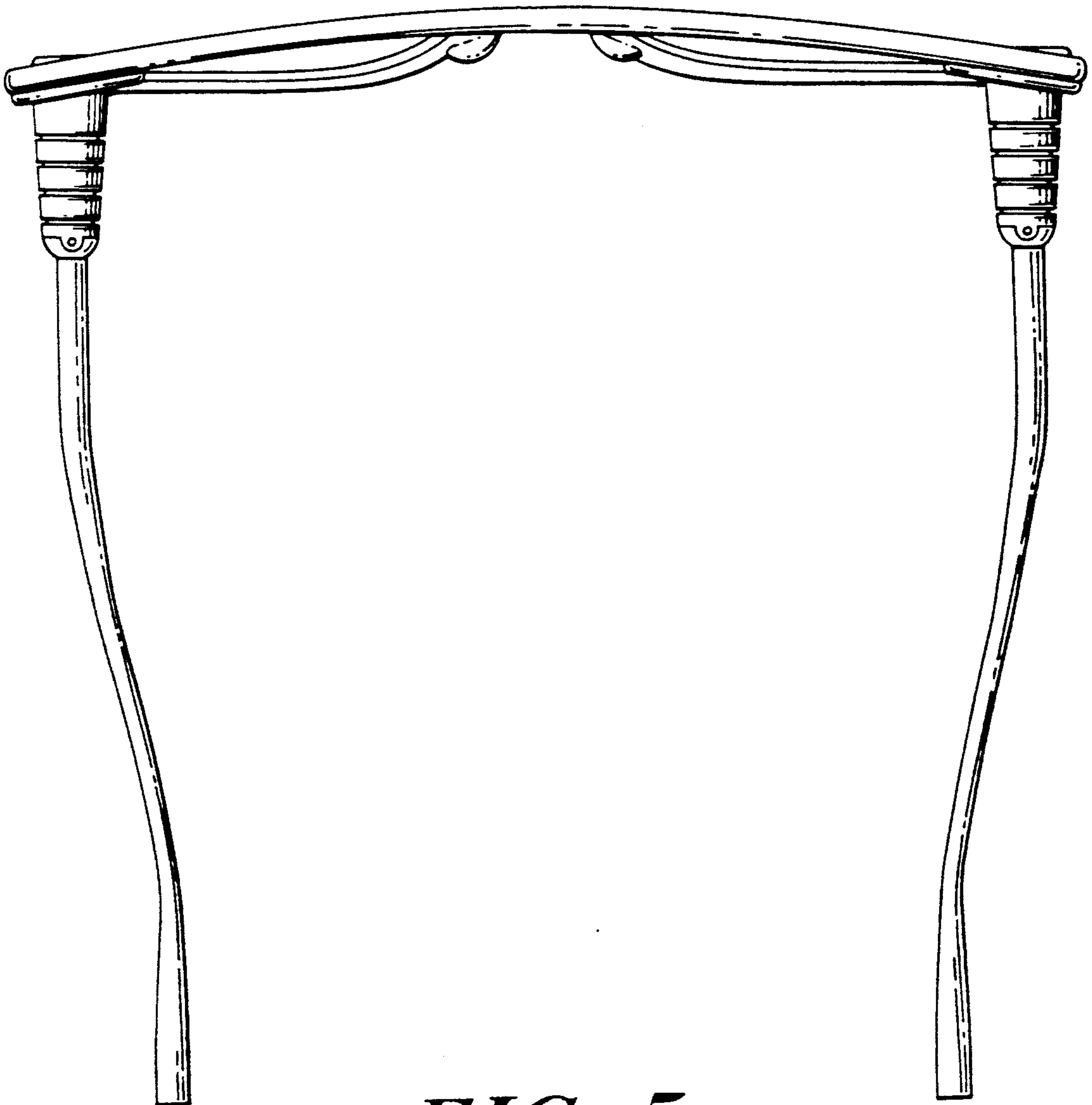

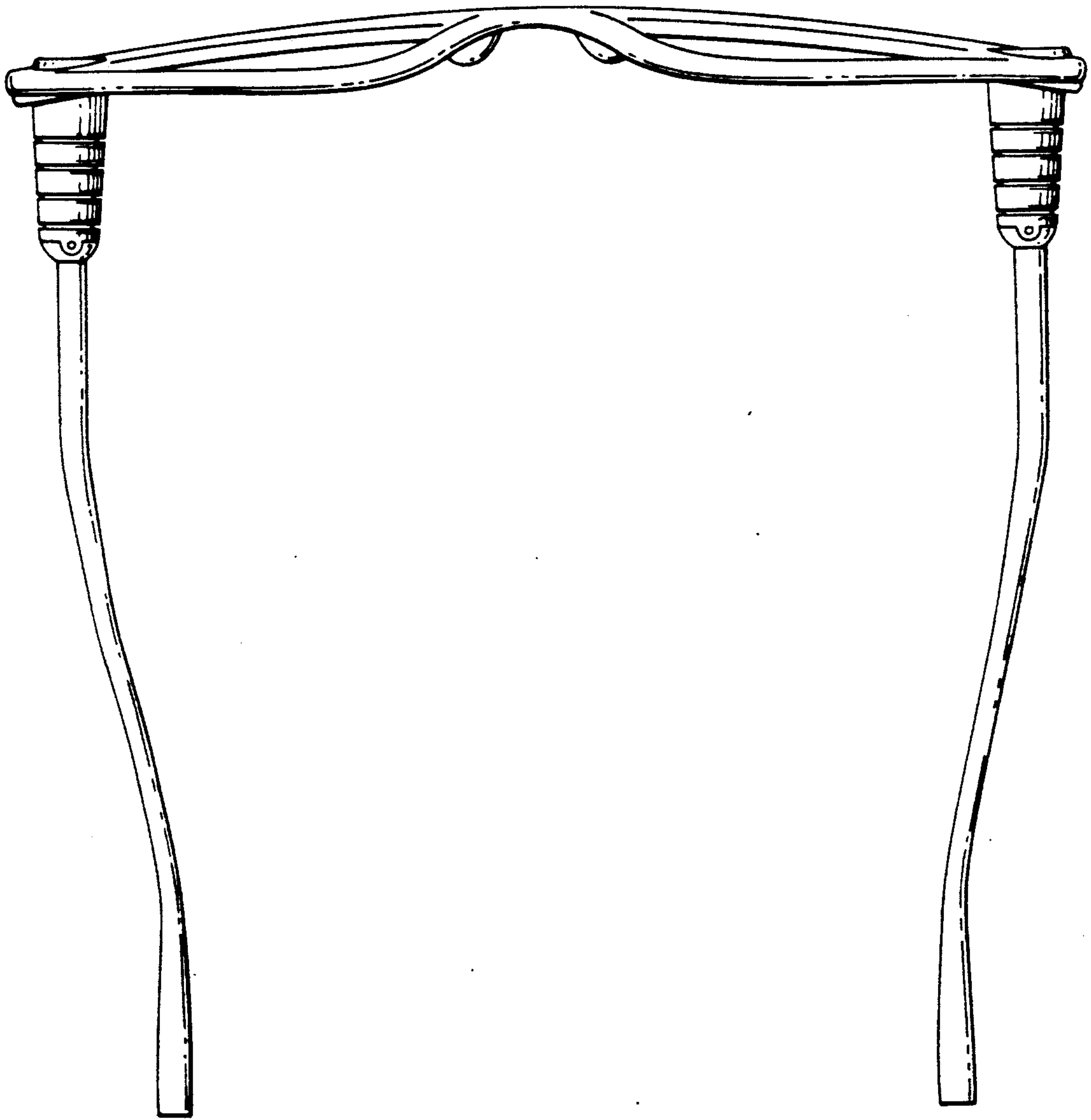
