[57] **CLAIM**

The ornamental design for a golf ball, as shown and described.

**DESCRIPTION**

FIG. 1 is an elevation of a golf ball showing our new design. The views from the opposite, left and right sides and from the top and bottom are the same as that shown in FIG. 1; and,

FIG. 2 is an elevation of a golf ball showing a modification of the design of FIG. 1. The views from the opposite, left and right sides and from the top and bottom are the same as that shown in FIG. 4.

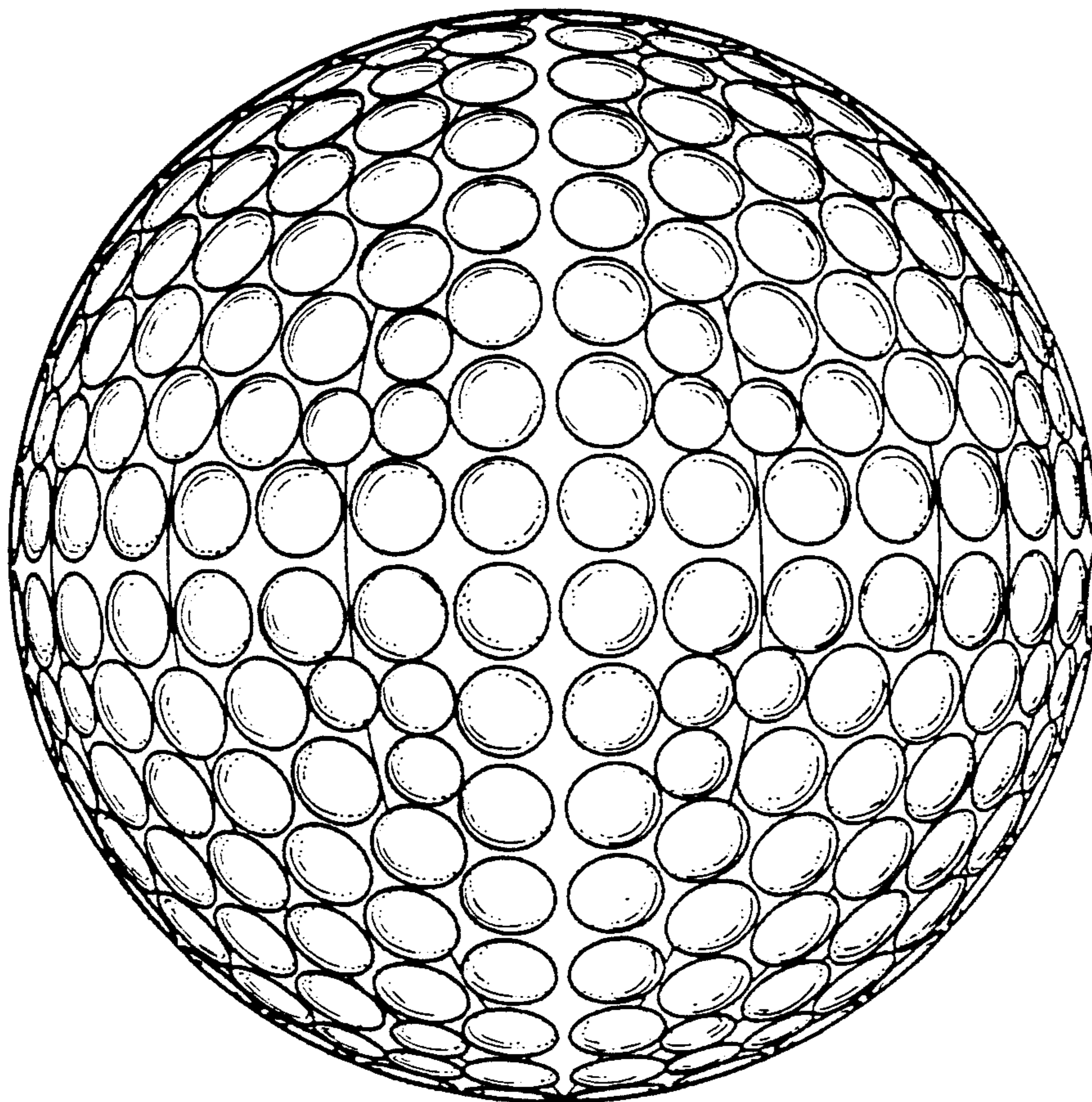

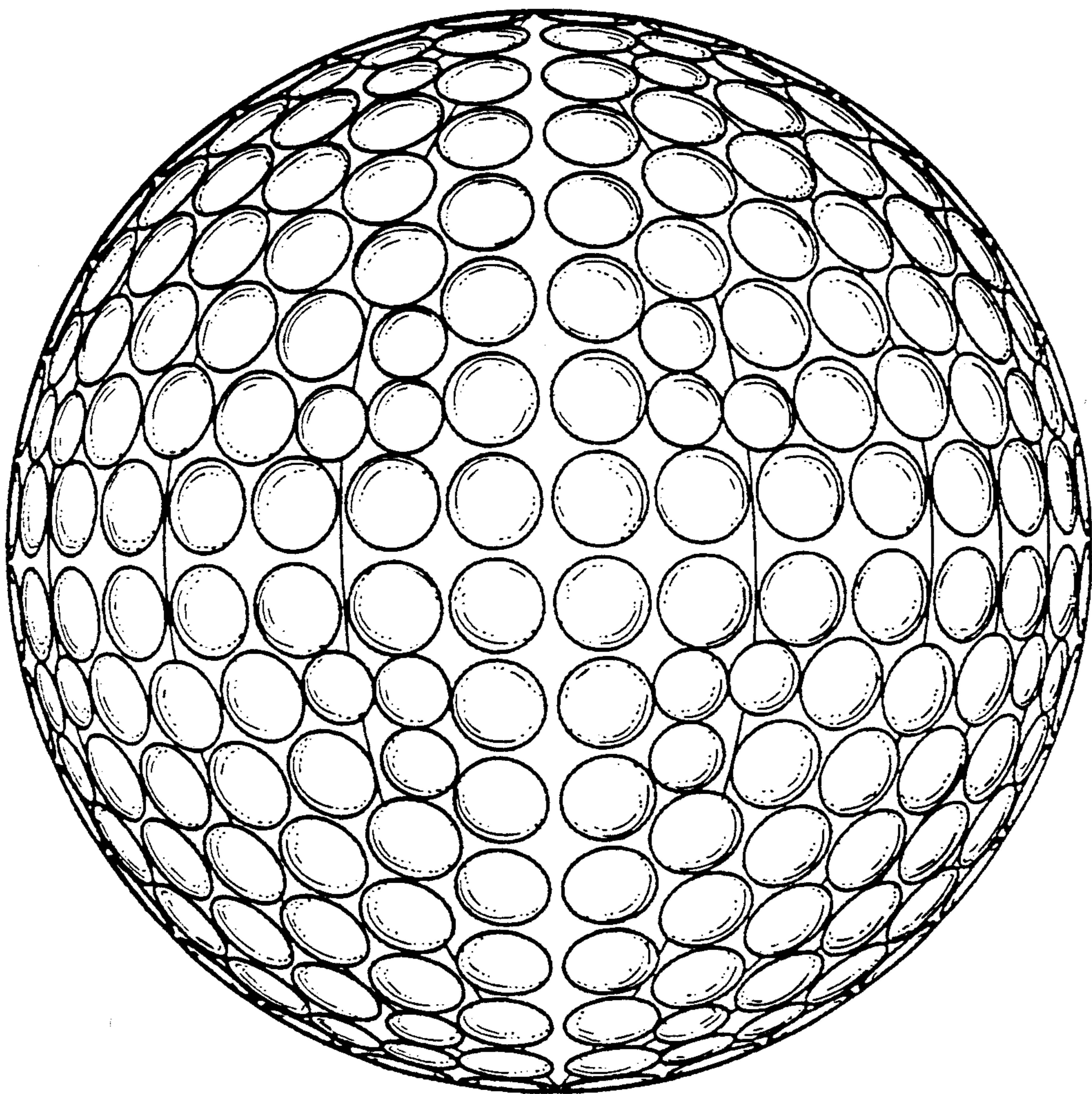
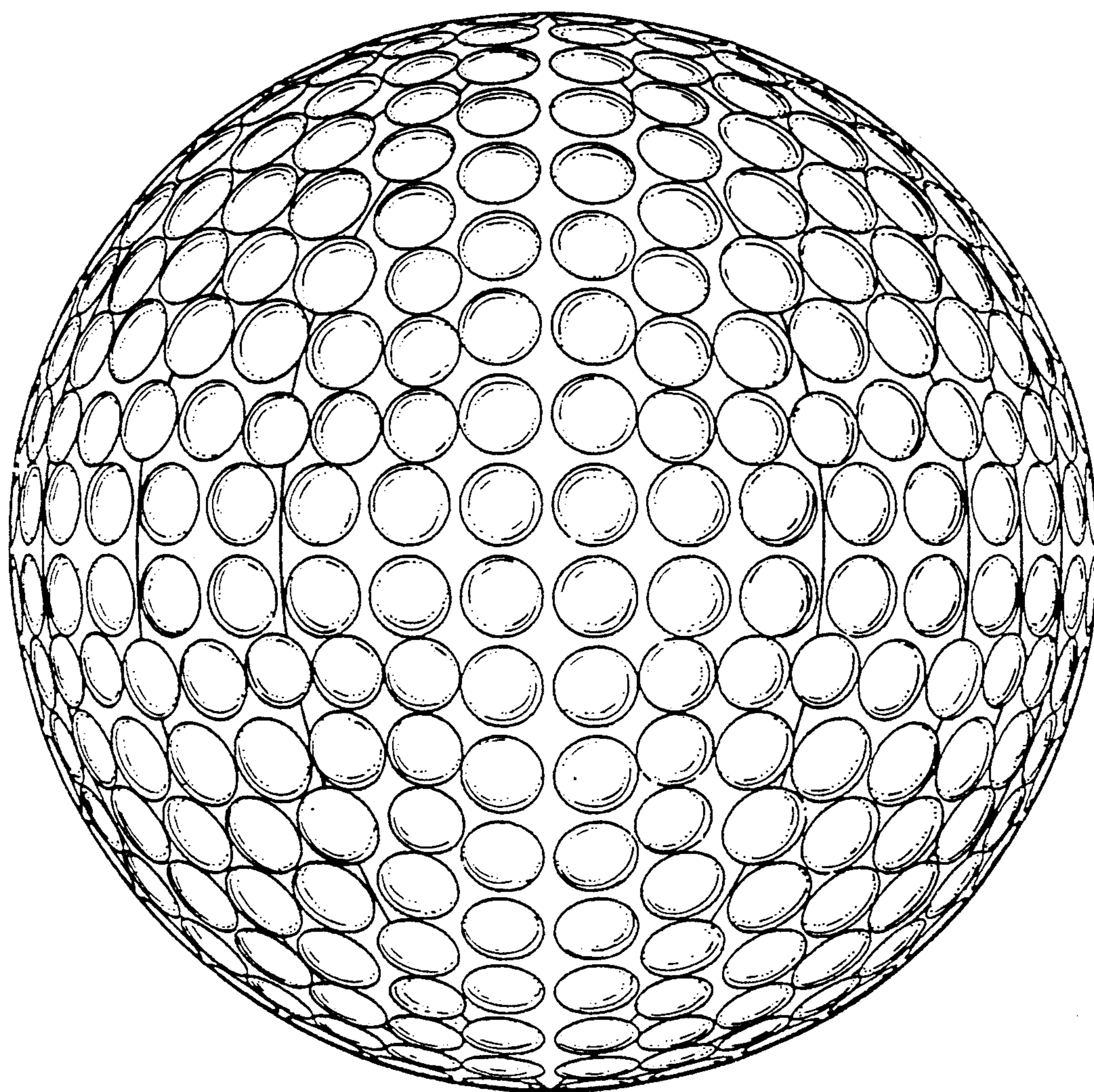
