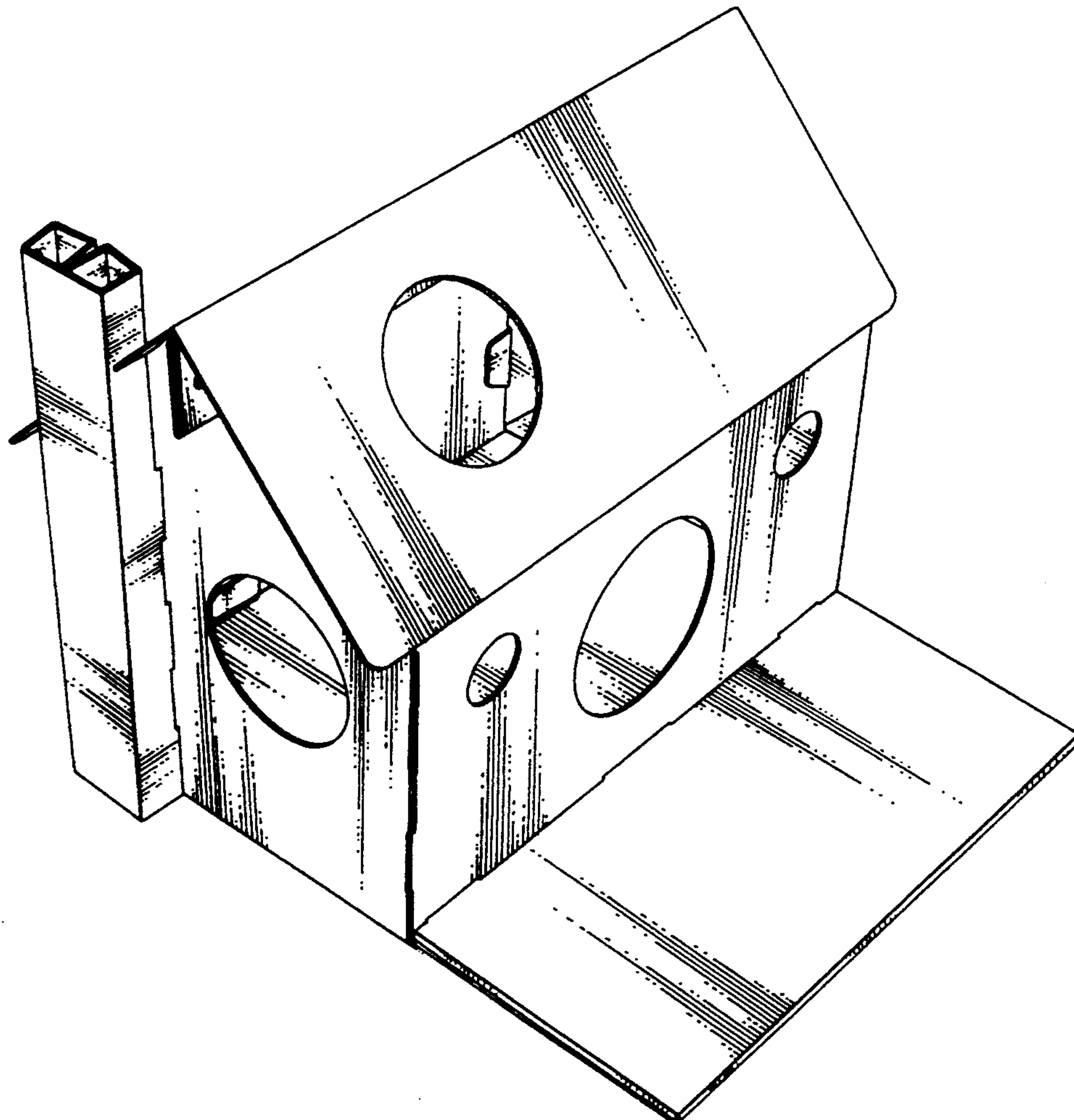

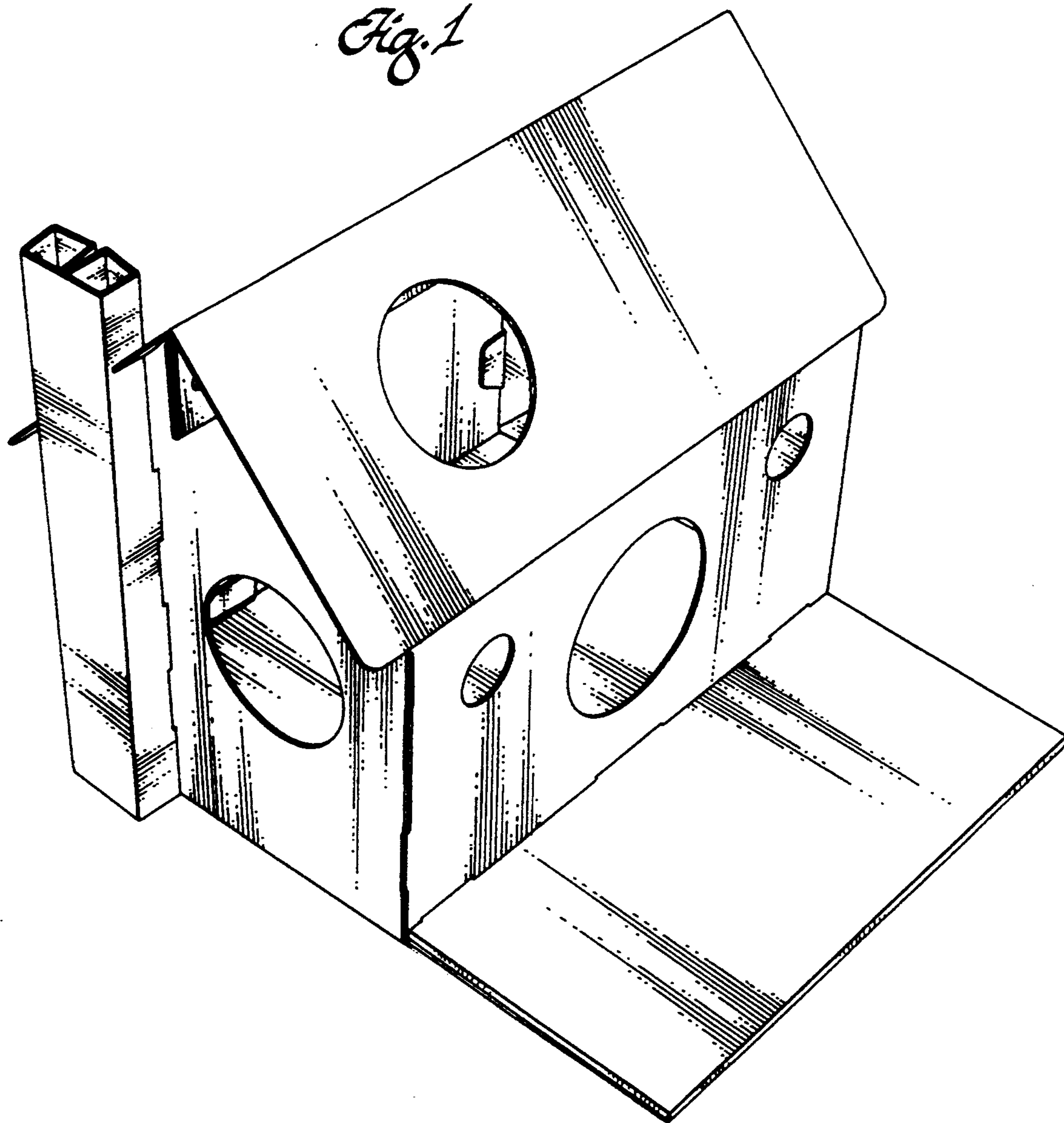

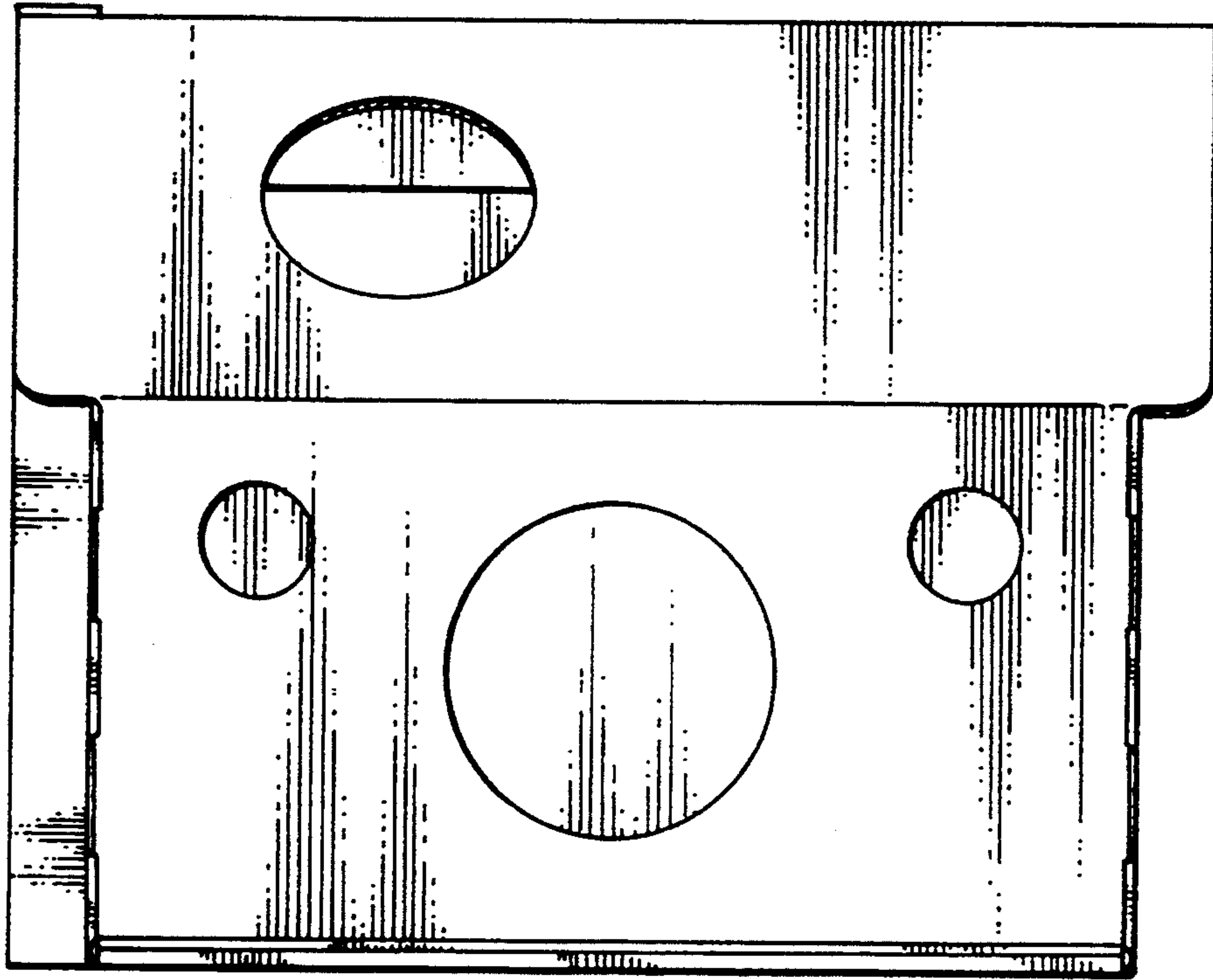
FIG. 1 is a perspective view of the pet house showing our new design;

FIG. 7 is a bottom plan view thereof.



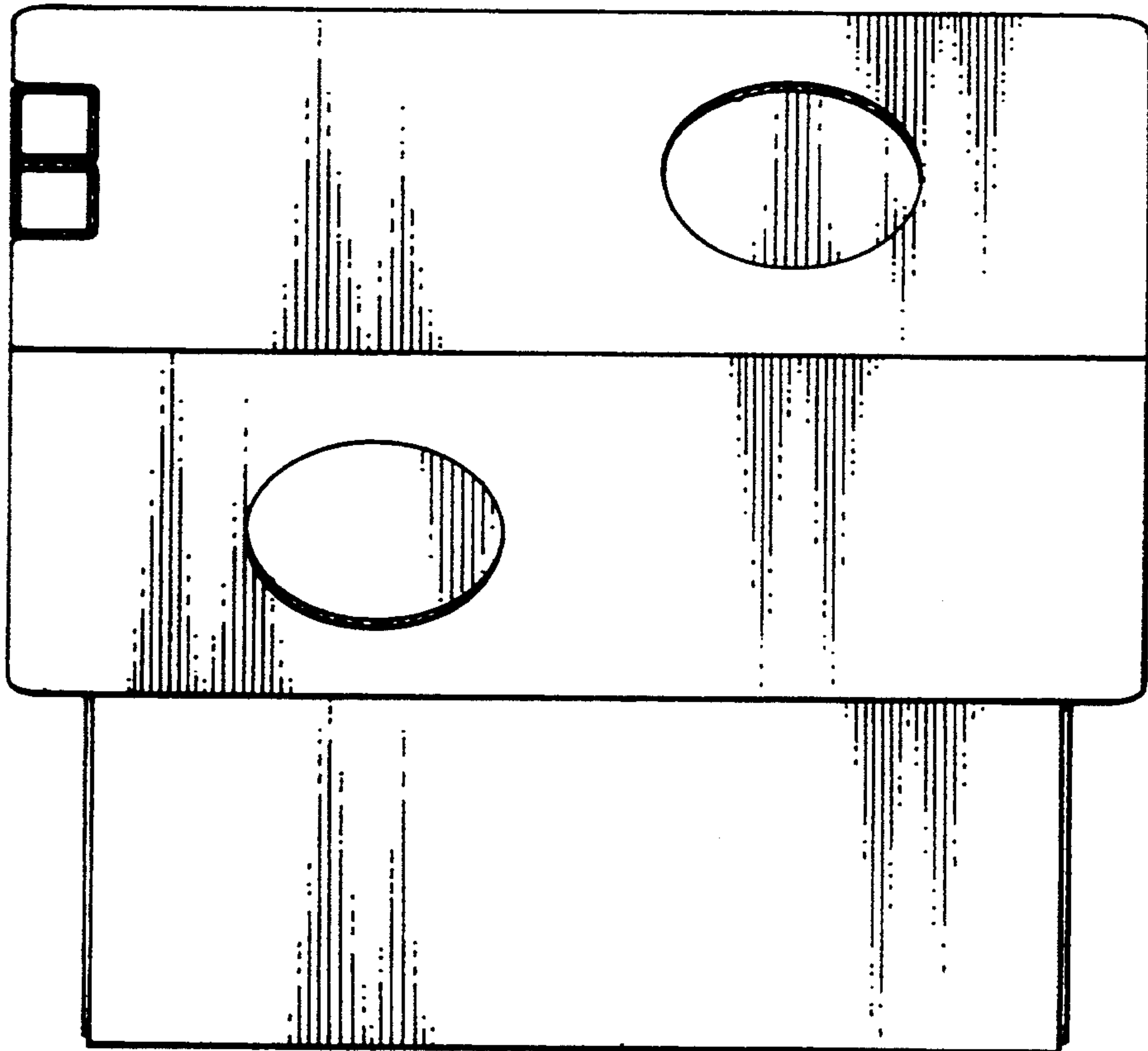

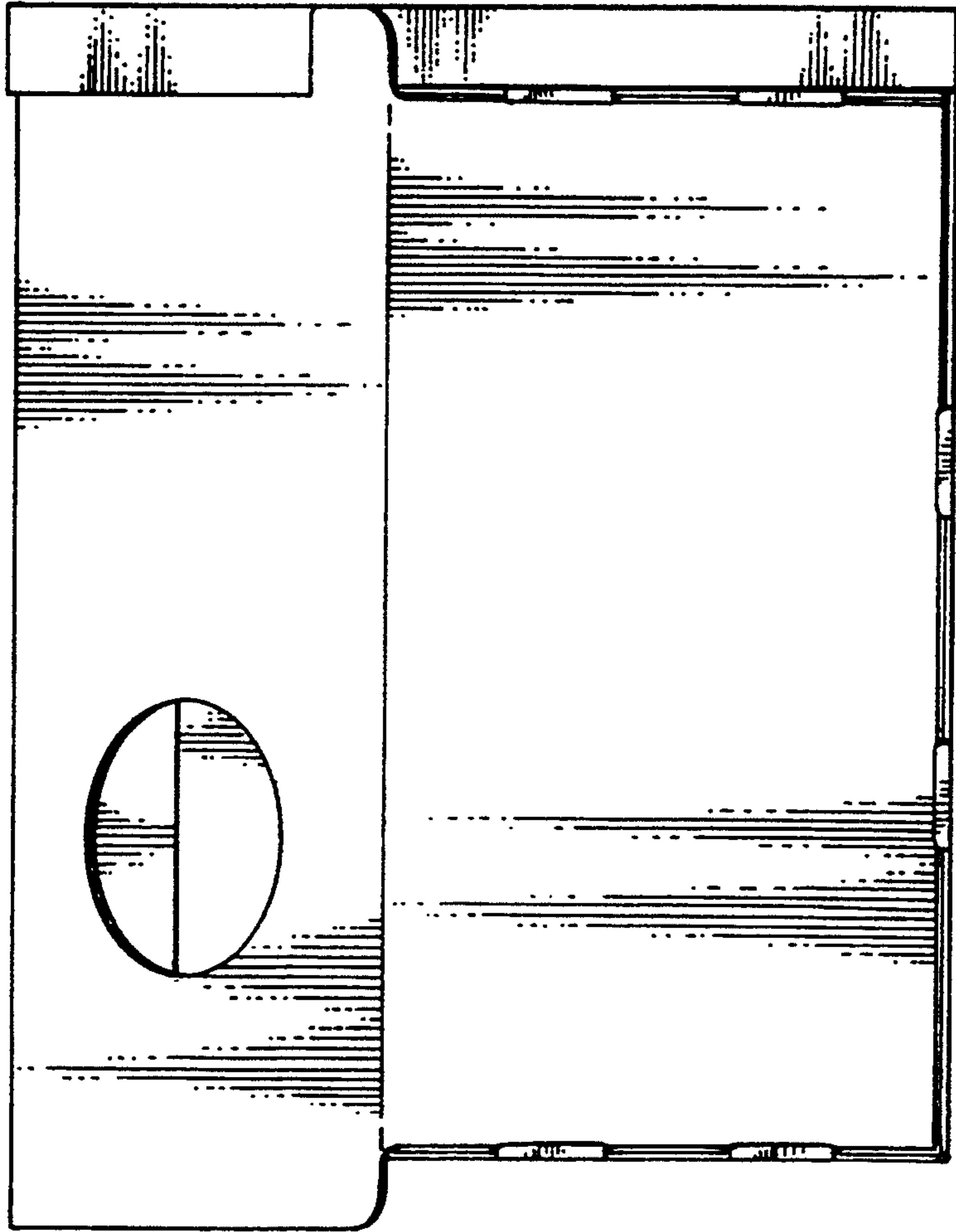

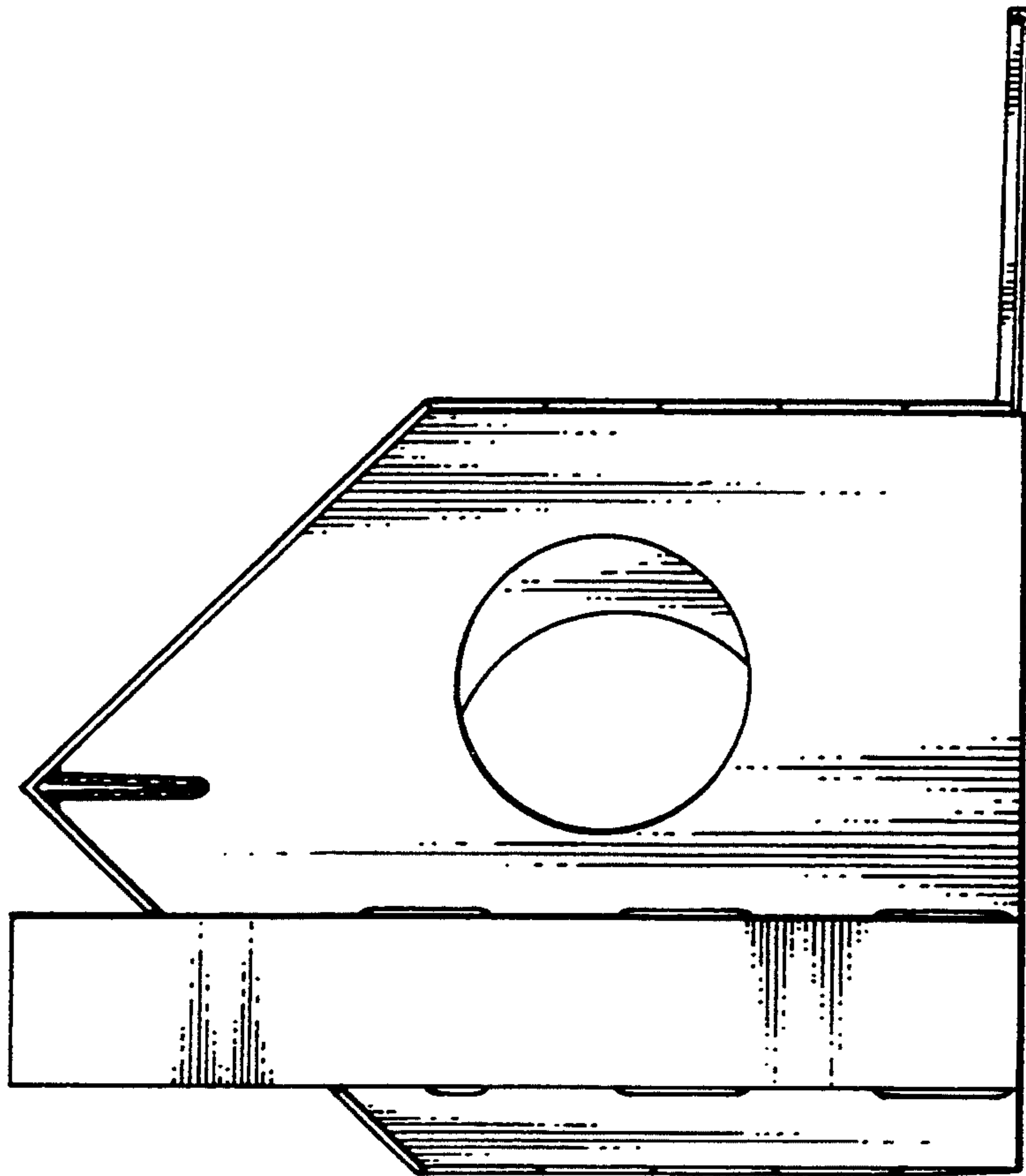




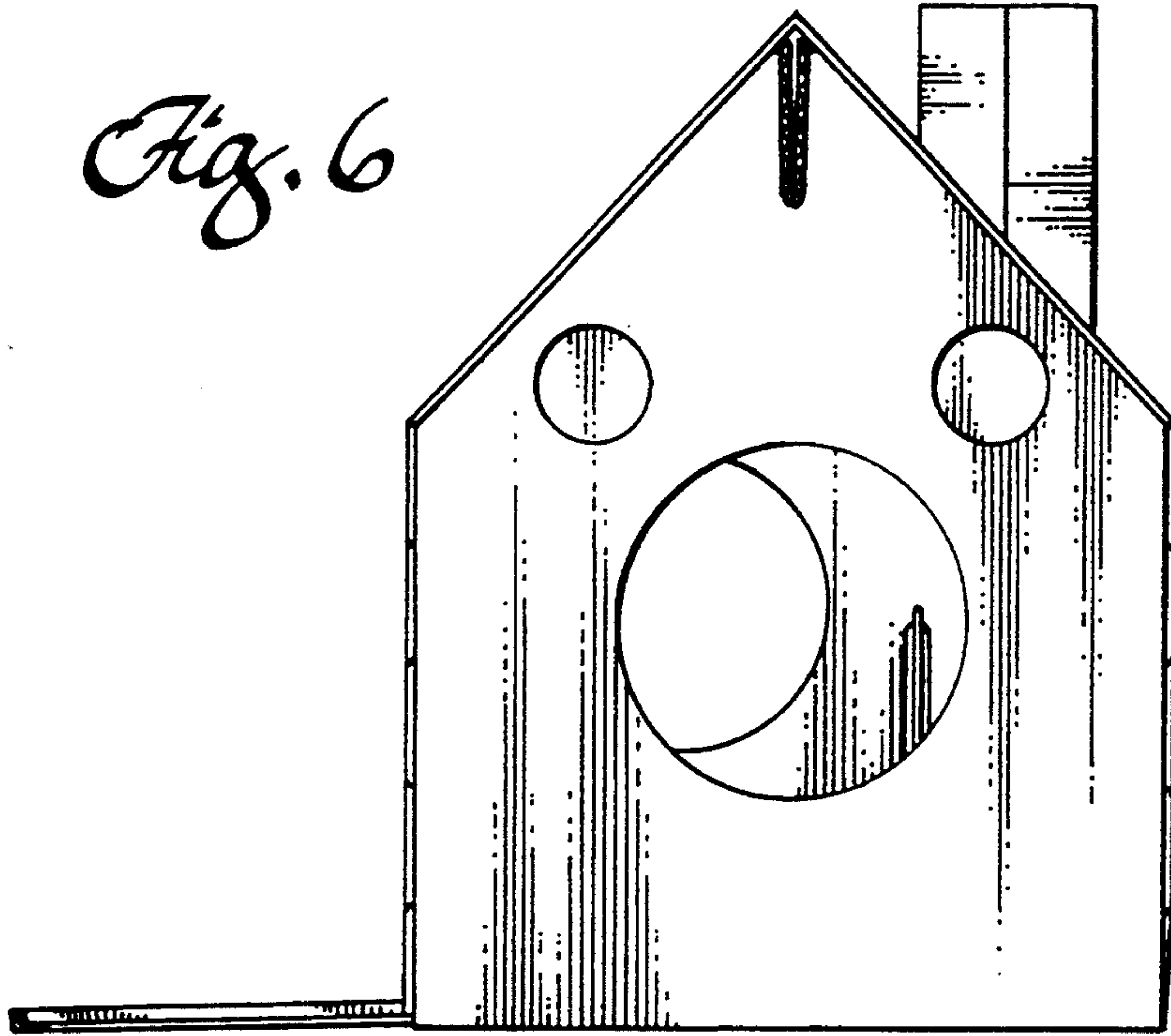
