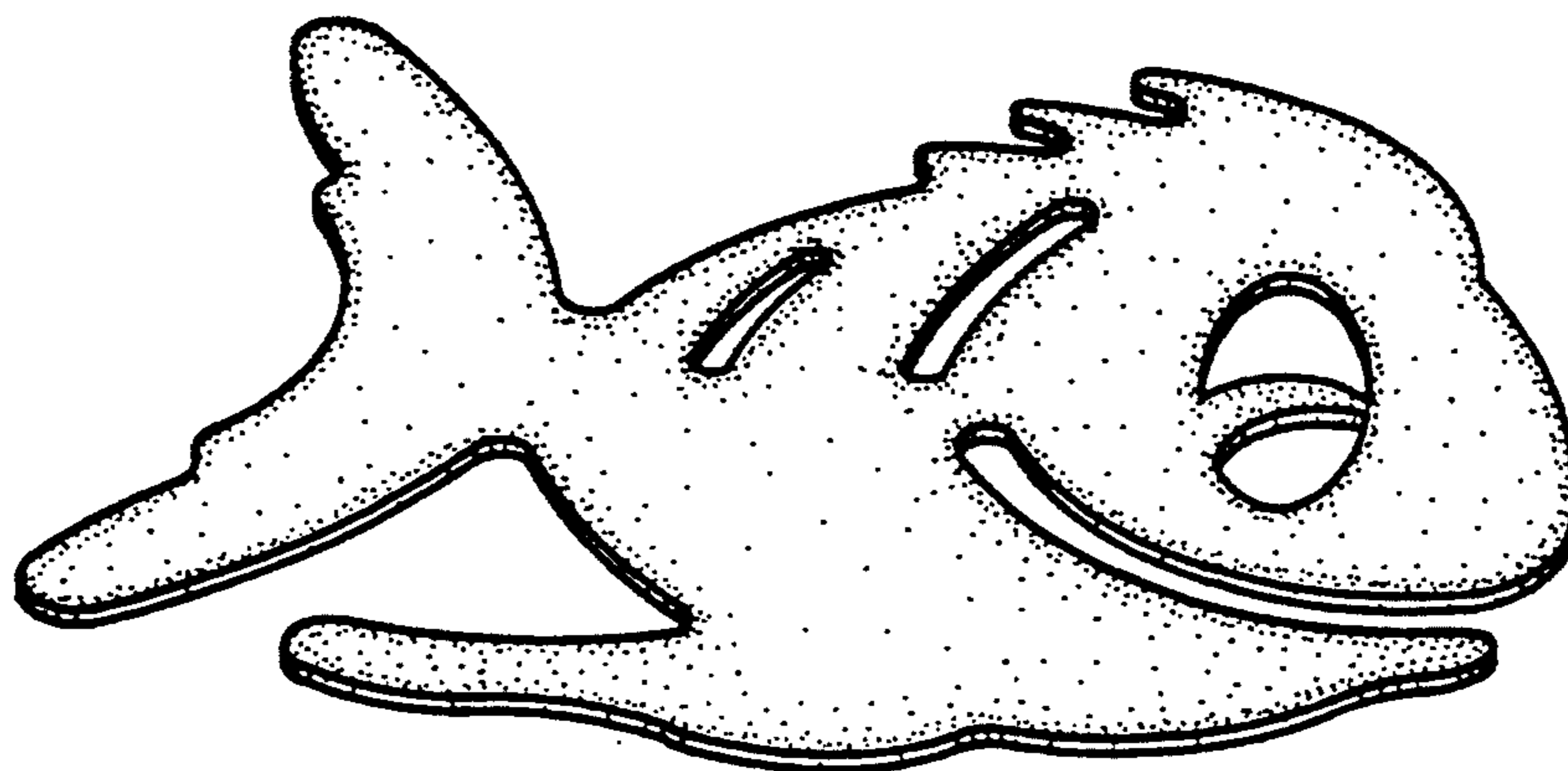

 FIG. 2 is a top plan view thereof, the bottom plan view being a mirror image thereof.



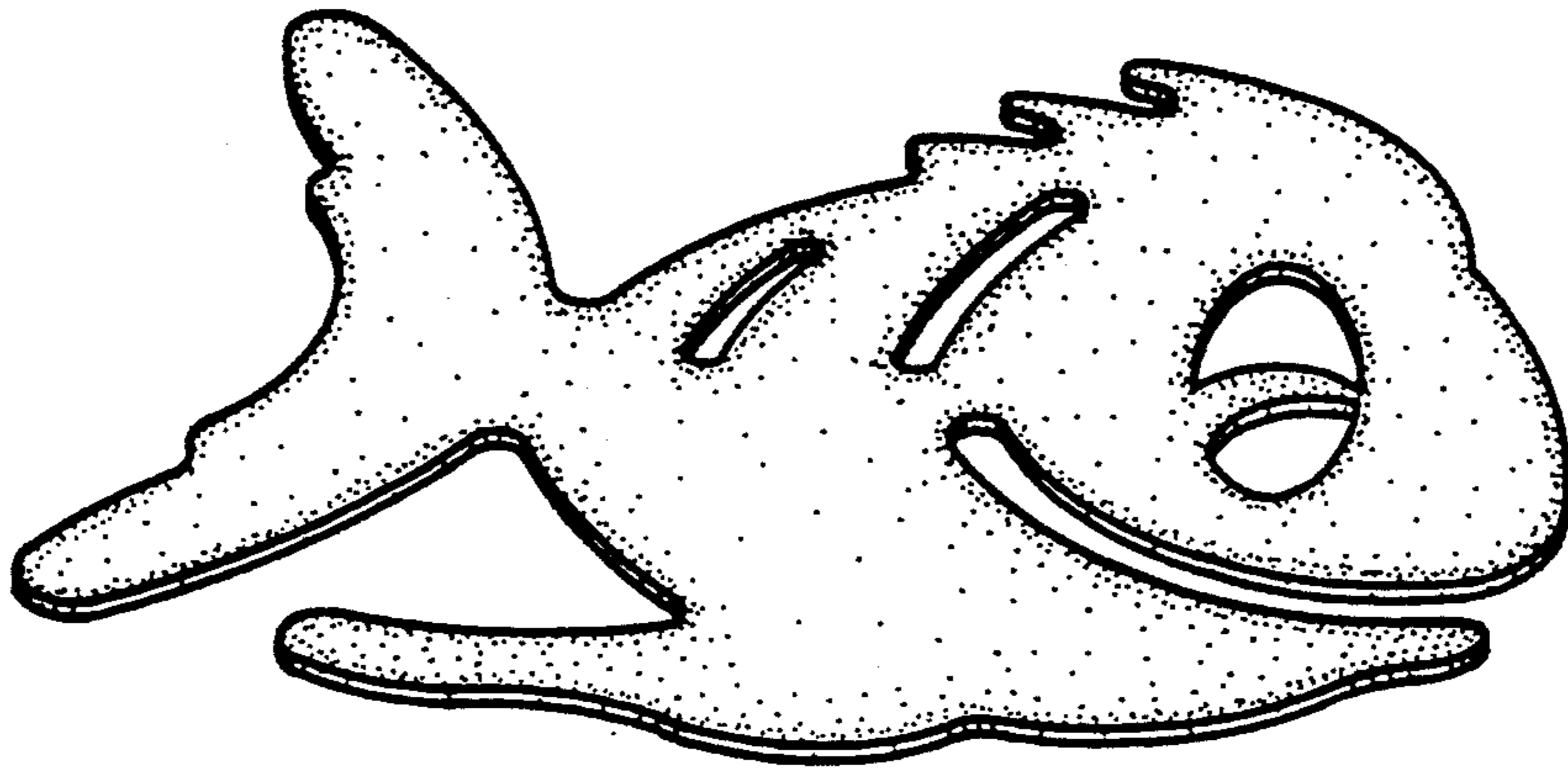

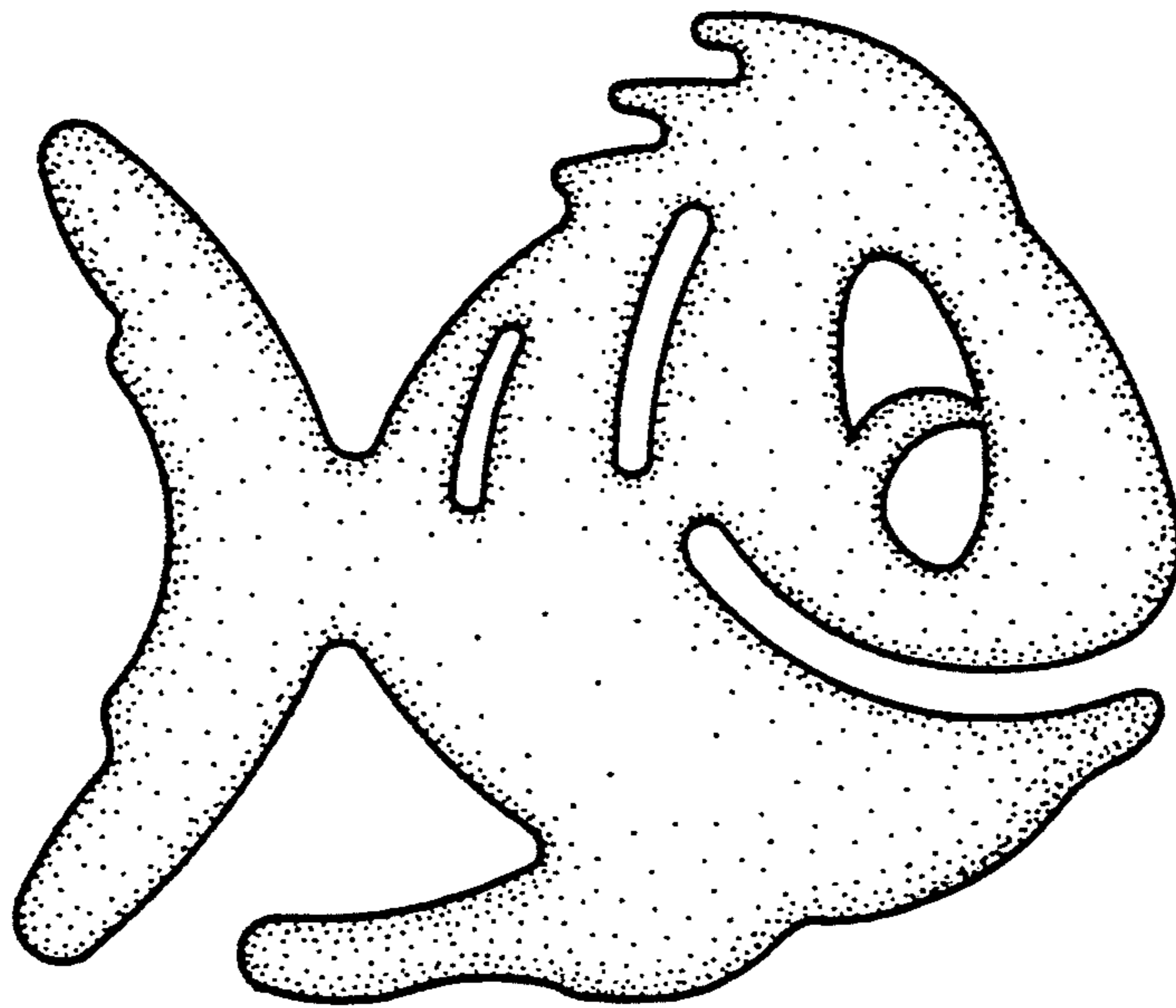
