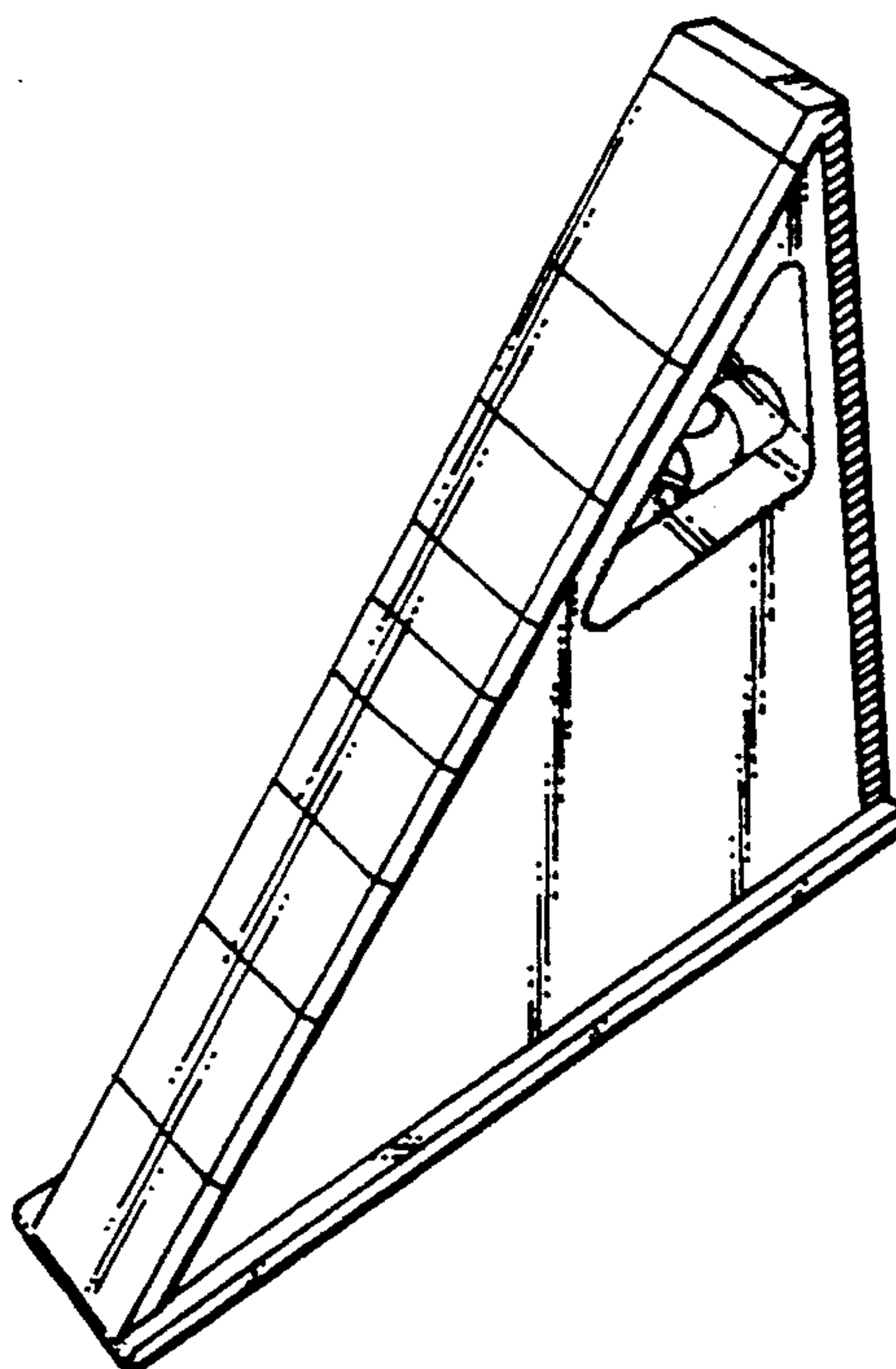

[57] **CLAIM**

The ornamental design for a tape square with level, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a tape square with level showing my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a right side elevational view thereof;
FIG. 5 is a left-side elevational view thereof;
FIG. 6 is a rear elevational view thereof;
FIG. 7 is a bottom plan view thereof;
FIG. 8 is a perspective view of an alternative embodiment of the tape square with level of FIG. 1; and,
FIG. 9 is a front elevational view thereof.
The broken line showing of a pencil is for illustrative purposes only and forms no part of the claimed design.



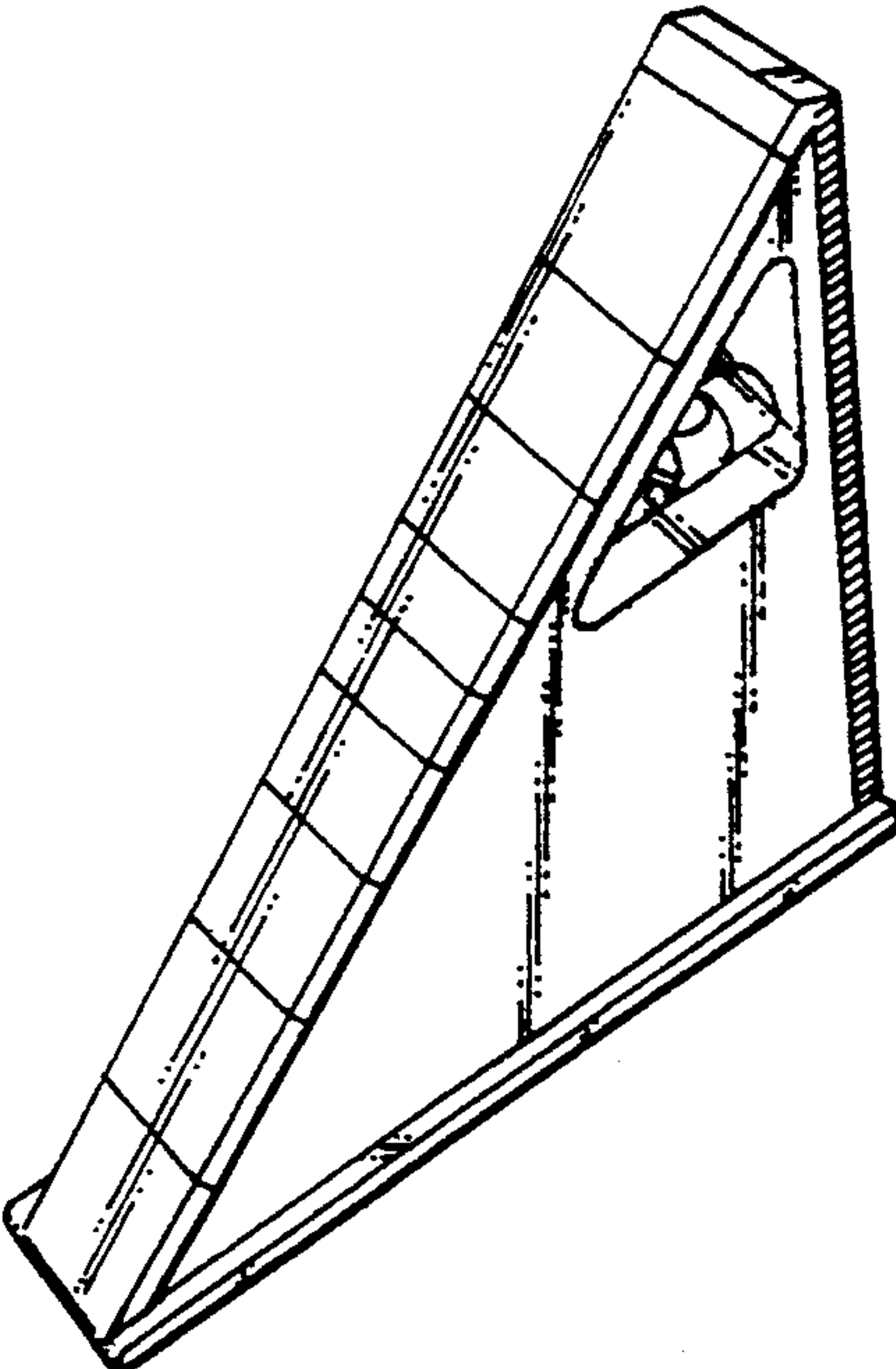

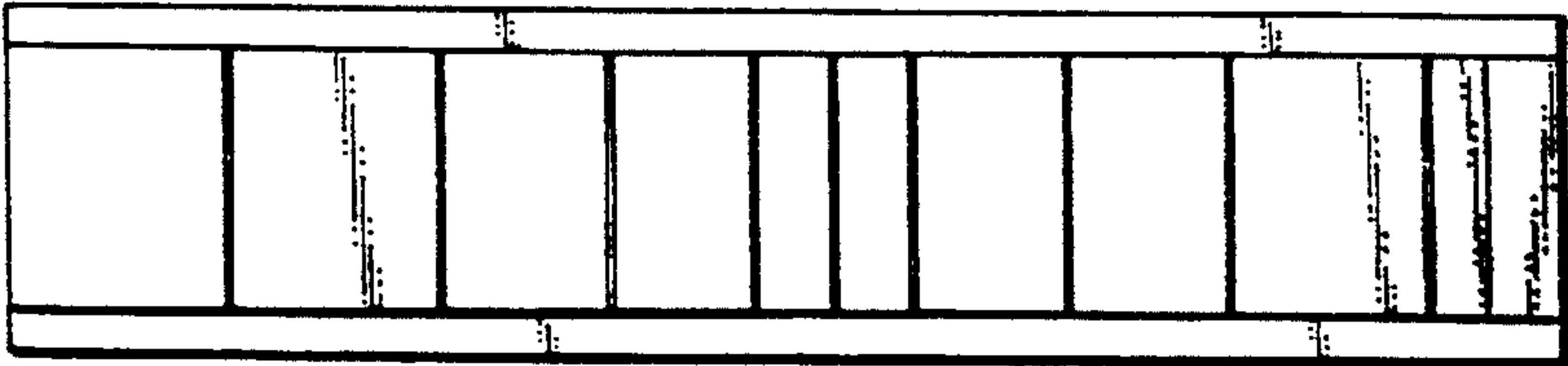

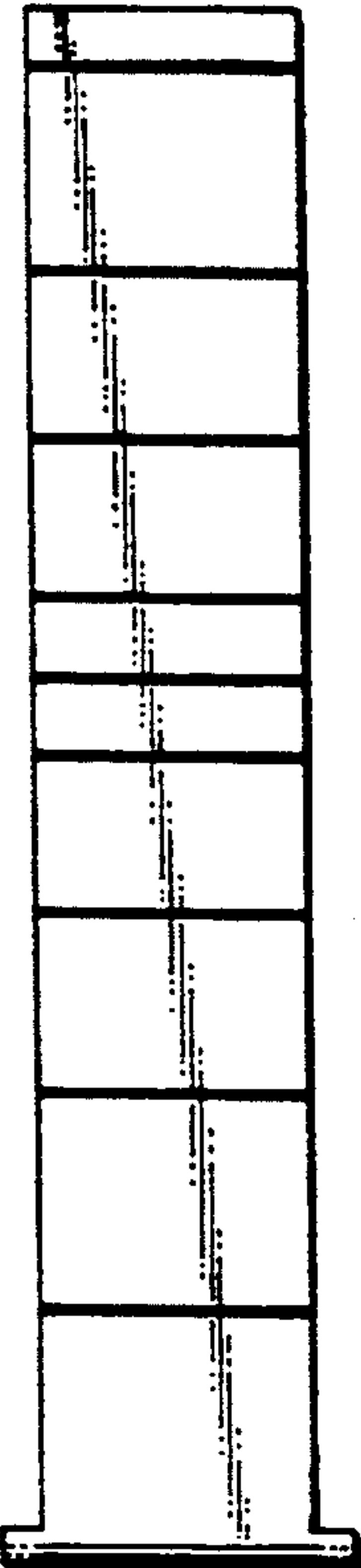

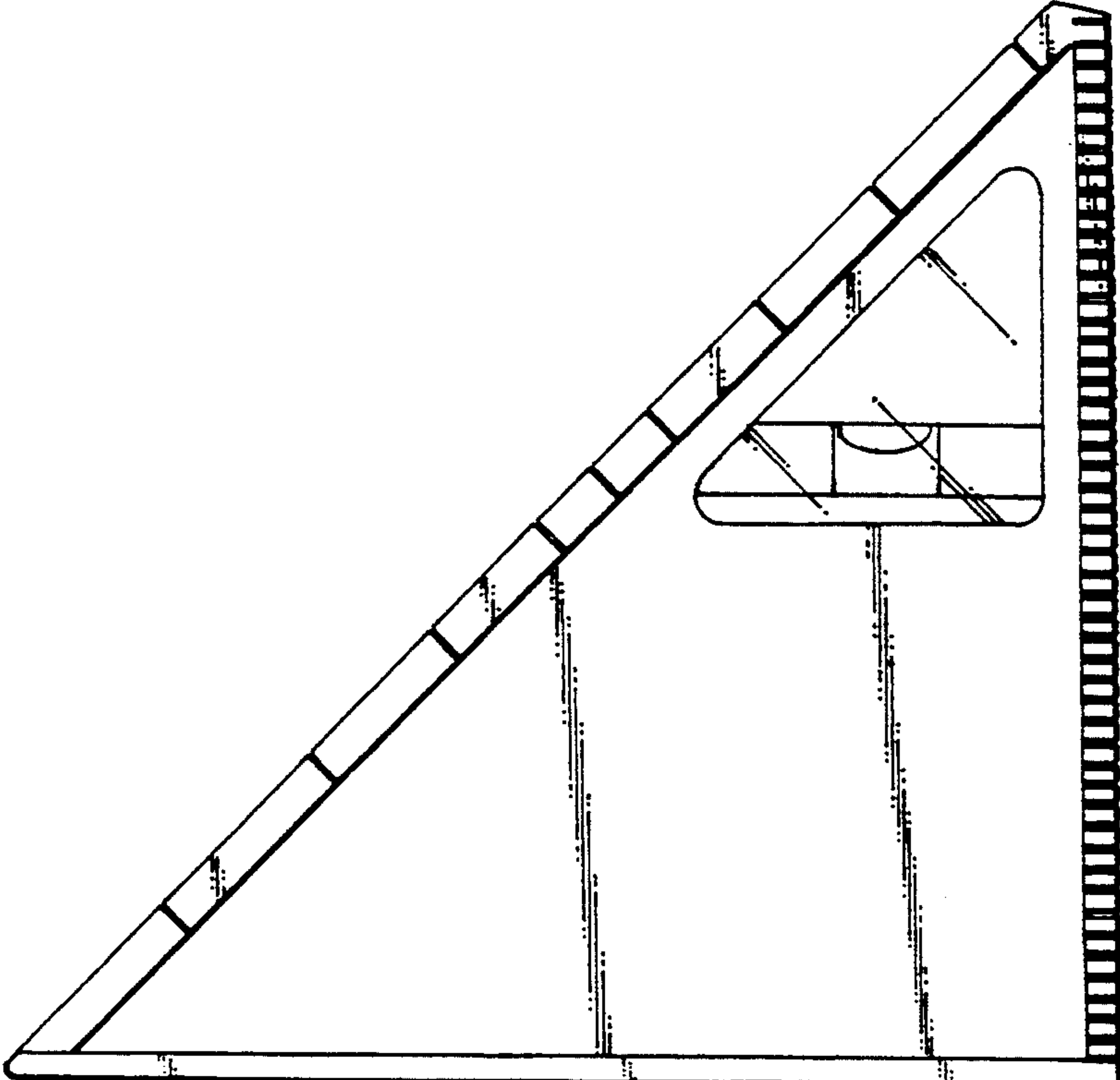

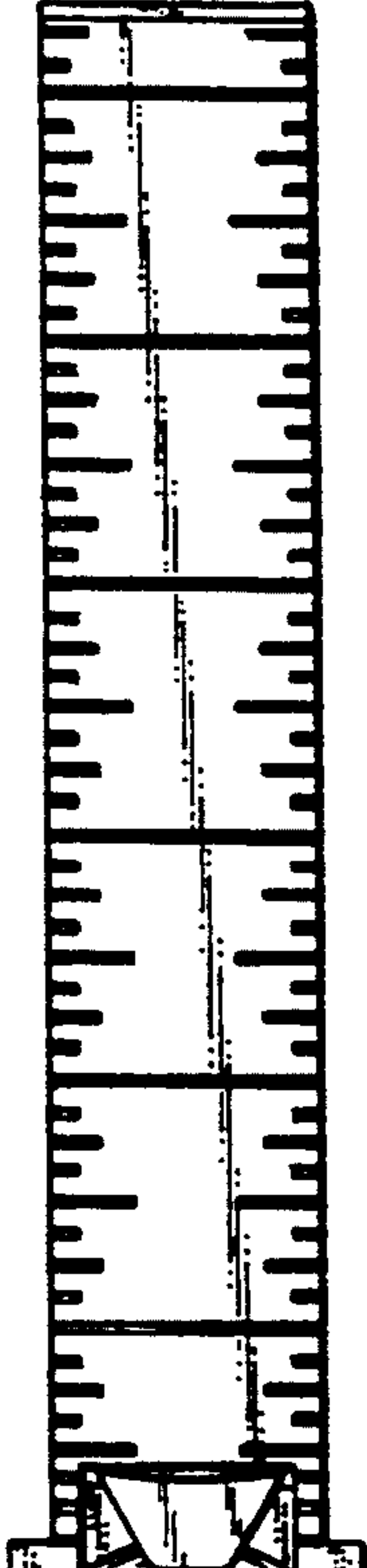

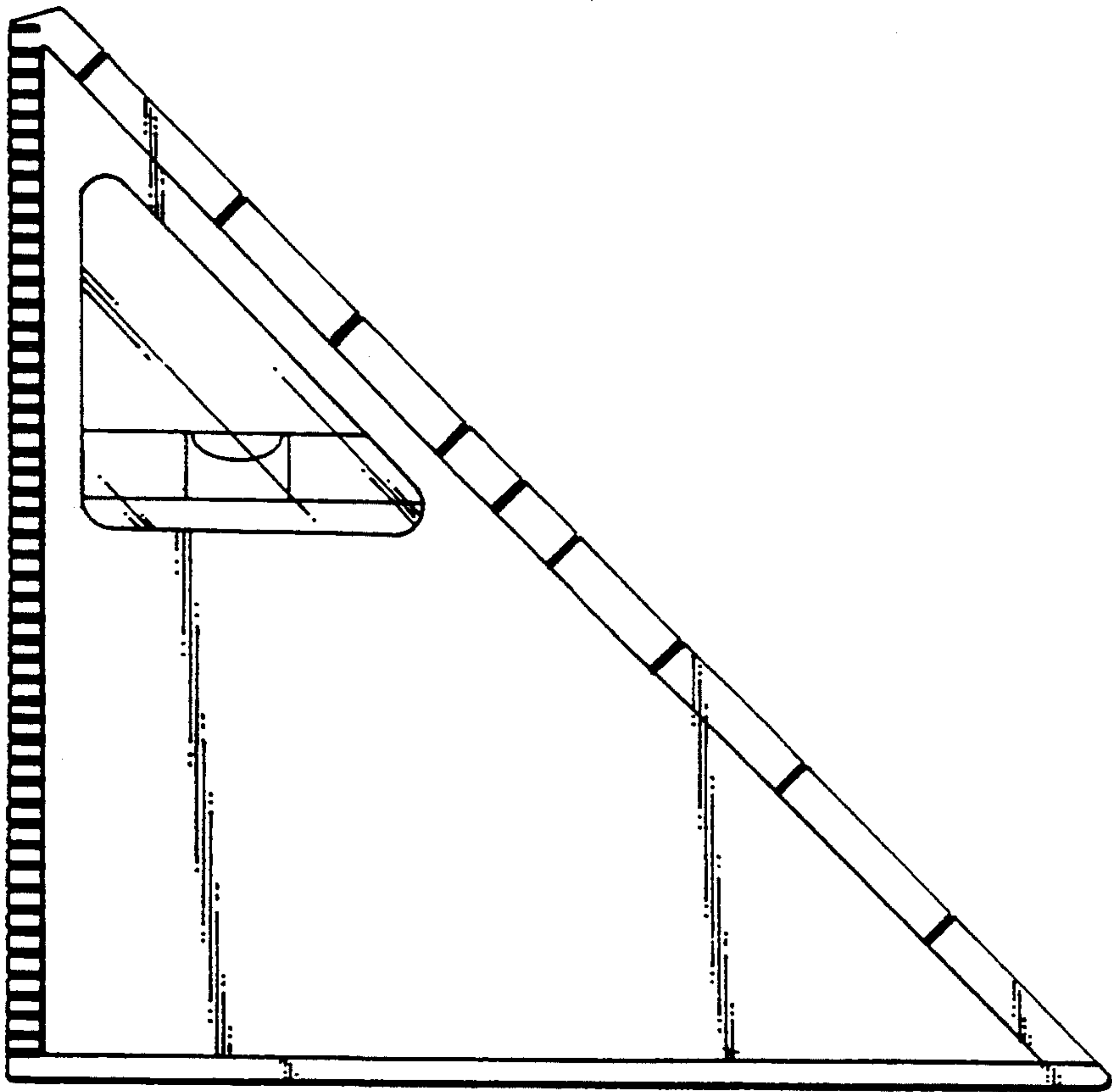

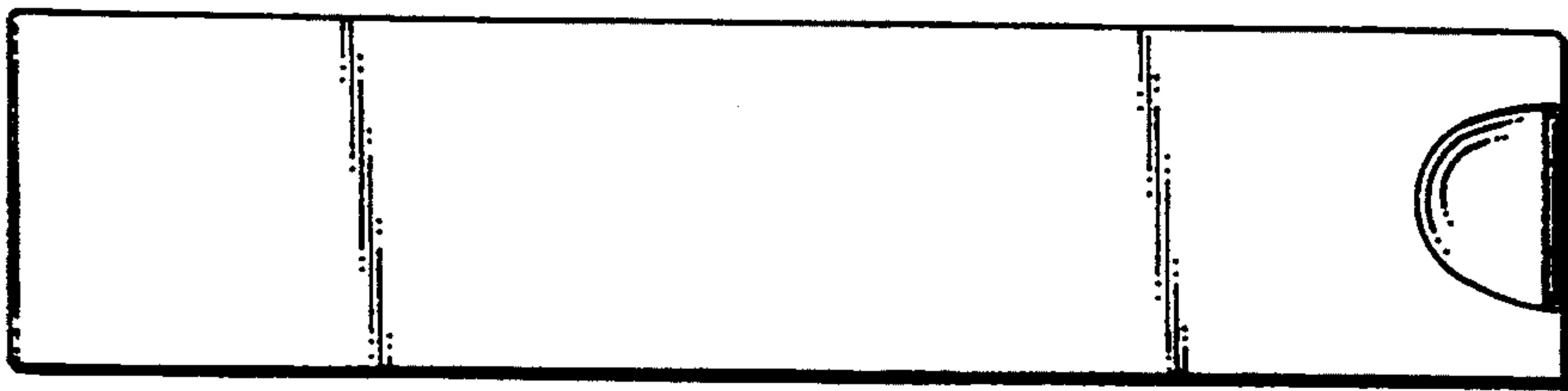

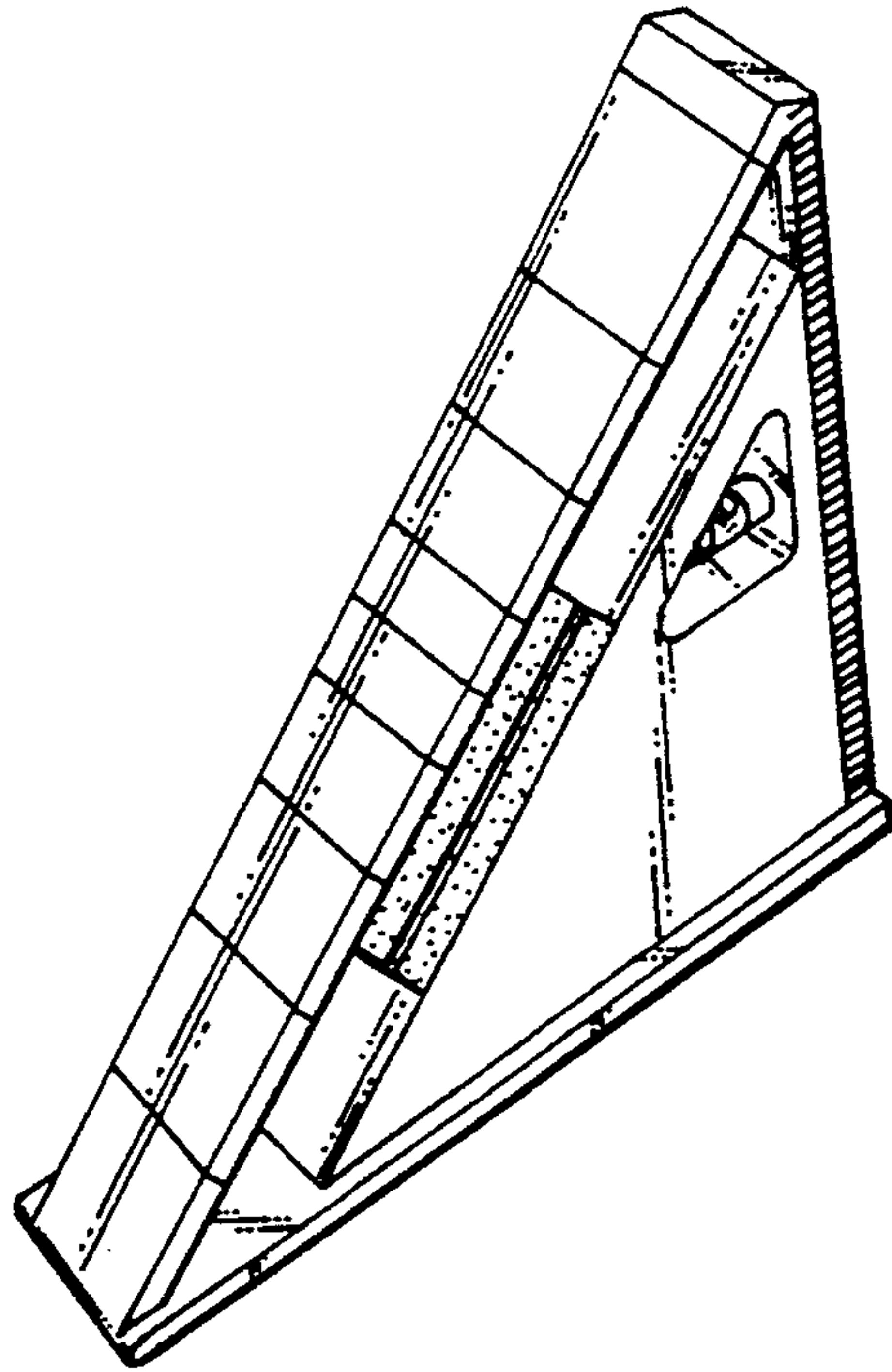

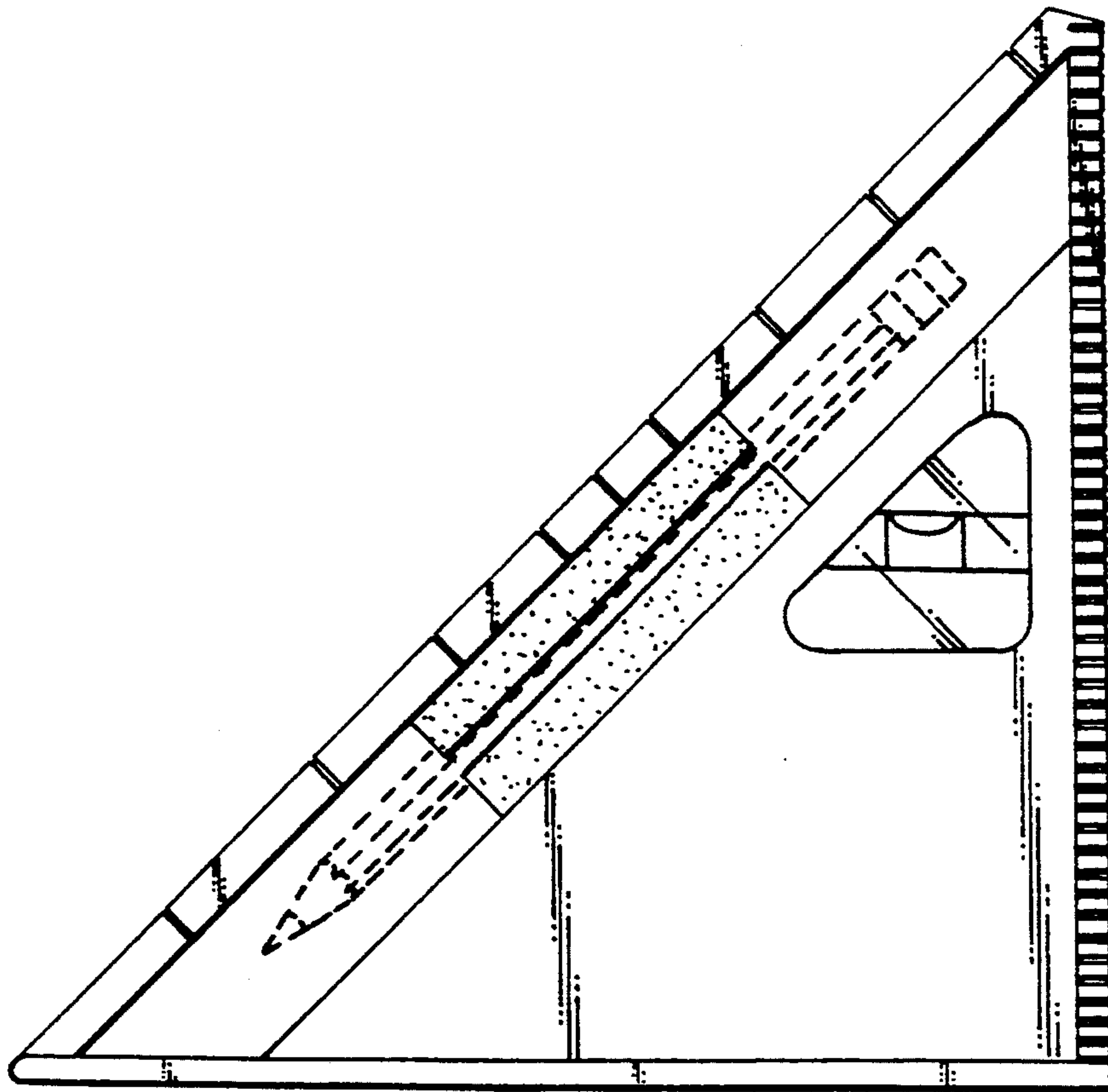
