DESCRIPTION

FIG. 1 is a perspective front, right side and top view of an ultrasonic flaw detector system showing our new design;
FIG. 2 is a front elevational view thereof;

FIG. 4 is a right side view thereof;

FIG. 6 is a rear view thereof;

FIG. 8 is a perspective view thereof, shown in a condition of use.

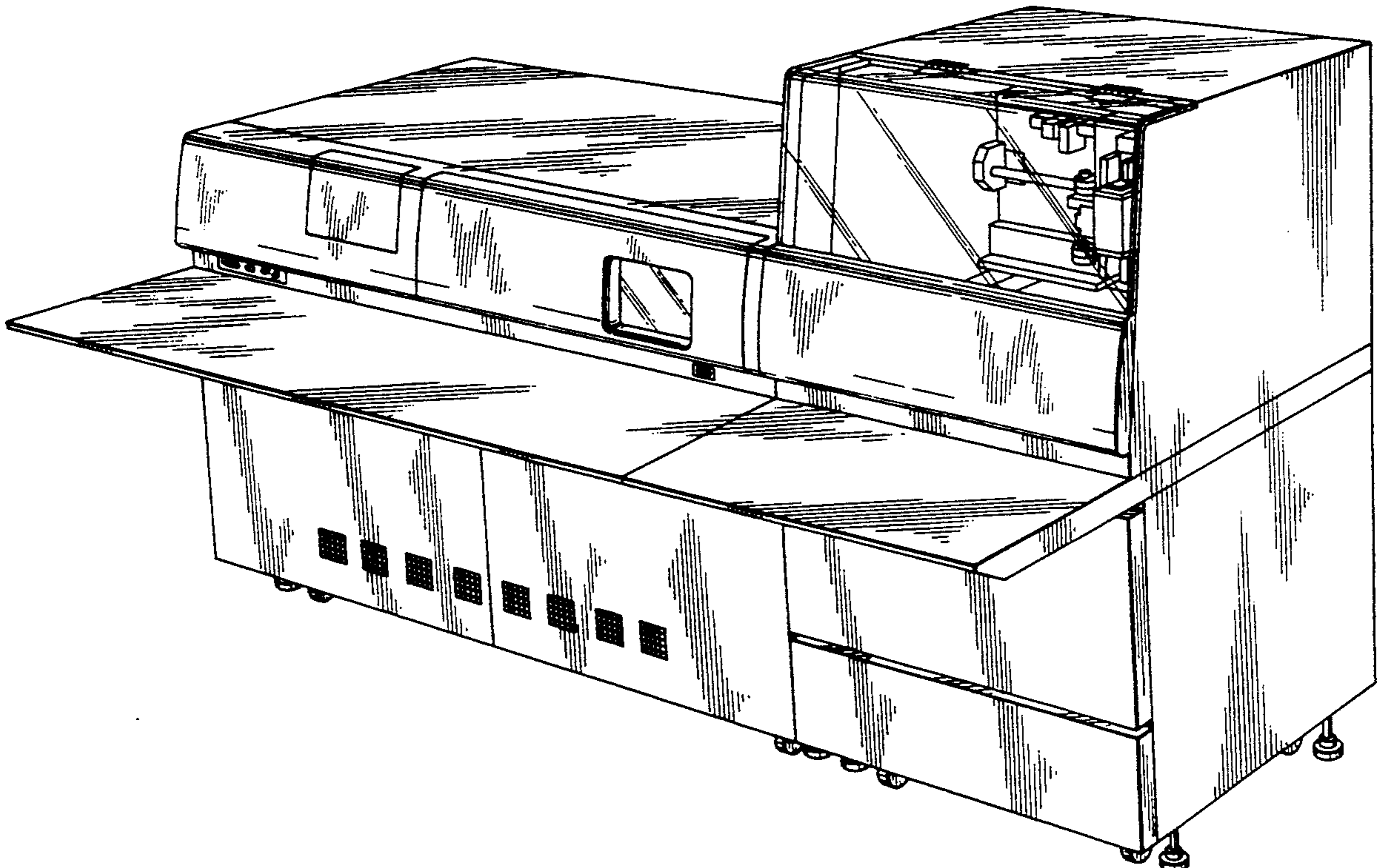

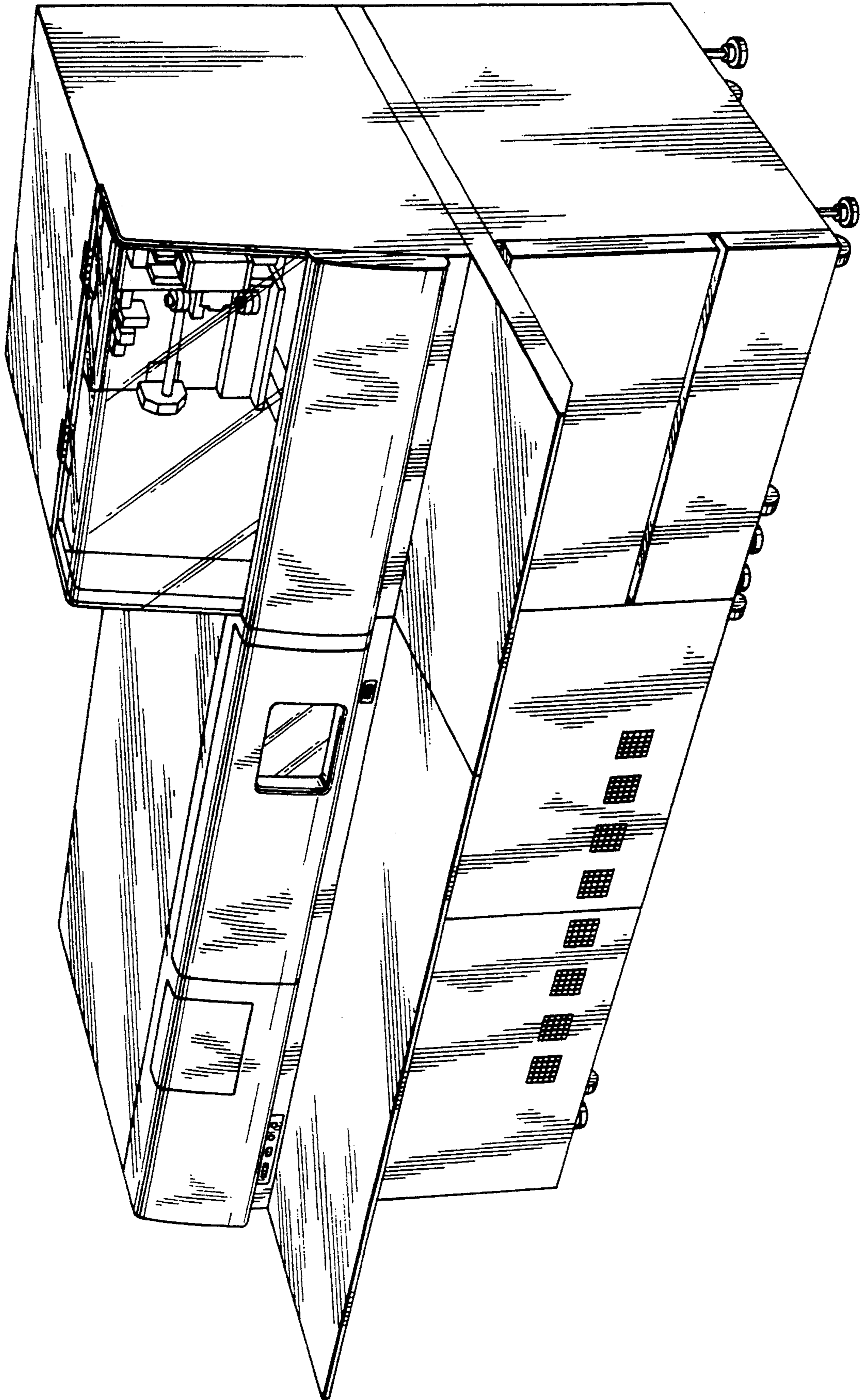

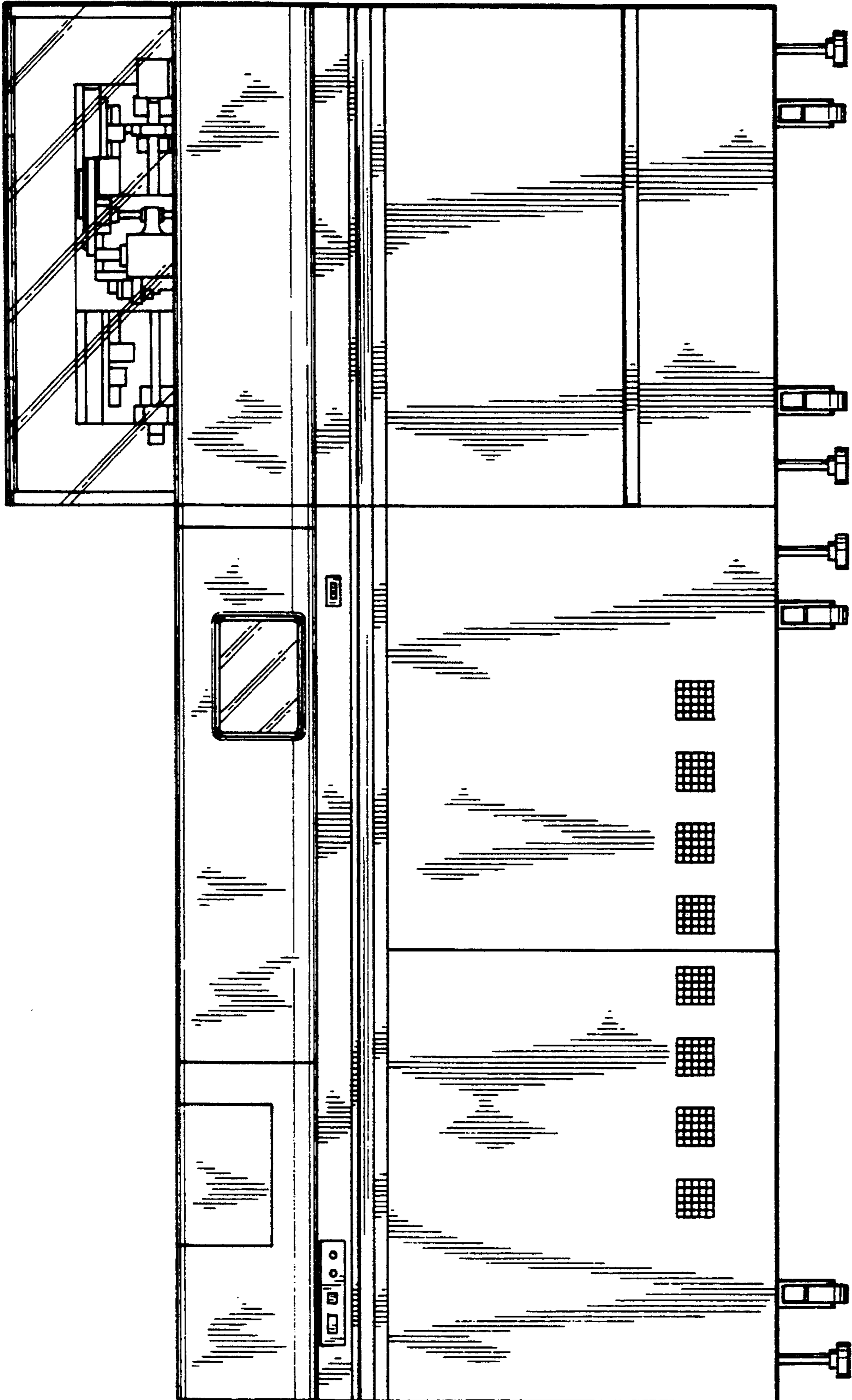

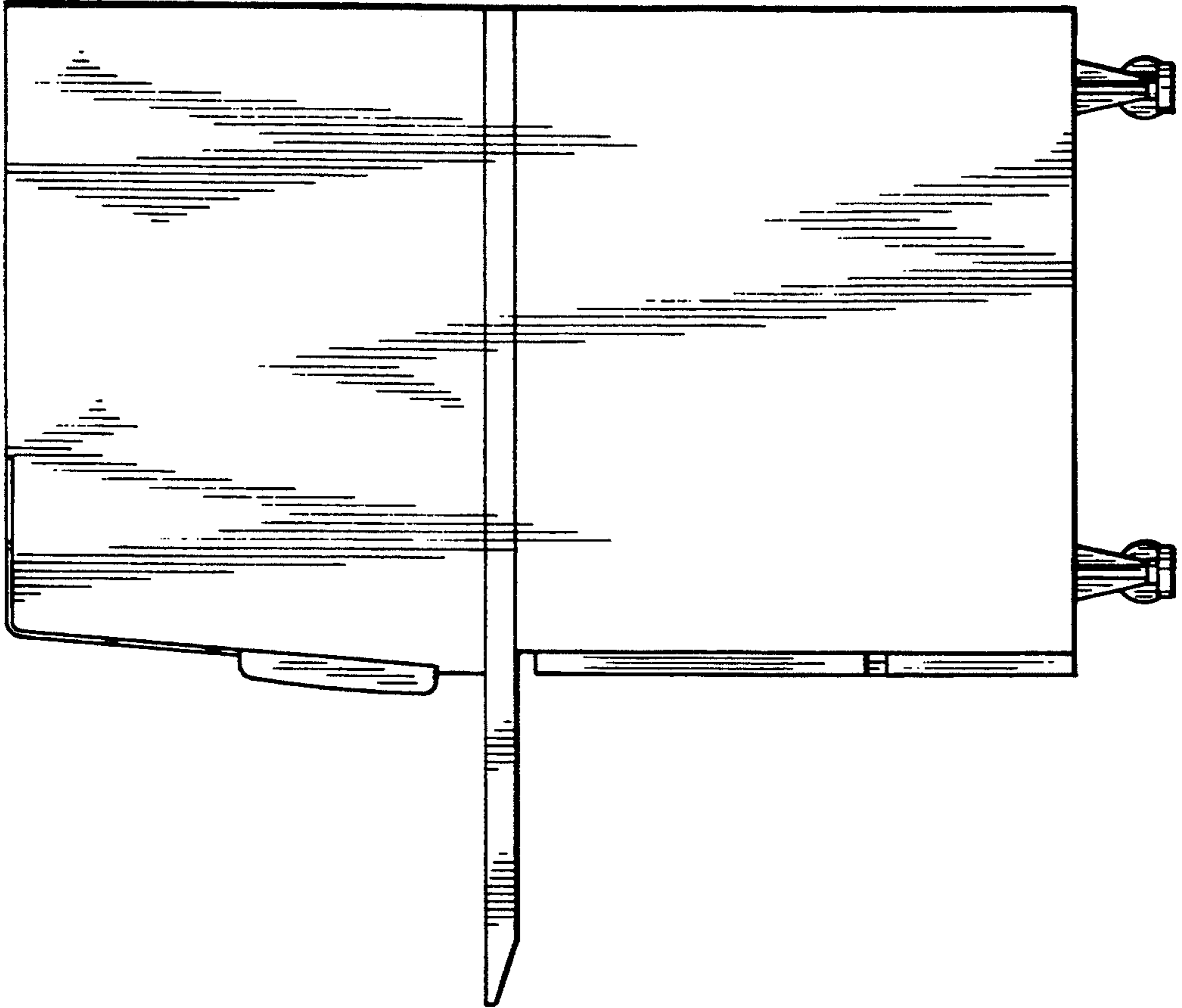

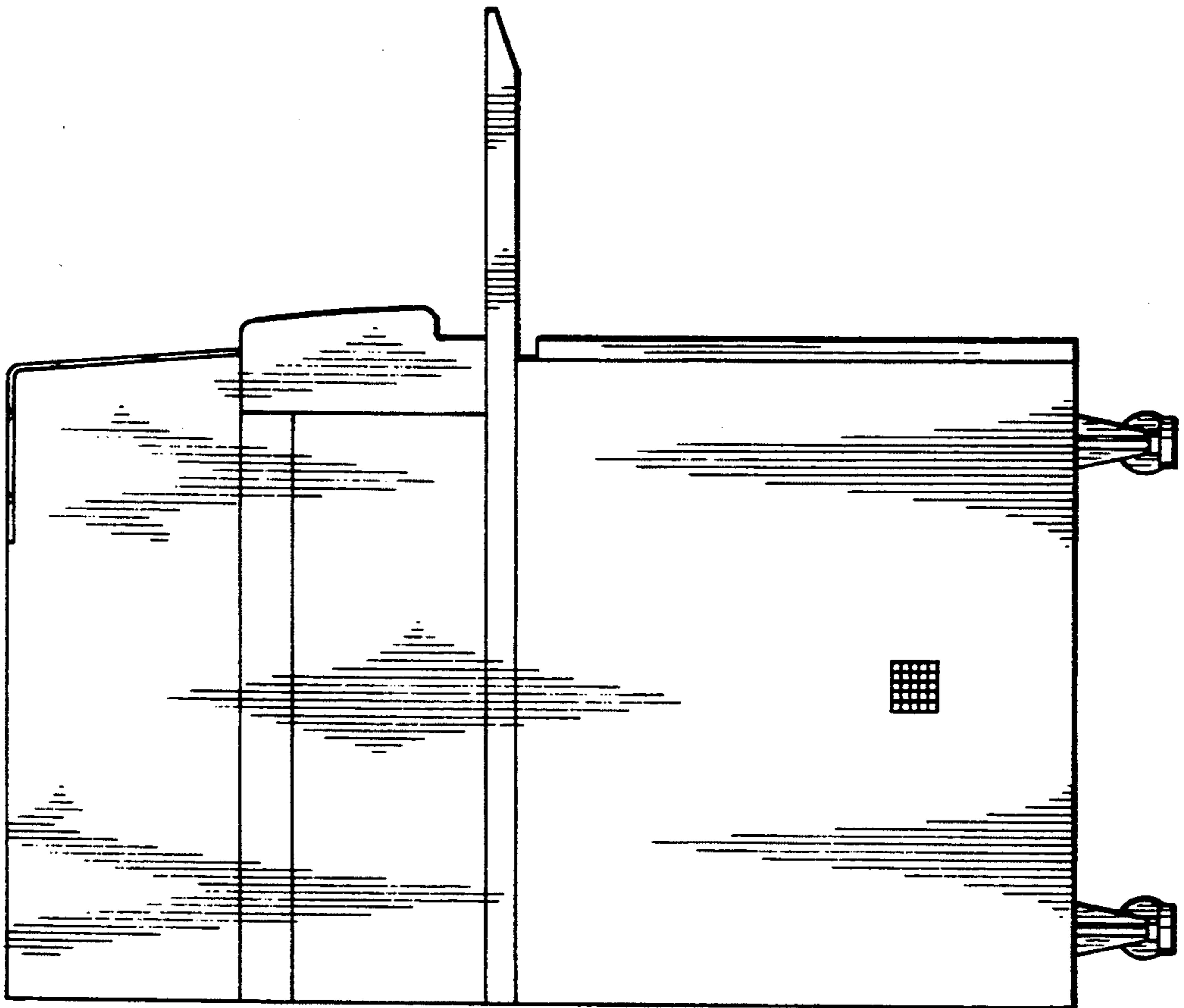

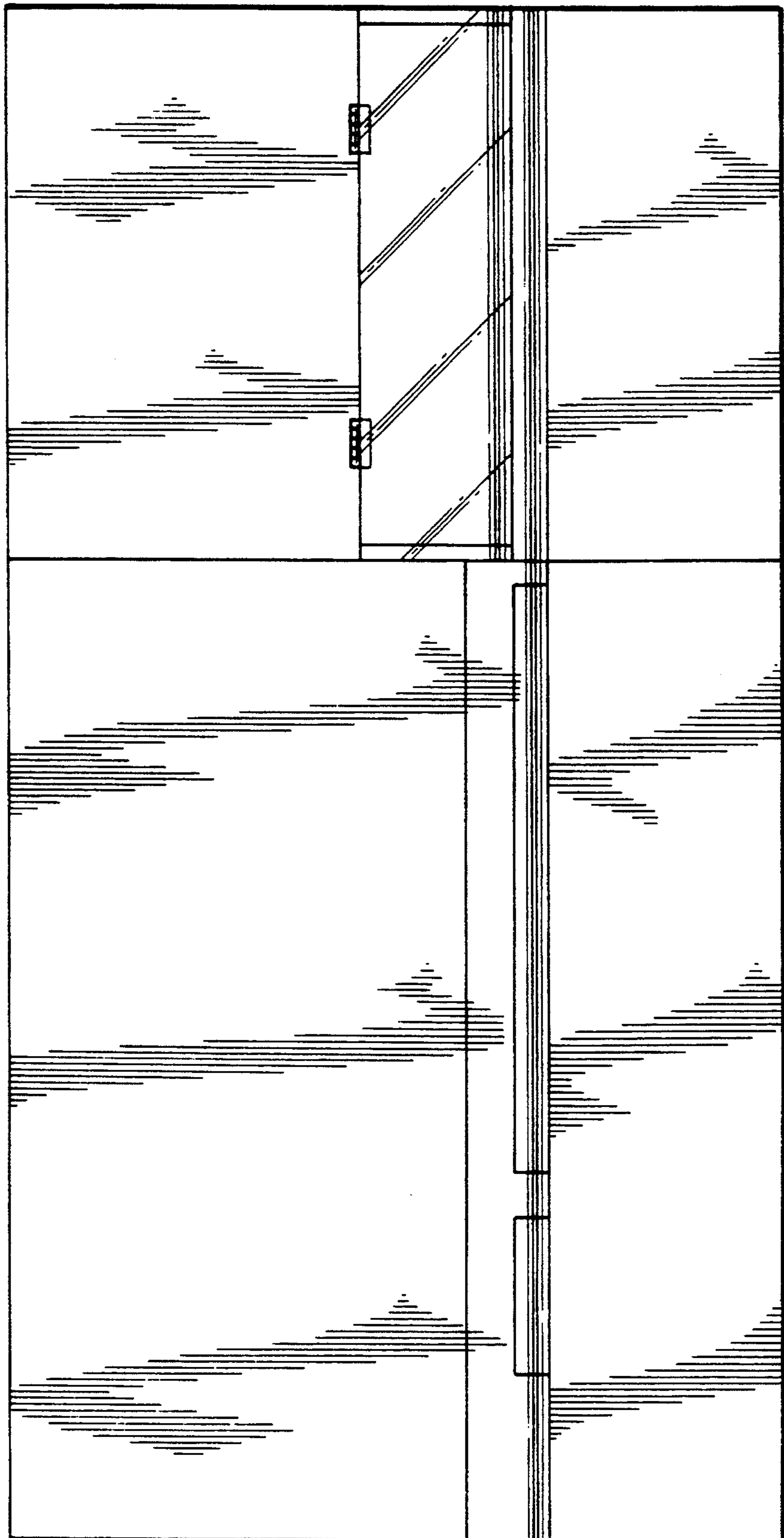

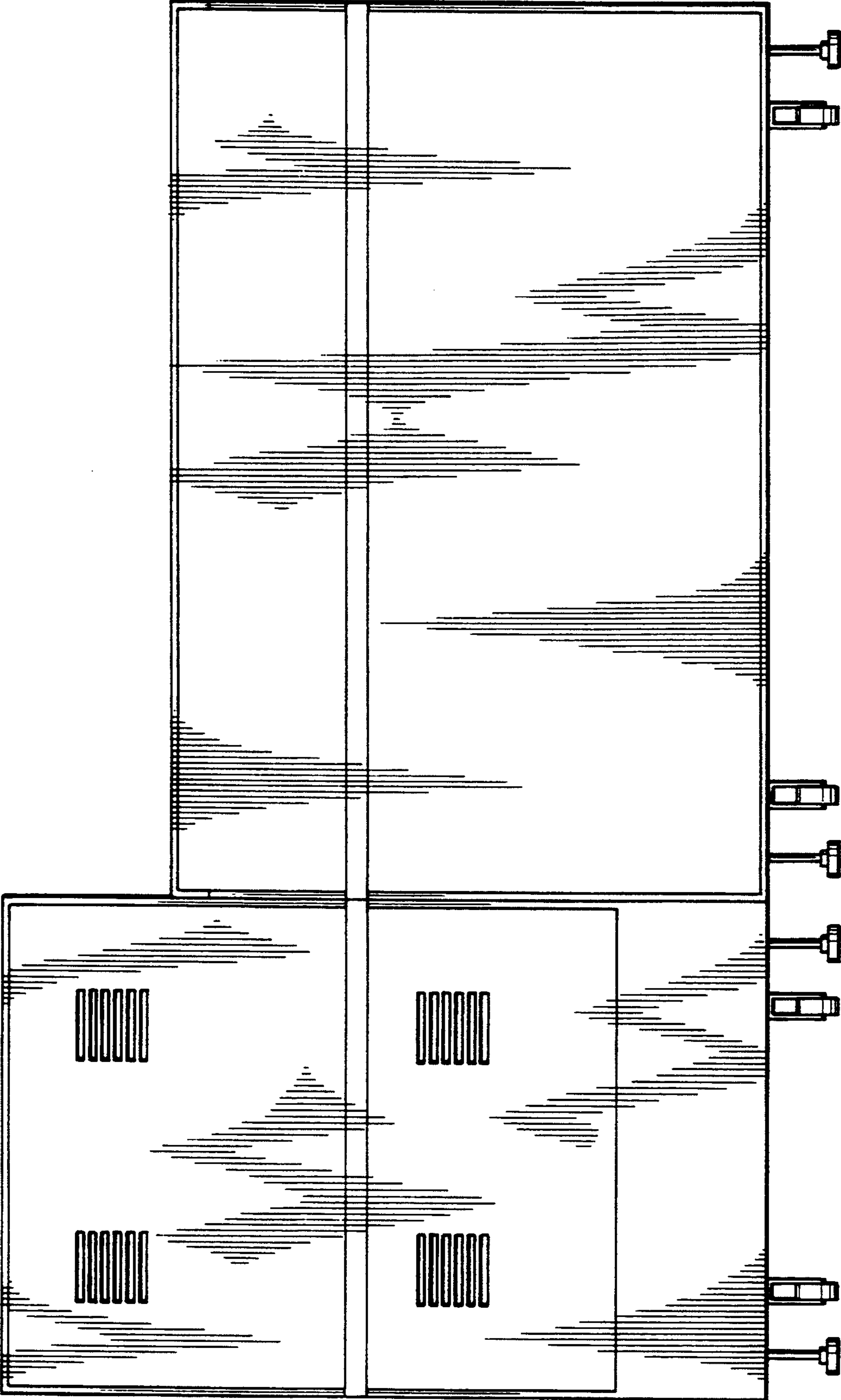
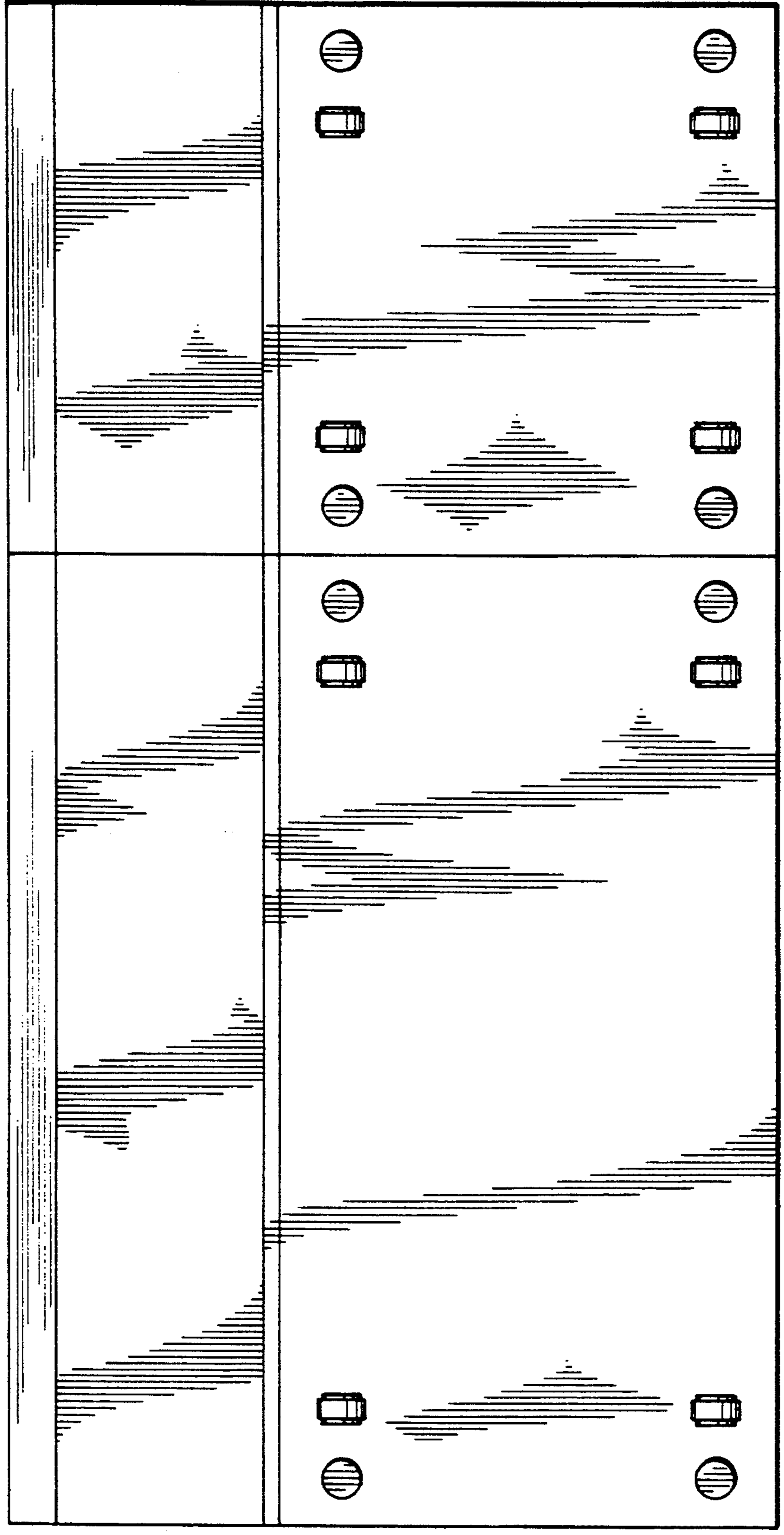

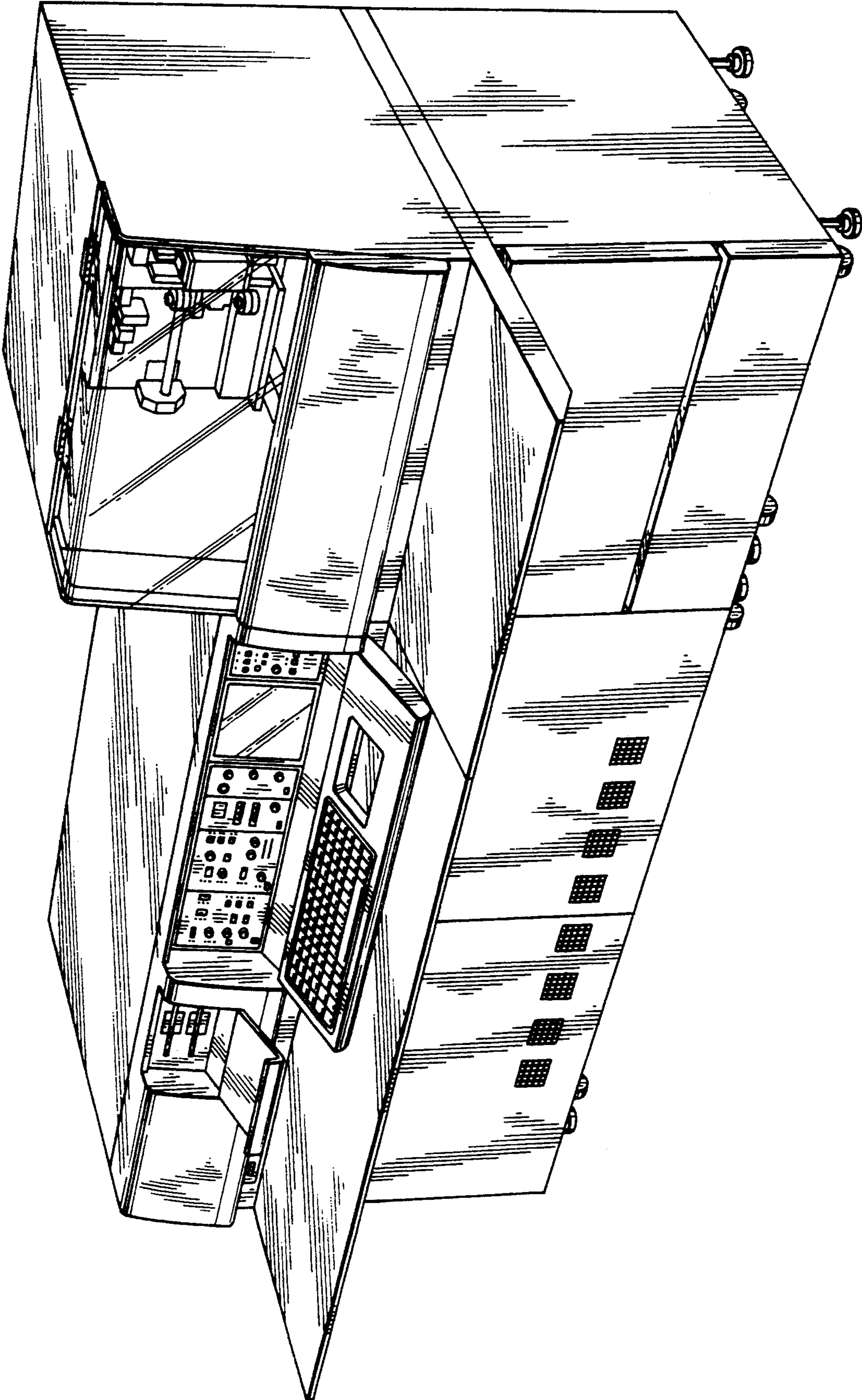
