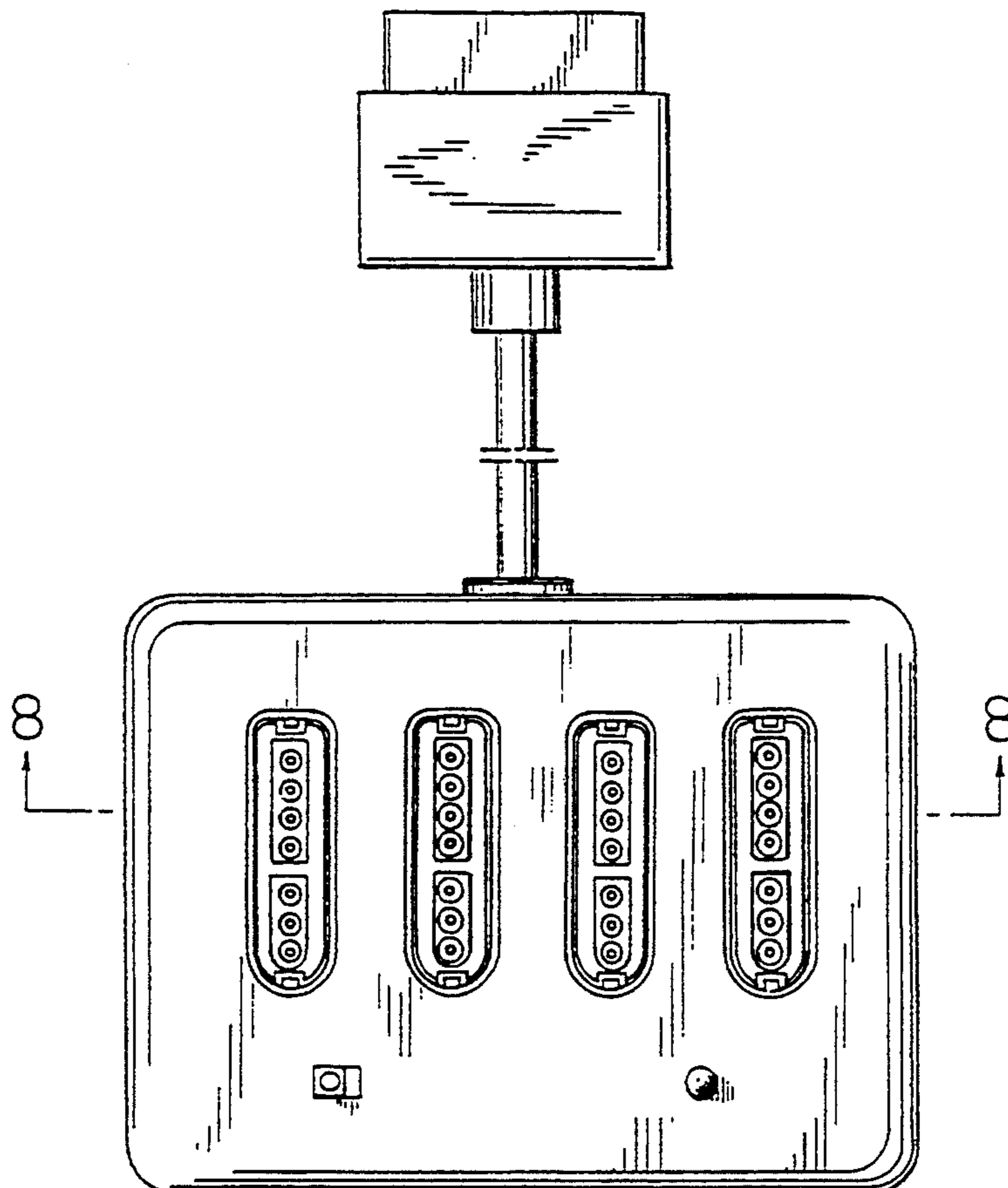

### [57] CLAIM

The ornamental design of a distribution unit for multiple controllers for video games, as shown and described.

### DESCRIPTION

FIG. 1 is a top view of the distribution unit for multiple controllers for video games embodying my new design; FIG. 2 is a bottom view thereof; FIG. 3 is a front view thereof; FIG. 4 is a rear view thereof; FIG. 5 is a right side view thereof; FIG. 6 is a left side view thereof; FIG. 7 is a sectional view of the distribution unit as taken along line 7—7 of FIG. 3, but with the internal structures eliminated for purposes of illustration; FIG. 8 is a sectional view of the distribution unit as taken along line 8—8 of FIG. 1, but with the internal structures eliminated for purposes of illustration; and, FIG. 9 is a perspective view thereof. The broken line showing of hand held controllers, video game control and conduits in FIG. 9 is for illustrative purpose only and forms no part of the claim.



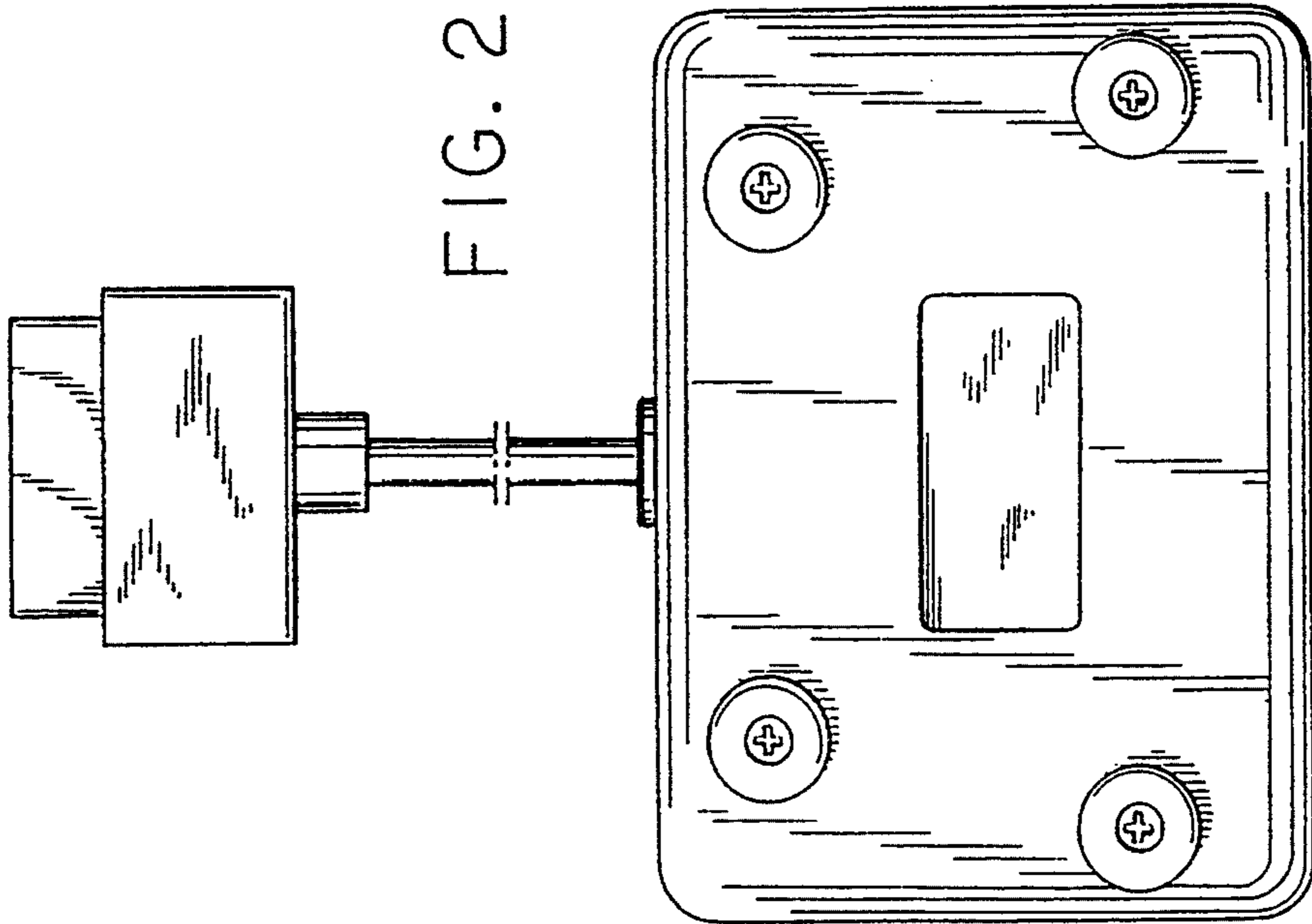

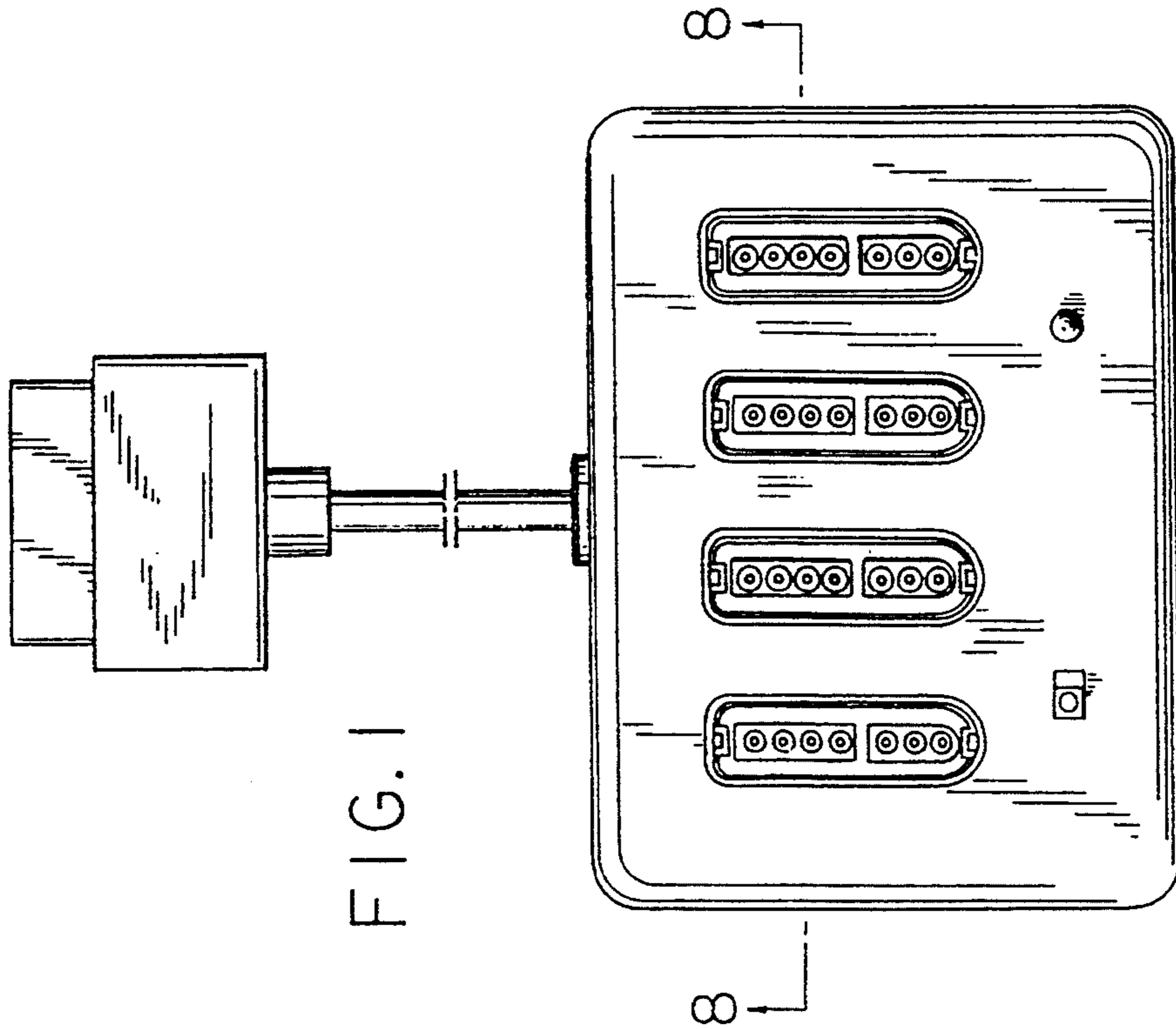

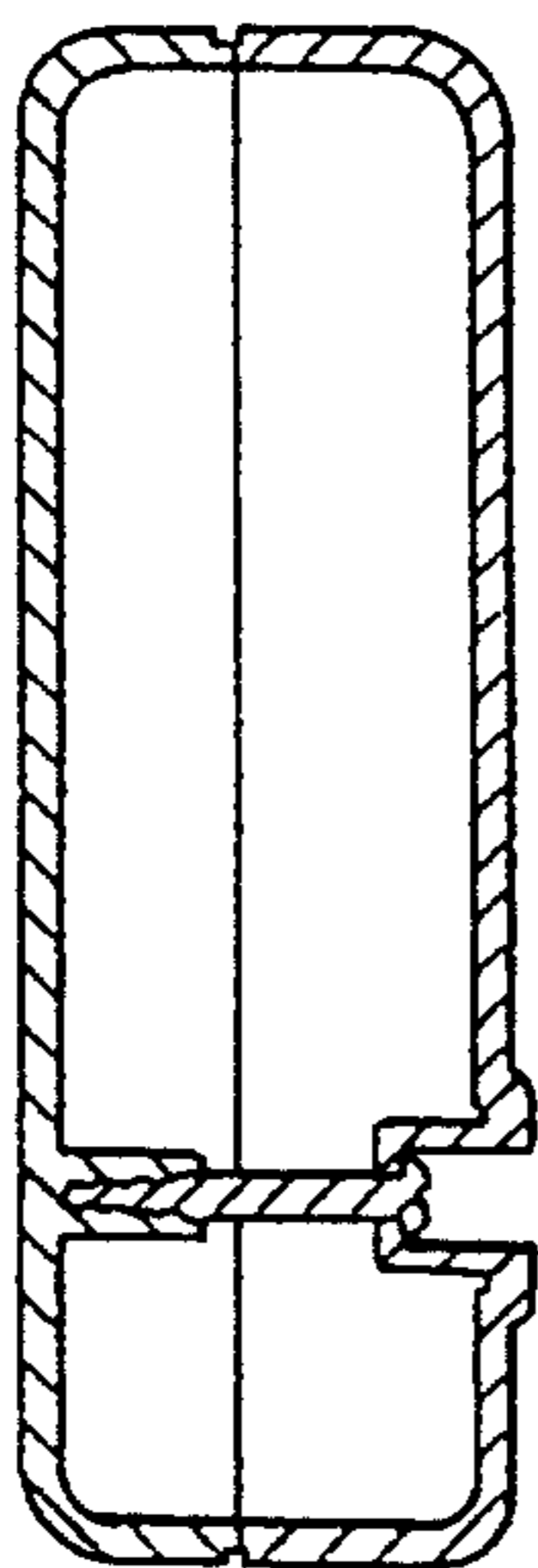

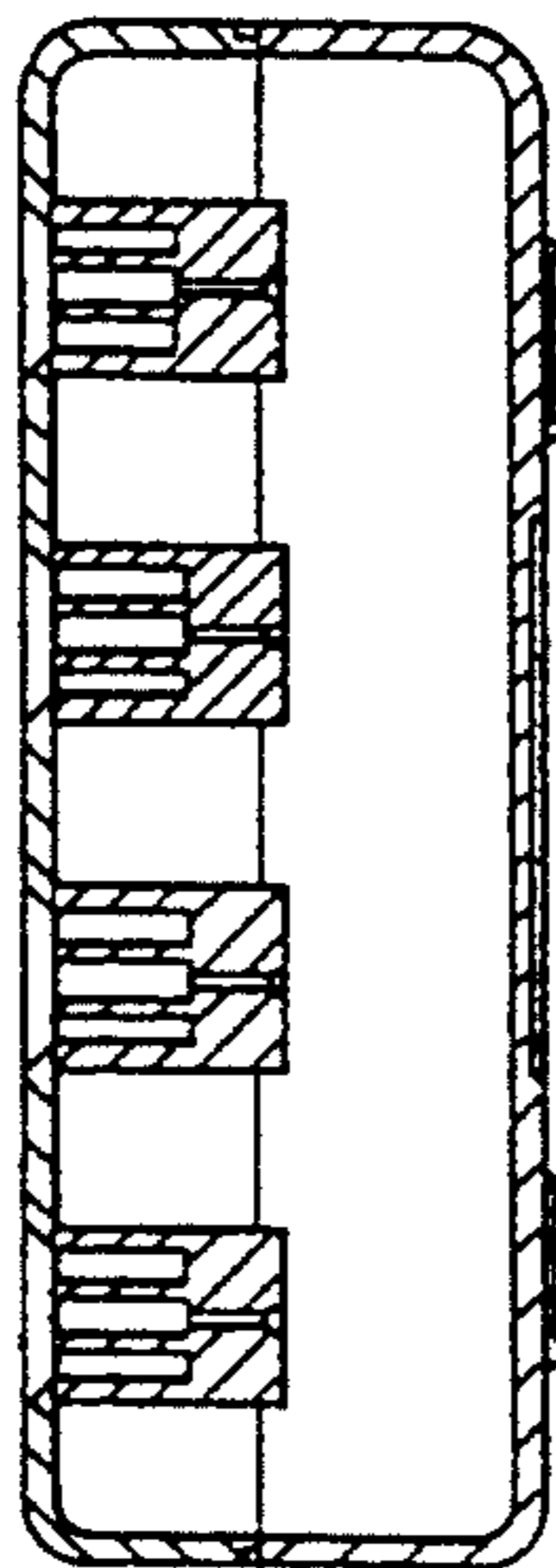

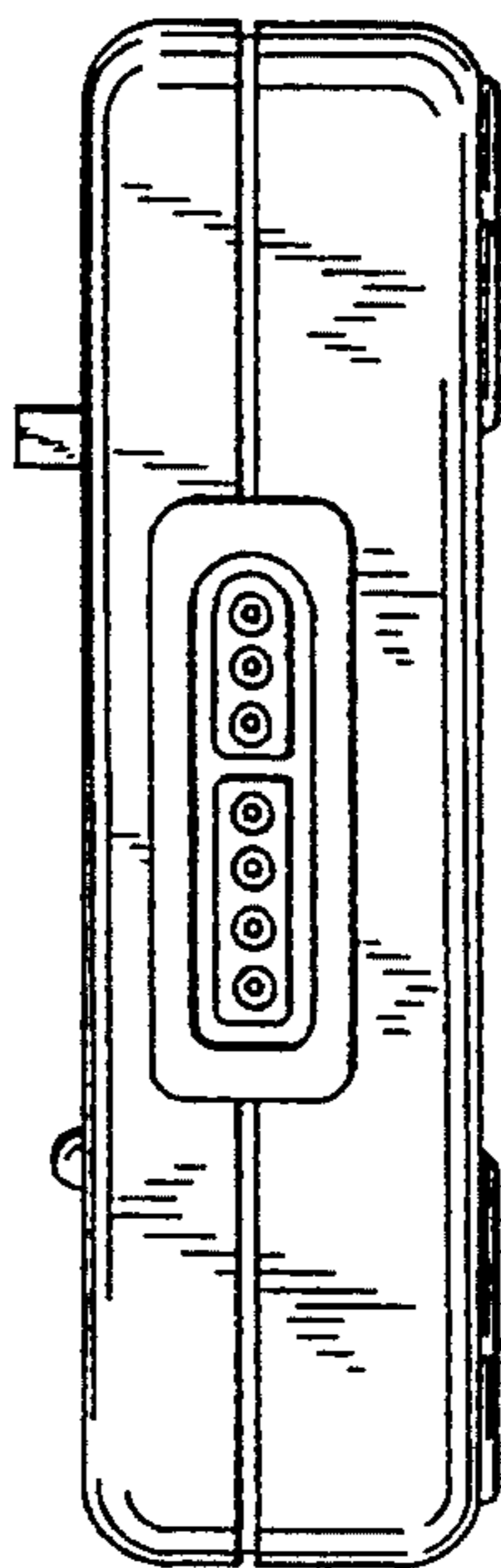

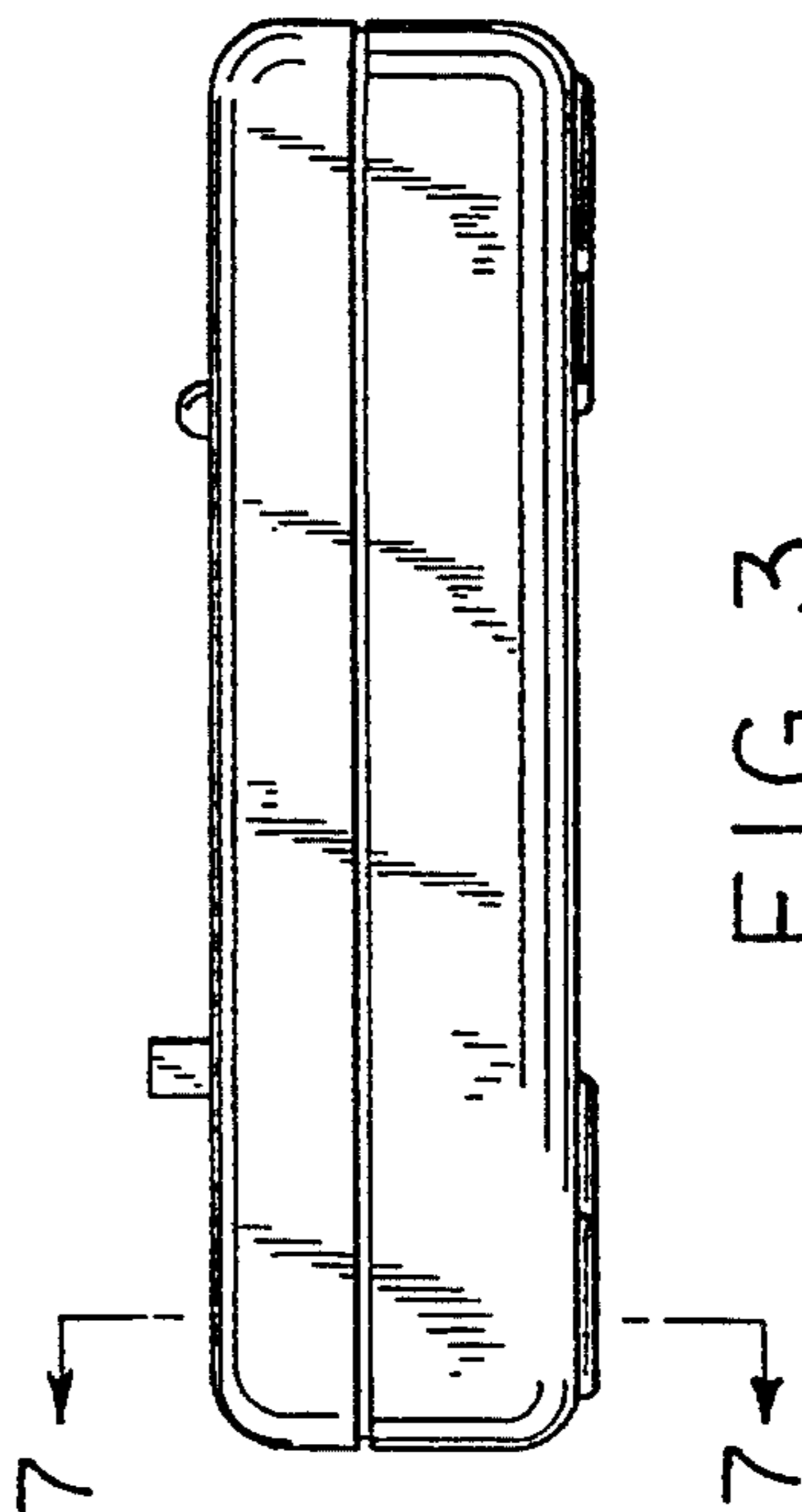

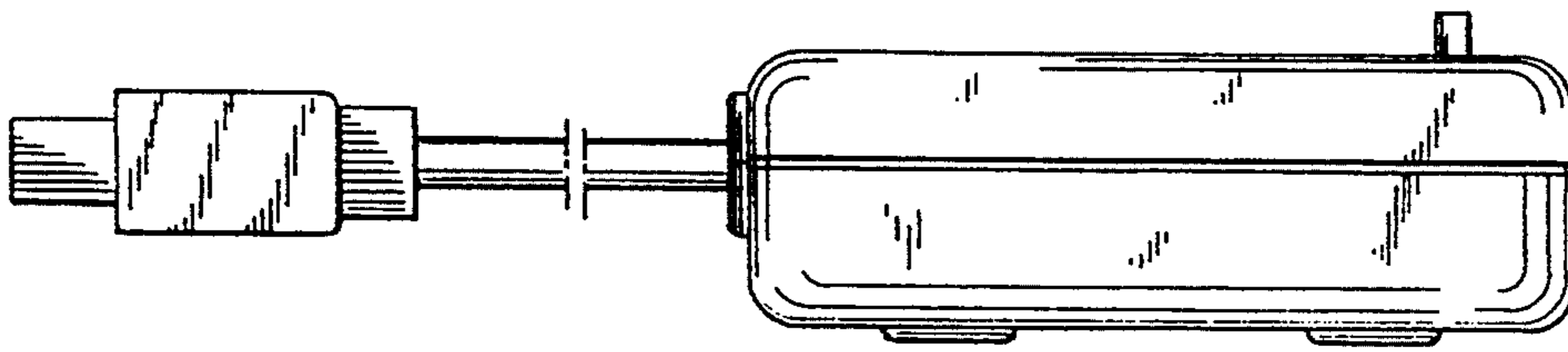

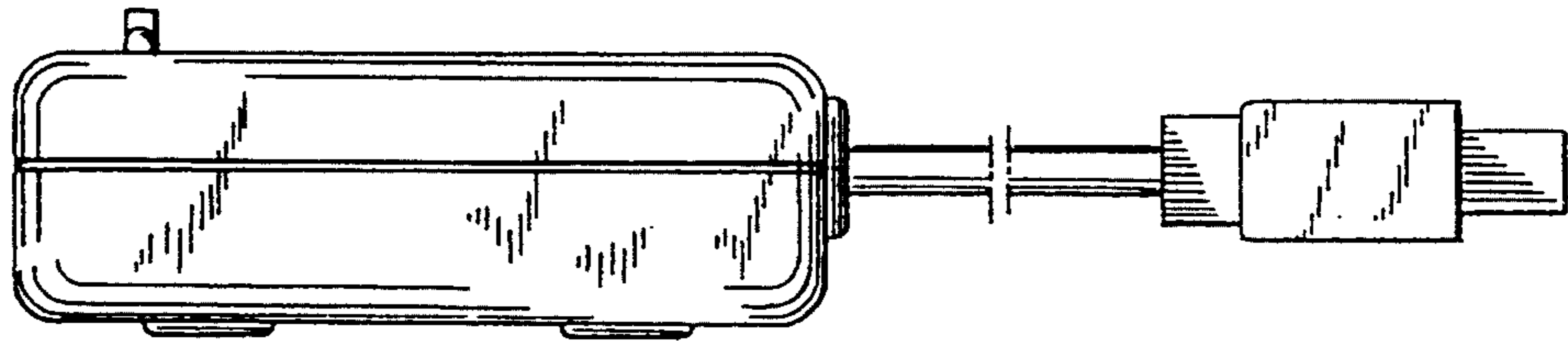

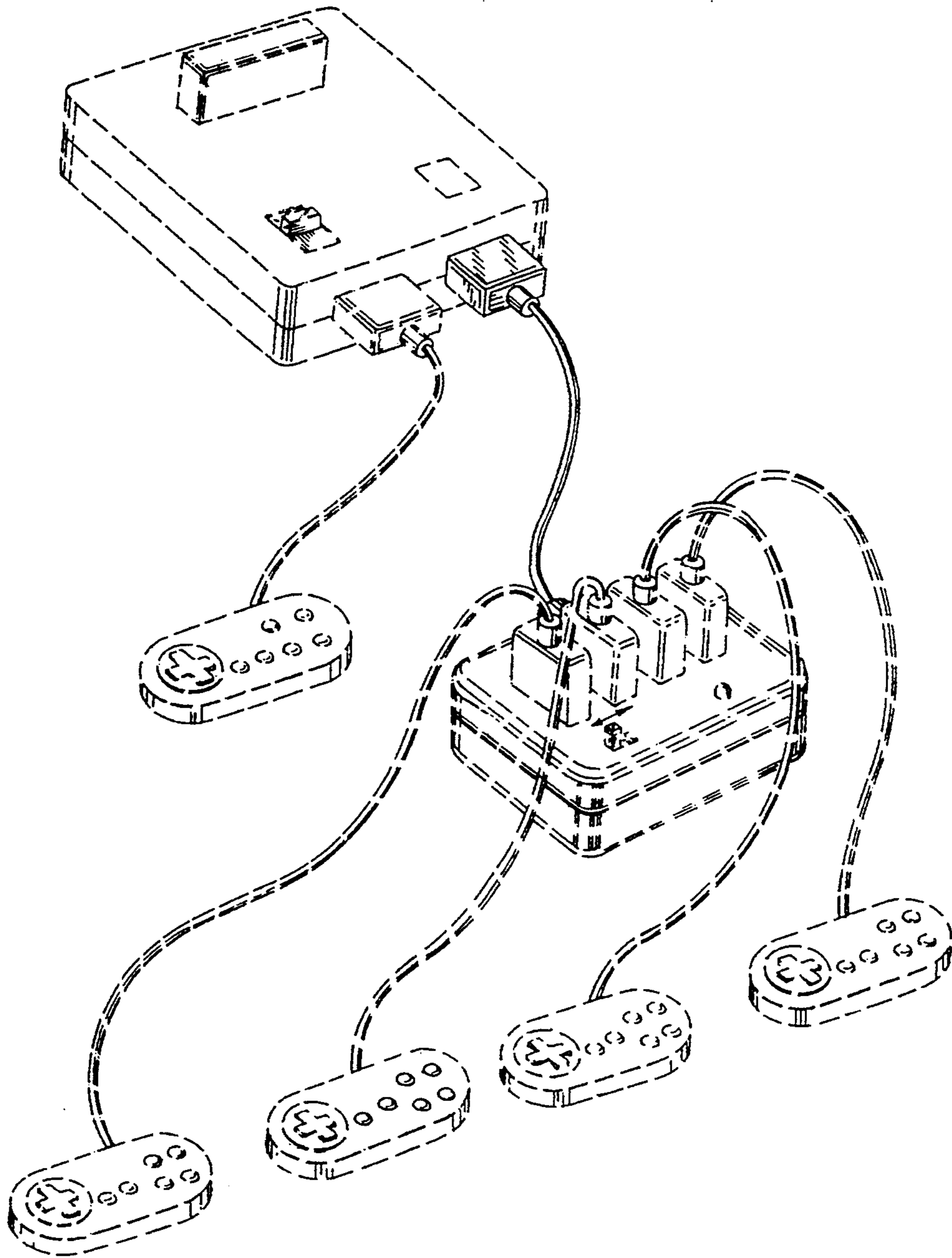
