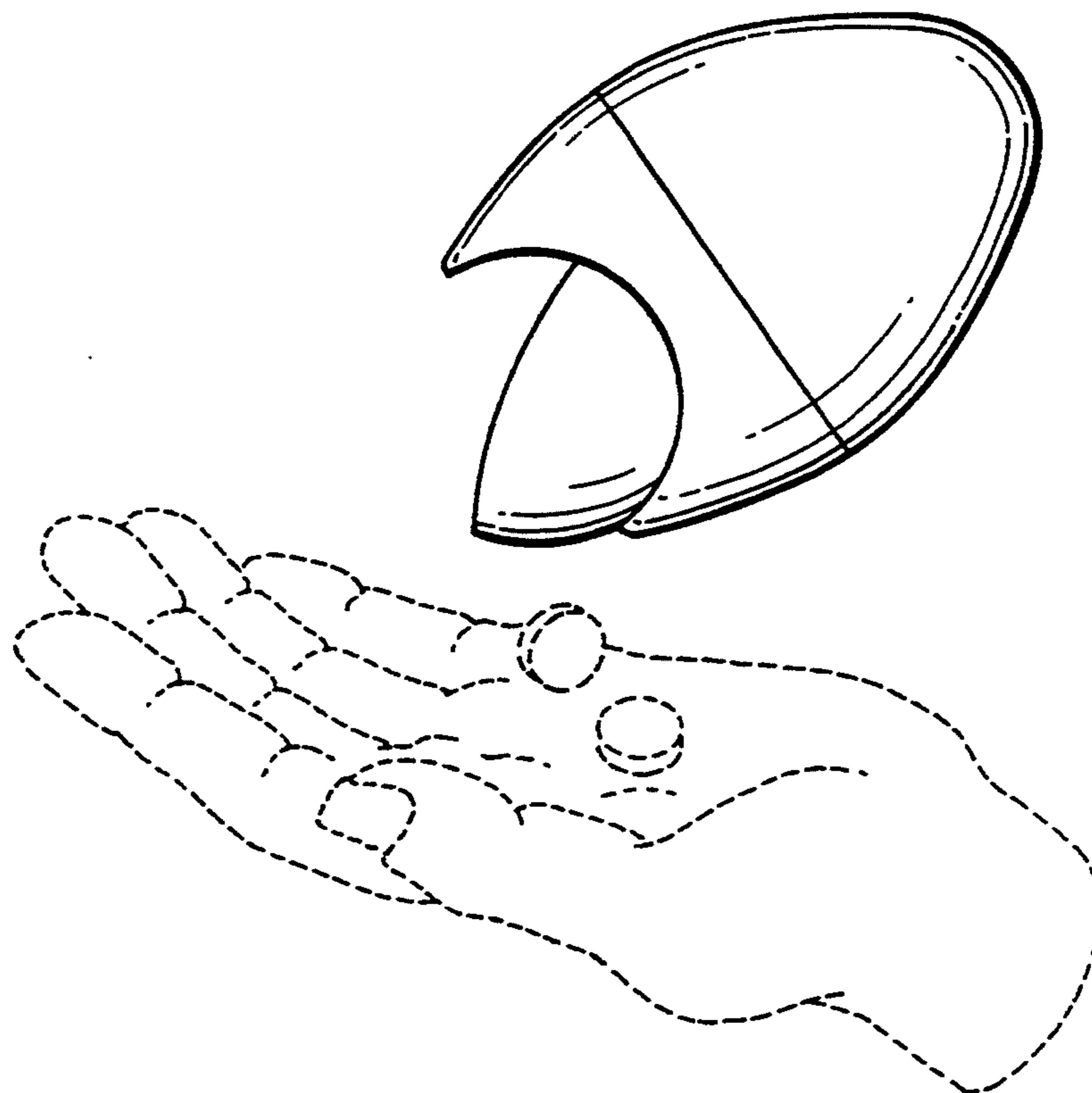
FIG. 1 is a front view of the tablet dispensing container;

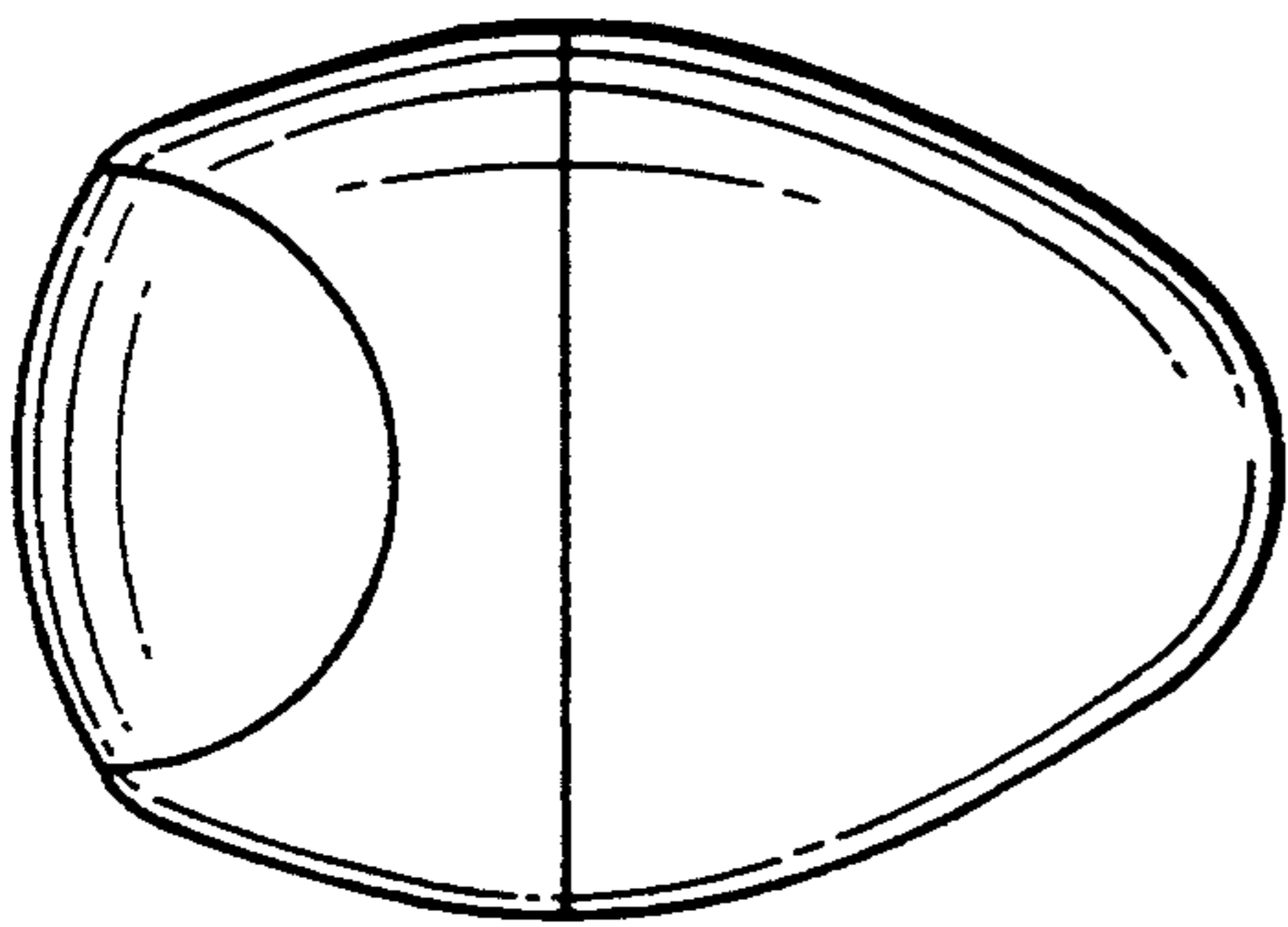

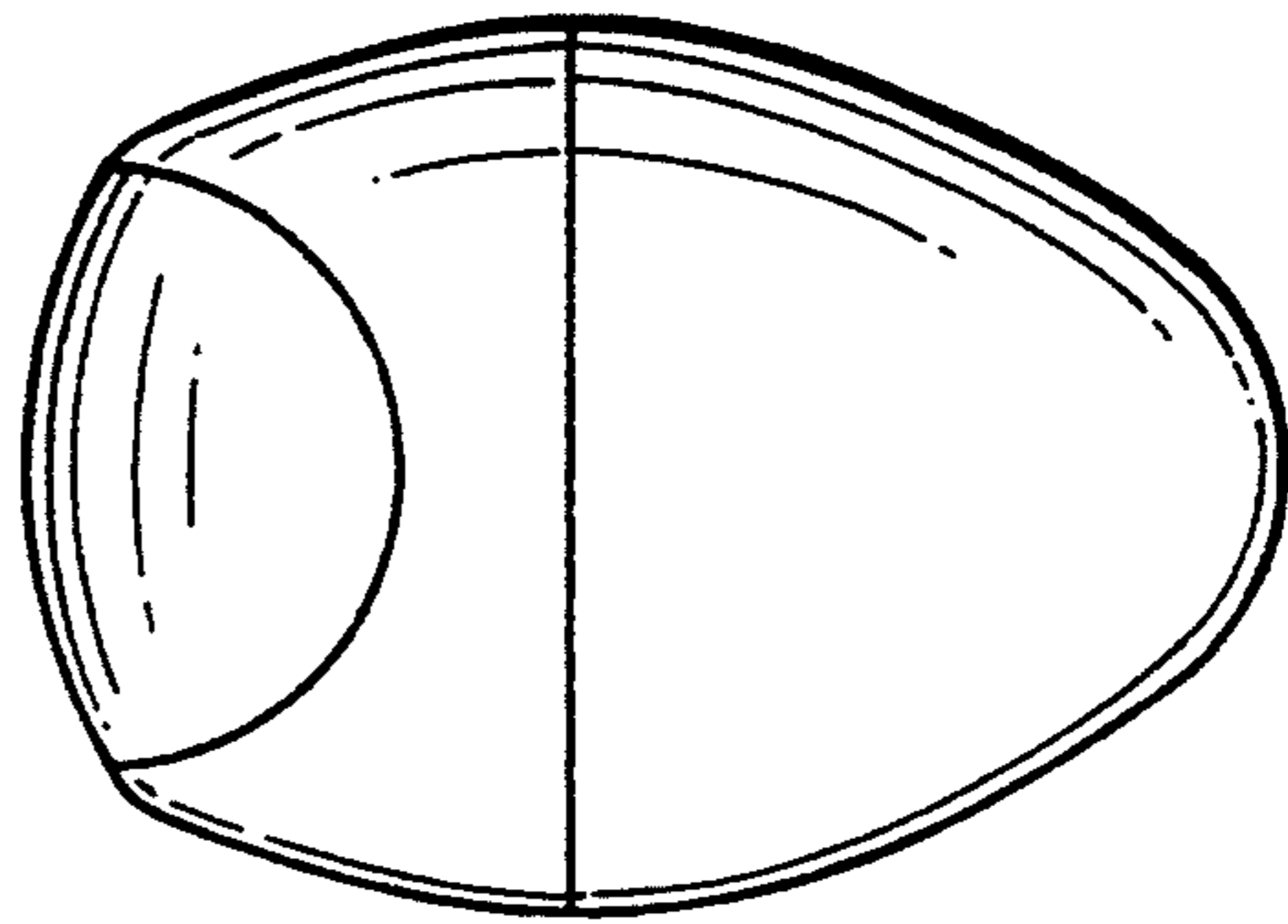

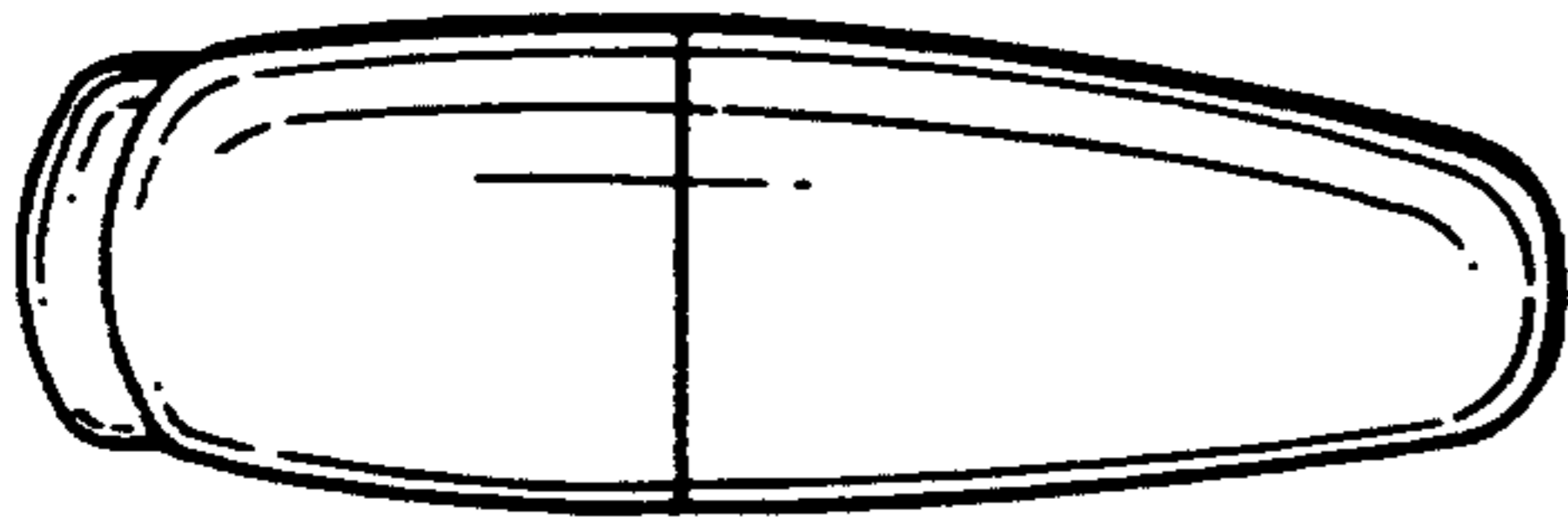

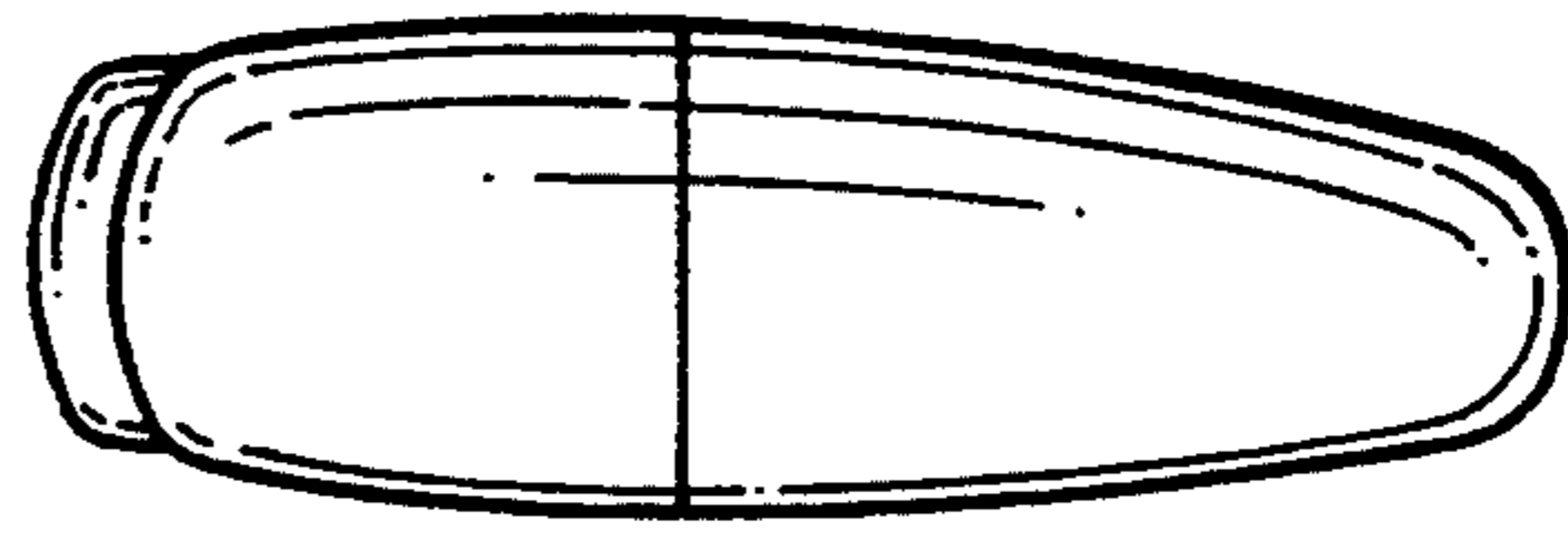

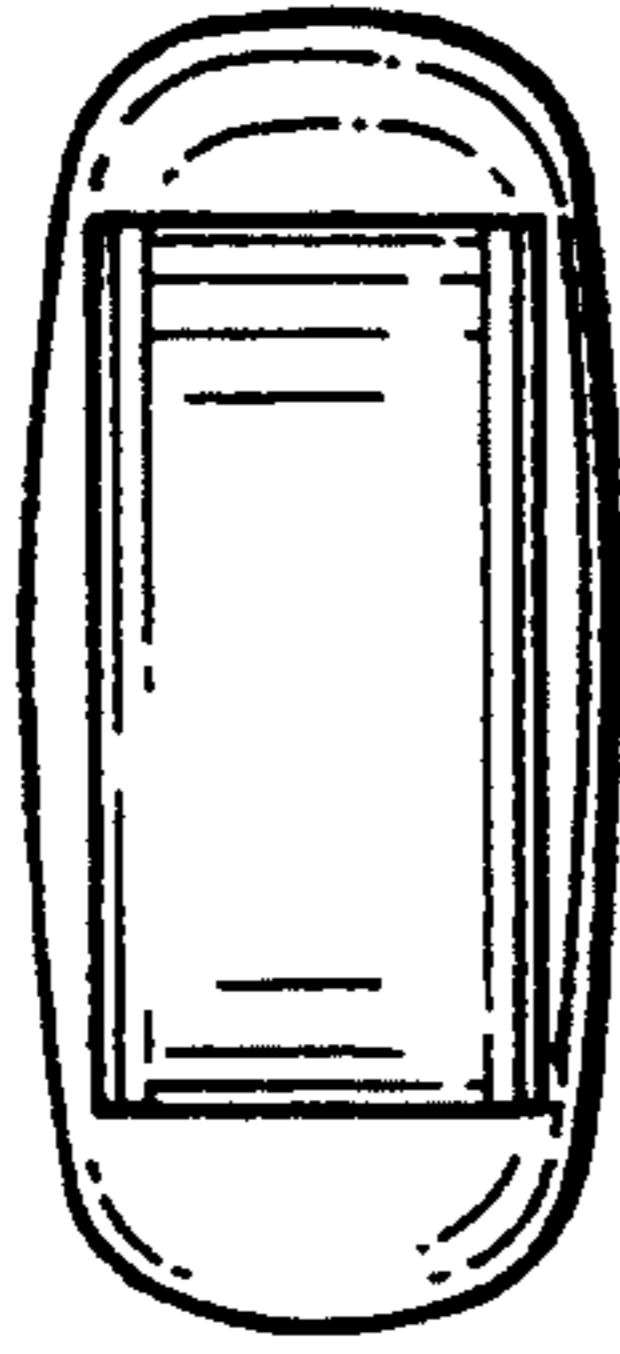

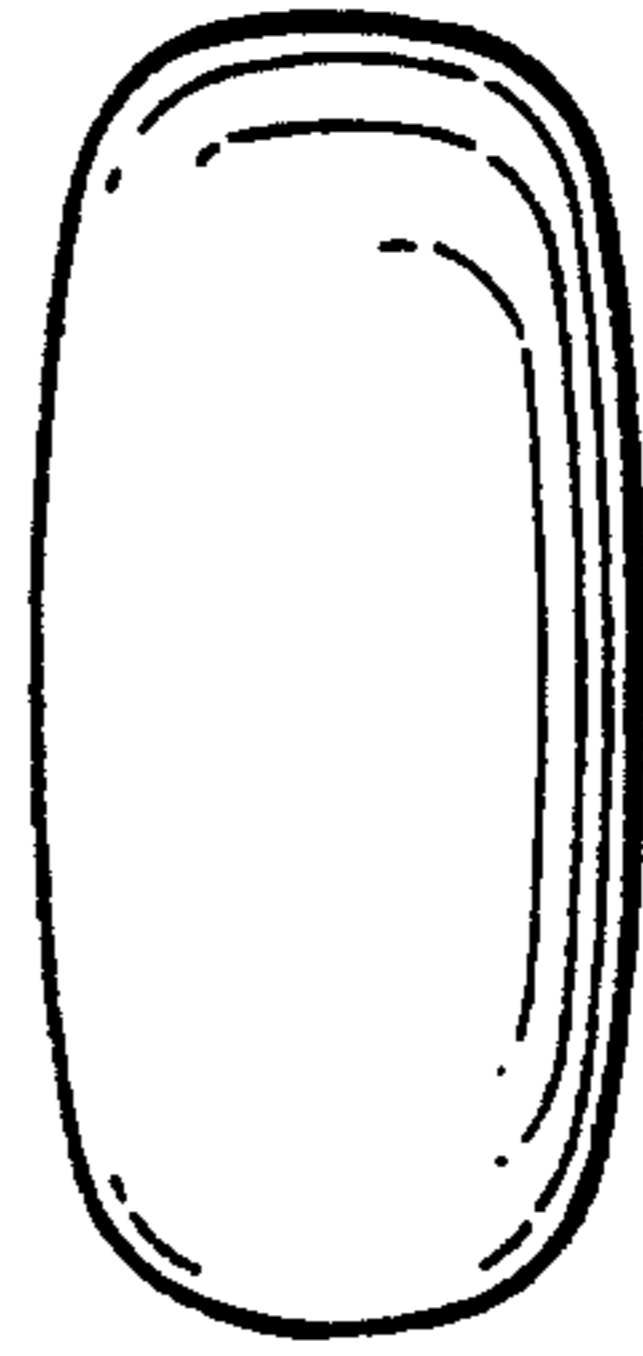

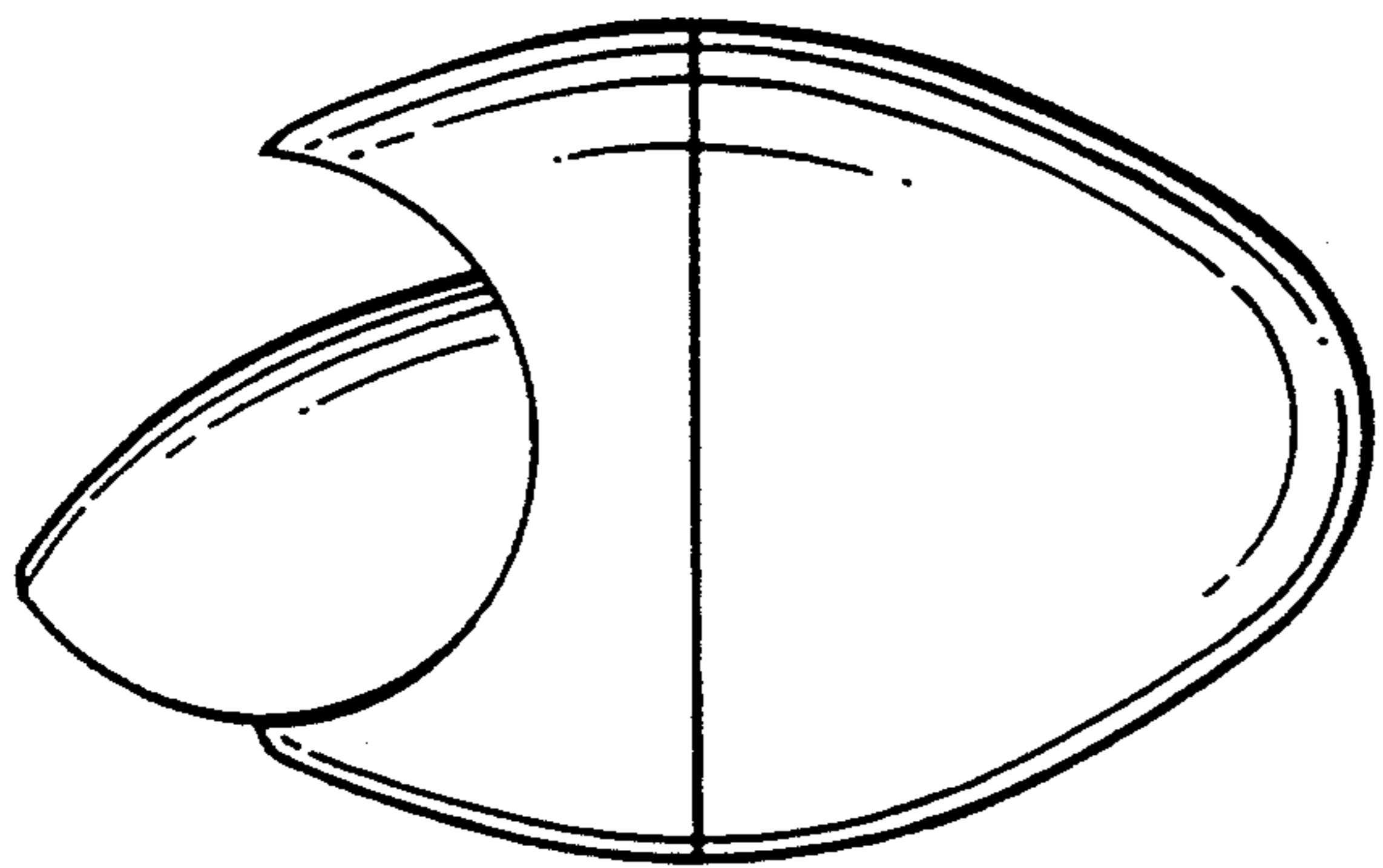

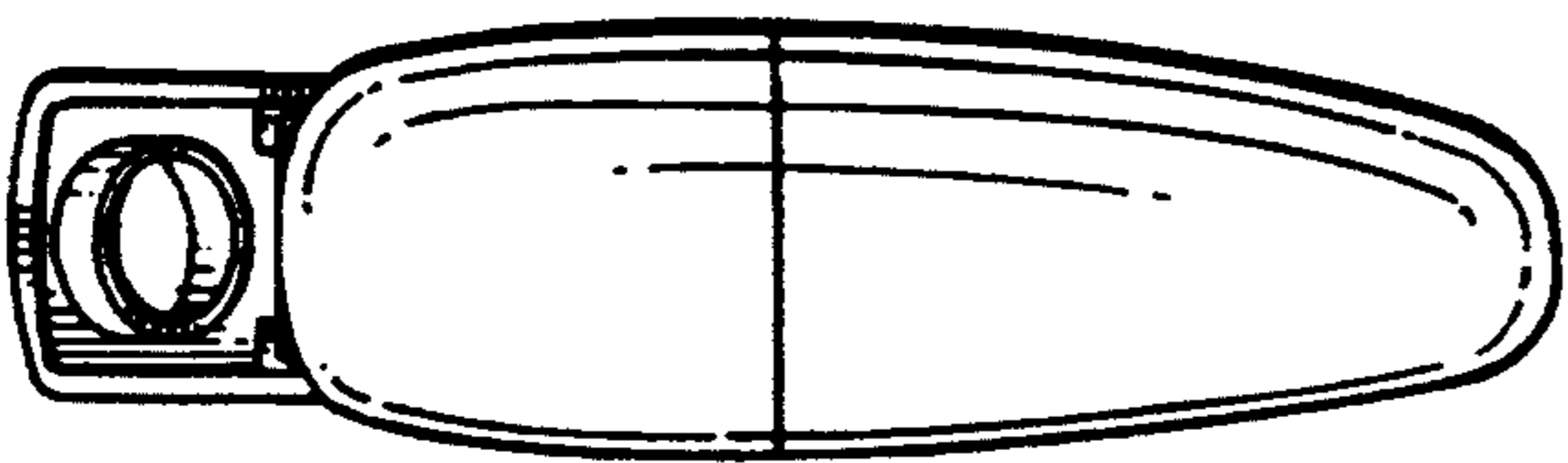

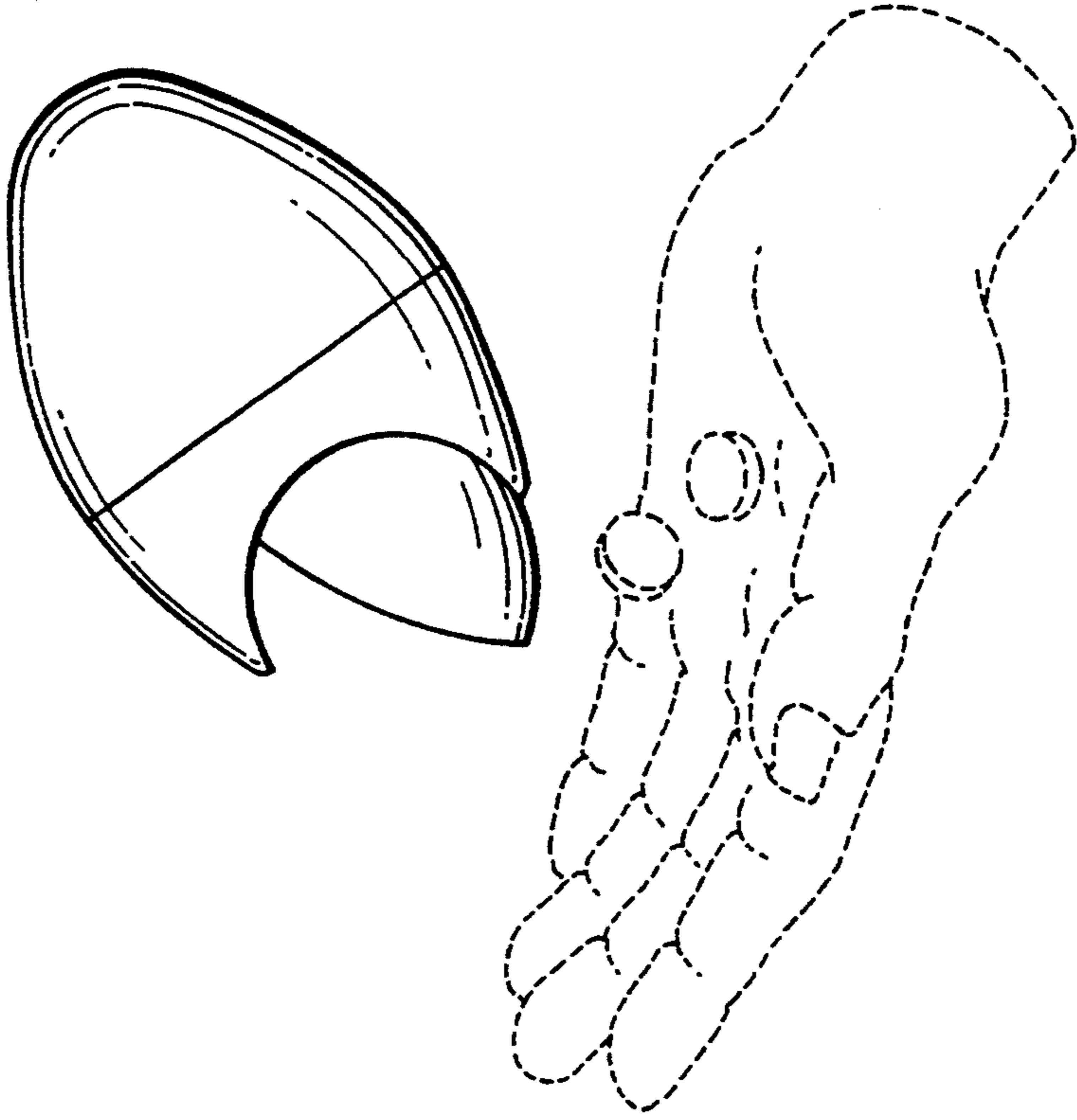
