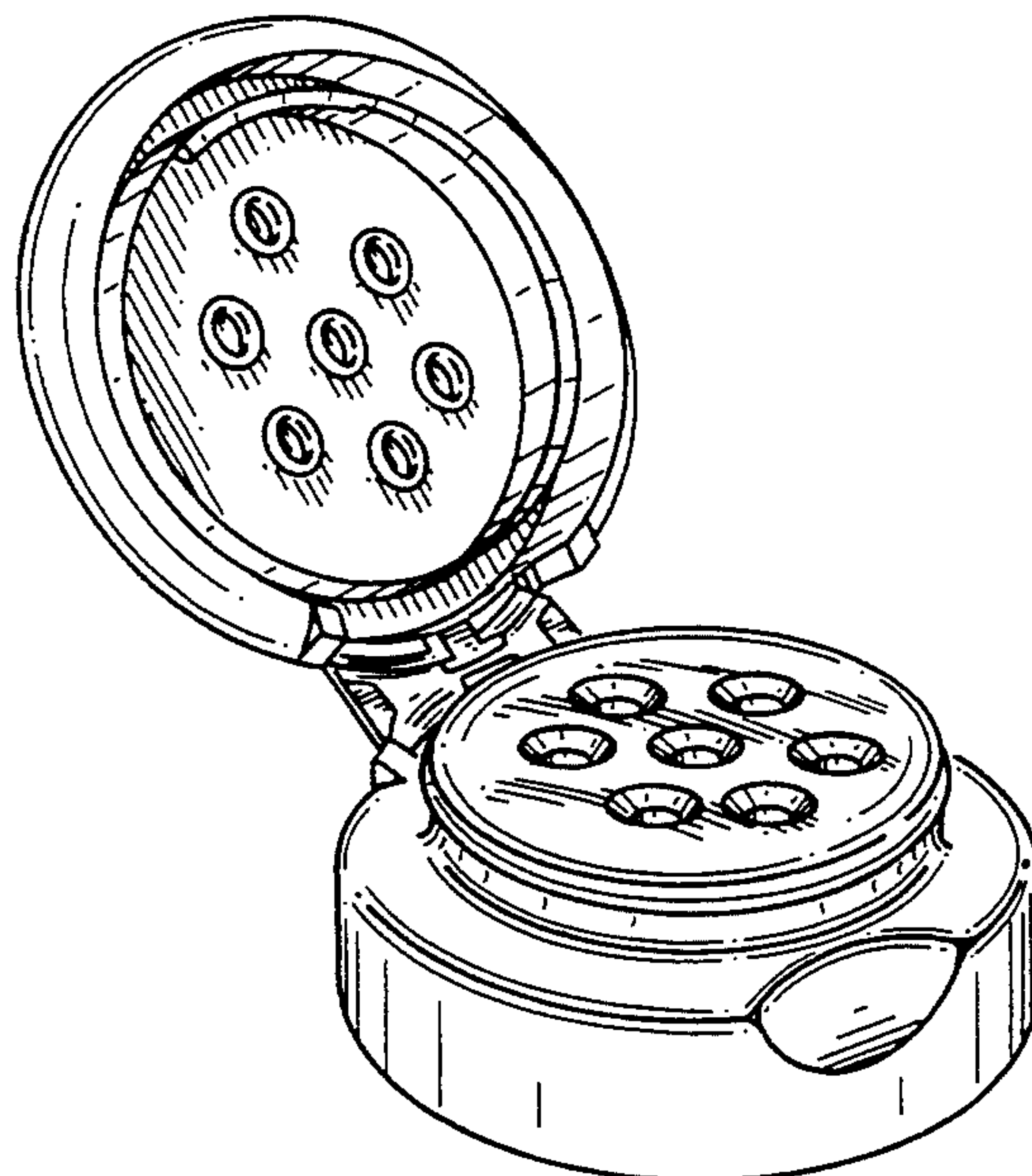
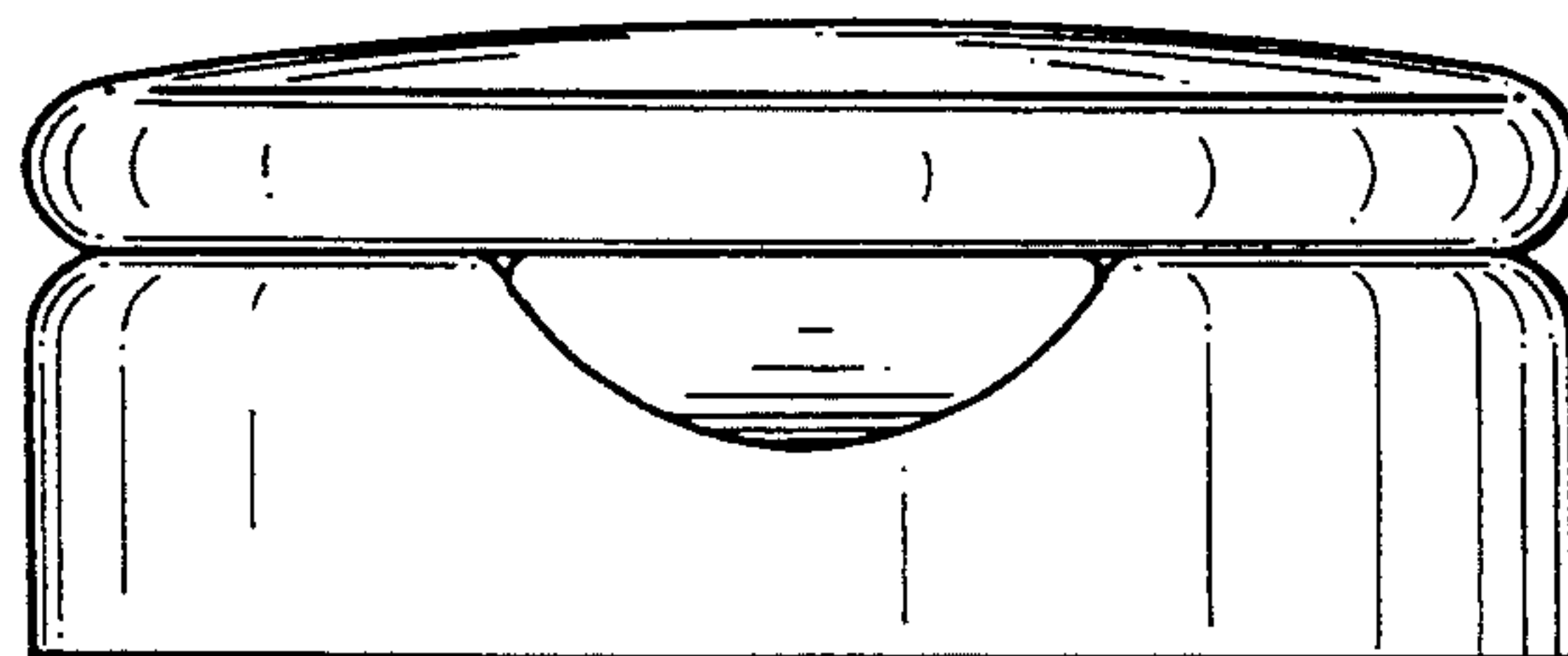

[57] **CLAIM**

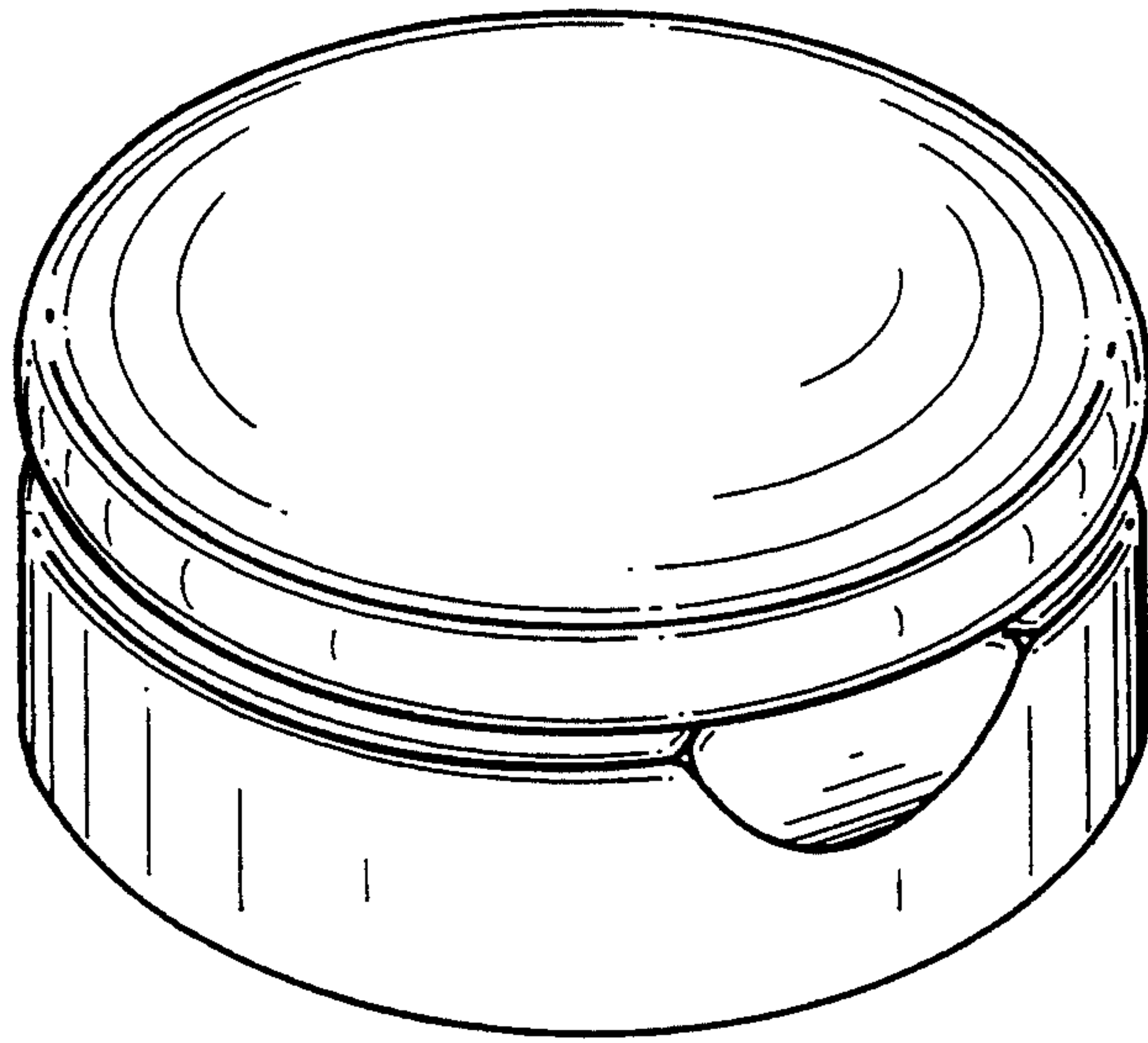
The ornamental design for a bottle cap, as shown and described.

**DESCRIPTION**

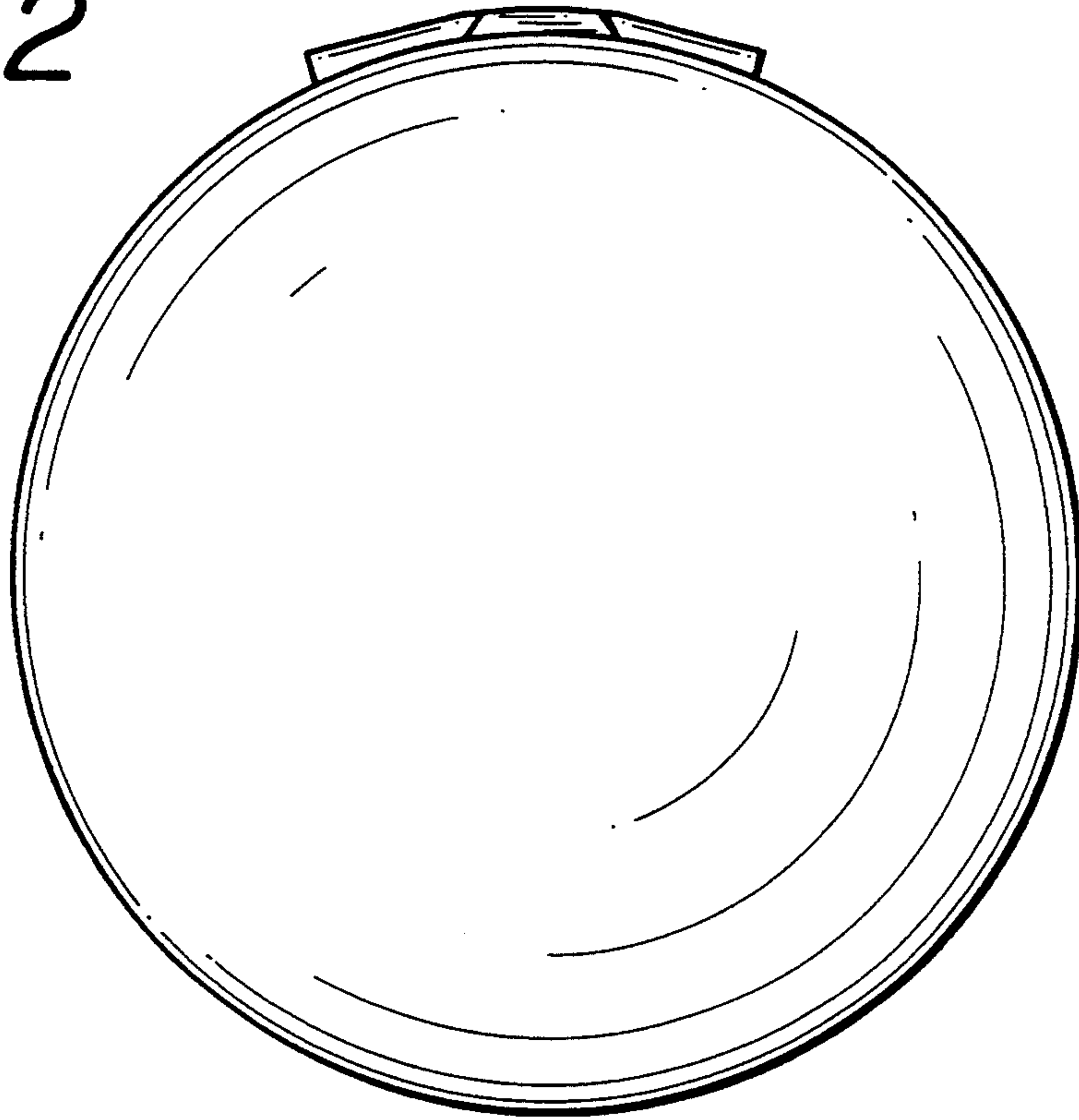
FIG. 1 is a top, front and left side perspective view of a bottle cap showing our new design; FIG. 2 is a top plan view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a right side elevational view thereof, the opposite side being a mirror image; FIG. 5 is a rear elevational view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a top, front and left side perspective view of the bottle cap in the open position; and, FIG. 8 is a top, front and left side perspective view of an additional embodiment of our new design showing the bottle cap in the open position. The second embodiment of the bottle cap in the closed position has the same appearance as the first embodiment shown in FIGS. 1 through 6.

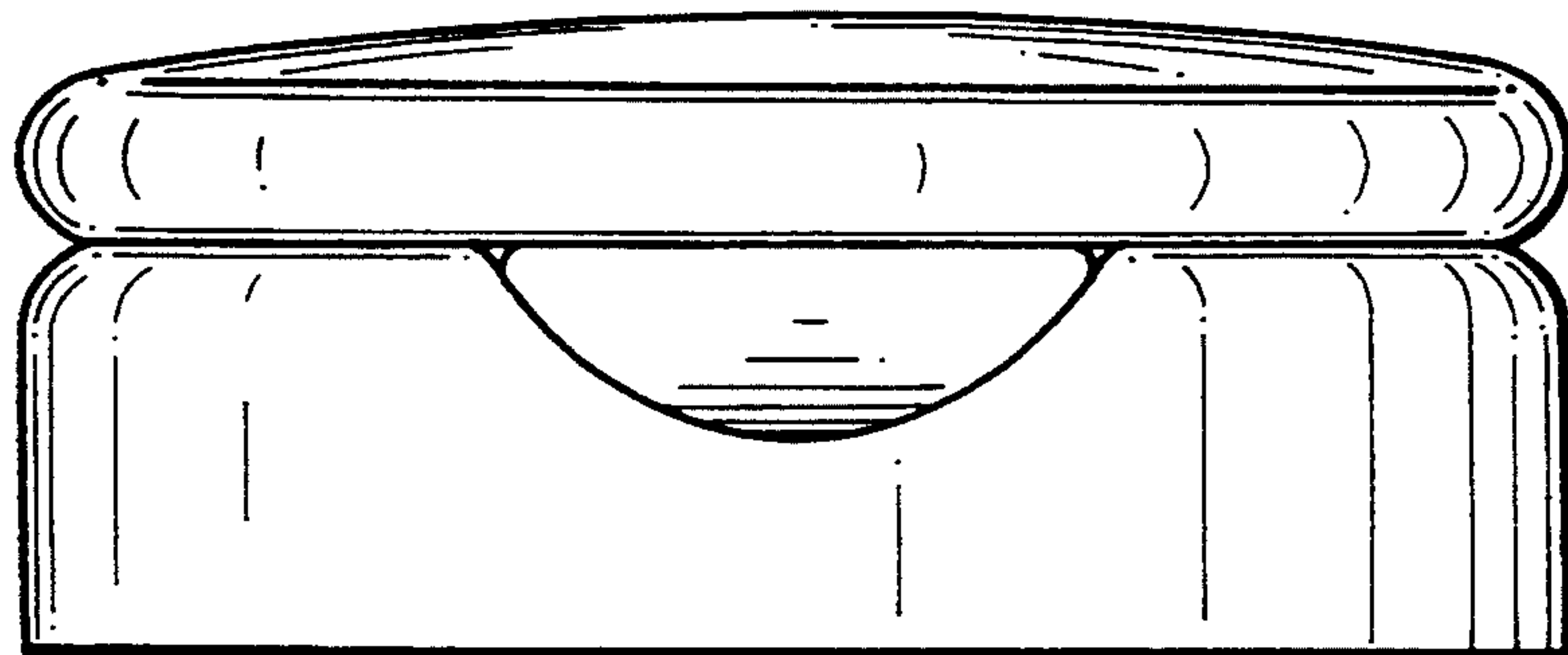

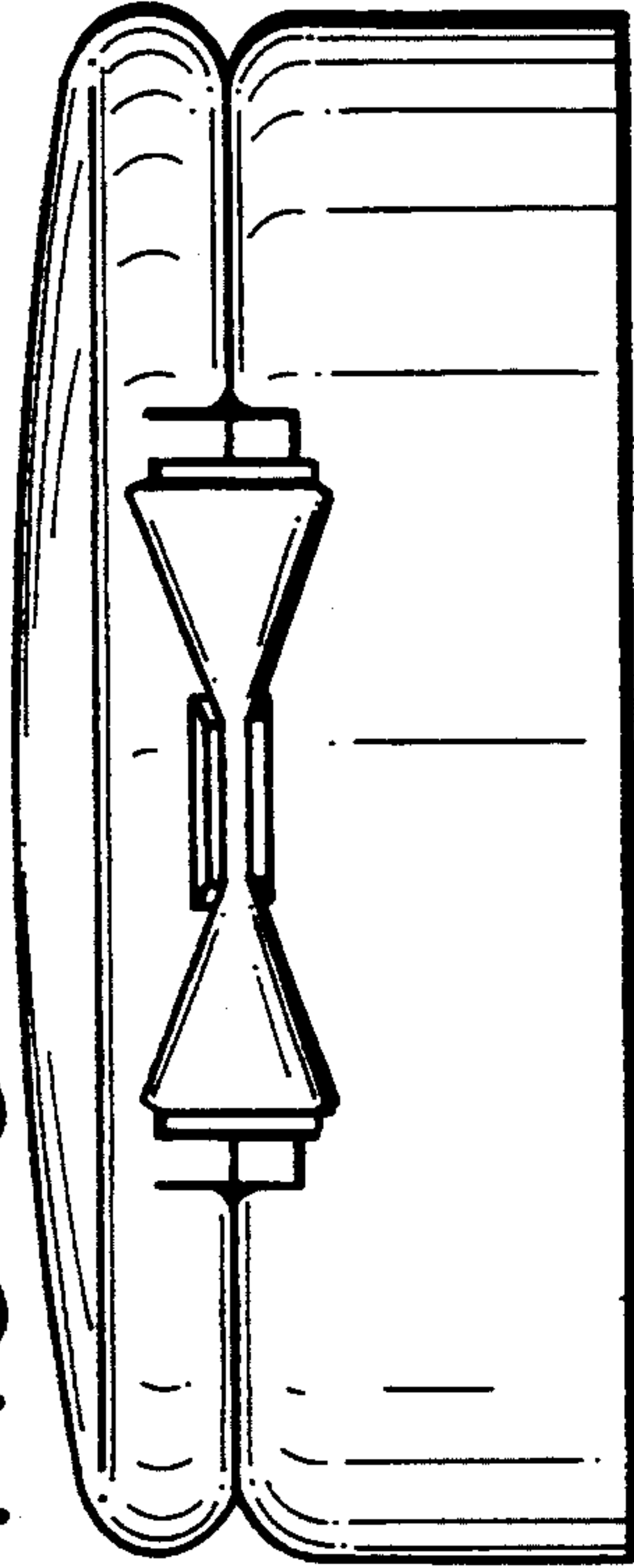

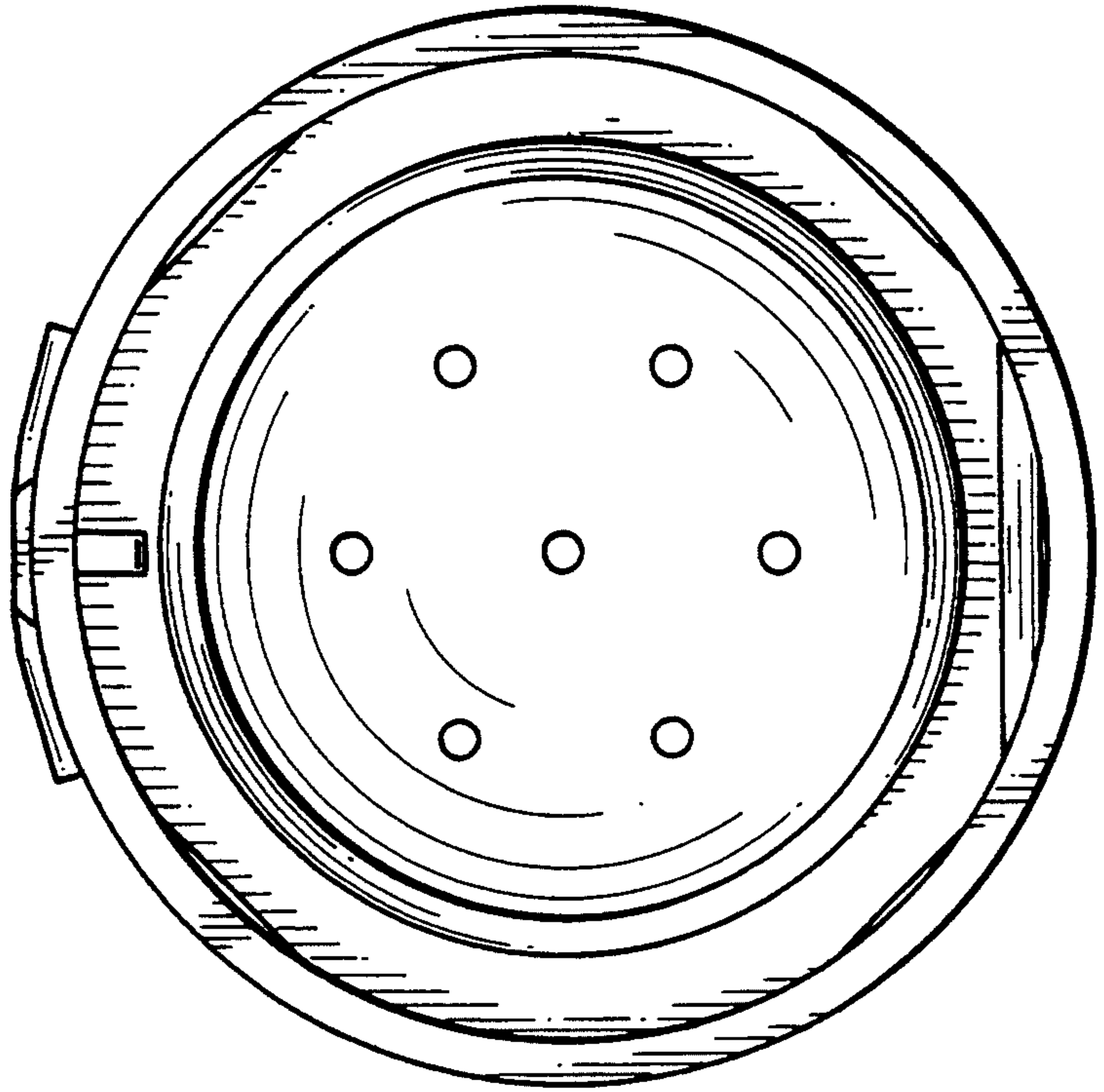
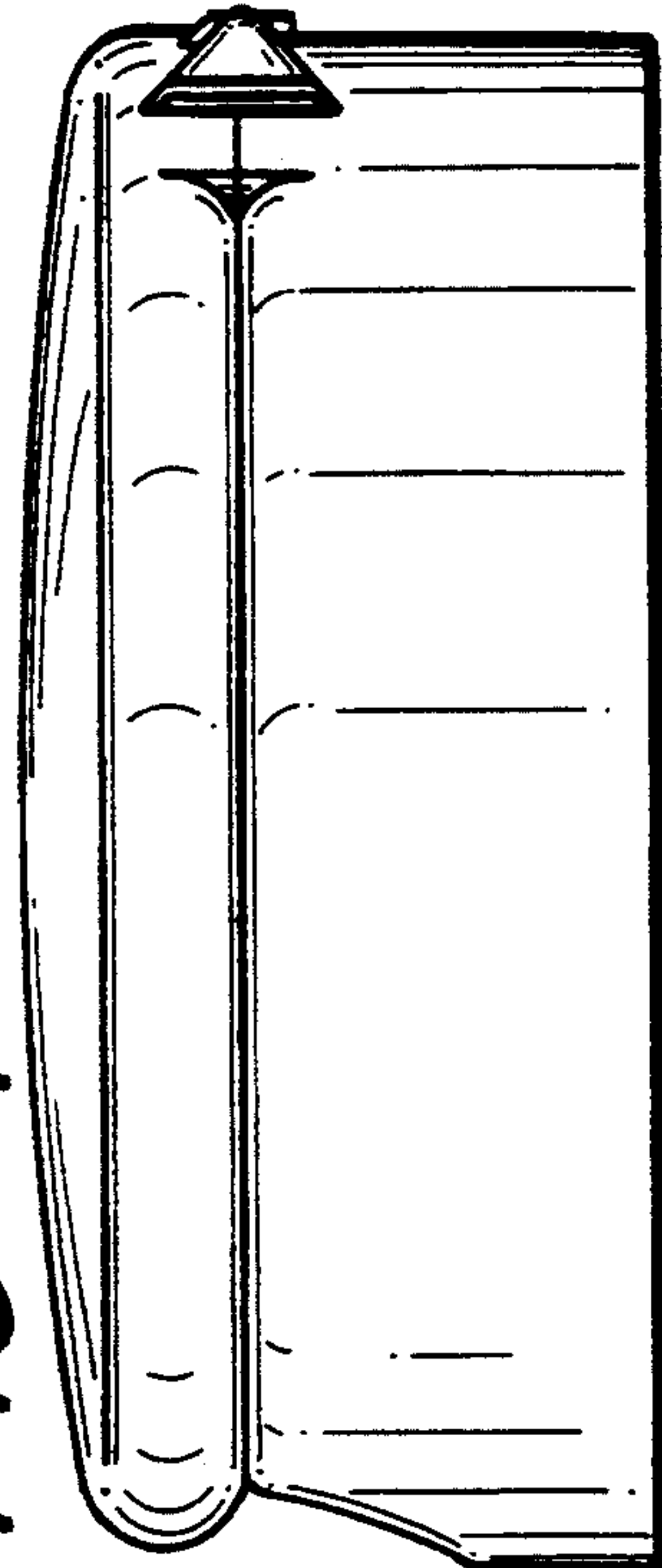

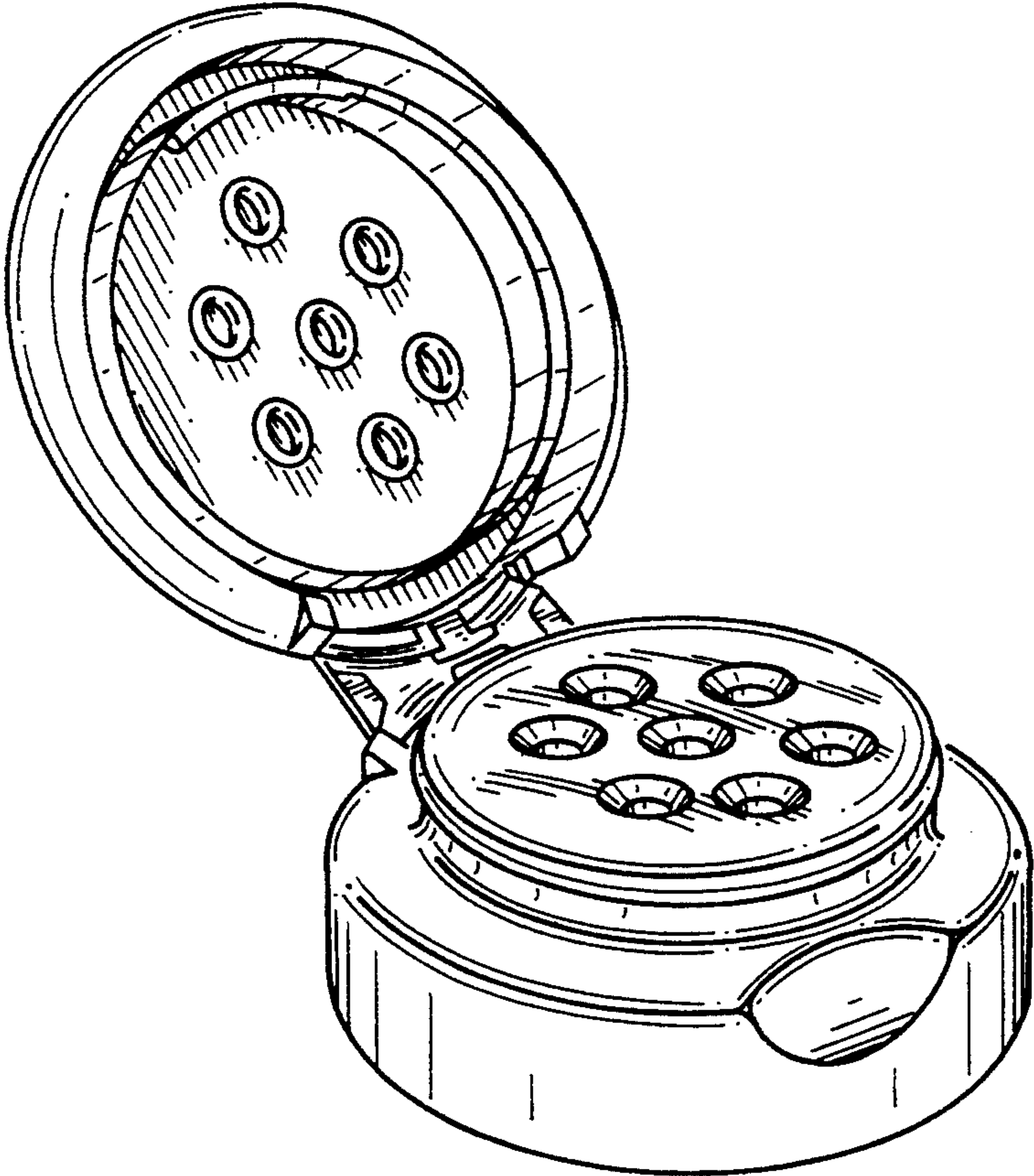
