[57] CLAIM

The ornamental design for an automobile tire, as shown and described.

DESCRIPTION

FIG. 1 is a right-side perspective view of the automobile tire showing the new design;

FIG. 2 is a left-side perspective view of the automobile tire;

FIG. 3 is a front view of the automobile tire, the top plan view and the bottom view being the same;

FIG. 4 is a rear view of the automobile tire;

FIG. 5 is a right-side view of the automobile tire;

FIG. 6 is a left-side view of the automobile tire;

FIG. 7 is an enlarged fragmentary front view, showing the portion of X-X' in FIG. 3; and,

FIG. 8 is a sectional view, taken on line 8—8 of FIG. 7.

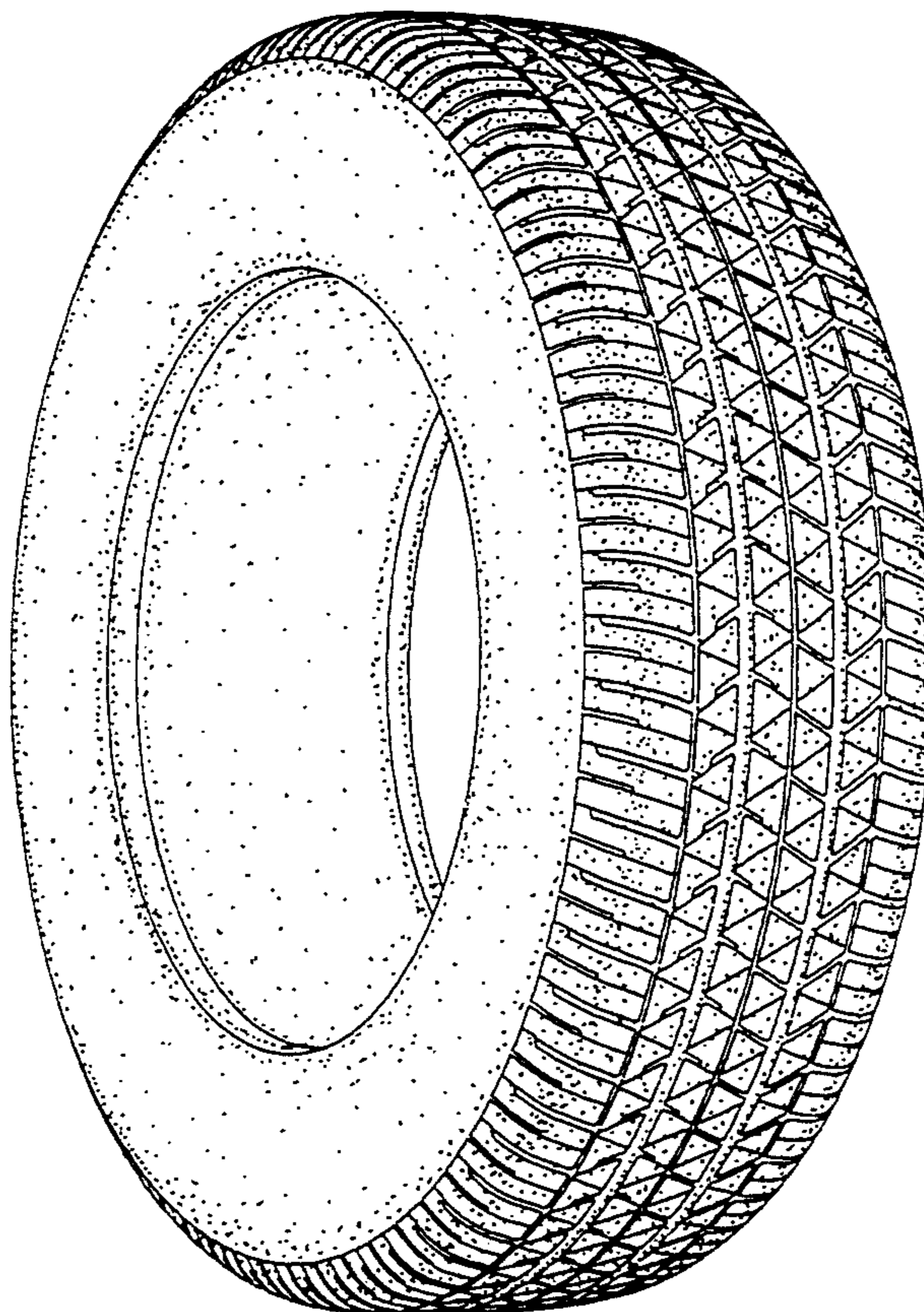

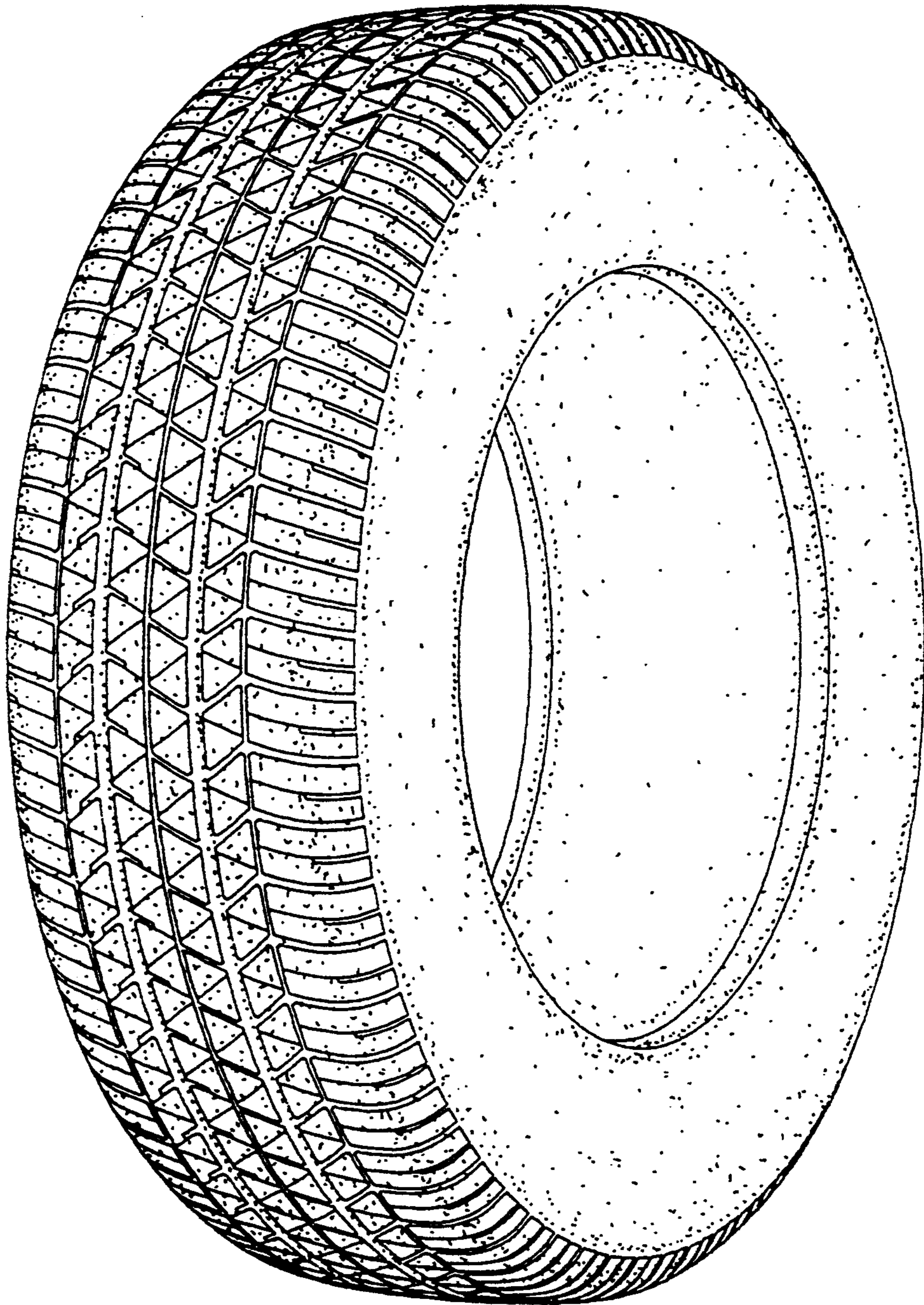
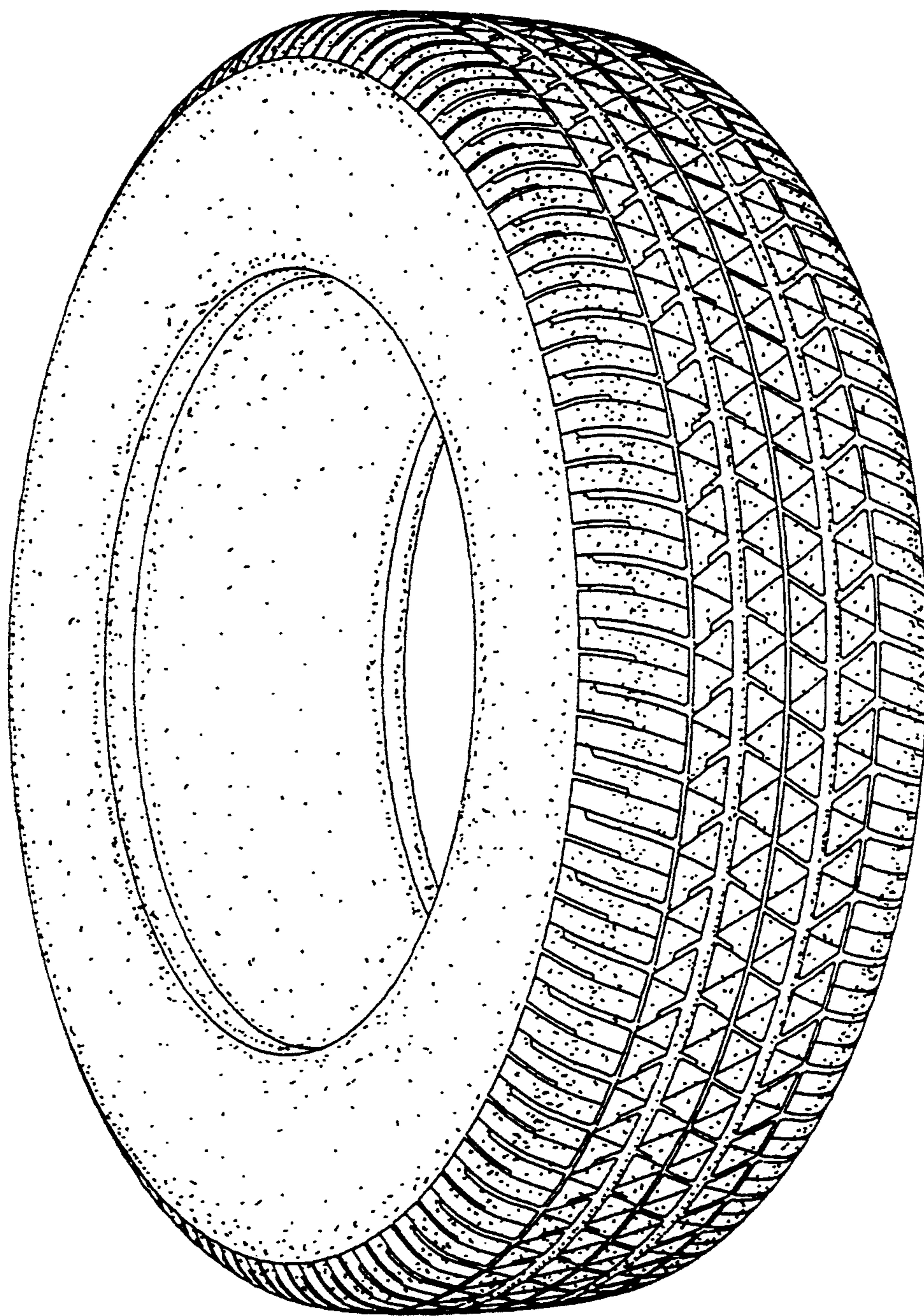

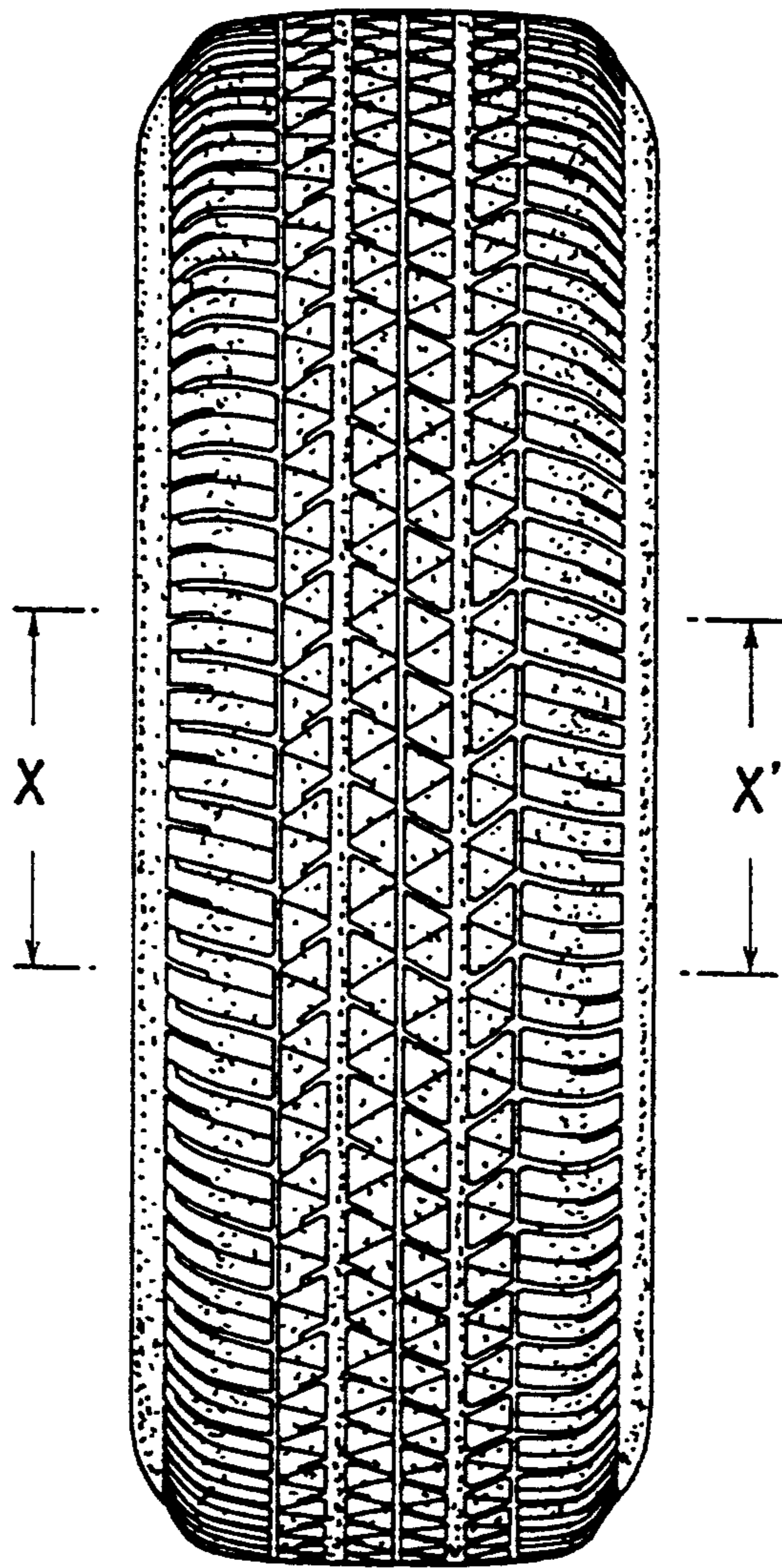

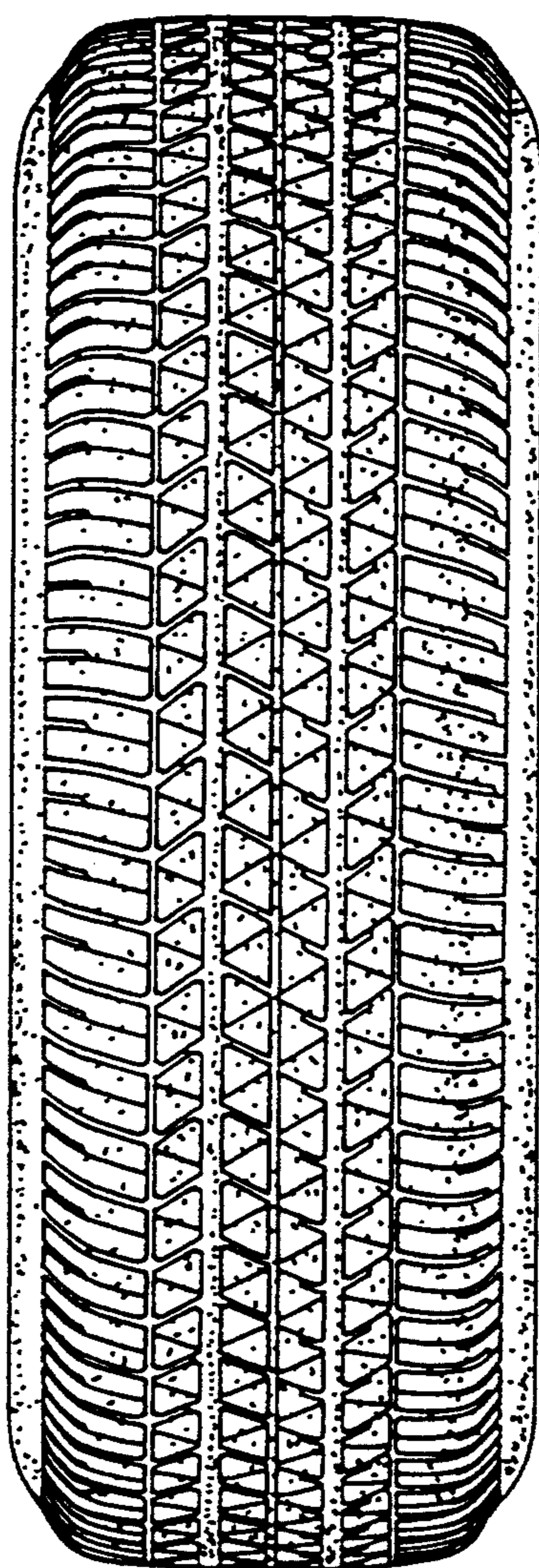

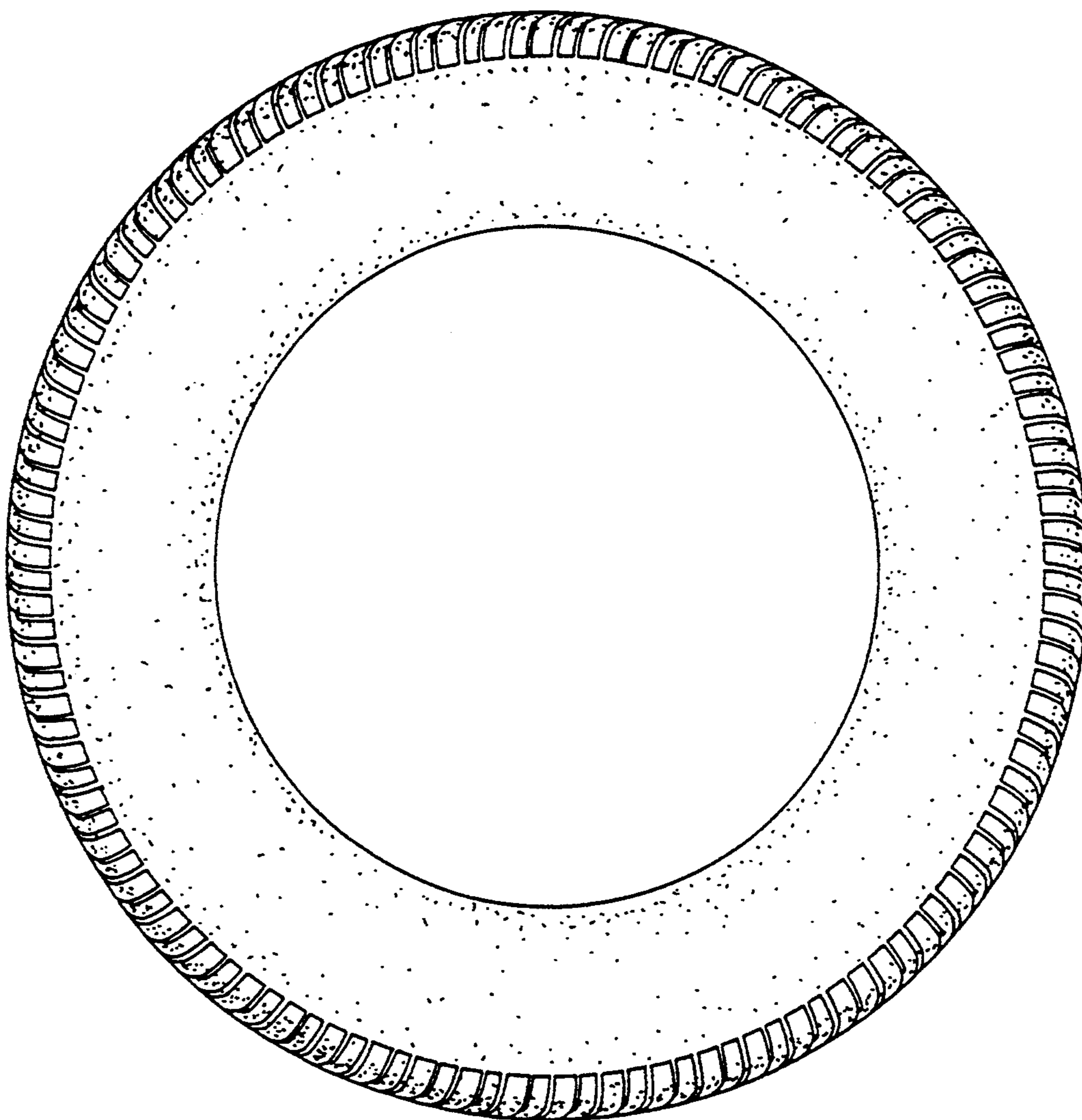

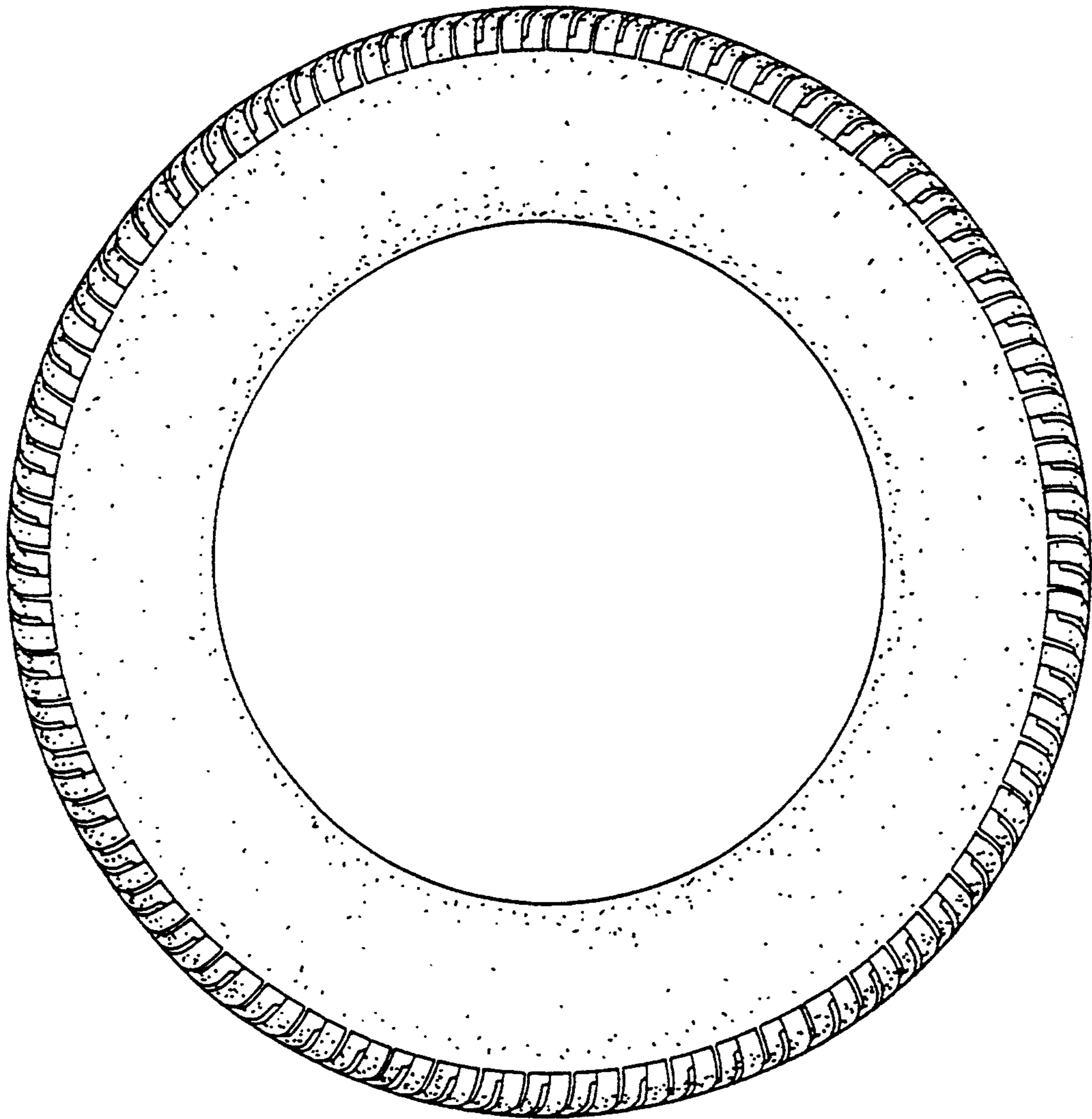

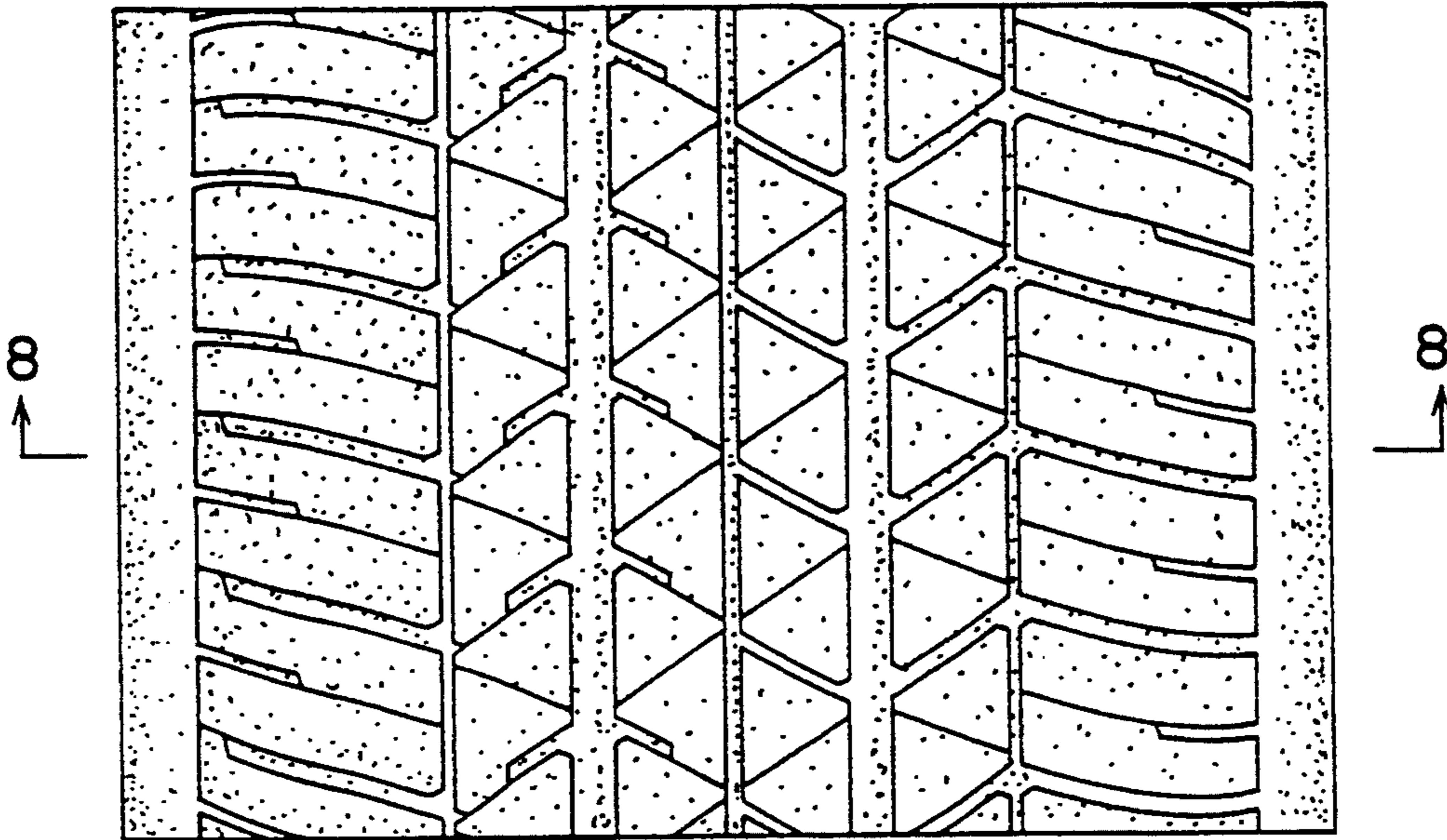
