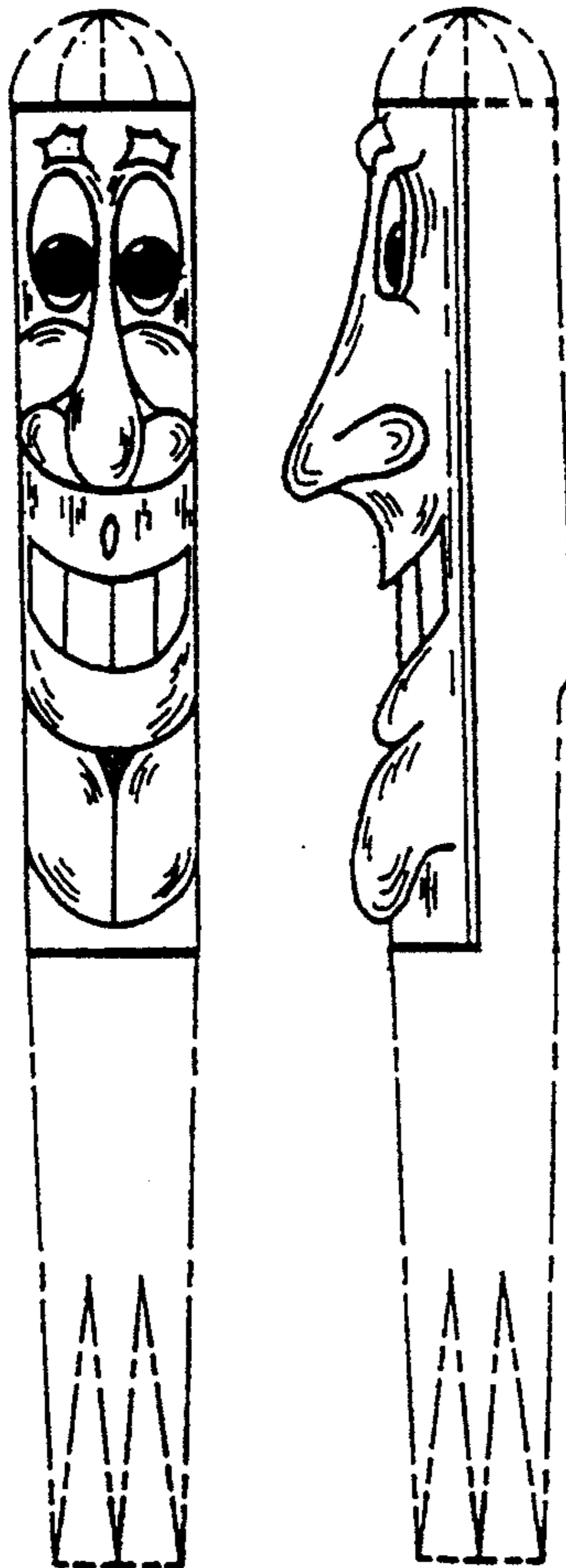

### [57] CLAIM

An ornamental design for a caricature portion for a writing instrument, as shown and described herein.

### DESCRIPTION

FIG. 1 is a front elevational view of a caricature portion for writing instrument showing our new design; FIG. 2 is a right side elevational view thereof; FIG. 3 is a left side elevational view thereof; FIG. 4 is a top plan view thereof; and, FIG. 5 is a bottom plan view thereof. The rear of the article is plain and unornamented.



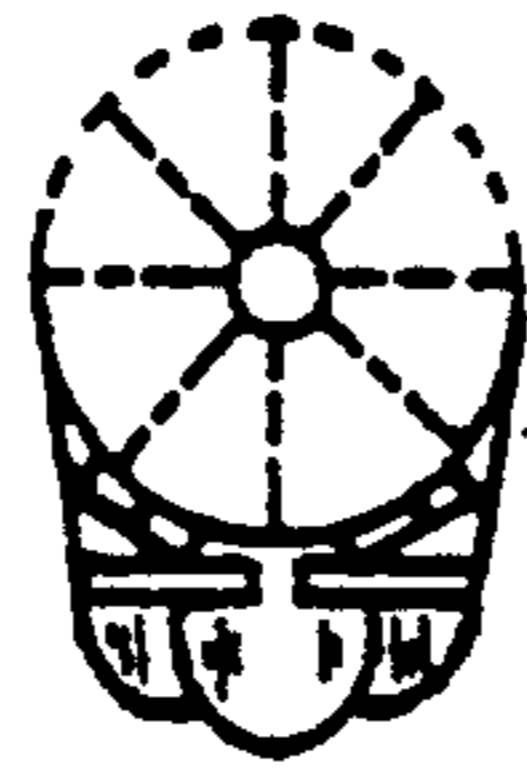

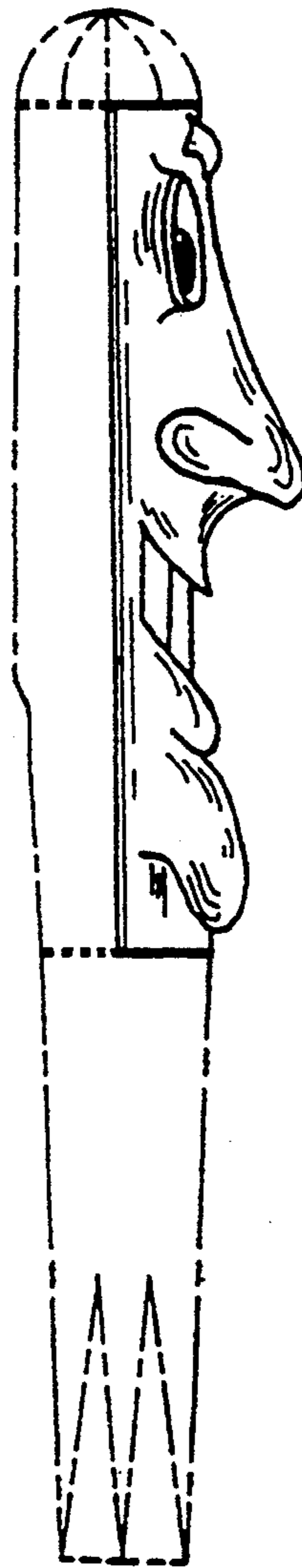

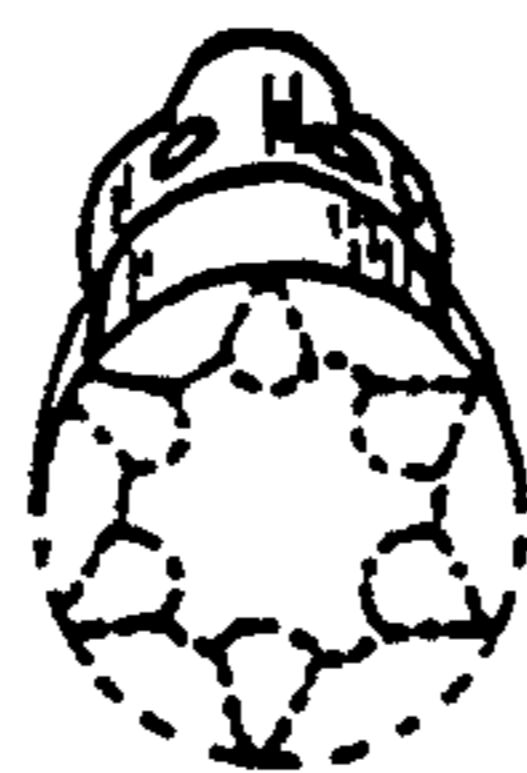
