The ornamental design for a line guide for fishing rods, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and right side of the perspective view of a line guide for fishing rods showing our new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a left side elevational view thereof;
FIG. 4 is a right side elevational view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom view thereof;
FIG. 7 is a front, top and right side of the perspective view of the other embodiment showing our new design;
FIG. 8 is a front elevational view thereof;
FIG. 9 is a left side elevational view thereof;
FIG. 10 is a right side elevational view thereof;
FIG. 11 is a top plan view thereof; and,
FIG. 12 is a bottom view thereof.

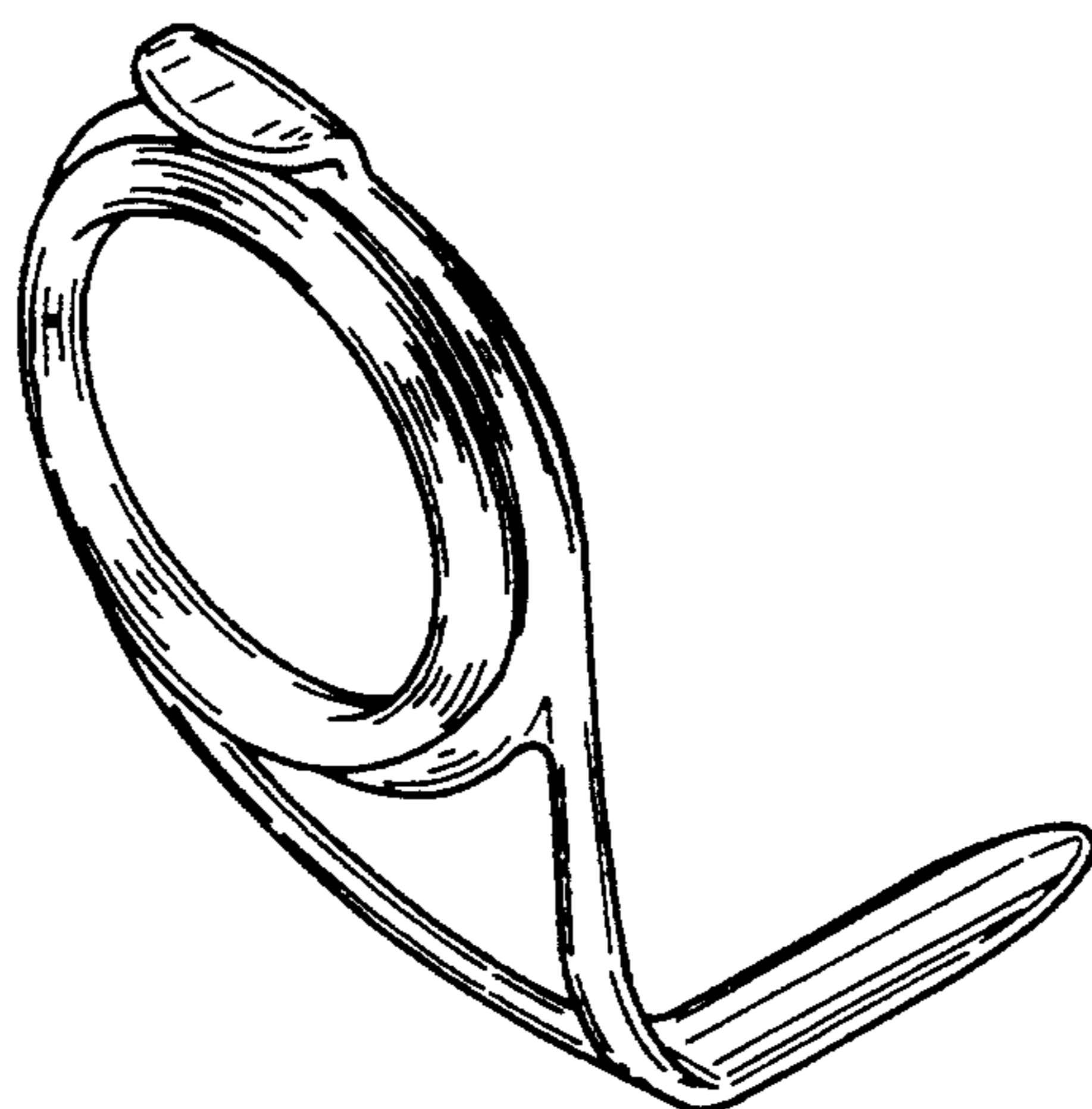

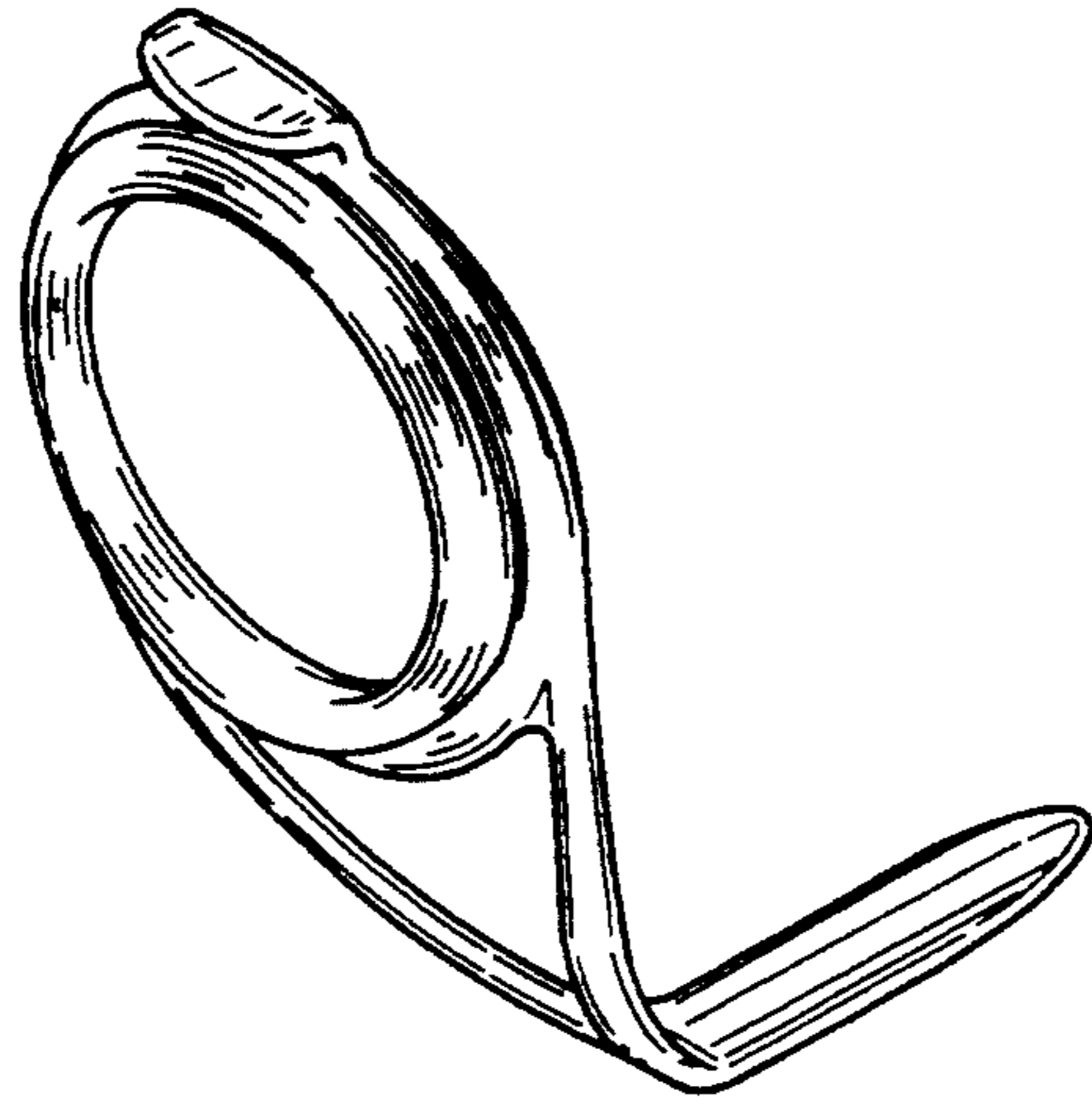

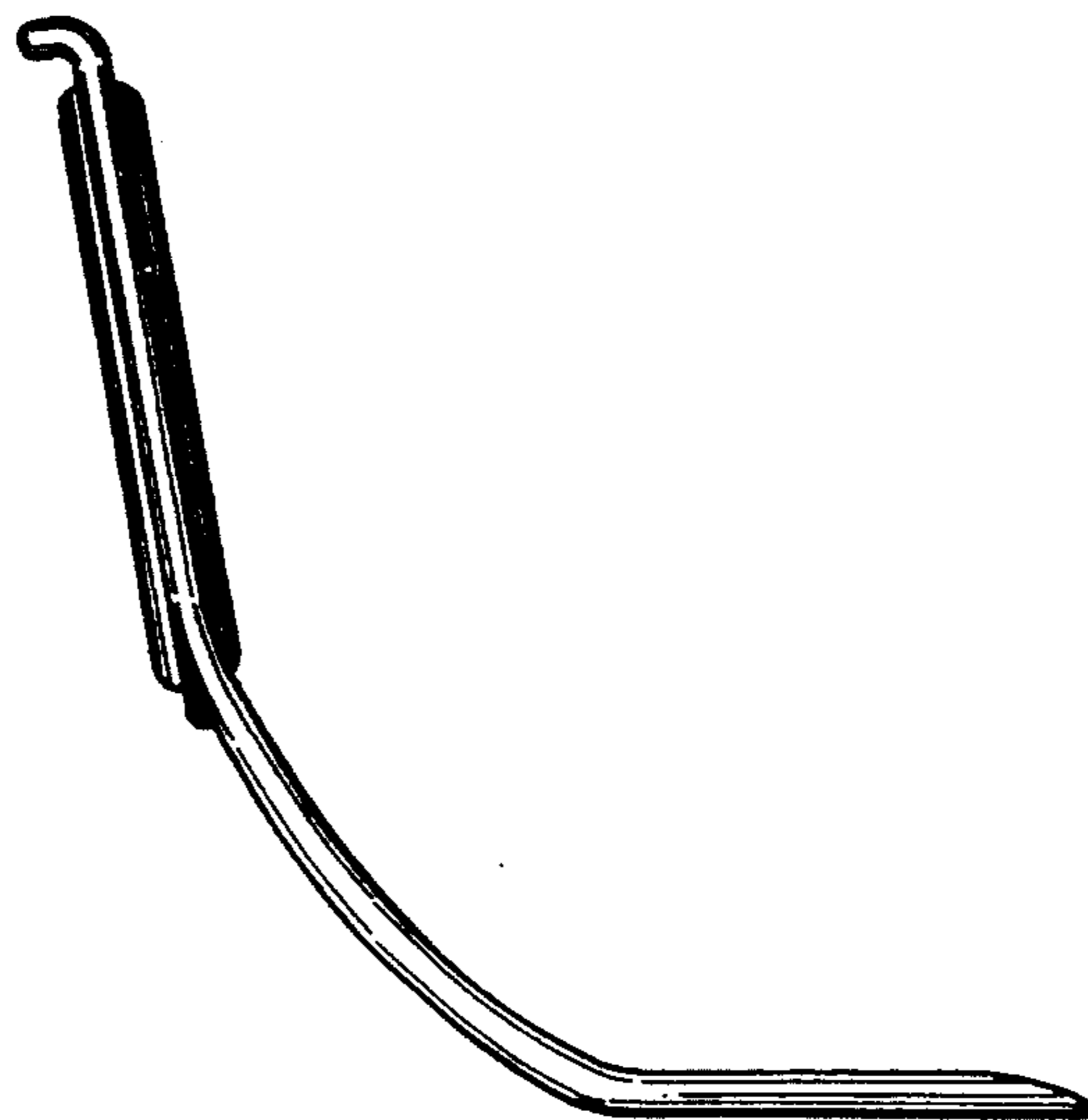

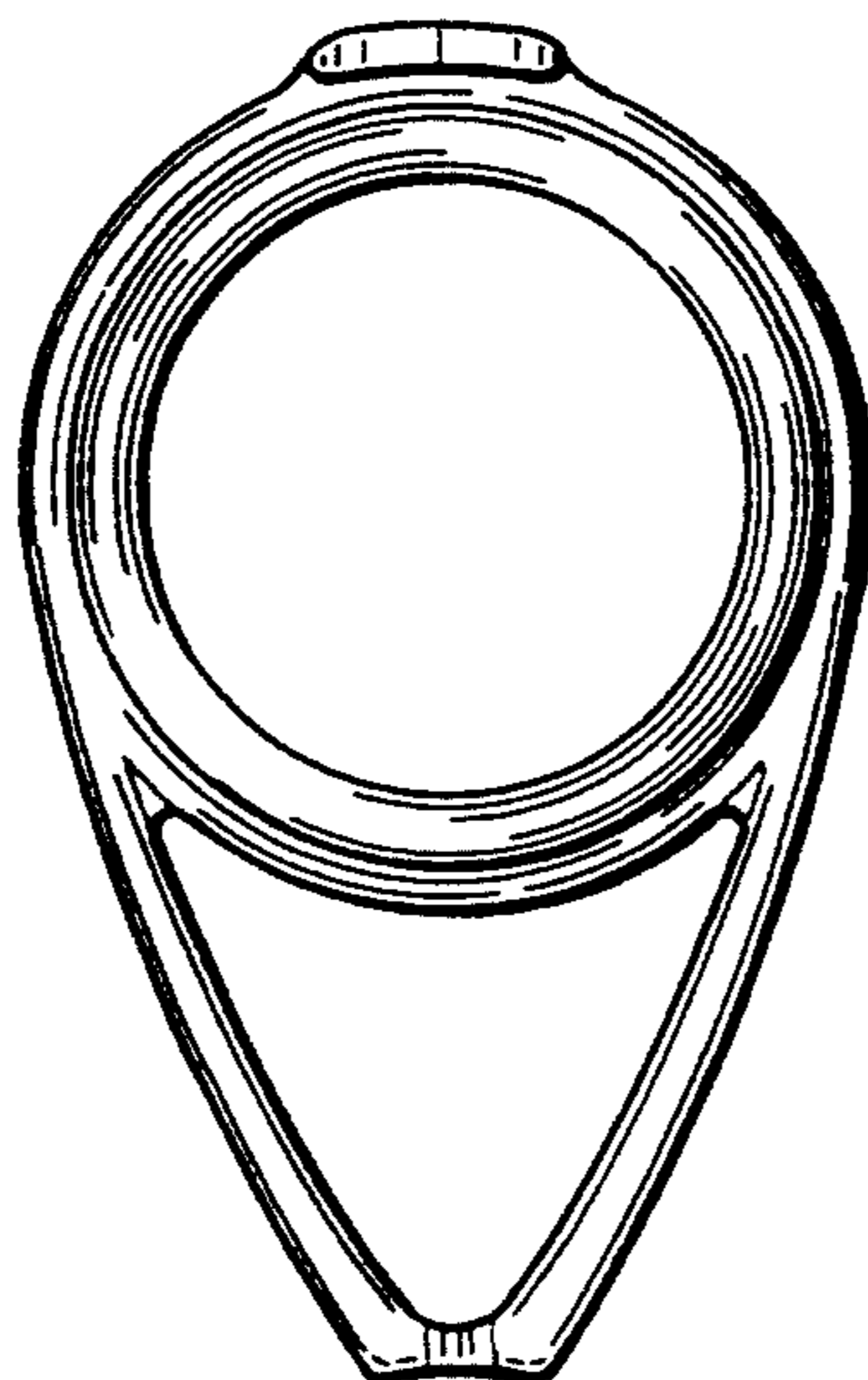

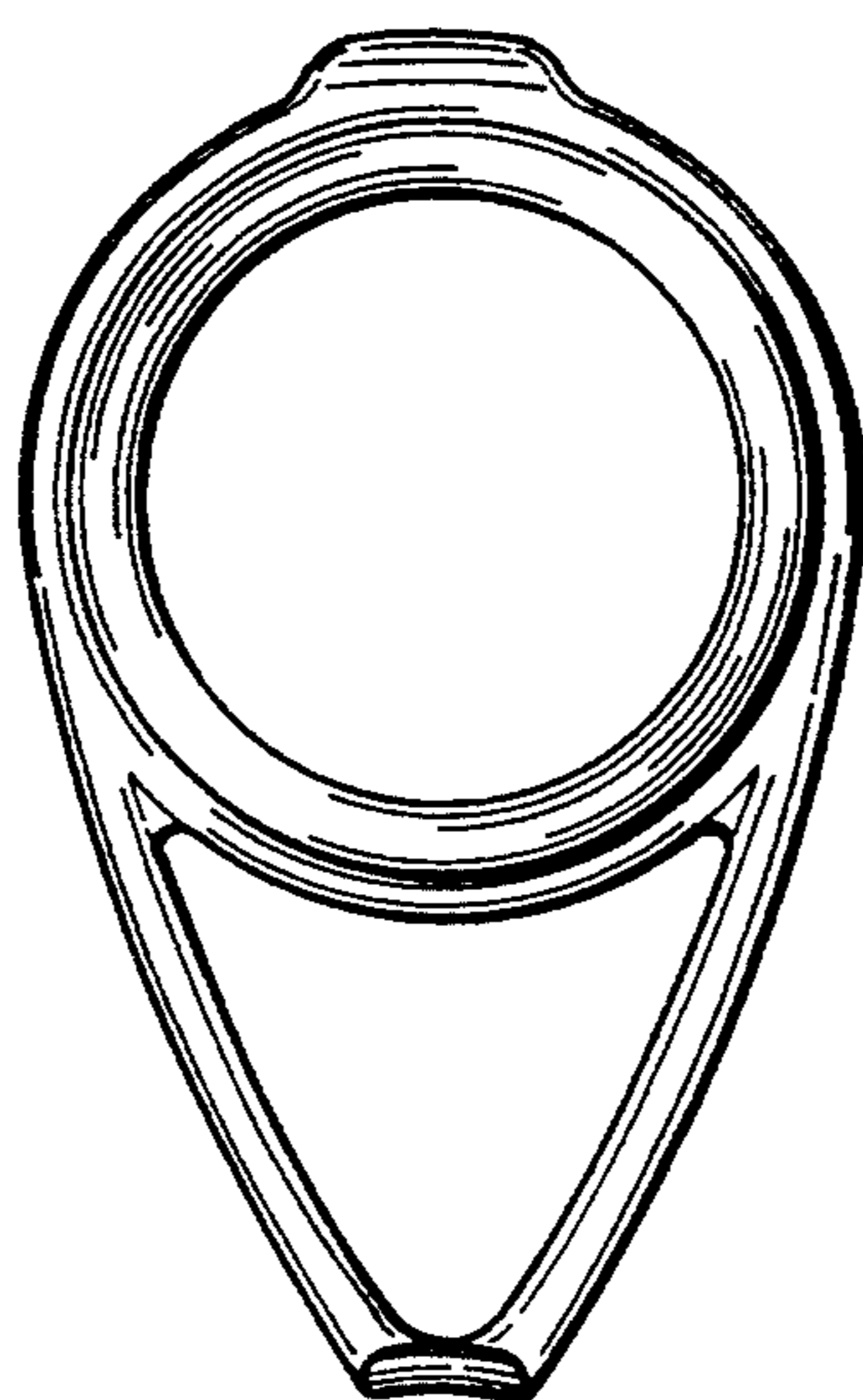

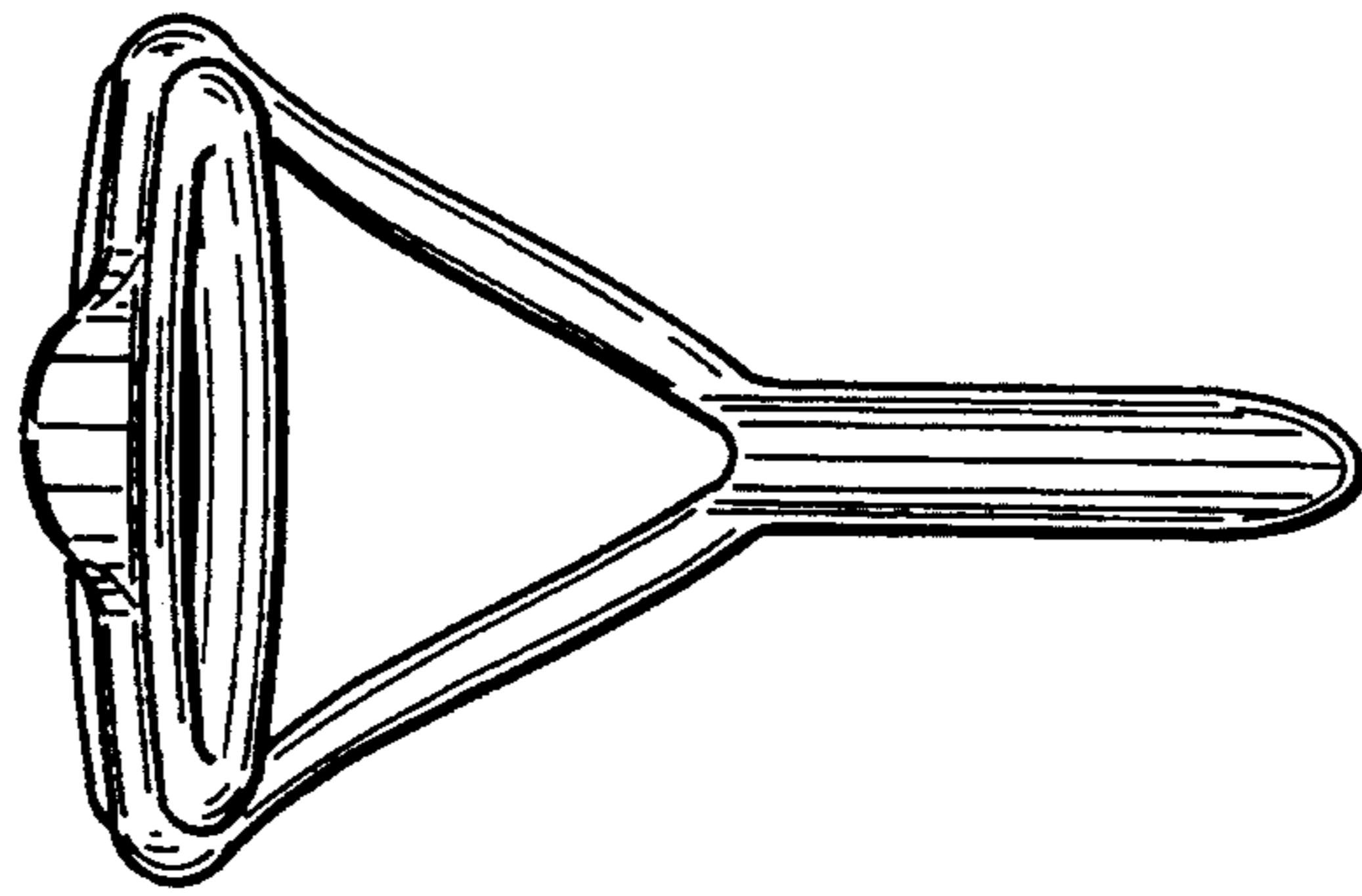

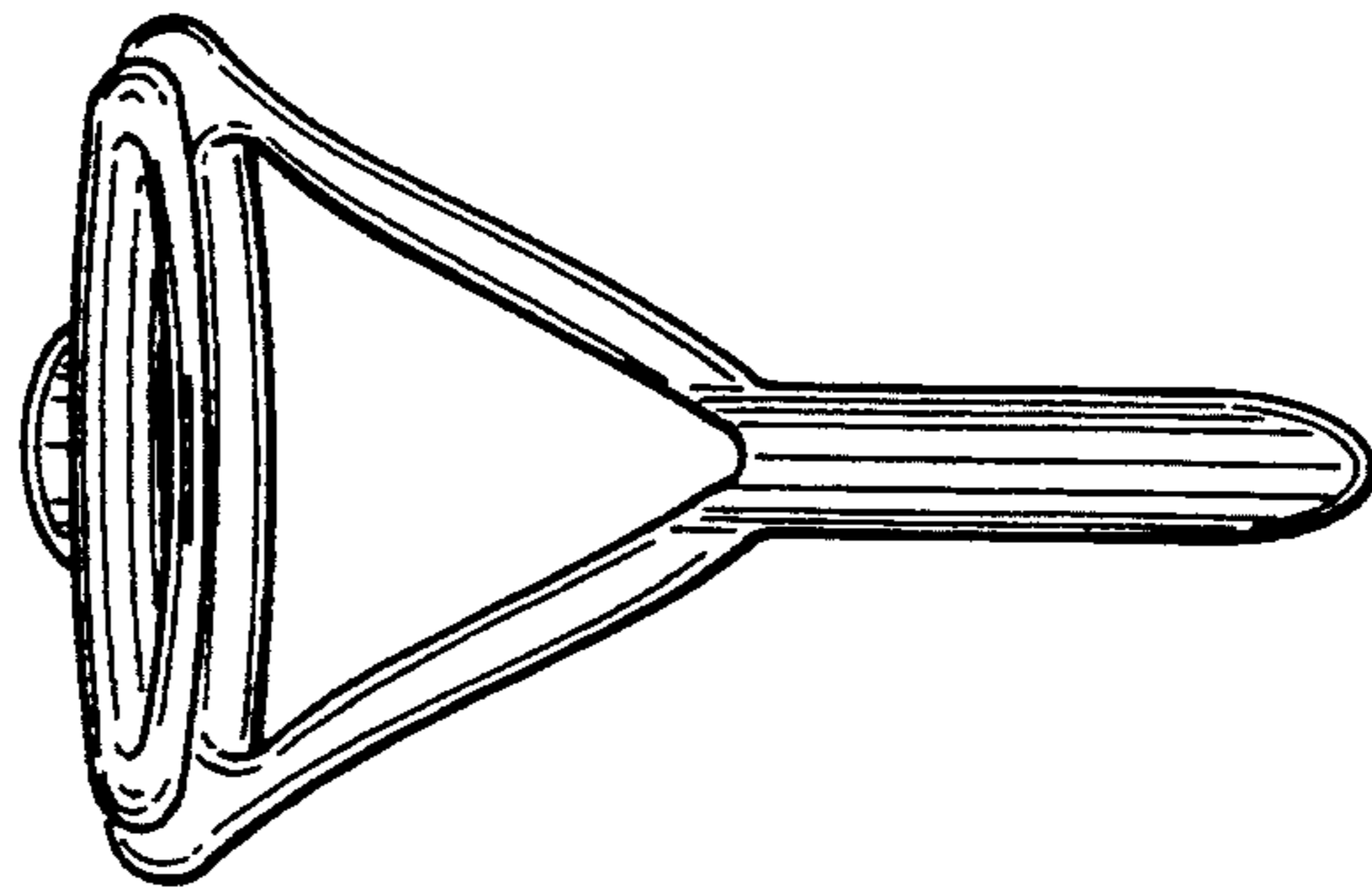

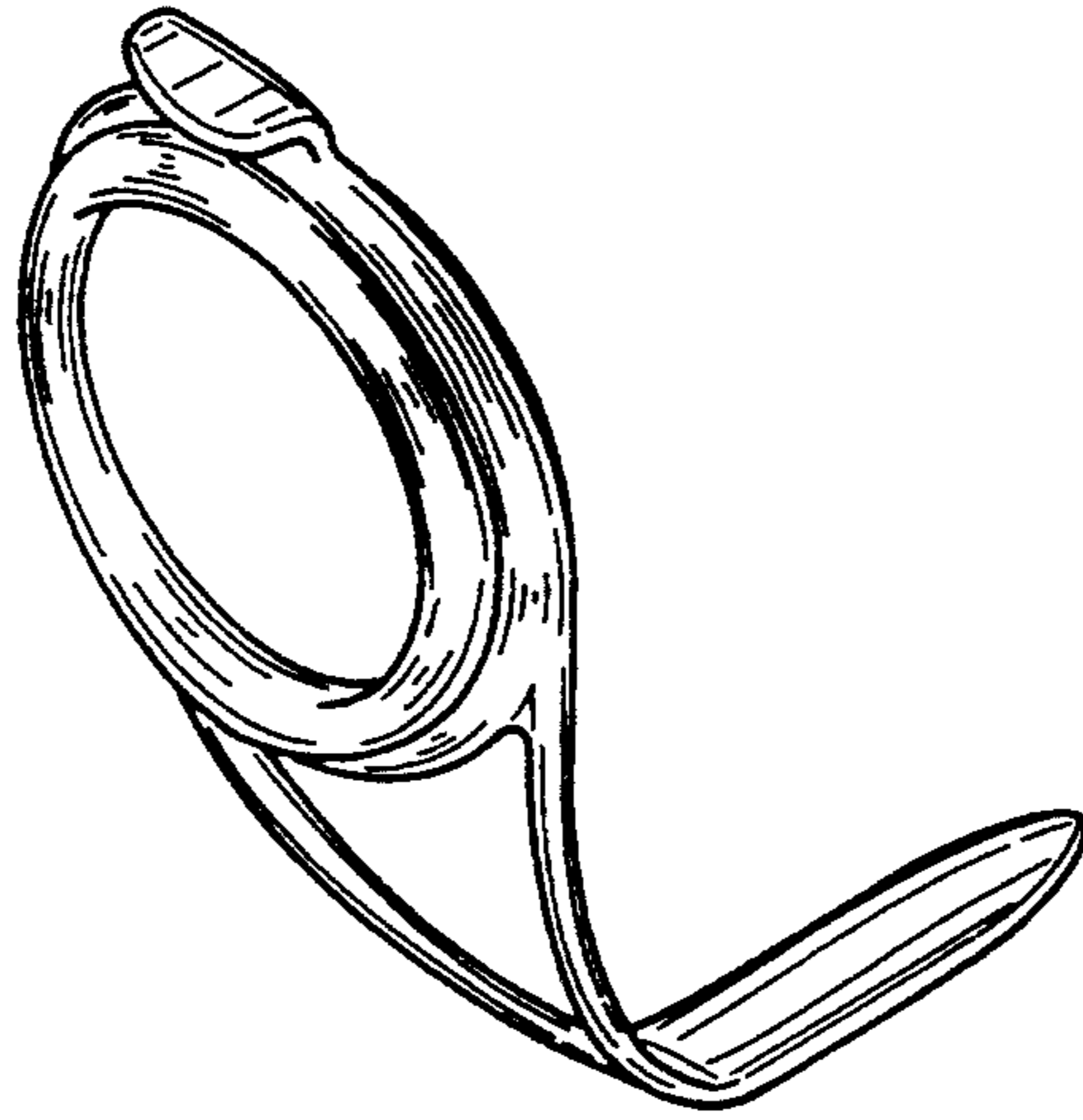

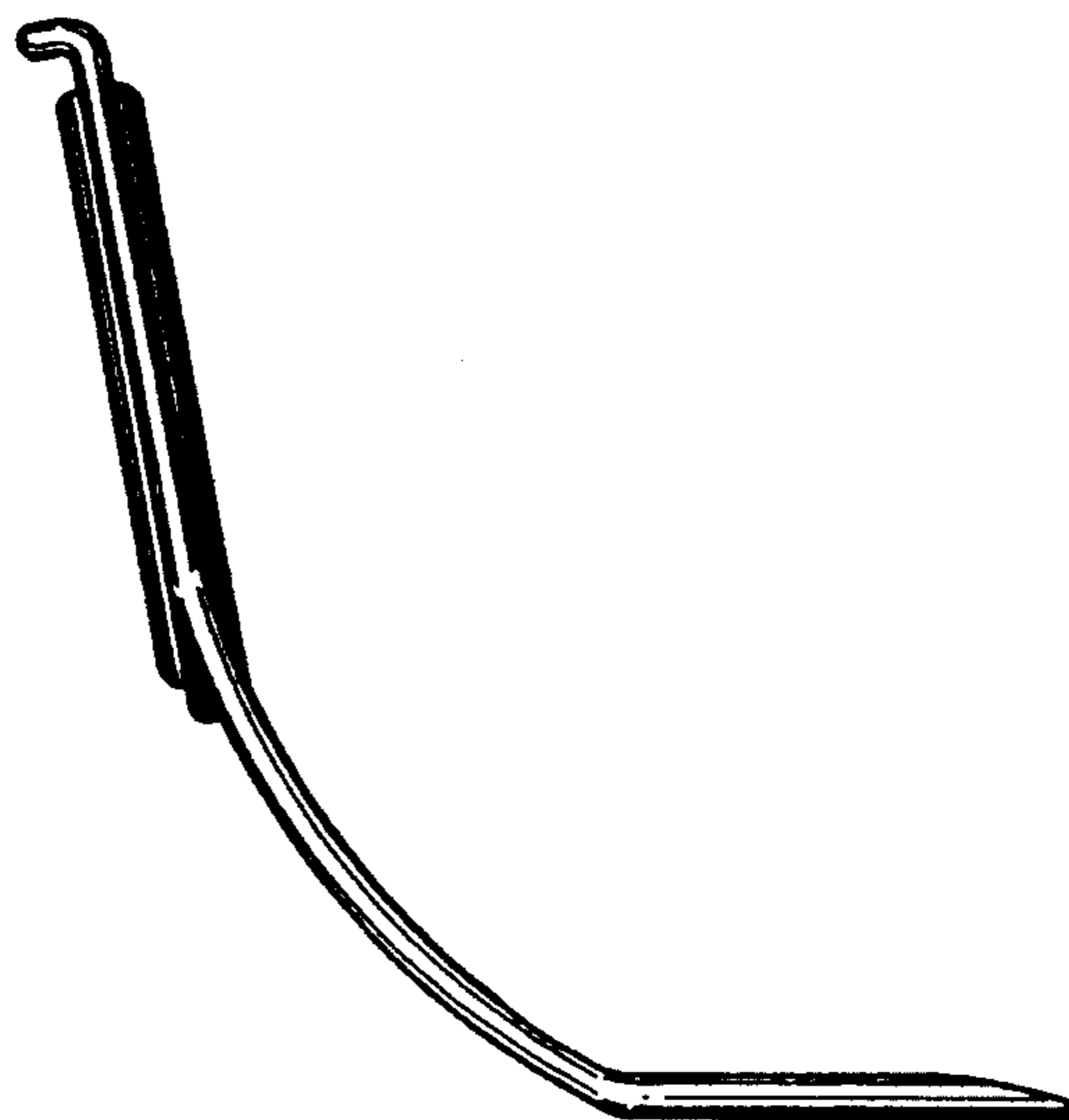

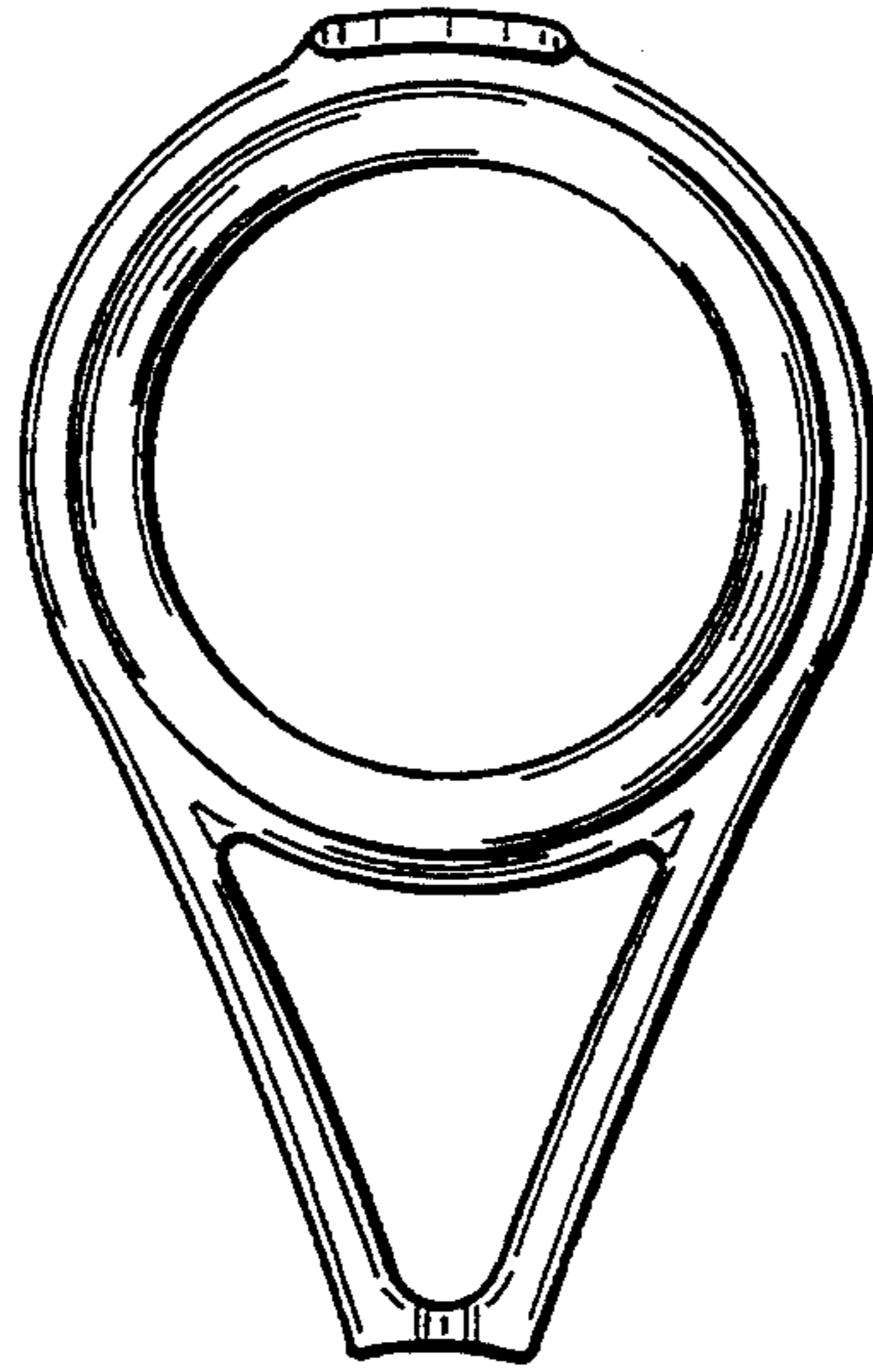

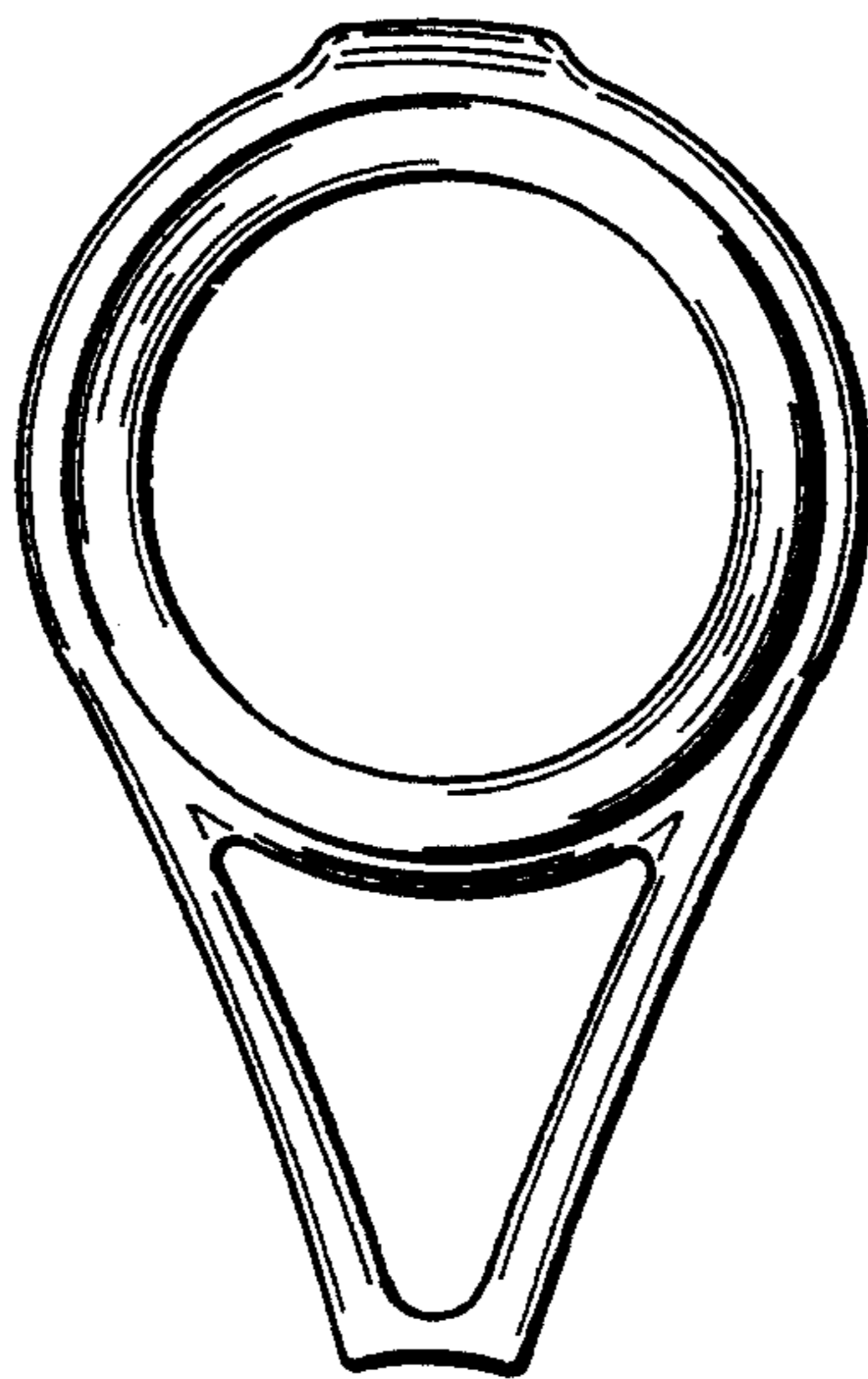

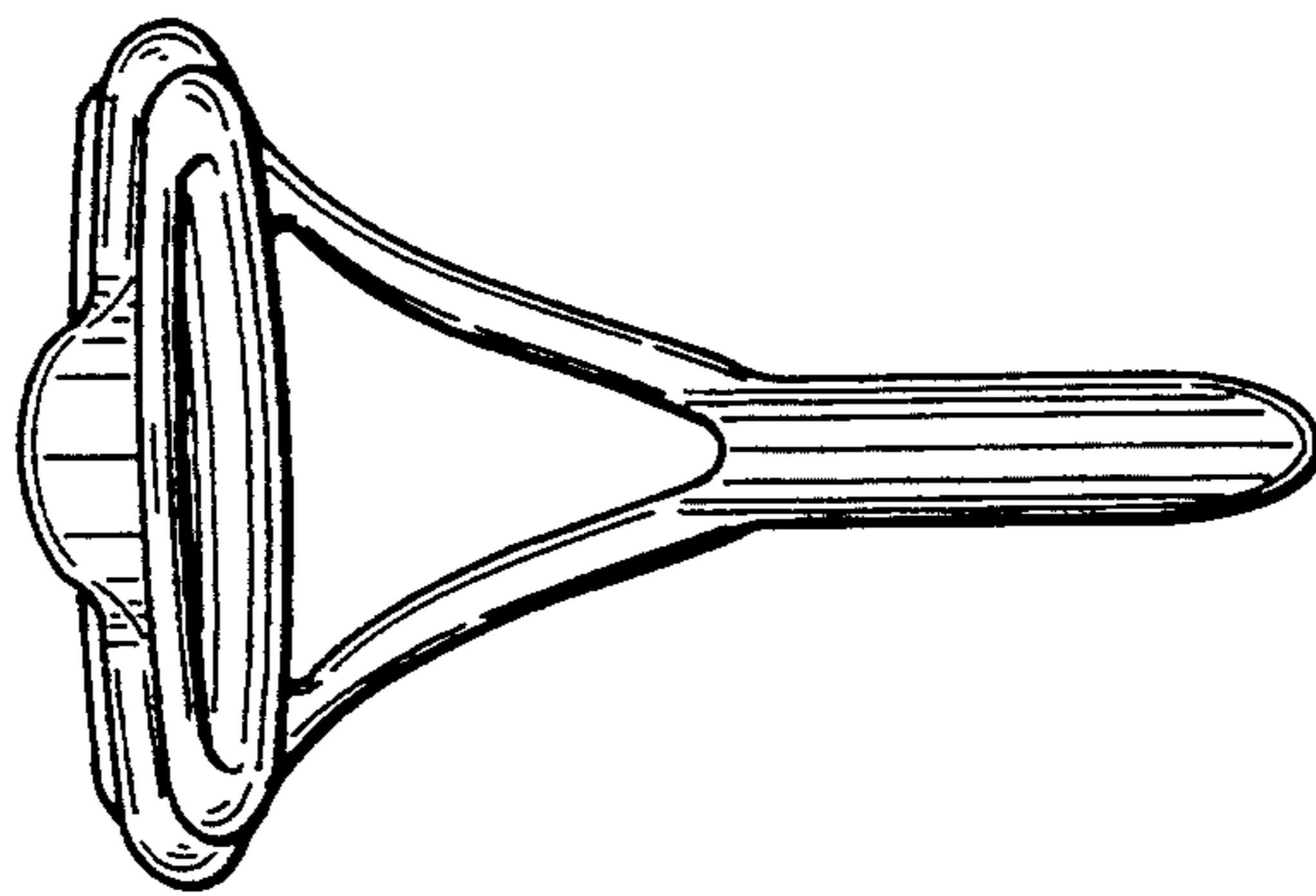
