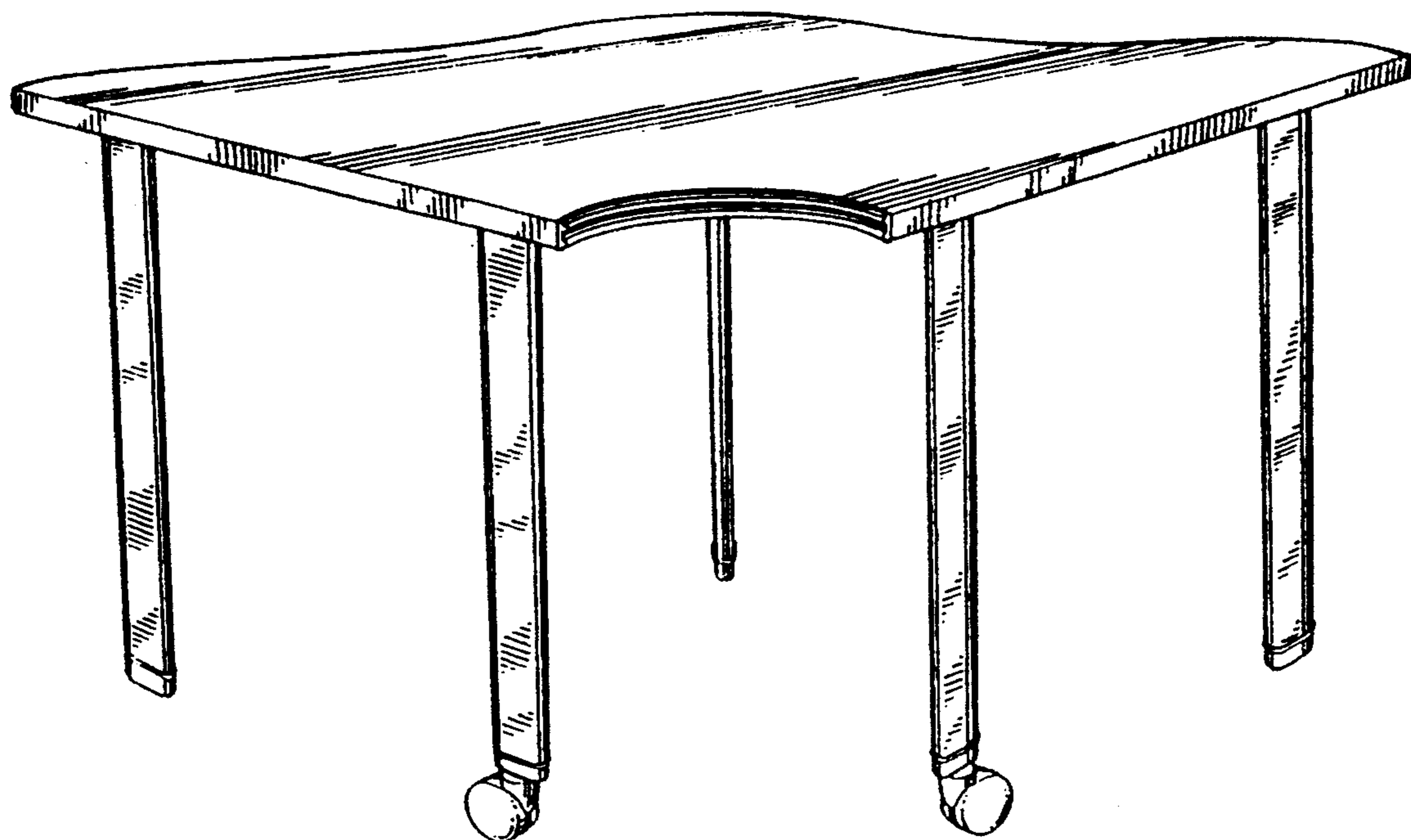

[57] **CLAIM**

The ornamental design for a mobile table, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of a mobile table, showing my new design;
FIG. 2 is a front perspective view;
FIG. 3 is a side elevational view taken from an exterior side thereof;
FIG. 4 is a top plan view;
FIG. 5 is a side elevational view taken from an interior side thereof; and,
FIG. 6 is an enlarged, fragmentary perspective view of an edge portion thereof.



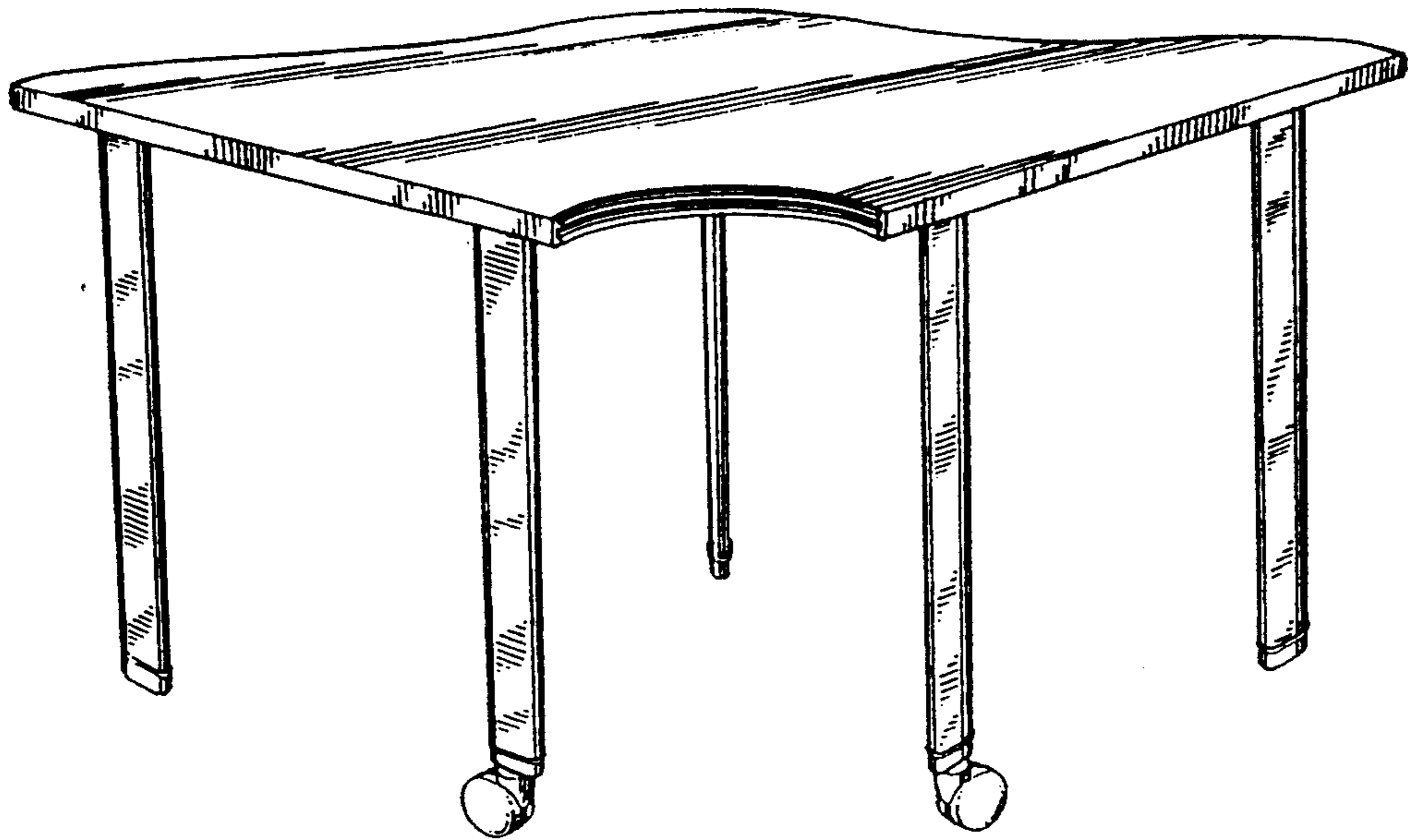

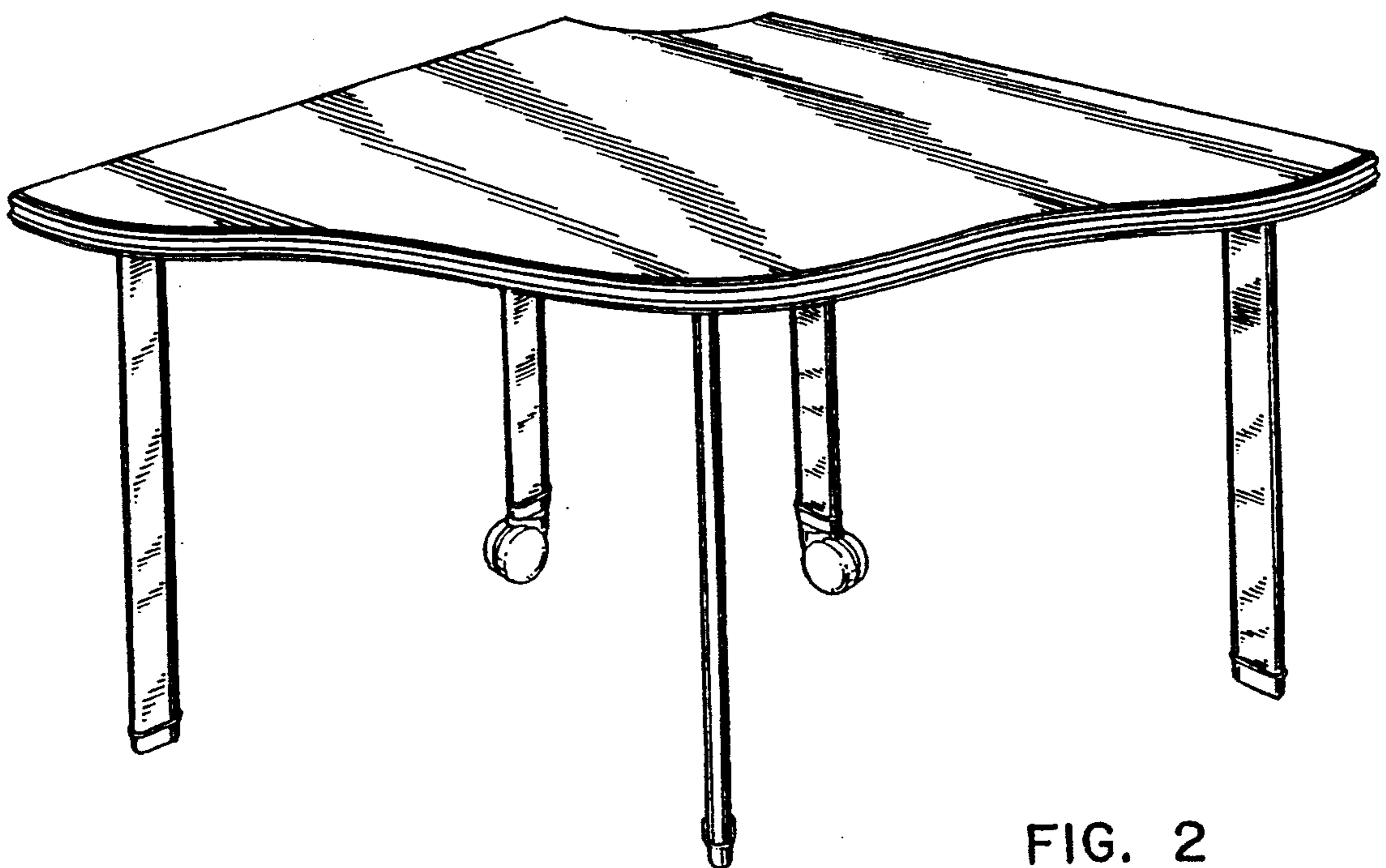

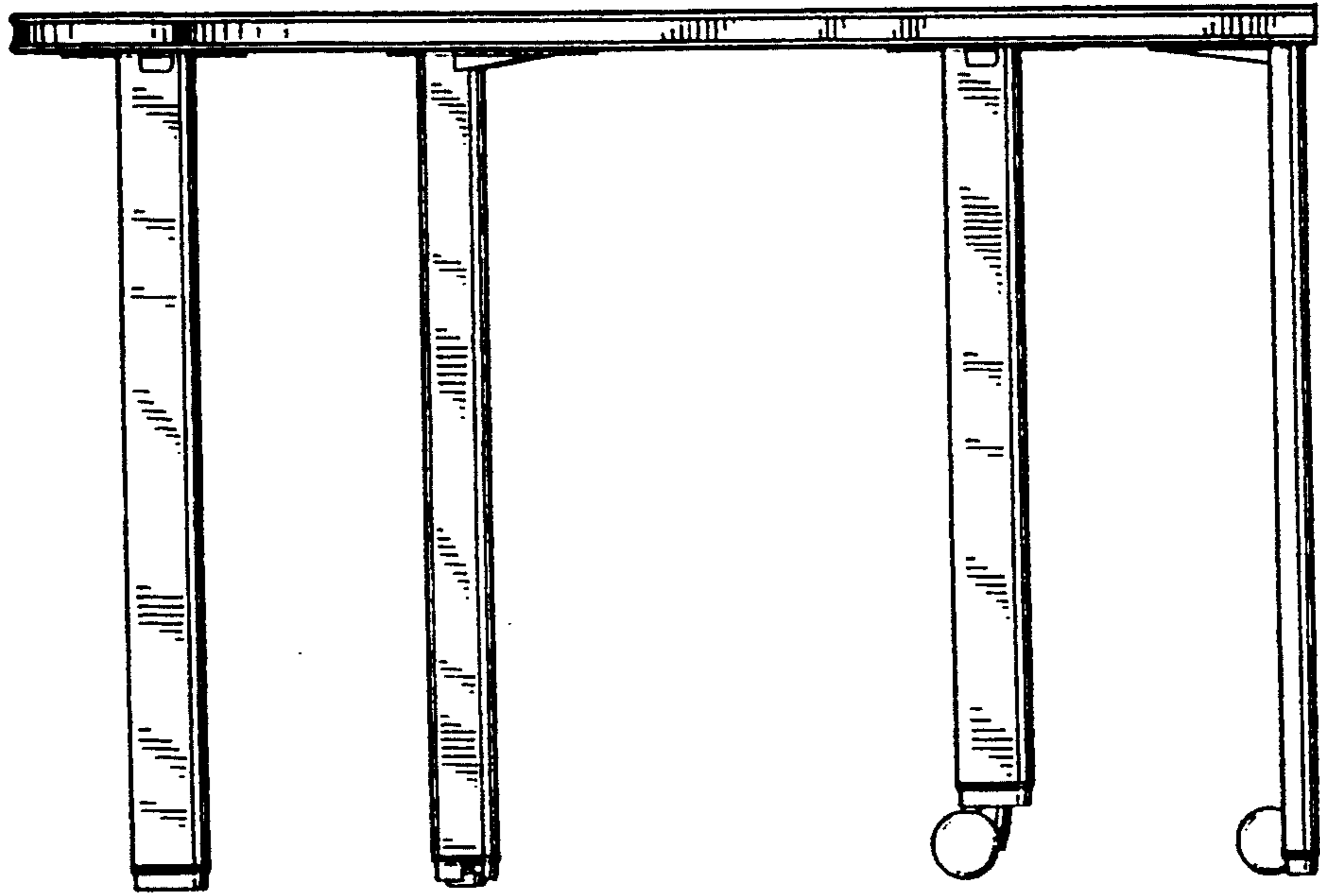

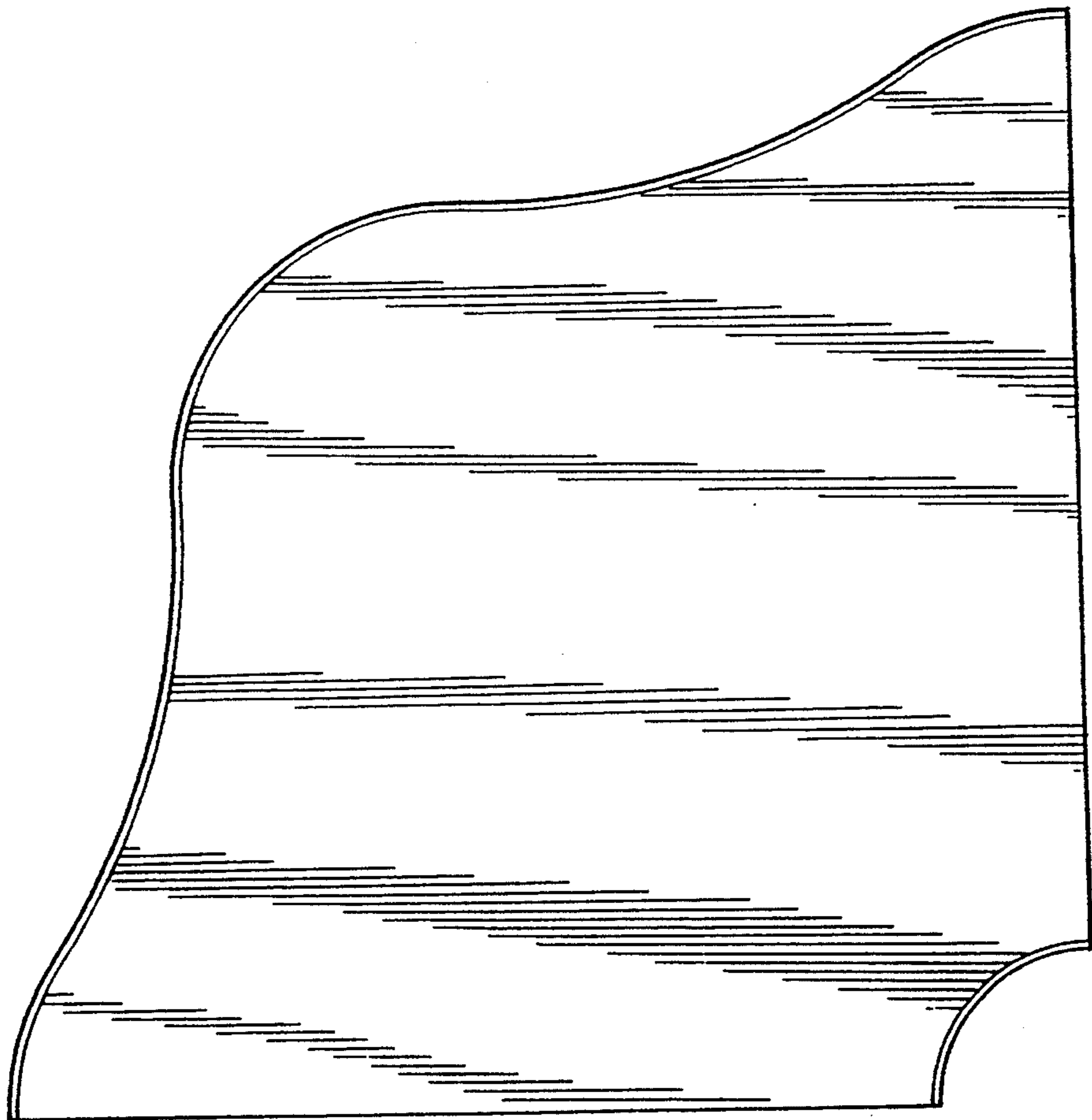

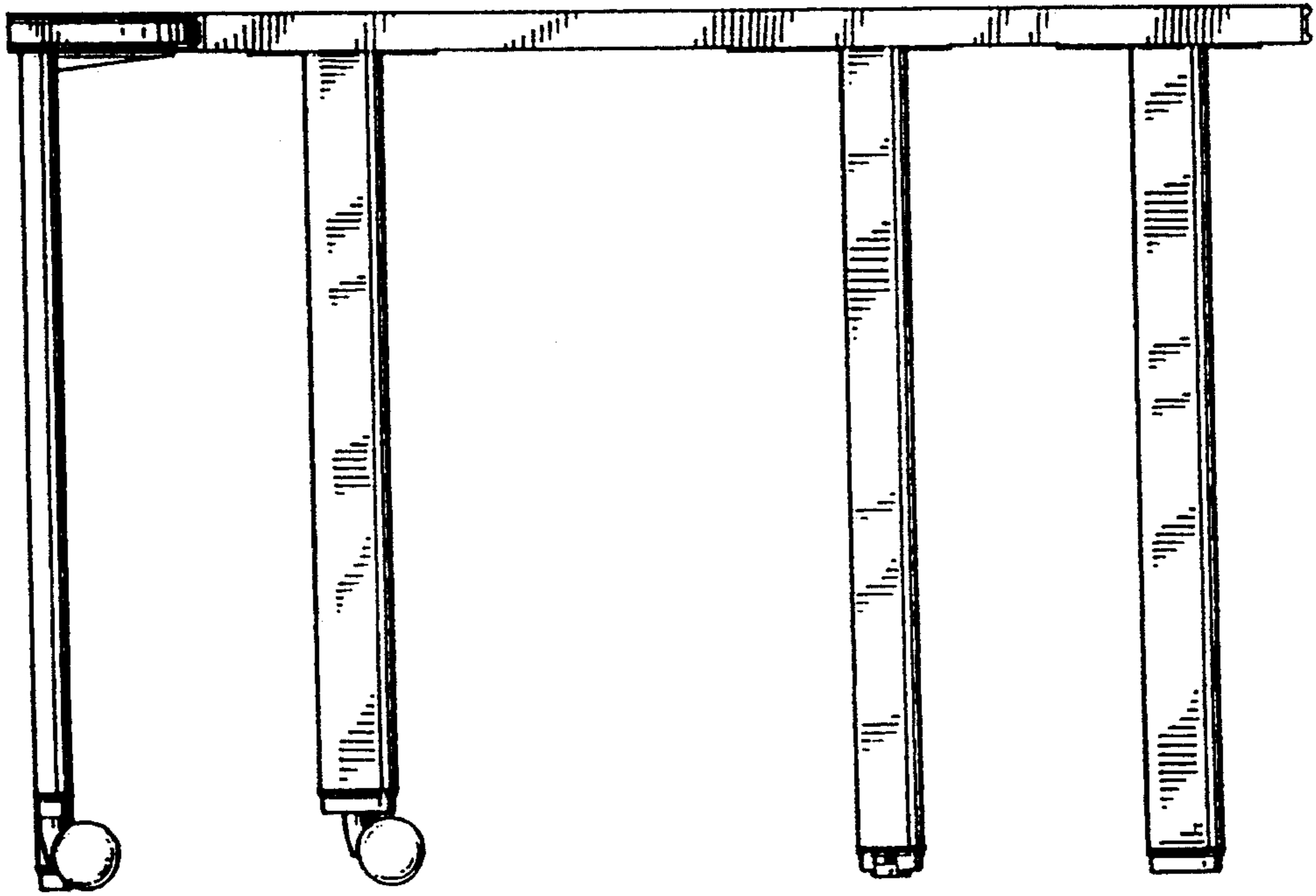

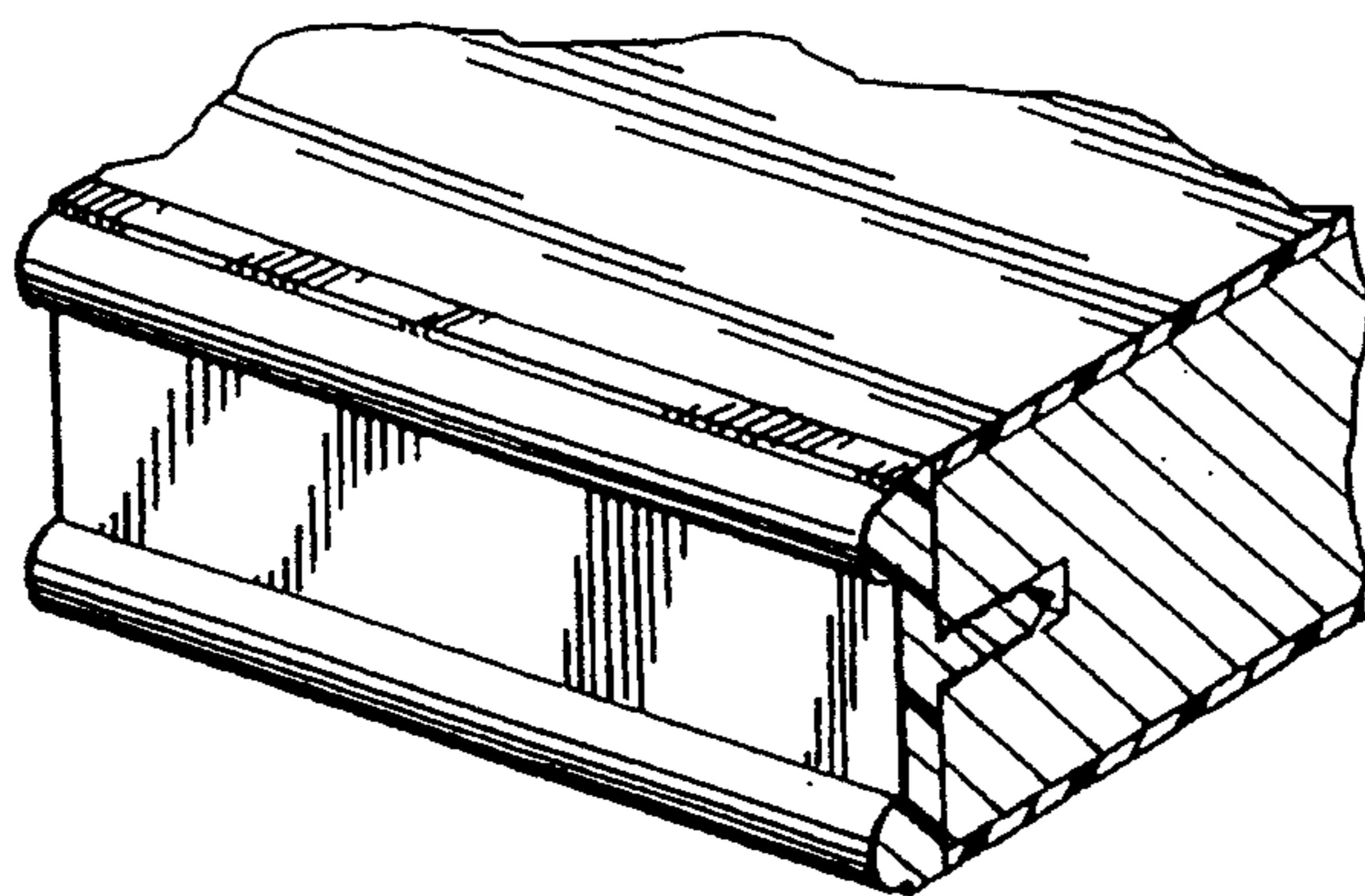
