[57] **CLAIM**

The ornamental design for a knife blade, as shown.

DESCRIPTION

FIG. 1 is a right side elevational view of a knife blade showing my new design, the left side being a mirror image thereof;

FIG. 2 is a top plan view thereof;

FIG. 3 is a bottom view thereof;

FIG. 4 is a front elevational view thereof;

FIG. 5 is a rear elevational view thereof;

FIG. 6 is a right side elevational view of a modified embodiment thereof, the left side being a mirror image thereof;

FIG. 9 is a front elevational view thereof;

FIG. 10 is a rear elevational view thereof;

FIG. 11 is a right side elevational view of a second modified embodiment thereof, the left side being a mirror image thereof;

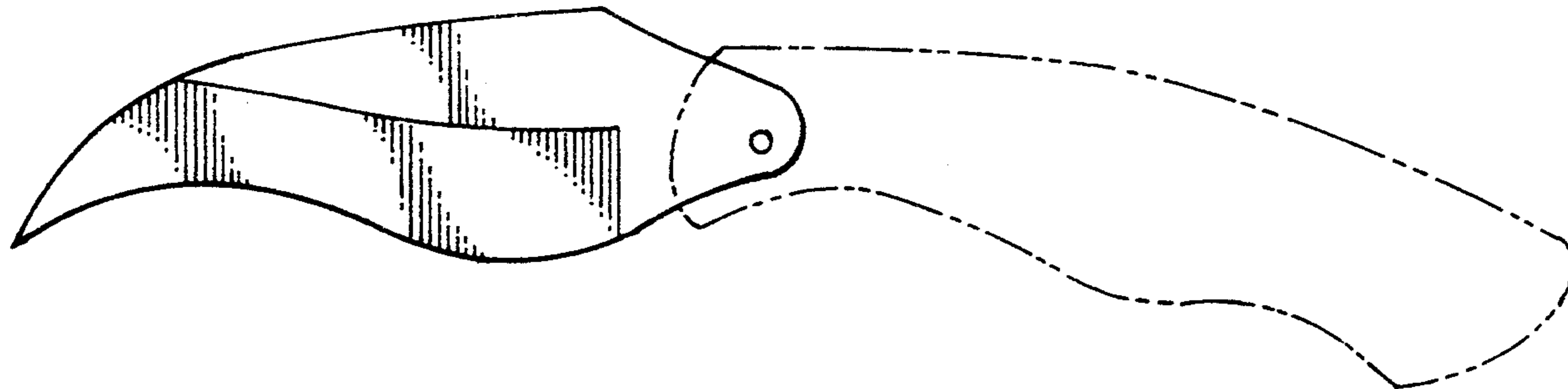
FIG. 12 is a top plan view thereof;

The broken line showing of the handle in FIGS. 1, 6 and 11 is for illustrative purposes only and form no part of the claimed design.



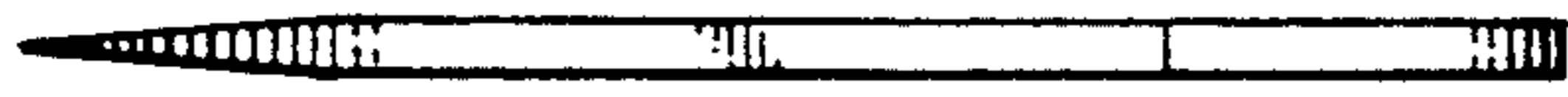
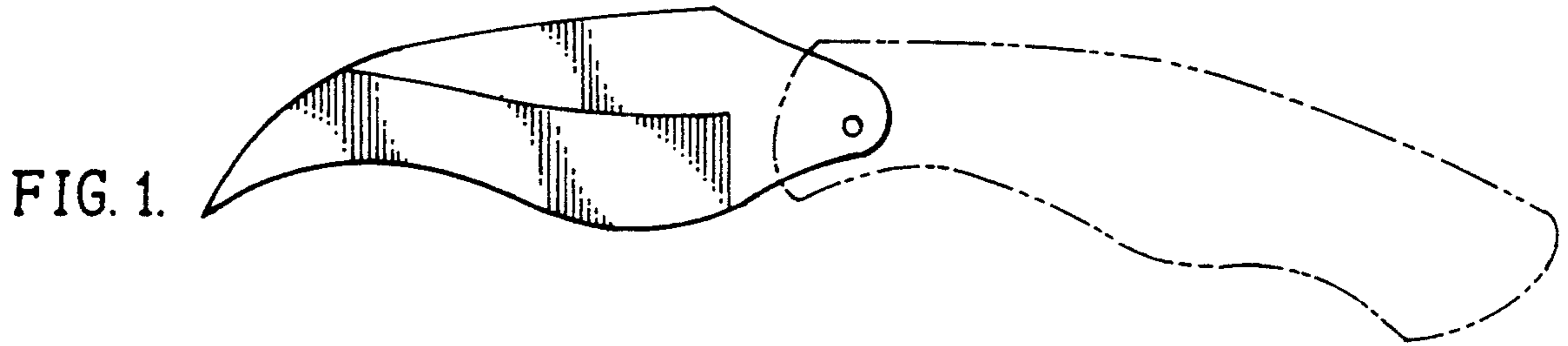

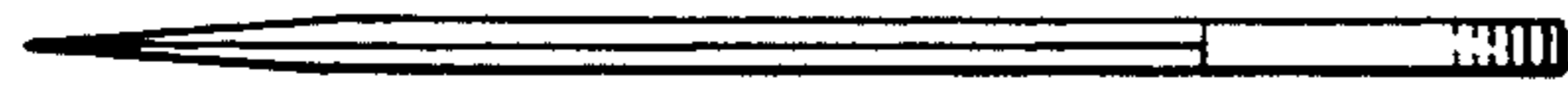

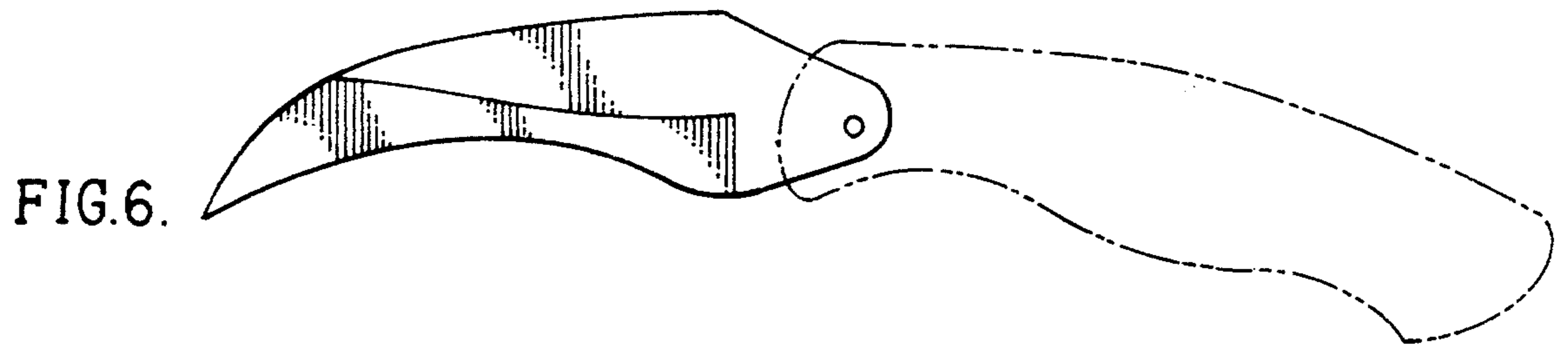

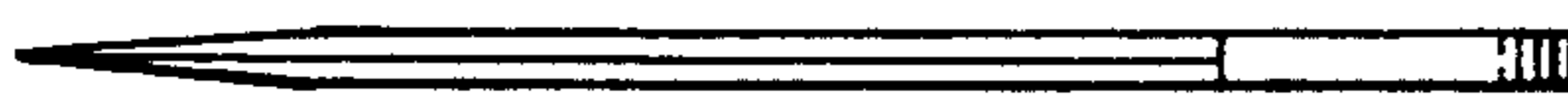

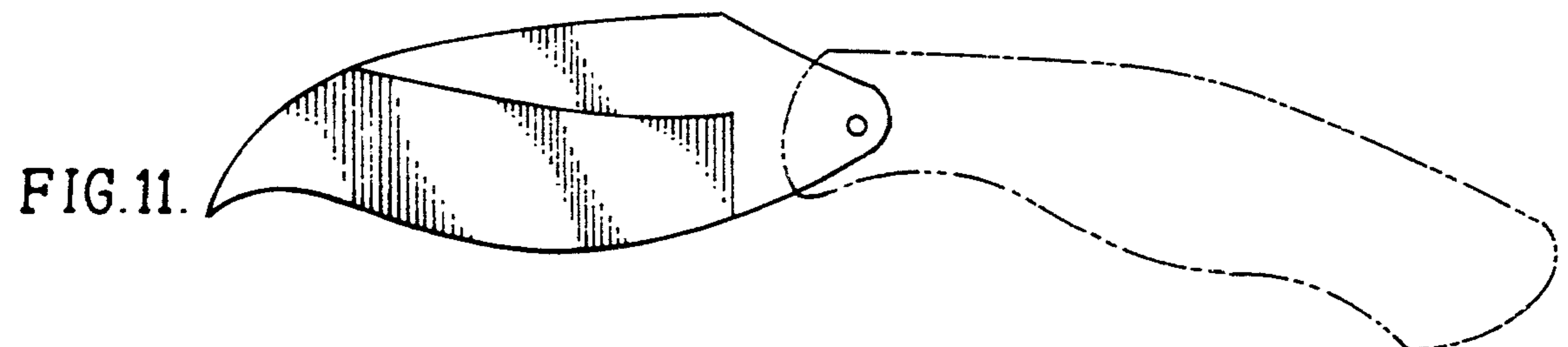

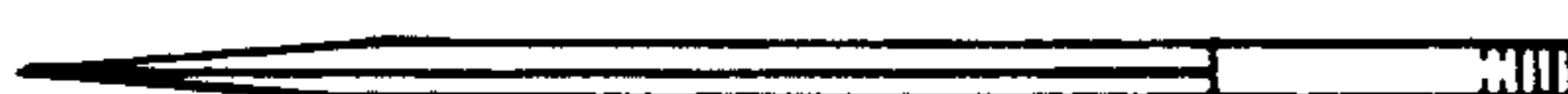
