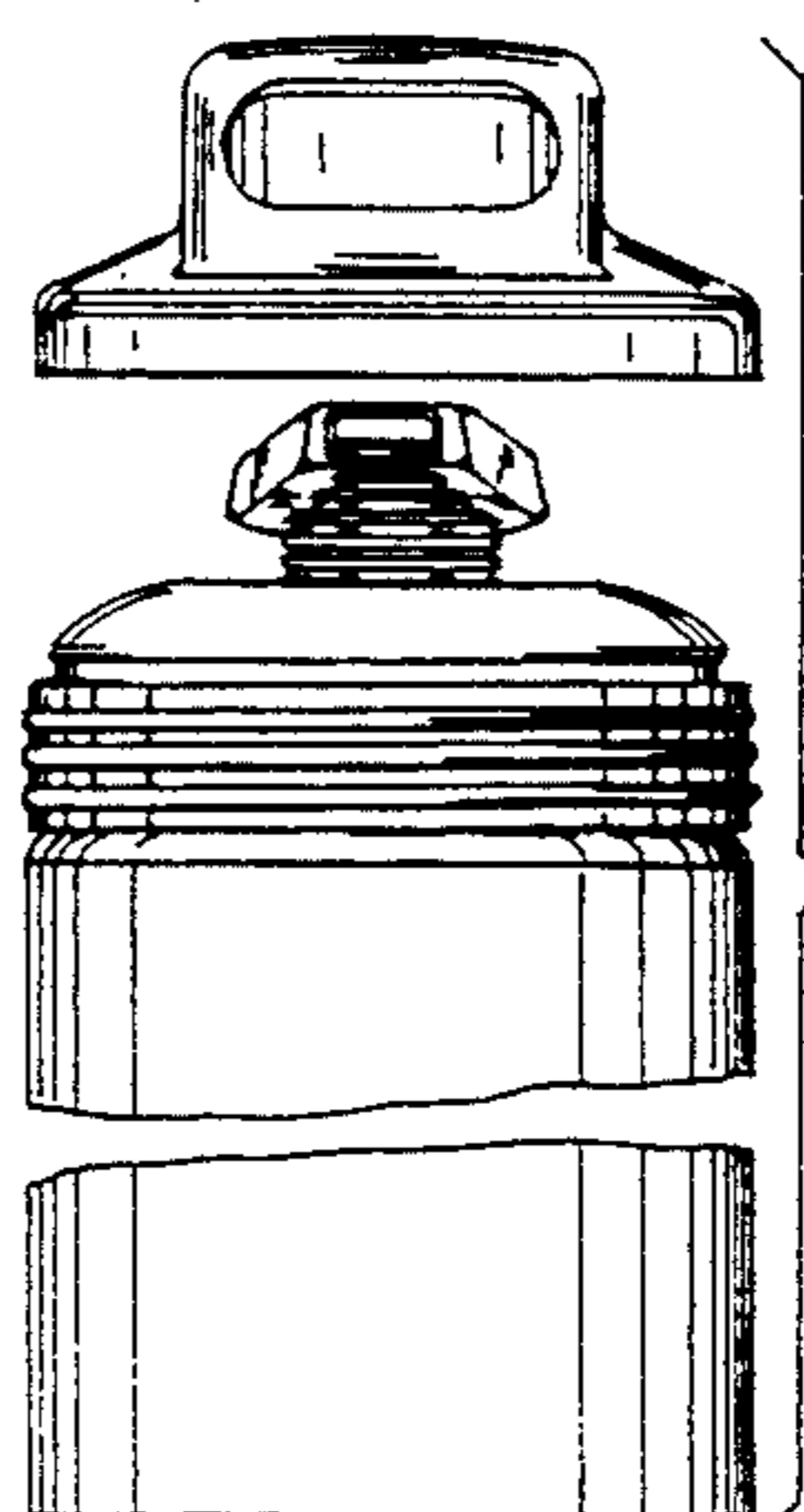
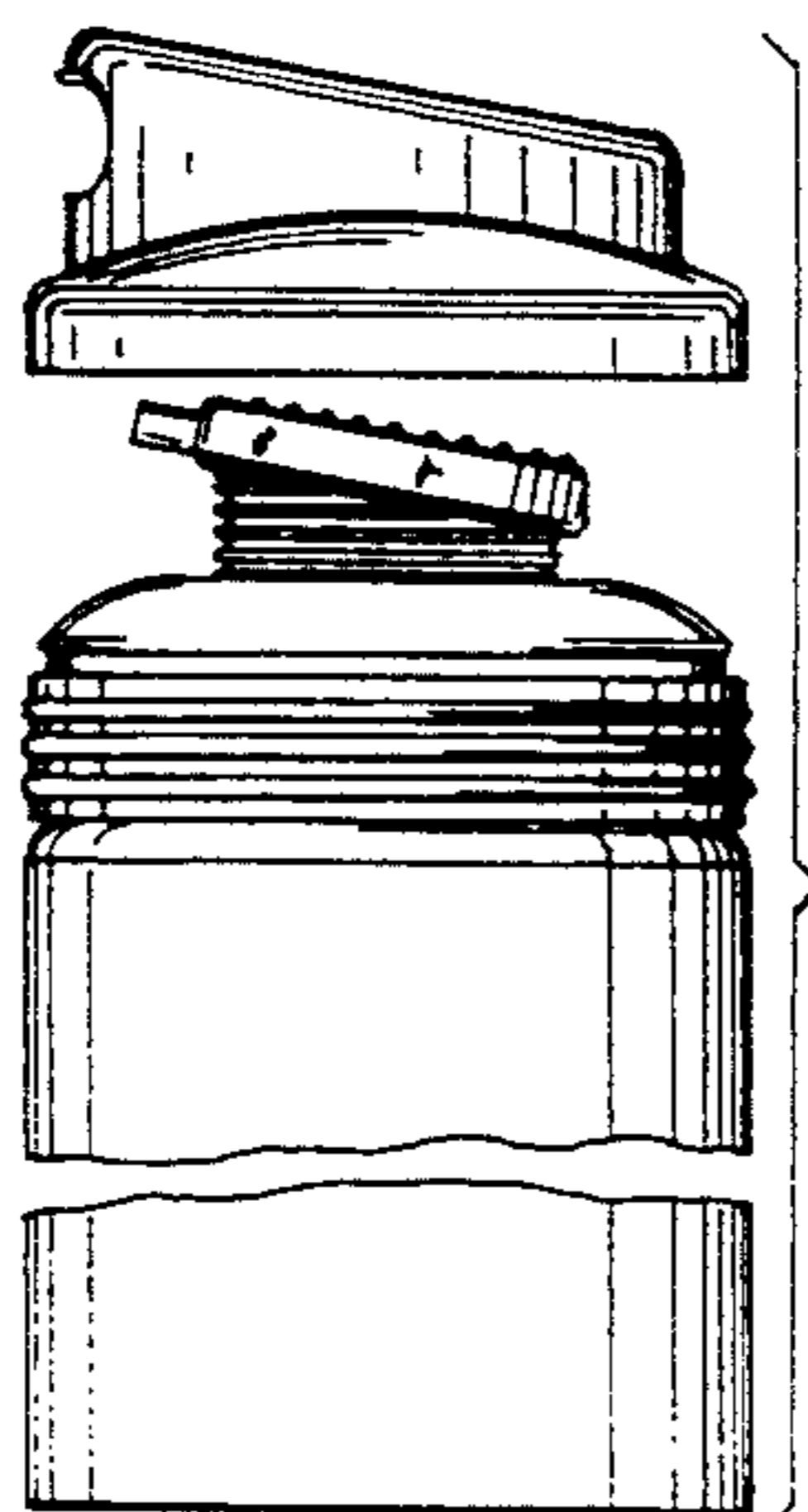
[57] CLAIM

The ornamental design for a combination actuator and hood for dispensing foam material, as shown and described.

DESCRIPTION

FIG. 1 is an exploded left side elevational view of a combined actuator and hood for dispensing foam material showing my new design, the undisclosed opposite side being a mirror image;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a rear elevational view thereof;
 FIG. 4 is a top plan view of the hood, shown for clarity of illustration;
 FIG. 5 is a top plan view of the actuator, shown for clarity of illustration;
 FIG. 6 is a bottom plan view of FIG. 4;
 FIG. 7 is a bottom plan view of FIG. 5; and
 FIG. 8 is a front elevational view.

The broken section is shown due to indeterminate length of the container.



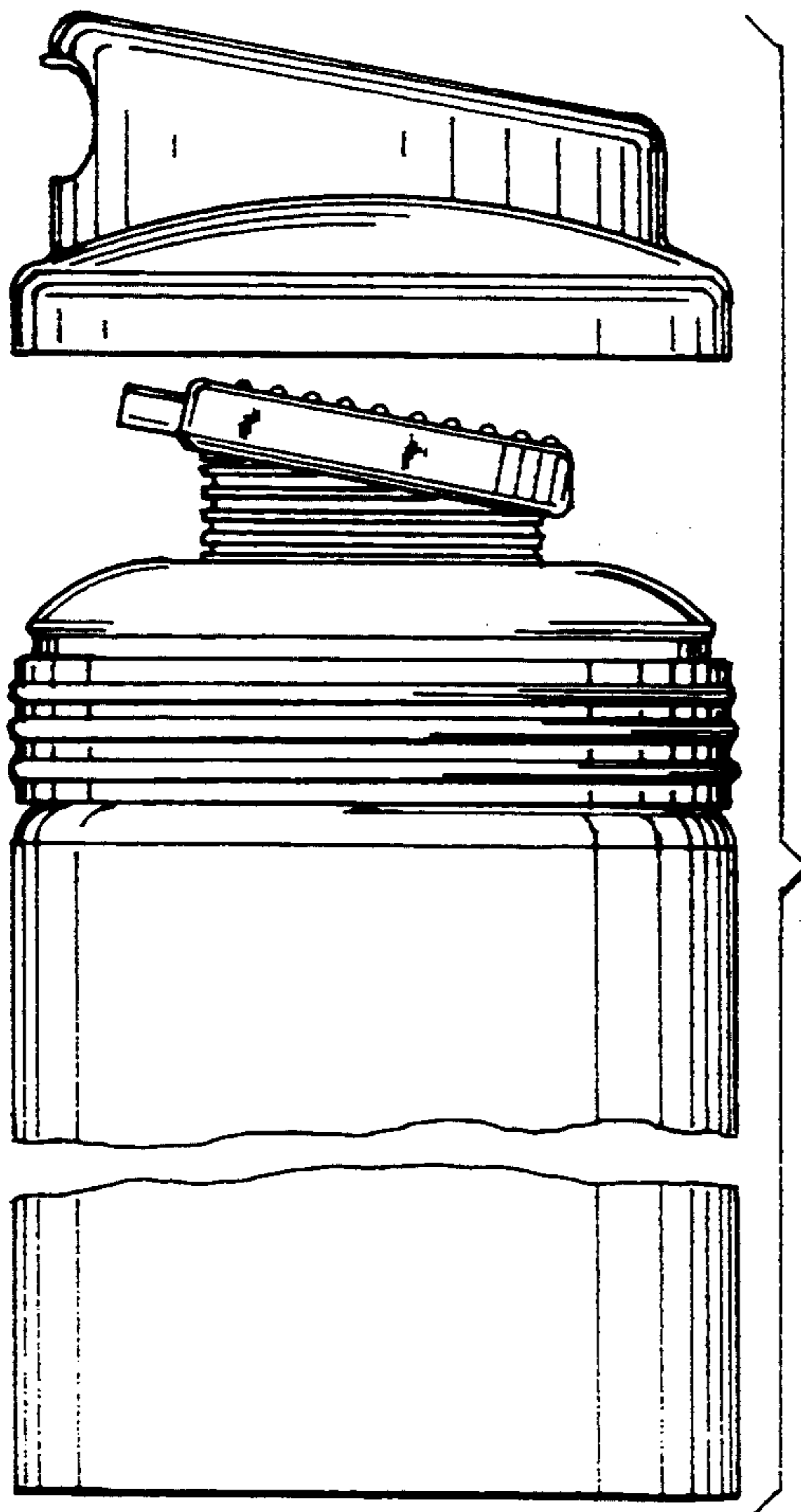

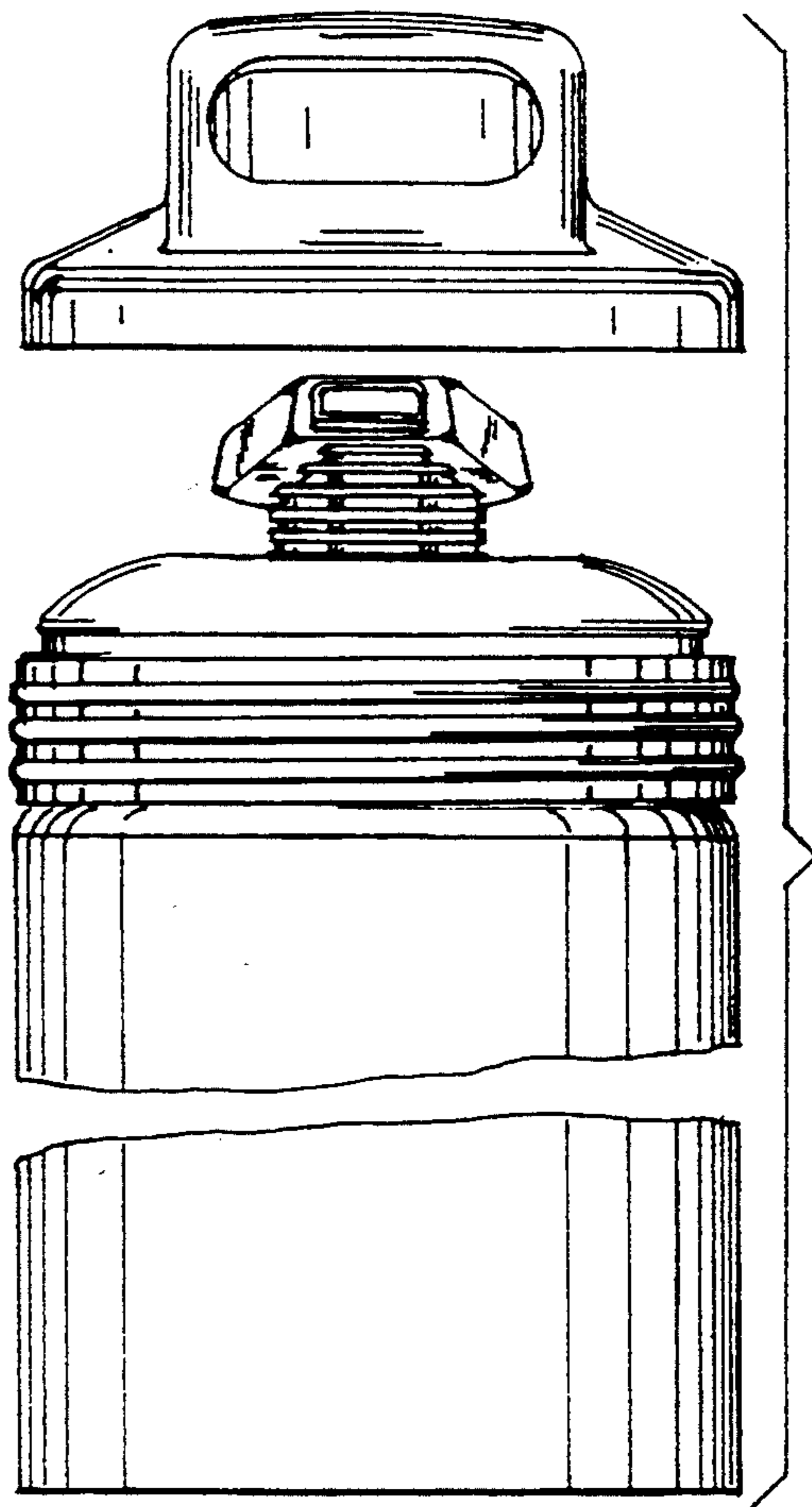

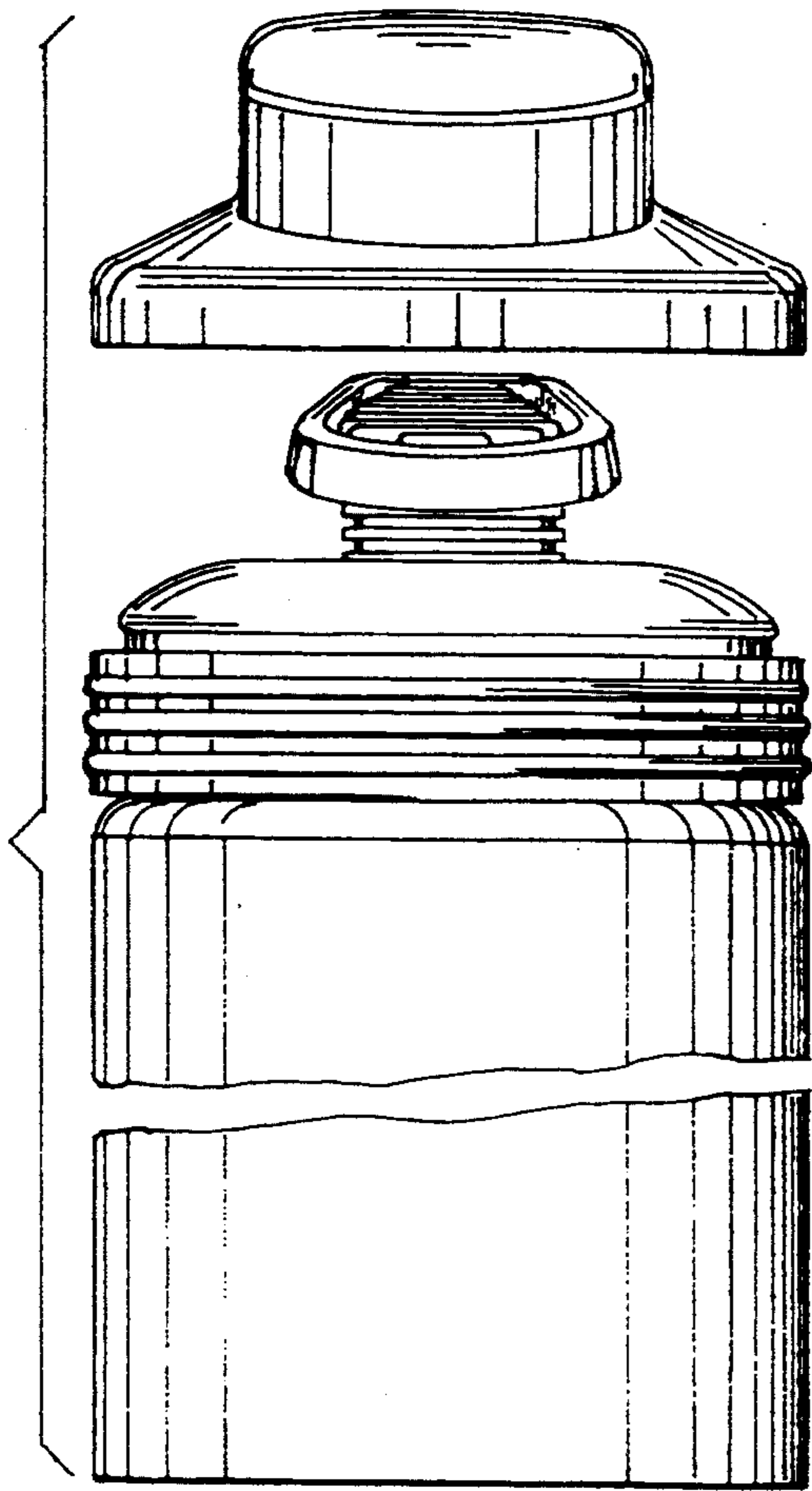

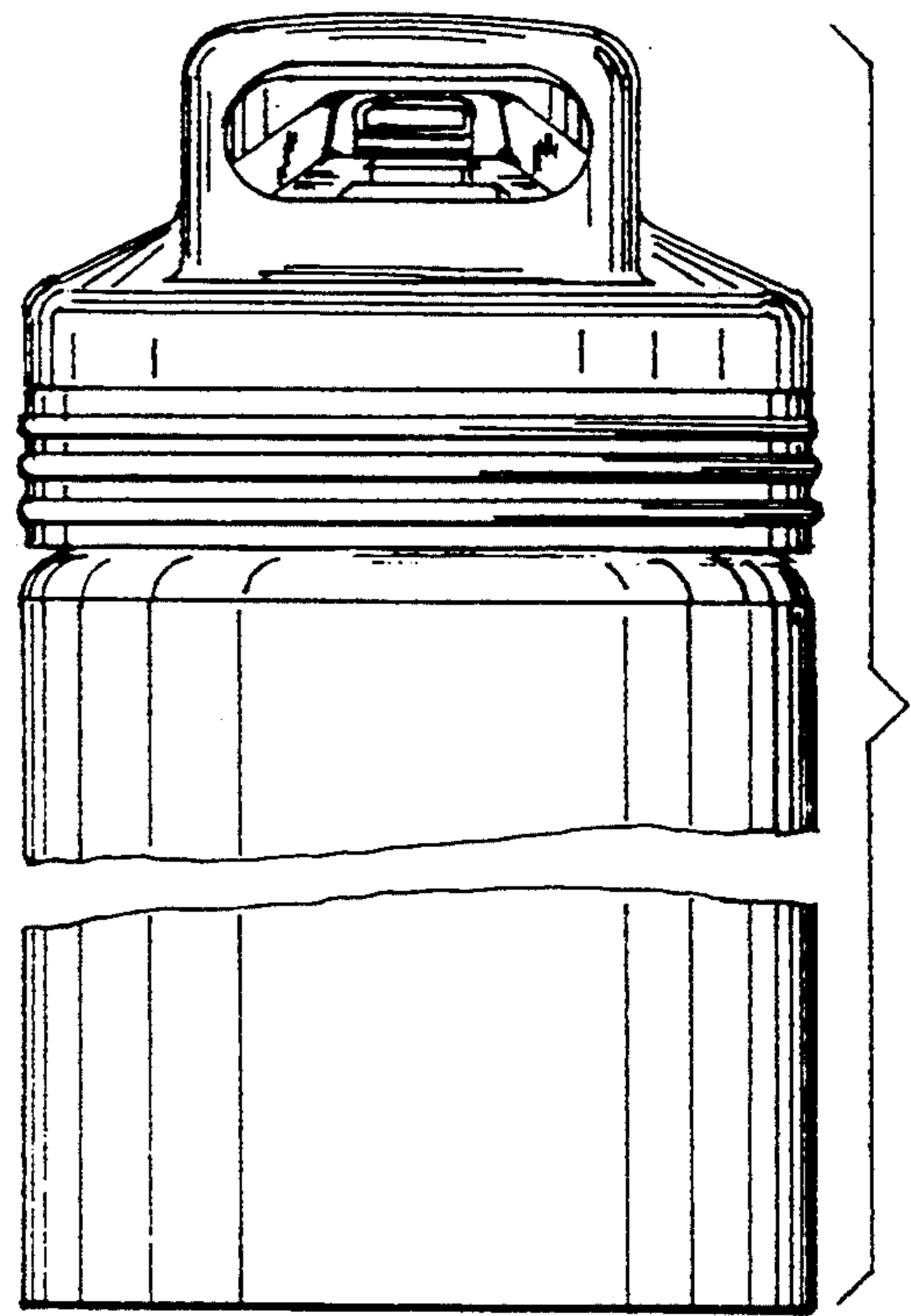

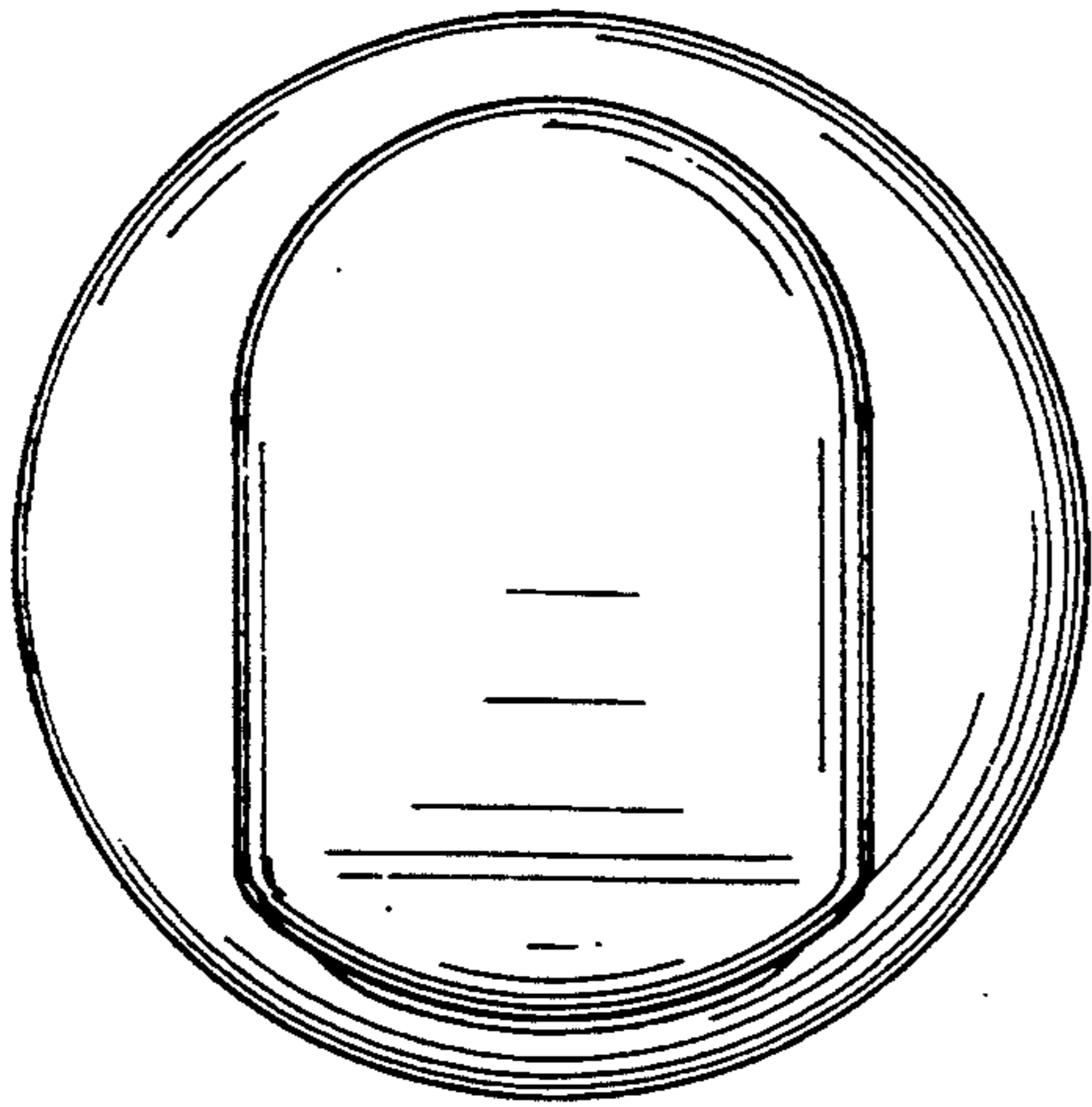

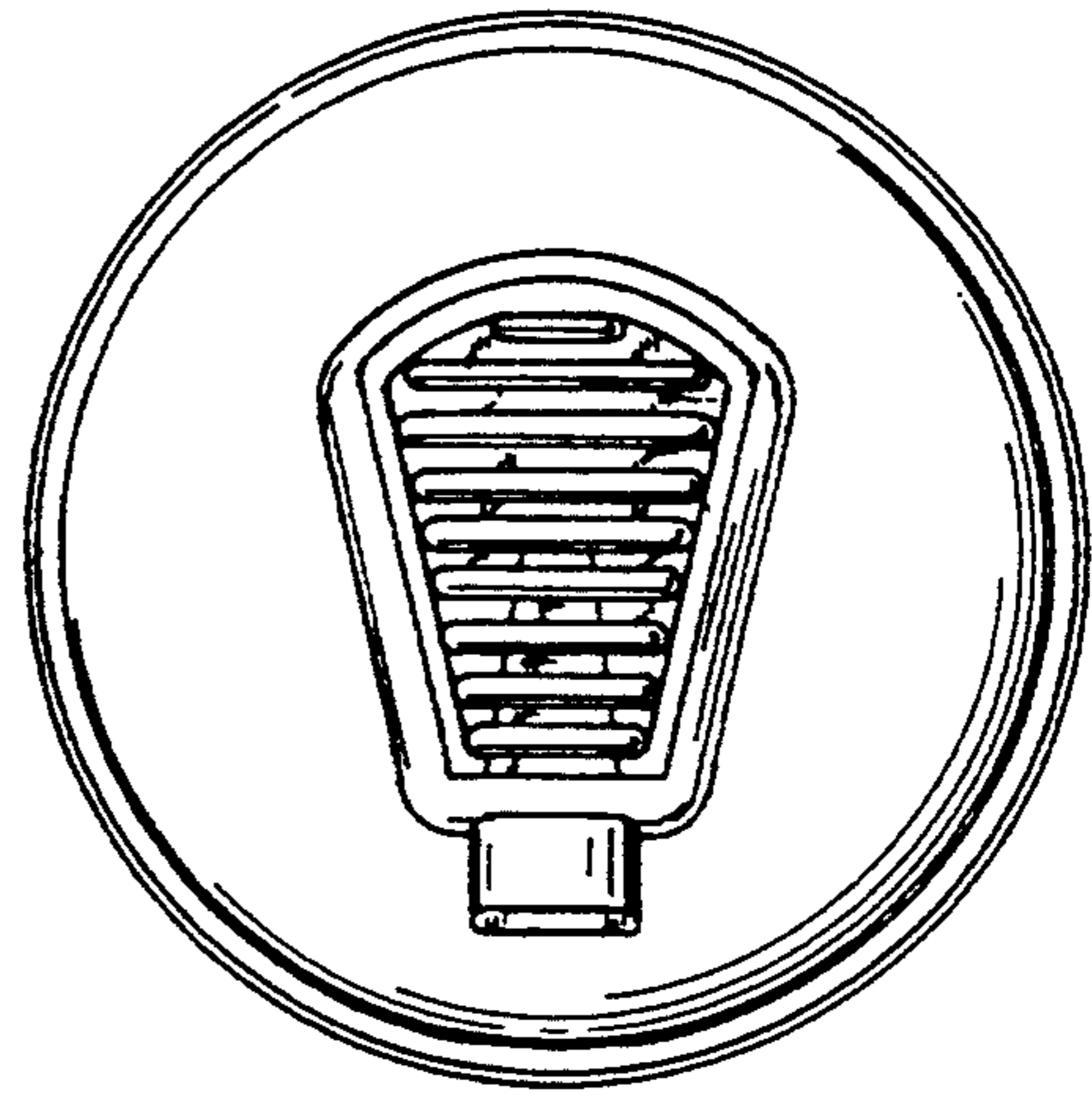

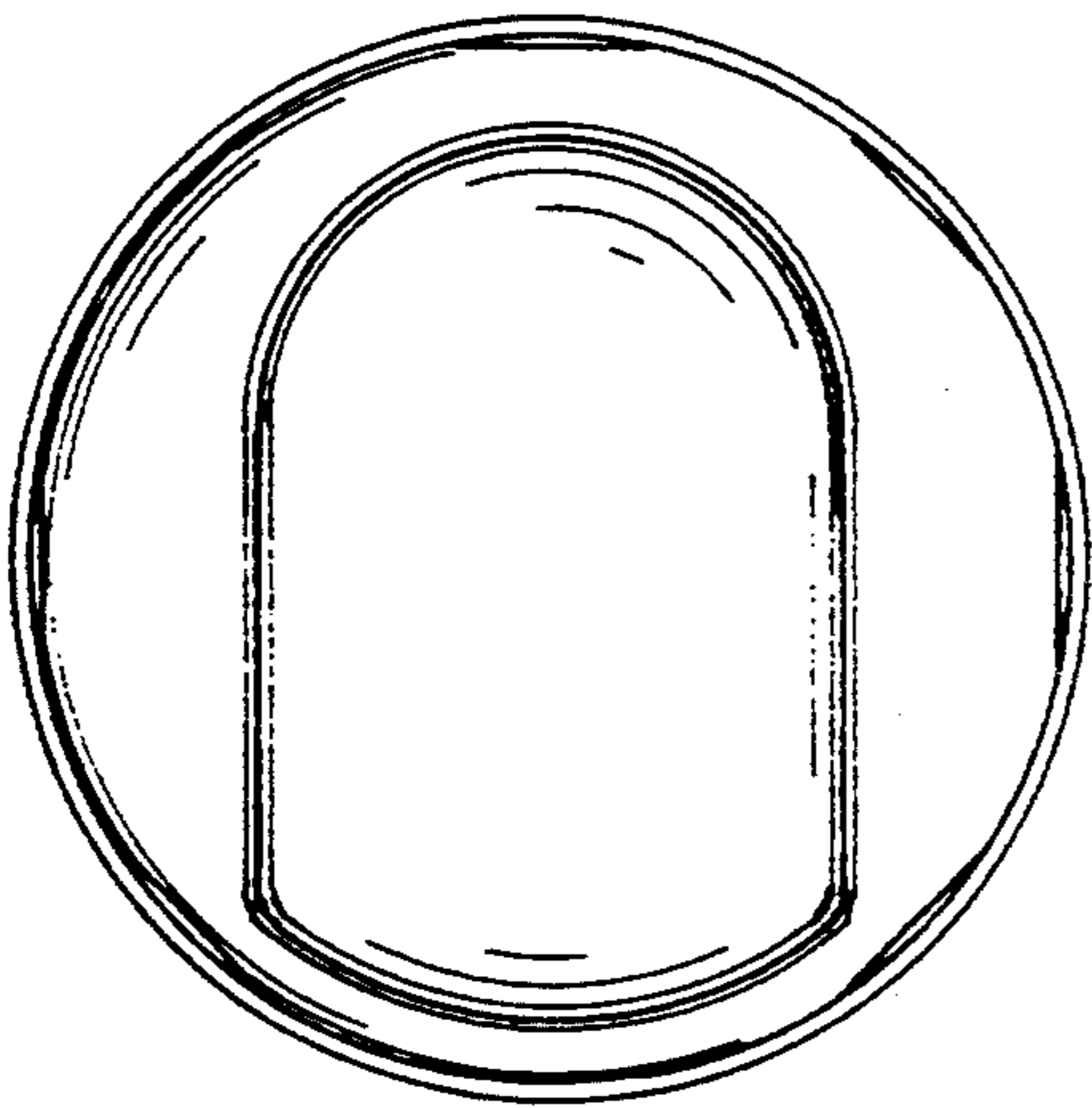

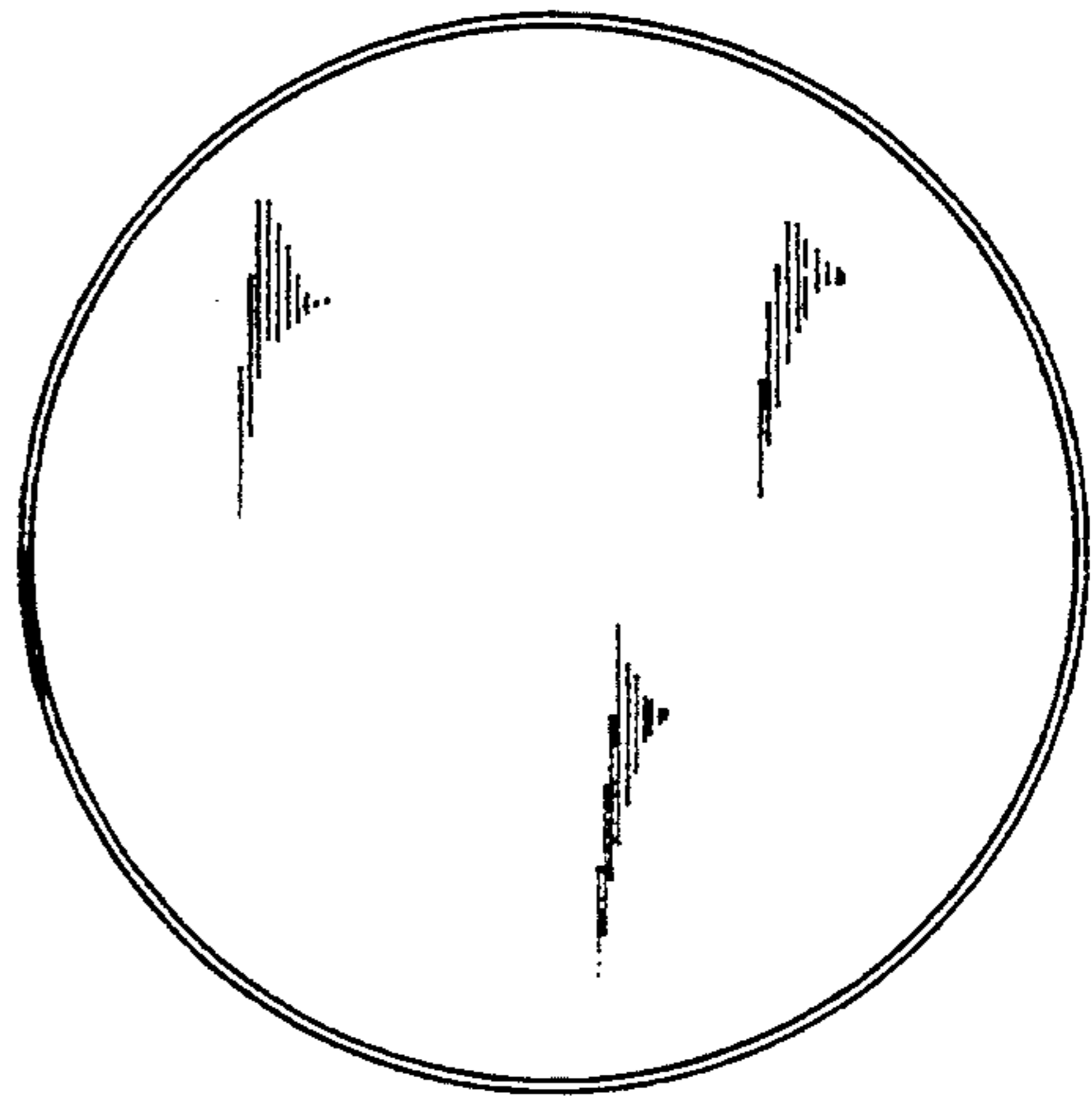
