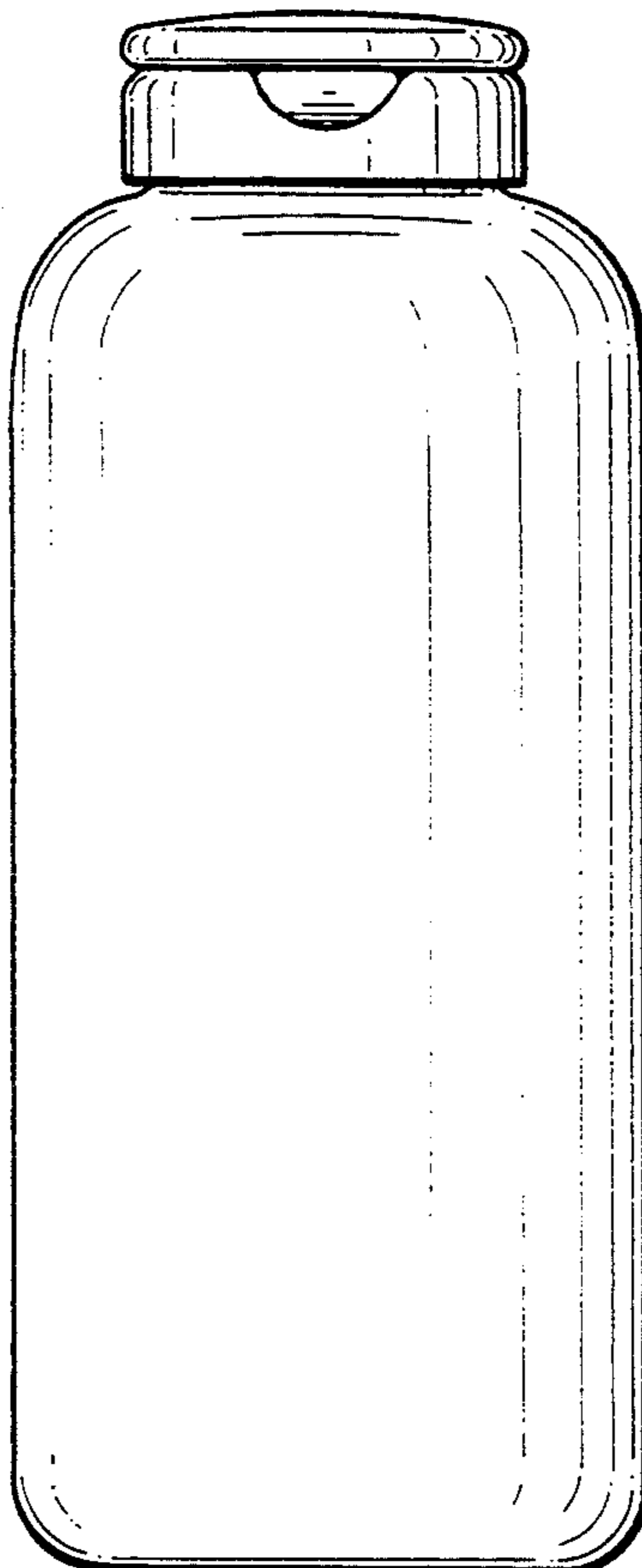

## [57] CLAIM

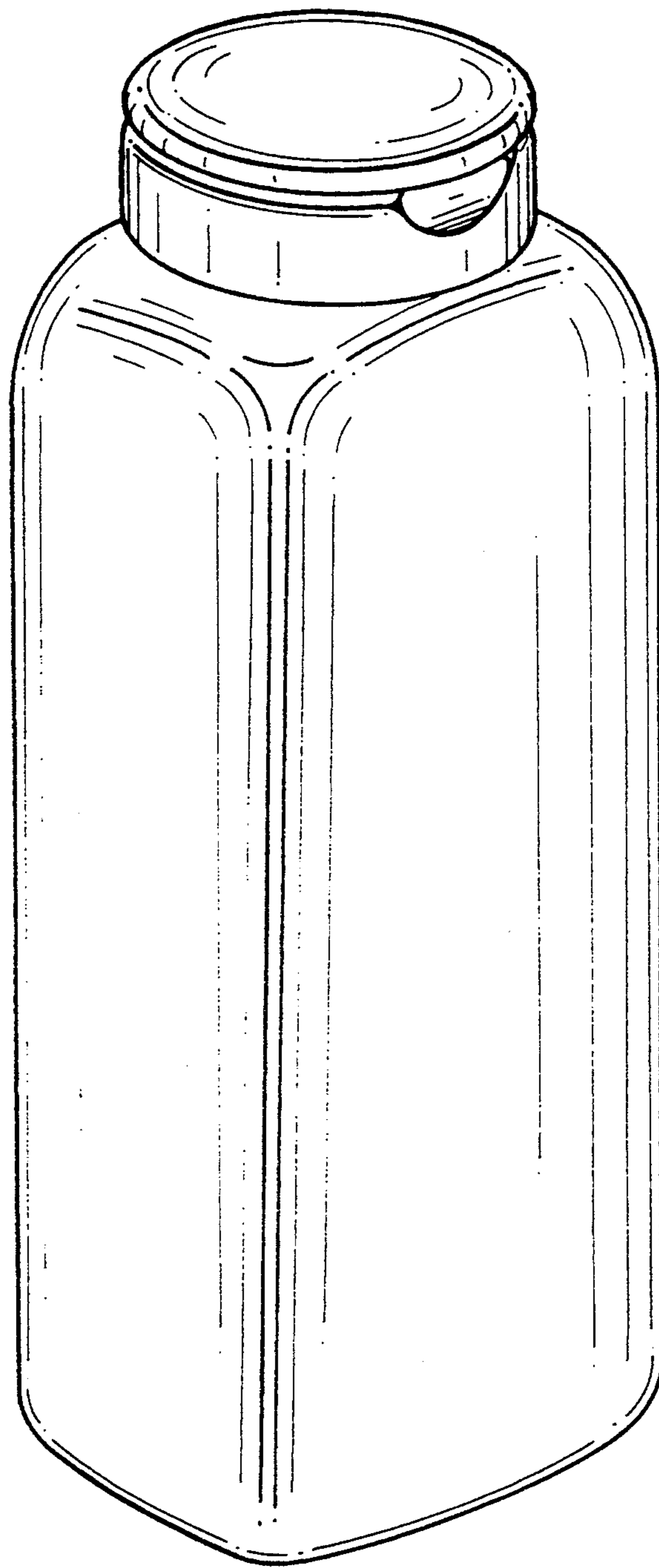
The ornamental design for a combined bottle and cap, as shown and described.

## DESCRIPTION

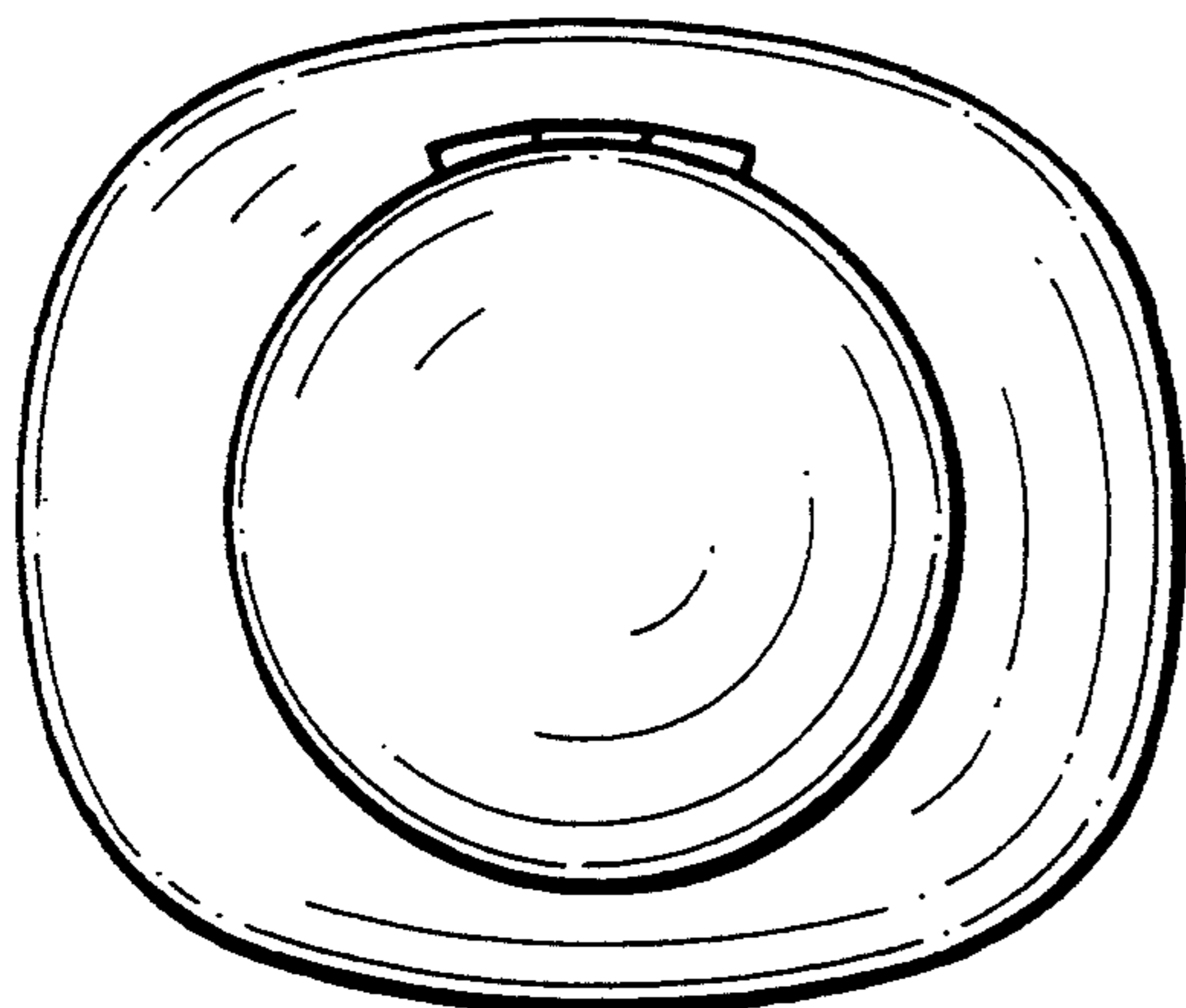
FIG. 1 is a top, front and left side perspective view of a combined bottle and cap showing our new design;

FIG. 6 is a bottom plan view thereof.



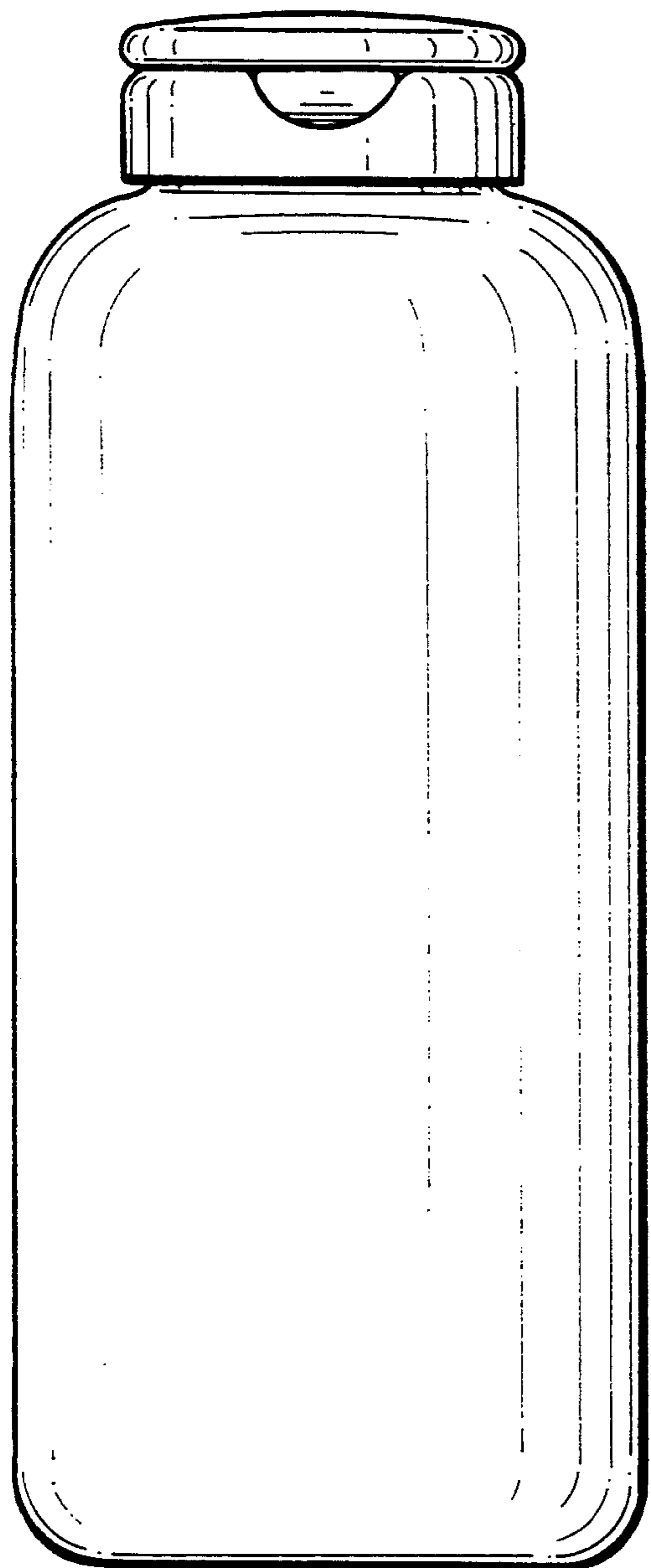

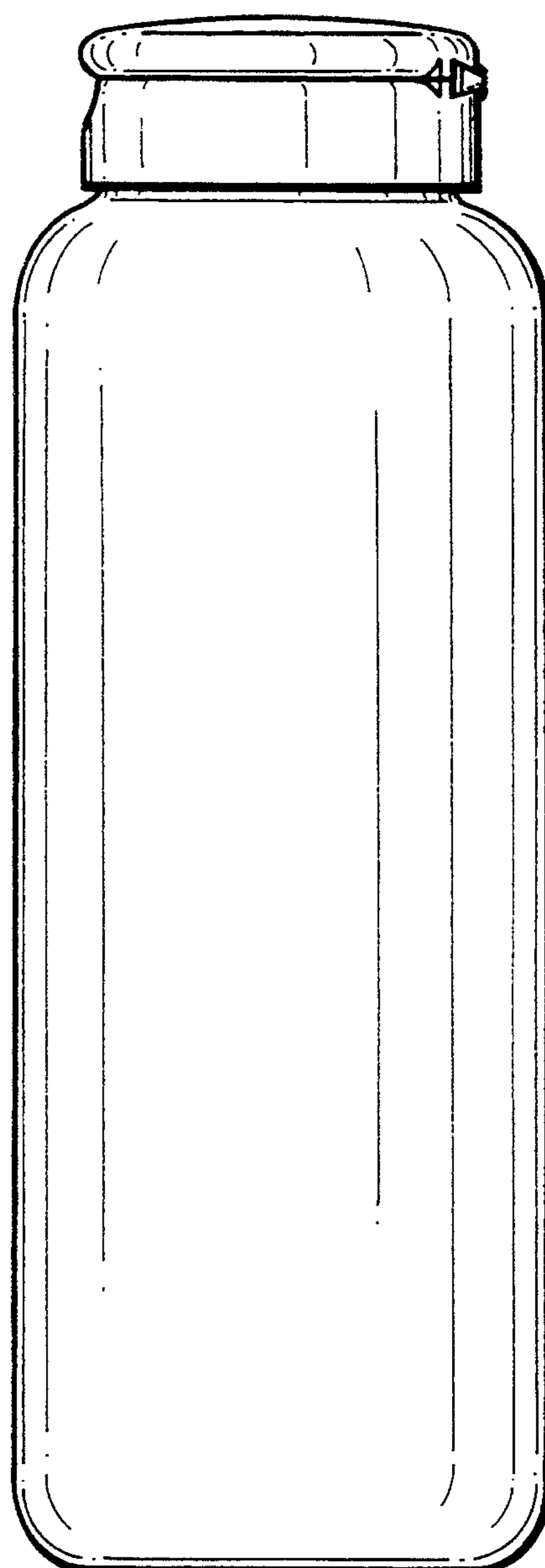

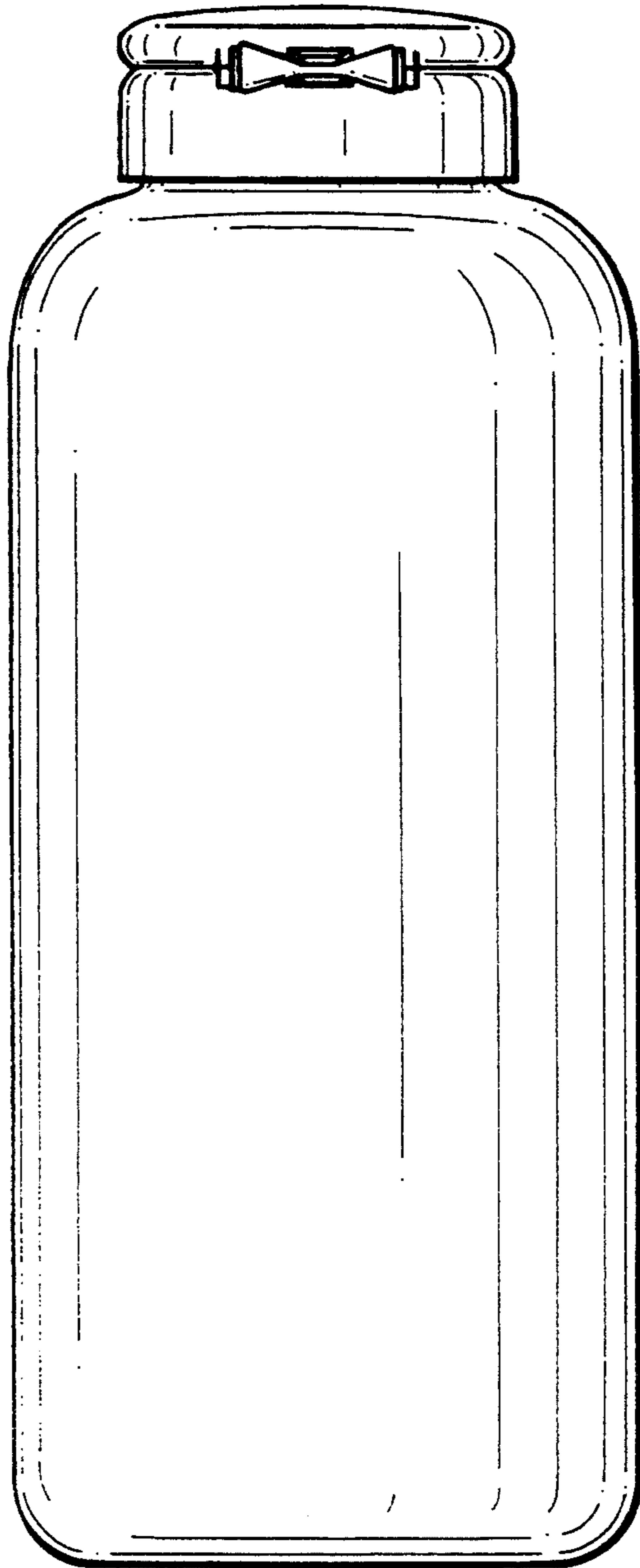
