FIG. 6 is a back plan view thereof.

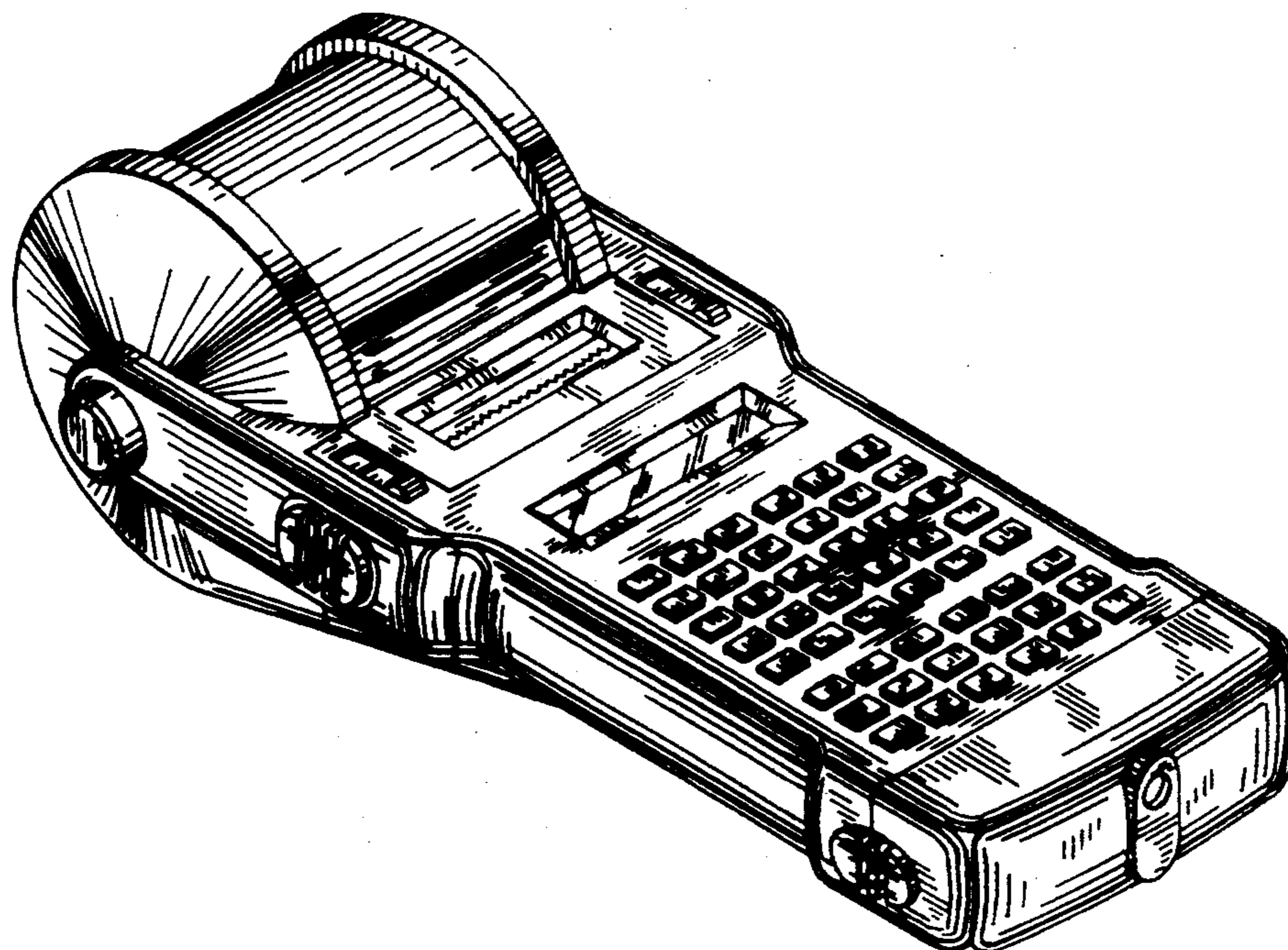

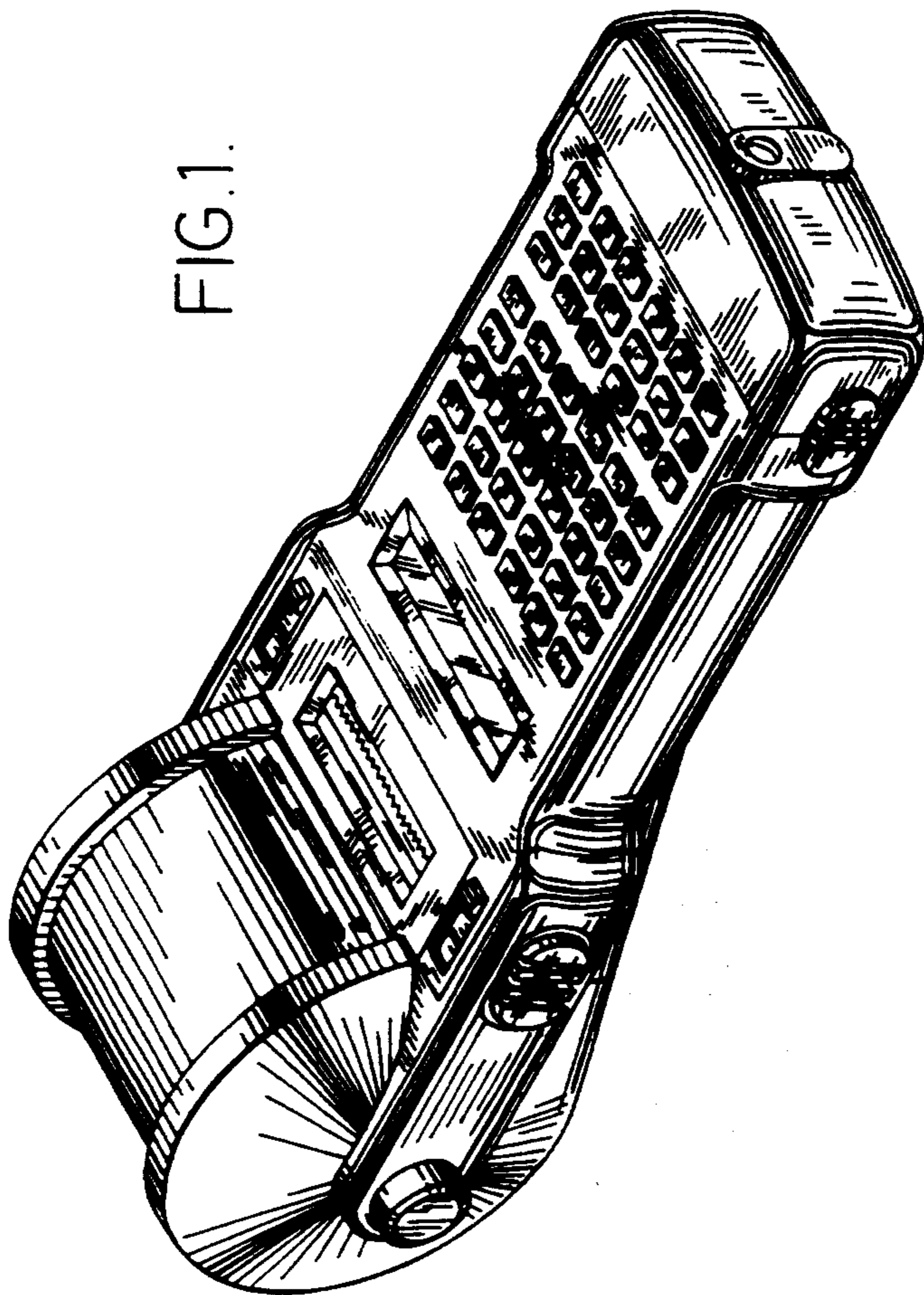
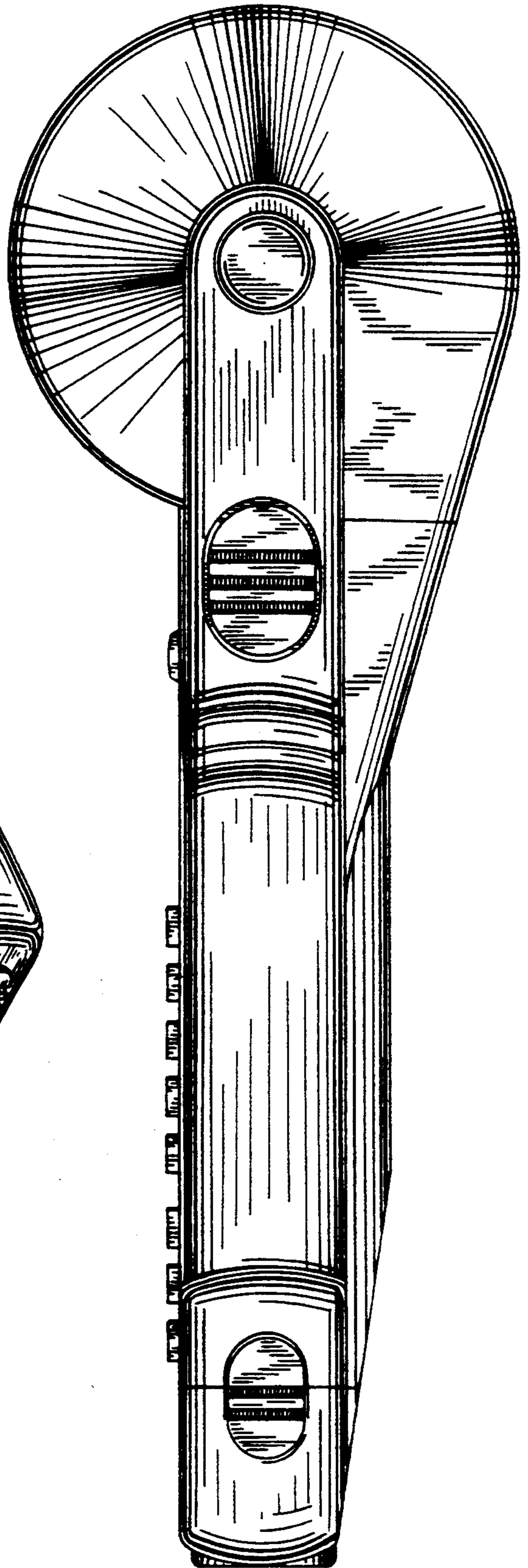

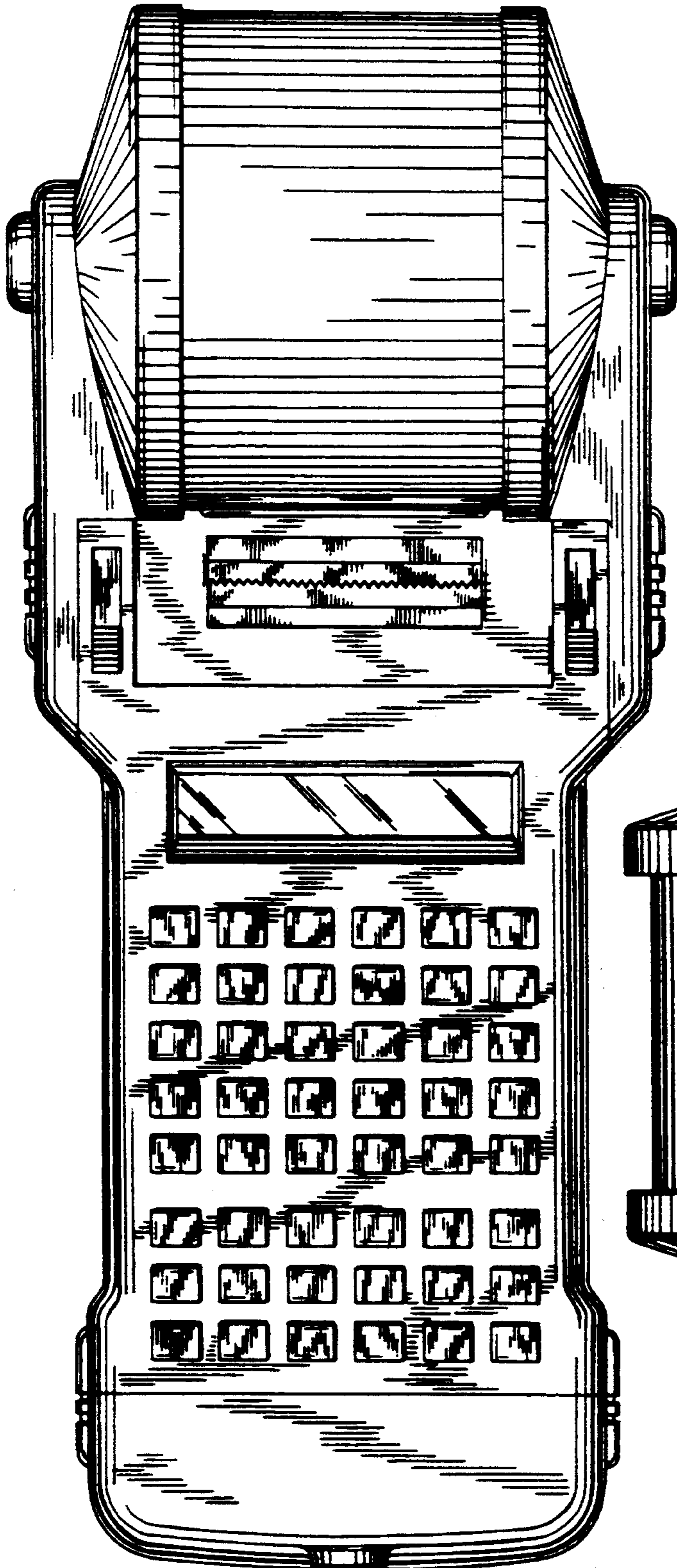

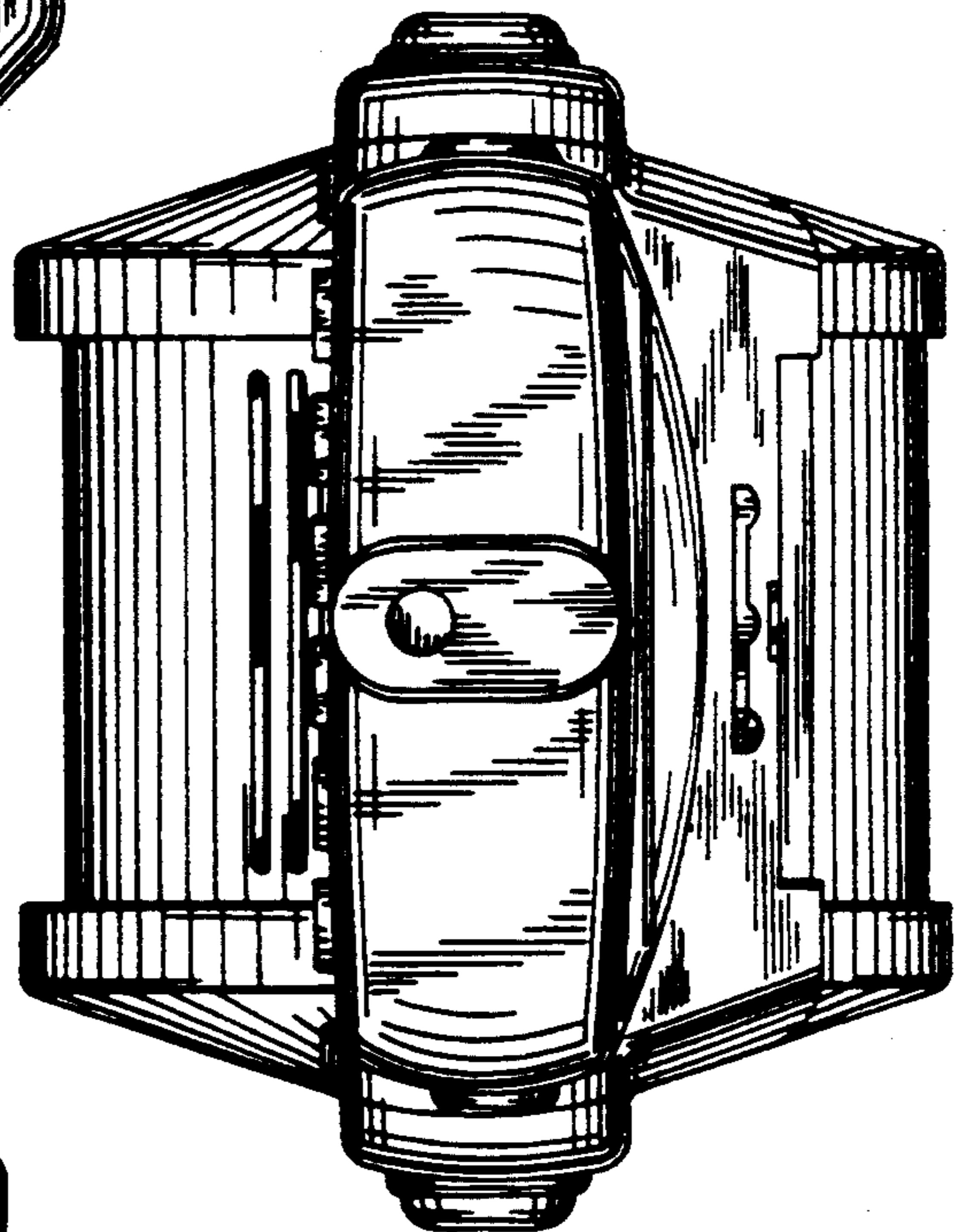

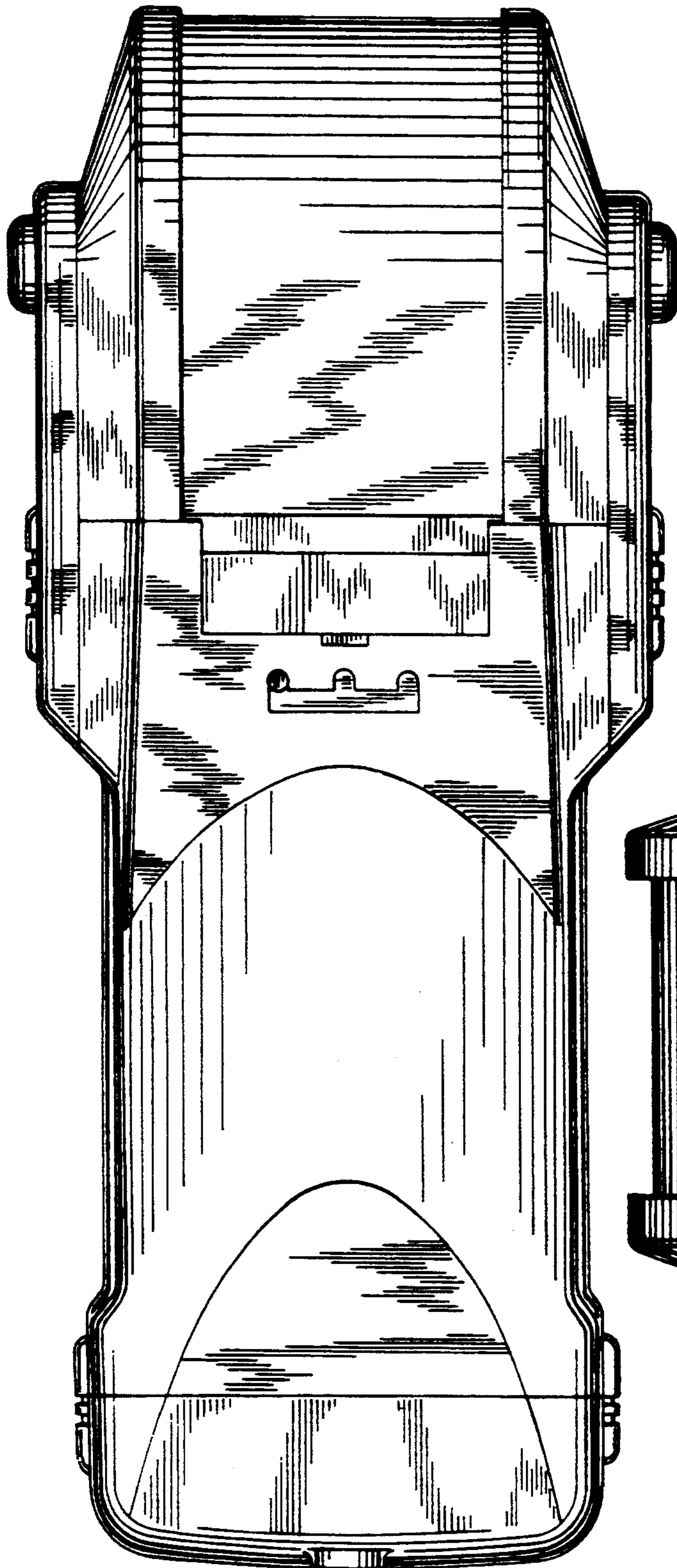

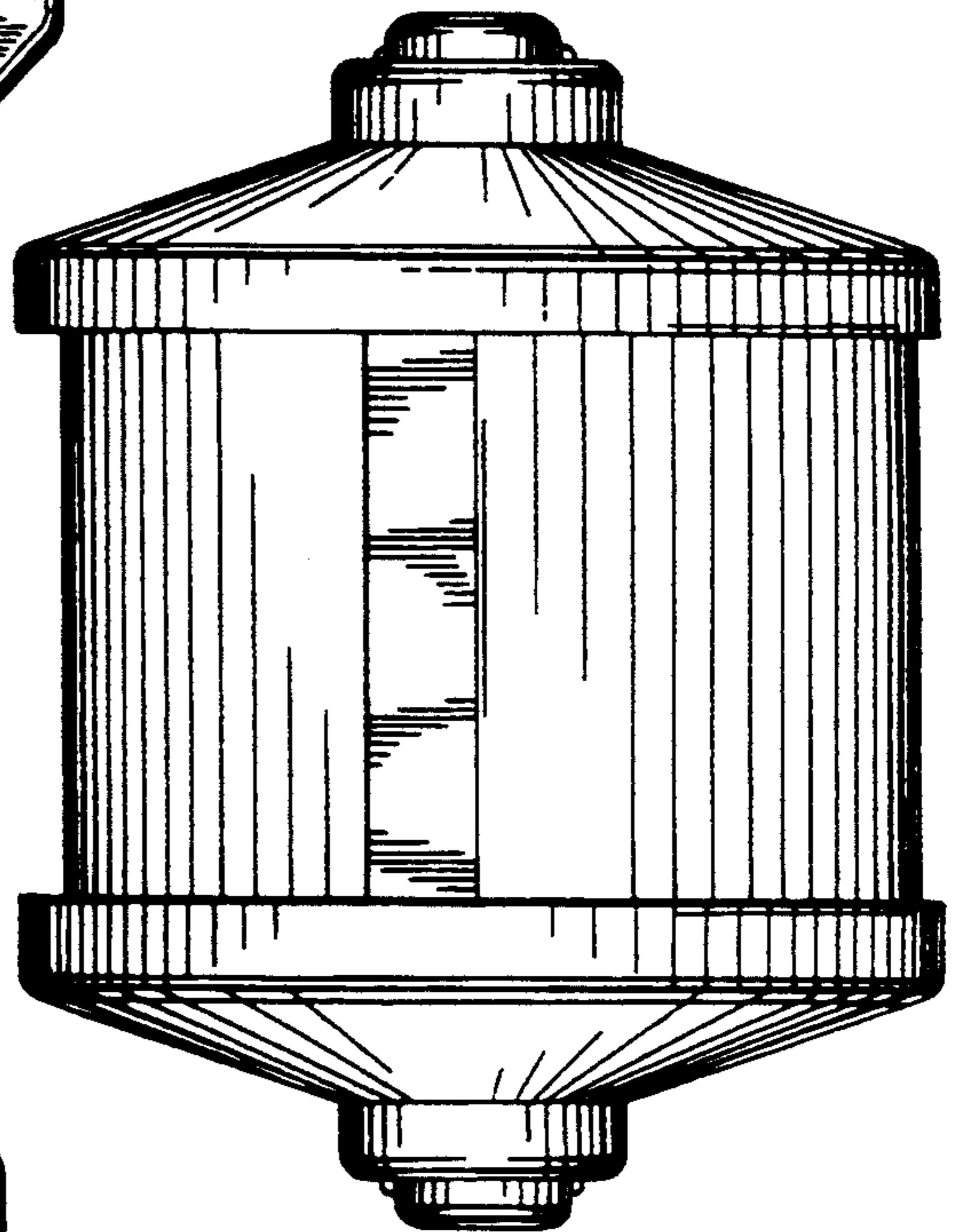
