### [57] CLAIM

The ornamental design for a reel seat for a fishing rod, as shown and described.

FIG. 1 is a left side elevational view of a reel seat for a fishing rod, showing our new design;  
 FIG. 2 is a front elevational view thereof;  
 FIG. 3 is a right side elevational view thereof;  
 FIG. 4 is a bottom plan view thereof;  
 FIG. 5 is a top plan view thereof;  
 FIG. 6 is a rear elevational view thereof;  
 FIG. 7 is a cross-sectional view thereof taken on line 7—7 in FIG. 3;  
 FIG. 8 is a cross-sectional view thereof taken on line 8—8 in FIG. 3;  
 FIG. 9 is a cross-sectional view thereof taken on line 9—9 in FIG. 3;  
 FIG. 10 is a cross-sectional view thereof taken on line 10—10 in FIG. 3;  
 FIG. 11 is a cross-sectional view thereof taken on line 11—11 in FIG. 3;  
 FIG. 12 is a reference view showing the reel seat for a fishing rod in a state of use;  
 FIG. 13 is a left side elevational view of a second embodiment of the reel seat for a fishing rod;  
 FIG. 14 is a front elevational view thereof;  
 FIG. 15 is a right side elevational view thereof;  
 FIG. 16 is a bottom plan view thereof;  
 FIG. 17 is a top plan view thereof;  
 FIG. 18 is a rear elevational view thereof;  
 FIG. 19 is a cross-sectional view thereof taken on line 19—19 in FIG. 15;

 FIG. 21 is a cross-sectional view thereof taken on line 21—21 in FIG. 15;

 FIG. 24 is a reference view showing the reel seat for a fishing rod in a state of use.

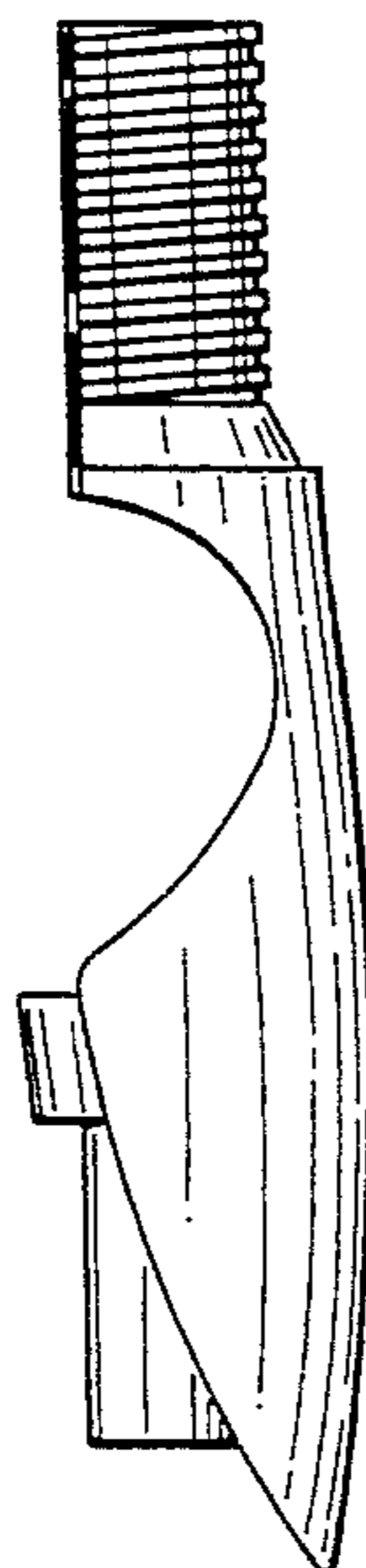

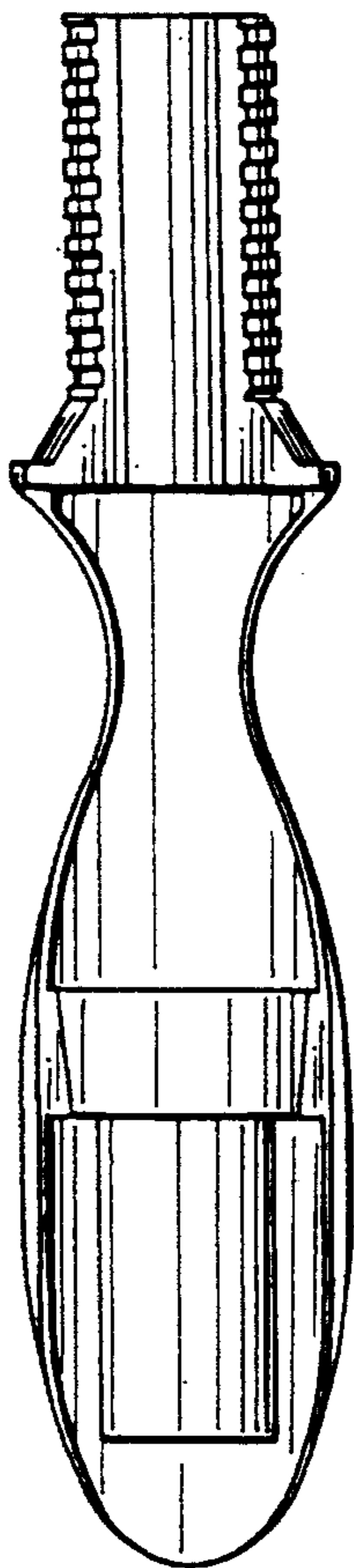

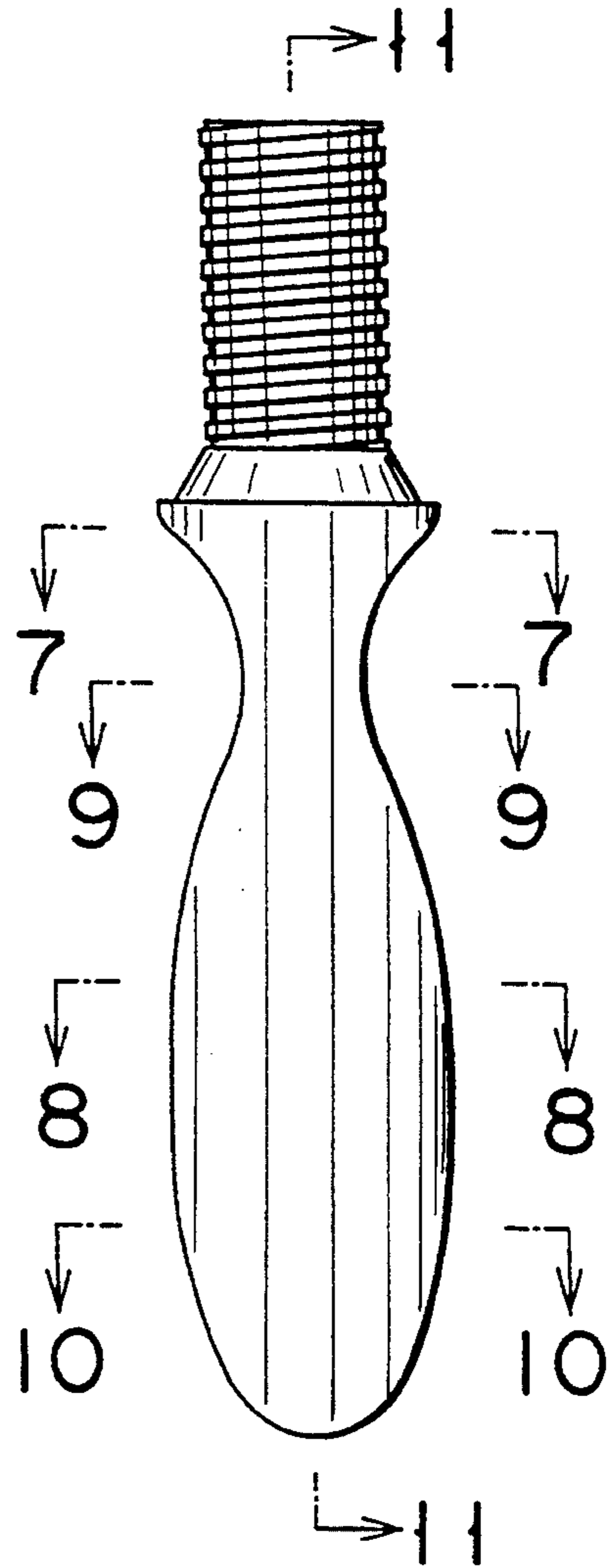

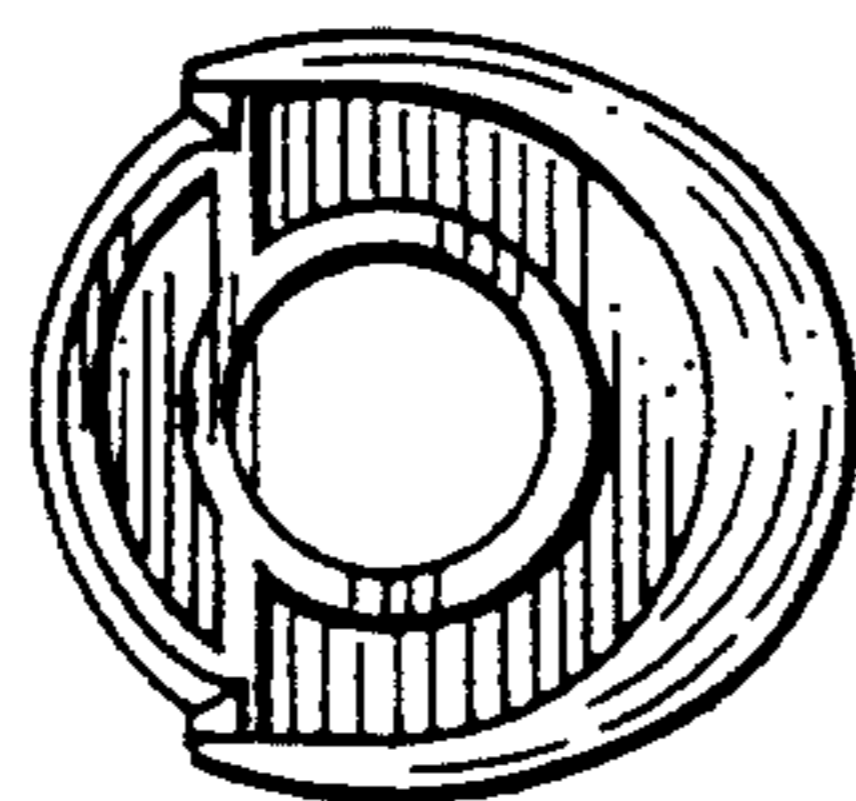

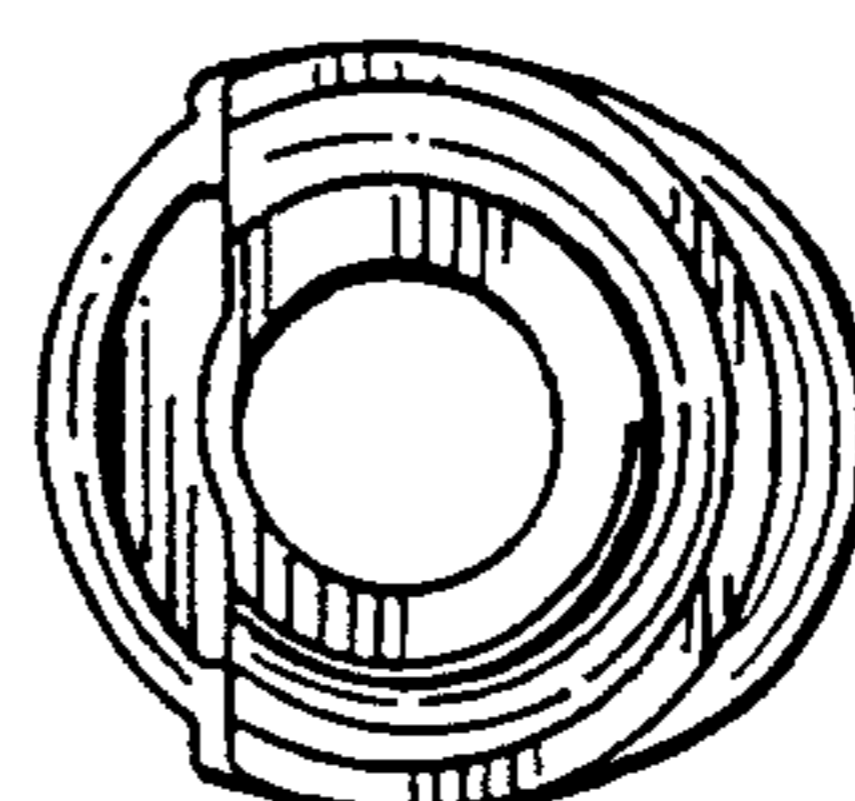

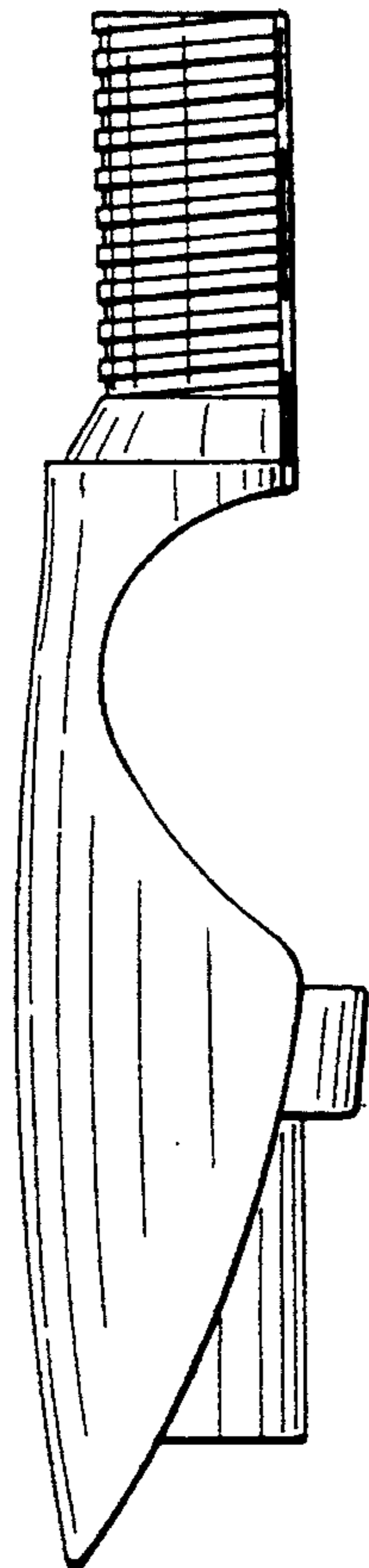

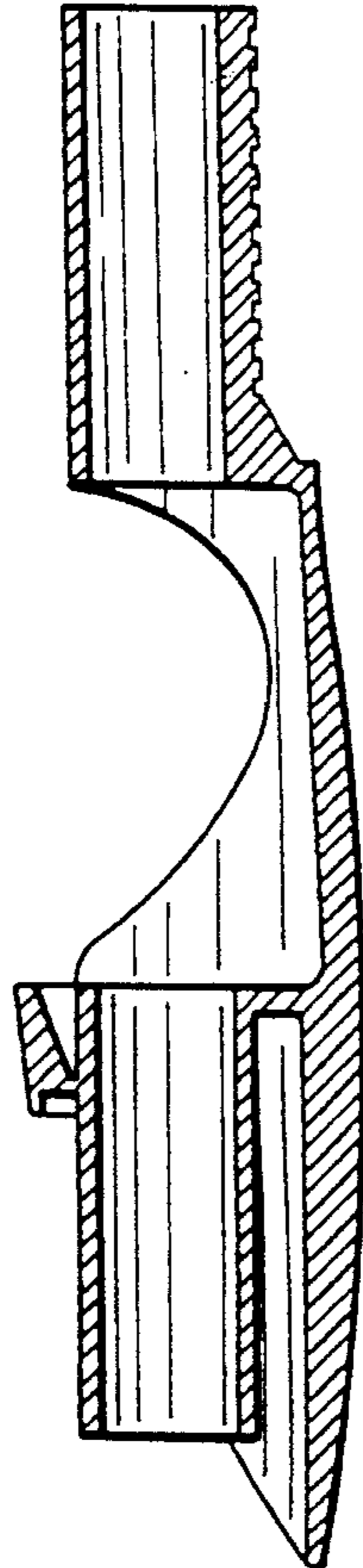

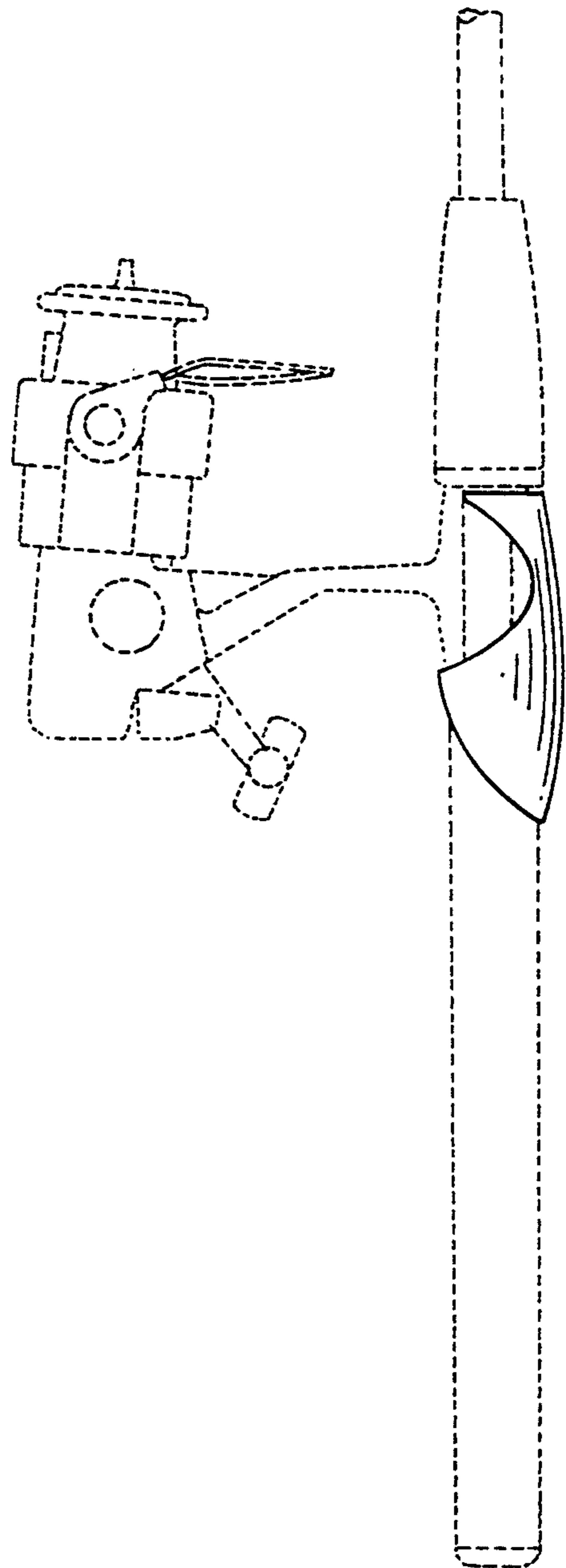

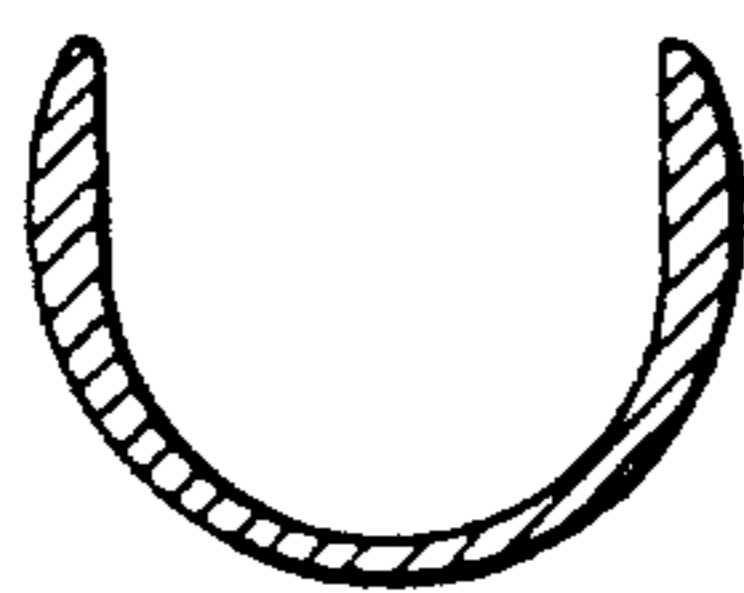

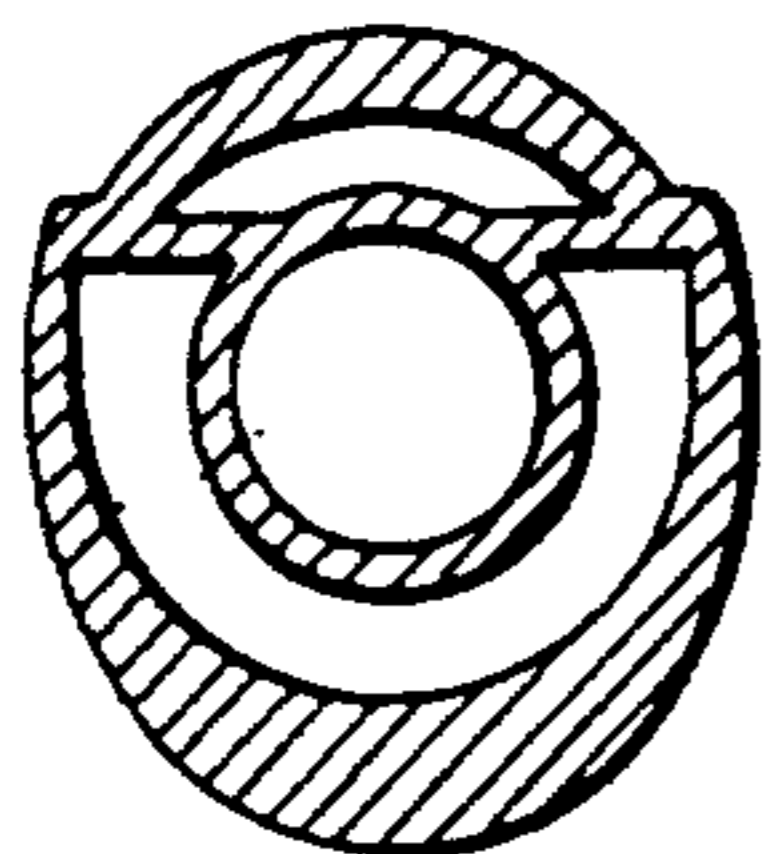

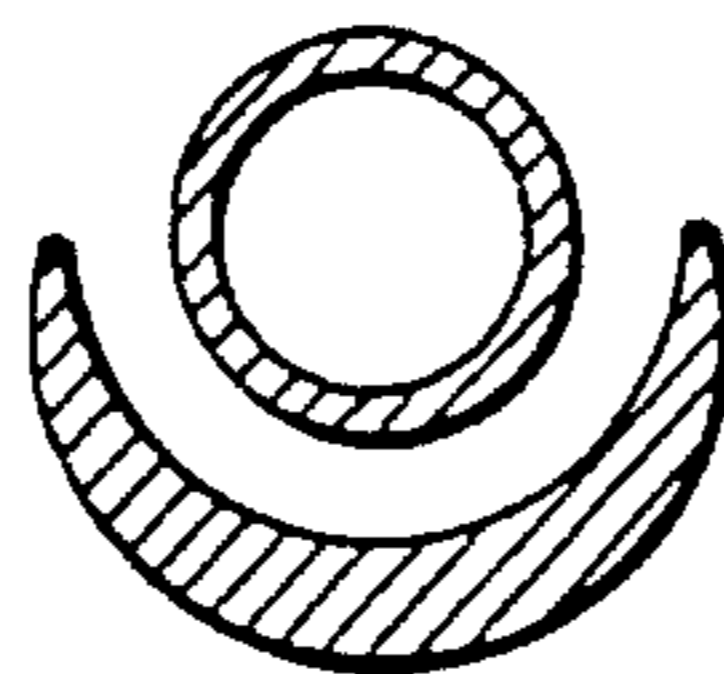

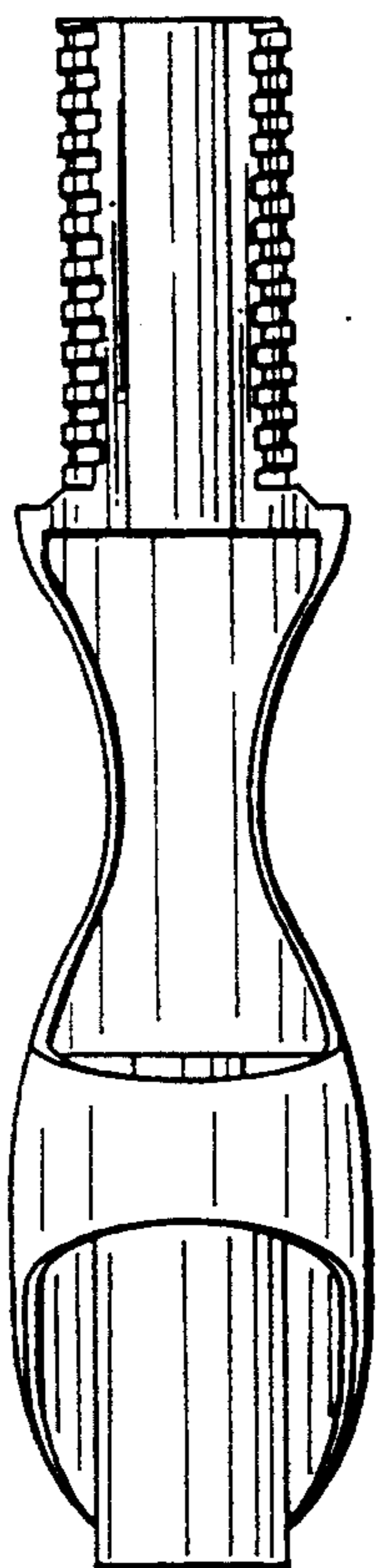

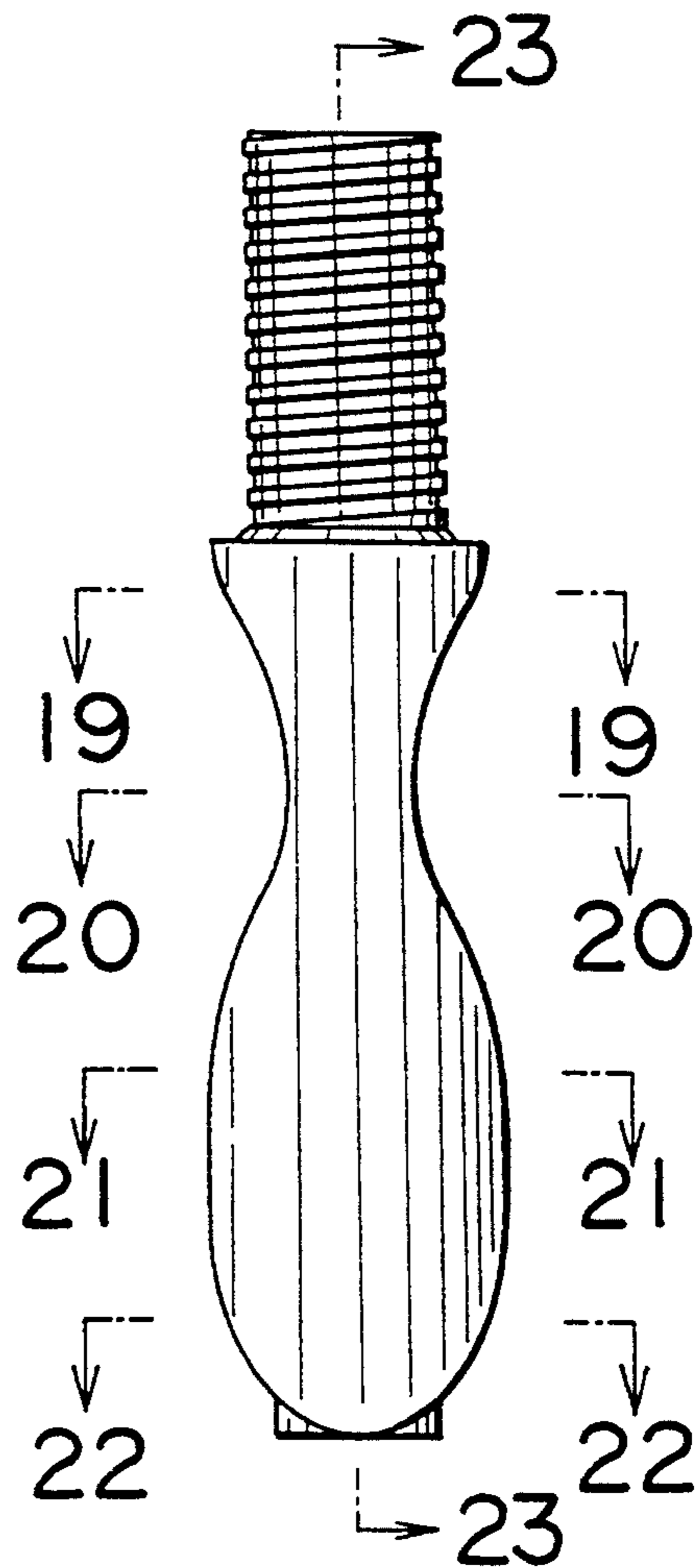

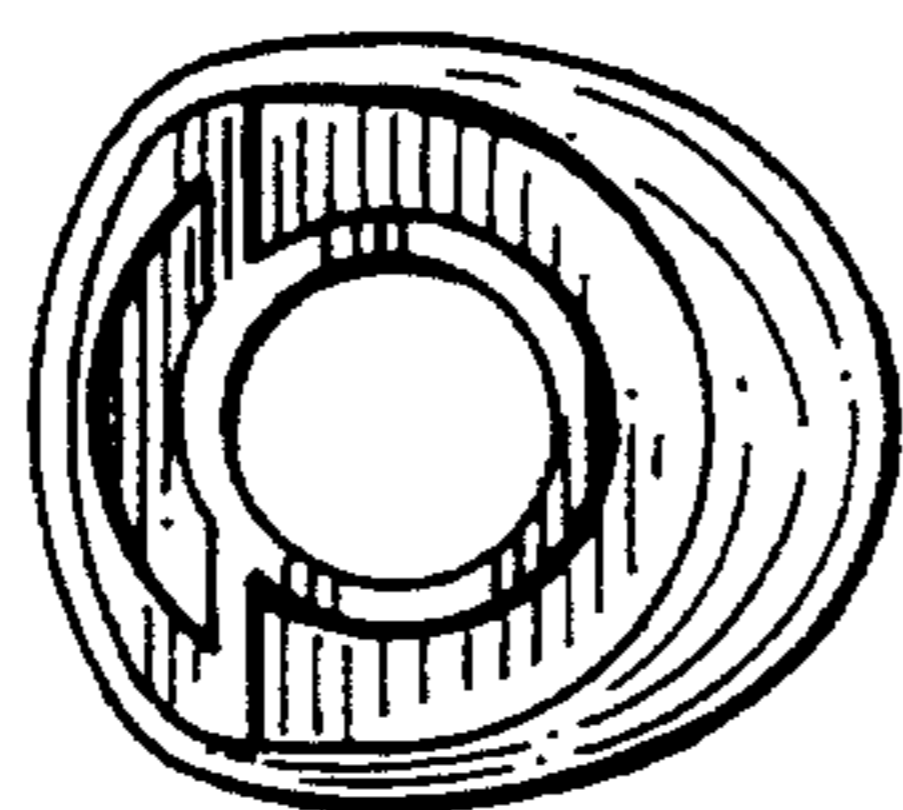

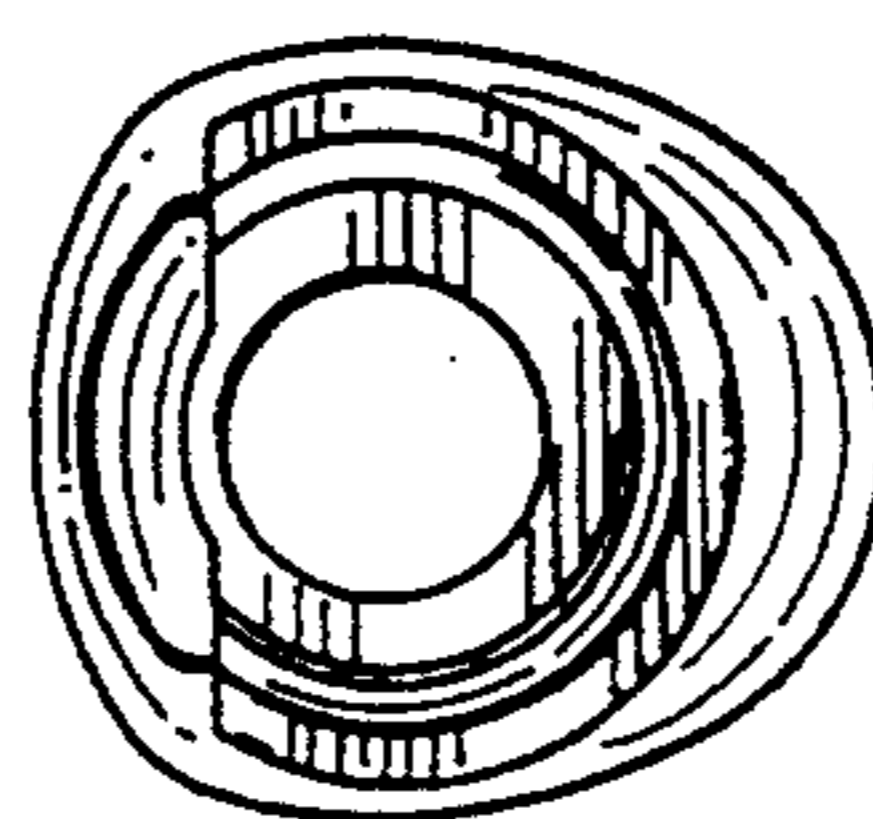

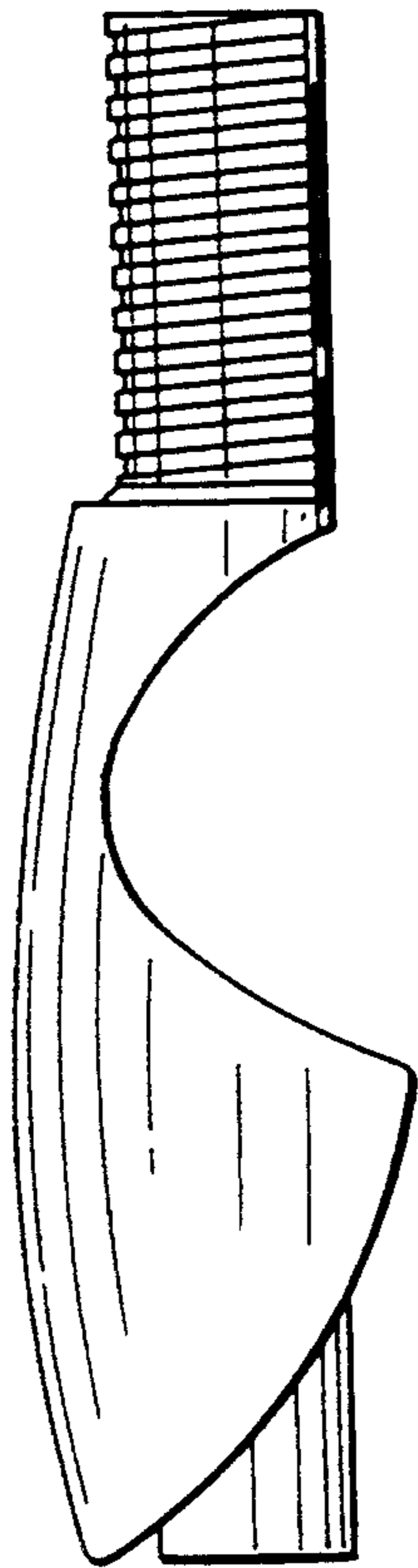

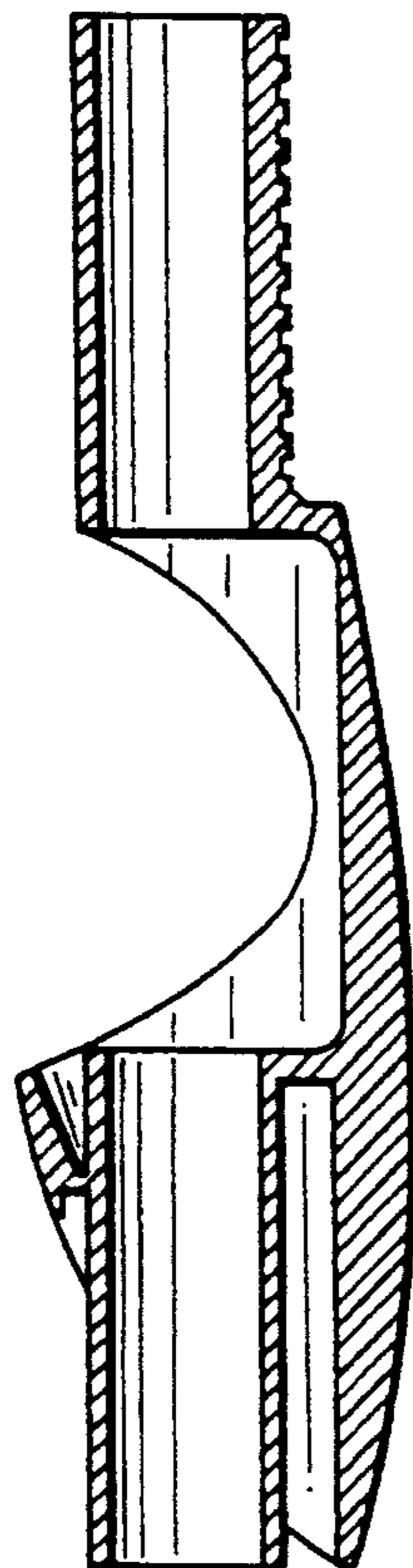

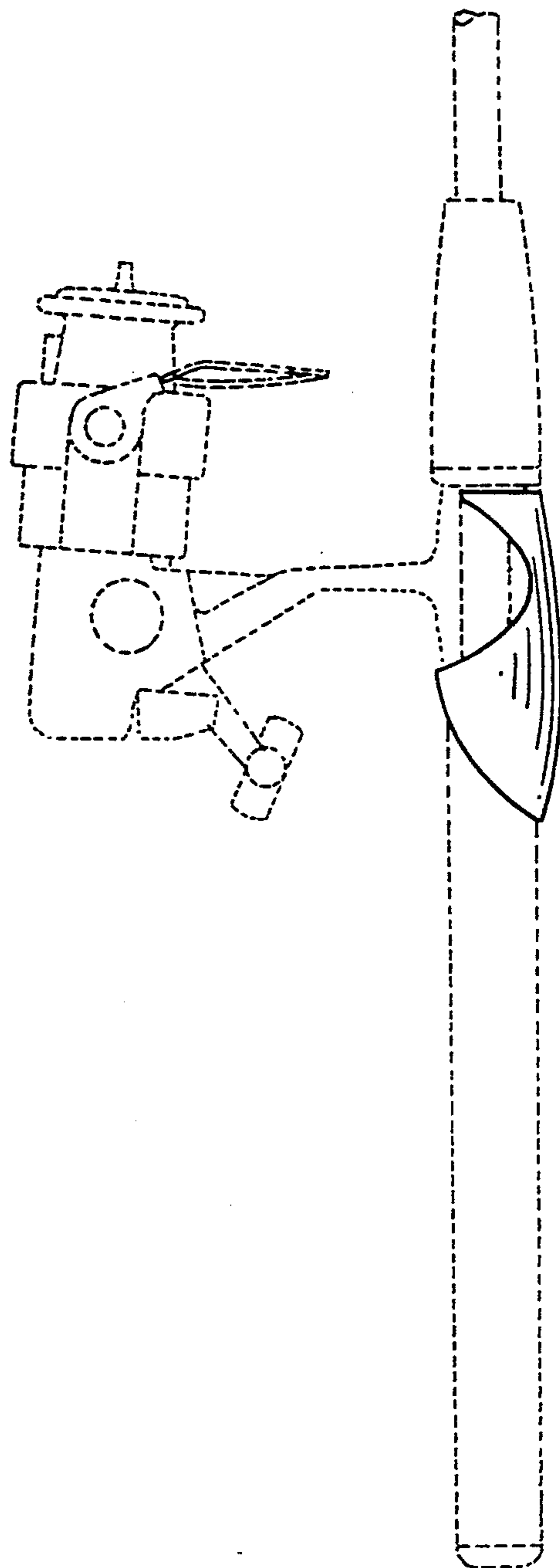

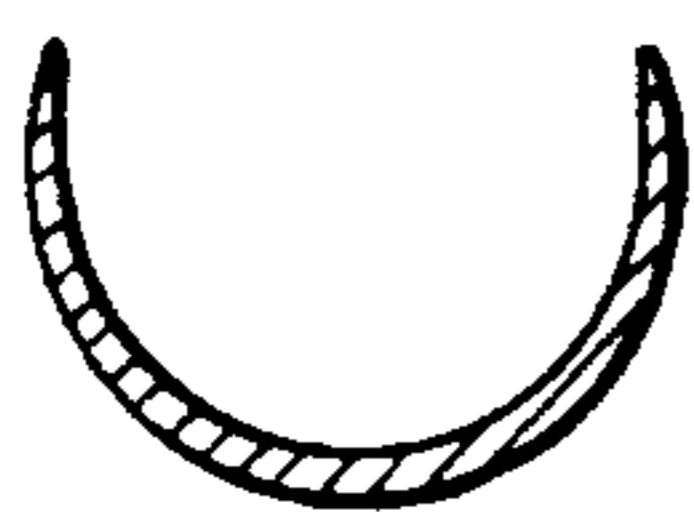

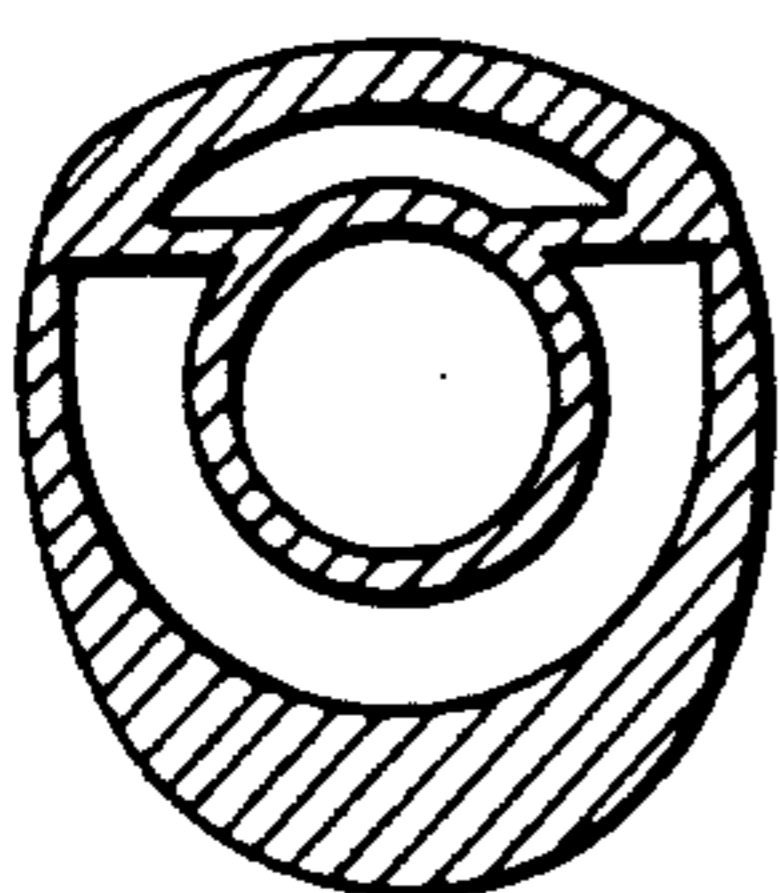
