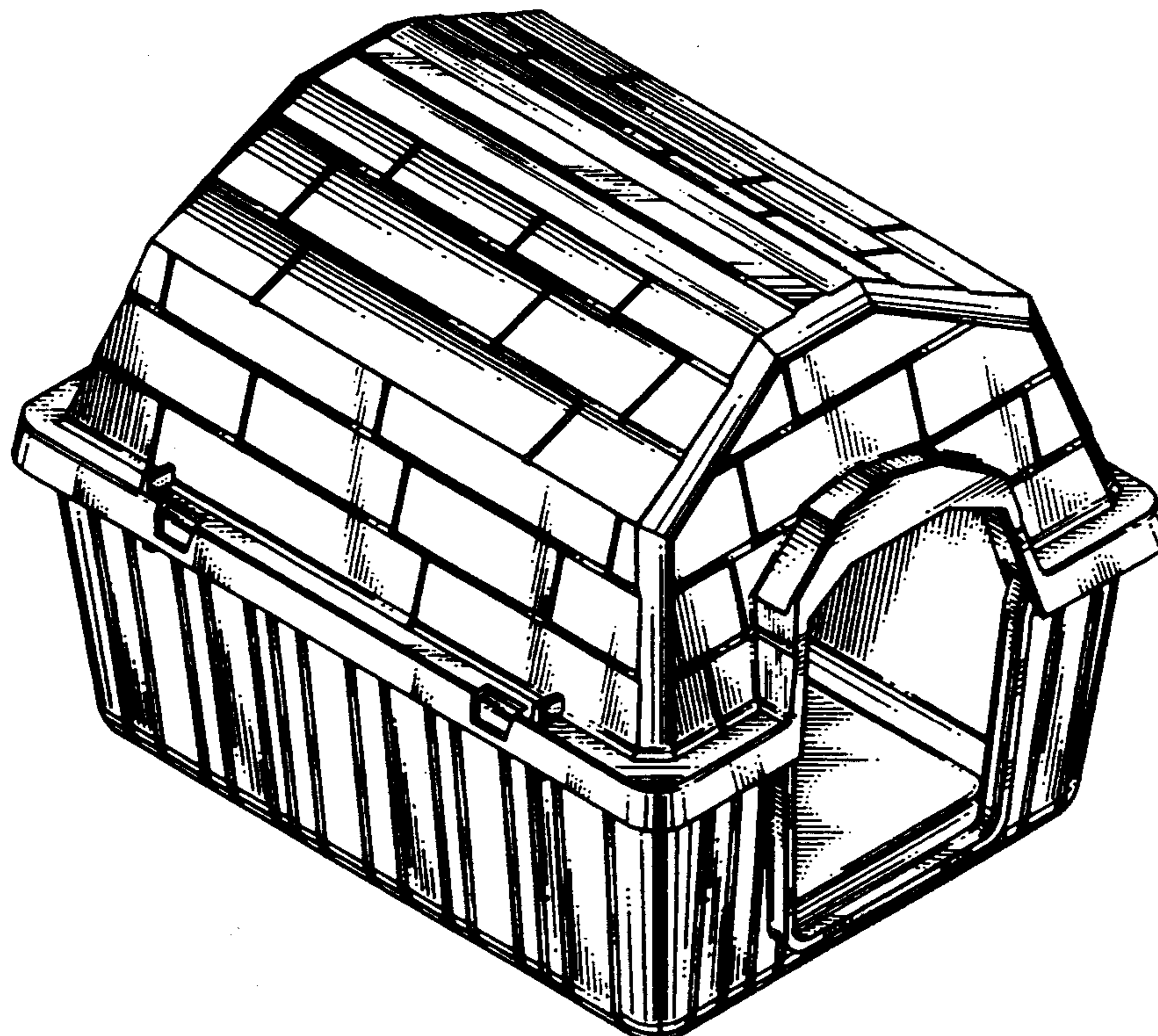

invention.



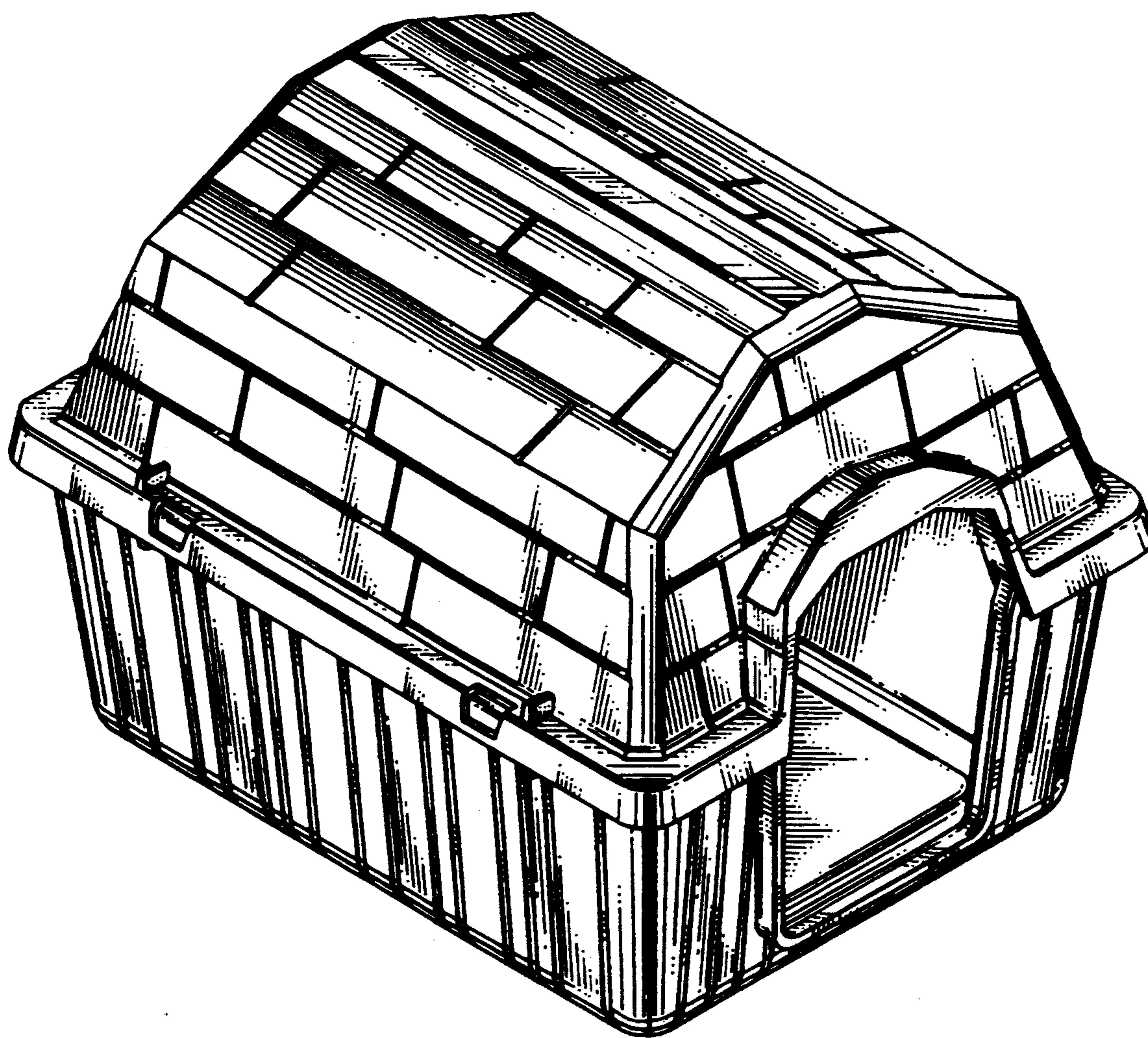

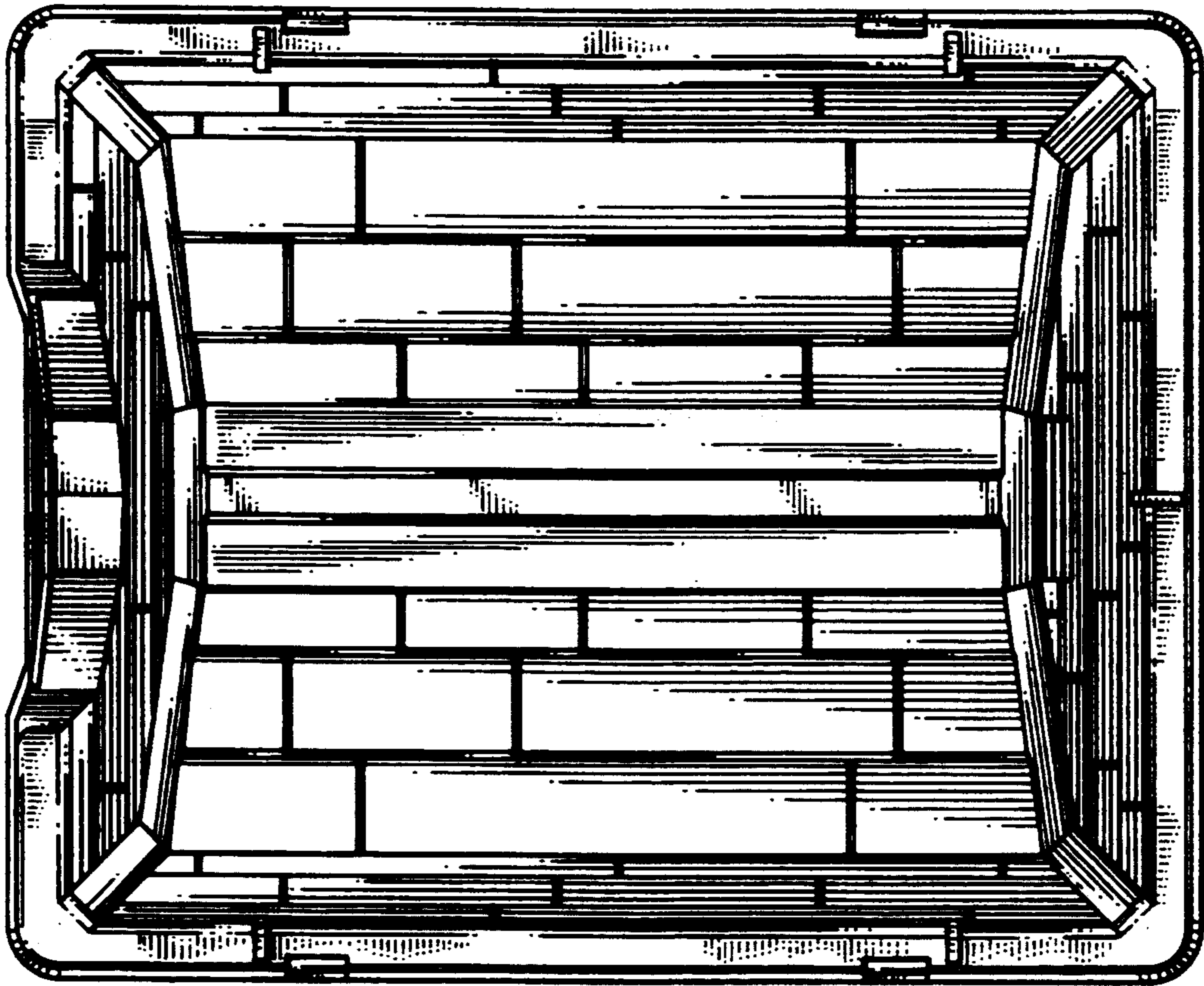

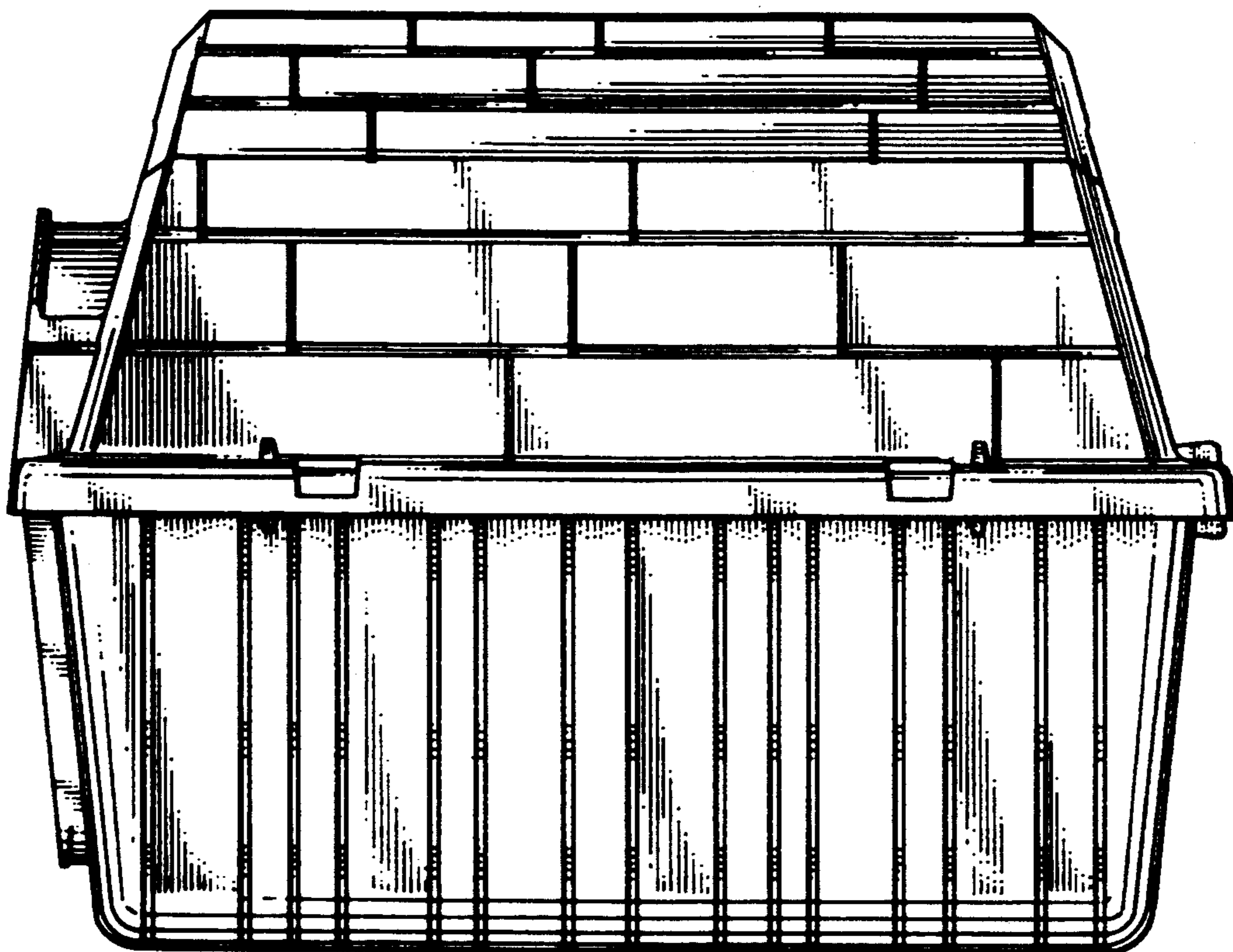

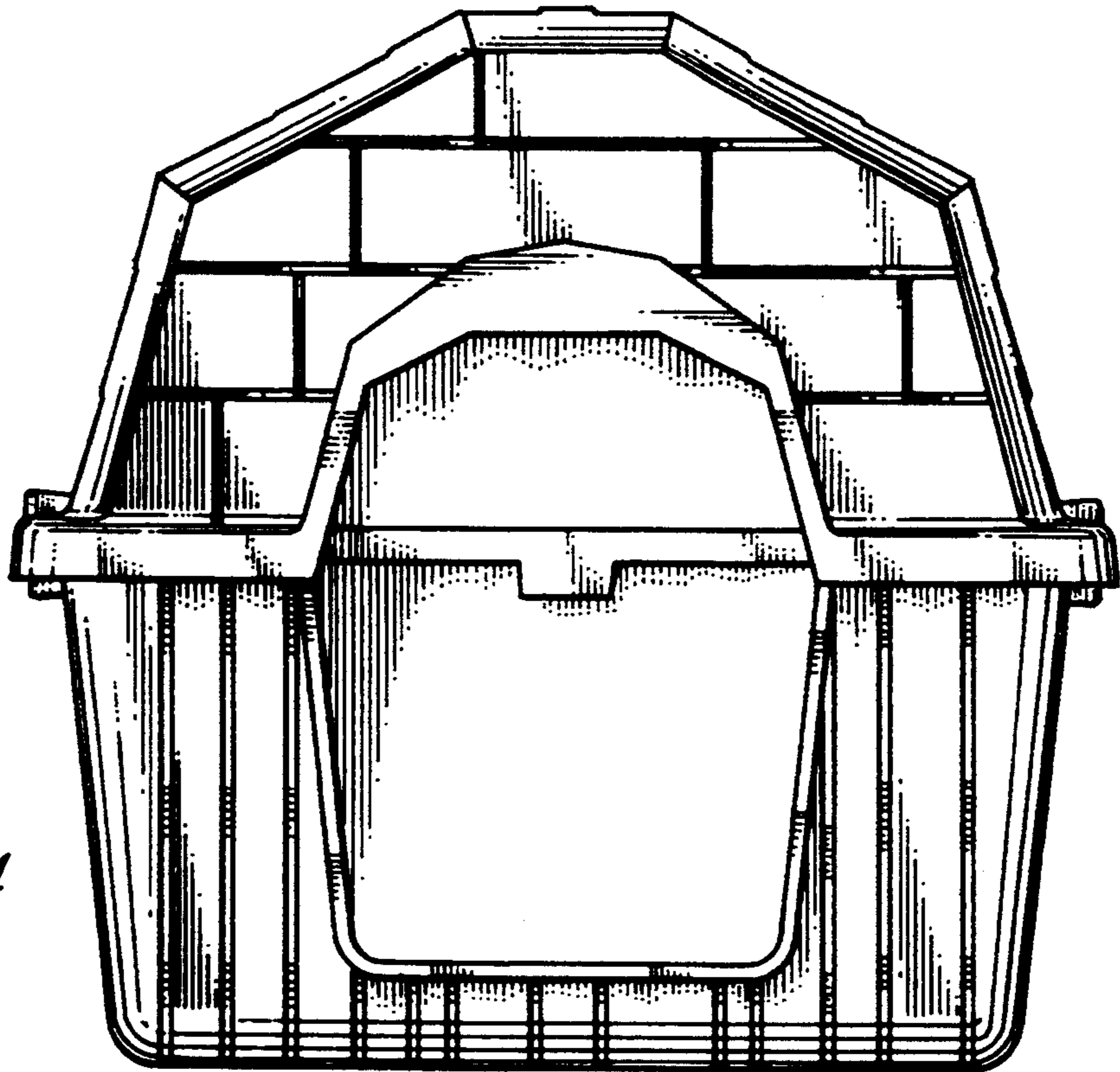

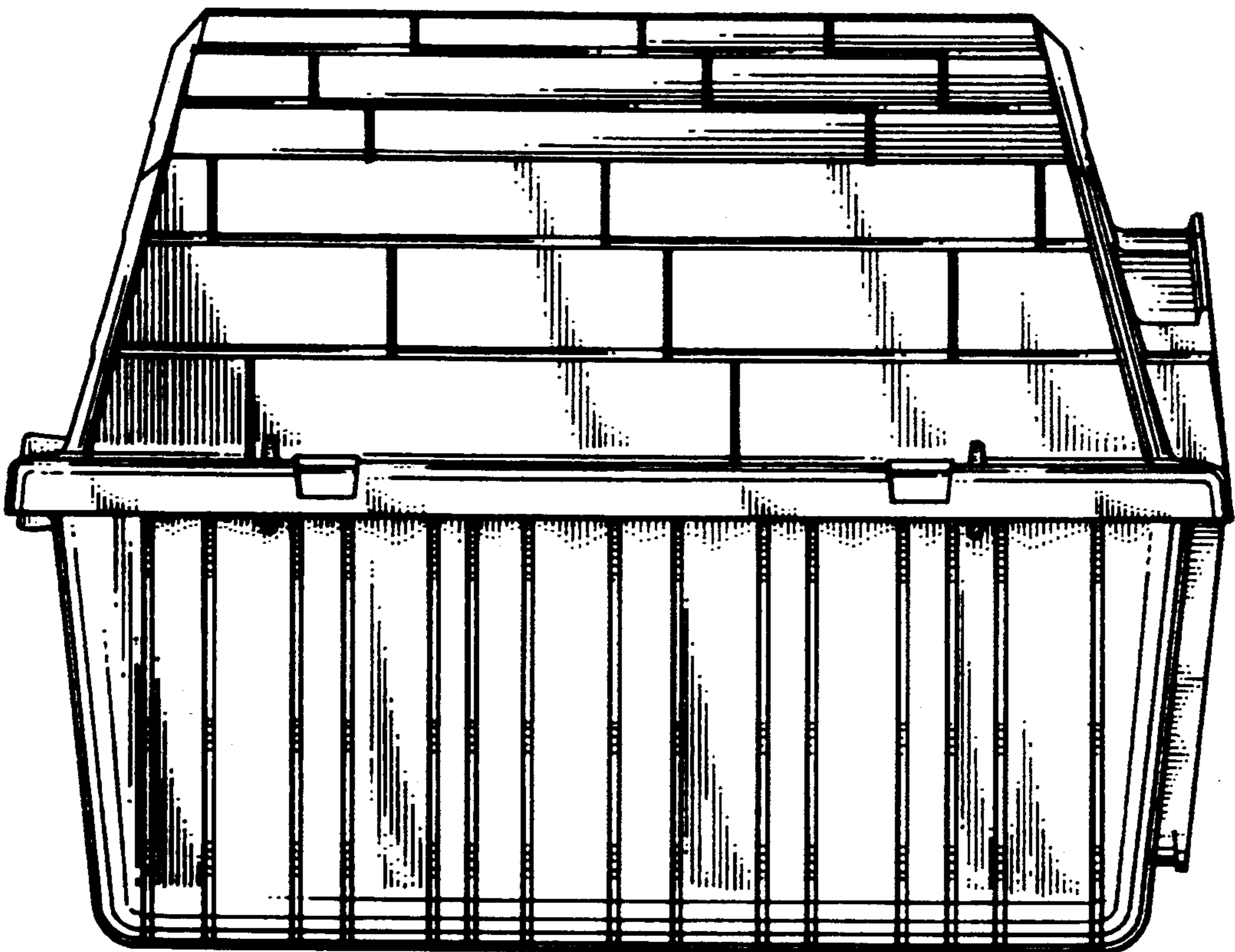

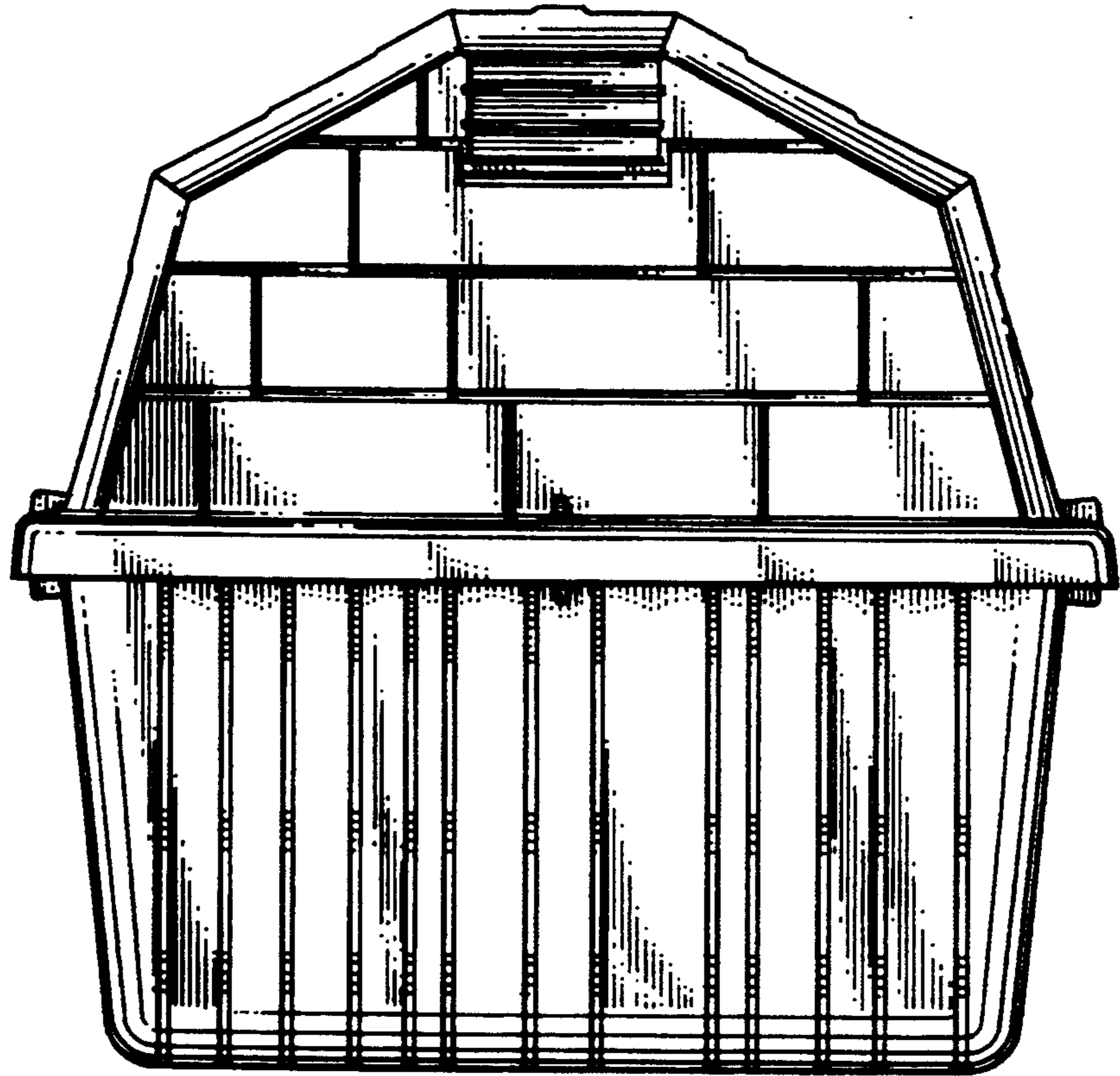

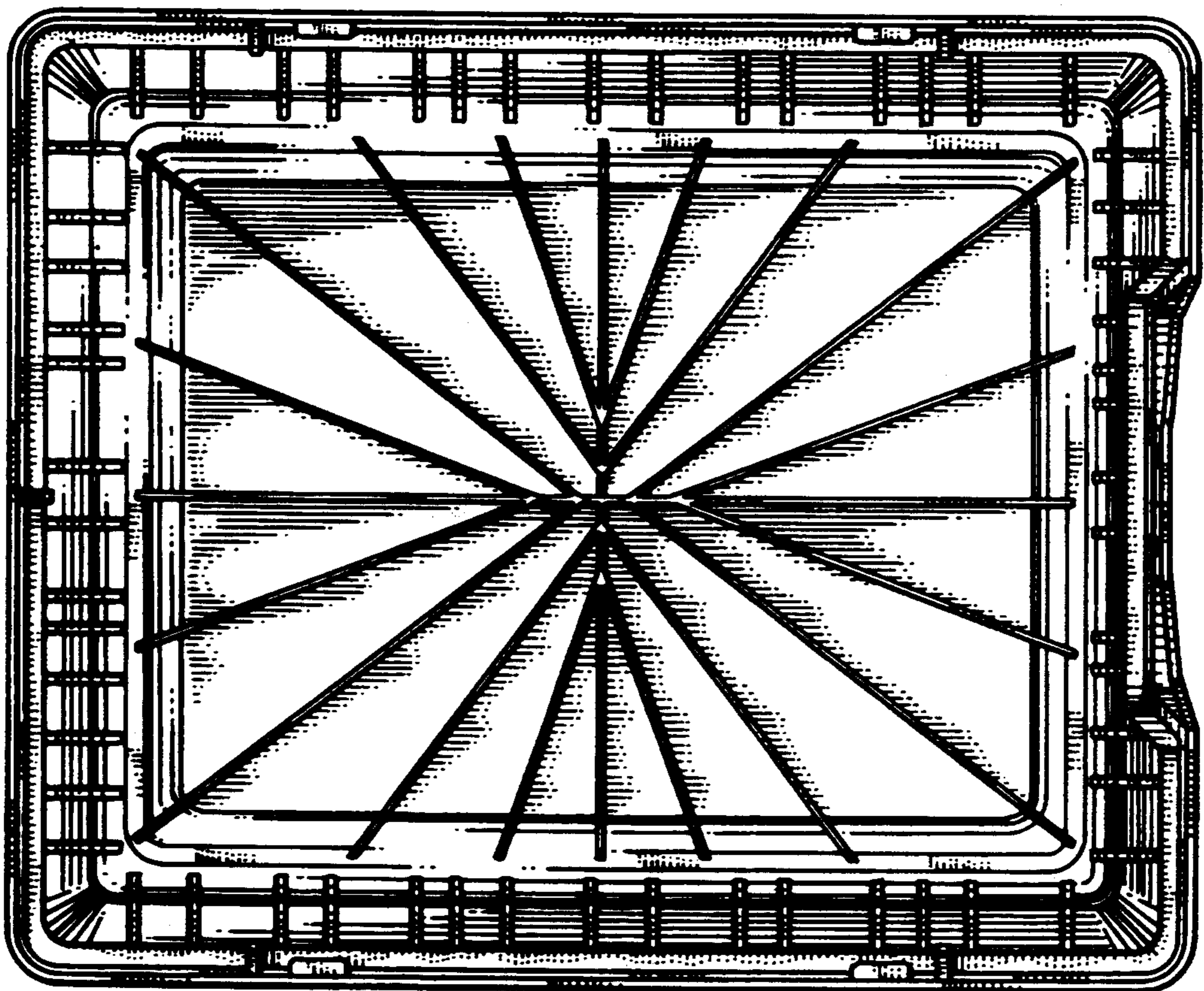
