### DESCRIPTION

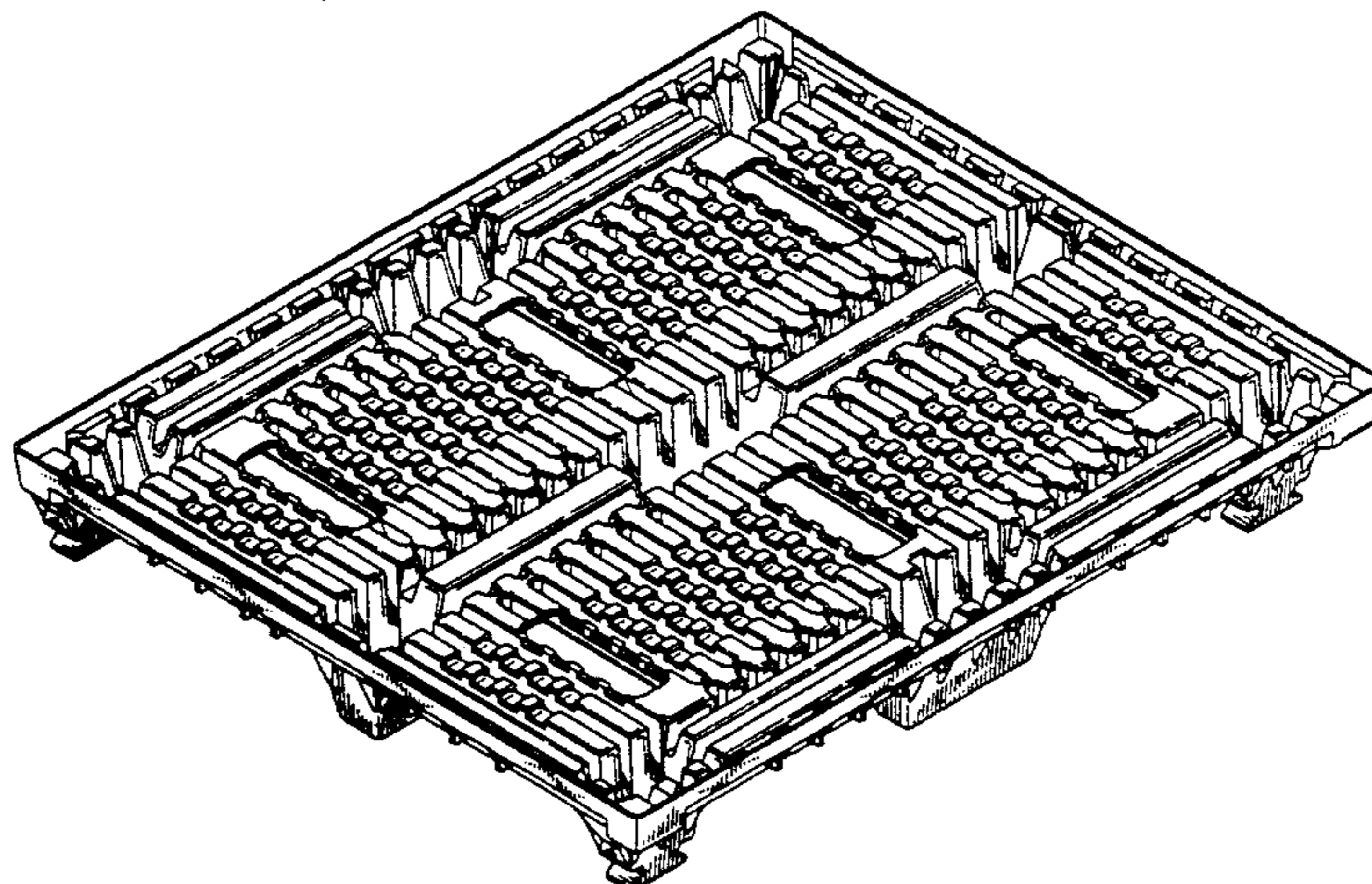
FIG. 1 is a top plan view of a ventilated pallet showing our new design;

FIG. 2 is a bottom plan view thereof;

FIG. 3 is a side elevational view thereof, the opposite side elevational view being a mirror image of that shown;

FIG. 4 is an end elevational view thereof, the opposite end elevational view being a mirror image of that shown; and,

FIG. 5 is a perspective view thereof.

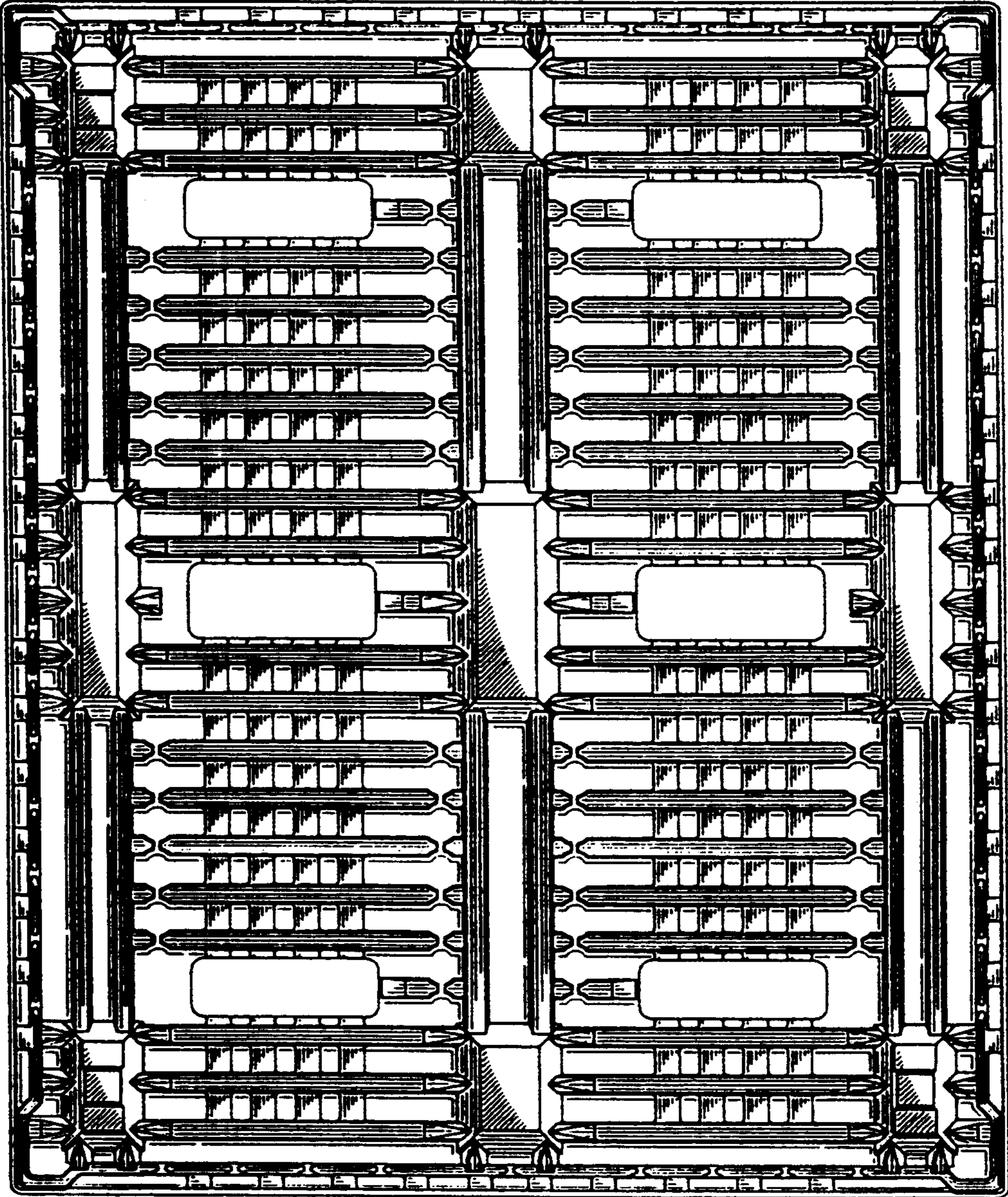

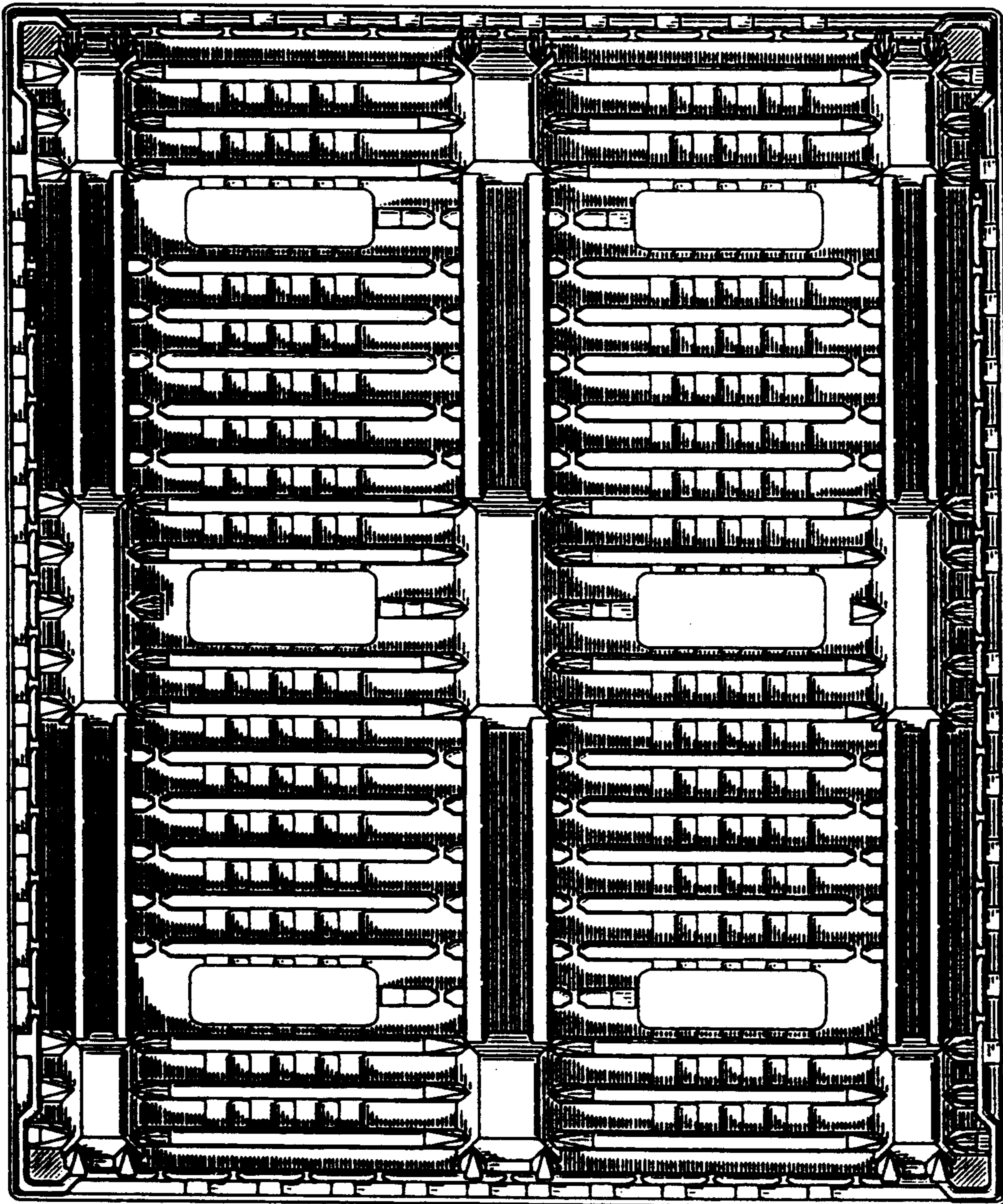

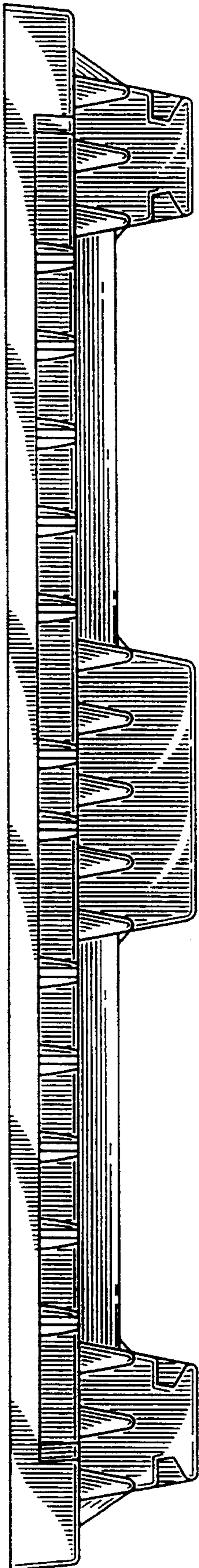

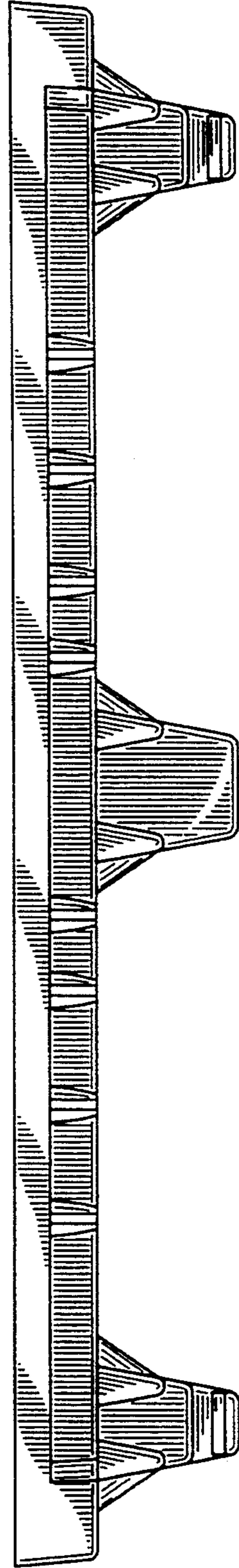

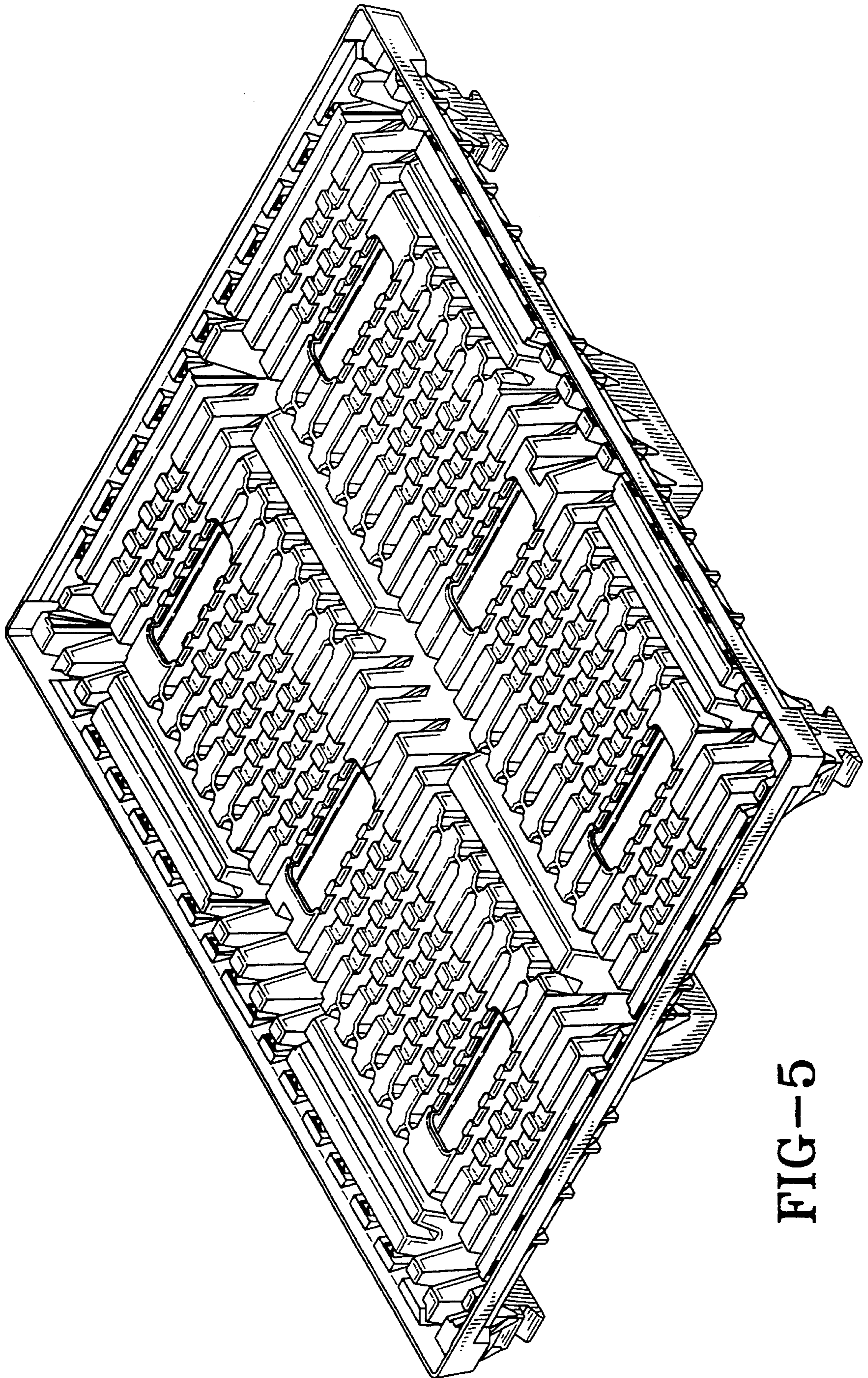
