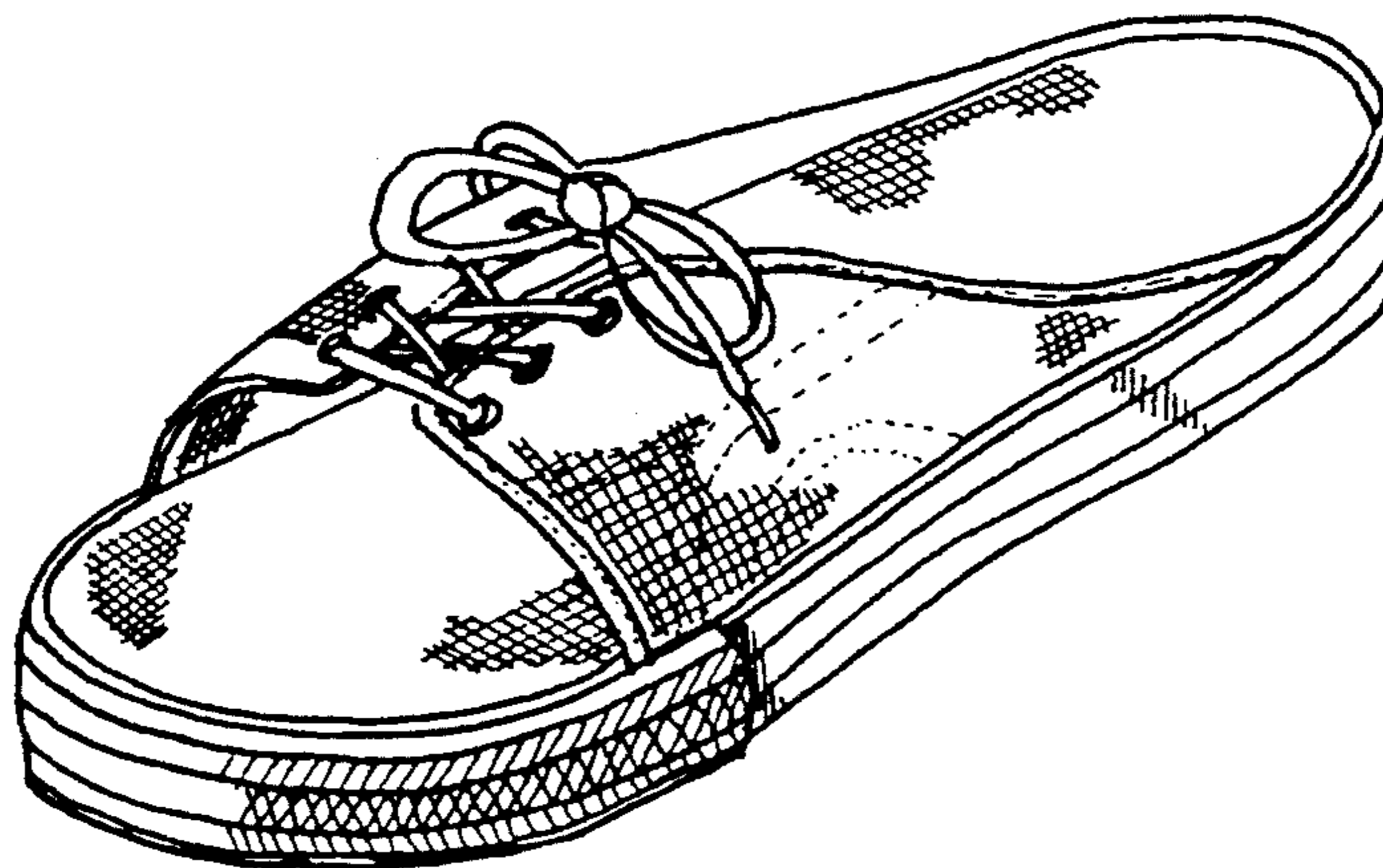

### [57] CLAIM

The ornamental design for a tennis shoe sandal, as shown and described.

### DESCRIPTION

FIG. 1 is a perspective view of a tennis shoe sandal showing my new design;  
FIG. 2 is a right side elevation, the opposite side being identical thereof;  
FIG. 3 is a front elevation thereof;  
FIG. 4 is a top plan view thereof;  
FIG. 5 is a rear elevation thereof; and,  
FIG. 6 is a bottom plan view thereof.



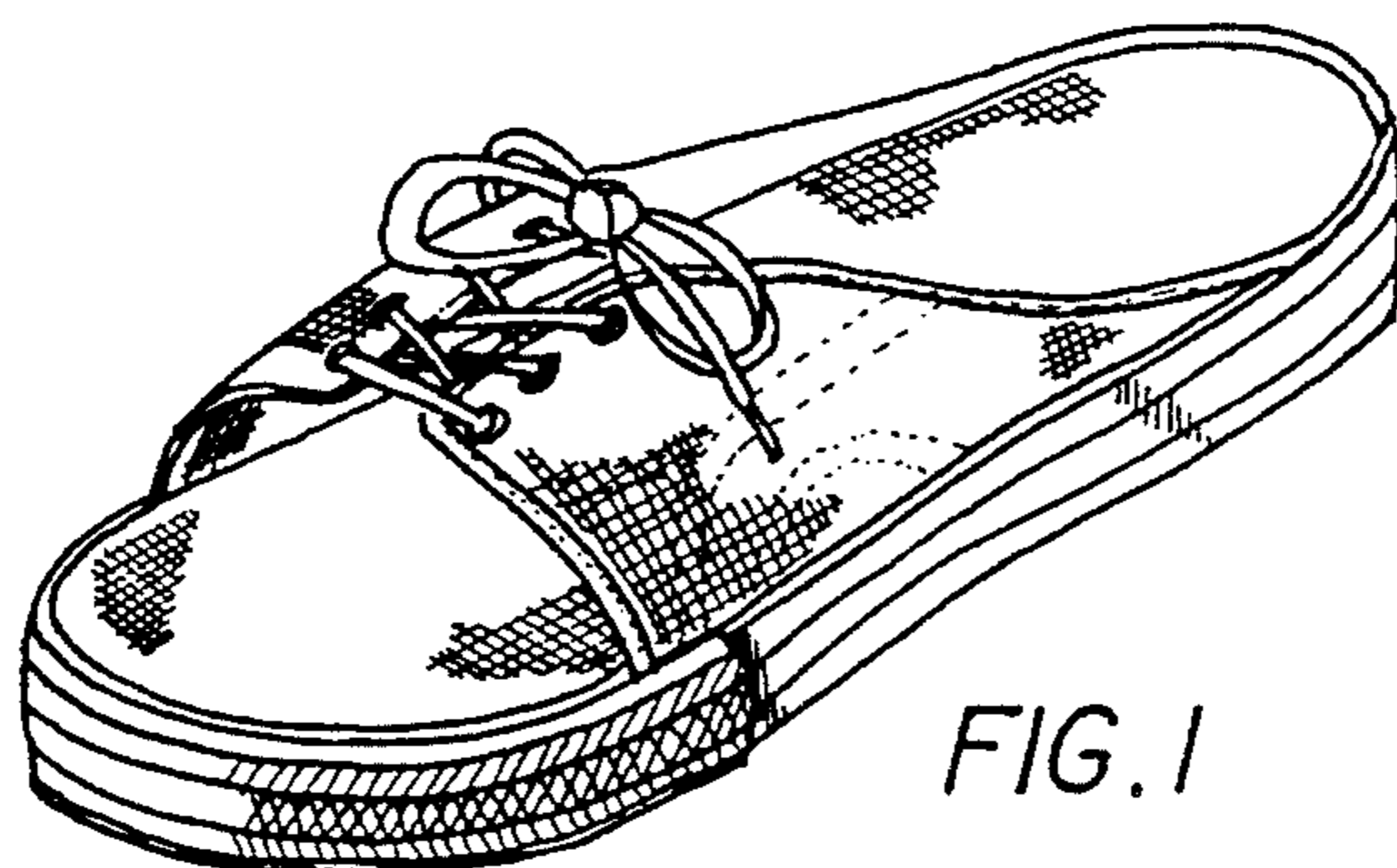

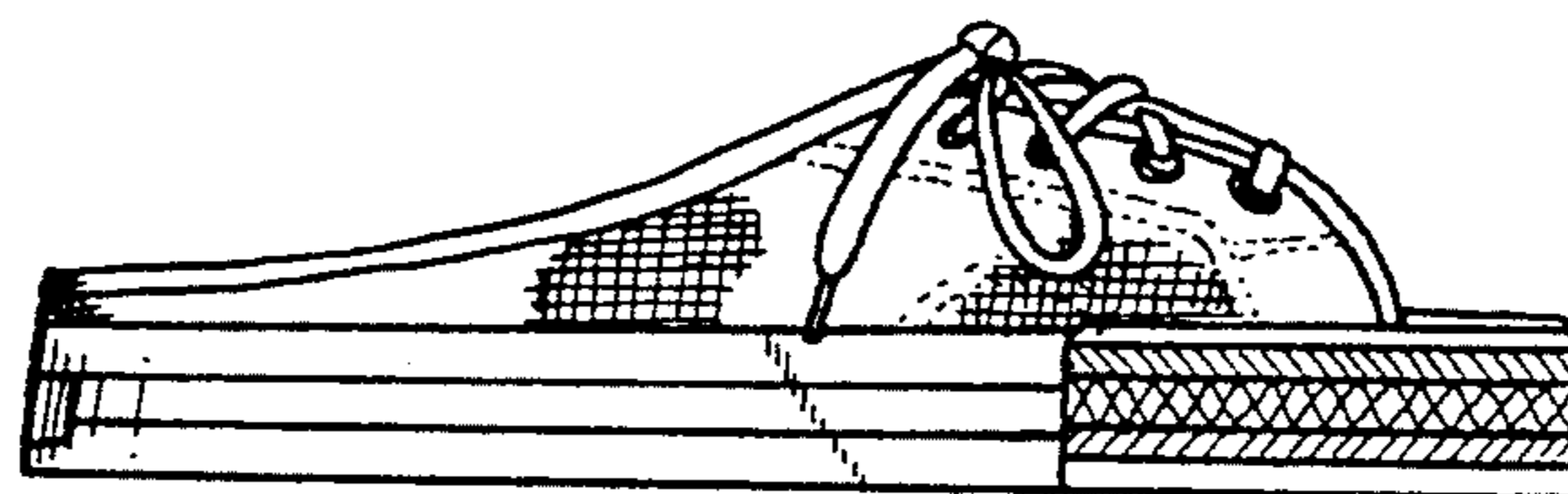

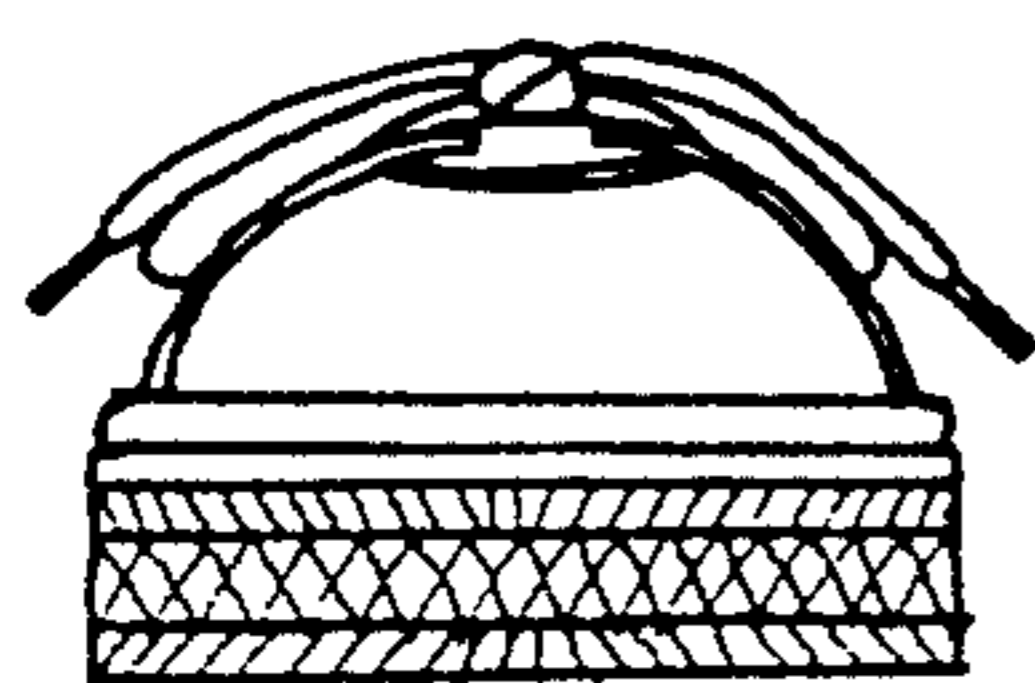

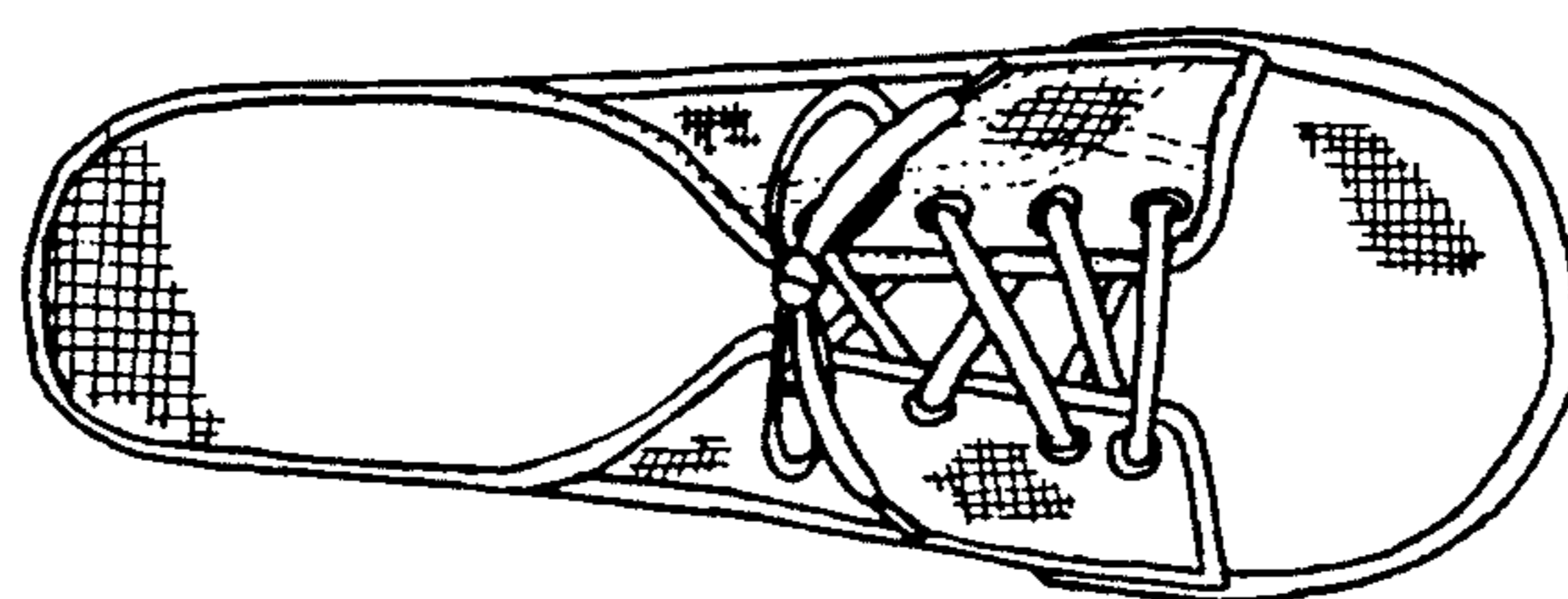

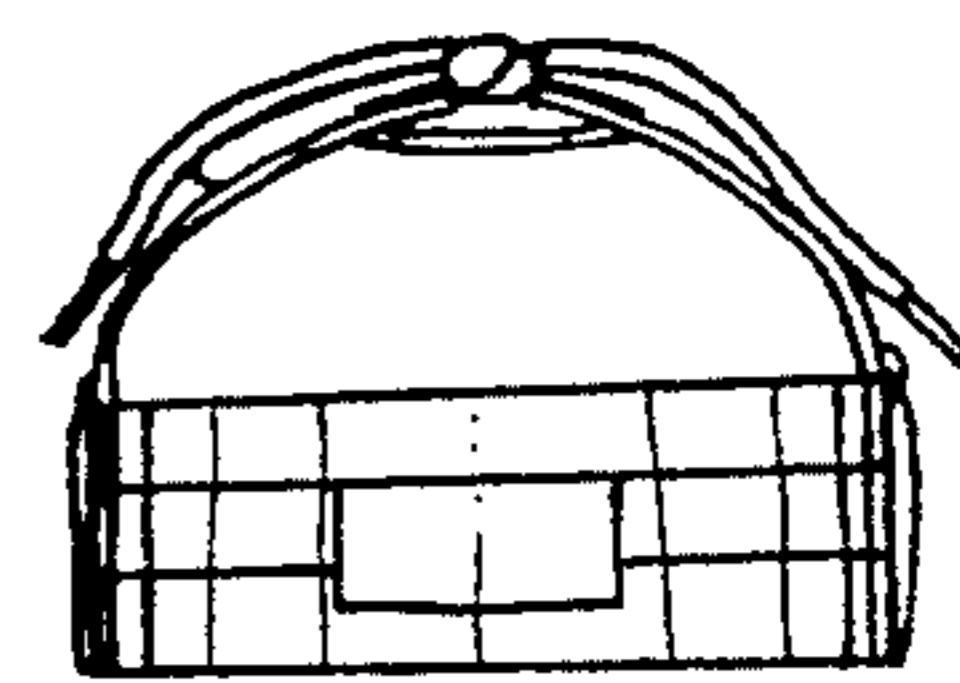

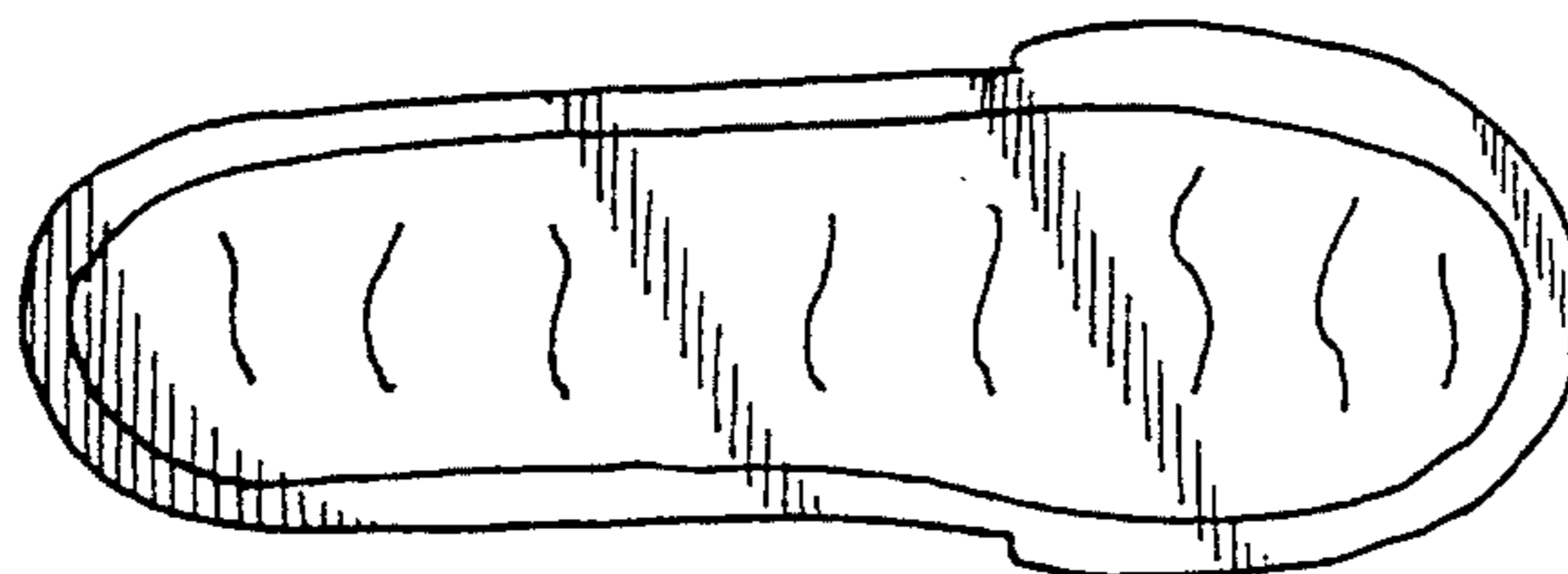
