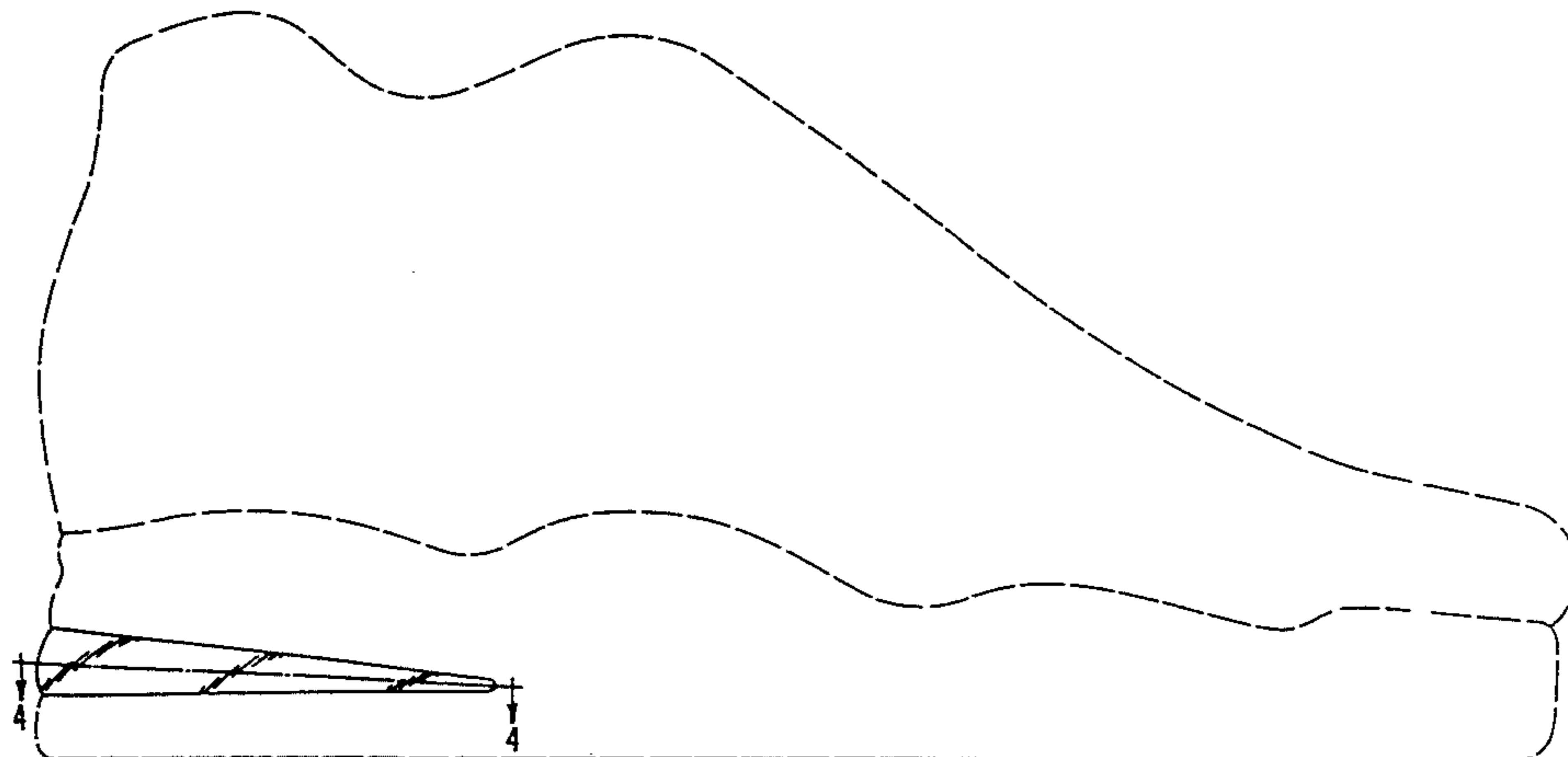

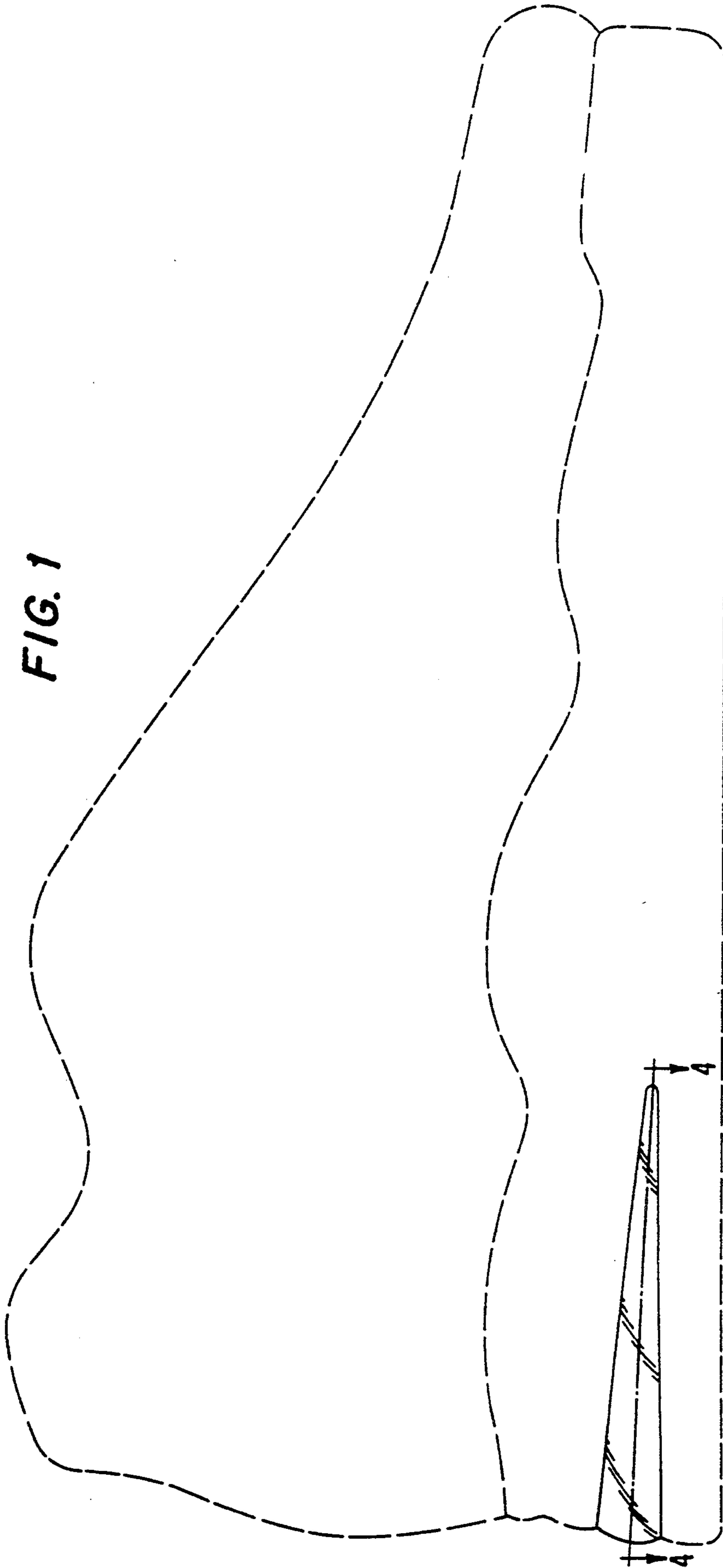
The ornamental design for an element for a shoe sole, as shown and described.

DESCRIPTION

FIG. 1 is a right side elevational view of an element for a shoe sole showing our new design;
 FIG. 2 is a left side elevational view thereof;
 FIG. 3 is a rear elevational view thereof; and,
 FIG. 4 is a cross-sectional view taken along the line 4-4 of FIG. 1.

The broken line showing of a shoe in FIGS. 1-4 is for illustrative purposes only and forms no part of the claimed design.





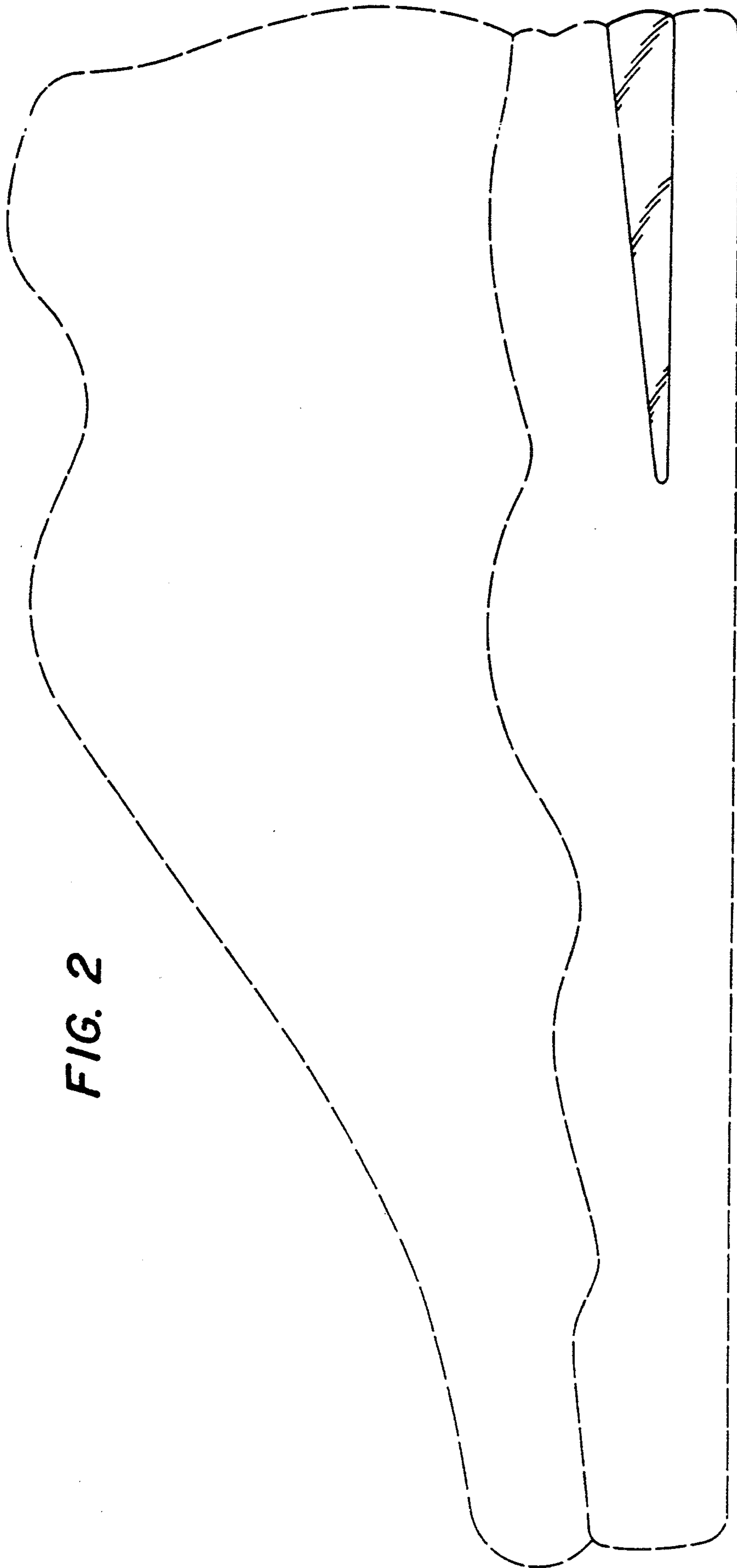

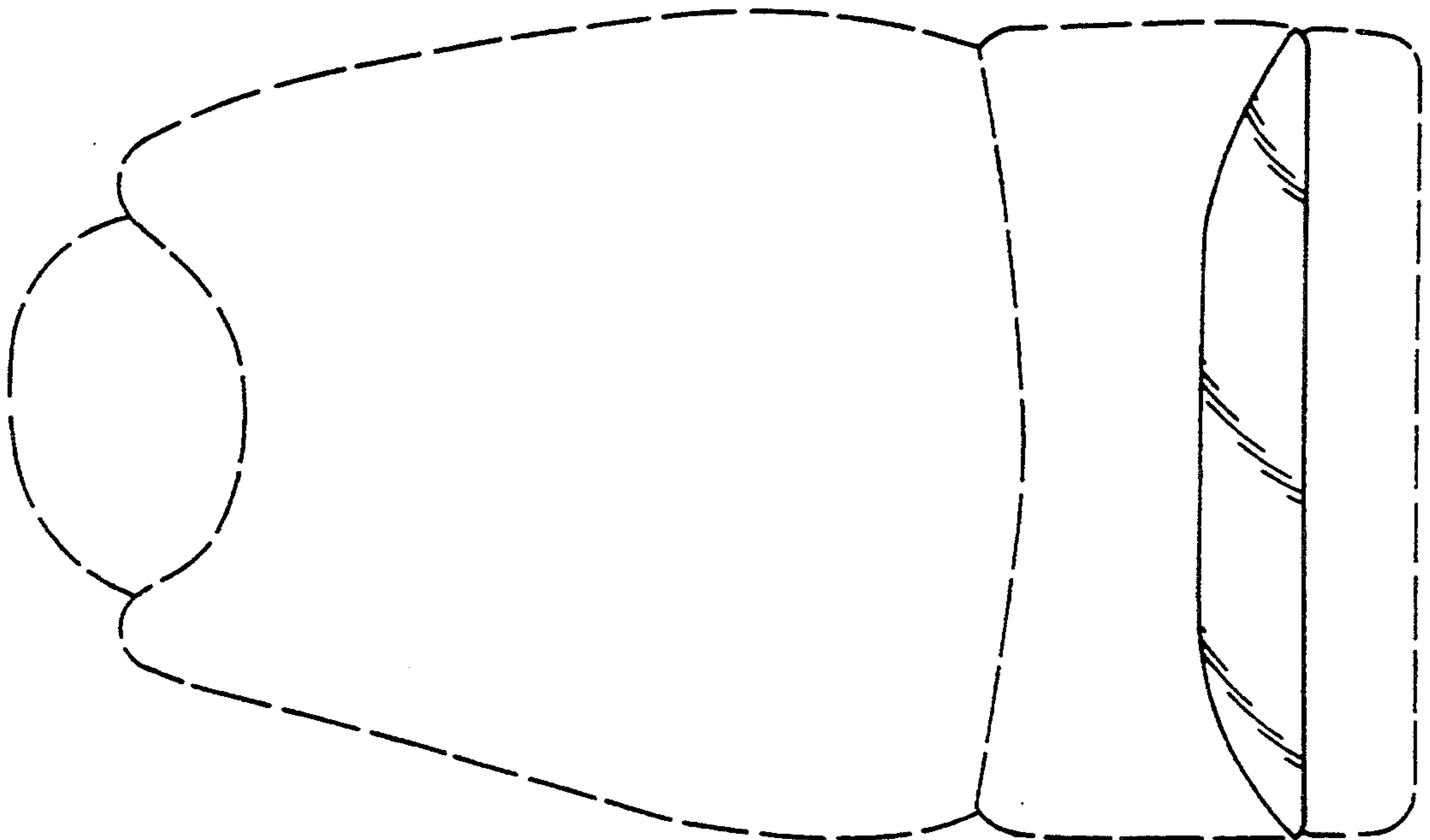
