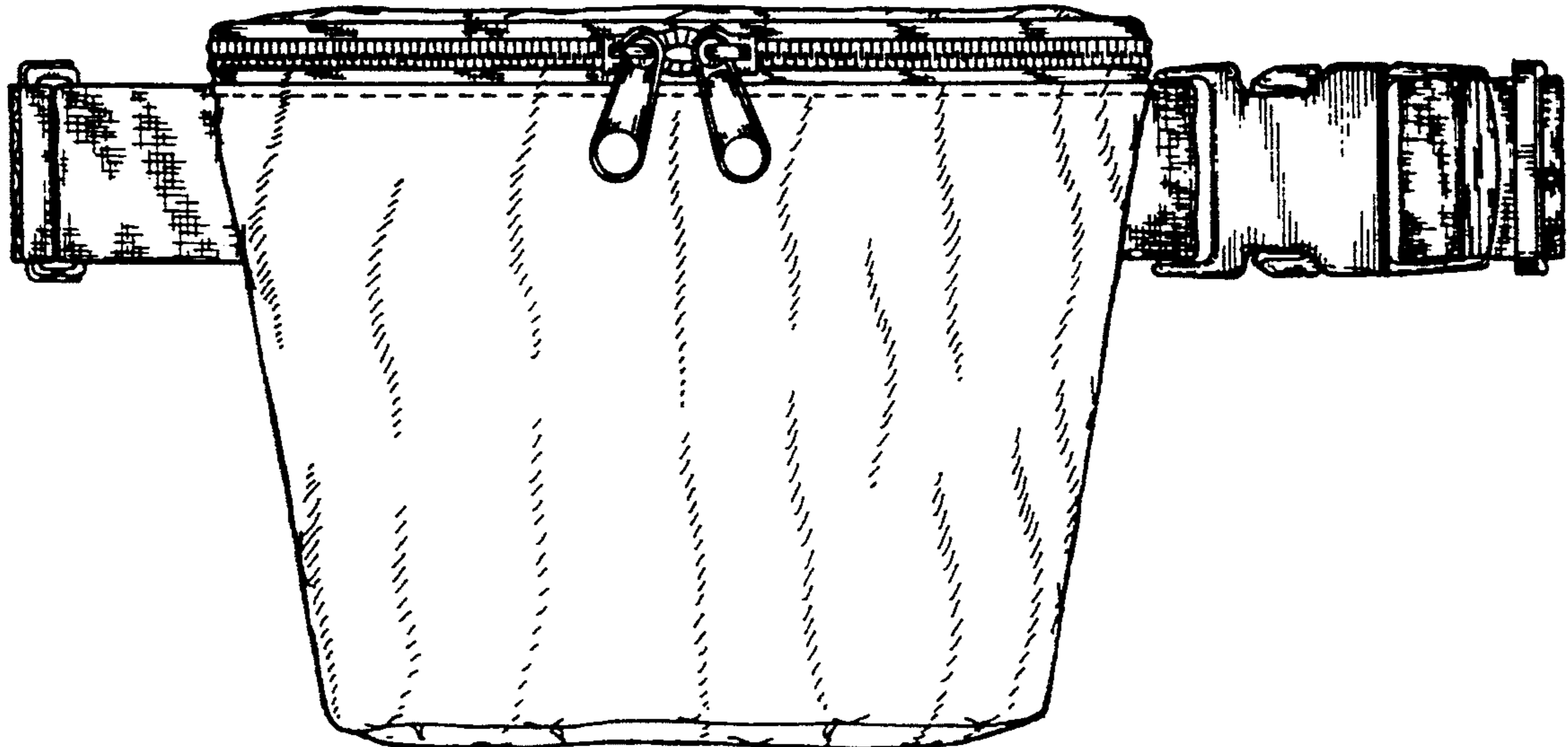
[57] **CLAIM**

The ornamental design for a coin holder pouch, as shown and described.

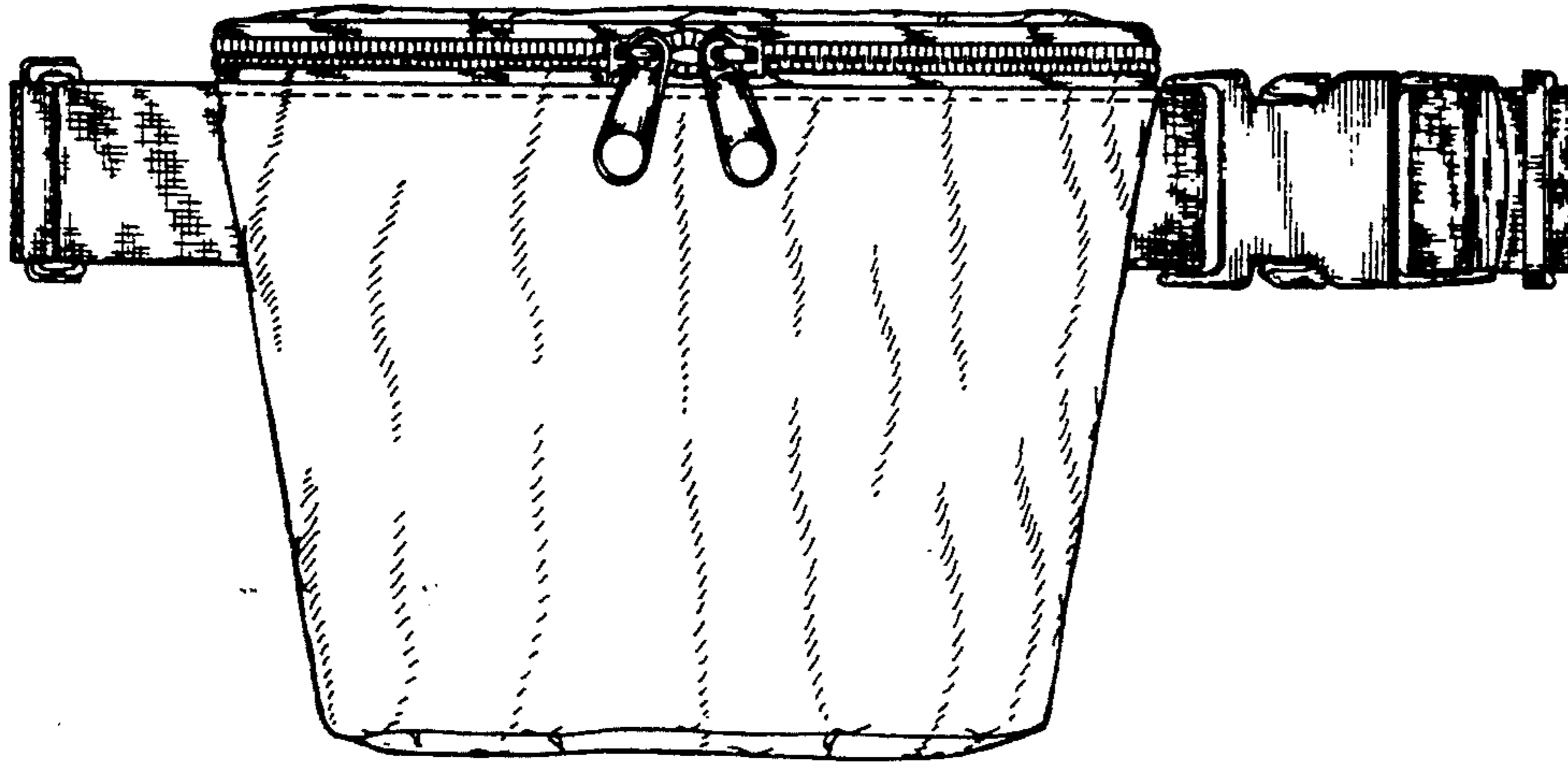
**DESCRIPTION**

FIG. 1 is an elevational view of a coin holder pouch showing a design of the present invention; FIG. 2 is a left side elevational view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a cross-sectional view taken along lines 7—7 of FIG. 3, the broken lines showing a container in FIG. 7 are for illustrative purposes only and form no part of the claimed design; FIG. 8 is a top frontal and right side perspective view of a second embodiment of the invention; FIG. 9 is a left rear bottom perspective view thereof; FIG. 10 is a top frontal and right side perspective view of a third embodiment of the present invention; and, FIG. 11 is a rear bottom and left side perspective view thereof.

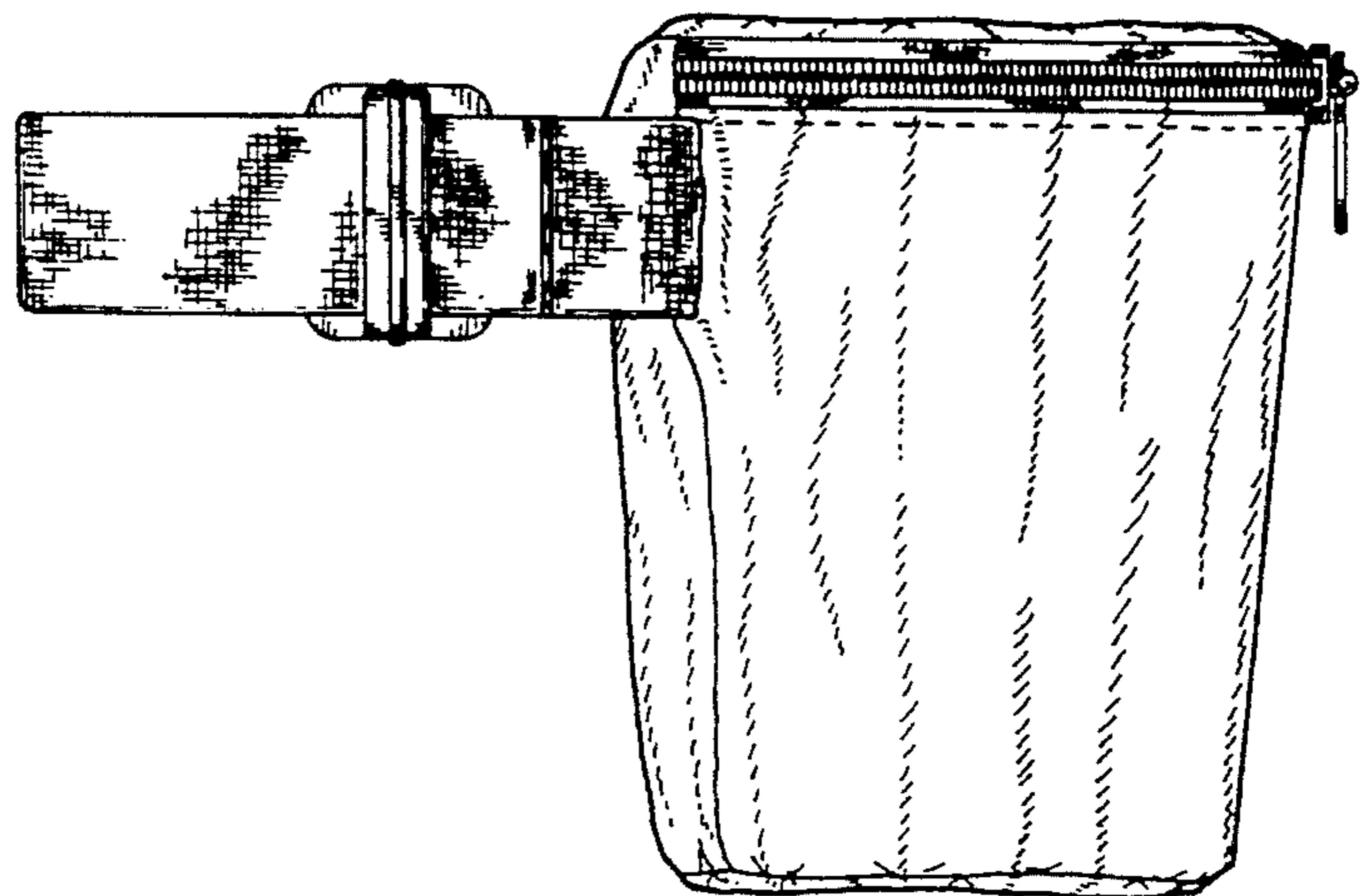

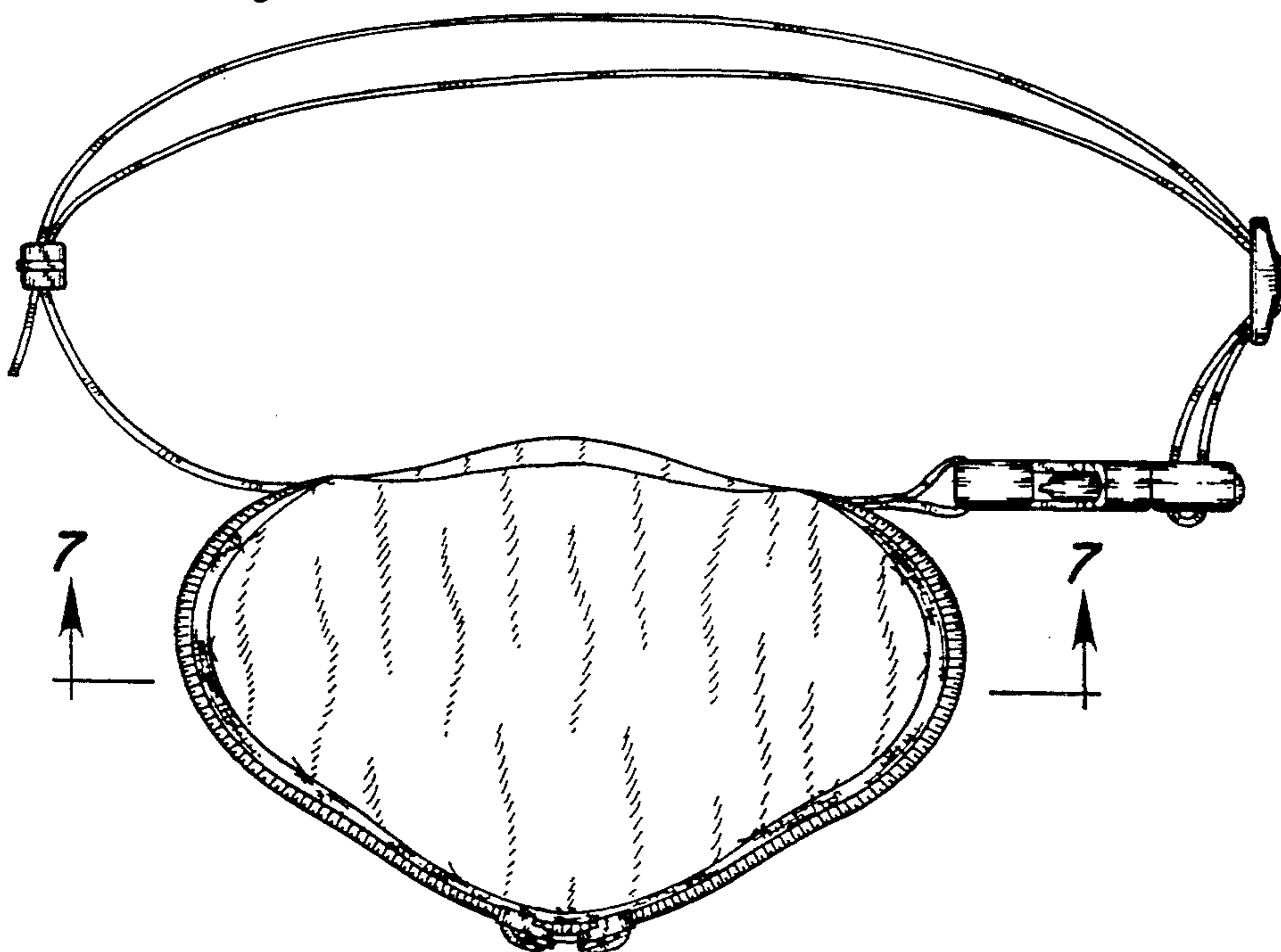

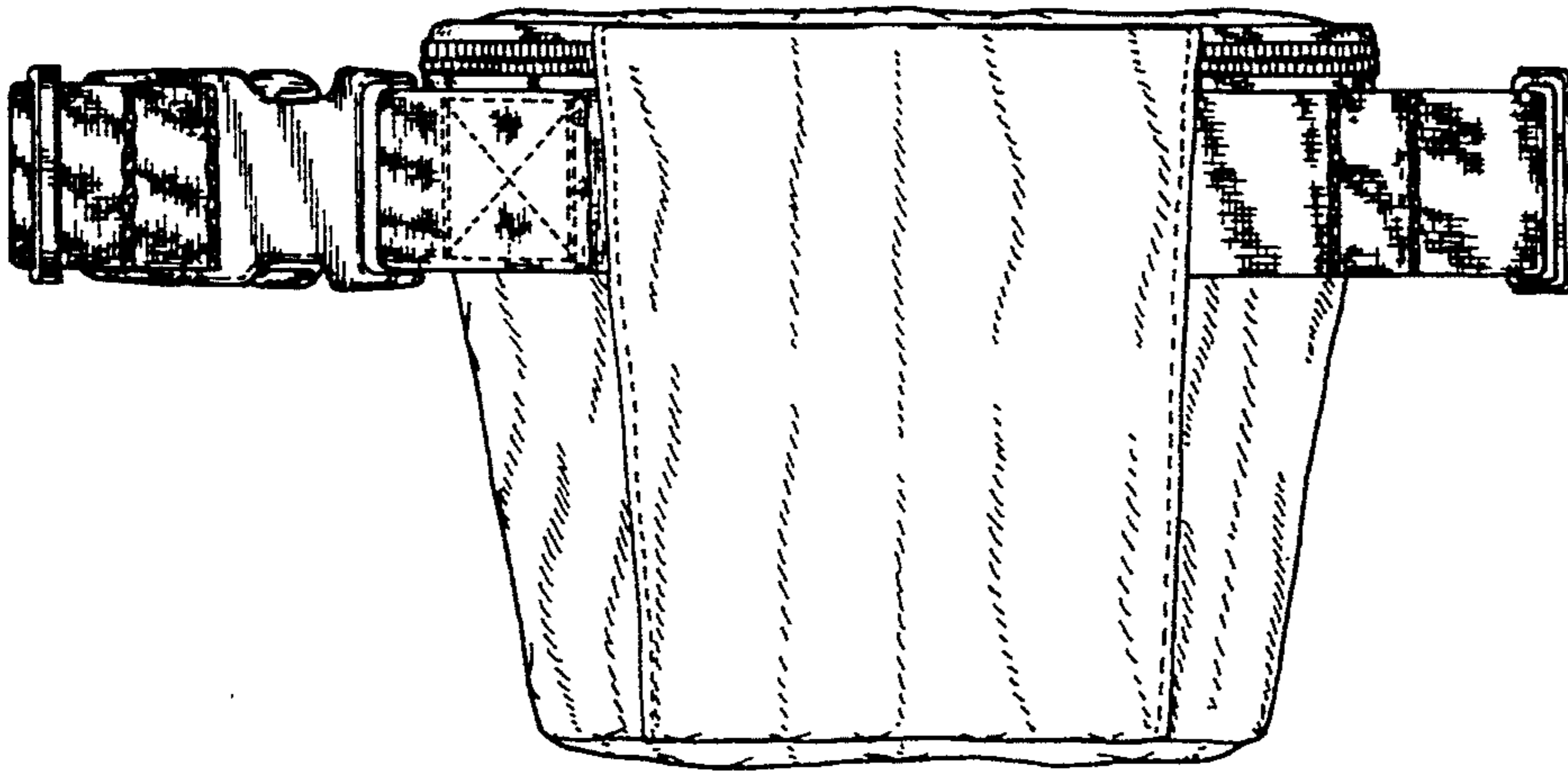

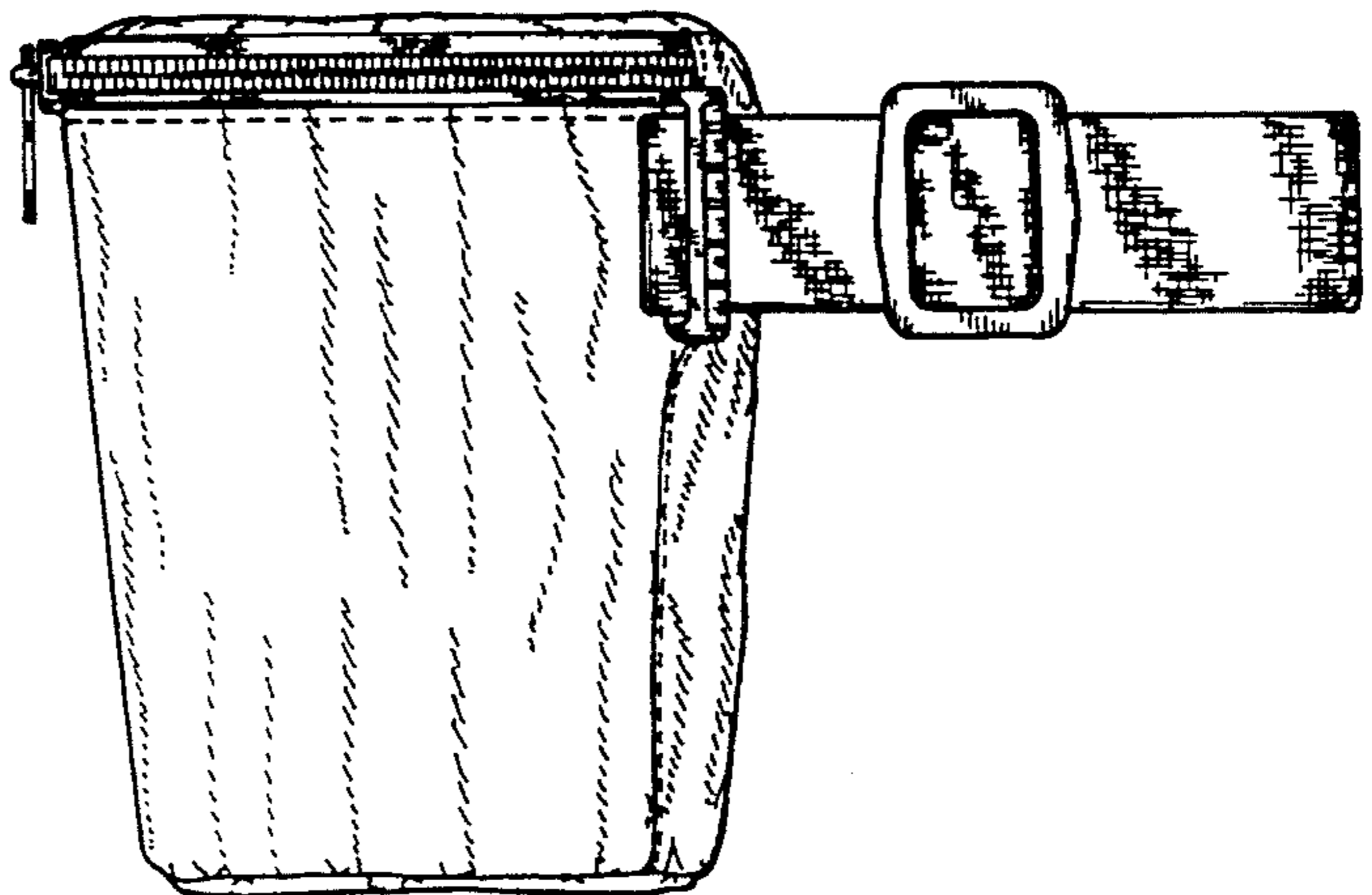

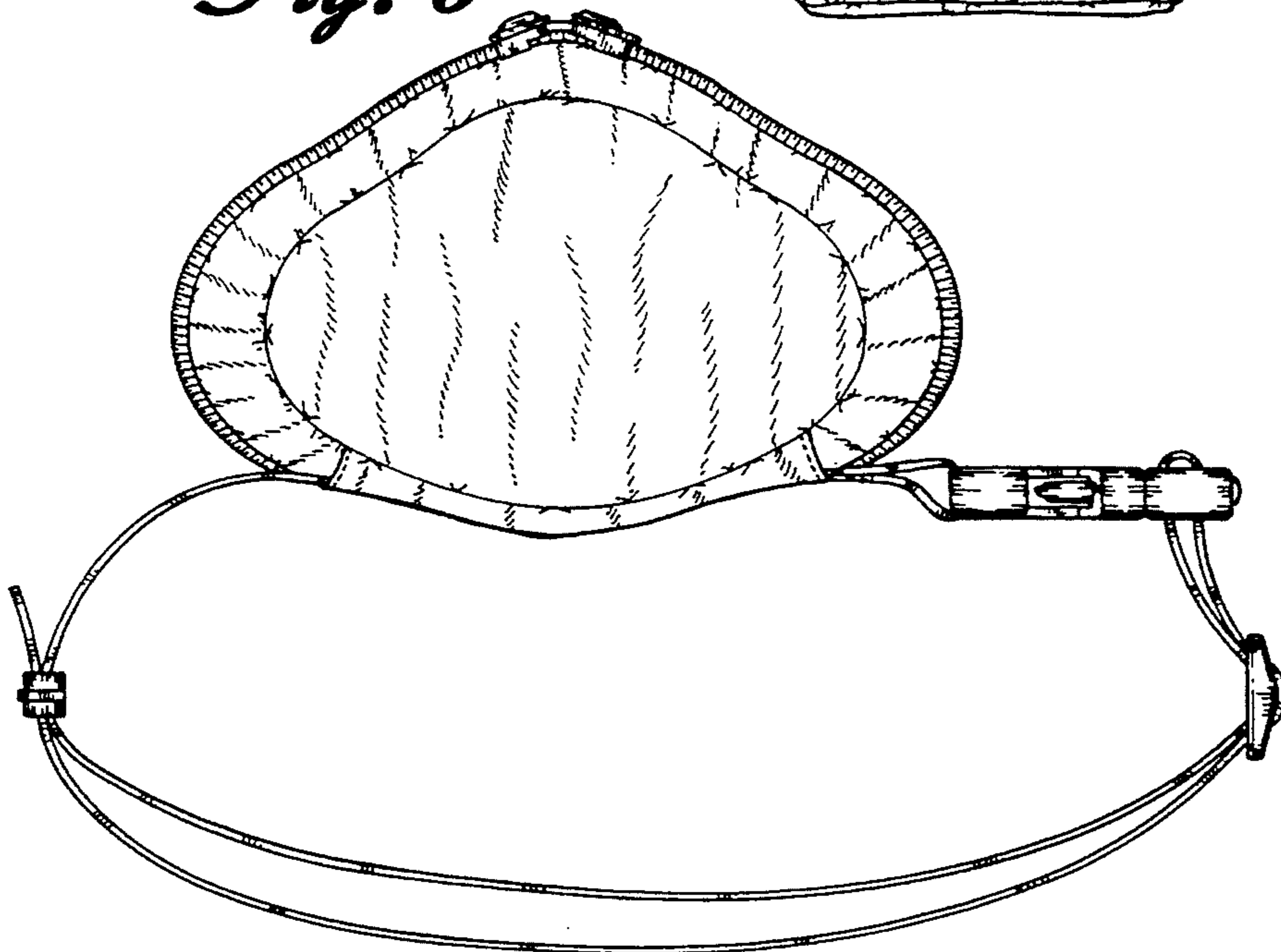

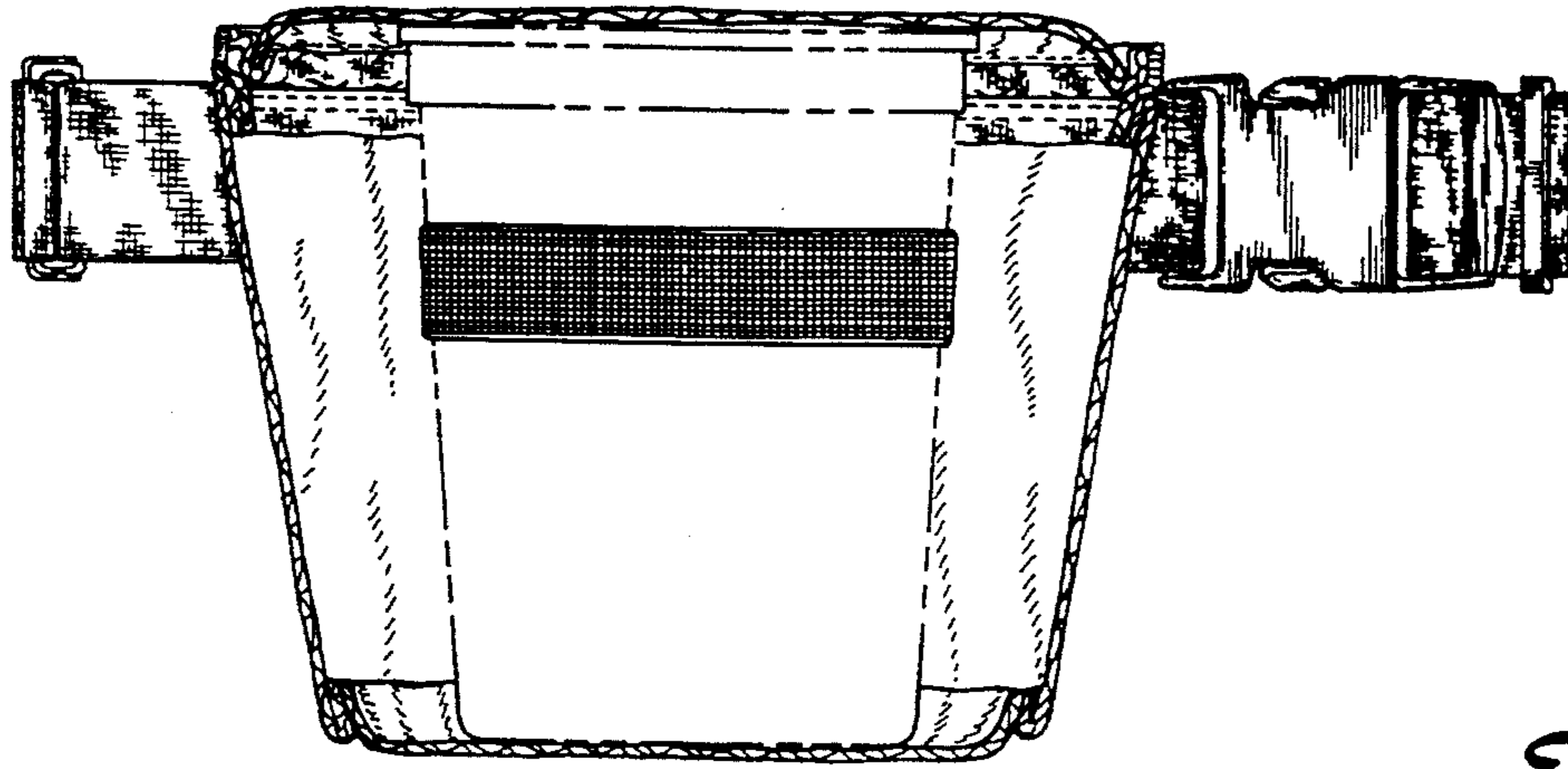

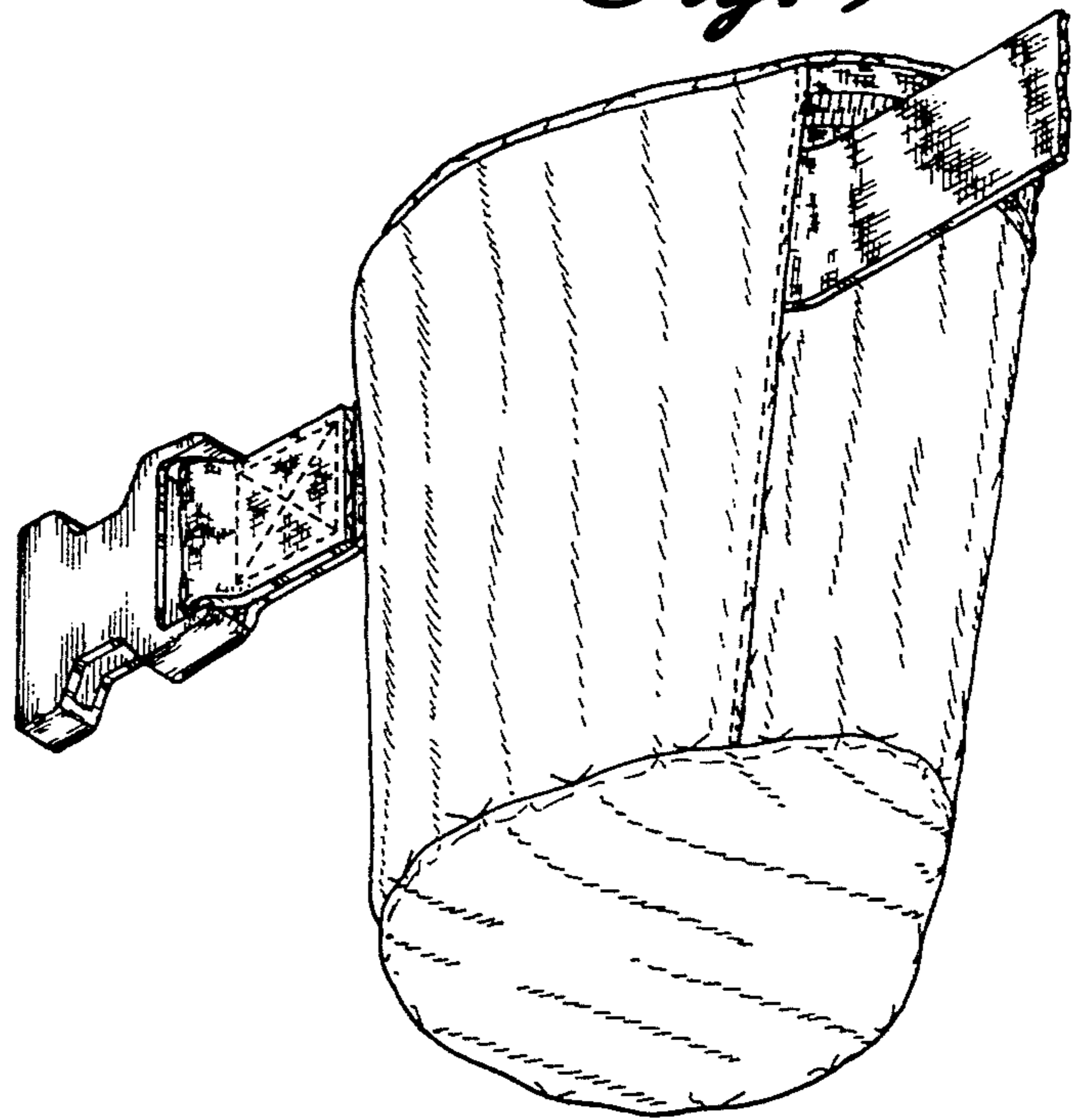

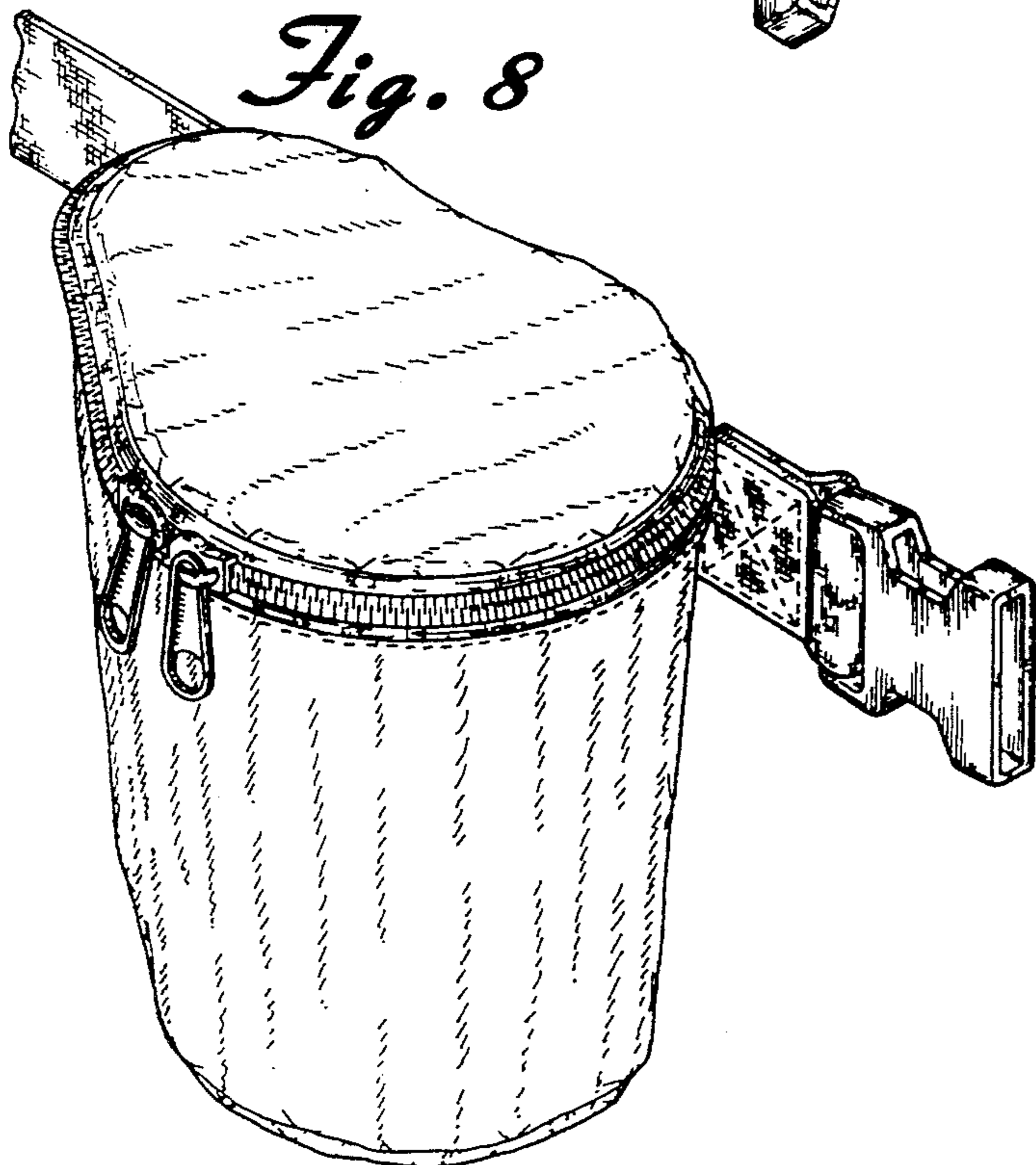

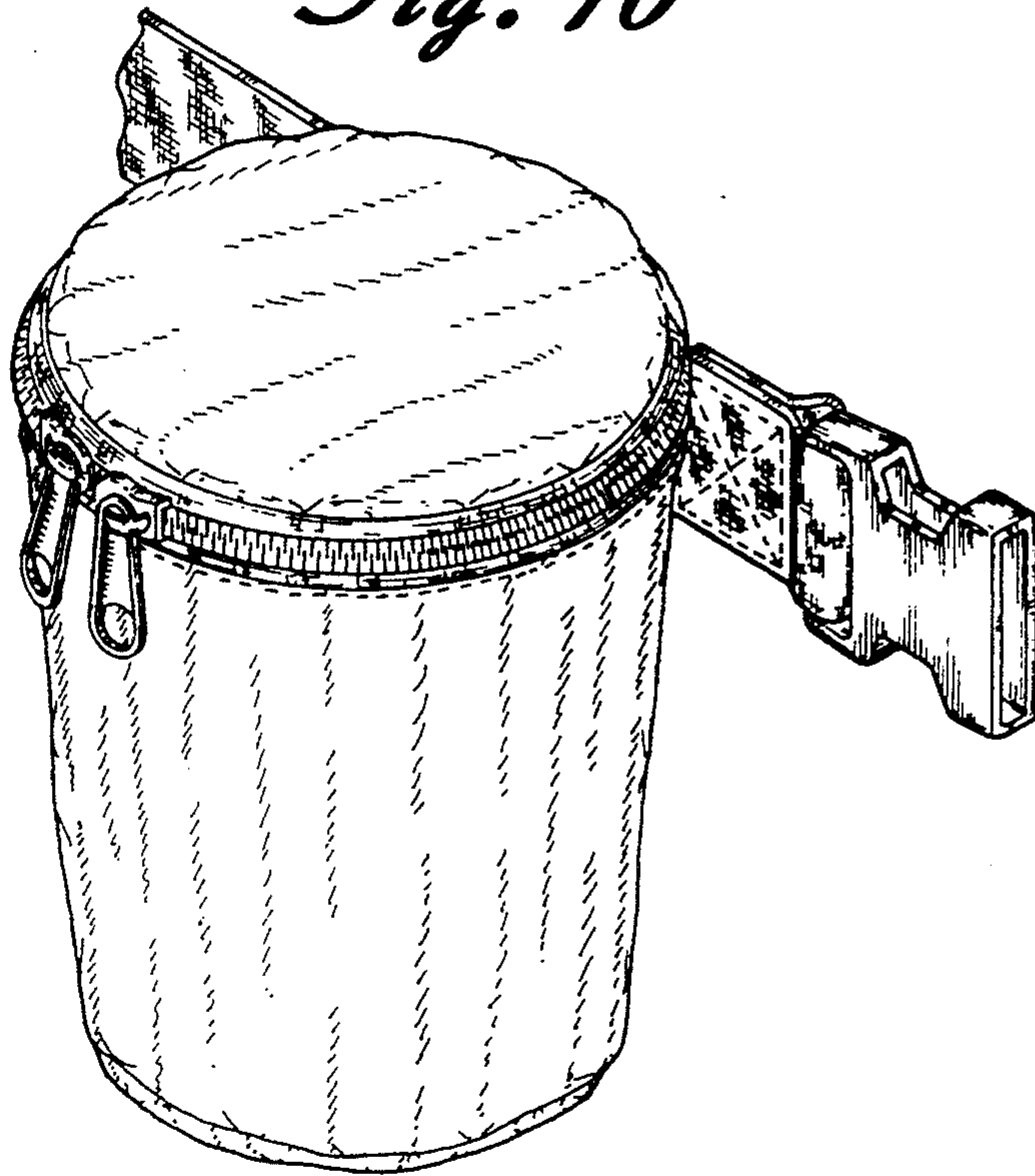
