### [57] CLAIM

The ornamental design for a floor construction for full depth crate, as shown and described.

### DESCRIPTION

FIG. 1 is a top plan view of a floor construction for full depth crate showing my new design;  
 FIG. 2 is a bottom plan view thereof;  
 FIG. 3 is a front side elevational view thereof; the rear side elevational view being a mirror image thereof;  
 FIG. 4 is a left end elevational view thereof; the right end elevational view being a mirror image thereof;  
 FIG. 5 is an enlarged cross-sectional view taken on line 5-5 of FIG. 2;  
 FIG. 6 is an enlarged cross-sectional view taken on line 6-6 of FIG. 2; and,  
 FIG. 7 is an enlarged cross-sectional view taken on line 7-7 of FIG. 2.  
 The broken line showing of the walls is for illustrative purposes only and forms no part of the claimed design.

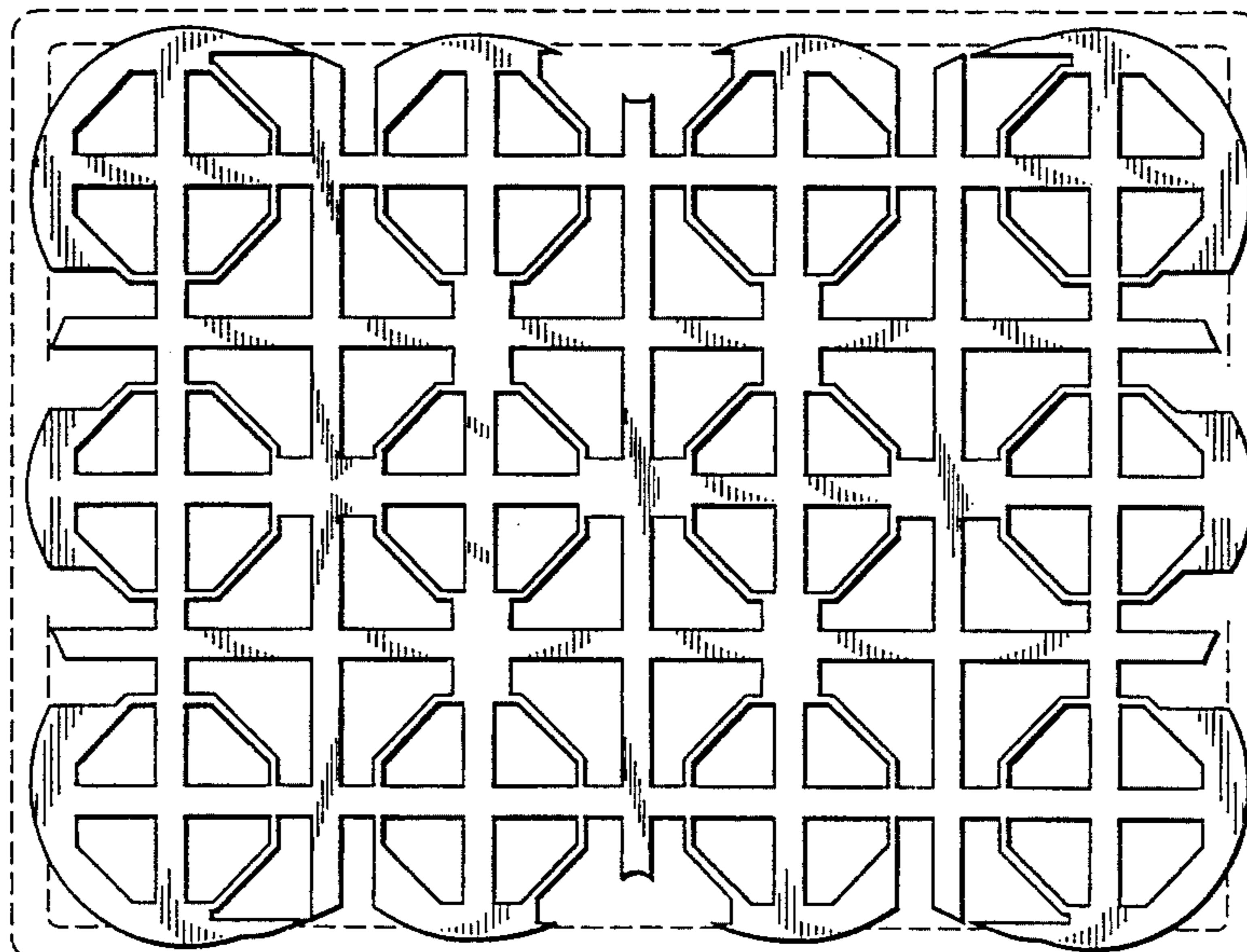

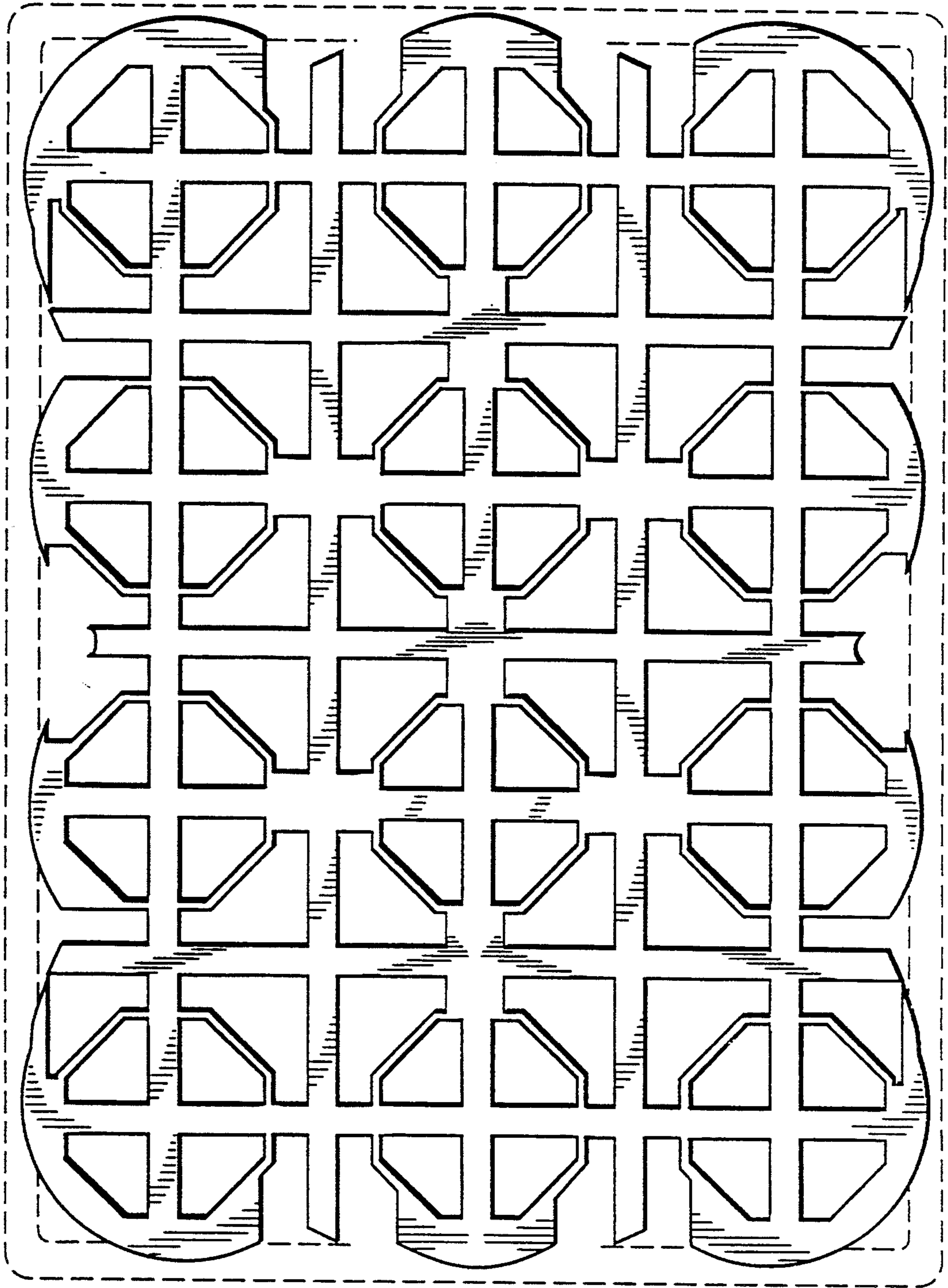

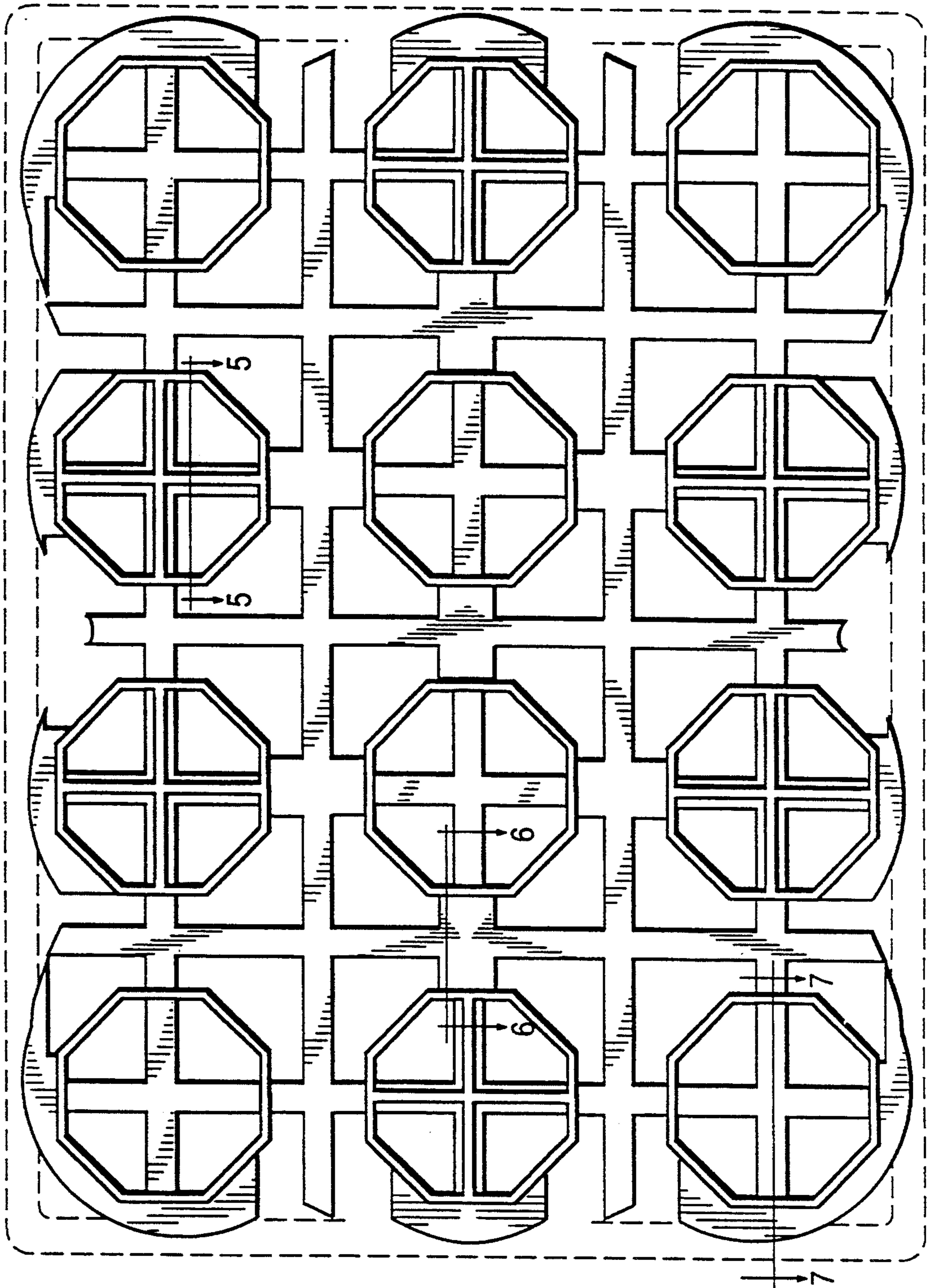
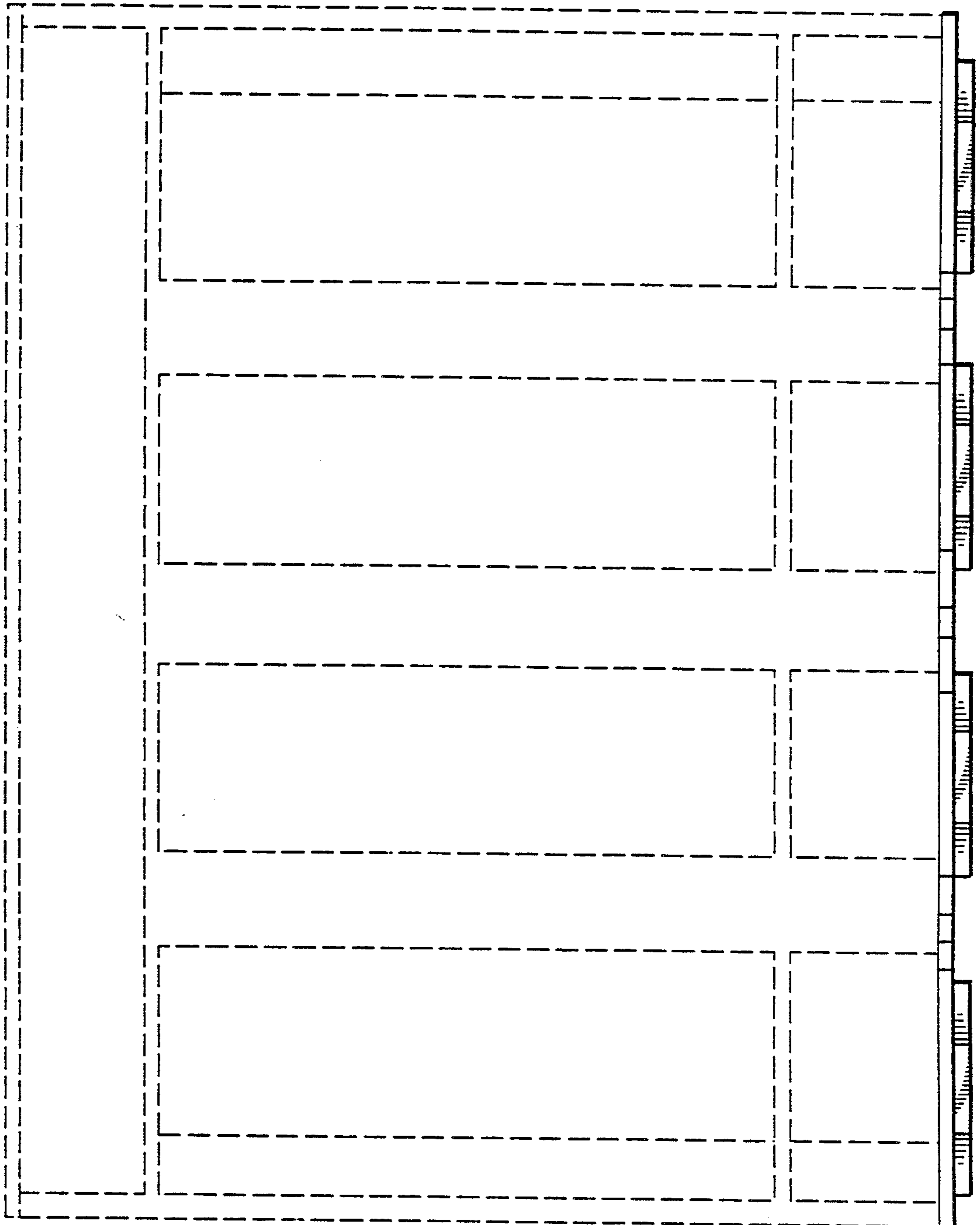
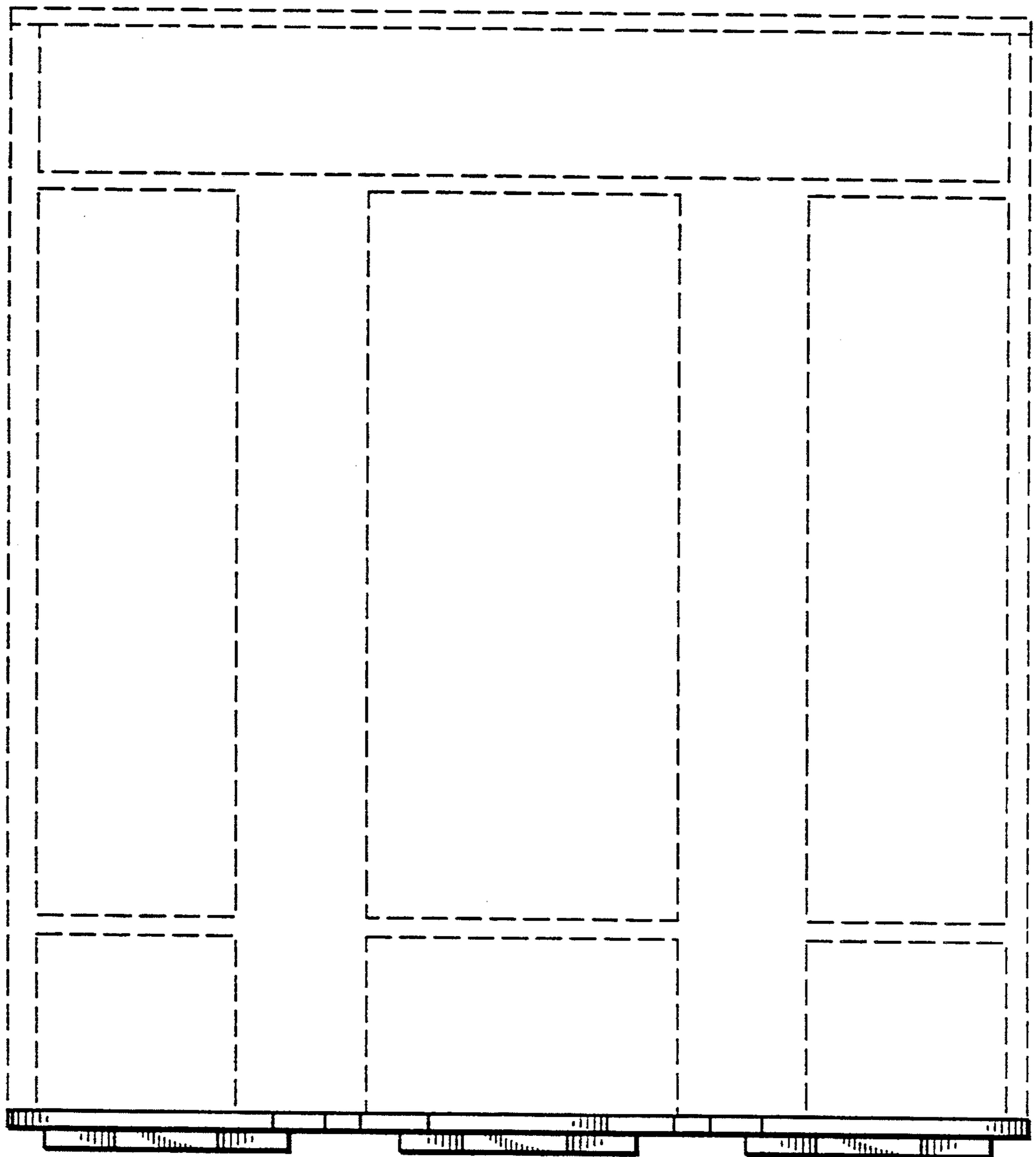


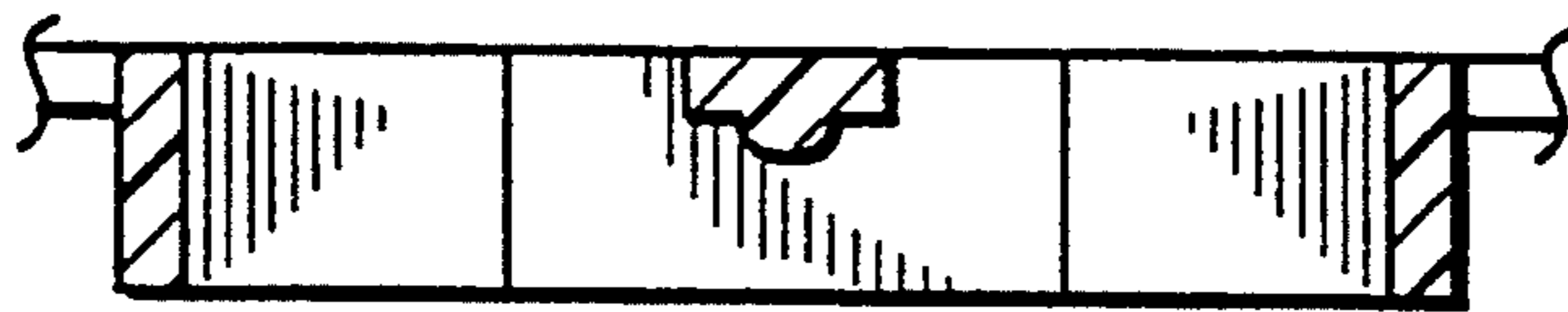
