The ornamental design for a bracelet, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a bracelet showing my new design;
 FIG. 2 is a top plan view, the opposite side view being a mirror image;
 FIG. 3 is a rear elevational view;
 FIG. 4 is a right side elevational view;
 FIG. 5 is a front elevational view of a bracelet showing a second embodiment of my new design;
 FIG. 6 is a top plan view of FIG. 5, the opposite side view being a mirror image thereof;
 FIG. 7 is a rear elevational view of FIG. 5;
 FIG. 8 is a right side elevational view of FIG. 5;
 FIG. 9 is a front elevational view of a bracelet showing a third embodiment of my new design;
 FIG. 10 is a top plan view of FIG. 9, the opposite side view being a mirror image thereof;
 FIG. 11 is a rear elevational view FIG. 9;
 FIG. 12 is a right side elevational view of FIG. 9;
 FIG. 13 is a front elevational view of a bracelet showing a fourth embodiment of my new design;
 FIG. 14 is a top plan view of FIG. 13;
 FIG. 15 is a rear elevational view of FIG. 13; and,
 FIG. 16 is a right side elevational view of FIG. 13.
 The broken line showing of a portion of a chain in FIGS. 1, 5, 9 and 13 is for illustrative purposes only and forms no part of the claimed design.

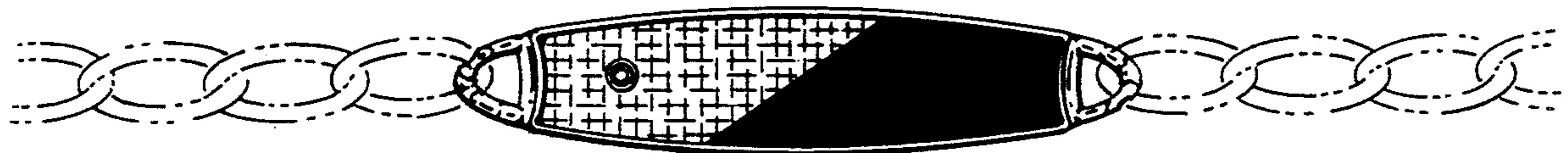

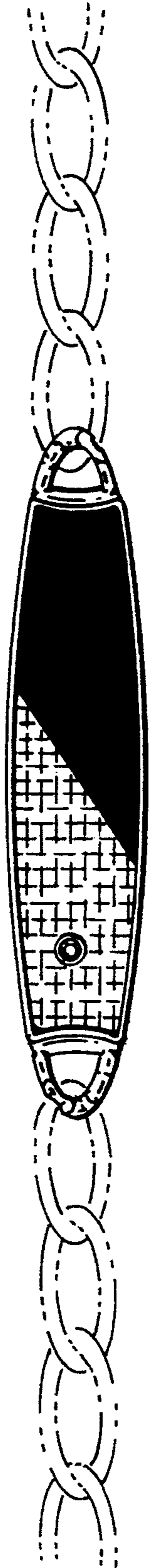

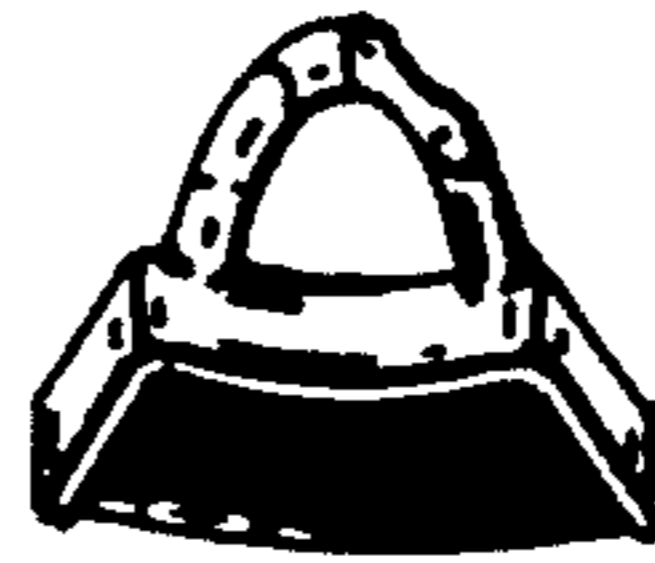

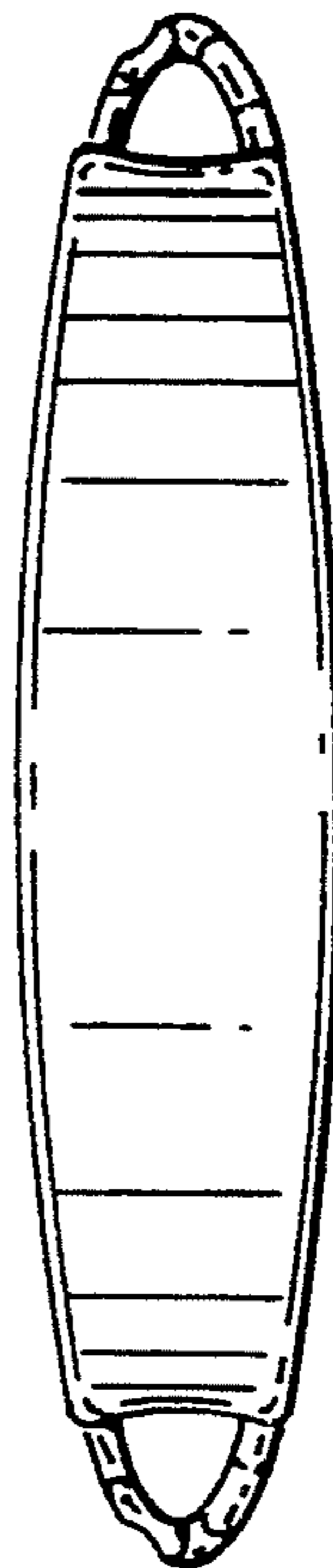

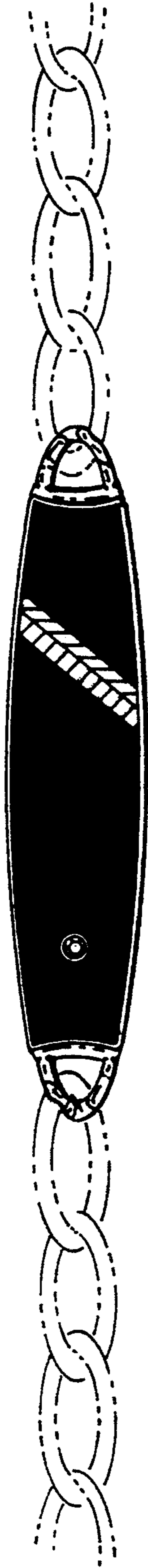

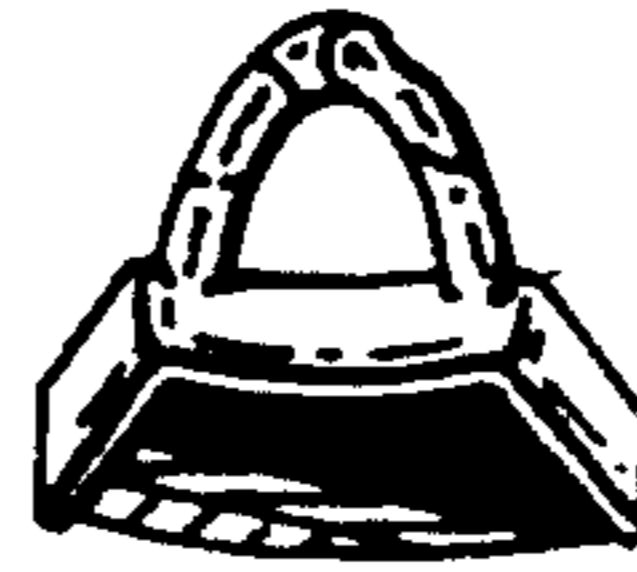

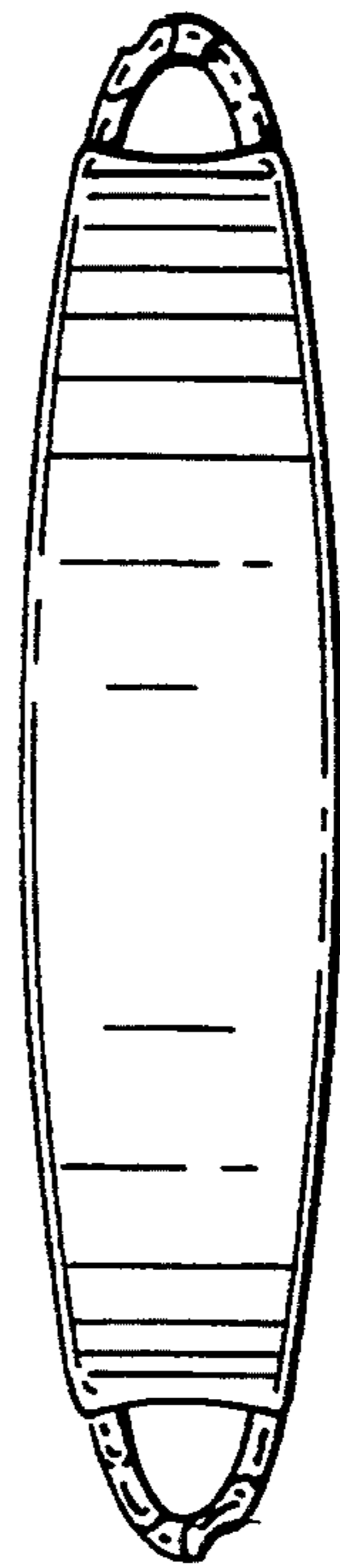

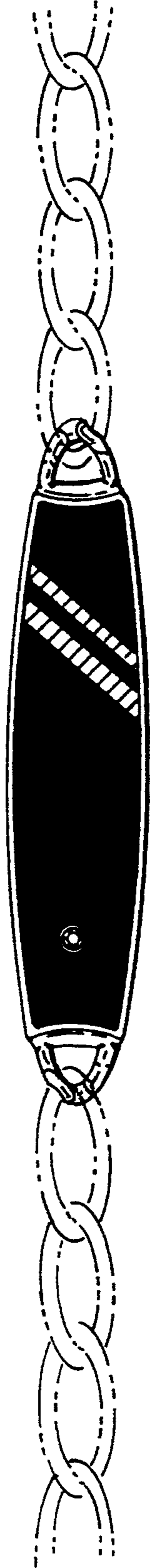

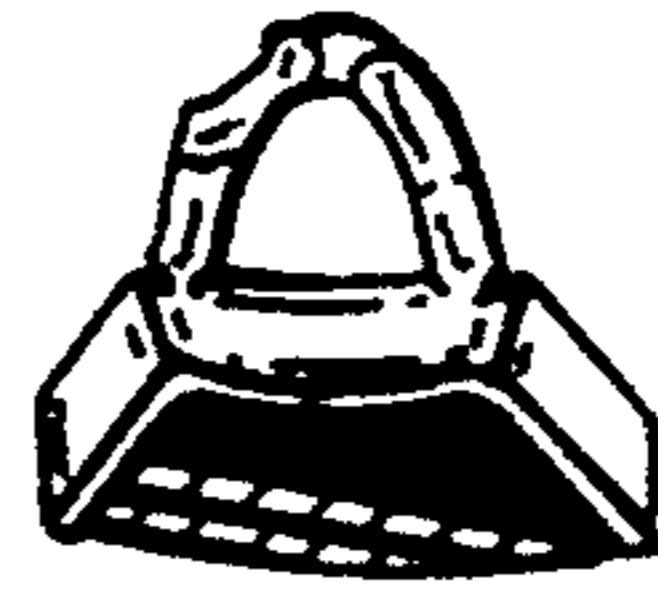

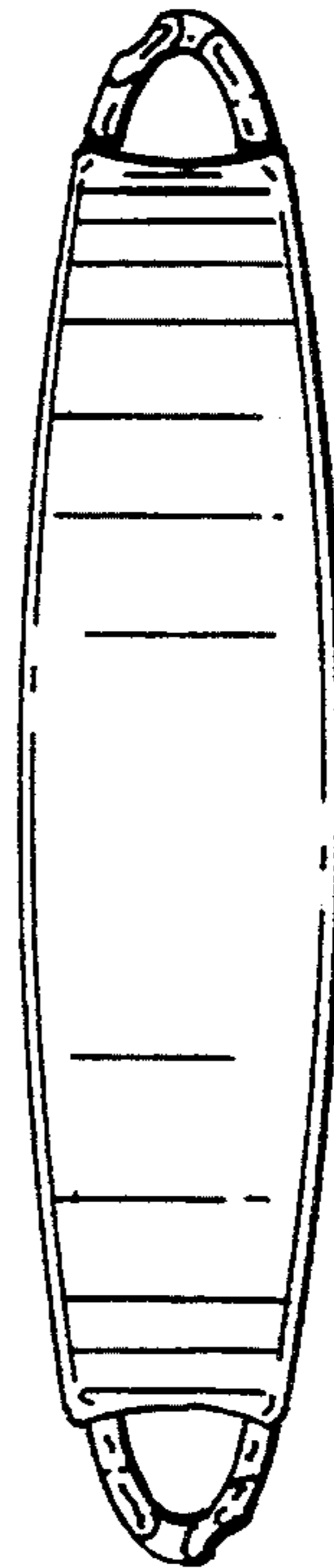

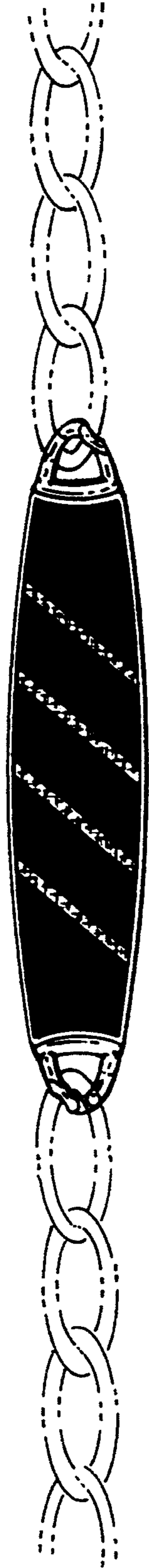

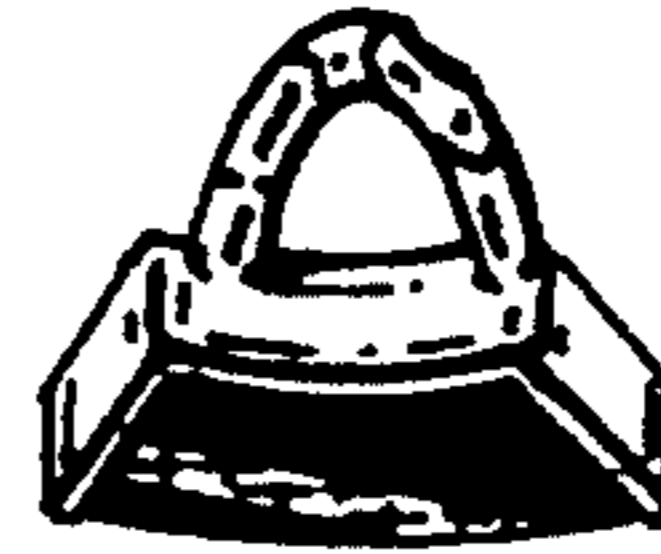

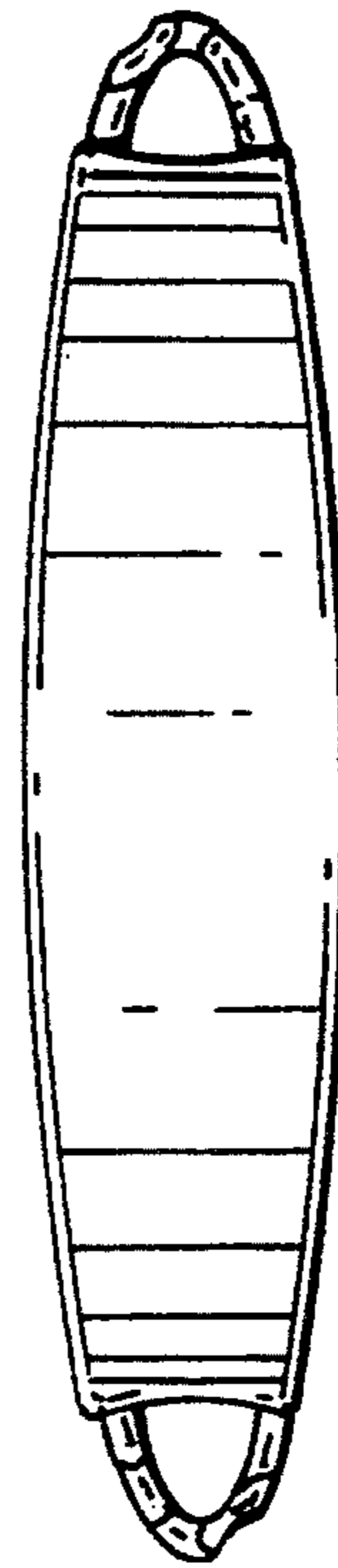
