DESCRIPTION

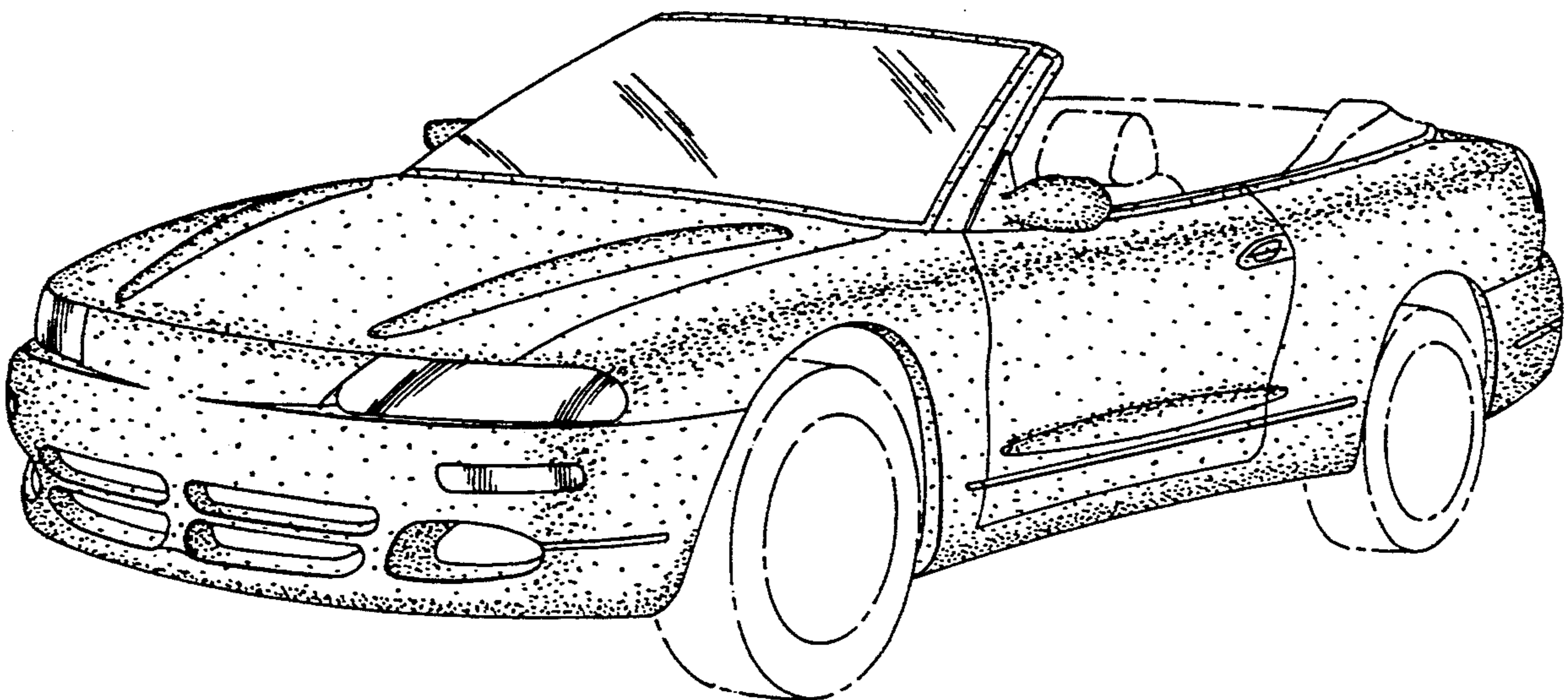

FIG. 5 is a rear view of the automobile body shown in FIG. 1.



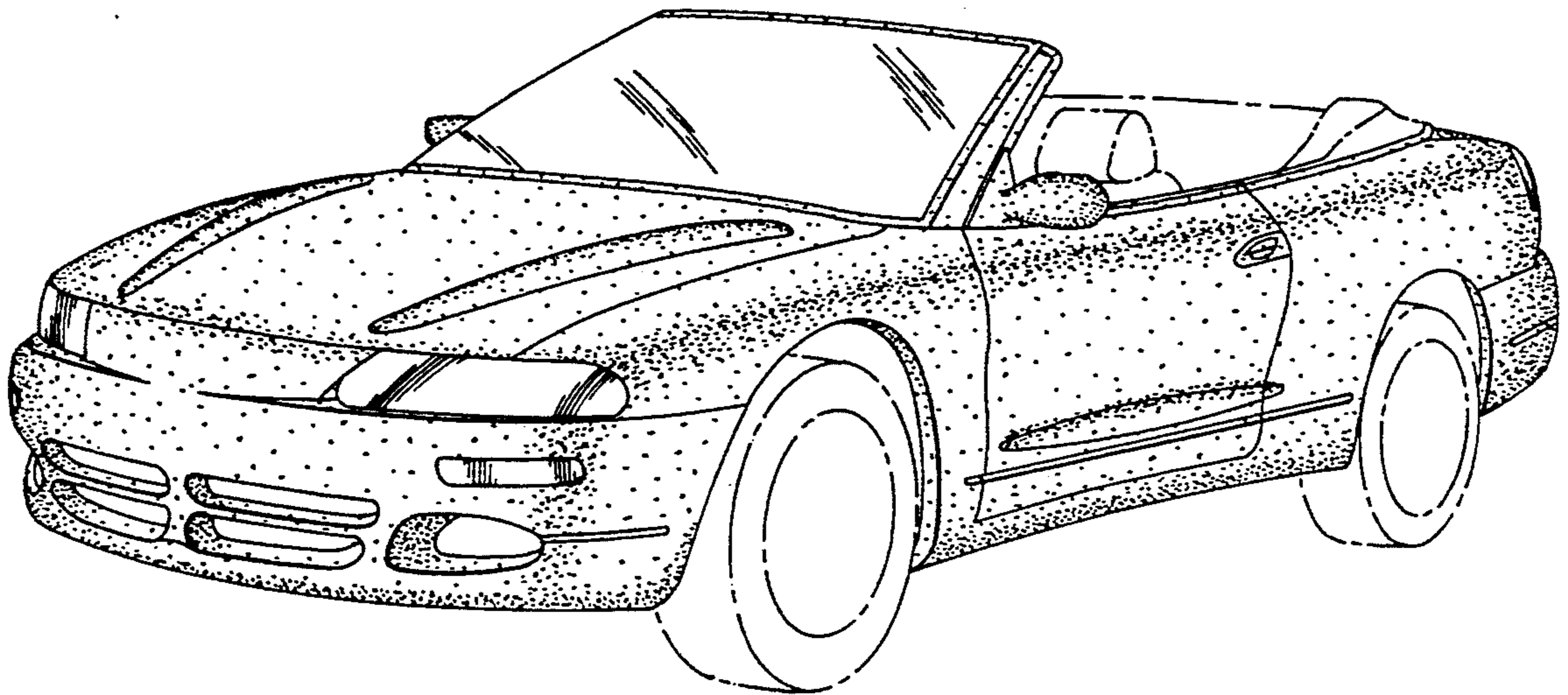

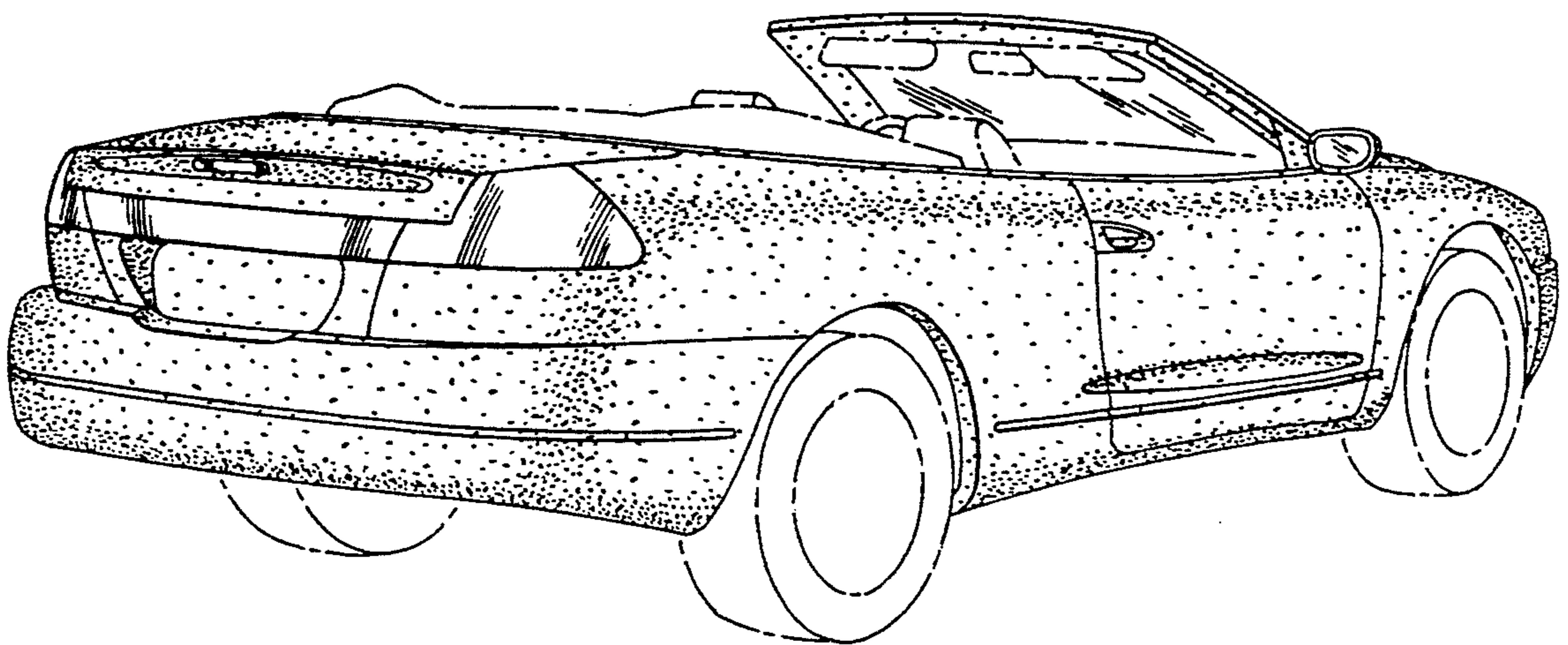

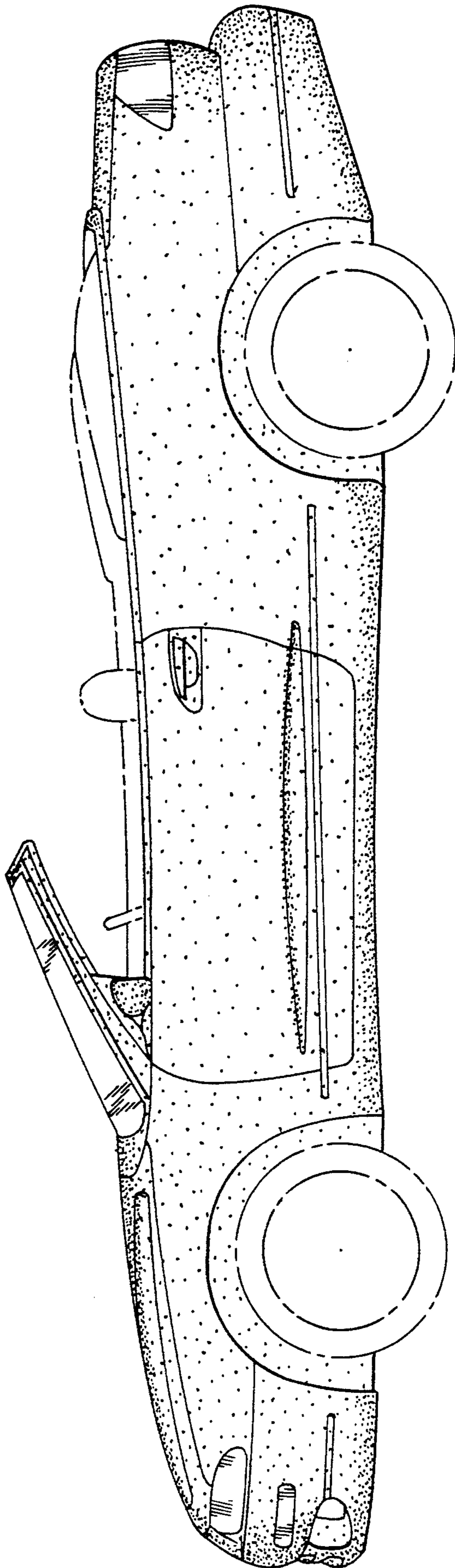

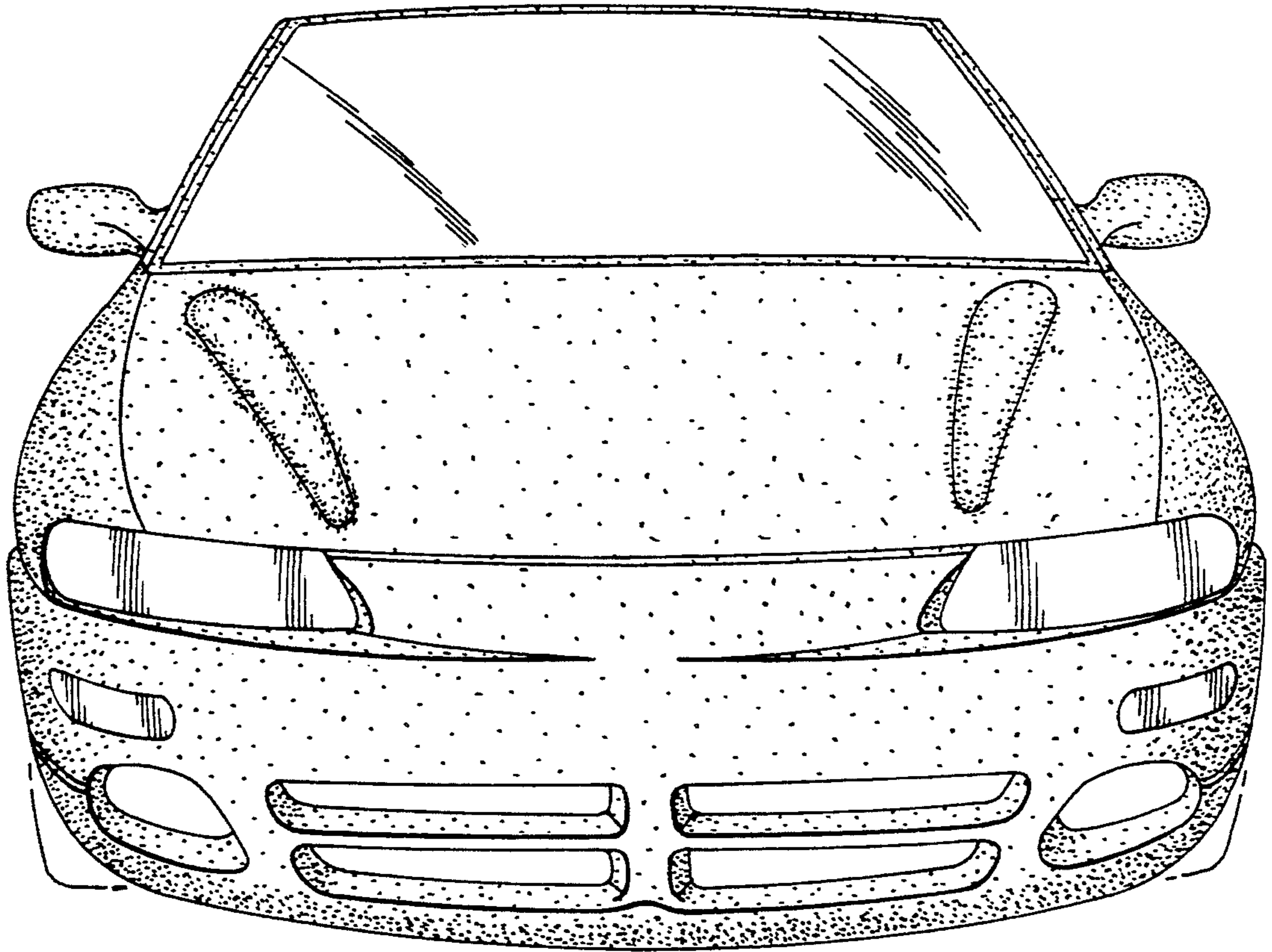
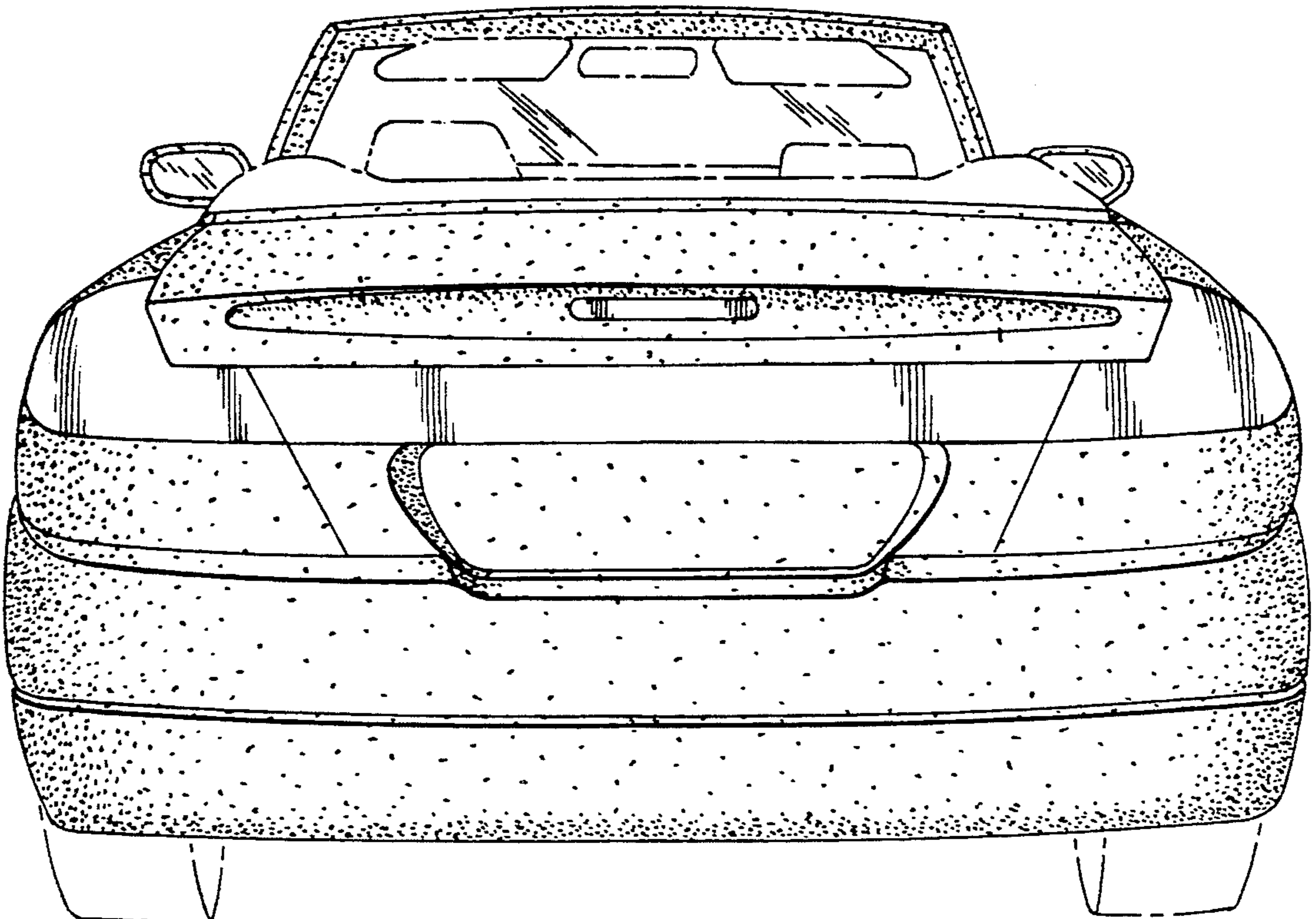
