FIG. 1 is a top plan view of graphic equalizer, showing our new design;

FIG. 7 is a front, top and right side perspective view thereof.

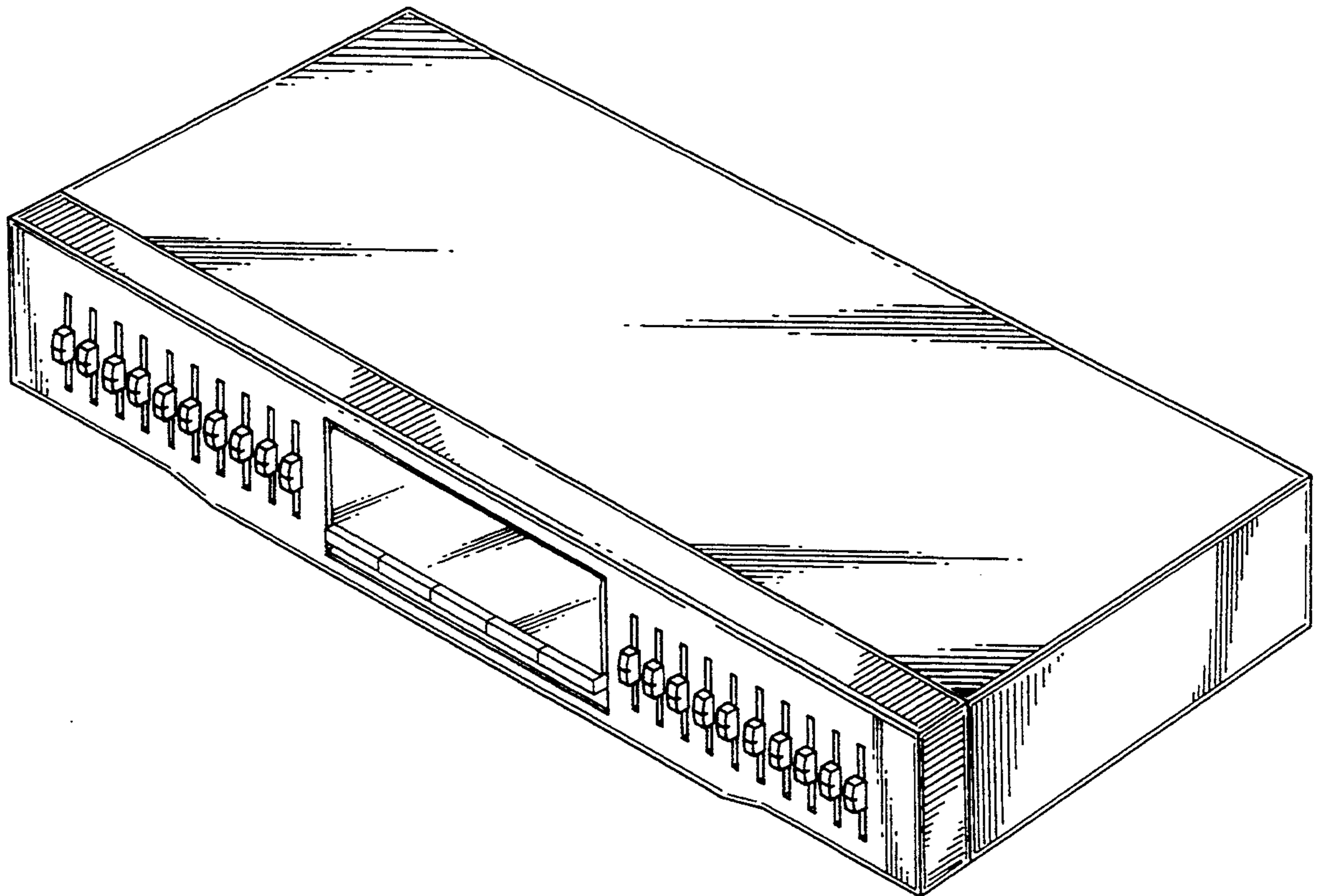

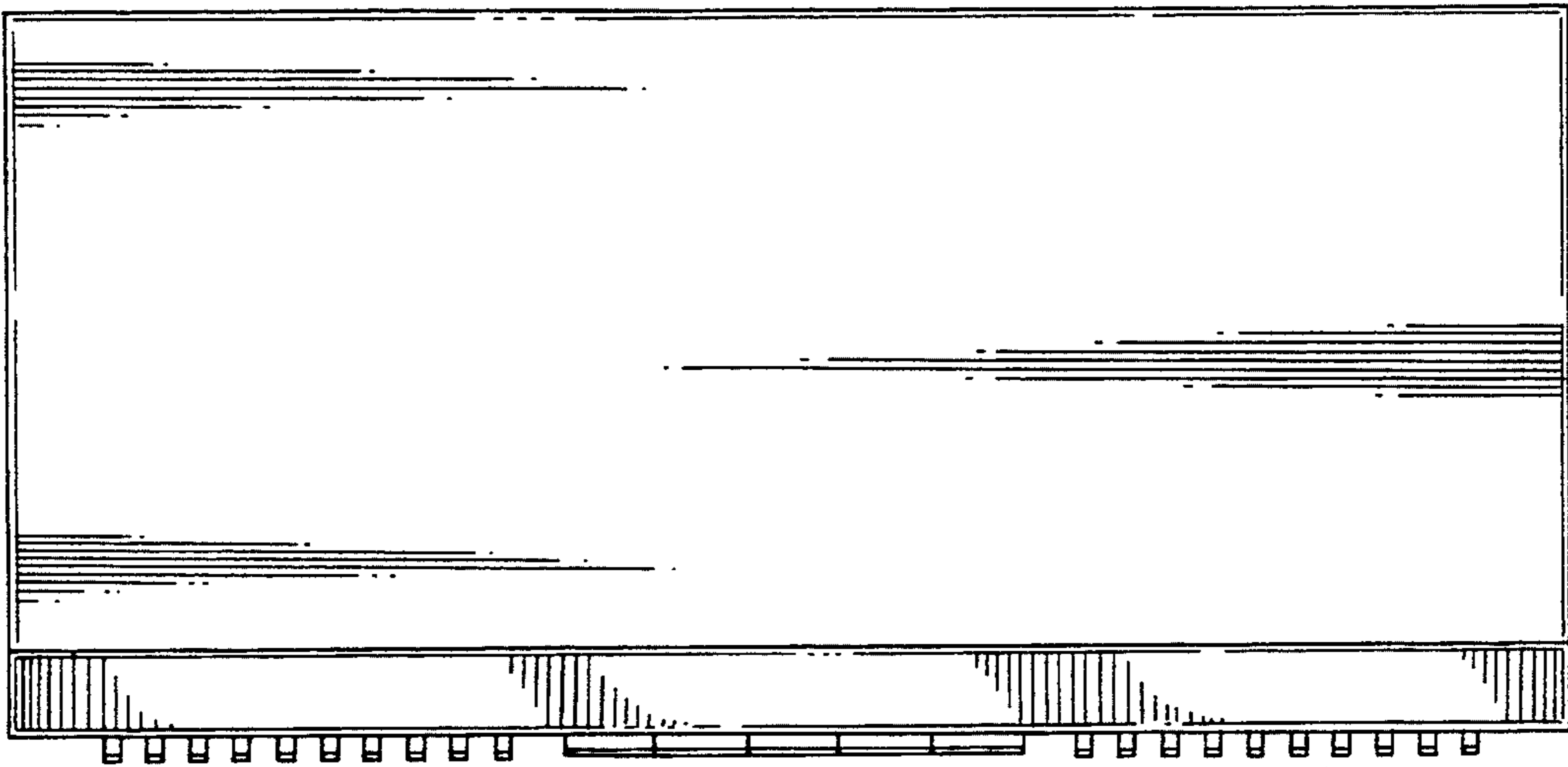

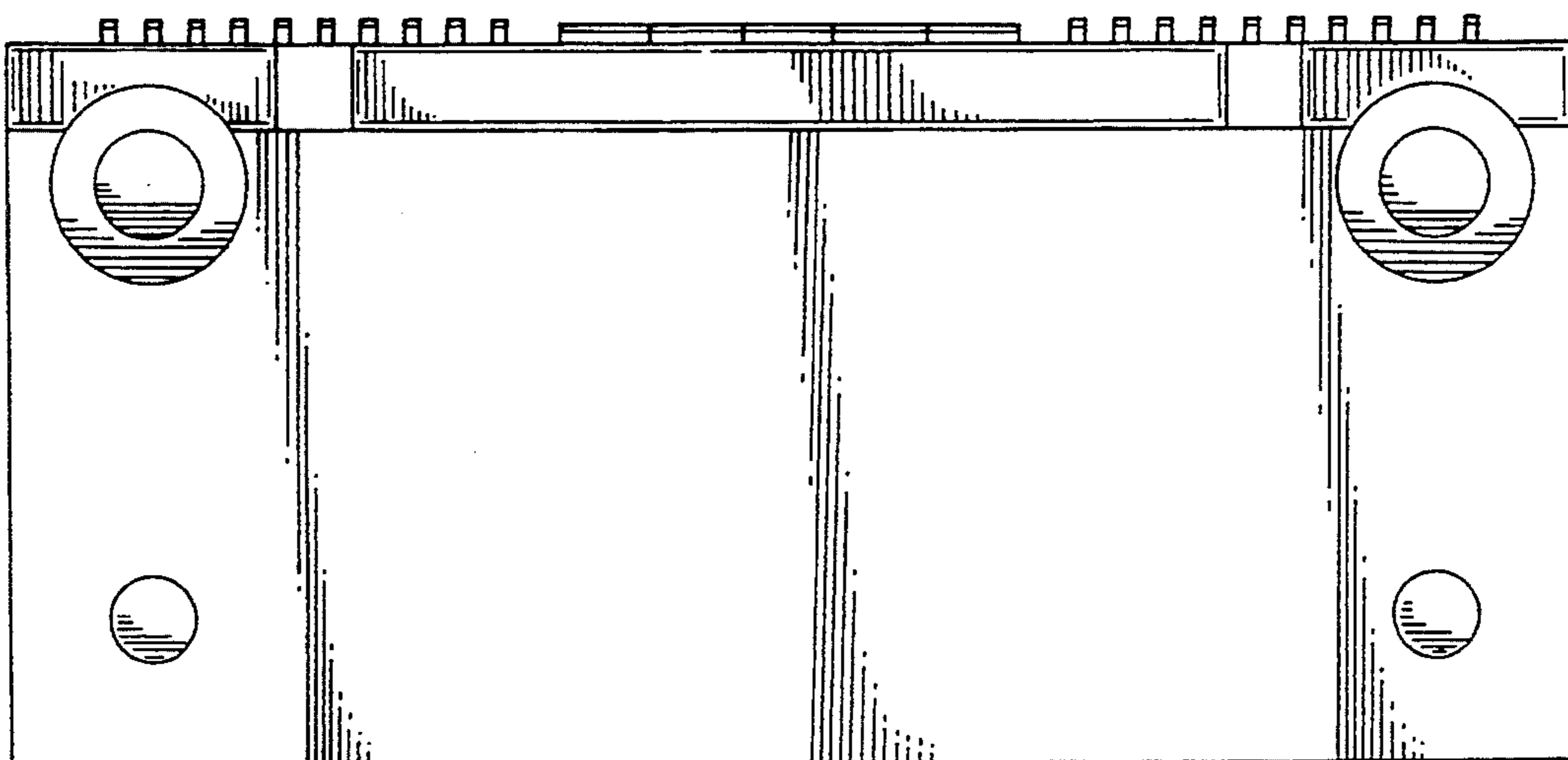

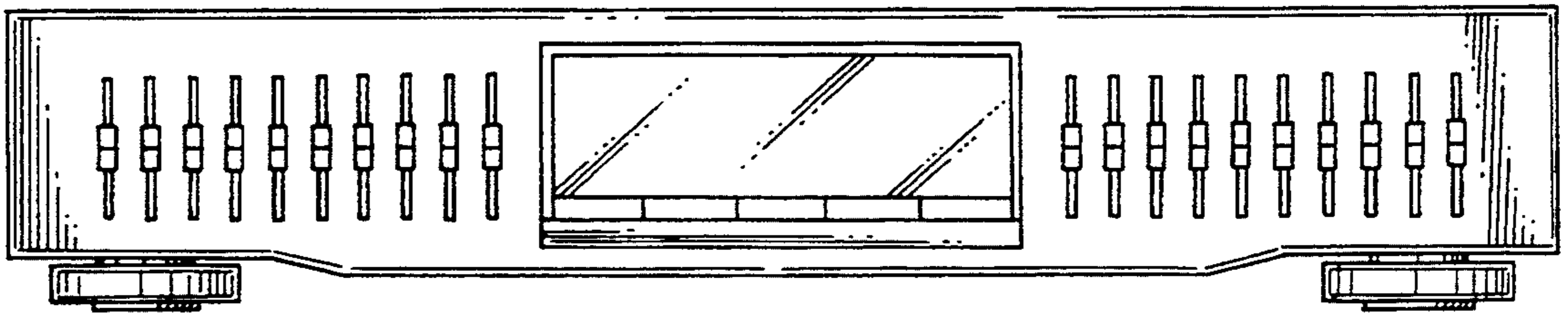

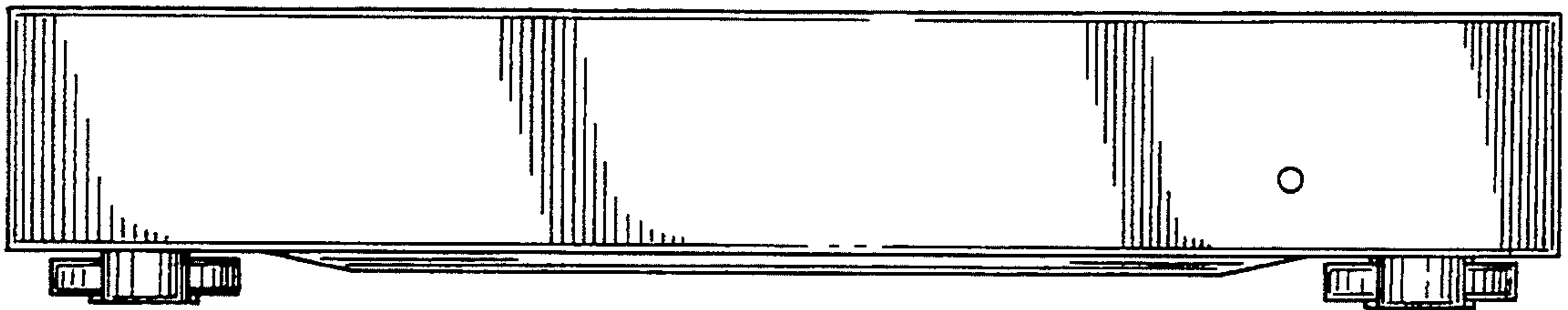

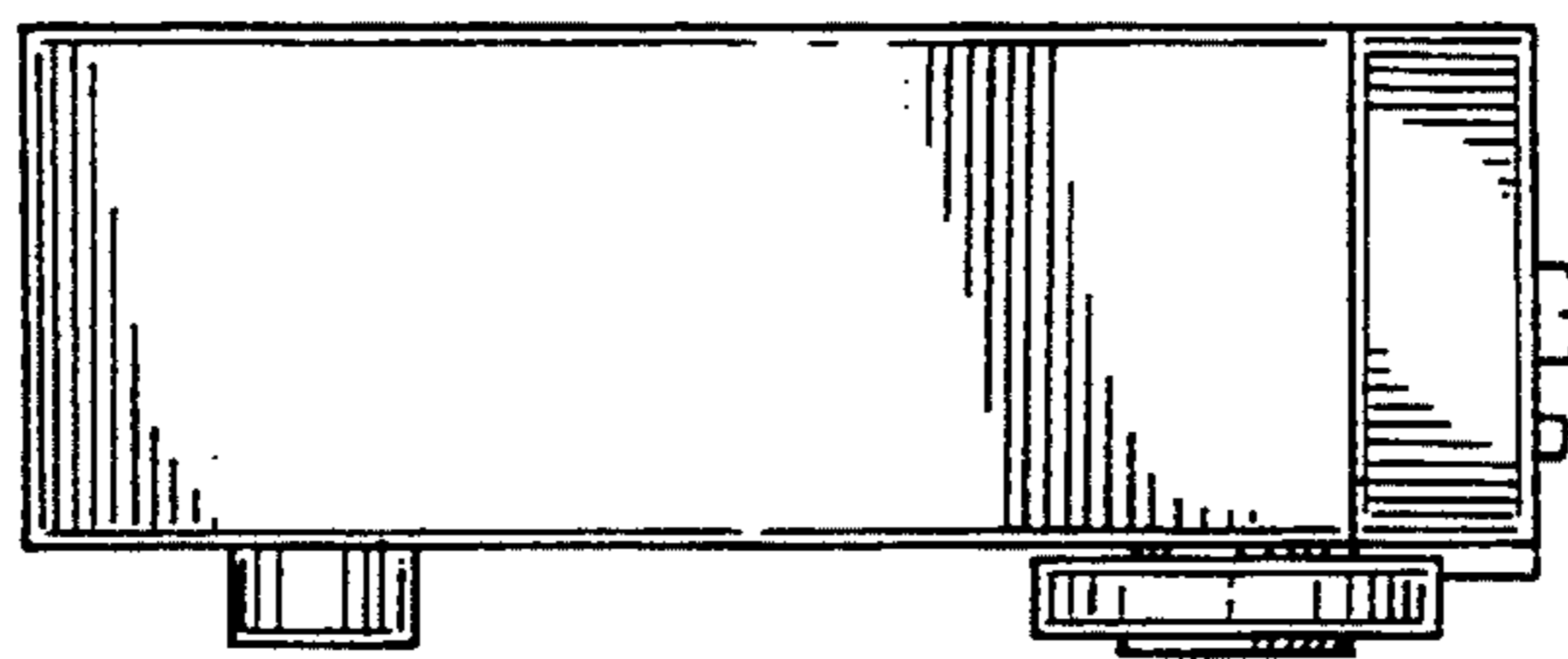

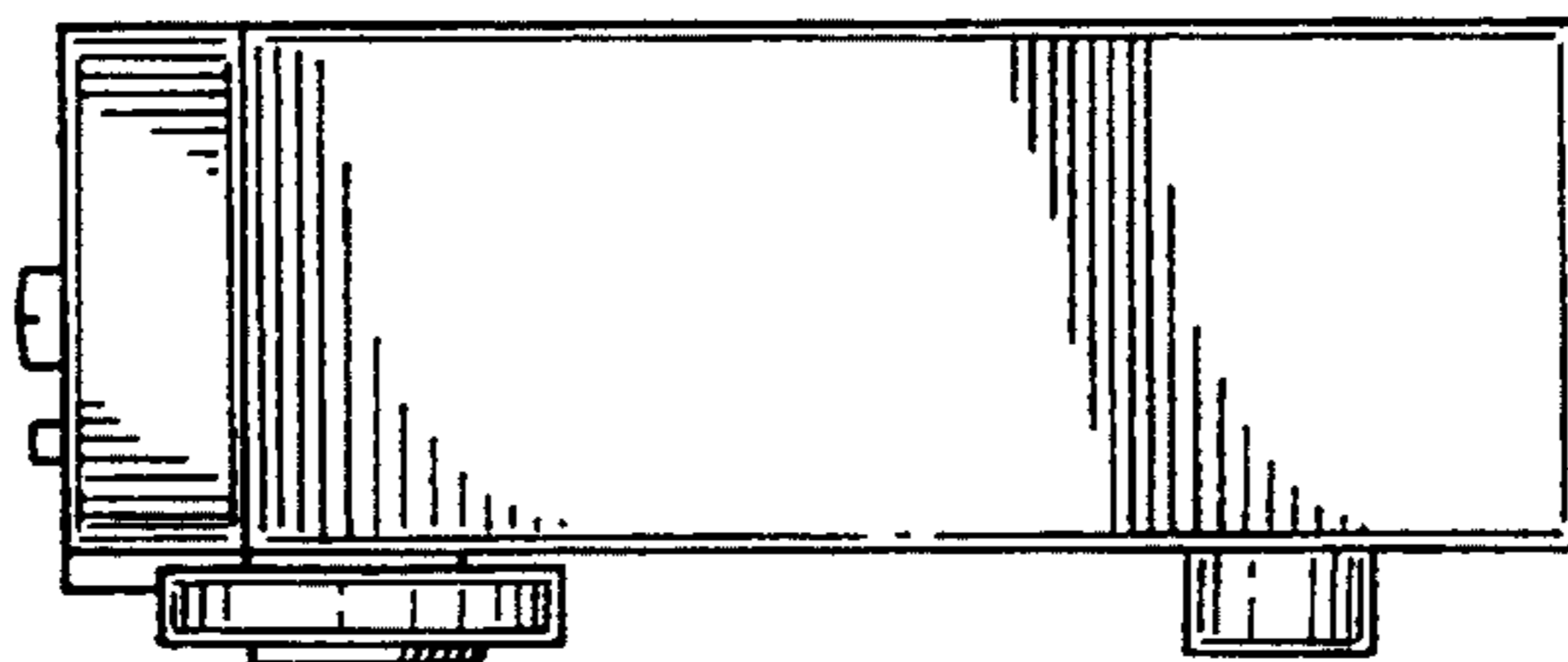
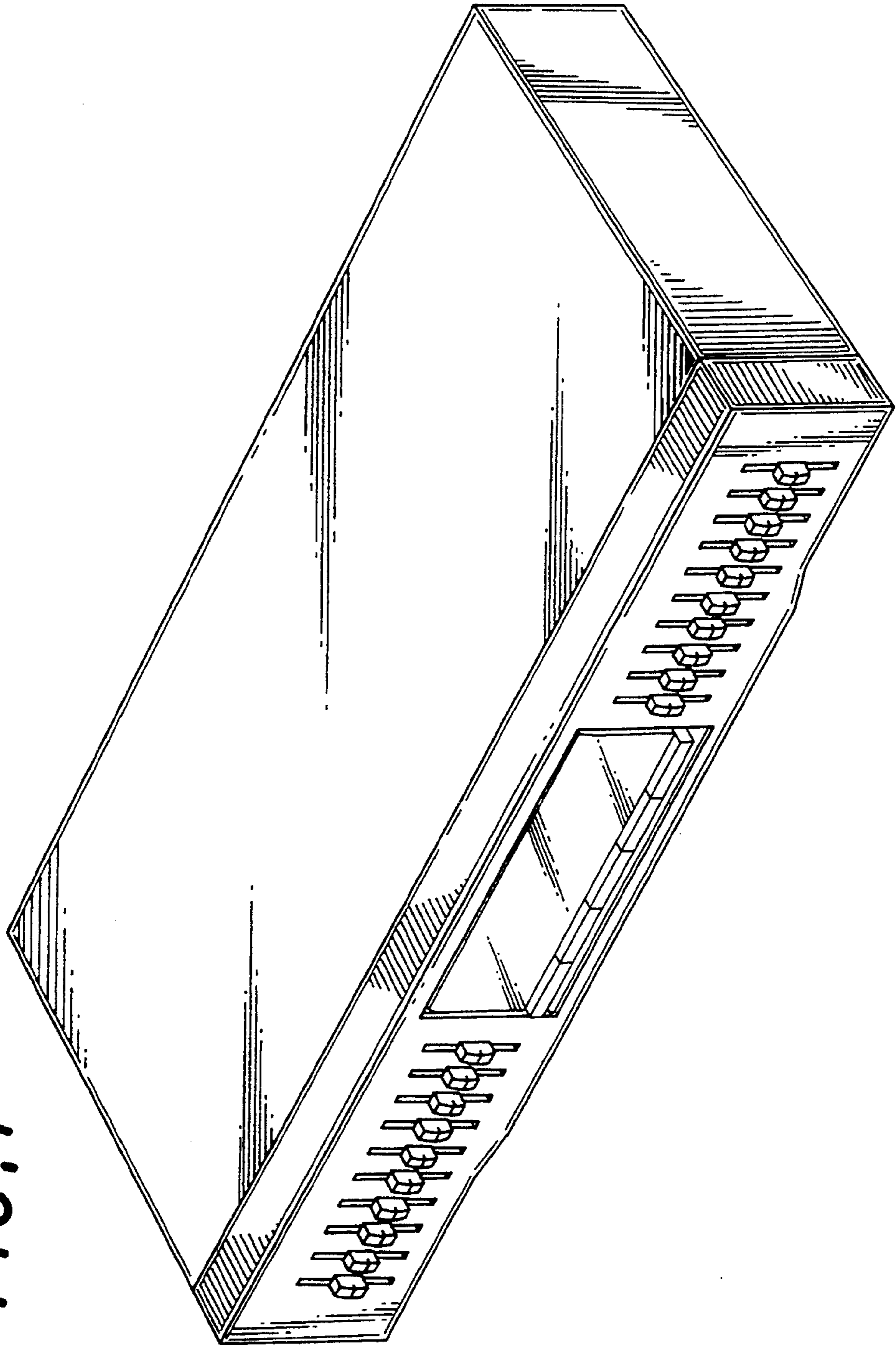
